CENTRAL UNION ORGANIZES OWN ELECTION CAMPAIGN: TEN MEETINGS IN BERLIN TUESDAY

Central Union Campaign Slogan: "Elect None of the Members of Anti-Semitic Parties"; Libel Suit Against "Angriff" Opens Monday; Vice-President of Communist Fraction in Prussian Diet and Leader Admit Communists Voted for Confiscation Law

BERLIN, July 8-The Central Union | Jew Weiss escaped from Paris in order of German Citizens of the Jewish to avoid punishment." Faith is organizing an election cam-paign, the slogan of which is "Elect None of the Members of the Anti-Semitic Parties," according to an announcement made today.

The Central Union is not associating itself with any political party.

The organization has arranged ten meetings of its own to be held in different sections of Berlin on Tuesday.

The Central Union reports that armed Nazis invaded the Dortmud Synagogue, fired at those present, but did not injure any one. One Nazi was arrested

A new wave of cemetery desecration is sweeping the country, the same organization reports. The desecrations are particularly rampant in Chemnitz and Butzweiler, where the number has reached a total of 125. A special booklet will be issued by the Central Union listing the desecrations of Jewish cemeteries.

LONDON, July 8-A Palestine Arts Collection Society has been formed, according to an announcement which appears in the form of a letter to the "London Times" yesterday.

The organizers of the society include

Sir Robert Mond, brother of the late Lord Melchett; Sir Ronald Storrs, former Governor of Jerusalem; Sir Her-bert Samuel, former High Commissioner for Palestine, Lady Erleigh, daughter of the late Lord Melchett and Sir Flinders Petrie, noted archaeologist.

The new organization is to be known as "Friends of the Palestine Museum." The leaders of the society, in making their announcement, point out that there is considerable danger that objects throwing light on the development of the Jewish, Moslem and Chris-

tian religious arts, now distributed throughout the world, may disappear. They ask for outright gifts or pieces for exhibition. The group plans to secure accommodations in Palestine for an exhibition of the articles.

The interest of the society extends to all objects illustrating the history of antiquities in the Holy Land and the development of various movements which had their roots there.

Immigration Tide Shrinks More Than 90 Percent

(Tewish Daily Bulletin) WASHINGTON, July 8-Immigra-tion in May totaled 2,479, while the number of aliens leaving the country to live permanently in foreign coun-

tries was 8,577, according to a state-ment by Harry E. Hull, Commissioner General of Immigration. May immigration was 90.3 per cent below the figure for May, 1929, three

years ago. Ten aliens are leaving the country for every three admitted, it is

stated

Deportations totaled 1,597, while 179 indigent aliens were returned to their native lands at their own request in May.

European countries contributed 1,449 newcomers this month, of whom 598, or 41 per cent, came from Italy; Germany with 182 was second in the list, followed by Great Britain with 109, the other countries of Europe sending less than 90 immigrants each. Canada supplied 481, Mexico, 188, and other countries 361.

Immigration as a whole declined 90.3 per cent since three years ago when the influx from all sources except Mexico was practically normal. The proportionate decrease was larger in some cases, particularly for the Irish Free State, Scandinavia, Germany, and Great Britain, while that for Italy was 68.5 per cent, and for Asia only 50.2 per cent.

MONTREAL, July 8-Under a cap tion "The Jews are Assassins," the anti-Semitic publication Le Miroir prints a lengthy article purporting to show that Jews kill gentile children to use their blood for ritual purposes and makes the inference that the Lindbergh baby has also been a victim of such a brutal

The article is full of vile accusations and many falsifications which have one tendency and that is to rouse the French Canadian population against the Jews of the Province of Quebec.

"It has been proven, without doubt, that certain Jews use Christian blood for the baking of unleavened bread. The Catholic Church has made its investigations and has found the allega-In Last Three Years

Alien Departures Exceed Admissions by the Bollandist Fathers?, says the publication and cites a chronological list of so-called ritual murders allegedly performed by Jews, and each crime, as it asserts, taking place before Passover. If that is not enough to convince the non-believers in these mediaeval

accusations this publication revives the famous Damascus blood accusation and relates that the priest, Thomas, was murdered in the house of a rich Jew so that his blood may be used for the feast of Passover. For this crime six Jews were sentenced to death, but according to this sheet, these Jews were able to buy their liberty with the aid of gold from the Rothschild coffers. The murder of Yuschinsky, for which Mendel Beilis was trialed and acquitted. was carried out, as is asserted by the paper, by the rabbis who are the chief users of Christian blood.

"The murder of a young Christian in Germany, last spring, has revived in Europe the history of the innumerable ritual crimes committed by the Israelites and it is worth noting, that in each case a child of noble birth was picked as the intended victim. Mrs. Schiff succumbed to the effects of an operation, undergone several months ago.

Interment will take place in the Cold Spring Harbor Memorial Cemetery where her husband is also buried.

Mrs. Schiff, it is stated, never recovered from the shock of the sudden death of her husband on June 4, 1931, while she was in Paris where he was to join her.

Mrs. Schiff was the former Adele Gertrude Neustadt, a daughter of the late Sigmund Neustadt and Mrs. Neustadt. Mrs. Schiff shared with her husband in his numerous philanthropic activities.

Mrs. Schiff was well known as a flower cultivator and this year won five blue ribbons and four reds at the Oyster Bay Horticultural Society with flowers grown in her gardens at Northwood.

Mrs. Schiff is survived by her son, John Mortimer Schiff; her daughter, Mrs. Dorothy Schiff Hall; her mother, Mrs. Neustadt; a sister, Mrs. Casimir I. Stralem and a brother, Maurice Neustadt.

BRONSTEIN IN SIGNED AFFIDAVIT ACCUSES CAPTAIN PANISOARA OF LEADING TORTURE

Says Torture Lasted for Twelve Hours and Twelve More Hours Elapsed Before Gendarmes Permitted Transfer to Hospital; States He Was Asked His Name Only; Press Continues to Discuss Bronstein Case

ture proceedings against him was dicture proceedings against him was dic-tated to the Jewish Deputy, Dr. Man-fred Reifer, by Samson Bronstein, Zionist leader of Yedinez, from his sick bed in the Czernowitz Hospital and

The statement by Bronstein confirms that he was arrested on May 7th, and states that the torture lasted for twelve hours and that twelve more hours elapsed before the gendarmes permitted him to be removed to a hospital.

The affidavit affirms that Bronstein was the organizer of the Poale Zion organization in Yedinez and asserts that he detests Communism and has never had anything to do with the Communist movement.

Bronstein states that the only question asked of him at the time of his arrest was whether his name was Samson Bronstein. The Roumanian authorities have stated that he was arrested on charges of being a Com-

Captain Panisoara to whom the statement refers by name has denied any guilt in connection with the torture of Bronstein, but will be held for trial. The Roumanian authorities, in a statement issued on June 22nd, accepting the guilt of Panisoara, announced that he would be transferred as a disciplinary measure, but the transfer has

not yet been carried out. Bronstein's statement bearing the date of June 13, 1932, reads as follows:

Bronstein Affidavit "The patient, Samson Bronstein, born in 1892, in Secureni, Bessarabia, residing in Yedinez, deposes as fol-

"Sunday, May 7th, 1932, at about 1 o'clock in the afternoon, I was stopped on the street by the Gendarmerie Section Commander in Yedinez, named Pantelia, and the Chief of the State Police Perecu. I was arrested and taken to the Gendarme post where Captain Chotin Panisoara hit me and pulled me into a room. The only question that was asked was whether my name was Samson Bronstein. In the evening the same Captain questioned me for ten minutes and then my hands were chained and I was dragged through several rooms and into a hut where I lay on the ground and the fol-

lowing procedure commenced.
"My feet were tied with ropes, my knees bent and drawn together with my chained hands by means of a rope. A long pole was drawn through the hollow of my knees and I was elevated. Then the following procedure began. I was whirled round and round and the

An affidavit, accusing Captain Pani-soara of the gendarme post in Yedi-tinuously. Then I was taken down, nez. Bessarabia of instituting the tor-land laid on the floor. Two gendarmes placed themselves on my feet and on my breast. One gendarme stood on my chest and another on my stomach. This procedure lasted until seven o'clock in the evening when my bloody signed by him. The complete affidavit feet were placed in buckets of vinegar and following this a mixture of lime and salt were poured over my wounds. "All this time the Captain of the

Gendarmes was urging them on to torture me more and more. At about 1 o'clock in the morning, Dr. Brilliant of the Jewish Hospital was called to me. He made some injections and applied compresses. He insisted that the gendarmes take me to the hospital where my wounds should be attended to. At five o'clock in the morning I was still not taken to the hospital. But some time after noon I was taken by car to the hospital at Trinka, about 16 kilometres from Yedinez, where I remained from the 8th of May until

the 5th of June, 1932. "I must state that I am not a Communist and detest Communism and I numer had anything to do with the Communist movement. I am the or-ganizer of the Poale Zion and am President of the section in Yedinez and Secretary of the Zionist group in the same city. At all times during the torture I categorically declared that I have nothing to do with the Communist movement because I am a Zionist," the affidavit concludes.

The Bronstein case still continues to be the topic of editorial comment.

A number of editorials culled from the Tewish press in this country read as follows:

The "American Israelite" of Cincinnati states:

"The torture of Samson Bronstein, Zionist leader of Bessarabia, Roumania, while unusually brutal even for that unhappy country, would doubtless have escaped public attention were it not for the vigilance of the Jewish Telegraphic Agency in discovering and reporting this barbarity and in verifying and finally obtaining an admission of the torture from the Roumanian government after the Roumanian Legation in the United States had branded the original report as "completely invented."

"Without the Jewish publications throughout the world, however weak and unsatisfactory they may be, the Jewish Telegraphic Agency would be powerless to appeal to the general sense of fairness before which even the most autocratic government must

bow.

Dr. Joseph Rosen Arrives: Says Condition of Jews in Colonies Better Than in Cities

Says It Is Ridiculous to Make a Jewish Issue of Valuta Affair

Dr. Joseph Rosen, head of the agricultural work of the Agro-Joint in Soviet Russia, arrived on the Bremen for a stay of several months. In an interview with a representative of the Iewish Telegraphic Agency, Dr. Rosen discussed conditions of the Jews in the colonies and in the cities.

The Jewish colonists in Crimea are better off this year than the Jews in the cities, because they have more bread and other food than is now obtainable in the urban districts of Soviet Russia,

Dr. Rosen said. "The situation in the Crimean colonies

re studenon in the crimean colonies is greatly improved by the irrigated vegetable gardens which cover about three thousand acres of land," he stated. "As a result of the better food situation in the colonies, one thousand lewish families, more than has been planned, have settled in Crimea this year. They came from the cities on their own initiative, and were also called by their relatives in the colonies. And so instead of fifteen hundred Jewish families which the Agro-Joint has planned to settle this year in Crimea, there are twenty-five hundred families being settled," Dr. Rosen pointed out.
"The food situation in the Jewish

colonies in Ukraine was not as good as in Crimea because the harvest in Ukraine was not good last year. But pros-pects of this year's harvest are good in Ukraine, just as in Crimea. And it is therefore to be expected a considerable betterment in the food situation, not only in the colonies and the farms, but in the cities as well."

Asked about the general situation of the Iews in Soviet Russia, Dr. Rosen

declared:

"Well, they are just as good or as bad off as the entire population of Soviet Russia. There is no such thing as

BERLIN, July 8-That the Communist fraction in the Prussian Diet voted for the law calling for the confiscation of the property of East European Jews who entered Germany after August 1. 1914, was confirmed to the Jewish Telegraphic Agency yesterday by Wilhelm Kaspar, vice-chairman of the Commu-nist fraction in the Diet and Wilhelm Koenen, leader of the Communist fraction.

The statement by the Communist Diet representatives contradicts the denials issued by the Communist organ in Berlin, "Rote Fahn," and by the Communist organ in New York, "The Freiheit.

The Communist fraction leaders denied that they had any prejudice against the Jews. They stated that the Communists voted for the measure after their amendment had been defeated, because the tax proposals con-tained therein were far-reaching in their effect against capitalism.

In this fashion, they stated, they planned to expose the Nazi demagogy and embarrass the government of

unemployment in Russia. There are six jobs for one man. But there is a general lack of commodities and a shortage of products."

Questioned as to the so-called Valuta affair in Soviet Russia, Dr. Rosen declared that it is ridiculous to make of it a Jewish issue.
