MARTIAL LAW DECLARED IN PRUSSIA; CENTRAL UNION SAYS IT IS NOT MOVE TOWARDS HITLERISM

Chancellor Von Papen Named Reich's Commissioner in Prussia; Premier Braun and Minister of Interior Severing Ousted; Will Appeal to Supreme Court

BERLIN, July 20-Martial law was use of explosives, damaging of raildeclared today in Prussia, occupying two thirds of the territory of the Ger-man republic and seat of its leading industrial sections, by a special decree signed by President Paul von Hinden-

burg.
Chancellor Franz von Papen was Premier Otto Braun and Minister of Interior Karl Severing were ordered to yield their portfolios. This the latter refused to do on the ground that it was unconstitutional and asserted that he would yield his office only by force.

The Prussian government will take its claims that the presidential decrees are unconstitutional to the Supreme Court.

States rights were ended in Prussia and the control of the police force comprising 90,000 men was ceded to the Reich Administration with General Kurt von Schleicher, Federal Minister of Defense in charge.

The action of the Federal government is interpreted in some circles as concession to the demands of Adolph Hitler and Alfred Hugenberg who asked that the police and the Prussian administration be taken over by the Reich in order to quell political disturbances. Franz Bracht, Lord Mayor of Essen, was named Prussian Premier and

Minister of Interior.

The martial law order abrogated the articles of the constitution dealing with the right of free speech, the right of assembly, the rights of private property and telephone and postal communications. All these rights may be curtailed as necessity dictates.

Z.O.A. President Pays Tribute to Lewin-Epstein

Tribute to the memory of Elihu Lewin-Epstein, one of the founders of the colony Rehoboth and a veteran of the Zionist movement, who died at Bad Nauheim, Germany, in his sixty-ninth year, was paid by Morris Ro-thenberg, President of the Zionist Organization of America, in a state-

ment he issued yesterday.

The late Mr. Lewin-Epstein, a member of the Board of Directors of the Jewish National Fund at the time of his death, had in the course of his residence in the United States during the past thirty years served in many capacities on administrative bodies of the Zionist Organization of America and on the Boards of numerous agencies dedicated to the development of Palestine as the Jewish National Home.

"With the death of Mr. Lewin-Epstein a unique figure disappears from the Zionist scene," Mr. Rothenberg stated. "His life, spent in Eastern Europe, in Palestine and in the United States, was an exemplary expression of the high ideals which had animated the generation of pioneers who laid the foundation of the Jewish renascence in Palestine as well as for the creation of a vital and strong Jewish life in the United States. Rehoboth, one of the first and oldest colonies in Palestine, will forever stand as a monument to his vision, devotion and practical idealism; the record of the numer-ous endeavors in which he was engaged in this country in behalf of Palestine as well as in behalf of important Jewish causes is likewise eloquent testimony to the useful life which had been interrupted, to the regret and sorrow of American Zionists."

Clinic Because Majority Of Patients Are Jews

Controversy Raging Over Closing of St. Marks Clinic: Untermyer Intervenes

A long standing controversy be-tween Dr. William Norman Guthrie, rector of St. Mark's church in the Bowery and Bishop William T. Man-ning, is bringing about the end of medical aid to Jewish poor in the vicinity of the church located at Tenth Street and Second Avenue.

Dr. Guthrie, involved in many quar-rels with the Bishop, has yielded on the question of the Body and Soul Clinic in the church building, to pres-

sure from the vestry and has acquiesced to the closing of the clinic.

The official announcement of the clinic's closing stated that economic reasons were responsible. The clinic reasons were responsible. The clinic was established by Dr. Edward S. Cowles, some nine years ago, who paid all expenses involved. This was made known in a communication addressed to the Vestry by Samuel Untermyer in behalf of Dr. Cowles, wherein he openly charged that the vestry ordered the clinic closing because the majority of the patients are Tewish.

Mr. Untermyer challenged the "Christianity" prompting this action and stated that the vestry stand was taken because the chief beneficiaries

of the church are Jews. A number of meetings have been held in protest against the action of the church.

Shoshkis, Here on Visit, States That Government Credits Most Essen-tial for This Work

Ch. Shoshkis and Consul General Mikhail Stashevsky, members of a. delegation from Warsaw, who are now in this country to arrange for Polish representation at the Chicago exposition, were feted at a luncheon yesterday by the Polish Consulate here.

Today the Polish delegation will be received in Washington by the Polish Minister, Tytus Fillipowicz. From Washington they will proceed to Philadelphia where they will be the guests of former Minister Stetson, now the president of the American Polish Chamber of Commerce.

After this round of hospitality, Mr. Shoshkis and General Stashevsky will go to Chicago where they will spend three weeks preparing for the Polish

In an interview with the Jewish Telegraphic Agency, Mr. Shoshkis, who is the general inspector of the Co-operative Bank of Poland, described conditions in Jewish co-operative insti-tutions in Poland.

Despite the depression there are 500 co-operative banks in Poland, Mr. Shoshkis said, with whom 200,000 families are connected. Loans in the amount of 160,000,000 zlotys have been granted. The Co-operative banks constitute the strongest Jewish economic organization in Poland at this time, he said.

He said that crisis of confidence has greatly reduced the amount of savings deposits. He also deplored the dearth of cheap credits. The American Jewish Joint Foundation, he pointed out, is reorganizing its work in Poland and a new central Co-operative bank is in process of formation. Government credits for the new bank are necessary, he emphasized.

"We have nothing to withdraw. The fact is that horrible brutalities have been committed against the Zionist worker, Bronstein, in Yedinez, Bessa-rabia, and for these brutalities the Roumanian government must be held responsible and not the J.T.A. as Mr. Rosenthal wishes to imply."

This statement was made by Dr. S. Margoshes, editor of "The Day," in yesterday's edition, in reply to a letter which he received from J. Los Angeles Bar Endorses Two Jewish Judges (Jewish Daily Bulletin)

LOS ANGELES, July 20-Two Jewish judges, at present incumbents of the Los Angeles County Superior Court, were given a very high endorse-ment by the plebiscite of the Los Angeles Bar Association and its eleven allied associations in Los Angeles County. They are Lester Wm. Roth, president of the Jewish Consumptive Relief Association, and Isaac Pacht. One thousand, seven hundred and seventy-two members of the associations voted their preferences, Judge Roth re-ceiving 1,393 votes as against his two opponents' total of 263.

(Tamich Telegraphic Agency) AMSTERDAM, July 20-Dr. A. A. Musset, of Utrecht, leader of the Dutch Nationalist Socialist party, in an interview with a representative of the Jewish Telegraphic Agency, declared that his party, as far as Holland is concerned, rejects anti-Semitism.

It is untrue he stated that according to our program Dutch Jews will become secondary citizens should the

Nazi party come into power.

The Iews in Holland, he asserted, are Dutchmen and there will be no difference between them and other Dutchence between them and other Dutch-men. If, however, the Jews oppose National Socialism, the Nazi Party will fight them as they fight Socialists and Communists, Dr. Musset said. He denied that the Dutch Nazi Party

has concluded an agreement either with Adolph Hitler or Mussolini.

The American students of the Town ish faith, who want to go to study in the German universities, have nothing to fear as long as they themselves do to fear as long as they themselves do not mingle in political affairs, declared Dr. Herman Kaufman, a Hamburg Jewish physician, who arrived here several days ago from Germany, in a lecture delivered Tuesday evening as the Woodstock Hotel

Dr. Kaufman stated that the American Jewish student is respected in Germany as an American foreigner and that no harm will come to him as long as he does not participate in the nolitical controversies of the country. Dr. Kaufman declared that the popu-

or assumption abroad, that the popu-lar assumption abroad, that the Hit-lerists are the leading anti-Semites, is basically false, in an interview with a representative of the "Staats Zeitung."

"The so-called anti-Semitic policy of

the German nation in accordance
with its population representation, is the German nation. Germany has sixty million people, of whom six hundred thousand or one percent are lews. "As to the latest reports from abroad, in connection with fights between National Socialists on one hand, and Communists and Socialists on the other, - controversies which, in those reports, were described as anti-Semitic outbursts on the part of National Socialists — I, as a Jew, wish to emphasize that they were purely political demonstrations.

"Hitler's assistant, Mr. Strasser, him-self recently stated in a radio speech, that his party opposes all Jewish per-secutions and that it would never permit Czaristic pogroms, or similar riots in Germany. I can, with all truthful-ness, state that the Jewish scholar, the physician, the artist, the businessman, the artisan, in Germany and in Austria, can perform his business undisturbed just as the Jewish student, especially the American, can go about his studies undisturbed. "It seems that in the cabled reports to

America, there was not sufficiently em-phasized the fact that the reported demonstrations were not directed against the Jew as a believer of another religion, but against his political views. Look at the American Socialists and Communists and you will see how many of them are immigrant Jews, especially aliens. Consider the American so-called radicals and you will realize that also among them is a very great percentage of those elements whom our National Socialists oppose," Dr. Kaufman declared.
