## GERMAN JEWS URGED TO GO TO POLLS TODAY; THREE IMPRESSIVE MASS MEETINGS UNDER CENTRAL UNION AUSPICES; SCORE GROWTH OF ANTI-SEMITISM

Dr. Weil Scores Attempts to Limit Rights of Jews; Says Foreign Jews in Germany Will Be Protected by Their Governments, But Not German Jews; Dr. Weiss Openly Accuses Government of Dismissing Him as Concession to Nazis; Says Terror in Provinces Exceeds That of Cities; Overflow Audience Accommodated in Two Additional Halls

BERLIN, July 29—German Jewry last night openly voiced its protest against the growth of anti-Semitism in a resolution adopted at an impressive mass meeting held under the auspices of the Central Union of German Citizens of the Jewish Faith.

The throng which came to attend the meeting was so large that it completely filled the largest auditorium in the Lodgen House, with room for 1,000 and the overflow audience had to be accommodated in two additional auditoriums in the same building. The same speakers addressed all three meetings.

Special police details were on guard to prevent any disturbances.

Dr. Julius Brodnitz, vice-president of the Central Union, presided. An outstanding impression was made by the appearance and address of Dr. Bernhard Weiss, deposed vice-president of the Berlin Police Department. Addresses were also delivered by Dr.

Bruno Weil, outstanding Central Union leader; Dr. Alfred Hirschberg, press chief of the Central Union, Dr. Wiener, and Rabbi Leo Baeck.

Dr. Weiss, who received a remarkable ovation, openly accused the present government of forcing him to leave his police post as a concession to the Nazis. "I was dismissed primarily because I am a Jew," Dr. Weiss stated.

He appealed to the Jews to fight fearlessly for their rights and to meet the present serious situation with dignity. The tragedy is, he said, that German Jews now feel isolated in their

## Jewish War Veterans Threaten to Follow Nazi Tactics if Jews Not Protected

Mass Meeting Held in Vienna Demands Government Offer Adequate Protection to Jews

VIENNA, July 29—A mass meeting of a thousand Jewish veterans of the world war, headed by the Jewish General Heller, was held here last night to protest against the persecution of the Jews in Austria by the Nazis.

Speakers emphasized that Jewish soldiers laid down their lives for Austria during the war.

Resolutions adopted demand the government offer effective protection to the Jews. The soldiers threatened to use the same methods employed by the Nazis for self-defense if the government does not take the necessary protective measures.

## WEIZMANN INDICATES HE HAS NO INTENTION TO SEEK RETURN TO LEADERSHIP IN WORLD ZIONIST AFFAIRS

In Statement to J. T. A. He Says Scientific Work Occupies All His Time; Arlosoroff in Address at Actions Committee Says Wauchope First High Commissioner to Really Understand Palestine Needs; States Transjordanian Will Eventually Have to Be Used for Jewish Colonization; Debate on Political Reports

LONDON, July 29—Dr. Chaim Weizmann, in a statement to the Jewish Telegraphic Agency today indicated that he has no intention of seeking to return to leadership in world Zionist affairs at present.

Rumors that adherents of Dr. Weizmann would seek to pave the way for his return to leadership at the Actions Committee meetings have been current.

Dr. Weizmann, who made an unexpected appearance at the sessions yesterday afternoon, stated to the Jewish Telegraphic Agency that he does not intend to participate in the debate in the Actions Committee.

He is attending the sessions merely to prevent any misinterpretations and to set at rest any rumors that he is boycotting the Actions Committee of which he is a member.

Dr. Weizmann asserted that he is devoting himself entirely to scientific work which absorbs him fully and that he

does not intend to change his present mode of life.

LONDON, July 29—This morning's session of the Actions Committee was devoted to a debate on the reports submitted yesterday by Prof. Selig Brodetsky and Dr. Chaim Arlosoroff, members of the world Zionist Executive in charge of political affairs, the former in London and the latter in Jerusalem.

A debate on the report of Victor Jacobson, dealing with the work of the Zionist office in Geneva was also held. The speakers included Dr. Isaac Gruenbaum, Polish Jewish Zionist leader, S. Kaplansky and J. Sprinzak of Palestine, representing the Poale Zion and Dr. Nahum Goldmann, Radical Zionist of Germany.

## Permit Instruction in Yiddish Language in Two Flemish School Districts

Believe Concession Offered in Order  
to Prevent Jewish Children from  
Transferring to French Schools

ANTWERP, July 29 — Permission for the teaching of the Yiddish language in the Flemish Municipal schools of the 6th and 7th districts, where there are a considerable number of Jews, has been granted by the authorities.

Yiddish language instruction has been introduced, it is learned, with a view to induce Jewish children to continue their studies in the Flemish schools instead of transferring to the French Schools.

It is believed that a Jewish Committee will be appointed to co-operate with the Flemish Education Committee on Jewish educational matters.

Commissioner to really understand the needs of Palestine is Sir Arthur Grenfell Wauchope, the present incumbent, stated Dr. Chaim Arlosoroff, member of the World Zionist Executive in Palestine, in the course of his address delivered yesterday at the second session of the Actions Committee.

Dr. Arlosoroff denied that most Palestine officials are anti-Zionist. There is no doubt some of them are adhering to established anti-Zionist tradition, but Sir Arthur is fighting these sentiments, Dr. Arlosoroff declared.

Referring to the report of Lewis French, Palestine Land Commissioner, Dr. Arlosoroff revealed that the original number of claims entered by so called "landless" Arabs exceeded 4,000. This number was subsequently reduced to 1,700 he said. Actually, however, the recognized claims now number 249, he asserted. Of this number, 200 "landless" Arabs are in Wadi Hawareth.

Dr. Arlosoroff urged the need for counteracting the anti-Jewish propaganda of the Grand Mufti in Arab countries. Some steps in this direction have already been taken, according to Dr. Arlosoroff, who also stated that the understanding between Jews and Arabs, locally, is progressing.

Dr. Arlosoroff, in his address recognized the necessity of extending Jewish colonization to Transjordan in the course of time.

Contact has already been established with various sheiks anxious to sell their land, but the Jewish Agency has not sufficient funds for this undertaking, he asserted. It is concentrating thus far on maintaining its contacts for future use.

He referred to the case of four Jews who were beaten up and driven out of Transjordan although they had come to purchase land of a woul-

**Chalutzim for Palestine**

JERUSALEM, July 29—Ten thousand new Chalutzim for Palestine were demanded by a mass meeting last night of settlers in the Emek.

The meeting urged the Actions Committee to overcome petty differences within its ranks and to unite the forces in the Diaspora to strengthen the Jewish community, the Jewish National Fund, the Palestine Foundation Fund and to develop Palestine for the absorption of all classes of Jewry.

Harlem, chairman of the celebration; William R. Blumenthal, executive director of the Home; and William Cohen, superintendent.

**Testimonials on Schechita**

HELSINGFORS, July 29—A booklet containing approval of Schechita, the Jewish orthodox ritual of slaughtering animals for food, written in the Finnish and Yiddish languages has been circulated by the Jewish community among the deputies in Parliament and all members of the government.

The booklet contains approval of Schechita by recognized authorities and scientists both in Finland and elsewhere who attest to the humane method of Schechita.

The testimonials have been distributed in connection with the bill which Parliament will consider when it resumes in the fall, calling for the prohibition of Schechita. The Jewish Community feels confident the measure introduced by the Society for the Prevention of Cruelty to Animals will be rejected by Parliament.

**Nathanyah School**

**Honors Oscar Straus**

TEL-AVIV (By Mail)—The children of Nathanyah have named their new school-house in honor of the late Oscar Straus, American Ambassador to Turkey. The founders of the colony who three years ago when they broke ground, lived in tents, named the colony after the late Nathan Straus. The laying of the new corner-stone was coupled with a vivid ceremonial of the delivery of deeds to Nathanyah's latest settlers among whom were M. Levontin, manager of the Anglo-Palestine Bank of Tel-Aviv.

Arab Sheiks of the neighboring villages, the Governor of Tul-Karem and the registrar of lands participated in the joint ceremony and expressed surprise at the unprecedented growth of Nathanyah which in three years, with the private resources of its Palestinian-American settlers, has increased its population to 500 people, planted 3,500 dunams of orange groves, built over 85 houses, equipped with all modern conveniences.

An additional 10,000 dunams have been acquired by the Hanotiaih Colonization Agency, and a new colony, Yehudiah, with an area of 6,000 dunams, was founded between Nathanyah and Tel-Mond. Yehudiah was named in memory of Eliezer Ben-Yehuda, the father of modern Hebrew, in commemoration of the tenth anniversary of his death.

## Urges Family Physician to Go Into Preventive Medicine To Lower Medical Costs

**Dr. A. J. Rongy Deplores High Cost of Medical Care; Blames Family Physician in Part for This Situation**

The family physician is urged to go into preventive medicine in order to reduce the costs of medical care to his patients, by Dr. A. J. Rongy, prominent Jewish physician, according to the Associated press which quotes from an article written by Dr. Rongy, who is the chairman of the Greater New York Committee on Health Examination, in the current "Health Examiner."

The publication is issued by his committee in conjunction with the New York Academy of Medicine.

"The methods of medical practice which obtained during an era of prosperity no longer continue," Dr. Rongy says. "The lavish expenditures which prevailed in the treatment of the sick will no more be possible.

"The family doctor, to a large degree, is responsible for the tremendous and very often unnecessary hospitalization of patients throughout the country. Many a patient who could just as easily be cared for at home is sent to the hospital. This generally proves costly to the patient and very often he is unable to meet his obligations to the physician."

"The family physician, according to Dr. Rongy has been remiss in preventive medicine. "The family doctor must call a halt on all unnecessary and superfluous specialist expenditures. Instead, he should try to broaden his sphere of medical practice. This will help to reduce the cost of medical care," Dr. Rongy declared.

## Ask Funds for More

### Yiddish Text Books

MOSCOW, July 29—A campaign to induce the government publishing house of the Ukrainian Nationality minorities to assign additional funds for the publication of Yiddish text books for use in the Yiddish primary and high schools is in progress under the auspices of the "Stern".

There is a great shortage of school text books and it is believed this will present a sharp problem when the school term opens next month.

## Jews Deny Expulsion

### From Transjordan

**Not Enough Jews in Western Parts of Czecho-Slovakia; Consider Plan to Merge Communities**

PRAGUE—The Eastern provinces of the Czecho-Slovakian Republic contain a dense Jewish population, especially Carpatho-Russia and large parts of Slovakia. The Jewish population in these parts is not only numerically but also Jewishly strong. They retain completely the old Jewish distinctive religious and national culture. They carry on a separate Jewish communal life, imbued with deep religious feeling, with East European folk ways and their own distinctive Jewish forms of life, not only inwardly, but also outwardly. The process of disintegration of Jewish life in contact with Western civilization, and the dangers of assimilation have hardly touched this Jewry. The intense Jewish life in this reservoir of Jewish religious and national orthodox bids fair to stand firm like an iron wall for many years to come against all the assaults from the West.

The exact opposite obtains in the Western parts of the Republic. Except for a few small orthodox separatist communities, and a few Zionist efforts aiming at a revival of Jewish national, political and cultural activity, the Jews in Moravia, Bohemia and Silesia are rapidly assimilating, becoming absorbed.

There are not many Jews, and they are scattered all over the country—a couple of dozen Jews in this town and in that among a thousand non-Jews, with all Jewish national-cultural distinctiveness, or traditional religious Judaism gone. There is complete linguistic and cultural assimilation with the Germans here, and the Czechs there and these Jews are completely cut off from Jewish life as a whole. They have lost all Jewish distinctiveness. Old Jewish communities in towns and villages are dying out. There is not a minyan of Jews left in them. Not even three Jews to say grace together at the table. The Orthodox Jewish newspapers published in Czecho-Slovakia are full of letters from readers complaining that in this or the other famous ancient Jewish community the synagogues and the community buildings have been turned into business houses, factories, even stables for cattle. The last Jewish family in this town or in that has sold the Jewish communal property, and the new non-Jewish owner is putting it to a different use.

This is happening not in two different countries, but in the same Czecho-Slovakian Republic—in one part of Czecho-Slovakia, in the west, Jewishness is dying, crumbling, as a result of former affluence and over-advanced emancipation, while in the other, in

## Dr. Guthrie Upsets Hailed Clinic Controversy Settlement In New Communication

**Now Declares That Vestry as Church Owners Have Right to Oust Any Activities to Which Opposed**

Temporary settlement of the dispute over the ouster of the Body and Soul Clinic from St. Mark's on the Bowwerie, which was hailed by Dr. Edward S. Cowles, director of the Clinic, as a result of the alleged stand taken by the rector of the Church, Dr. William N. Guthrie, has been disrupted by Dr. Guthrie himself.

In a statement by Dr. Guthrie on Thursday, released through the clerk of the church vestry, Oran Capshaw, Dr. Guthrie, as reported in the "Herald-Tribune," asserted that he had not changed his position with regard to the vestry's ouster of the church on June 27th.

He reiterated that he would make no move to carry out the decision of the vestry but at the same time made it clear that the vestry, as the owners of the church, have the right, if they choose, to close out such activities as they see fit.

On Wednesday, Dr. Cowles, referring to a letter written by Dr. Guthrie taking issue with the vestry's action and asking a month's suspension of the clinic's activities, had announced a complete victory for the clinic. Moreover, Dr. Cowles addressed to Dr. Guthrie a letter of thanks in which he declared: "I respectfully suggest that you send your letter to the vestry in order that they may be officially notified that it is our agreement that the clinic continue in the church as long as you are rector and only be sus-

ended for the month of August for necessary cleaning and repairs."

Dr. Guthrie's newest statement, which has added to the general confusion on the matter, declares:

"I desire to state as a matter of personal privilege that I have never changed my position in regard to the clinic or in regard to the action of my vestry on June 27th. I have stated ad nauseam that I was in accord with the minority of two and made a strong plea for its position when the vote was eight to two in the vestry proper against the continuance of the clinic on our premises; that I held it to be good work and hoped it can be continued elsewhere, if not at St. Mark's, with my glad co-operation.

"If my vestry as owners, according to the older laws governing our church, because of its ancient charter, take action to close their premises to the clinic, I shall regret it, but I will make no appeal. The bishop has expressed himself as in agreement with the majority vote of the vestry. I will not combat the decision of the bishop, neither will his decision bind my conscience. Therefore, I cannot, personally, as a minister of Christ, in these times of great distress order the closure of the church myself for a good work, even though it be not so conducted as some of us would like, Dr. Cowles included.

"From the very beginning I have construed the vote of eight in the vestry as an act of corporaion and so said repeatedly. Personally, I am worn out with this perpetual rehashing and misrepresenting of the facts in the case. I have written to Dr. Cowles a letter, given to the press prematurely, intended to establish a 'Truce of God' for the month of August which means that if there be any further hostilities they at least will not trouble us during this hot month and Dr. Cowles will have a chance for convalescence and we for survival and the church for much needed cleansing and repairs," Dr. Guthrie's letter concludes.

## Professor Levine Sails for Hague and Geneva Conferences

In the East, Jewish life is strong and virile, culturally and religiously, while materially, there is over-crowding and economic distress. In the one place too many Jews, in the other not enough Jews.

Might it not be a good thing to merge these two sections of Jews, citizens of the same country, to help the one economically, and the other Jewishly?

The Jewish press of Czecho-Slovakia is busy now discussing the question. Why, they ask, should these two Jewries living in one and the same country be sundered in this way, as if they were two different peoples, living in two different countries? The only points of contact between them are the Zionist Organization, which embraces some of the Jews in both sections and a few schools conducted by the modernized orthodox movement.

So there is a discussion going on about the practical possibilities of settling a number of Jewish families from the Eastern districts in the midst of the weaker Jewish communities of the Western provinces.

In ordinary times, with economic conditions more or less stable, the idea would not encounter any serious difficulty, but at the present time, with the economic crisis growing, even in the industrialist and highly developed Western provinces, there is little room for additional Jewish merchants and shopkeepers to come in from the Eastern provinces. Still less for the young Jewish workers from Carpatho-Russia. The Czech and German trade unions would resist such an invasion even by resorting to Nationalist and anti-Semitic slogans.

So the thing has to be put off till better times come. There is room, however, for a number of artisans, and the idea has been mooted to begin by transplanting some tailors, cabinet-makers, house-painters, upholsterers and the like. As a precedent, it is pointed out, that there has been a stream of orthodox Eastern Jewish artisans within the last few years into Topelitz and Machrisch-Ostrau that has kept these two communities alive.

The Jewish nationalist modernized papers refuse to place any hope in such an internal colonization plan. They do not believe that it is possible to maintain Judaism in the highly cultured Western provinces, by the observance of the Shulchan Aruch and the wearing of beards and earlocks.

There is consequently a heated quarrel going on between the orthodox and the modernists. And before it had been in progress very long, the anti-semites joined in. The anti-Semitic papers are holding up the bogey of an East-European Jewish invasion into the Western provinces. The "Robotnicki Novini" a Labor paper, is terribly afraid lest the Jewish youth of Carpatho-Russia will invade the Czech countries.

own country. He blamed the Christian church in Germany for tolerating anti-Semitism.

In an impressive address, Dr. Bruno Weil scored the Nazi terrorization tactics and attempts to limit the rights of the Jews. Such an attempt, he said, will reflect on the rights of the German national minorities in such countries as Poland and Czecho-Slovakia.

He expressed certainty that no foreign Jews residing in Germany will suffer because their governments will protect them, while German born Jews will remain unprotected.

Dr. Weil indicated that there is a section in the minorities treaties which would offer some protection to German Jewry, were efforts made to infringe on their rights.

Dr. Wiener described the terror prevailing in the provincial cities. The Jews there, he said, are afraid of appearing in the streets in the evening. Jewish children are isolated in the schools. Jewish houses are stoned. Berlin is paradise compared to the provinces, he said.

Dr. Brodnitz urged every Jew to go to the polls on Sunday. He emphasized that while the situation is serious, there is no reason for panic.

Dr. Hirschberg asserted that Germany is compromising itself abroad by tolerating the Nazi tactics. He quoted foreign press comment condemning anti-Semitism in Germany.

Funeral services were held for Rabbi Joseph Marcus, of the Mishkan Israel Synagogue, who died at Belmont, N. J., at the age of fifty-seven.

He was known as a Talmudic scholar and served as chairman of the Board of Orthodox Rabbis.
