#### LEHMAN INAUGURATED AS NEW YORK'S FIRST JEWISH GOVERNOR IN TWO SIMPLE SERVICES

Death of Governor's Sister Causes Cancellation of Social Events Planned in Connection with Inaugural; First Oath of Office Administered by Judge Irving Lehman in Governor's New York Home: Public Ceremony in Albany Yesterday

Herbert H. Lehman was sworn in as I the first Jewish Governor of the State of New York in two ceremonies, the first of which took place Saturday evening in New York, in the presence of a small group of friends and relatives a small group of Friedric and Friedric and the second yesterday, a public ceremony attended by 2000 persons.

The oath of office as the Chief Executive of New York State was ad-

ministered to Governor Lehman on Saturday evening in his New York home by his brother Judge Irving Lehman of the New York State Court of Ap-peals. A shadow was cast over the ceremony by the sudden death of the Governor's sister, Mrs. Clara L. Limburg on Friday.

#### Joint Foundation to Grant \$175,000 in New Credits To Jewish Institutions

Jewish Institutions in Four Countries to Benefit; Bernard Flexner Re-places Lehman as Vice-President

(Jewish Telegraphic Agency) LONDON, Jan. 2—New credits in the amount of \$175,000 will be granted to Jewish institutions in Poland, Czechoslovakia, Lithuania and Roumania by the American Jewish Joint Foundation, it was decided at a meeting of the Foundation held here under the Chair-manship of Sir Leonard Cohen.

Reports were delivered by Dr. Bernard Kahn and M. Louis Oungre, manring directors of the Foundation. Dr. Cahn, who is the European director of the activities of the American Jewish Joint Distribution Committee, described his personal impressions of his recent visit to East European countries, in-

cluding Soviet Russia.

Nazis Bears Tone of Pessimism; Victory No Longer Predicted Liberals Forecast the Complete Col-lapse of the Nazi Movement in 1933

BERLIN, Jan. 2—A New Year's message issued by Adolph Hitler, the National Socialist leader and his chieflieutenant Paul Joseph Goebbels, head of the Berlin Nazi Party, bears a tone of pessimism unlike previous messages. No longer is there any prediction of

victory. It enumerates several victor-ies claimed for Hitlerism during 1932, among them the retirement of Dr. Bernhard Weiss, the Jewish Vice-President of the Berlin police department, who was forced out of office as a result of sustained Nazi agitation and a campaign of scurrilities hardly equalled even in the annals of Hitlerist propaganda. The only specifically anti-Jewish passage in the Nazi New Year's message is

University of Kovno Will Not Yield to Demands for Numerus Clausus, Rector Assures

Views of Extremist Groups Will Have No Effect on Administration; Jews Constitute 26% of Student Body (Jewish Telegraphic Agency)

JERUSALEM, Jan. 2—The University of Kovno will not yield to the demands of the extreme Nationalist student groups for the introduction of numerus clausus, the rector of the University, Professor Tchepinsky, has informed the Lithuanian Consul Gen-eral in Palestine, G. Valkauskas.

Professor Tchepinsky's statement was in reply to an inquiry addressed to him by the Lithuanian Consul General who referred to the recent reports of the Jewish Telegraphic Agency con-cerning the demands for a numerus clausus.

#### To Protest Pogroms in Poland on January 8th

A meeting to protest the recurrent anti-Jewish attacks in Poland has been arranged for January 8th at the Manhattan Lyceum by a Committee calling itself the United Committee for Struggle Against Pogroms in Poland.

Thirty Jewish professors, writers and other intellectuals have joined in the call for the meeting and have issued a public appeal to New York Jewry to unite in a vigorous public protest against the policies of the Polish government affecting Jewish and other national minorities in Poland.

The recent attacks on Tewish students in Poland are characterized as the "culmination of the constant oppression of national minorities in Poland" by "rulers seeking a scapegoat for their own crimes."

#### Vindicated Jews Still Imprisoned in Harbin

(Jewish Telegraphic Agency) HARBIN-Although some time has elapsed since Moses Zutch, accused of organizing pogroms against the White Russians, has been vindicated by the High Court of the Manchukuo Government. he is still under arrest, the Tewish Telegraphic Agency is informed.

A representative of the Foreign Ministry of Manchukuo attributed Zutch's continued detention to the fact that he had too many enemies in Harbin, who would secure his death if he were given his freedom. The Russian press reports that Zutch is kept in solitary confinement, with his hands and feet fettered, because, after his vindication, he made an unsuccessful effort to escane.

#### Jewess Sues Physicians For Alleged Theft of Blood for Transfusion

#### Takes to Court Charge Physicians Extracted Blood for Serum While She Was Unconscious

(Jewish Telegraphic Agency)

WARSAW-A doctor's dilemma is now occupying the attention of the legal and medical world in Poland in connection with an action brought by a Jewish girl, Rachel Schuster, against doctors. The charge is that the doc-tors extracted blood from the girl while she was lying unconscious in the hospital for the purpose of blood transfusion. The girl claims that this is an ordinary case of theft, and in addition to claiming damages demands also that the doctors be punished. On the other hand the doctors claim

that the girl was aware of the extrac-tion of blood. Alternatively, they claim that as the blood was required for the purpose of saving life the extraction, even if the girl was ignorant of it, was perfectly justified.

The girl suffered in her early child-hood from infantile paralysis, from which she had entirely recovered, con-sequently developing in her blood a natural resistance to this illness. Infantile paralysis is now raging in Poland and only by the transfusion of blood from those who have successfully recovered from it can a cure be af-

The doctors claim that altogether 25 grams of blood were extracted from the girl, who had recovered from the operation on the second day, while the girl insists that she was swindled, and informed that the extraction was necessary so that her blood could be tested for purposes of her health.

The girl has now handed the case to the public prosecutor and an interesting trial is to be expected on whether or not the extraction of blood is to be considered as theft. On the other hand, a public trial may be avoided, as the authorities of the hospital are still trying to arrange terms with the girl so as to avoid action in court.

#### Communist Leaders Threatened When Collective Quota Drops (Jewish Telegraphic Agency)

MOSCOW, Jan. 2-M. Kipper, director of the Communist Party in the Stalindorf region and secretary of the Jewish collective, "Apikoires," was reprimanded and threatened with expulsion from the Communist Party because the region failed to deliver its bread quota to the government.

Two Communist members of the collective, Kusovski and Simkin, were ex-pelled from the Party and will be placed on trial. The charges against them are that they co-operated with the Kulaks and failed to maintain sufficient watchfulness over the affairs of the collective.

#### People May Now Leave Russia; Passport Fees Prohibitive, However

By Our Moscow Correspondent MOSCOW-The Torgsin, the Soviet Trading Organization, which sells goods to residents in the Soviet countries, citizens and foreigners, for foreign valuta only, announces that it is undertaking all formalities for obtaining foreign passports and visas for Soviet citizens who wish to emigrate permanently from the Soviet Union. A foreign passport will cost for workers 550 roubles, and for non-workers

1,100 roubles in gold or foreign valuta.

This announcement published by the Torgsin in all the Soviet papers has given hope to thousands of Soviet citizens who have long wanted to go abroad to join their children or other relatives, but have been unable to do so because no foreign passports were issued.

The number of potential emigrants is particularly large among the Jewish population, who, more than any other nationality in the Soviet Union, have relatives living in other countries, above all in America.

There is doubt, however, among people with a realistic view of things, whether the concession will amount to much in practice, because only those people who have wealthy relatives abroad able and willing to pay the exceptionally high sums demanded for a passport will be able to take advantage of the opportunity of emigrating. Foreign residents, who want their parents and other members of their families to join them in the countries where they are living will have to pay for passports alone thousands of dollars, and there are no people left in Soviet Russia who

possess such sums themselves. It was reported in 1929 that the Jewish Colonization Association (Ica) was Mohiley-Podolsk, Charkoff, Odessa, Kiev, Jitomir, Vinitza, and Proskurov for the purpose of advising wives and shildren and parents of American residents able to obtain permission to enter America, and others wishing to emi-grate to the Argentine, Brazil, Australia and other countries.

About a year abefore that, the Ica concluded an agreement with the Sovted Government, under which it was authorized to carry on relief work among Jews, desiring to emigrate from the Soviet Union, and Leo Zack, the Ica's representative in Russia, told the Jewisi Telegraphic Agency at that time that the work of the emigration offices of the Ica would be carried on along he same lines as the work of the Ica emigration offices in the prewar yeas.

#### Noted Professor Strikes Blow At Nazi Theory of Racial Superiority of Pure Strains

Says the Assertion the More Pure the Race, the More Genius and Productivity Is False

The Nazi theory of race purity and race superiority which forms one of the chief weapons of their campaign against the Jews of Germany is struck a blow by Dr. Ernst Kretschmer, psychiatrist, famous professor of the University of Marburg.

Dr. Kretschmer, who attained a world wide reputation with his book, "Body Structure and Character," repudiates the theory of racial superiority of the pure strain in an interview which appears in the German publication, "Diè Woche," which has reached this coun-

There is no foundation for the allegation the more pure the race, the more genius, Dr. Kretschmer asserts.

Dr. Kretschmer writes an article in the German periodical "Die Woche," which has just reached this country; entitled "Know Thyself," in which he discusses race, race superiority, and mixed races. The Scherlverlag publishes the periodical and is in close connection with the National Socialist Party.

The opinion," Dr. Kretschmer writes, "that types of structure correspond to types of races are conclusively dis-proven by the comprehensive thorough investigations of Henkel, Weiden-rauch and others. On the other hand it is highly likely that the various structural factors occur in different races and tribes in varying proportions, a fact by which certain differences of temperament in those different stocks may be explained. . . .

"Very few race theories," he asserts, "are free from political and romantic prejudices. We are today still very far from having enough material for a comprehensive racial psychology. But already today, we might say that the incidence of genius and cultural achievements are based on complex biological factors and are not at all the privilege of a certain race. assertion: the more pure the race, the more genius and productivity, is false: It is true, fortuitous mixture of races is not favorable for cultural production; but it appears that certain good crossings of previously inbred stocks, might enhance the production of genius. I have in mind the invasion of the Germans into Italy in times of migration of nations; it is very prob-; able that also the high standard of Babylonian Assyrian culture must be attributed to such repeated invasion,

Last Monday his body was fished out of the Matler Dam and an inquest established that he had been shot and his body mutilated before being tied up in a sack and dropped into the water.

Three members of Hentsch's Storm Troop are suspected of the crime. The three suspects fled to Italy and their extradition is urged upon the Foreign Office by the government of Saxony.
