Charge Polytechnic Institute Seeks to Introduce Yellow Badge for Jewish Students

Authorities Deny They Have Issued Special Registration Cards With Yel-low Badge for Jewish Students

(Jewish Telegraphic Agency) VIENNA, Jan. 27-The Polytechnic Institute of Vienna is charged by the "Arbeiter Zeitung" with seeking to in-troduce the yellow badge, symbol of compulsory ghetto days, for Jewish

students.

The paper alleges that the authori-ties of the Institute have introduced special registration cards with the yelspecial registration cards with the yea-low badge to identify Jewish students. Different certificates to differentiate the Aryan students will be issued, the paper further charges. The distinctive registration cards are being issued for the purpose of identifying the Aryan students in the event of renewed disturbances, the paper asserts.

The rector of the Polytechnic Insti-tute denies the allegation. The rectorate explains that new registration cards are being issued for all students. It may be that quite accidentally the Jewish students received the first cards of the new series, the rectorate says.

The Minister of Education also expressed doubt as to the correctness of the allegation, explaining that a spe-cial mark to distinguish Jewish stu-dents would be open infringement of equal rights guaranteed to all citizens of the country.

The Jewish Community of Vienna is preparing to take vigorous action should the charges be authenticated.

Will Establish Greek Colony in Palestine

(Jewish Telegraphic Agency) SALONICA, Jan. 27-In line with the plan proposed by Asher Moissis, President of the Executive of the Jewish National Fund for Greece, about forty prominent Jews from Salonica, Athens, and Janina will visit Palestine next March, with the intention of making the necessary arrangements for the formation of a Greek colony in Palestine, for which a sum of ten thousand pounds sterling has been received and handed over to the Jewish National Fund through the efforts of the late Dr. Cof-

Report Goering and Frick Will Be Included in New Von Papen Cabinet

Forecast Goering Will Hold Key Posi-tion as Minister of Interior

(Jewish Telegraphic Agency)

BERLIN, Jan. 27-The possibility that Captain Herman Goering, president of the Reichstag, and Dr. Wilhelm Frick, National Socialist leaders, notorious for the extreme anti-Semitic views they hold, will be included in a new cabinet to be formed under former Chancellor von Papen, is forecast by the Ullstein press.

The forecast is causing considerable anxiety to the Jewish population in view of the attitude of the two Nazis to the Jews and their repeated pledges of severe measures against the Jews once they secure power.

Goering, according to the reports, is slated for the post of Minister of In-terior and Premier of Prussia, while Dr. Frick is slated for office as Minister of Justice.

Although Jewish leaders believe that von Papen as Chancellor would seek to preserve an impartial attitude to-ward the Jews, they fear that the Nazis would infect other members of the cabinet with their own anti-Semitic views. Goering, in particular, would hold a key postion to internal affairs were he named Minister of Interior.

Separate Electoral College For Jews to Be Maintained In Greek Elections

Tsaldaris Cabinet Which Fell Had Promised to Abolish This Practice; Jews Entitled to Two Seats

(Jewish Telegraphic Agency) SALONICA, Jan. 27-A separate

Electoral College for the Jews will be retained in the new Parliamentary elections which take place on March 5th, it became known today, while proportionate elections will apply to the remainder of the population.

Under the separate Electoral College, Jews are entitled to but two seats in Parliament.

The present decision blasts the hopes of the Jews that the discrimi-nation which has been practiced in the past will be abolished. A promise to this effect was given by the Tsaldaris Ministry, but the short-lived existence of the Tsaldaris cabinet prevented it from realizing its pledge.

A motion to abolish the separate Electoral College was introduced in Parliament by Daniel Allalouf, Jewish deputy from Salonica, and was sup-ported by seven non-Jewish deputies. The same day, however, the cabinet of Premier Tsaldaris fell.

The Zionist parties are for the pres-

ent showing no keen interest in the clection campaign which opened today. Their attitude will probably depend on the Jewish candidates for election.

Decision Handed Down in Suit Brought by Student Against University of Maryland

Excavations at Ancient Synagogue of El-Hamme by Hebrew University Archaeological Expedition

IERUSALEM -In the course of November, a Hebrew University archaeological expedition directed by Dr. E. L. Sukenik, undertook the excavation of the ancient synagogue at Hamat-Gadar (El-Hamme), on the northern bank of the Varmuk river. The synapogue had heen revealed at the beginning of the summer by the Palestine Department of Antiquities. Jewish workmen of the Kibbutz "Hashomer Hatzair" at Kinnereth and native laborers living on the spot were employed in the excavation. The funds for the work had been received by the University from a Jewish resident of Palestine, who wishes to remain anonymous. Suleiman Bey Nassif, of Haifa, who holds the concession for the hot springs at El-Hamme. placed at the disposal of the expedition and workmen a number of buildings that had been used by the warm-baths establishments, and in so doing greatly contributed to the success of the undertaking The synagogue had been built on a

hill, and — as was established by poterty and eartherware vessels found scattered on its slopes — this place had been settled in the Early Bronze Age and partly also in the Middle Bronze Age. But the mound was later abandoned, and a Roman city was built at the foot of the hill from the northern tip of Hamat-Gadar down to the Yarmul.

The whole area of the synagogue and its adjoining buildings were cleared in the course of the diggings. The synagogue itself had been built in the form of a square, the walls being about thirteen metres long. Two rows of the area into a nave and two aides, while a row of columns on the northern side left a narrow passageway, similar to the one in the synagogue at Capernaum. Judging from this row of columns on the north, it may astely be galley, ovidently for the use of female worshippers, as in many other ancient synagogues.

On the southern side, facing Jeru-

salem, the excavators uncovered an apse, like the one at Beth Alpha, which was reached by a short light of steps. This part of the building was evidently used as the repository of the Ark of the Law, this being proved by the many fragments of marble tablets, part of the railing round the apse, which were found there.

Open Factory for Manufacture Of Oil From Oranges (Jewish Telegraphic Agency)

JERUSALEM, Jan. 27—A new industrial plant for the manufacture of oil as a by-product of the orange industry has been opened in Rehoboth by a group of Jewish planters.

The plant, it is estimated, will utilize

500 tons of oranges daily, thus increasing the demand for oranges in the country and opening employment possibilities to several hundred workers. The oil process from orange neel has

been worked out by an American Jewish chemist, Joseph Braverman, who has settled in Palestine and is one of the group which has organized the plant.

Three similar plants will be established by the same company in various sections of Palestine, according to present plans.

teaching of children, etc., were uncovered outside the synagogue. By far the most important discovery was the interesting mosaic floor of the synagogue While some of the mosaics were broken, the major part was ne-

vertheless still preserved, and showed various designs as well as four Aramaic inscriptions. The first panel, near the Ark of the Law, had designs of lions with cypress-trees worked in on either side of an inscription of ten lines, set in a round frame. There were two long inscriptions found at the head of the second mosaic panel, decorated with flowers and pomegranates. The third panel was principally composed of geometrical symbols, and also had an inscription.

The inscriptions on this floor excell among those hitherto found in other ancient synagogues of Palestine, in that together with the names of the donors they mention also the various sums of money contributed towards the construction of the synagogue. The value of these inscriptions to Jewish history lies in the fact that in addition to the names of these donors, who came from different communities to the baths at this place, there are also given the names of the cities from which they hailed. Capernaum is mentioned among such towns, this being the first time that its name appears in an inscription of the same period.

A number of coins, a few fragments of pottery, and many pieces of marble from the railing around the Ark of the Law, upon some of which there are also remnants of inscriptions, were

found in the excavations.

The expedition also undertook the investigation of the theatre at Hamme and the remains of the Roman haths built over the hot springs. After having completed the excavation of the synagogue, the expedition also investigated other ancient synagogues in Lower Galilee, particularly the remains of the MYOLD PRINTING CO., Inc. old synagogue in Khirbet Kanef, in Go-Now York lan, east of Lake Kinnereth.
