Hitlerism to Be Condemned By Federation of Churches And Interfaith Committee

Catholic and Protestant leaders of the Greater New York Federation Churches and the Interfaith Committee have decided to utter a protest on behalf of the Christians of America against the anti-Jewish terrorism, which has become a feature of the Hitler re-

New York Federation of Churches have been in conference with former Governor Alfred E. Smith; Bishop William T. Manning; Rev. Dr. William B. Millar. Executive Secretary of the Federation of Churches, a Protestant Organization, and Charles H. Tuttle, Chair-man of the Interfaith Committee, which comprises Catholics and Protestants, have prepared the draft of a protest which will be submitted for signature to prominent Christians, who will sign it, after which it will be made public.

SEATTLE.-His first flight on a furtrading by airplane adventure that was "going to make us rich" ended in death last week for Marian W. Goldstein, Alaska fur dealer, who left Seattle February 18th, with a new plane, planning to start an aerial fur-trading company in Alaska to supplant trading by dog team.

Killed with Goldstein was Ted Morris. Seattle aviator and Goldstein's pilot. The crash occurred near Fairbanks, Alaska.

Goldstein was born in Juneau and is survived by his widow and son, as well as his father and mother and a sister living in Los Angeles.

Jabotinsky Demands Fuller Primacy of Revisionist Discipline Over Zionist Organization and Election of Three Members on Revisionist Executive to Support His View; Grossman Opposes Further Widening of Revisionist Discipline Over Zionist Organization. Holds Jathotinsky's Request Is Untenable

Le con-tended that the Calais agreement, which was ratified at the Revisionist World Conference held in Vienna last August still shackled the Revisionist Union to the Zionist Organization, and hampered the full development of political work. He averred that the composition of the present Revisionist Exmentation of the Calais agreement, in that the section of the Revisionist Union, which demanded greater independence, was not sufficiently represented on the Executive. He accordingly demanded that three more mem-Clerical and lay leaders of the Greater bers of this own wing be co-opted on the Executive. In reply, Meer Grossman, Vice-presi-

dent of the Union, declared that the argument advanced by Jabotinsky for the co-option of three members of his own wing to the Executive was uniter-able, as never, in any circumstances, had any section of the Revisionist Ex-ceutive made use of its majority to out-vote Jabotinsky. M. Grossman also opposed a further widening of the primacy of Revisionist discipline over that of the World Zionist Organization, arguing that in actual practice. Zionist discipline had never prevented Revisionists from carrying out separate political work.

In view of the acute differences of opinion obtaining between the two extreme views as represented by V. Jatbotinsky and M. Grossman, a center group has been formed at the Conference with the object of preventing a split, in any circumstances.

The conference at Kattowitz was called in order to decide the future relations of the Revisionist Union to the Zionist Organization, in view of the recent decision of the Zionist Conune recent decision of the Zionist Con-gress Court suspending the Revisionist Union as a separate Union. The Con-gress Court went into the question of the Calais agreement, which it held a breach of Zionist discipline, in that it allowed members of the Revisionist Union to carry out Union to carry out separate political

ganized in two sections, under a single gamzed in two sections, under a single Executive. One section, led by V. Jabotinsky, refuses to acquire the Shekel and adhere to the Zionist Oroneset and adnere to the LIONIST Organization. It was owing to the action of this section that the Calais agreement, which declared that the Revisionist Union was no longer an integral part of the Zionist Organization, came into being. The Calais agreement was in the nature of a compromise, allowing those members who did not wish to belong to the Zionist Organization to remain members of the Revisionist Union, and in the same organization as those who still retained membership in the Zionist Organization.

Jewish Service Men to Be Granted Furloughs for Passover Furloughs for Passover have been

granted all Jewish service men, it was announced by Dr. Cyrus Adler, Chairman of the Army and Navy Committee of the Jewish Welfare Board. The U. S. War Department, the Bu-

rean of Navigation of the Navy Department, and the U. S. Coast Guard have each issued orders to their respective Commanding Officers, authorizing them to grant leaves to men of Jewish faith from noon Monday, April 10 until mid-

night of April 12, 1933.

The U. S. Veterans' Bureau has had a standing order since 1925, as follows: "At the request of the Jewish Welfare Board and in accordance with the established policy and practice, beneficiaries of the Jewish faith whose physical condition permits will be granted passes to participate in the celebraed passes to participate in the ceiepra-tion of High Holy Days, including Pas-sover (covering the Seder Days), the New Year (Rosh Hashonah), and the Day of Atonement (Yom Kippur)"

The Jewish Welfare Board will arrange for religious services of men residing at a distance from their homes and who are not able to leave their posts, and for disabled veterans who are unable to leave hospital.

The Board's representatives are arranging for the observance of Passover at outlying points, including China, Manila, Hawaii, Panama, and Haiti.

German Persecution to Be Held At Madison So. Garden March 27

Speaker Rainey, Senators Borah and Copeland, Former Gov. Smith, Bishop Manning May Address Demonstration

The monster demonstration at Madison Square Garden decided on at a conference held last Sunday under the auspices of the American Jewish Congress, is to be held on March 27th. At the same time, protests against the Nazi persecution on German Jewry will be voiced throughout the country. The resolution drafted at the Conference, also called upon all Americans to join in the nation-wide protest. It declares, "Americans who believe in the brotherhood of man, we invite to join with us in a demonstration of Ameri-can faith in the sacredness of human rights, and the sanctity of human fellowship.

It is probable that Bishop Manning and former Governor Alfred E. Smith will speak at the meeting at the Madi-son Square Garden. In addition, if son Square Garden. In addition, it congressional duties permit, Speaker Henry P. Rainey of the House of Representatives and Senators William E. Borah and Royal S. Copeland will address the demonstration.

MONTREAL, March 21-Canadian Firm Succumbs at 70 Jewry is moved to its depths by the reports of the occurrences in Germany. From all parts of the country, the Jewish centers in Montreal and Ontario have received appeals urging the organization of protest demonstrations against Hitlerism.

The first organized effort to bring conditions in Germany to the notice of public opinion was taken yesterday under the auspices of the Jewish National Workers Alliance which decided to call a mass conference of all Jewish bodies next Sunday in order to arrange an impressive demonstration against Hitlerism. A telegram has been sent to the American Jewish Congress expressing the solidarity of Canadian Jewry with the action taken by their American coreligionists.

In the province of Ontario, April 2nd has been fixed as a day of protest against Hitlerism, according to the decision of the Central Actions Committee in Toronto. The Actions Committee, which has in charge all the protest arrangements, is also contemplating the proclamation of the boycott on all German goods. The main demonstration in Ontario

In addition to the National Socialist Organization in the United States, a League of the Friends of the Hitler Movement has been established, with headquarters in Hamburg. The task of the League is to carry on propaganda for the German National Socialist movement. Only foreign citizens may be members of this League; German citizens are not permitted to join. The members of the League are charged with the tasks of informing public opinion abroad about the aims of the Hitler movement; they are to help National Socialists to establish contacts with Government authorities, as well as with newspapers and other influential personalities. However, capacity of members of the Friends of the Hitler Movement, they are not to interfere with the internal politics of other countries.
