"Jew Money from N. Y." Shouts Prosecutor at Trial of Negro Youths

Leibowitz, Defense Counsel, Resents Slurs on Race; Motions for Mistrial

(Tewish Daily Bulletin) DECATUR, Ala., April 8-The ugly spectre of anti-Semitism reared its head here in the Morgan County courthouse, where Haywood Patterson, one of the nine Scottsboro Negroes, is being retried for his life. Formerly convicted of criminally assaulting two white girls, the United States Supreme Court up-held a plea for retrial, recently begun here.

Wade Wright, Solicitor of Morgan County, put into words the feeling of hostility against the defense, represented chieflly by Samuel Leibowitz, well known New York criminal lawyer.

Addressing the jury, Wright shouted: "Let it be demonstrated by you that Alabama justice cannot be bought and sold by Jew money from New York." Mr. Leibowitz moved for a mistrial. He made a second motion for mistrial when made a second motion for mistrial when Wright referred to the "New York clothes" worn by Ruby Bates, one of two accusing girls. And a third when Wright said that Lester Carter, witness for the defense, had probably changed his name from Carteretsky, Mr. Leibowitz, in his reply, asserted

that he was representing the Negro boys without any fee and at considerable cost to himself.

Jewish Lawyers Being Allowed to Re-apply (Jewish Telegraphic Agency)

BERLIN, April 8-In the courts of Altona, Dr. Jonas and Rudolf Warburg are the only two Jewish lawyers who will in future be admitted to practice, according to a report in today's Boersen Courier. A sign that the Nazis may be calming down was seen in today's decree of Minister of Justice Kerrl that Jewish notaries and lawyers may now again apply for admission to the courts, since special cases require special treatment. Applicants, in their written applications, must declare their loyalty to the present government.

Britons Jeer Bismark Appeal for Nazi Rule

Sir Alexander MacFadden's Reply Suggests That Hitler Mend His Manners Towards Jows

(Jewish Telegraphic Agency) LONDON, April 8-A severe setback was given to Prince Bismark, Nazi envoy, who arrived here on Wednesday in order to enlist the sympathies of the British public toward the Hitler govern-

At a private meeting of the Royal nstitute for International Affairs, which is one of the most influential bodies in England. Bismark attempted in his address to minimize the anti-Jewish campaign in Germany by throwing respon-sibility for the anti-German propaganda on the Iews abroad. This effort, however, met with derision. Speakers who followed Prince Bismark in discussion, without exception expressed unqualified condemnation of the Nazi policy. Sir Alexander MacFadden, in a striking statement, declared: "I ask Prince

Expert for Germany at Versailles Lectured at American Schools, Author of Many Works

(Jewish Telegraphic Agency) BERLIN, April 8-Professor Moritz J. Bonn, famous scholar, resigned today from the Berlin Institute of Trade of which he was the head. He is one of the hest known economists in Germany.

Prof. Bonn is also known in the United States, where he taught at the University of California in Berkeley, at the University of Wisconsin and at Cornell. in 1915 and 1916. He was one of the experts for Germany at Versailles and later attended also the Reparations Conference. He lectured at the Institute of Politics in Williamstown. He is a members of the European board of the Carnegie Foundation and is the author of a considerable number of books dealing with economic and political questions, among them "America's Enemy," 1917; "America and Its Prob-lems." 1925; "The Fate of Capitalism," non-Jewish employees were dismissed etc. He is considered a particular expert

Sir Austen Chamberlain Calls on Hitler to Halt His Private War on Jews

Conservative Chief Says Nazis Are Justifying the Worst That Can Be Thought of Germany

(Tewish Telegraphic Agency) LONDON, April 8-Liberal and Con-

servative circles buzzed with excited comment here today on the outspoken warning to the Nazis uttered at Birmingham last night by Sir Austen Cham-berlain, former Foreign Secretary of Great Britain, on the occasion of his election as president of the Conservative Association

Sir Austen said, in effect, that the internal war on a racial minority which is being carried out by Hitler justifies, in deed, the worst that the Allied nations could say against German barbarity and frightfulness. In informed circles it is felt that Sir Austen's speech was not prepared without the knowledge, if not without the approval, of the present British Ministry. Sir Austen's speech follows in part:
"I want the German Government to

think of the impression which its attitude toward fellow-citizens within its power must give the world of what its attitude to other nations would be if it were in a position to force its will. Germany met her fate in 1918 because, in overweening pride and egocentric van-(Continued on Page 4)

Messages, cablegrams and letters came from all sections of the country testifying to the esteem and respect in which he is held. At noon congregational members tendered a luncheon at the Hotel Galvez to Dr. Cohen. Adrian F. Levy presided on account of the illness of Robert I. Cohen, Sr., President of the congregation for twenty-eight years.

Following the Temple services a public reception was held in the Henry Cohen Community House, dedicated by the Congregation to Dr. Cohen.

City of Tel-Aviv Adopts Budget of \$576,150

(Jewish Telegraphic Agency) TEL-AVIV, April 8—The budget of Tel-Aviv for the fiscal year will be £167.000 or \$576.150, according to the budget proposals submitted by the municipality administration to the municinality council.

This is the largest budget of any city in Palestine, although Tel-Aviv is the second largest city in the country, after

The new budget will involve a taxation of some £3 per capita for the population of approximately 60,000.

344 Jews Serving on Palestine Police Force

Wise Criticizes Pressure Against American Protest

That the American Jewish Congress may yet be compelled to declare itself in favor of an economic boycott against Germany, was the statement against Germany, was ine statement made by Rabbi Stephen S. Wise, Hon-orary President, and Bernard S. Deutsch, President of the American Jewish Congress, at a newspaper lunch-eon at the Hotel Commodore last Fri-

Dr. Wise read a number of letters which depicted atrocities committed against Jews in Germany. Dr. Wise declared that the reassuring statements made by leading Jewish organizations in Germany were due to coercion. He criticized the German Jews in the United States for exercising pressure on the Congress to desist from its protest, explaining that many of them cannot imagine that Germany, which they had known in their youth as the country of Goethe and Schiller, should have been arned into the country of Goebbels and Goering.

Dr. S. Margoshes urged the newspapermen to report the truth about the developments in Germany. Abraham Goldberg criticized the Washington administration for its attitude of silence.

Rabbi Adolph H. Fink of Spokane, Washington, presided at the convention of the Pacific Northweat Association for Adul Education held in the Temple Emanue El Bullding, Arril 3rd titte board and one of the organizers of the Association which represents the States of Montana, Idabo, Oregon and Washington, Rabbi Fink lectured on the topic: How to Feorest the Librard Thicker.

U. S. Aid to Palestine Falls Below Poland's

(Jewish Telegraphie Agency) JERUSALEM, April 8-The sums transmitted to Palestine from the United States during the last five months equal those contributed during the same period by the small Tewish community of Palestine, it was pointed out here in Zionist circles.

While the United States has undertaken to contribute this year no less than £75,000, the sums transmitted to the Keren Hayesod so far are not more than £3,800. The United States conthan £3,800. The United States con-tributes to Palestine today much less than Poland or England. Whereas it once was at the top of the list of countries collecting funds for Palestine, this year the United States has been shifted to fifth place.

The Executive of the Jewish Agency here is disappointed in the results of the present campaign in the United States, and an intensive exchange of cables is going on between the Jewish Agency and the New York headquarters, in which the Zionist leaders in New York are urged to greater activity.

Nazis Brand Rabbi, Rhineland Refugee

(Jewish Telegraphic Agency) PARIS, April 8-The "Haint," a Jewish daily here, reports from Brussels that a Rhineland rabbi arrived from Germany in a terrible state. The Swas-tika had been branded by Nazis on his face and his beard shaved off.

Invalid Forced to Leave Bed, Beaten by Nazis; Atrocity Toll Rising

Too Ill to Walk, He Is Compelled to Run Gauntlet; Farcical Trial Reported

(Jewish Telegraphic Agency)

LONDON, April 8—A Jewish invalid in a village of Hessen, Germany, was ordered by the Nazis to leave his bed, march through the streets carrying a Nazi flag and to shout "Heil Hitler!". according to a report which appeared Guardian. The Jew pleaded that he was too ill to walk, but under the threats of armed Nazis, he was forced to run through a Nazi gauntlet until he fainted. He was later picked up in a semi-conscious condition and brought home, where he died.

It is untrue, the correspondent of the "Manchester Guardian" points out, that the Nazi terror has ceased. A feeling of terrible despair and panic, he continues, prevails among the Jewish population in Germany. sad chapters in the history of the Jewish people in its 2,000 years in the Diaspora, know of no case where a government prohibited its Jews to make a living and at the same time forbade them to leave the country. While in the larger towns the terror has subsided, conditions in the smaller towns and villages remain frightful.

The paper also relates the farcical trial of a Jewish peddler in Drlin, David Leisten, a man without country. Leisten was tried by the Monbit court for allegedly spreading false rumors regarding atrocities. The State counsel who was supposed to defend Leisten declared he did not wish to offer protection to the accused, that on the contrary, he joined with the prosethe contrary, he joined with the prose-cution in condemning the attitude of Leisten, which, he said, was under-standable, however, if the occupation and the race to which he belongs are taken into consideration. Leisten was

sentenced to a year's imprisonment. The correspondent of the "Manchester Guardian" points out that the atrocity Leisten had referred to is absolutely authentic.

The paper reports another gruesome case in a village in Upper Hessen, where a Jew was beaten by the Nazis. hung by his feet, his head suspended from the ground, and when the Nazis finished their tortures the Jew was dead.

In the Vogelberg region in Upper Hessen many cases of Jewish maltreatment have been reported since the elec-tions. Several Jews are now in the hospital at Frankfurt suffering from injuries they received while being beaten up by the Nazis.

DETROIT, April 8—Tudge Charles Rubiner of the Common Pleas Court was re-elected for a six-year term, receiving 128.272 votes, seainst 116.576 for Former Judge Drake, his opponent, Judge Rubiner's success at the polls was not only a personal triumph for him but was also a defeat for religious prejudice.

(Continued from Page 1) Bismark to take the following message to Germany. Undoubtedly many influ-ential people in England developed a real friendship for Germany since the War. But now they openly declare their sympathies to lie more with France than with the Germans. As long as the German government acts in the fashion it is doing at present it is useless to expect that Germany will receive fair play, which it complains it does not receive because nobody believes the news emanating from Germany which we consider to be officially tainted. The anti-Jewish persecutions are causing irreparable harm in Germany, especially in an economic sense." MacFadden rejected the excuse offered by Prince Bismark that the maltreatment is confined to East European Jews, citing Professor Albert Einstein, Lion Feuchtwanger and Bruno Walter.

"I do not wish to ask Prince Bismark any questions, but I would like him to take this statement back to Hitler," he concluded. The Secretary of the International Law Union pointed out that some of his friends, comprising the most brilliant minds in Germany, have been turned out and if Prince Bismark has

any influence with Hitler, he would ask

icy of mistreatment of innocent men and women in Germany be abandoned. Bismark's intention to convert intellectual England toward Hitler resulted in the opposite effect. The entire audience displayed definite antagonism and instead of being impressed by Prince Bismark's statements, asked him to tell Germany that intellectual England is horrified by the policy of Jewish persecution in Germany. The unanimous condemnation of the policy pursued by the Nazis against the Jews could permit of no doubt in the mind of the Nazi envoy where the sympathies of the leading British circles lay.

Before we can return to their level, we must be sure they seek equality for their own security and to maintain peace and not to threaten the security of other nations, and I say, with the sense of responsibility which must attach to a person who has held the position I have, that it ill becomes Germany to be so narrow or overbearing or exclusive

Hias Launches Campaign for German-Jewish Refugees

At a special meeting of the Board of Directors of the Hebrew Sheltering and Immigrant Aid Society of America (Hias), held yesterday, with Abraham Herman, the president, in the chair, it was unanimously decided to launch immediately a Hias Emergency Campaign for funds in aid of the Jewish refugees from Germany.

This decision was arrived at as a result of the cable dispatches which the Society received from Dr. James Bernstein, its European commissioner, who stated that the Hias offices in Paris and in other European countries were crowded with Jewish refugees who were in terrible straits, requiring immediate assistance. Funds for this purpose, Dr. Bernstein reported, were being raised in Europe and relief was already being given. But in view of the situation, thousands of Jewish refugees being in-volved, the American Society was called upon to collect moneys at once.

The Hias offices in Europe have made all arrangements to receive and provide for the needs of the refugees and everything is being done to help
