Extensive discussion on the rights of the Jews is expected at that time, led by Joseph Paul-Boncour, French Minister of Foreign Affairs, and representatives of some of the smaller resentatives of some of the similar powers. It is also considered likely that Sir John Simon, British Secre-tary of State for Foreign Affairs, may return here in time to participate.

The Iewish Telegraphic Agency is informed that it is not intended to let the Jewish question be considered without an impressive discussion of the treatment of the Jewish nonulation by Germany.

It was learned from authoritative sources that the German representatives spent most of last night in negotiations with Sean Lester, of the Irish Free State, rapporteur on mi-norities, and offered to make a new and more satisfactory declaration regarding Jewish rights in Upper Silesia provided that this declaration would not be followed by a public debate on the question.

The general opinion of the German declaration made by Friedrich von Keller yesterday, in which the onus for anti-Semitic activities in the plebiscite area was put on the shoulders of minor officials, as un-officially expressed in League cir-cles, was unfavorable. This reaction is believed to have induced the Nazi diplomats to offer a new declaration. Mr. Lester, however, indicated that

Meeting of Authors. Riles German Group

(Tewish Telegraphic Agency) RAGUSA, Yugoslavia, May 27 .-The controversy over Hitlerism exploded again today at the Interna-tional P.E.N. Club annual meeting here following a compromise reached carlier on the Jewish question.

H. G. Wells, British author who is presiding at the session, gave the floor to an independent German delegate and permitted him to ad-dress the session. The official Ger-man delegation objected vociferously and left the conference in a body after informing Mr. Wells that its members would not attend the ban-quet tonight in honor of the delegates.

This action was preceded by a heated debate in which the question of Jewish persecutions in Germany was discussed, Mr. Wells ruling that the conference was entitled to discuss political questions as part of the "spiritual strivings of man." The delegates of sixteen countries, in-cluding France, Belgium and Po-land, supported the anti-Hitler motion, but the American and Swiss delegates, and, surprisingly, the Austrian Jewish novelist, Felix Salten, demanded no intervention in the internal policies of Germany.

Vienna Nazi Students Attack Catholic Meeting. Police Enter Grounds (Tewish Telegraphic Agency)

VIENNA, May 27-The Austrian Government today overrode the traditional autonomy of Austrian universities and ordered police to enter the University of Vienna grounds when a gang of Nazi students attacked a celebration of Catholic students at which Chancellor Dollfuss was delivering an address. University buildings hitherto had been free from police intervention except when the rectors of the institutions gave permission.

Three hundred policemen pene-trated the university and occupied posts in the lecture-halls in order to prevent further rioting.

This drastic action had long been advocated in connection with anti-Jewish excesses perpetrated by Austrian student followers of Adolf Hitler. It is hoped that it will make further Jewish disturbances at the university impossible because, once the precedent of police intervention is established, police action will follow whenever peace is threatened.

## Plan to Add Medical School And Hospital to Hebrew U. Plans for the establishment of a

medical school and university hospital at Jerusalem as part of the He-brew University, that will provide for a number of German-Tewish scientists and students who have lost their positions in Germany, were announced Saturday by Dr. Nathan Ratnoff, president of the American Jewish Physicians' Committee, at its annual meeting at the Jewish Club.

The situation in Germany, Dr. Ratnoff pointed out in his report. makes it essential to widen the scope of the Hebrew University in line with the decision of the board of governors of the university last summer. Applications and requests for positions have already been received in large numbers from some of Europe's most distinguished scientists. he said, who are asking "merely for a place to work in peace. They are interested only in securing the barest economic necessities and the assurances that opportunities for study and for intensive research will be made available in a friendly atmosphere."

The committee will launch an appeal for funds for the project, it was announced. Assurances of support already received, it was said, make it evident that the medical school and university hospital will be rushed to completion.

Since its inception, the American Jewish Physicians' Committee, which includes over 500 prominent American Jewish physicians, has been ac-tive in support of the Hebrew University. Its activities include the purchase of a ten-acre plot at Mount Scopus as the site for the medical school building, the maintenance of the Microbiological Institute headed by Professor Adler and the maintenance of the chemical laboratory. Other activities include maintenance of the Dr. Julius Jarcho Medical Library as well as the equipping, in collaboration with the Hadassah Medical Organization, of an X-Ray institute at the university. Judge May Asks Jews Get Behind "Congress"

An appeal to the Jews of Ameri-ca was issued yesterday by Supreme Court Justice Mitchell May, presi-dent of the Brooklyn Federation of Iewish Charities, to accept the invitation of the American Jewish Congress to unite in action in behalf of the Jews of Germany.
"There is no room for dissension

in Iewish life on this point," he declared, "and the demands for unity of action which have been current in the press in recent weeks have received a proper reply in the unity resolution adopted by the American Jewish Congress at the close of the session in Washington."

# Enlisting Mid-West Jews in Relief Drive

Midwestern Tewish communities have been requested to send delegates to a special conference on the German Relief Campaign of the American Jewish Joint Distribution Committee, to be held in Chicago, June 4, Rabbi Jonah B. Wise, national fund-raising chairman of the committee, announced yesterday. The conference, at which the Jews of fifteen states are expected to be represented, will consider methods of making relief available to the Iews in Germany and refugees from that country.

#### Nazi Torture of Jewish Prisoners Is Described By Non-Jewish Refugee (Jewish Telegraphic Agency)

PRAGUE, May 27-Torture of Jewish prisoners in the Oranienburg and Hohnstein concentration camps is described by a refugee here who himself bears unmistakable evidence of the tortures to which he had

been subjected. In an interview with the Neue Weltbuehne, he declared that Jewish prisoners continue to receive worse treatment than political prisoners and are frequently isolated in cells where they are compelled to shout "Heil Hitler", and sing the Horst Wessel song.

This refugee, who is not a Jew, witnessed scenes in which confessions were extracted from Jewish prisoners after they had been beaten with rubber clubs and horsewhips. When one tortured Jew, he said, complained to the commandant of the camp, the beatings he had received were renewed most inhumanly and he had to be taken to the hospital.

When and if a Jew is released from a concentration camp, the refugee declared, he is forced to sign a document asserting that he had not been maltreated. Nazi doctors also issue medical certificates testifying that the released prisoner's wounds were either "self-inflicted" or unconnected with any form of torture.

The stage setting that has been designed for "Romance of a People" will be distinguished by the lavish and spectacular use of color. It will be color "painting" by means of light. Oman and Lienthau, Chicago architects, Paul Bachelor and Mr. Van Grove have worked together on the designing of the stage settings.

#### Reich Jews Divided on Proposed Minority Status (Jewish Telegraphic Agency)

BERLIN, May 27-The question of national minority rights for the Jews of Germany is the most important one of the day for the Jewish population and is being considered by all elements of German Jewish life. Some of the reactions to the question are to be seen in answers to a questionnaire circularized among Jewish leaders by the Israelitisches Familienblatt of Ham-

The replies to this questionnaire concern themselves almost exclusively with the question whether minority rights are acceptable to the Jews of Germany. The Central Union of German Jews, the Jewish War Veterans' Association and the Agudath Israel, orthodox organization, oppose acceptance of minority rights. Georg Kareski, of the Jew-ish Party, declared himself in favor of the proposal.

Heinrich Stern, liberal leader, argues that since the systematic exclusion of the Jews from the German nation is "historically, politically and humanly unjust and unbearable, we must concentrate on the removal of existing disabilities, because the res-toration of citizenship rights, which it is possible to secure as a national minority, is not sufficient. We de-mand also moral and spiritual equality as part of the German nation."

Alfred Hirschfeld, of the Central Verein, declares that being a national minority is a "utopia" for German Jews who are lacking in the usual minority characteristics such as a different language, and their own living culture.

## Rabbi Goldstein Resents Remarks of Cong. Fish to Jews to Shun Communism

Approval of the resolution calling upon President Roosevelt to make representations to the German Government concerning the treatment of the Jews in Germany, introduced in the House of Representatives Thursday by Congressman Hamilton Fish, was voiced yesterday in a broadcast over Station WMCA, by Rabbi Israel Goldstein, of Congrega-tion B'nai Jeshurun. Remarks made by Congressman Fish in introducing the resolution, in which he advised American Jews to shun Communism, "cannot be countenanced, however Dr. Goldstein said.

"The resolution which Congressman Fish proposes to introduce to the House of Representatives, that the American Government should take up with the German Government the question of its anti-Jewish policies, deserves the approval of American Jewry," Dr. Goldstein said. "Congressman Fish wants to know how American Jews feel about the resolution. The feeling can only be one of approval. The resolution should receive immediate favorable action. It is high time that the American Government should speak out, as it has spoken out on previous occasions when Jews were persecuted in foreign lands, beginning with the 'Damascus Affair' in 1840.

(Continued from Page 3) Communism is gratuitous and uncalled for. American Jews, like all citizens, are represented in all political classifications, Communism and Socialism included.

"If Mr. Fish were not known to be utterly free from racial and religious prejudices, his comment might by implication, be construed as half apologizing for Hitler, in suggesting the possibility that the menace of Communism has driven him to his anti-Semitic program. It must be evident, by now, to the entire world, that Hitler and his regime are against Jews, whether they be ca-pitalists or Communists. Jews are dismissed from offices and positions no matter what their political views, and Tewish children are barred from schools no matter what parties their parents belong to. The issue in Germany today is clearly one of anti-Semitism, without reservations or qualifications. Those who confuse that issue with any other issue are offering Hitlerism a loophole. The attempt of the German Government to prevent the bringing up of the Silesian question before the League of Nations, is adequate testimony to its villainy as well as to its coward-"The kind of statement which

would do justice to Mr. Fish would be one such as was published on the same day and was signed by 1,200 of America's leading Christian clergymen. It is the voice of the Christian conscience of America which places the blame squarely where it belongs and sees the issue clearly as a crime against the Jew and as a blot upon Germany's re-putation."
