Alleged Kin of Gov. Lehman Reported Victim of Nazis (Jewish Telegraphic Agency)

AMSTERDAM, June 6 - The death of the Jewish banker. Hofman, in Kissingen, as a result of imprisonment by the Nazis is revealed today by the Labor daily, Het Volk, which claims that the German Foreign Office did everything in its power to hush up the man of New York.

His death, according to the paper, startled Berlin and embarrassed the Foreign Office in view of his relationship to the New York poyernor.

The banker was arrested by the Nazis at Kissingen and died after two weeks in prison, but the family was ordered to announce that he had died of a stroke although only (Continued on Page 2)

German Boxer Gives Share of Admissions To End Silent Boycott

(Jewish Telegraphic Agency) LONDON, June 6-Walter Neusel, German boxer, now fighting in England, has stipulated that twenty percent of the admission fees to contests in which he is taking part must be turned over to the relief fund for German Iews in order to overcome the silent boycott which has been waged against him because he is a German.

Neusel fought before a small audience in Albert Hall last week in a match that should have been wellpatronized. The hall was only half filled because Jewish fight fans would not attend a bout in which a German was taking part.

Daniel Prenn, German-Jewish tennis star who was banned from the German Davis Cup team because of his Jewish origin, is entered in the tennis tournament at Wimbledon. He said he was not playing for Germany but was just a "free lance".

Nazi Government Aids Crippled Film Industry

(Jewish Telegraphic Agency) LONDON, June 6-The German ministry of propaganda and public enlightenment has allotted the sum of ten million marks for a special credit bank to support the rapidly dwindling German film industry, it was learned here today. No Jobs for Jews Under Law Changes Says Nazi; Radio System 'Cleansed' (Jewish Telegraphic Agency)

BERLIN, June 6-"The Jews need not hope that modification of the employment laws will restore Jewish rights to employment. Only those of German blood can be given work," Herr Sprenger, Reich's commissar for Hesse, declared in an address before a Frankfurt massmeeting.

Sprenger's interpretation referred to modifications of the employment laws through which many Jews hoped for reinstatement in certain categories. The present modifications, he said, were of a temporary nature, but the employment law will remain basically the same as is provided in Article 25 of the program of the National Socialist party.

Sixty-seven Jewish lawyers in Frankfurt have been officially notified by the ministry of justice that they will no longer be admitted to

practice in the courts. One hundred and thirty-six em-

the Reichsfunk, the German radio system, in a "cleansing" move, it was announced today. The Reich minister for radio, Krukenberg, in an announcement today promised "complete purification" of the radio system within ten days, but it is as yet impossible to predict the total expected to be affected. So far. all the expelled Jewish employees have been replaced "by men known as fighters for the national revival and proven as qualified to conduct the radio in the spirit outlined by Dr. Goebbels."

was still imprisoned. The paper claims to have learned from a reliable source that anti-Tewish persecutions have been resumed on a large scale in Bavaria, particularly in the small towns and villages. In spite of the reassuring Government announcements that visitors to German health resorts would not be molested, the paper claims, the rabbi of Kissingen has been in prison for three weeks and the synagogue there repeatedly searched. A large number of Jewish citizens there, with whom Herr Hofman was imprisoned, are still in custody, the paper says.

Reached at his office, yesterday, in Albany, by the Jewish Telegraphic Agency, Governor Herbert H. Lehman declared that "so far as I know, I have no relatives in Germany by that name". He pointed out, however, that he has not been in close touch with all the members of his family who may reside in Germany, and that Herr Hofman may be distantly related.

At the office of Arthur Lehman, brother of the Governor, it was said that the Lehman family had a distant relative by the name of Hofman in Germany.. It was said that no word had been received here about the reported death.

Economic Group's Tour To Palestine Announced

Plans for a non-profit making Palestine Tour, designed to enable its members to see Palestine from the inside, have just been completed by the American Economic Committee for Palestine, Israel B. Brodie, the Committee's president, announced yesterday. This tour, Mr. Brodie stated, will leave New York for Naples on the S.S. Conte de Savoia on July 8, proceeding on the S.S. Es-peria to Jaffa, which will be reached on July 19. The tour will spend thirty days in visiting all parts of the Holy Land. It will depart on the S.S. Ganges from Jaffa for Naples on August 17 and will reembark at Naples on the S.S. Conte di Savoia, which will arrive in New York on August 31.

The tour has been arranged especially to meet the requirements of students and teachers. Every phase of Palestine development-agricul-tural, industrial, educational, social and religious-will be studied during the trip.

Chile Opens Doors To 50 Refugee Families (J.T.A. Special Correspondence)

SANTIAGO, Chile, May 25-Permission to bring into Chile fifty lewish families from Germany has been granted by the Government to the Jewish Immigrant Aid Commit-

Epstein, Democrat, was the only candidate elected among the twenty judges who were named, who had not previously held the judicial position.

Former Cossack Poerom Leader En Route to Paris on Secret Mission (Jewish Telegraphic Agency)

MONTREAL, June 6-A former Cossack commander, under the Pogrom Ataman, Semeonoff, yesterday mission to the Russian "emigre" organizations whose headquarters are

The commander is Col. Boris Oulianoff, who led a detachment of Cossacks and helped in the formation of the short-lived Far-Eastern Republic after fighting the Germans, Austrians, Turks and afterwards the Bolshevist Red Army. After the anti-Soviet debacle, together with thou-sands of other former Czarists, he found refuge in Mukden and Harbin. Now, according to this former pogrom leader, the situation of the Soviets has again been made insecure by the threatened invasion of the Japanese. He worked his way over the Pacific and intends to do the same for the rest of the journey but refused to state the purpose of his mission.

Canadian Industrialist Excuses Hitler Excesses (Yewish Telegraphic Agency)

MONTREAL, June 6-The cause of Hitlerism has received a prominent champion in Canada in the person of Sir Newton Moore, president of the Dominion Steel & Coal Corporation, who has recently re-turned from a business trip to Europe. According to him, Hitler deserves the thanks of the Western nations for his proscription of communism against which Germany is now the first western bulwark. He also discounts the persecutions against the Jews.

"I am satisfied", Sir Newton stated, "that the reports of the persecution of the Jews have been exaggerated. The spear-head of the attack was against the Communist Jews from the East who invaded the country in large numbers after the war, and through the mistaken policy of the Republican government were given German citizenship. I feel to regard with a reasonable amount of Pennsylvania, who declared interof tolerance the early excesses which are bound to occur in a revolutionary movement. I am convinced that a spirit of optimism is renewed in Europe", he concluded.

Washington Conference Asks President to Act For Jews of Germany (Jewish Daily Bulletin)

WASHINGTON, June 6-Resoluintroduced in the House of Repreattorneys headed by Elihu Root and Bainbridge Colby. United Hebrew Trades Aids HIAS Relief Fund

Under the auspices of the United Hebrew Trades, with which seventyfive unions are affiliated, the International Ladies Garment Workers Union, the Amalgamated Clothing Workers Union and other labor hodies, representing a membership of a quarter of a million, a Trade Union Committee representing all the Jewihs labor unions in Greater New York has been formed in support of the Hias Emergency Fund for the Relief of Jewish Refugees from Germany. This fund has been created by the Hebrew Sheltering and Immigrant Aid Society of America (HIAS) for the purpose of assisting the more than 50,000 Jews who have fled from Germany.

He expressed the hope that all who had suffered in Upper Silesia as a result of discriminatory legislation and methods would be restored to their rights and that the rapporteur would watch all meas-ures to be applied to this end.

The Czechoslovakian representative, Dr. Stefan Osusky, pointed to the record of toleration toward the Jews in his country since the thir-teenth century. Prague, he said, possessing the oldest synagogue and cemetery, "respects the rights of the living as well as of the dead." He hinted that the whole question of the Jews in Germany would be brought up at the next session of the Council, which will be held in September.

Captain Anthony Eden, Under-secretary of State for Foreign Affairs, and British representative at Geneva, expressed gratification at the progress thus far made and hope that this progress will continue until a final solution of the German Jewish problem is reached. The Norwegian delegate also stated he hoped for further progress.

Followed Long Negotiations

The Jewish victory here today followed prolonged negotiations of the powers with Germany to move the Reich to abandon its stand that the League should consider itself satisfied with the previous German declaration.

League circles are highly pleased League circles are highly pieased with the German defeat hoping that this, indirectly, will make Germand on other important world problems before the League, and also in her treatment of the Jews within the Reich proper.

In closing the discussion, Mr. Lester said he was sure that the League Council would not again have to consider the Upper Silesian question since Germany will adhere

to its obligations.
