### American Jewish Congress To Appeal to League to Aid Jews of Germany

A petition will be presented to the League of Nations by the American cign Friends of Hitler Movement" Jewish Congress, through Dr. Leo Motzkin, chairman of the Committee of Jewish Delegations, and Dr. Emil Margulies, Czechoslovakian Jewish leader, who presented the Bernheim netition to the League, requesting the League Council to extend its jurisdiction over anti-Semitic discriminations beyond Upper Silesia to include the whole of Germany.

The American Jewish Congress will also anneal to the British Government, requesting it to introduce the subject at the next session of the Council, which will be held in September.

The petition to the League of Nations will be based on the moral and legal grounds implicit in Article 4. section 5 of the League Covenant, empowering the League to act on "any matter within the sphere of action of the League or affecting the peace of the world".

# No Jewish Attorneys

For Berlin City Cases (Jewish Telegraphic Agency) BERLIN, June 8-Berlin city in-

stitutions must not be represented in the courts by Jewish lawyers, according to an order of the Nazi state commissar, Hafeman, made public yesterday. The order, issued in the name of the mayor of the city, declares that the list of approved attorneys compiled by the municipality officials for the guidance of city institutions, has been abolished. Any lawyer at all may now be retained, providing that he is "Aryan".

The list, the order explains, was aimed to take out of the hands of Jewish attorneys all municipal law cases, and to put them in the hands of "Arvans". This aim has now been accomplished.

#### All Jewish Activities In Cuba Suspended by Police Ban on Meetings (Jewish Telegraphic Agency)

HAVANA, June 8-The Jewish colony here is very much perturbed over the action of Brigadier Frederico Rasco, military commandant of Havana, who prohibited all gatherings, conferences and even directors' meetings of the Tewish institutions here without any exceptions. At the same time permits are issued to non-Tewish organizations to hold public meetings.

The prohibition of Jewish meetings was first issued May 16. when the Jewish colony prepared to hold a protest meeting against the anti-Jewish persecutions in Germany. It later become known that that prohibition was a result of reported intervention by the German Minister in Cuba, who asked the government to suppress the protest

## Toscanini's Name to Be

In J. N. F. Golden Book

The name of Arturo Toscanini will be inscribed in the Golden Book of the Keren Kayemeth Le Israel (Jewish National Fund) for his refusal to direct the Wagnerian Festival at Beiruth later this month as an expression of protest against the discriminatory policies of the Hitler regime in Germany. One hundred pages in the Golden Book are devoted to inscriptions of the names of distinguished Jews and non-Jews who have rendered unusual services to the cause humanity and the upbuilding of Palestine as a Jewish national home.

A message was sent to the famous maestro at Milan yesterday by the Tewish National Fund informing him of the decision to inscribe his name and applauding him for his action.

Stressing the duties of the social worker, Dr. Rubinow declared that "it is the duty of the Jewish social worker, the trained professional servant and spokesman of that community, to make for a healthy, intelligent, self-respecting lewish community as a setting in which there can grow up a healthy, happy, integrated Jewish personality, and which as a whole can make its constructive contribution to the life of the American Nation of which we constitute an integral, permanent even though distant part."

The social worker must also assume the "role of competent interpreter of his own group to the surrounding macrocosm," Dr. Rubinow pointed out. He dare not avoid this duty, he said. "It is his because of his assumed training and competence in applications of social psychology. It is his because of his familiarity with the needs of the minority. It is his because of his contacts with the civic leadership of the community as a whole." Education Council Program

#### Klemperer Not German Spirited Says Nazi Press

(Jewish Telegraphic Agency) BERLIN, June 8-Otto Klemperer, world-known Jewish conductor, who was ousted from his position as director of the Berlin State Opera yesterday by Minister of Education Bernhard Rust, is highly gifted, the German press declares, but is not fully German-spirited and hence, despite his acknowledged genius, cannot

continue in the State Opera post. Herr Klemperer received the news of his dismissal at Budapest, where he is acting as a guest conductor. His contract with the State Opera was to have expired in September. 1937.

#### Government Opponents May Base Their Fight On Anti-Jewish Program (J.T.A. Special Correspondence)

SALONICA, May 27-M. Mayados, a candidate in the electoral division of Salonica, filed a protest against the results of the elections on March 5 in Salonica, immediately after the elections, basing his protest on the grounds that the Germany, will discuss relief needs separate electoral college for the Jews is unconstitutional. pression throughout the country. The electoral battle, both legislative and electoral, which will take place at the same time at Salonica, has already begun. The opposition parties, the most important which is the Venizelist party, are dissatisfied with the abolition of the separate electoral college. certain circles of the opposition the idea has been entertained of conducting the battle on religious grounds. If this idea is adopted. the opposition bloc will form a Christian list and fight the Government candidates with an anti-Jewish program. No decision has as yet been taken, however, on this point.

The Government party will include three Jewish candidates in their lists.

(Continued from Page 1) the Zionist organization, the Jewish Center, the Jewish Women's Society, the Tuberculosis Committee and the Union of Representatives of all Jewish organizations, asked the government for permits to hold their annual elections of officers. but the military commandant refused to allow any Jewish gatherings without giving any reasons.

A Jewish delegation was told by the government that the Jewish meetings are prohibited because it was feared that they may be turned into anti-Hitler protests, which the Cuban government is determined to prevent.

The Cuban Minister of Foreign Affairs, Dr. Orestes Ferrara, who has often intervened in behalf of the Jews, is now on the way to London as Cuban representative to the world economic conference. Several Jewish leaders have appealed to General Herrera, Cuban War Minister and acting Foreign Minister, asking him that prohibitions of Jewish meetings be rescinded. General Herrera promised to intervenc with the military commandant concerning the Jewish request.

Despite this promise, the military commandant, however, refused to allow the Tuberculosis Committee to meet to hold its annual elections of

officers.

The Jewish population is concerned over the situation created. All contact between Jewish leaders for consultations are impossible because of the state of martial law according to which no three persons may gather without a special permit. The correspondent of the I.T.A.

was promised an interview with Brigadier Rasco in order to secure information concerning the new attitude toward the Jewish Comanunity.

#### German Envoy Attempts To Muzzle Greek Press

(J.T.A. Special Correspondence) ATHENS, May 27-M. Einselohr, German Minister at Athens, has anproached M. Maximos, Minister of Foreign Affairs, and has expressed his surprise that certain newspapers, in particular Jewish newspapers, have lately been employing unsuitable language against Chancellor Hitler of Germany. As a result of this. M. Maximos held a telephone conversation with the Governor General of Macedonia, who called together the directors of the Jewish papers and made certain recommendations

to them with the purpose of avoiding injurious expressions about the Berlin government. Greece, he said, had a great interest in maintaining friendly relations with Germany. The representatives of the Jewish press replied that the situation was such in Germany, where efforts were being made to annihilate 600,000 innocent Jews, that they could not hide the facts from their readers nor refrain from joining the protests of the entire civilized world. "This must be the next step of the League", the statement says. "It cannot, we maintain, as the arbiter of international law and morality. limit by territorial divisions within one and the same country the application of a principle which it condemns."
