Dr. Rubinow Makes Plea For Help of German Jews At B'nai B'rith Convention (Jewish Daily Bulletin)

CHICAGO, July 3-Dr. I. M. Ru-binow, sccretary of the executive committee of B'nai B'rith, delivered a stirring address at this morning's session of the 65th convention of the Sixth District, B'nai B'rith, at La Salle Hotel here.

Discussing the plight of German Discussing the plight of German Jewry, he declared that immediate relief is necessary there, as thousands are reduced to absolute starvation. Money must be raised and dispatched without delay, he asserted. The next important thing, he said, is to find a place which could be used as a haven for recould be used as a haven for refugees. In the latter connection Dr. Rubi-

now suggested that efforts be made to extend the German immigration quota to this country to permit the entry of German Jewish refugees.

Marco Nadler, a confectioner, from Alexandria, Egypt, who is in Chicago to attend the Century of Progress Exposition, made an impassioned plea before the convention for an economic boycott against Germany. Nadler stated that in Egypt such

Exodus of German Jews Intensifies Border Control: Thousands Seek Zion Permits

In Many Western Towns Not a Single Eastern European Jew Can Be Found

(Jewish Telegraphic Agency) BERLIN, July 3-The exodus of Jews from Germany has assumed such proportions that in many western German cities and towns not a single eastern European Jew can be found, it was reliably re-ported from Essen yesterday.

The Jewish Agency Office in Berlin has announced that it cannot accept new applications for immigration to the Jewish homeland because it is already flooded with thousands of requests with which it is unable to deal, in view of the limited number of certificates received from the authorities in Terusalem. 142 AMERICAN COLLEGE PRESIDENTS AND 77 SOCIAL SCIENTISTS SEND GERMAN COLLEAGUES PROTEST AGAINST INTOLERANCE

In a "statement of belief" addressed to the hade of every institution of higher learning in Germany, 142 presidents of celleges and universities and 77 of this country's leading social scientists in every section of the United States have signed a declaration inspired by the recent political developments in Germany affecting Jewish and other minority elements, which is today being forwarded to the German educators by the National Conference of Jews and Christians.

The statement, originally worked out and signed by the social scientists and later concurred in by the college and university presidents, notes that minorities are suppressed and discriminated against to some degree in every land. It then pro-ceeds, "But the growing interdenendence of the world makes it appropriate that individuals far from Germany should express their concern about the intense anti-Jewish campaign. As different cultural and racial groups come into close con-tact with one another, conflict is a frequent result. There are always those who want to destroy, or render impotent those who greatly dif-fer from them. Such an effort is likely to be an emotional and not a rational reaction, and is diametrically opposed to principles of sound statecraft.

German Citizenship Denial For Jews Seen in Forecast (Jewish Telegraphic Agency)

BERLIN, July 3—German Jews will undoubtedly lose their German citizenship if the project outlined at Dresden by the Reichstag Deputy Stiehler, at a mass meeting attended by 70,000 Nazis, materializes.

Stiehler, who is the chief of Saxony's Labor Front, in which both labor unions and employers are included, declared that only the producing elements, to which the Jews as a matter of course cannot belong, can be included in the Labor Front, only members of which are eligible

Not Even Roosevelt Can Make Us Change Our Ways, Asserts Nazi Paper in Attack

Anti-German Attitude, Says Deutsche Nachrichten, Forcing Luther Out

(Tewish Telegraphic Agency) BERLIN, July 3-Nobody-not even Franklin D. Roosevelt, president of the United States-can induce Germany to change its attitude toward the Jews, declared Berlin's Deutsche Nachrichten today in article attacking President Roosevelt.

Attacking the American president as an outspoken friend of the Iews. and as an anti-German, the newspaper hinted that the atmosphere in Washington of late has been unfriendly to the German ambassador, Dr. Hans Luther. Due to this unfriendliness, the paper said, Dr. Luther will soon be compelled "to return to Germany for a prolonged stay."

The appointment of Jesse I. Straus as ambassador to France was also remarked upon by the Deutsche Nachrichten as additional proof of President Rosevelt's anti-German and pro-Jewish orientation.

Anglo-Jewish Association Hears Hindenburg Criticized For Ignoring Jews' Plight

(Jewish Telegraphic Agency) LONDON, July 3—Criticism of President Hindenburg for interven-ing with Chancellor Hitler on the question of Nazi interference with the Evangelical Church and yet passing over in silence the persecu-tion of German Jews was expressed here yesterday by Leonard Stein, presiding over a meeting of the Anglo-Jewish Association.

Describing the deepening gloom and anxiety felt by German Jewry over Nazi aggressiveness in anti-Semitic work, Mr. Stein pointed out that at present the Hitlerites are avoiding the conducting of their anti-Jewish activities with the pub-licity they delighted in giving it a few months ago, but instead are preferring to do their destructive work in silence and secreev. Therefore, he declared, the most effective and irresistible weapon of Jewry would be to force the public opinion of the civilized world to prevail upon the Nazis to stop their anti-Semitic campaign.

Sephardic Jew's Arrest Leads to Rumor He Has Clue to Murder of Arlosoroff (Jewish Telegraphic Agency)

JERUSALEM, July 3-The arrest here yesterday of a humble Sephardic Jew on unknown charges caused a rumor in the press here that he was connected with the scarch for the murderer of Dr. Chaim Arlosoroff. One paper said it has information that the Sephardi resembled the description of the assassin given by Mrs. Arlosoroff.

Police here, however, informed the Jewish Telegraphic Agency that the rumor was without foundation. In any case, they hinted, it would be difficult to imagine what connection an obscure Sephardic Tew who has no political connections would have with Dr. Arlosoroff's slaving. Authorities are still continuing their quest for the man or men who were responsible for the tragic death of the young Zionist leader.

Greek "Political Chetto" Ended. But No Jews Wins In Parliamentary Election

(Jewish Telegraphic Agency) SALONICA, Greece, July 3-Jewry's fight in Greece for a franchise in parliamentary voting resulted today in not one single Jew being elected to the Greek Parliament. Previously, under the separate electoral college system, Jews were sure of a representation of two delegates.

Eleutherios Venizelos, who vigorously opposed the abolition of a separate Jewish electoral college in Salonica even though proportionate representation was introduced the country over, came out victorious in this city's voting today. Since not one Iew was included on his lists. not one will go to parliament.

The election here, which was held vesterday, was caused by the annulment of the previous election by the Tsaldarists, who on coming into power in March declared Salonica's separate elections illegal and ordered another to be held.

In spite of Jewry's failure to secure parliamentary representation this time, leaders are satisfied with the principle, which gives Jewish voters a chance to exercise their influence on the results of the general that the next step will be to declare election. U.S. Jewish War Veterans Thank Gentile Fighters Against Nazi Terrorism

In Convention, Resolve to War on German Trade and Commerce Until Hitler Goes Down

(Jewish Daily Bulletin) ATLANTIC CITY, N. J., July 3— Delegates to the annual encamp-ment of Jewish War Veterans in session here today passed a resolu-tion thanking Charles M. Schwab, Arturo Toscanini, James W. Gerard, General Charles R. Sherrill and Chancellor Dolfuss of Austria for their fight against Hitlerism.

The delegates also approved the committee's decision to seek the endorsement of Samuel Untermyer as representative of all American veterans at the forthcoming conference

in Geneva A resolution was approved asking General Sherrill to withdraw American participation from the Olym-pics in 1936 unless they are held

outside of Germany. Resolving to wage an unremitting and relentless war on German trade and commerce until the Hitler government is overthrown, the delegates also condemned American

Nazi Ordinance Seen to Aim At Extinction of Communal Life of Jews of Germany (Jewish Telegraphic Agency)

BERLIN, July 3-The Jewish community here, which has had a recognized official status, is in danger of losing that status, with the implied right of collecting taxes and applying them to social and communal purposes.

This is expected to result from the authoritative opinion expressed today in connection with this morning's official ordinance providing that statutory religious institutions must not employ Jews. In view of the fact that the Jewish community is such an institution, it is feared the Jewish community a private organization, which would entail the loss of its public rights.

Today's press, in featuring the ordinance in the official gazette, declares it an intensified application of the Aryan paragraph in the Nazi code, but refrains, however, from more extended comment

(Jewish Telegraphic Agency) BERLIN, July 3-A compromise regarding the Jewish question need not be expected in Germany, Chancellor Hitler indicated yesterday when addressing the first meeting of leaders of the storm troopers and steel helmets at Bad Reichenhall, Bavaria, near the Austrian border.

The race principle must be taken as the basic principle for the success of the German revolution, and it must be strictly adhered to, Hitler declared.

(Jewish Telegraphic Agency) BERLIN, July 3-Julius Brodnitz president of the Central Union of German Jews, and a well-known legal counsel, has been expelled from his profession, the Hitler government announced vesterday.

A list of 61 other Jewish lawyers practicing in Berlin also was released, and they too were officially banned from doing any law work in Germany hereafter.

(Tewish Telegraphic Agency) BERLIN, July 3-Germans married to Jewish women or women of Jewish origin, or German women married to men of Jewish origin, must not be appointed government officials and should be dismissed from their posts if already engaged, according to an official government ordinance published in this morning's Reichs Gesetzblatt.

In the future, said the ordinance, persons of non-Aryan origin must not be employed in Reich, federal, communal or municipal enterprises. The ordinance further declared that railroads, the Reichsbank and religious bodies having public relations must not engage Jews. Further details regulating these categories would be released at a later date, the ordinance concluded.
