American Zionist Manifesto Urges Support of Congress Slate, Embodies Program

A manifesto to the Zionists of America embodying the program which the delegates of the Zionist Organization of America will follow at the World Zionist Congress which will open in Prague in August was issued last night at a meeting of New York Zionists in the Hotel Pennsylvania.

The meeting was in preparation for the nation-wide election of delegates which will take place June 16 and support of the organization's ticket was urged by Morris Rothenberg, president; Louis Lipsky, Morris Margulies, secretary of the Z.O.A., and Abraham Goldberg, member of the Administrative committee.

The coalition ticket, half of which was named by the Hadassah pursuant to an agreement reached between the Zionist organization and the women's group, is as follows:

Sefer Torah Brought To Spain by Refugee

MADRID, July 11—An impressive ceremony of thanksgiving today accompanied the installation in the Madrid Synagogue of a valuable old Sefer Torah (holy scrolls) brought to Spain for safekeeping by a German-Jewish refugee. The synagogue was filled with worshippers when the formal handing over of the Sefer Torah took place.

Many persons at the ceremony saw it as a symbolic act, reminding them of the time when Jews once were expelled from Spain and Sefer Torahs were carried, homeless, from land to land. Now they have all been brought back to this country.

Swiss Confiscate Zion Protocols as Jews Move Against Anti-Semites

BASLE, Switzerland, July 11—The authorities here yesterday confiscated 761 copies of the "Elders of Zion" protocol from the headquarters of the reactionary, anti-Semitic National Front. This organization, it was discovered, had been engaged in distributing the spurious protocols.

Since according to Swiss law only the insulted party could bring action, Julius Dreyfus Brodsky, president of the Jewish community, and Dr. Marcus Cohn brought action against the National Front in their names. They charged this group with distributing outrageous falsifications libelling the Jewish people.

The trial is expected to be held shortly.

Meanwhile a mass meeting called by the National Front proved a double-edged sword. Fifteen hundred persons attended the meeting, but shortly after their arrival they moved that a resolution be passed overthrowing the chairman, and they appointed their own chairman in his place. The latter proclaimed amid generous applause that the meeting would be held with the devotion to the principles of democracy uppermost in everyone's mind.

Two Arabs Arrested In Arlosoroff Murder

JERUSALEM, July 11—Two Arabs were arrested today in connection with the murder in Tel-Aviv on June 17 of Dr. Chaim Arlosoroff, noted Zionist labor leader.

Two Jews, Abraham Stavsky, a member of the Zionist Revisionist group, and Yehuda Mintz, a member of the Brith Trumpeldor, Revisionist youth organization, are also under arrest in connection with the crime.

Jewish Merchants Liquidate Businesses In Face of Nazi Drive

BERLIN, July 11—Despite the recent government declaration of a policy of non-interference with business, the German Nazi drive against Jewish merchants has resulted in their voluntary liquidation of their businesses in many places. This is particularly true in the provinces, where Jewish merchants have liquidated rather than face the alternative of daily picketing of their stores by Nazi storm troopers.

Following last week's panic among Jewish merchants in Dortmund as a result of the reintroduction of an official anti-Jewish boycott, many Jewish firms in that city have closed down altogether. As a result, many non-Jews have been thrown out of work. So many Jews are fleeing Dortmund that the last three Jewish schools there have shut their doors for lack of pupils.

Side by side with the movement against Jewish merchants, Jewish peddlers have been driven from the market places of many towns and cities. In Leipzig the movement against Jewish peddlers has reached such proportions that they are permitted to trade at present only on one street. Thus they are practi-

Agents Spy on Jewish Refugees Says Nazi Sheet

BERLIN, July 11—An admission that German agents are spying on Jews abroad was made today by the Deutsche Woche, Nazi organ, in the course of an article which tried to create the impression that the entire anti-German boycott in foreign countries is being carried on at the initiative of German Jews who fled their homeland under Nazi persecution.

Reproducing several printed boycott appeals which appeared in foreign newspapers, the Deutsche Woche claimed that "this is the work of Jewish industrialists and financiers, from Germany, upon whom we must keep a watchful eye." The paper hinted that if the boycott continues the Jews still remaining in Germany will be made to pay a high price for it.

Jewish School Children May Observe Sabbath Education Ministry Rules

(Jewish Telegraphic Agency)

BERLIN, July 11.—The action of individual German schools in refusing Jewish pupils the right to stay away from classes on Saturday and in some cases compelling them to write on the Sabbath was corrected yesterday by an order from the ministry of education. The order stated that religious liberty still exists in Germany's schools.

Jewish children should be excused from school on Saturday, if their parents insist, the order stated. Children also should be excused from writing on the Sabbath if they so desire, the order further declared.

The ministry of education added, however, that as a result of the granting of religious liberty the schools would not be held responsible if Jewish children fell behind in their work.

Saarbrücken Tribunal Upholds Ritual Charge

PARIS, July 11.—An anti-Semitic flourish by the Saarbrücken tribunal today created a painful impression in France, for that city until now has been considered free from Nazi domination due to the fact that it is an independent territory.

The Saarbrücken tribunal, however, tried a local bookseller on the charge that he displayed in his shop obscene anti-Semitic literature, including the well-known "ritual" accusation. The tribunal's president, M. Messinger, dismissed the case and declared that "the Jewish ritual practice was not an endorsement of public disorder, but was a fact."

Nazis Oust Jewish Metallurgists, Then Name Them As Advisors

BERLIN, July 11.—A curious incident in the campaign of "purifying" Germany of Jewish influences occurred here yesterday when all Jewish members of the executive committee of the metallurgical industries organization were ousted from their posts and replaced by Nazis. As soon as this was done, however, it was realized that the move left the association without experts and the new executive committee thereupon decided to appoint an advisory committee to which, cautiously enough, they elected the six Jews who had been their predecessors on the executive committee.

These men are Paul Friedmann, well-known as a director of the Stas & Friedmann Company; Carl Goldberg, of Levy, Stern & Company; Moritz Hoffmann of the Hirsch Oer and Metal Company; Dr. M. Lissauer, of Lissauer & Company; Adolf Schöper, of the H. Schöper Company, and Ludwig Stern of the Oskar Reier Company of Frankfurt.

Zeire-Agudath Israel Pledges Palestine Aid

A number of resolutions pledging aid in the upbuilding of Palestine and providing for the establishment of a committee to carry on educational work in this country were adopted Monday evening at the closing session of the Zeire-Agudath Israel convention held at the Broadway Central Hotel.

The convention also decided to begin a drive for new members, particularly among young people, to work for Sabbath observance, kosher and the New York yeshivas.

New officers elected at the closing session include Isaac Strahl, president; Israel Wilkowitz, vice-president; Meyer Sanft and Morris Bernstein, secretaries, and M. Gluck, treasurer.

Huge Sign Barring Jews Arouses Ire in Hamilton

TORONTO, July 11.—Jewish residents of Station 6 Beach, near Hamilton, Ontario, were incensed yesterday when they found on the beach a sign, eight feet square, saying: "No Jews Allowed on Shore Within 500 Feet Either Way of This Sign."

Police, when informed, had the sign taken down, and they are now trying to discover the persons, believed to be Hitlerites, who put it up. The City Council of Hamilton has ordered an investigation.

Tangiers Jews Warn Against Nazi Agitation For Modern-Jewish Strife

MADRID, July 11.—Nazi-fanned propaganda campaigns in Spain and Spanish Morocco are being strongly felt by the Jewish communities. While here in Spain the Hitlerite propaganda has resulted only in attacks on Jews in the press, in Tangiers it has assumed the form of periodically-recurring physical violence. Arabs usually are the instigators of these attacks against members of the Jewish community.

All this has prompted the Jewish community in Tangiers to publish a statement yesterday in which it was said that "strange elements are making efforts to provoke quarrels between Moslems and Jews." The Jewish community begged the Jewish population in Tangiers to ignore all provocations, which, it was said, were aimed solely to spoil the existing pleasant relations.

Lay Cornerstone for New Hebrew Yeshiva

JERUSALEM, July 11.—The cornerstone for the new Yeshiva in Hebron was laid yesterday in the presence of representatives of the Palestine government and prominent Jewish institutions.

Hechal Harbutza, of the Jewish Agency, Rabbi Uziel and other well-known persons spoke. Abdallah Kardous, Hebron district officer, addressed the gathering and said that the achievements of one community would be helpful to the development of surrounding communities.

"I hope Arab-Jewish relations are improving," said Abdallah Kardous.

Canadian Revisionists Boycott Congress Voting

TORONTO, July 11.—Even though the World Zionist Organization eight days ago permitted the Revisionists' vote in Canada, where hitherto they had been banned, that party will not take part in the election of delegates to the World Zionist Congress, it was learned yesterday. The elections throughout this country are scheduled to take place tomorrow.

The headquarters of the Revisionists in this city has had instructions sent to all branches in Canada to refrain from voting in the elections. It is believed that the Revisionists have decided that eight days' time was not sufficient to draw up a slate of candidates, and therefore they have told members to refrain from voting as in former years.

man, David Podolsky and Israel R. Brodie.

A vote for the Zionist ticket, which is labeled No. 1, means a "vote to party warfare and Dr. Chaim Weizmann returned to his place" in world Zionist leadership, the manifesto issued last night says. It means also "a progressive, liberal economic policy based upon social justice" in Palestine.

The delegates of the Zionist Organization of America to the World Congress will be pledged to the following program, according to the manifesto:

"First, the four year plan to settle 250,000 Jews in Palestine (chiefly German Jews), with an internal loan from Jews the world over, and an appeal to the nations for political and financial co-operation.

"Second, a coalition Zionist Executive on the four year plan, with a treaty to party warfare, and Dr. Chaim Weizmann returned to his place in such leadership.

"Third, a progressive, liberal economic policy based upon social justice.

"Fourth, co-operation with the Mandatory Government; vigorous advocacy of our rights under the Mandate; against the Legislative Council; our promised rights to a fair share of employment in Palestine public works.

"Fifth, the strengthening of our national funds, Keren Hayesod and Keren Kayemet, as indispensable for the creation of a National Home; priority of allegiance to the national funds by all Zionist parties and factional organizations.

"Sixth, the stimulation of private initiative and its guidance in service to the national interests.

"Seventh, arbitration of differences between employers and employees; Jewish courts to settle Jewish disputes.

"Eighth, a vote for List No. 1 is a vote in favor of maintaining the supremacy and integrity of the Zionist Organization and a rebuke to the Revisionist claim of right to carry on independent political activities; no divided allegiance to the Zionist Organization; the Zionist Organization is a world movement dedicated to the objective described in the Basic program and not a loose federation of organizations, coming and going as Zionist Congress decisions please or displease them."

Opposite Congress Branch in Utah

SALT LAKE CITY, Utah, July 11—A branch of the American Jewish Congress has been organized here by leading Salt Lake City Jews.

Kashruth Association To Call Convention For Supervisions Plan

At a meeting of the committee of 100, the governing board of the Kashruth Association of Greater New York, held Monday night at the Broadway Central Hotel, it was decided to convocate a city-wide convention of the presidents and representatives of the 1,380 orthodox congregations in New York City for the purpose of considering the kashruth question and in order to advance the centralized and uniform community supervision plan for kashruth, for which the orthodox rabbinate and many noted laymen here have devoted the last two years through the medium of the Kashruth Association.

According to Rabbi Nachman H. Elkin, who acted as chairman of the meeting, the Kashruth Association is determined to guard the interests of the kosher-consuming public in connection with the formation of trade organizations and the drafting of fair competition codes for submission to the National Industrial Recovery Administration. "Steps will be taken," said Rabbi Elkin, "to present the point of view of the consumers and the interest of the Jewish community before the National Administration approves the codes which are to govern trade practices in the several branches of the kosher industry and to regulate prices of Kosher food-stuffs at a higher level than the prices affecting non-kosher food-stuffs."

Ben-Zvi on Executive

JERUSALEM, July 11—The Labor party have agreed yesterday to I. Ben-Zvi, Palestine labor leader, as a new member of the Jewish Agency Palestine Executive. He will officially join the Executive in a few days.

The vacancy on the executive was created when Dr. Chaim Arlossoff was murdered. Ben-Zvi, like the late Dr. Arlossoff, is an outstanding labor leader.

Mourning Period Began

The "Three Weeks" period of mourning over the destruction of Jerusalem began yesterday with Shabbat Aser be-Tamuz, the day of fasting which commemorates the siege of Jerusalem. The "Three Weeks" and with another fast day, Tishab be'Av, which this year will be August 1. During this period it is forbidden for the orthodox to eat meat, to celebrate marriages, to bathe and to cut the hair.

cally enclosed in a ghetto, as in the middle ages.

Tiara Owners Eliminated

The Jewish owners of the Tiara Stores, with branches in several cities, have been disowned and the administration of their business has been transferred into government hands "as a means of developing healthier economics and eliminating social abnormalities."

The small number of Jewish employees remaining in the Tiara Stores were immediately dismissed as soon as the special commissar, who hitherto will direct the business, took charge.

Prior to taking over the business the government imposed a high tax which the Tiara Stores were unable to meet. This gave the government its legal excuse to step in and take over the business. The ultimate aim of the government is said to be to transform all department stores into small business run by independent small traders, who will of course be Aryans.

Samuel Niger, Yiddish Writer, 50 Years Old

Samuel Niger, renowned Yiddish critic, politician, lecturer and cultural worker, was fifty years of age yesterday. This fact was brought to light by a congratulatory cable addressed by Simon Dubnow, famous Jewish historian, and Daniel Charney, poet and younger brother of Mr. Niger, to The Day, where Mr. Niger is now a staff writer.

Mr. Niger was born in 1883 into a Chassidic family of Dubno, in the province of Minsk. His interest in world affairs and in the Zionist movement in particular were aroused while he was still a young rabbinical student. He became a member of the first Poale Zion group founded in Minsk and later was one of the founders of the Zionist Socialist Party. On account of his party activities Mr. Niger served several prison terms in Warsaw, Vilnius and Odessa. As editor of The Day in Wilno in 1918, he was court-martialed together with A. Weiler, writer, and the poet, Leif Jaffe, who is now at the head of the Keren Hayesod in Palestine. Writer was shot by the Polish legationists, while Niger and Jaffe were deported to Lida. Thanks to the efforts of Jewish leaders, these two Jewish writers were saved from death. Niger then came to America and made his home in New York.

Mr. Niger did his first writing in Hebrew and Russian, later devoting himself entirely to work in Yiddish. He is best known as a literary critic, but has also written many articles and essays on other subjects. Only a small part of his work has been published in book form.

Besides writing for The Day, Mr. Niger has edited the New York Kinder Journal since 1921, and contributes frequently to various periodicals in this country and abroad.

Rabbi Klein of Berlin To Arrive Here Friday

Rabbi Dr. Herman Klein of Berlin, one of the leading rabbis in Germany and well known in this country for his many scholarly works on Jewish subjects in both Hebrew and German, will arrive Friday from Europe on the Berengaria. Rabbi Klein comes to the United States as the guest of the Central Relief Committee, and is to be the principal speaker at the annual convention of the Agudath Mithkenim.

A representative delegation composed of American rabbis and officers of the Central Relief Committee will extend a welcome to Dr. Klein at the ship.
