Revisionists, Others Jailed in Palestine as Police Seek Revolutionary League

(Jewish Telegraphic Agency)

JERUSALEM, July 23 — More than twenty Revisionists and British Transjordanians were arrested in various parts of Palestine yesterday. Police took into custody seven persons in Tel Aviv, including Dr. Hilar-aron, Aba Achimsir and Lichter, manager of the newspaper, Haaretz Ha'am. Among those arrested in this city were Advocate Avnith and his wife. Six persons were arrested in Kfar Saba, five in Nathania and a number of others in Ramat-gan and Kalamia.

Altogether, there were ten persons arrested here in Jerusalem, and four were quickly released after being interrogated by the police. The release of persons arrested in other places is expected shortly. It was learned that each of the persons taken into custody was asked if he belongs to the British Biryounin, or Revolutionary Zionist League. Police have long been suspecting the existence of a Revisionist terrorist group under this name.

One of the men quickly set free in Jerusalem was Yovlin. Only two of the ten were detained, four being set free on bail of 200 pounds each besides the other four who were released unconditionally. One man was detained for further questioning.

German-Americans Klited by J.T.A. Ban, Says Nazi Paper

LONDON, July 23—German-American circles are alarmed at the Nazi Government's prohibition of the Jewish Telegraphic Agency service from Germany and have given the decision to do so an extraordinary welcome, the Lokal Anzeiger of Berlin says today in a report from its New York correspondent.

The Wolff Agency's announcement of the ban on the Jewish Telegraphic Agency service was featured throughout the entire German press.

"The Jewish Telegraphic Agency carried daily, on a mass-scale, inciting reports from Berlin which were published, not only in the Jewish press but also in the anti-German American and British press," the Lokal Anzeiger's correspondent declared in his story.

FORD, GENERAL MOTORS, MORGAN AIDED NAZIS, GERMAN CHARGES IN BOOK OUT TODAY

LONDON, July 23 — Startling revelations regarding financial support of Adolf Hitler's National Socialist party in the years before it came to power in Germany are contained in the book, "Hitler as Frankenstein," which will be published here tomorrow. The book is by Johannes Steel, the pseudonym of a German known to have had intimate Nazi contacts. Professor Harold J. Laski, noted political scientist, has written the preface for the volume.

In his preface, Professor Laski confirms Steel's exceptional access to sources of Nazi information ordinarily unavailable and emphasizes the seriousness of the matter if the greatest international financiers are subsidizing a movement such as Hitler's.

"It is a serious matter for Jews everywhere, if true, that Henry Ford, having stopped his anti-Semitic campaign in America, proceeded to endorse a similar campaign

on a wider scale in Germany," Professor Laski points out.

Feld Commissioners

Steel, revealing that the Nazi movement spent 350,000,000 marks in the five years preceding its assumption of power, proves convincingly that it was impossible to raise this amount in Germany alone despite the fact that Nazi collectors work on a commission basis, receiving as much as 25 percent even for street collections made with the reaction boxes.

The author circumstantially describes how Hjalmar Schacht, present Reichsbank president and chief Nazi authority on financial matters; Hermann Goerring, present premier of Prussia; Dr. Joseph Goebbels, Nazi propaganda chief; the Hohenrollers princes and others who now have positions of authority in the Nazi Government were engaged in convincing funds abroad to support the Nazi party activities. Financiers, particularly in America, constituted their chief field of operations, Steel asserts.

The Nazi fund emissaries used as their chief argument the claim that the Hitler assumption to power would mean a return to prosperity and implied the protection of American interests in Germany and the thawing of capital frozen there.

Jewish Lawyers Must Prove Actual Service in Trenches To Be Readmitted to Bar

LONDON, July 23—Only those Jewish lawyers who can prove with documents that they actually fought in the trenches will be considered by the Frankfurter, association of active German war veterans, for readmission to the practice of their profession, yesterday's Berlin Official Gazette stated. The interpretation given by the Official Gazette means that the reinstatement of Jewish lawyers to the bar will be confined to a small portion of those dispossessed because they were non-Aryans. They will have to give documentary evidence as to the exact dates when they fought in the trenches, and will be forced to prove the definite location of the trenches.

This evidence is almost impossible to collect in Germany at present. Even Aryan war veterans would in most cases be unable to find such evidence, and for Jews the chances are slimmer.

100 Nuremberg Jews Freed By Nazis After Mass Arrest

LONDON, July 23—Of the 300 Jews who were arrested in Nuremberg, Germany, last Thursday, 100 were set free yesterday. Most of the Jews arrested were proprietors of small shops. They were compelled to march through the streets of Nuremberg flanked by huge crowds of Nazis who took a malicious delight in the spectacle of their Jewish neighbors being humiliated.

No reason was given for the release of the 100 Jews, just as no reason was given for the mass arrest.

2 Arabs Who Blackmailed Jewish Settlers Banished

(Jewish Telegraphic Agency)

JERUSALEM, July 24—Samir Benkhan, son of the mayor of Tulkarm, and Rashid Hameen, son of a rich landowner, were sentenced by a Tulkarm court to six months' banishment today for instigating Fellahs Bedouins to commit agrarian crimes against Jewish settlers in Nakhla. Ibrahim was banished to Acre, and Hameen to Nazareth. Each man also was required to post up 250 pounds as security for his good behavior for a whole year.

At the trial it was brought out that the two defendants had for a long time blackmailed Jewish planters in Nakhla into paying them 20 pounds a month to keep squatters off their field. Finally the Jewish planters refused further payments, and as soon as no more money was forthcoming, Ibrahim and Hameen revived the agrarian crimes, encouraging squatters to menace the lands of the Jewish settlers around Nakhla.

The case is typical of the situation of the whole Sharon plain. Thousands of pounds are paid annually for "protection" against squatters to men like Ibrahim and Hameen.

Detroit Holds Annual Herald Memorial Meeting

House of Morgan, which he asserts, contributed \$30,000 in three installments. Another American bank, whose president frequently visited Berlin, followed suit, he says. Most of the checks by which it paid its contributions were drawn on other banks.

The largest contributions from the United States, however, came from non-bankers such as Ford and the General Motors Corporation, Steel asserts. The latter concern, he claims, contributed \$200,000 because of certain labor interests in connection with its purchase of the Opel automobile concern in Germany.

The first contribution from Ford amounted to \$40,000 following acquisition of the Dearborn Independent on which Ford published in the United States, Steel says. He asserts the contribution was given to a Nazi publisher to spread anti-Jewish literature throughout Germany.

Ford declined to furnish additional funds, following his initial grant, the author reports, but the young Hohenzollern prince, Ferdinand, who went to Detroit to work in the Ford plants, was instrumental in the resumption of relations which had been terminated because of the manufacturer's disappointment at the sale of his books.

Appended to Ford's Feelings

In breaking down this feeling held by Ford, Steel reports, the young prince used the same arguments successfully used by Nazi agents with other financiers and industrialists and in addition appealed to his prejudice against the Jews and to his desire to avoid a strike in the Ford German plants.

Steel expresses surprise that Ferdinand was permitted to enter the United States outside the quota although he came ostensibly as a worker.

Ford's gifts to the Nazis subsequently amounted to \$300,000 paid to Ferdinand under cover of an especially large salary and bonuses as an expert engineer, Steel says.

Ferdinand and August Wilhelm, "Aron," who were popular in Chicago society, succeeded in raising large sums there for Hitler, which were forwarded to Germany through four different banks, according to Steel.

Italian-Americans also aided in raising funds for the Nazis, according to Steel. He names specifically Julia Maronini of Riverdale-on-the-Hudson, whose father, came to America when Garibaldi's famous red-shirt legions disbanded. (Giulia Maronini, who was known as a recluse and occupied the old Maronini

mansion at Riverdale, died on February, 1932.—E.S.)

Among the European industrialists and financiers supporting the Nazi movement, Steel names Sir Henri Deterding, Dutch oil magnate; the late Ivar Kruger and various prominent concerns even in France, Poland and Czechoslovakia.

Meet in Jewish Banker's Office

A particularly interesting chapter of the book deals with the fateful meeting of German industrialists leading to Hitler's accession to the chancellorship. Under the chairmanship of Col. Franz von Papen, Steel says, the German industrial leaders meet at Dusseldorf in the offices of the banking firm of R. Levi and Company. Levi, according to Steel, is a Jewish banker.

At the meeting, the industrialists threatened to withdraw their support and financial backing from Hitler unless he agreed to a coalition administration with Dr. Alfred Hugenberg, Nationalist party leader, in the cabinet. Hitler, under threat of losing his financial backing, was thus forced to accept this agreement before he assumed the chancellorship.

Nazi Cheerfully Distribute Morse Advertising Accounts

LONDON, July 24—The Radloff Morse Advertising Company, with branches throughout Germany, has been shut down. It was disclosed here today. The advertising for the Morse press has been transferred to other firms or to concerns newly established for the purpose. Several Jewish employees dismissed when the Morse firm was closed have taken part in the formation of new companies in the hope that they will be able to obtain a living this way.

Hamburg Jews Dismissed

LONDON, July 24—The Hamburger Nachrichten Nachrichtenblatt, Hamburg, Germany, has reported the dismissal of Dr. W. A. Beeson from his professorship and Dr. Ernst Del Bueke from the chief doctorate of Hamberger Hospital. The paper also reported that Dr. Arthur Lippman has been dismissed from his post at St. George Hospital and Dr. Hans Tackeborn, one of the oldest living Hamburg University professors, has been fired from his job at the college. The newspaper published a long list of other Jews, including lawyers and architects, who were dismissed from their jobs.

Palestine Laborites Lead in Polish Elections For Zionist Congress

WARSAW, July 24—Election results tabulated today from 530 Polish centers in 103 cities or towns recorded over 90,000 votes, with the Palestine Laborites far in the lead with 26,326 votes. Following in order were the Jabotinsky Revisionists, with 20,467 votes; the Mizrachi, with 14,289; the General Zionists, with 10,518; Grossman's Democratic Revisionists, with 2,761; the Hirschbach Party, with 2,726; and the Et-Shevet Party, with 1,271.

Preliminary election results today indicated that out of 33,174 Shehal holders in Warsaw only 8,669 voted. Results so far are as follows:

Palestine Laborites, 2,686 votes; Jabotinsky Revisionists, 2,039 votes; Mizrachi, 1,835; General Zionists, 1,331; Grossman's Democratic Revisionists, 462; Et-Shevet Party, 362; and Hirschbach Party, 90 votes.

In Lodz the early results of voting were:

Jabotinsky Revisionists, 2,100 votes; Palestine Laborites, 1,800; General Zionists, 1,600; Hirschbach Party, 700; Et-Shevet Party, 500; and Mizrachi, 500.

Results from elsewhere in the provinces are as yet unknown.

The elections yesterday and today occupied the attention of Polish Jewry. In spite of trouble last week, there were few incidents of an untoward nature, and the were quickly put in order. Not more than 40 percent of the city's Shehal holders voted.

World Maccabee Meet

Transferred to Prague

LONDON, July 24—After receiving word from the Romanian government that they cannot guarantee the safety of Lord Alfred McAlister, who, as honorary president of the World Maccabee intended to be present at the Maccabee Sports Meet in Caernarvon, the Maccabee Executive today resolved not to hold the sports meet at Caernarvon. They decided to transfer the meet to Prague and to hold it in conjunction with the gathering of the World Zionist Congress.

Emergency Session

An emergency session of the National Executive Committee of the American Jewish Congress has been summoned for August 6, Dr. Joseph Trachtenberg, chairman of the committee, announced yesterday. The emergency session intends to formulate a coordinated plan of action to aid German Jews. The meetings will be held at the Hotel New Yorker, it was announced.

16 More Jews Murdered at Dachau Concentration Camp, London Newspaper Asserts

LONDON, July 24—Murdering of Jews in the Dachau concentration camp in Bavaria allegedly "for attempting to escape" is continuing unchecked, the Berlin correspondent of the London Referee reported to his paper yesterday. Sixteen recent victims of the Nazis in the concentration camp were named, including Arthur Kahn, Erwin Kahn, K. Goldmann, Alfred Benarion, Michael Segmann, Joseph Gots, Dr. Alfred Strauss, Wilhelm Aron and W. Hirsch. All these men were brutally murdered in cold blood, the London Referee correspondent declared.

Seattle Jewish Leader Assails Whiteshirt Group Sponsored by the Legion

SEATTLE, July 24—Germany can keep its brownshirts, Italy its blackshirts, Russia its redshirts, and America, which has the Stars and Stripes, does not need a shirt as an emblem of patriotism. F. Allen Radden, Jewish leader in this city, declared today in the face of a plan by Seattle American Legion officials to organize a Whiteshirt Corps.

The Whiteshirt Corps is the brainchild of the Seattle Times, controlled largely by the Riddler brothers, publishers of the New York Staats-Zeitung. In the Independence Day parade here this month 5,000 Whiteshirt youths marched proudly along. As yet the Whiteshirt Corps is a localized super-patriotic organization, but it is learned that the leaders of the local branch of the American Legion are planning to suggest at the next national legion convention that the white shirt be used by American youth as a symbol of patriotism.

Hinder for "Inspiration"

When the Seattle Times belittled the Whiteshirt Corps into popularity here the paper published photos of Adolf Hitler reviewing his brownshirt storm troopers in Germany to "inspire" Pacific Coast youth.

Mr. Radden, who is 5'11" High District Grand Lodge officer and president of the Moral Congregation here, stated that American youth should not ape European shirt-wearers. "Let us consider for a moment what the brownshirts, blackshirts and redshirts of Europe symbolize," he declared. "In Italy the blackshirts represent an absolute dictatorship, wholly contrary to every doctrine of the American form of government and entirely inconsis-

British Board of Deputies In Secret Session Decides Against Boycott Sponsorship

LONDON, July 24—The Board of Jewish Deputies after a long session yesterday from which the press was excluded decided by a large majority to uphold President Neville Laski's policy of refusing the motion to call upon British Jewry to abstain from using German goods and services. The Board of Deputies, however, went on record unofficially as overwhelmingly in favor of an anti-German boycott.

They accepted the report of the Joint Foreign Committee which declared that the boycott was natural and inevitable as an expression of Jewish feeling and which called for the consideration of calling into action a conference of Jewish organizations throughout the world to consider the extent of the desire for the boycott.

The official vote was 118 to 27 against proclaiming a boycott of German goods at present. After the meeting it became apparent that a crisis had arisen in the break between the East End Jews who want an immediate official boycott and those more conservative leaders of England's Jewry.

Samuel Untermyer, who arrived here yesterday from Amsterdam, where he was busy putting into action a worldwide boycott campaign in defense of the Board of Jewish Deputies leaders, said that he was not disappointed by the Board of Deputies' decision, as he had expected it.

Reports Excesses in Nazi Concentration Camps

VIENNA, July 24—Bloody maltreatment of Jews in German concentration camps was confirmed today in an affidavit submitted to the Catholic Press Association here by a non-Jew named Dodder Rakus, formerly a member of the newspaper Zentralblatt in Dusseldorf. Rakus has just arrived in Vienna after three months' imprisonment in Dusseldorf Prison at the Sieghart concentration camp in Prussia.

Jews confined in the camps, Rakus declared in his affidavit, were forced to clean the inmates' boots and actually to kiss the feet of the Nazis — otherwise they were immediately beaten.

"I have seen how the hair of Jews were torn out of their flesh, how Jews were compelled to beat their faces with their own fists as well as each other's faces, until the blood spouted," he stated. "There are many ghastly incidents in these prisons," Rakus concluded.

"Romance of a People" To Be Shown in New York

"Romance of a People", pagant depicting the history of Jewish life, will be staged in New York at the Polo Grounds on September 14 for the benefit of German Jewish relief in Palestine, it was announced yesterday by Louis Lipsky, national chairman of the American Palestine Campaign. Governor Herbert H. Lehman will act as honorary chairman of the pageant.

The pageant, when shown at the Chicago World's Fair, this month, was witnessed by more than 100,000 persons.

tent with every principle of Americanism and of the spirit of '76.

"In Germany today the brown shirt is the symbol of the most despotic, intolerant, bigoted and inhuman form of government that any civilized country has had since the Middle Ages. In short, the European 'shirt' is a European symbol of despotism and autocracy and completely foreign to the American spirit.

"It occurs to me that the only symbol which we need properly to represent the principles of Americanism is the Stars and Stripes. More than 120,000,000 people living under a most democratic government regime which represents the ideals of liberty, justice and equality should need no symbol other than their own flag, and certainly not one which represents everything contrary to their doctrines."

Arnold Schoenberg, Composer, Is Reconverted to Judaism

PARIS, July 24—Arnold Schoenberg, the famous composer who abandoned the Jewish faith in 1921, today was officially readmitted into the Jewish religion. The ceremony was held at the Liberal synagogue here with Rabbi Louis Germain Levy officiating.

Dr. David Marianoff, son-in-law of Professor Albert Einstein, and Marc Chagall, the noted painter, acted as witnesses.

Schoenberg, a native of Vienna, is 59 years old. He has conducted masters' classes in the Berlin Academy of Arts and has written works for orchestra, chorus and chamber music ensembles. His "Study of Harmony" was published in 1921. He is known as a poet and theoretician.

University Governors in First Jerusalem Meeting

JERUSALEM, July 24—For the first time the governors of the Hebrew University will hold their meeting in Jerusalem, it was learned today as it was announced that Dr. Chaim Weizmann, president of the University, had decided not to convene the meeting in Zurich, Switzerland in August, as originally contemplated, but to hold it here in October instead. The Council of the Institute of Jewish Studies and the Academic Council will meet in Zurich, as originally scheduled. Dr. Judah Leon Magnes, Chancellor of Hebrew University, will participate in the Zurich conferences.

ing, and another, on whom a revolver was discovered, will be held in prison until he can be tried on the charge of unlawful possession of a firearm.

Lichter, manager of Hazit Ha'am in Tel Aviv, was set free early this morning, as were several other suspects.

Police officially informed the Jewish Telegraphic Agency of the purpose of the raids in the following announcement:

"Police carried out the raids early in the morning, simultaneously in various places, including Jerusalem, Tel Aviv, Nathania and Kfarsaba. Two revolvers were found and a number of documents were taken pointing to the existence of an illegal association. Several persons were brought to police stations for interrogation, including two persons who, it was found, are living in Palestine without permission. Some persons have been detained pending further inquiry."

Resides this official announcement, police would give no further explanation of the raids.

Asheville Citizens Sign B'nai B'rith Petition

ASHEVILLE, N. C., July 24—Nazi persecution of Jews in Germany has been protested here by between 300 and 400 persons who signed petitions circulated for the past two weeks by the Asheville B'nai B'rith lodge. Signatures of persons of all races and creeds have been affixed to the petitions.

The petitions, along with those circulated in other cities of the nation, will be presented to President Roosevelt.

Rabbi Korff Ill

BOSTON, July 24—Grand Rabbi Jacob Israel Korff of the Congregation Adath Jacob at Mattapan is seriously ill at the Beth Israel Hospital here, where he was taken two days ago after suffering a sudden collapse at his home on Woodrow Avenue. Hospital physicians are hopeful that he will rally.

Rabbi Korff's eldest son, Isaac, was ordained an Orthodox rabbi only two weeks ago. Friends of Rabbi Korff assert that the collapse was due to his having worried too much over the plight of the Jews in Germany.
