

Jews Doing Business in Germany at Own Risk Berlin Court Holds

(Jewish Telegraphic Agency)
BERLIN, Aug. 17—The German courts, in a decision reported today, hold that a Jew doing business in Germany is doing so at his own risk and cannot hold the State responsible for negligence in maintaining order and affording him protection.

The decision, reported in the *Saarbrücken Freiheit*, reveals that a Jewish merchant, whose shop was destroyed by uniformed storm troopers while the regular police stood idly by, brought suit for damages in a Berlin court. The judge dismissed the suit with costs assessed against the plaintiff, and in a remarkable decision held that the claim for compensation was unfounded.

When a Jewish businessman establishes or conducts an enterprise in Germany, the court ruled, he must be aware that this constitutes an extraordinary provocation for an overwhelming majority of the German people. He must, therefore, from the first, count on the possibility of the destruction of his business and this danger should form part of the entrepreneur's risk which every Jew in Germany must bear.

Swastika at Ball Game Provokes Toronto Riot With 8,000 Participating

TORONTO, Aug. 17—Firm action in dealing with the Swastika Club, pro-Hitlerite organization reportedly made up of Nazi agitators from the United States, was promised by Mayor Stewart today as the aftermath of serious rioting last night when Hitlerite supporters and Jews clashed in the course of a softball game between St. Peter's and Harbor, a team composed mostly of Jewish boys.

Although the excitement had largely subsided today, there was still a strong atmosphere of tension in the city. The vigorous measures taken by the police at Mayor

Actions Committee Reaches Compromise With Labor

PRAGUE, Aug. 17—The Actions Committee of the World Jewish Organization met today following postponement of the session from Tuesday as a result of demands made by the Laborite group for representation in proportion to their strength in the Eighteenth World Congress. Dr. Chaim Weizmann was not present at the meeting.

As the largest fraction, with a representation of approximately forty percent of the total at the Congress, the Laborite group, at the meeting today demanded the presidency of the committee. They agreed, however, to have Dr. Leo Motzkin continue in that position as usual with the proviso that no members of the Revisionist group be included on the presidium.

1,264 Entered Palestine in June

JERUSALEM, Aug. 17—Official Government figures, made public yesterday, reveal that 1,264 immigrants entered Palestine during the month of July. Of this number 1,263 were Jews, including 227 in the capitalist classification.

Reprisals Against German Zionists for Congress Action Threatened by Rosenberg

BERLIN, Aug. 17—Reprisals against those who are "guilty of complicity" is threatened in a leading article in the *Vorkämpfer* newspaper, personal organ of Chancellor Hitler, dealing with the Zionist Congress. The article is signed with the initials A.R. which stand for Alfred Rosenberg, chief of the Foreign Affairs Division of the Nazi Party.

Despite the fact that the German Zionists are not participating in the Congress and that the *Jüdische Rundschau*, organ of the German Zionists, is a leading editorial appealed to the Congress to refrain from anti-German declarations and that even the German Zionist officials left Prague in order not to lay themselves open to Nazi reprisals, Rosenberg declares that the "London castle of the Zionist leader, Melchett, is actually the center of the world Jewry for the anti-German boycott."

Zionist Boycott

Rosenberg insists that the Jewish boycott is the Zionist boycott and bitterly attacks Leo Melchett, stating, "Alfred Mond's anti-German

Boycott Jew Who Sang At Wagnerian Festival, London Chronicle Urges

LONDON, Aug. 17—A call for the boycotting of Alexander Kipala, Jewish artist who appeared in the Wagnerian Festival at Bayreuth, is made editorially today by the *London Jewish Chronicle*, influential Anglo-Jewish publication. Kipala is expected here shortly to begin a concert tour in England.

Kipala, although a Jew, participated in the Bayreuth festival, while many non-Jewish musicians refused to perform in Germany as long as present conditions continue.

The *Chronicle* dismisses the fear that the public might retaliate against Jewish artists because, it de-

American Govt. Barring German Jewish Refugees Nazi Paper Reports

BERLIN, Aug. 17—Measures have been taken by the American Government to prevent Jewish refugees from entering the United States, the *Frankfurter Zeitung* reports today. The paper's assertion is based on the allegation that the American consent in Paris demands conclusive proof from German citizens seeking American visas that they still are permanent residents of Germany. The only German citizens exempt from this ruling, according to the *Zeitung*, are those presenting certificates from the German authorities that they are not political refugees.

High Commissioner at Levant Fair Ceremonies

(Jewish Telegraphic Agency)
TEL AVIV, Aug. 17—In the presence of ranking Government officials, foreign diplomatic representatives and leaders of the Palestine community, Sir Arthur Grenfell Wauchope, High Commissioner for Palestine, yesterday held the ceremonies for the Levant Fair which will be held in this city in 1934.

The elaborate ceremonies incident to formal start of preparations for the function were followed by a reception at the Ritz Hotel.

Announcing that the Levant Fair was now acquiring a permanent home in Tel Aviv, Mayor M. Dizengoff, of Tel Aviv, predicted that Tel Aviv and the surrounding country would soon become the center of commerce for the whole Middle East.

The High Commissioner promised to lend the project all assistance at his command and expressed his personal pleasure that one of the permanent functions of the Fair would be the British Pavilion. In this connection he stressed the fact that England consumes fifty-five percent of Palestine's total exports.

"I am sure that the 1934 Fair will be a historic mark in the development of Tel Aviv and will benefit all of Palestine," the High Commissioner said.

Eastern France Objects to Competition of Refugees

PARIS, Aug. 17—Considerable dissatisfaction with the settlement of German Jewish refugees in Eastern France is expressed in resolutions and letters to the press from local chambers of commerce. According to these groups forty thousand German refugees have invaded the district. Most of the refugees are Jews.

Although the majority of the complaints show appreciation of the Jewish plight, they urge the League of Nations to help since Eastern France alone cannot bear the entire burden. The largest group of the refugees have come into Eastern France because it is near the German border, and the French population there understands German.

Only the Metz chamber of commerce has actually indulged in anti-Semitism, declaring that the majority of the refugees were highly undesirable types and constituted a serious danger to honest French traders.

The Paris Mail suggested that thousands of German Jewish doctors now in exile in France be settled in the French colonies, particularly in Africa, in order to check the abnormally high death rate there, since French doctors are reluctant to emigrate to the French colonies.

Sholem Maximon Buried At Tel Aviv Amid Eulogies

JERUSALEM, Aug. 5—The interment of the body of Sholem Maximon, noted American Hebrew writer and teacher, took place at Tel Aviv a few days ago. According to the wishes of the deceased, his body was brought to Palestine for permanent burial.

Rabbi Arison, Professor Dizendrook, Dr. S. Ginsburg, Dr. Yehuda Kaufman and Mr. Jacob outlined at length on his activities in the fields of Hebrew literature and pedagogy. He was buried near the graves of Achad Ha'am and S. Derzhan.

Mr. Maximon was 59 years of age when he died. He was one of the pioneers in the United States in the Hebrew movement and contributed many articles to Hebrew newspapers and magazines. In recent years he taught Hebrew at Hebrew Union College in Cincinnati.

Becker Special Counsel For Wisconsin Bank Board

MILWAUKEE, Aug. 17—Samuel Becker, legislative counsel to Philip F. LaFollette when he was governor, and well known Milwaukee Jewish attorney, has been assigned by the Wisconsin state board of deposits as its special counsel to go to Washington and plead for a loan of \$18,000,000 from the Reconstruction Finance Corporation to liquidate the public funds of cities and counties now tied up in closed and "monetarized" banks.

Back Jewish Leader For Binghamton Post

Gail, president Binghamton attorney, active in Jewish communal affairs, today was announced as the choice of the Democratic organization for the office of district attorney of Broome county. His name will be placed on the organization ticket in the primaries on Sept. 19.

Less Than 2 Percent Jews In Russia, Census Shows

MOSCOW, Aug. 4—The Jewish population of Soviet Russia numbers two and a half million souls, or 1.7 of the total population, according to the electrified soap of Soviet nations and nationalities at the exhibit of Peoples of Soviet Russia, arranged in connection with the tenth anniversary of the promulgation of the Soviet Constitution.

The statistics are taken from the last census, but cannot be taken as final, since a number of Jews were registered as Russian, White-Russian or Ukrainian. Actually, the number of Jews in Russia approximates three million.

Brazil Scholarship Winner Given Concerts on Return

RIO DE JANEIRO, Aug. 7—Miss Esther Epstein, Jewish pianist who has been studying abroad on a government scholarship, recently returned from Europe. Since her return she has given several concerts which have been enthusiastically received by music critics here.

Miss Epstein is the first holder of the scholarship, which she won several years ago in competition with a number of other aspirants for the prize.

Levy and Fertig Are Named for City Offices on Regular Democratic Slate

Samed Levy and M. Mallowa Fertig were named by the regular Democratic organization to run for the office of Borough President of Manhattan and President of the Board of Aldermen, respectively.

Mr. Levy is the present incumbent in the office of Borough President and has been named to succeed himself. He is prominent in many Jewish organizations and is an active worker in Jewish philanthropic movements.

M. Mallowa Fertig, selected for president of the Board of Aldermen, is a native of the Bronx. He is 45 years old and is counsel for Governor Herbert H. Lehman and was also counsel for Mr. Roosevelt when he was governor of the State of New York.

Mr. Fertig is president of the Y.M.H.A. in the Bronx, trustee of the Federation for the Support of Jewish Philanthropic Societies and president of the Metropolitan League of Jewish Community Associations.

Appoint Ellmann Assistant Michigan Attorney General

LANSING, Mich., Aug. 17—Former Justice James L. Ellmann of Highland Park, was appointed assistant attorney general by Michigan's attorney general, Patrick H. O'Brien.

Mr. Ellmann has been appointed to serve as counsel of the newly-formed public trust commission and the state bondholders committee.

From 1918 to 1923 Mr. Ellmann was justice of Highland Park. Last year he won the nomination for mayor of Highland Park, losing the election by less than 100 votes.

Seaboard Zionist Region Meeting in Washington

WASHINGTON, Aug. 17—The executive committee of the Seaboard Zionist Region will hold its semi-annual meeting here on September 19 to consider internal Zionist problems in each constituency. Rabbi Edward L. Israel will preside and Judge William M. Lewis, vice-president of the Zionist Organization of America, will be the guest speaker. A luncheon at the Jewish Community Center will precede the meeting.

California Legionnaires Denounce Persecution Of Jews by Hitlerites

PASADENA, Cal., Aug. 17—The California Department of the American Legion, which is holding its annual state convention here, today adopted resolutions condemning persecution of the Jews in Germany by the Hitler regime.

Pro-Nazi organizations here have been very active in recent months in attempting to enlist the support and sympathy of American Legion posts, meeting with conspicuous failure. The Legionnaires have steadfastly refused to cooperate with pro-Nazi organizations here and many of the posts, prior to the convention, went on record as denouncing the persecutions.

Grant Visa to Jabotinsky To Attend Prague Congress

PARIS, Aug. 17—Vladimir Jabotinsky, leader of the Zionist Revisionist movement, who had been refused a visa permitting him to enter Czechoslovakia to attend the Zionist Congress at Prague, received the visa with an apology from the Czechoslovakian legation here yesterday. It was explained that a misunderstanding had been responsible for the earlier refusal.

PRAGUE, Aug. 17—A division of opinion between the Czechoslovakian Foreign and Home Offices regarding the granting of a visa to Vladimir Jabotinsky, Revisionist leader, enabling him to attend the Zionist Congress which will open here next week, was responsible for the delay in giving him permission to enter the country, it was learned today.

The Home Office, it was learned on good authority, had objected to Jabotinsky's visit on the grounds that too many disturbances had resulted from his previous visit when his followers and other Zionists met at a mass meeting, and the ministry wished to avoid any repetition.

The Foreign Office insisted, however, that Jabotinsky, as the leader of an important Zionist faction, could not be barred from attending the Congress and that he must be granted a visa without limitations.

Jabotinsky did not apply through the Congress Bureau which arranged details for the majority of the delegates to the Congress, and re-

Demented Youth's Act Basis for Anti-Jewish

BERLIN, Aug. 17—The slight wounding of a Christian woman, a Miss Oliver, in Hyde Park, London, by a demented Jewish youth forms the basis of another wild attack on the Jews in Hitler's *Voelkischer Beobachter*. The incident proved, the paper asserts, "who actually is indulging in atrocities even against defenseless women."

The fact that the youth is believed by the police to be demented and that he was taken to an asylum instead of being held for trial is explained by the paper as Jewish manipulation to squash the case and give "all Jews sufficient time to start an offensive for the release of the poor madman."

The facts of the case, as the *Voelkischer Beobachter* did not report them, are that the youth, Harry Bloomstein, meeting Miss Oliver, a stranger to him, in Hyde Park, cried out "I'll take revenge on the Germans!" and stabbed her slightly. His victim was not German, but English. It is not expected that Bloomstein will be tried as the police are satisfied he is insane.

E. B. Freed Inducted as U.S. Attorney at Cleveland

CLEVELAND, Aug. 17—Emanuel B. Freed, prominent Jewish attorney, was sworn in as United States District Attorney here. Mr. Freed, who is 33 years old, is the youngest man ever to hold the post here and is believed to be one of the youngest United States Attorneys now in office.

Several hundred civic, political and communal leaders attended a testimonial dinner to Mr. Freed at which the speakers' list included Mayor Ray T. Miller, Judge Manuel Levine, Homer G. Powell, chief justice of the common pleas court and Judge Maurice Barson.

Swastika at Ball Game Provokes Toronto Riot —With 8,000 Participating

Stewart's orders, however, greatly reassured the population.

Swastika Burned

The police commission, in a special meeting today called on account of the riots, officially banned the display of the swastika in the city on the grounds that it is provocative. Anyone displaying this ruling and displaying a swastika flag will be prosecuted, it was declared.

Strong police detachments patrolled the Jewish section of the city until four o'clock this morning to prevent attacks on Jews by roving bands of hoodlums whose activities threw the neighborhood into a panic.

The origin of last night's clash developed Monday evening when the Harbord team won the first of the playoffs and someone in the crowd displayed a large swastika flag crying "Heil Hitler"

The third game of the series was played last night. Both sides came to the field with reinforcements, prepared for trouble. It came after the first inning when a large swastika flag was broken out on a nearby hill. The Jewish youths charged up the hill, seized the flag and ripped it to shreds.

Hoodlums Spread Over City

The rioting thereupon broke out in full fury with 8,000, according to police estimates, participating. Police reserves were rushed to the scene but were unable to check the fighting. Groups of hoodlums left the field in the direction of the Jewish neighborhood shouting "Heil Hitler, Kill the Jews!"

Small groups of Jewish youths banded together at strategic points to check the invaders and put up a stiff resistance which sent several to the hospital. Among the seriously injured are Joseph Goldstein, 13, and Louis Kotecz. Five Jews and five Hitlerite sympathizers were in Toronto hospitals today and scores received first aid treatment and were sent home.
