## Jewish Day in New York; 58,000 Expected at Pagant At Polo Grounds Tonight

Fifty-eight thousand people are expected to be present tonight at the Polo Grounds at the opening performance of "The Romance of a People". Today, by official proclamation of Mayor O'Brien, is Jewish day, in recognition of the presentation of the pagant.

There will be brief introductory addresses to welcome the audience on behalf of the nation, the state and the city. Nathan Straus, Jr. will open the proceedings and short speeches will be delivered by Senator Robert F. Wagner, who has been delegated to represent President Roosevelt in place of Postmaster James A. Farley, Governor Herbert H. Lehman and Mayor John F. O'Brien. Prior to the pagant a dinner to the notable guests is being given by Mr. Straus at the Plaza Hotel.

A squadron of some thirty planes will leave the North Beach Airport at 5 P.M. today in an aerial celebration of Jewish day. The air armada will fly over City Hall in a gesture of tribute for the dedication of September 14th as Jewish day and then will go to the Polo Grounds and circle the huge stage.

## Scientists Table Move For Formal Expression of Sympathy With Einstein

LEICESTER, England, Sept. 13.—No official action was taken by the British Association, foremost scientific institute, upon a suggestion made at yesterday's session, by a delegate, that the Association send a message of sympathy to Professor Albert Einstein, now in seclusion in England.

The suggestion was made unexpectedly by a scientist present at the meeting of the mathematical section of the Association, which was discussing the Einstein theory. He asked the meeting to pass upon a vote of sympathy for Professor Einstein. The chairman of the section intervened and asked that the vote be postponed for a day, in order to enable a committee to consider the matter. Since a vote would

## Christian Firms Advised To Obtain Aryan Signs; Jews Guests of Nation

BERLIN, Sept. 13.—Christian firms all over Germany were advised by the Department of Commerce today to obtain special Nazi trade signs which will make it clear to their customers that they are neither Jewish nor foreign. At the same time the firms were given the address at which the signs could be obtained.

This followed yesterday's announcement by the Department of Commerce that Jews may be admitted as members of the Trader's Association, but that Jews are not entitled to occupy executive positions in the Association, and that the same ruling applies to all foreigners.

The order explains that the Nazi movement consider the Jews as guests of the nation who are permitted to trade in Germany. The logical consequence is, that Jewish firms cannot belong to the management.

## Commissioner's Order Protects Readmitted Jewish Lawyers

(Jewish Telegraphic Agency)  
BERLIN, Sept. 13.—Strict orders that the readmitted Jewish lawyers must not be hindered in their work or in appearing in the courts, were issued today by Commissioner of Justice Frank. This will undoubtedly prevent any further ordering of Jewish lawyers from the courts and relieve them of the fear of physical violence.

The orders make it clear that non-Aryan lawyers, as long as they are admitted to practice, are entitled to state protection and to practice their profession, just as Aryans.

Obstruction of the work of non-Aryan lawyers will not be tolerated in the future, the order states, and severe measures will be taken against court officials who create undue difficulties for the readmitted Jewish lawyers.

## Has Lotteries for Jewish Relief

BERLIN, Sept. 13.—Jewish organizations will no longer be permitted to conduct lotteries for the purpose of raising relief funds, the Prussian Ministry of the Interior announced today.

## German Jewry Prepares For New Year Observance Not Provocative to Nazis

BERLIN, Sept. 13.—Jewish communities in the provinces of Germany have decided to abstain from synagogue services celebrating the Jewish New Year next week, in order to avoid anything that might be considered as provocation to the Nazis, it was learned here today.

In Berlin, however, the sale of seats in the synagogues for the High Holidays is larger than ever before, reflecting the greater sense of security felt by the Jews in the capital.

The Union of Jewish Women, in a moving appeal to the Jewish women of Germany, appealed to them not to dress conspicuously on the holidays and not to draw too much attention to themselves. "In this time, the appearance of Jewish women is of great importance," the appeal pointed out. "It must be modest in design and combination of colors in order to reflect our mood at this present time. All that is conspicuous is harmful to the individual and to all Jews and provokes animosity."

"Therefore," it continues, "it is the duty of every Jewess to obey the

## Famous Artists Refuse Furtwangler Invitation To Perform in Germany

LONDON, Sept. 13.—Yehudi Menuhin, Fritz Kreisler and Arthur Schnabel, are among the world famous artists who have refused the invitation extended them by Wilhelm Furtwangler, noted German conductor, to give concerts in Germany, it was revealed here by the violinist, Bronislaw Huberman, in today's issue of the London Times.

Mr. Huberman quoted from a letter sent him by Herr Furtwangler, enclosing an announcement by the German Ministry of Culture, which states that there is no intention of excluding the works of non-German composers from German concerts and emphasizing that before the principle of merit, every other consideration must give way.

The violinist replied that a reconsideration of his refusal to play in

### Alfred Sato, Playwright, Dies After Brief Illness

(Jewish Telegraphic Agency)

LONDON, Sept. 13.—Alfred Sato, famous playwright, died Tuesday night at his home in Surrey. He was 70 years old and succumbed to bronchial pneumonia. He was sick only a few days.

Mr. Sato was a brother-in-law of the Marquess of Reading, noted English statesman, and was closely connected all his life with the London Spanish-Portuguese Synagogue and with Jewish life.

He was born in London on August 7, 1863, a son of Dr. Sigismund Sato. He was educated at the City of London School and in Brussels. The dramatist married Stella Isaacs, a daughter of the late Joseph M. Isaacs, London merchant, and a sister of the Marquess of Reading.

He won his first recognition as a playwright in 1904 with the play "The Walls of Jericho." The late William Archer, distinguished English dramatic critic, encouraged him in his ambition.

For more than 30 years, from 1896 to 1929, Mr. Sato maintained a steady output of plays, including co-act pieces and French adaptations. Some of the better-known plays are: "The Builder of Bridges", "Making of a Gentleman", "The Forgiven Husband", and "The Desperate Lovers".

His friendship with Maurice Maeterlinck led to his being chosen to translate three of his prose works, including the famous "Life of the Bee."

### Hitler Imperils World; Won't Abate Persecutions, Stanley High Declares

Stanley High, for the last six weeks special correspondent in Germany for the Literary Digest, on his return aboard the Majestic yesterday declared that Hitler "has placed in peril not only the rights of the German people but of the entire world."

"The fate of Jews in Germany has been sealed," he said. "So long as Hitler or any National Socialist successor to Hitler holds sway in Germany there is nothing ahead for the German Jew but darkness and, in the end, extermination."

Mr. High termed Hitler's persecution of the Jews "a war against civilization, of which anti-Semitism is only the crudest indication."

#### Tragic for Jews

"If Hitler gets away with it," he said, "it will be tragic for the Jews. But if the world allows Hitler to get away with it, it will be more tragic in the long run for the structure of free institutions which, with the Jews bearing the brunt of it, Hitler is threatening. What is at stake in Germany is the whole system of elemental human rights, which have been won at a vast cost and are the lifeblood of America and the world, and which are now placed in peril."

Mr. High forewarned the need of changing or abandoning many of the tenets in the Nazi program, and he prophesied drastic changes in a majority of Nazi principles, "excepting only that which calls for the eventual casting of the Jews."

"Hitler," he said, "would like to be more moderate than his followers on many issues. He has tried to play in the realm of economics and international politics a somewhat milder game than was expected; but Hitler's moderation on any issue will be dictated, not by honest conviction, but by expediency."

#### No Let-up in Persecution

The correspondent stated that he saw no let-up in Jewish persecution. "It goes forward as violently and relentlessly as it did in the early days of the revolution. I did not meet a single objective observer in Germany who believed the Jews' lot was one whit better than it was four or five months ago. The only difference is that, after so much experience in the business of persecution, the Nazis have developed a technique which enables them to carry forward their program with more haste."

Mr. High believed that Hitler would drive the Jews out of Germany as rapidly as the German economic situation permits.

### Twin Cities Jewry Brings German-Jewish Student Here to Complete Studies

MINNEAPOLIS, Minn., Sept. 13.—A Jewish student, denied the right to complete his education in Germany by the Nazi regime, will be brought to the University of Minnesota and given a scholarship. Selection of this particular student is being made now through the Institute of International Education by a committee headed by Professor R. A. Gortner of the university department of bio-chemistry.

The plans to befriended some Jewish student were made known by Louis D. Coffman, president of the University, after Jews here and of St. Paul had raised \$1,200 to provide for the scholarship. As soon as the student is chosen, funds will be cabled to Germany and he will be brought to the university in time to start work in the fall term.

Mrs. Arthur Brin and Anna Dinard, prominent Jewish communal workers, were the leaders in the work of gathering the scholarship fund.

### Mrs. Jules Cahn, Dallas Social Worker, Killed

DALLAS, Sept. 13.—Mrs. Jules Cahn, director of the Jewish Social Bureau here for the past eight years, was shot and killed, yesterday, by a damaged relief applicant. Her slayer, Joel Zimmerman, 38, committed suicide.

Mrs. Cahn, who was 53 years old, was one of the best known members of the local Jewish community and was widely known throughout the city for her social service activities.

### Goebbels Denies Vatican Reports

BERLIN, Sept. 13.—Der Angriff, newspaper published here by Minister of Propaganda Goebbels, last night denied completely reports that the Vatican had raised questions regarding the treatment of baptized Jews or about the treatment of the Jews generally. Semi-official government sources previously had disclosed that these subjects had been raised in a memorandum in connection with the concordat.

### Applaud "Jewish Star" System

BERLIN, Sept. 13.—In addressing a meeting of the directors of the Prussian state theaters, yesterday, Premier Wilhelm Goering of Prussia emphasized the fact that he is against the star system in the theaters, only when actors are managed and paid "along the Jewish line of publicity-made stars." However, the Premier declared that he had nothing against the starring of real talent.

### Soviet Confiscates Jewish Cemetery; Holds Three Sextons for Extortion

**MOSCOW, Sept. 13**—Draconic action against the Jewish community of Nablino, White Russia, was ordered today by the White Russian Central Committee, the ruling body of the republic. Three guboyim (sextons) of the Chevra Kadisha (burial society) were ordered to submit themselves to trial, and the Jewish community cemetery was confiscated and turned over to the department of communal management.

In accordance with ancient traditions, the Chevra Kadisha collected payment for burial allotments. This was interrupted by the Central Committee as the extortion of money from workers and compelling the relatives of the dead to give them religious burial.

Those arrested for trial are: Leib Pagan, Moshe Kufrow and M. Berkovson.

### Fill American Quota With Jews, Suggests Brodbachter

**BERLIN, Sept. 13**—A sensational proposal that Germany's immigration quota to the United States be filled exclusively with German Jews, was made here by the Volkischer Beobachter, personal organ of Chancellor Hitler and leading Nazi paper. This would mean that twenty-five thousand German Jews could enter the United States within the quota.

In discussing the problem of German-Jewish emigration, the Beobachter states that it is the duty of the American government, out of courtesy to Germany and to the millions of Germans who for so many years emigrated to America and devotedly participated in the development of the United States, that America should now open her doors, "not for our best sons, but for the Jews and their Jewish friends about whom a good opinion still exists in America."

The Beobachter urges the German government officially to introduce negotiations with the American government in order to influence Washington to reserve the entire German quota for German Jews instead of non-Jews.

### Nazi Announces Citizenship Figures

**BERLIN, Sept. 13**—Over 1,013 Jews obtained German citizenship in Berlin alone between the years of 1928 to 1930, it was officially announced today in connection with the withdrawal of naturalization certificates now in progress. Forty-one percent of these were Polish Jews and twenty-three percent were "stateless" or men without citizenship in any country.

### Revisionists and Laborites Clash at Vienna Meeting

**VIENNA, Sept. 13**—Five persons were slightly injured and one Revisionist, extreme right wing Zionist, and one Laborite Zionist, were arrested in the course of a serious fight that occurred here last night when Revisionists attempted to break up a meeting arranged by the Laborites to discuss the Eighteenth World Zionist Congress, which closed at Prague. The meeting, which closed prematurely, was to have been addressed by Berel Katzenelson and Israel Moravinsky, Palestine labor leaders.

According to the police report, peace was established only after heavy police reinforcements had arrived on the scene and intervened. The arrested Zionists were released after being detained for a short time.

### Alberg, Noted Attorney, Suicide in Switzerland

**BERLIN, Sept. 13**—Professor Max Alberg, internationally known teacher of law and famous as an attorney, committed suicide yesterday at Sarnaden, Switzerland. Professor Alberg was fifty-six years old. He was of Jewish descent, but had been converted to Christianity in his youth.

Professor Alberg was born in Bonn, Germany, November 16, 1877. He was the author of many books on legal subjects, including one called "The Trial of Socrates in the Light of Modern Jurisprudence and Psychology." He was associate publisher of the Wissenschaftliches Zeitschrift. Professor Alberg was a specialist in defense in important criminal cases. He defended Vice-Chancellor von Helldorf in the trial against Mathias Erbsberger. He was defense attorney in some of the most sensational cases all over Germany in the last twenty years. He was a collector of antique art. Nazi restrictions barred him from practice of his profession.

### Bolivia Denies Reports Of Aid to German Doctors

**BERLIN, Sept. 13**—The Bolivian legation here officially denied today reports that the Bolivian consulate in Warsaw had announced that special facilities would be granted German Jewish dentists and doctors who desire to emigrate to Bolivia.

The Berlin legation declared that on the contrary, all foreign doctors and dentists who go to Bolivia, must pass examinations in Spanish.

### Would Be Christian But For Devotion to Zionism

**Jerusalem, Sept. 13**—Abba Achimeir, an extreme Revisionist and defendant in the Arlossoff murder and British Baryonim addition cases, would become a Christian but for his "devotion to Jabotinsky and Zionism," according to an interview in the Dohar Hayom today.

"I would become a Christian were it not for my devotion to Jabotinsky and Zionism because of the slanders and evils that the Jews are leveling at me," Achimeir told the interviewer.

Asked why he did not turn to Islam, Achimeir answered, "Because my heart turns to the West, not to the East."

The interview followed unusual disclosures yesterday at the magistrate's hearing of charges against fourteen Revisionists accused of belonging to a terroristic secret society.

Zvi Rosin, a handwriting expert and police interpreter, testified re-

### Rosenberg Warns Britain Against Boycott Results

**BERLIN, Sept. 13**—The British attitude is the chief factor in whether or not the Jewish campaign for an anti-German boycott will continue, declares Alfred Rosenberg, head of the Nazi Party's foreign affairs department, writing in the Volkischer Beobachter, Hitler's own newspaper.

Admitting that "execution of the Jewish world boycott must lead to a weakening of Germany's buying power," Rosenberg warns that this will simultaneously and directly affect British exports.

"Combating the boycott, therefore, is not only in the German interests, but also to the interest of the British," he declares. "In addition, there is the fact that if Germany breaks down eventually, all other countries will feel the effect."

Rosenberg expresses the hope that Great Britain will not follow the anti-German policy which he asserts France is circulating for the next League of Nations session.

### Rabbi Levensberg to Head Cleveland Congregations

**CLEVELAND, Sept. 13**—Rabbi J. H. Levensberg was elected chief rabbi of the Federation of Jewish Congregations in popular voting, according to results made known today. He received 1,823 out of approximately 2,500 votes cast. The federation has 28 congregations in its membership.

Germany cannot be expected from an artist whose human dignity has been trodden underfoot and lowered to the level of a parish by the guardians of German culture who ignore Anton Rubenstein, Felix Mendelssohn and Joseph Joachim.

In conclusion, Mr. Haberman stressed his personal friendship for Harry Furtwangler, but regrets that he must renounce Germany as she is now.

In the past few months the efforts of the Nazi regime to induce foreign artists to appear in Germany has proven to be a dismal failure. Some of the most famous artists in the world have refused point blank to appear in Germany as long as the Hitler regime is in power.

garding several letters and professions seized among the possessions of the accused men, which revealed, among other things, plans to employ girl propagandists. He read several extracts from the correspondence.

### Teachings of Christ

One of these, which drew particular attention, was a reference to "a certain Jew in Jerusalem whose ideology rings true and lives within our conscience."

The defense attorney, Dr. Cohen, protested that there was nothing in this reference which could be considered as against the public peace since it referred to Jesus Christ and his revolutionary leadership and did not refer to present-day leaders. He offered to back this assertion with citation of passages from Achiner's diary dealing with the teachings of Christ.

### Had Removed Swastika

One of the disclosures made at the hearing yesterday was that three of the defendants, Dviri, Horowitz and Szwarc, were accused of removing the swastika flag from the German consulate building in Jerusalem last May. A statement to the police by Rudolf Mark of Jerusalem, asserting that the three defendants had removed the flag and that she had taken it to Achiner in Tel Aviv was read to the court. The act was nationalistic, not terrorist, she declared.

The Mark woman was called upon yesterday to testify but refused to do so. She was warned by the magistrate that if she persisted in her refusal before the district court, she would be liable to prosecution.

Inspector Solomon Goffey testified briefly to the finding of documents and other evidence in the possession of Dviri and Horowitz.

Contrary to previous sessions of the hearing, the court was half empty and much of the air of excitement surrounding the earlier sessions was absent. At the conclusion of the hearing, Achiner was removed to prison, where he is held in connection with the Arlossoff murder. The other defendants are free on bail. The hearing will be continued Sept. 26.

## Nazi Press Continuing Strong Attack on Einstein

BERLIN, Sept. 13.—The Voelkischer Beobachter today continued its series of unrelenting attacks on Professor Albert Einstein, featuring a cartoon associating the noted scientist with communism. Under the heading, "The psychopath, Einstein," the paper viciously attacks him for making himself the center of anti-German agitation in England. It quotes him as allegedly declaring in the London Daily Herald that he does not understand why the world does not declare war on Hitler. Against this alleged quotation, the newspaper builds up a heavy attack on the exile. The paper also expresses anger at the report which it also features, that a hundred non-Jewish students have been organized as a bodyguard for Professor Einstein.
