#### Frankfurter Zeitung Hopeful of Pin Holes In Reich Press Gag

(Jewish Telegraphic Agency) BERLIN, Oct. 7—Although the journalists's law framed by Paul Joseph Goebbels, Nazi Minister of Propaganda and Public Enlightenment, makes no exception in the case of Jewish war veterans, ordering a clean expulsion of all who are of Jewish origin, the Frankfurter Zeitung declared today that it has learned that modifications of the law may be expected. The clean sweep provided for by the law at present, will not be executed, it declares.

The Frankfurter Zeitung sees the following loopholes in the law:

1. The possibility that it may not be made retroactive. Thus persons of Jewish origin already in posts may possibly be permitted to retain them

It is the general feeling here that condemnation of Germany's repressive anti-Jewish measures is being soft-pedalled.

Christian L. Lange of Norway, rapporteur for mandates, submitted a resolution at the sixth commission meeting today expressing the League's confidence in mandatory power. The resolution also calls upon Great Britain to fulfill her obligations undertaken for the estab-lishment of a Jewish national home, and establish a method for the set-tlement of refugees and other immigrants who at the present time might possibly create a serious unemployment problem in the Holy Land.

#### Not a Jewish Lawyer In Marburg, Press Boasts; More Dismissals Announced (Jewish Telegraphic Agency)

BERLIN, Oct. 7-Not a single Jewish lawyer now remains in Mar-burg, today's press boasts, declaring that the city is completely "Juden-rein" (free of Jews). The press disclosed that the last Jewish lawyer has just been suspended, in spite of the fact that this is in open contradiction to the declaration of the Minister of Justice that there will be no further dismissals of Jews.

At the same time a large number of Jewish professors and employees of the University of Frankfurt were dismissed today, including ten pro-fessors, twenty-five honorary professors, twelve privatdozents (in-structors) and four commissioned lecturers.

It was also revealed that on October 1, not a single Jewish doctor was left in the Berlin ambulance service.

#### Protestant and Catholic Condemnation of Hitlerism in "The Voice of Religion"

Editorials from the religious press of more than fifteen Christian denominations and statements by lay and religious leaders of Christian opinion on the persecutions of the Tews in Germany are gathered in a Jews in Germany are gathered in a booklet published today by the American Jewish Committee under the title, "The Voice of Religion." Bishop William T. Manning of the diocese of New York; Hilaire Beloc, noted Catholic; Dr. S. Parkes Cadman, former president of the Federal Council of the Churches of Christ in America; Michael Williams, editor of the Catholic weekly, Commonweal; the Archbishop of York, the Archbishop of Canterbury, and Dean Inge are among those who have spoken for the religious conscience of America and England on the oppression of hundreds of thousands of Germans who have worshipped or whose ancestors have worshipped in the Jewish faith. The pamphlet also prints the text of a protest against these persecutions written by Dr. Harry Emerson Fosdick and signed by 1,200 Christian clergymen of the United States and

Canada. Although it is claimed that the resolution does not justify modification of the original resolution adopted before the opening session of the League Agenda Committee, it is urged that the Haiti delegate submit his proposals to the committee, since they are intimately related to the minorities question.

A deadlock in the proceedings of the League of Nations subcommittee dealing with the Jewish question was reached here earlier today when the German delegates made a strong attempt to block the debate on the grounds that the League cannot consider the minorities question. Every other delegation at the session has backed the resolution but unanimity is required for final adoption.

Negotiations are going on with the Reich representatives to induce them to pass the resolution, but little headway is expected. The matter will be brought up before to-night's assembly and is to be submitted to the second committee by Tuesday when it is expected the matter will be decided. The subcommittee's proposed resolution reads Vienna Stuermer Attacks

as follows:
"The Assembly having regarded the situation created by the fact that a large number of persons, including members of the Jewish faith, have left Germany and in recent months taken refuge in several countries; considering their pres-ence in those countries constitutes economic, financial and a social problem which can be solved only with international cooperation, makes the following suggestions:

"1. The League Council nominate a High Commission to negotiate and direct such collaboration.

"2. The expenses of the office of the High Commission are to be defrayed out of a fund contributed by private individuals and from other

"3. The Council is urged to approve a sum not exceeding 2,500 f.ancs to be a working capital for the Commission.

"4. Those states which are memhers of the League that have not as vet received many of the refugees will be urged to open their gates to as many refugees as possible, giving them employment when possible.
"5. The League's Geneva secre-

Sir Austin told representatives of the press that he has not been approached about the matter. He was unable to say whether he will accept the membership on the Commission.

Their contention is that it is a broad hint that the United States and indirectly Canada, lower the bars of immigra-tion. #### Flemish Nazis in Ghent Riot: Police Halt Opening Of Hitler "Green House" (Jewish Telegraphic Agency)

ANTWERP, Belgium, Oct. 7-The demonstration of Flemish Nazis in Ghent, which was to have taken plact last week on the occa-sion of the opening of a Nazi Green House, was frustrated by the police, who surrounded the building and prevented the demonstration, where-upon the Nazis announced that the inauguration of the Green House had been indefinitely postponed.

A fierce agitation by the anti-Semitic group, headed by the daily newspaper L'Assault, has developed in Antwerp in connection with the decision of the Antwerp municipality to withdraw subsidies from all religious schools. Despite the fact that the Jewish schools are also af-fected, L'Aassault alleges that the Jews continue to obtain a subsidy of 250,000 francs, inciting the population against this alleged domination by the Jews.

#### Lewis Douglas to Address Federation Dinner Starting 1933 Appeal for \$4,200,000

Lewis W. Douglas, Federal director of the budget, will head the list of speakers at the opening dinner of the 1933 appeal of the Federation for the Support of Jewish Philanthropic Societies to be held next Sunday evening at the Hotel Commodore. The dinner, at which Supreme Court Justice Samuel I. Rosenman will preside, will launch the campaign to complete a budget of \$4,200,000 for the support of the Federation's ninety-one affiliated charitable agencies.

Chairmen of 130 committees, each designed to promote the raising of funds in a specific trade or profession, were announced by Samuel D. Leidesdorf, chairman of the Business Men's Council, the Federation's money-raising unit. Membership in the committee will be drawn from an army of 2,500 volunteer workers.

Speakers at the dinner will include former Justice Joseph M. Proskauer, the Federation's president, and Mrs. Felix M. Warburg, co-chairman of the campaign in the Women's Division, in addition to Mr. Douglas and Justice Rosenman,

Early responses from civic, business, social and philanthropic leaders indicate that a record number of persons will attend the event. More than 1,200 men and women are expected to be present.

In announcing completion of the list of trade chairmen, Mr. Leidesdorf said: "The enthusiasm with which our chairmen, all men of prominence in their respective fields. volunteered their services makes us extremely hopeful of attaining our goal in this year's campaign.
