Palestine Authorities Start Drive to Halt Illegal Entry of Jews

(Jewish Telegraphic Agency) IERUSALEM, Nov. 13-A concerted effort on the part of British officials to end illegal immigration into Palestine tightened here today when a mass hunt, directed exclusively against Tewish newcomers.

was started. The campaign, which is assuming the proportions of a large-scale pursuit of violators, is in line with a pronouncement made in the British House of Commons by Sir Philip Cunliffe-Lister, Secretary of State for the Colonies in the Cabinet, last Thursday, that vigorous steps would be taken to prevent illegal immigration.

Special motorboat patrols were de-tailed in the vicinity of Haifa, while British and Arab constables, assisted by peasants, engaged themselves in scouring the coastwise territory

Protest Settlement of Jewish Refugees in Cyprus (Jewish Telegraphic Agency)

ATHENS, Greece, Nov. 13-The threat that sixty thousand Jews will be forcibly expelled from Salonica if it is true that German-Jewish refugees, numbering approximately 50,-000 persons, are to be settled in the isle of Cyprus, was made in Imerisios Kyrix, a daily newspaper published here. The paper gave prominence to an

article reporting that the World Conference for the relief of Ger-man-Jewish refugees held at London had adopted resolutions to this effect and warned that if the report were true, expulsion of Jews would follow any attempt to carry it out.

The article adds a proposal that the Greek claim to possession of the island should be seriously consid-ered, since the majority of its population is Greek. (Four-fifths of the inhabitants of the island, which was annexed by Great Britain in 1914, are Greek Christians while the remainder are Turkish Mohamme-

McDONALD ACREES TO FIGHT JEWISH REPRESENTATIVES ON REFUGEE COMMISSION

GENEVA, Nov. 13—High Com-missioner James G. McDonald to-day agreed to invite eight Jewish mous governing body organizations to be represented in the League of Nations autonomous governing body for German refu-gees, in accordance with the decis-ion of the London conference for the relief of German Jews. from the governing body, composed of representatives of fifteen nations, including the United States. To Boycott Nazi Goods (Jewish Daily Bulletin)

MILWAUKEE, Nov. 13-An endorsement given by the Socialist party of Milwaukee to the local Deutsche Zeitung, a German daily,

has been withdrawn because of the paper's pro-Hitler sympathies, it was revealed here. Organized about a year ago as a

liberal newspaper, the Deutsche Zeitung was given Socialist support to help it in its drive for subscribers. The paper was sponsored largely by the various German-American

societies of Milwaukee. At a large anti-Fascist rally here

under the auspices of the Socialist party, Heinrich Bartel, former edi-tor of the Milwaukee Vorvaerts, a German Socialist weekly, belabored the Germans here who cling to a blind loyalty to "Das Vaterland" in spite of its present rulers. He called for a boycott by Germans of all German products as long as the Nazis remain in power. He attacked the entire German-American press as being almost completely pro-

Large Chicken Farm Planned for Palestine

(J.T.A. Special Correspondence) JERUSALEM, Nov. 1-Elaborate plans for the establishment of a large poultry-raising settlement have been projected by Mr. Maniloff, an American Jew, to meet the large demand for poultry products.

It is estimated that the Jewish population consumes a hundred mil-lion eggs annually. Farmers are producing about one-tenth of the supply, the rest being obtained from foreign countries. Approximately £250,000 are expended on imported poultry products to this country.

The poultry settlement will be financed by loans floated for three years. Fruit and vegetable farms will supplement the chicken raising. A central marketing unit will dis-

tribute the products.

Dickstein Inquiry Holds

WASHINGTON, Nov. 13-Public hearings on Nazi propaganda activities in the United States will open here tomorrow when the sub-committee of the Committee on Imimigration of the House of Representatives will hear the first witnesses called to testify in the investigation ordered by Congressman Samuel Dickstein, chairman of the Committee on Immigration.

The committee began its work today in a private session at which its course of procedure was outlined. The investigation will concentrate on the activities of aliens in this country with the general purpose of having the deportation ordered of all aliens found to be engaged in subversive activities in connection with efforts of the Nazis in this country.

The first public hearing will open at 10:30 A.M. tomorrow. The names of the witnesses to be called were not disclosed this afternoon.

The investigation committee is composed of Congressman Dickstein, John H. Kerr, Mell G. Underwood, Eugene B. Crowe, Martin Dies, Charles Kramer, J. Will Tay-lor, Benjamin Focht and Everett M. Dirksen.

Untermyer Fails to Attend Order B'nai B'rith Banquet Because of Boycott Stand

The ninetieth anniversary of the founding of the B'nai B'rith is being commemorated this week by celebrations of the various branches of the order. Plans for the week-long celebration include meetings by va-rious lodges, addresses by Jewish notables, patriotic exercises and special religious services.

The commemoration of the B'nai B'rith anniversary began with a banquet Sunday night at the Hotel

Roosevelt.

Samuel Untermyer, president of the League for the Defense of Jewish Rights, who was to have been one of the main speakers, declined to attend the banquet because of an article against the boycott of Germany, reprinted in the B'nai B'rith Magazine.

Mr. Untermyer was to have spoken on "World Jewry." His refusal to speak was made known by the chairman of the celebration committee, Dr. Harold Korn, who acted as toastmaster.

"A reply has been sent to Mr. Untermyer, expressing keen disap-pointment at his decision not to speak here," declared Dr. Korn. "It has been made clear to him that the B'nai B'rith Magazine is an open forum for the free expression of opinion. Articles on both sides of controversial subjects, such as Zionism, have appeared in it without in any way being an expression of the Order. Had Mr. Untermyer availed himself of the opportunity of speak-ing here, this audience would have tal decree. welcomed hearing his views on the "All dis subject World Jewry'."

Recovery Assembly Votes Study Plan for New Leisure

To meet the new leisure created as a result of the NRA, the National Recovery Assembly convened by the United Synagogue Sunday decided to establish a central bureau which will seek the cooperation of institutions of higher learning. Formal study courses in the field of Bible, history and current events will be organized, seminars dealing with communal and individual problems will be held and courses conducted for leaders and aspirants to leadership of the synagogue and its affiliated institutions. In this way it is hoped that the problem of the new leisure will be met in every community. Credits for these courses will be given and certificates will be issued by the United Synagogue of America. The assembly adopted a budget of

\$50,000, submitted by Israel Silber-man, treasurer of the United Synagogue. A campaign among the syn-agogues to raise this sum will begin at once.

Louis J. Moss, president of the United Synagogue, declared that the NRA is the dawn of a new era for countless thousands, not only eco-nomically but spiritually as well. "It represents the fulfillment of one of the chief aims of the socially mind-ed," Mr. Moss said. "And it is the answer to the fervent prayers of rel-What was sought to be acigion. complished on broad and humanitarian grounds with but very little success has been brought about as an economic measure by governmen-

"All distinctions based on social and financial cleavage must be abolished in the synagogue. We must give greater recognition to those who serve and less to those who give," declared Mr. Moss.

It is expected that the first guns of opposition to the affair, which will display the swastika emblem, will be sounded at the meeting. Mr. Rosenbaum said that many

leaders of Jewish societies have indicated an eagerness to take action on the matter and define their viewpoint on plans being set forth by the Steuben Society, sponsors of the affair.

Vereins Aid Fete

While no definite plans for the program of the celebration have been completed as yet, the week-end saw additional support of German societies being swung to the Steuben Society.
The United Plattdeutsch Vereins

on Sunday unanimously voted to take part in the celebration, and at the same time the Schwaben Ve-rein of New York warmly applauded their president, Christian Schwarz, when he called upon them to present a united German front at the festivaties and urged all Germans and those of German descent to "fight for a place in the sun" for their fatherland. Mr. Schwarz's plea was made at the church fest of the yerein Sunday night at Ebling's Casino. At the meeting of the Plattdeutsch Vereins, the president, William G. Fust, demanded that the various or-ganizations represented be present at the German Day celebration. One thousand tickets for the affair were

distributed among those attending the Sunday session in the German Free Mason Temple. President Fust was granted spe-cial powers of calling the vereins together at a later date in the event

Warsaw Rabbinate Asks Pres. Roosevelt to Permit Woman to See Son in U. S. (J.T.A. Special Correspondence)

WARSAW, Oct. 27-A letter from the rabbinate of Warsaw to President Roosevelt may be the means of uniting a Tewish mother in Poland with her only son, whom she left with her mother-in-law twenty years ago. The young man is now a student in Cleveland, Ohio.

In 1913. Zeshe Rusne, a widowed seamstress, left her four-year-old son with her mother-in-law in the town of Lomza and went to Warsaw to earn her living. She did not correspond with her mother-in-law. with whom she had quarreled, so that in a short time she lost all contact with her son. When a fit of longing for the child finally seized her, she returned to Lomza, only to find that the mother-in-law had left for the United States and had

Zeshe Rusne's desire to see her son grew, and she toiled hard and long to earn passage to the Argen-tine. The United States would not admit her, but she consoled herself with assurances that being in the Argentine brought her nearer the

child. Twenty years passed, yet the mother found no way to see her son. As a last resort she inserted an advertisement in a New York Jewish newspaper, asking for in-formation about her child. A few months later, the advertisement having brought no answer and Zeshe's second husband, whom she had married in the interim, having also died, the disappointed mother gave up hope of ever seeing her son and returned to Poland.

A few days ago she received a message from the Argentine to the effect that eight days after her departure for Poland, her son had arrived in the Argentine. He had seen the advertisement in the newspaper. Of course, when the young man did not find his mother, he returned very much disappointed to the United States.

Zeshe Rusne, her hope of seeing her son once more aroused, appealed to the rabbinate here to get her a tourist passport to Cleveland. The rabbinate forthwith sent a letter containing the story to President Roosevelt, in the hope that he will take action so that mother and son may meet again.

(Continued from Page 1) for smuggling of Jewish immigrants. A reward was announced by the government for the capture of culprits.

Along the northern frontier of the Holy Land, control of traffic was tightened, but only passports held by Jews were carefully examined.

The new regulations governing immigration require a deposit of immigration require a deposit or sixty pounds as surety from Jewish tourists coming from certain coun-tries. This is intended to preclude the possibility that they will overstav.

Tourists now in Palestine are to be questioned, while prospective vis-itors will be obliged henceforth to undergo examinations. Legal immigration by means of certificates is not to be affected.
