#### McDonald and Britain at Odds Over Palestine's Part In Refugee Settlement Work

(Jewish Telegraphic Agency) GENEVA, Nov. 27-Differences of opinion have arisen between James G. McDonald, who was ap-German refugee problem, and the British government, it is learned. The differences are based on the British government's condition at the time the League took action on the refugee situation by creating an autonomous governing body and the post of High Commissioner to exclude Palestine, over which Great Britain holds the mandate, from the sphere of activities of the High Commissioner.

This condition, it is learned, was made at a private session of the League and Palestine was accordingly omitted from the resolution which the League adopted creating the refugee assistance body.

In case one of the parents is dead, proci must be submitted that the parents lived together at least three years, otherwise the children will be officially declared illegitimate. They

#### Kalinin Voices Approval Of Jewish Bureya Unit; Creation Delayed Until 1937

(Jewish Telegraphic Agency) MOSCOW, Nov. 27-Michael Kalinin, president of the Union of Socialist Soviet Republics, in an inter-view with the Jewish Telegraphic Agency correspondent, today spoke with enthusiasm of the project for the establishment of an autonomous Tewish republic at Bureva in Siberia. within the Soviet Union, and of Iewish possibilities there.

"If I were a Jewish agriculturist, I most likely would have, myself, settled in Bureya, since there is nothing more interesting than the building up of one's own home," declared

M. Kalinin expressed his conviction that the possibilities for Jews in Bureya are great and made clear his approval of the work of establishing the first Jewish republic there. Plans for the creation of an au-

tonomous Jewish unit in Bureya, however, have not proceeded according to schedule. Jewish immigration and settlement of the area has not proceeded with the expected speed, with the result, the Jewish Tele-graphic Agency learned today on excellent authority, that autonomous status will not be proclaimed until 1937, when it is expected that one-half of the population of the area will be Jewish. #### Joint Distribution Committee Says Funds Must Be Increased For Relief of German Jewry

On account of the unrelenting anti-Tewish repressions in Germany which are reported to be growing in scope and intensity, there is a need for immediate measures in relief of the children of the German Jewish Funds must be raised at families. once for salvation of these children. according to an announcement of the German Relief Fund of the American Jewish Joint Distribution Committee of which Rabbi Jonah B. Wise is chairman.

Present plans of the Committee call for an immediate expenditure of \$1,200,000 in addition to sums al-ready advanced for German Jewish relief purposes.

"Those who are ashamed to dis-close their poverty as well as those who admit it will have to be helped," said Rabbi Wise. "But should there be new calamities, if the Jew will not be included among the benefi-ciaries of governmental relief funds, which has been the case in a number of local instances, then such large sums would be required to maintain Jewish life in Germany that it would be idle even to estimate them."

Their descendants are supposed to have inherited their virtues and capacities for miracles intact. Each Chassidic rabbi has his own followers, scattered over the world, who make it a custom to visit the rabbi as often as possible, particularly when they are in trouble and need his advice. #### Warsaw Forbids Protests On Palestine Immigration (Tewish Telegraphic Agency)

WARSAW, Nov. 27-Polish authorities have strictly forbidden any further street demonstrations, such as the Polish Jews have been carrying on, as a protest against the drastic restrictions on Jewish immigration recently imposed by the Palea-tine government. The authorities announced vesterday that only one of the many scheduled mass meet-

ings of protest would be permitted.
Recently Polish Zionists of various factions carried out a protest demonstration in front of the Brit-ish Embassy in Warsaw. It was broken up only after the police charged the demonstrators and arrested several of them.

The Jews of Poland, who look upon Palestine as one of the few countries capable of absorbing a large number of Polish Jewish immigrants, have reacted violently to the curtailment of Jewish immigration into Palestine.

#### Rabbi Konvitz Supports Newark Plea for Kosher Meat for Jewish Needy

(Jewish Daily Bulletin) NEWARK, N. J., Nov. 27-The request of local Jewish agencies for kosher meat for the needy of that race instead of pork was strengthened by an admonition addressed by Rabbi Joseph Konvitz, newly-elected president of the Union of Orthodox Rabbis of the United States and Canada, to government officials, cautioning them "not to violate the feelings of the needy Iews by offering them salt pork."

Earlier in the week, the local relief office had forwarded to its cooperative agency, the Jewish Social Service Bureau, a batch of orders for salt pork, which were to be made available to needy Jewish families. The Bureau promptly returned them and the state relief administration was urged to provide kosher meat instead.

#### French Anti-Semitism Body To Start Self-Defense Units

(Jewish Telegraphic Agency) PARIS, Nov. 27-Violent anti-Zionist sentiment was displayed yes-terday by some of the delegates at the fourth congress of the League to Combat Anti-Semitism, which opened its sittings Saturday. The congress, however, after debate, de-cided to continue its policy of friendly neutrality toward the Zionist movement.

Helmuth von Gerlach, interna-tionally known German pacifist and former editor of the Welt am Montag, who is now a refugee, received a tremendous ovation when he ap-

peared at the congress. Bernard Lecache was reelected as

president of the League. The League adopted the boycott as the best weapon with which to combat Hitlerism. The congress also decided to create Jewish self-defense groups for the purpose of beating back the anti-Semites.

The congress concluded last night with a banquet at which the noted French statesman, Senator Anatol de Monzie, presided.

#### **Budapest Crowd Attacks** Nazis Disturbing Meeting (Jewish Telegraphic Agency)

BUDAPEST, Hungary, Nov. 27-Hungarian Nazis repeatedly interrupted the Jewish Deputy, Bela Fabian, who today addressed a political meeting in the Redoutensal, shouting abuses of the Jews. Finally the audience became so incensed that the entire group, including non-Jews turned on the Nazi intruders and beat them. Police were called to re-establish peace in the hall. They arrested a dozen of the hall. They arrested a dozen of the wastika, and all reference to real-librothyn singing societies.

#### Grand Jury Resumes Its Probe of Nazi Propaganda, Hears New Witnesses

Presenting a new set of witnesses, Assistant United States Attorney William Prager yesterday resumed hearings before the federal Grand Jury on Nazi affairs in this country. While Mr. Prager would admit only that hearings have been resumed "for the purpose of gathering further evidence" on Nazi organiza-tions and operations in this country, it is believed that the case is being prosecuted with a view toward securing indictments against a number of German agents of the Hitler Government now working in

the United States. Count Sauerman Douglas, known at present as Dr. Albrecht Sauerman, was questioned at length by the Grand Jury yesterday.

Miss Elizabeth Adams, secretary to Joachim Deutsch, was also put on the stand yesterday, where she was questioned by the federal panel.

Walter Kauf, convicted by a Newark jury as Spanknobel's bodyguard ark jury as Spankrobel's bodyguard for having carried concealed wea-pons to a meeting of the League of Friends of New Germany and for having wielded a lead pipe in a riot which took place after the meeting, was also before the Grand Jury. Plans to deport Kauf were protested by Representative Samuel Dickstein on the ground that he could give valuable testimony before both the Grand Jury and the House Committee on Immigration, which, under the chairmanship of Dickstein, is conducting its own investigation into Nazi operations.

Engeborg Roell, another promi-nent member of the German com-munity, also testified yesterday. Hearings will be held again today.

#### Swastika-less Fete Marks Brooklyn German Day Thousands of German-Americans

gathered in the Labor Lyceum in Brooklyn, Sunday night, to celebrate German Day, a fete commemorating the 250th anniversary of the landing of the earliest German immigrants in this country.

The success of the affair was described by those who attended as merely a prelimi-nary to the occasion of the German Day celebration which will be held in Madison Square Garden on December 6.

#### Hospitals Understaffed Because Jews Ousted Goebbels Paper States

(Jewish Telegraphic Agency) BERLIN, Nov. 27—Hospitals in Germany are working with fifty per-cent of their normal staff. A tremendous shortage of qualified medimemous snortage or quanted medi-cal men, doctors, professors and chemists exists, tonight's Angriff de-clares. The Nazi paper added that 518 of the best medical men in Ger-many had been removed from hos-pitals because they were Jewish.

While among the lower ranks of the medical profession the proportion of Jews is small and their expulsion was unfelt, the highest Jewish percentage was among the high-ly qualified leading spirits of Ger-man medicine, the Angriff stated. The Nazi newspaper, whose chief editor is Dr. Goebbels, Nazi Minister of Propaganda, declared that the proportion of Jews among the clerical staffs of the hospitals was small.

#### 6 Arrested in Connection With Anti-Nazi Riots in Boston (Tewish Daily Bulletin)

BOSTON, Mass., Nov. 27-Six persons were arraigned today in the Municipal Court for participating in the riot Sunday afternoon which was caused by an address delivered in defense of the Hitler government by a German pedagogue.

The rioting, in which it is esti-mated 5,000 persons engaged, ended in a clash between the police and the mob. A number of persons were

injured.

Professor Friedrich Schoenemann of the University of Berlin, who spoke on "Why I Believe in the Hit-ler government", was the object of the protest. In his address the speaker declared that anti-Jewish persecutions are the "natural" result of the revolution, and he lauded Hitler as the unifier of the German people.

that in making the condition regarding exclusion of Palestine from the High Commissioner's sphere, the British government merely wished to safeguard itself from intervention in the affairs of Palestine by another international body similar to the feel that Great British will give way to Mr. McDonald's demand for a quota distinct from the present allocation of immigration certificates made to the Jewish Agency for Pal-

The first meeting of the autonomous governing body set up by the League, in which fifteen countries are participating through representatives, will be held at Lausanne, December 5. At the meeting, three proposals concerning participation in the refugee settlement work by private relief and welfare organizations will be considered.

The first of these calls for the invitation to private organizations to send representatives to occupy permanent, non-voting seats in the governing body.

The second proposal calls for the creation of a separate body composed of representatives of the private organizations interested in the refugee work. This body would advise and cooperate with the High Commissioner.

The third proposal calls for the attendance at some or all of the governing body meetings of one or more representatives selected by this proposed body. This representative or representatives would act in a consultative capacity only.

Mr. McDonald, it is understood, is in favor of the latter proposal, considering that he would be able to achieve better results in the negotiations he will have to conduct if he can act as the representative of the various governments involved, not as the agent of private relief agencies and organizations.

will also be prohibited from carrying
the title of the parents.

Within the next six months, it was announced, all marriages of the last fifteen years will be sharply scrutinized and the titles cancelled in the categories enumerated, especially those marriages of Jewish women who married into the German nobility in order to acquire a title. Children who are declared illegiti-

mate, will be able to claim support from the father, just as other illegitimates are entitled to do under the law. The law will also be applicable to cases where Gentile families have adopted Jewish children.

This law is merely another step in the process of racial purification undertaken by the Nazis. Recently the German Nobles Association announced that all members would be compelled to prove their ancestry free of Jewish blood as far back as 1750. All members who fail to pass this test will be expelled.
