Czechoslovakia Demands Report on Czech Jewish Victims of Nazi Raids (Jewish Telegraphic Agency)

PRAGUE, Dec. 13-A warning to the German government was sounded today by Czechoslovakia in the repeated demand for information concerning the fate of many Cze-choslovakian citizens, mostly Jews, who had resided in Germany and had been arrested by the Nazi au-Communist sympathizers.

Most of these people, under the pretext of this suspicion, were taken from their homes and have disappeared from the sight of their relatives and friends, who fear that they were tortured to death in custody.

The Berlin secret police declined to furnish the Czechoslovakian government with the information on previous occasions as a matter of principle. The latter warned today, however, that unless the information is forthcoming, the list of names of those who have disappeared, with what details are known about their disappearance, will be published. The list has not yet been published, according to government authorities, in the interest of the persons in-

Hungarian Students Renew Rioting Despite Agreement On Anti-Jewish Demands

(Jewish Telegraphic Agency) BUDAPEST, Dec. 13 - Anti-Semitic disturbances broke out again today in Hungarian institutions despite the agreement reached between the demonstrating students and the government whereby the former pledged themselves to observe the peace when the government agreed to meet the majority of the student thorities under suspicion of being demands for restriction of Jewish registration in the universities and aid to Christian graduates. Prompt action by the dean of the

University of Debrecin today prevented physical maltreatment of Jewish students there when antiemitic rioting was resumed.

The Polytechnic Institute at the University of Budapest was also the scene of disorders today. The Institute was closed down immediately.

Bondholders Challenge Schacht Debt Statement

The American Council of Foreign Bondholders, with headquarters at 49 Wall Street, has issued a statement challenging an assertion made by Dr. Hjalmar Schacht, president of the Reichsbank, to the effect that the anti-German boycott puts foreign investors in danger of losing dividend payments, as well as payment on principal.

The statement, bearing the signature of Dr. Max Winkler, consulting economist, declares that on June 9, previous to the support pledged to the boycott by large American orgarications, including the American orga-nizations, including the American Federation of Labor, Dr. Schacht himself announced that foreign in-vestments had been defaulted by the German government.

"An analysis of German foreign trade," continued the statement, "as officially reported by the various German governmental agencies, suggests either that Germany is wilfully withholding what is rightfully due the American investing public, that statistics regarding the Reich's economic conditions are inaccurate, or that they are prepared for domestic consumption.

Leon Barzin, viola, and Ossip Gis-kin, violin cello, will join with Pro-fessor Einstein and Mr. Seidl in a chamber music evening. Harriet Cohen, celebrated British pianist, will also participate in the program. Emil Hild will conduct a chamber music orchestra in a double concerto by Bach.

Revoke Arvan Church Clause **But Racial Principle Holds** (Jewish Telegraphic Agency)

BERLIN, Dec. 13-The so-called Aryan clause barring non-Aryans from positions in the German Protestant Church has been removed. This, in effect, would make possible the holding of church office by Christians of Jewish ancestry.

Revocation of the Aryan clause, while hailed as a victory of the moderate elements in the church, is expected to be counteracted by new regulations governing the admission of students of theological seminaries. A law establishing a strict one and a half percent numerus clausus for non-Aryan students will be promulgated, according to the church press department. The law will make the racial principle as binding in the church as the Aryan clause which now has been revoked.

Growth of Tel Aviv Revealed in Figures

(J.T.A. Special Correspondence) TEL AVIV, Palestine, Nov. 26-The Municipality Bulletin publishes today some interesting statistics about this all-Jewish city.

The population is about 80,000. There were 2,198 births compared with 1,930 last year. The mortality was 689, compared with 634 last year. There were 901 marriages compared with 757 in 1932. Divorce figures increased from 176 to 240.

Municipal revenues during August were nearly sixteen thousand pounds and revenue for six months between April and September totaled about 85 thousand pounds. The income from building licenses trebled, water taxes doubled and other items showed a substantial increase

Temple Brotherhoods to Mark Chanukah Sunday

The seventh annual Chanukah dinner of the Metropolitan Conference of Temple Brotherhoods will be held Sunday evening, December 17, at the Hotel Astor. The affair will be part of a nation-wide celebration of the holiday sponsored by the National Federation of Temple Brotherhoods

Among the invited guests are Judge Irving Lehman, president of Temple Emanu El; Supreme Court Justice Meier Steinbrink, former Republican Coun-ty leader; Mrs. Jean Wise, president of the State Federation of Temple Sisterhoods, and others. Dr. A. L. Sacher, of the University of Illinois, will be the principal speaker.

Ambassador Luther Booed At Columbia Address

Braving a demonstration by student and New York anti-Fascist or-ganizations, Dr. Hans Luther, German ambassador to the United States, lectured before a large audi-ence in the Horace Mann audi-torium at Columbia University Tuesday night.

In sharp contrast to his address last Wednesday before enthusiastic celebrants of German Day in the Madison Square Garden when he launched a severe attack on the Versailles Treaty, Dr. Luther was strictly on the defensive before his highly critical audience at the university. Despite the efforts of large detachments of police who had been stationed within and outside the auditorium, heckling and anti-Nazi protests were distinctly more signi-ficant of popular sentiment than the support gained by the German ambassador.

Repeated charges by police and their severely enforced restrictions against loitering outside the audi-torium failed to dampen the ardor of anti-Fascist groups of Socialist, Communist, and independent organizations.

Luther, lending his address to a defense of his chancellor's policies, confined his remarks to denials of Germany's reported desire for war and export of Nazi propaganda, par-ticularly to the United States, for the purpose of undermining the con-

stitution of this country. From 116th Street and Broadway to 120th Street where Luther spoke and where antagonist groups held their demonstrations, Broadway was spotted with placarded denunciations of Hitler. A number of cardboards contained only a large black swas-

contained only a large black swas-tika dripping red.

Stopped by police from meeting in the shelter of the Horace Mann Auditorium, hundreds of protestants met on the far, unsheltered side of the street, where speakers berated Nazi agents, Dr. Luther in particular, and regaled the police for their interference with free speech. One speaker, addressing his street audience from a soap box, declared in part: "We know that Nazi organizations are being formed in this university and in every university in the country. They are plotting to overthrow our government under our very noses." He demanded action in ousting foreign propagan-dists from Columbia.

Inside the auditorium Dr. Luther met heavy opposition. He had no sooner mounted the rostrum than, "Why did Hitler burn the homes of German professors?" a young wo-man in the audience flung at him. Perceptibly embarrassed, the ambassador attempted to begin his adlast election for City Court Justice.

Federal Panel Ends Nazi Probe and Is Discharged

The federal grand jury, which for the last three months has been hearing testimony of various persons concerned with Nazi affairs in the United States and which handed down an indictment against Heinz Snanknoebel two months ago, was discharged vesterday.

It was explained that the time specified by law for a grand jury to be in session, three months, had elansed and adjournment therefore hecame automatic.

In discharging the jury, Federal Judge Grover C. Moscowitz ten-dered the thanks of the court for their services and complimented the members of the jury on the manner in which they heard testimony and acted upon it.

William Prager, Assistant United States Attorney, explained after the grand jury had been discharged that the adjournment did not necessarily imply that the federal investigation of Nazi affairs had been dropped. When asked whether or not he was contemplating resuming hearings before a new grand jury Mr. Prager was uncommunicative.

A large majority of the witnesses called before the federal grand jury, now adjourned, had been members of the League of Friends of New Germany, an organization created and led by Heinz Spanknoebel, now a fugitive from justice for having failed to present credentials as a German agent to the United States Department of State, a law created during the World War to cope with the threat of spies and agitators. No other indictments were handed down by the jury.

Advertised as a meeting which was to celebrate the anniversary of General Allenby's victorious entry into Jerusalem, the real purpose of the convention was obviously known to a considerable number of prominent political figures who declined invitations to attend. Among those present were one member of Partiament, diplomatic representatives of Arab countries, Lithuanian and Latvian ministers and the Roumanian charge d'affaires.

Following an appeal for funds to support the activities of the anti-Semitic group, Walter S. Taylor, former military governor of Jeru-salem, said that while he did not object to the idealistic aims of Zionisin, he opposes "the materialistic ambitions of the Jews in Palestine.

Viscount Heresford, who presided at the meeting, made the assertion that Zionists are underpaying the Arab landowners for their property.

Prosperity in Palestine Encourages Settlement By Jewish Immigrants

In spite of the depression, Palestine is enjoying a phenomenal pros-perity, reflected in expanded foreign trade, a government surplus and an acute shortage of labor, according to the Palestine Economic News, bulletin issued by the American Economic Committee for Palestine. The committee is devoted to the encouragement of private initiative in and promotion of the economic develop-ment of Palestine. Judge Julian W. Mack is honorary president and Israel B. Brodie is president of the committee.

The current survey is prefaced with a statement by Dr. Paul P. Gourrich, consultant economist to leading financial institutions in this country and an authority on railroads, who terms the economic situation in Palestine "almost as miraculous as the miracles of the Exo-In a world harassed by stag gering unemployment and unbalanced budgets, Palestine emerges as "the one bright ray of sunlight" and constitutes "a challenge to world economy-the proof that, when confronted with will power and determination, so-called economic laws and cycles become meaningless and ficti-

The bulletin contains statistical tables on price movements, foreign trade, agricultural and industrial development, immigration, government finances, etc., reflecting the unique prosperity of this pioneer country. The excess of government receipts over expenditures for the five-month period ending August 31, 1933, amounts to £482,272 as compared to a surplus of £190,978 for the same period last year.

Imports during the three months of April, May and June 1933 totalled £2,498,060 as compared to £1,660,526 in 1932. Exports of oranges for the same three months rose from 86,054 cases in 1932 to 137,728 cases in 1933

The number of Jewish industrial enterprises rose from 2,475 in 1929 to 3,132 in 1933, with a corresponding rise in invested capital from £2,235,000 to £4,630,000 and an increase in the number of employees and working employers from 10,968 to 16.870 persons.

as another question was shricked from the same interrogator. By this time police and ushers had begun carrying her from the room.

Three times the ambassador attempted to address his audience, and three times he was interrupted. Likewise, on three occasions the police attendants sprang into action, muffling the cries of hecklers with their hands as they dragged them from the auditorium. One of the hecklers, who screamed "Down with Hitler!" until she was carried out, was identified as a woman teacher of German at Columbia. The "Bronx Cheer" was heard in

the austere atmosphere of Morningside Heights as Russell Potter apologized at the end of the address for "the ill-mannered children", who contributed to the interruptions. Tardy hecklers, however, appeared to lack the spirit that marked early objections to the ambassador.

Luther declared in his speech that Germany was prepared to disarm to the last rifle if other European nations would do likewise. He explained that Germany had carried out the requirements of the Versailles Treaty despite the fact that other nations had violated every clause of the disarmament section.

He denied the "absolutism" of the German Government. He stated that it was not a commodity for ex-The ambassador said that "Ger-

many has not started propaganda in the United States with the idiotic aim of undermining the American Constitution. "I myself would certainly not de-

vote myself to such propaganda," he said.
