Palestine Tourist Hunt Turns on Europeans; Many Are Held for Deportation

Jewish Telegraphic Agency) JERUSALEM, Dec. 14—The campaign of the Palestine administration to round up all Jews in the country illegally, previously directed almost exclusively against Oriental Jews, veered in a new direction to-day when police and immigration officials took into custody a number of tourists from European countries, including Germany, who had remained in the country for a longer period than called for by their passports. All those arrested had found employment in the country

and had been gainfully employed.

Those arrested for being in the country illegally included Alfred Drucker and his wife, who came here eight months ago from Vienna; Jacob Levinter and Rudolf Ringer, also of Vienna, who have been here for five months, and Max Fogel, of Leipzig. All have been imprisoned pending their deportation.

#### Hungarian Students Riot In Nazi Move to Force Gov't Into Difficulties (Jewish Telegraphic Agency)

BUDAPEST, Dec. 14 - Student anti-Semitic disorders were vigor-ously resumed throughout all Hun-garian universities today as Nazi Premier Julius Goemboes to action for the maintenance of peace. Should the Hungarian dictator intervene against the rioting students, the Nazis would succeed in having forced him into the unpopular role of defender of the Jews.
Count Alexander Festetic, wealthy
supporter of Goemboes, whose de-

fection from the government ranks was reported several weeks ago, yesterday formally announced his resignation from the government party and proclaimed his intention to devote all his wealth and energy to the building up of a Nazi party in Hungary mainly on the basis of anti-Semitism. His announcement came after Premier Goemboes had vigurously den. tem.

Serious disorders were reported today from all university towns. At the University of Budapest, the dean of the Agricultural College attempted to calm down rowdy students but they drowned his remarks in a bedlam of anti-Semitic imprecations and songs. The rector of the university was compelled to call out the police to prevent students of the Polytechnic Institute which was closed yesterday, from entering the university grounds to attack Jewish students. The police were also called upon

to disperse a student demonstration in the streets of Budapest.

(Continued from Page 1) were responsible for the length of its duration.

In a statement issued here. Dr. Derry said:

"It was most unfortunate that a single phrase of mine, torn from its context in an extempore address and enveloped in phraseology that was not my own, should have appeared in the press and given occasion to my Jewish friends to interpret a single adjective as an aspersion on their race. Nothing could possibly have been more remote from my meaning or intent.

"In my remarks, in which I was discussing what I consider the four chief causes of the depression, I mentioned, as one factor, gold and the influence of international movements of gold on prices in the mar-kets of the world; in this connec-tion, I did once inadvertently use the phrase, 'a very small group of international Jews', alluding to the great international families like the Rothschilds, with whose position and power in the European banking world you cannot be unfamiliar. But sensing vaguely at once, even amid the excitement of delivery, how this phrase might be misconstrued and distorted out of its prospective, I immediately corrected the expression to 'international bankers' and 'international financial capitalists', Federation Breakfast which I employed several times in what was, after all, but a small portion of an address devoted for the most part to totally different phases of the economic situation.

"And, that it call upon the judicial and executive officials of the States in which lynchings have been perpetrated to perform their duty in bringing violators of the law before the bar of justice."

The editorial questions the sincerity of Dr. Nicholas Murray Butler, president of the University, in claiming freedom of speech to be one of his political creeds. Entitled "Dr. Luther and Dr. Butler-Par-don Their Embarrassment", The Post cites among other things the dismissal from the University staff of Donald Henderson, crusading in-James McKeon Cattell, Professor Henry Wadsworth Longfellow Dana and Charles A. Beard, historian, as Amon instances of Dr. Butler's illiberality. Another point made in the editorial is to the effect that Dr. Luther, hitherto a staunch defender of the Republic, is made a mouthpiece for a nation whose political platform he

"The Evening Post does not blame Dr. Butler for Dr. Luther's appearance at Columbia. Like Dr. Butler, this newspaper believes in free speech for all, even for those with whom it disagrees. But we cannot help feeling sorry for Dr. Butler in his embarrassment. An aroused student body and an aroused citizenry want to know why Dr. Butler brings Dr. Luther to Columbia, which is Dr. Lutter to Columbia, which is supposed to spread information and not hokum. Dr. Butler answers free speech, and Dr. Butler is right. And is Dr. Butler's lace red?"

The editorial proceeds to enumer-ate instances of Dr. Butler's viola-tion of what The Post calls freedom

of speech. "Dr. Butler may be liberal enough to lend Columbia to Dr. Luther for

#### Kauf, Spanknoebel Aide, Gets Six-month Sentence (Jewish Daily Bulletin)

NEWARK, N. J., Dec. 14—Walter Kauf, bodyguard of Heinz Span-knoebel, Nazi leader now in hiding, received a six-month sentence in the County jail here yesterday from Judge Daniel J. Brennan, of the Court of Common Pleas. The charge

was carrying concealed weapons. Kauf was arrested at a Nazi rally held here on Oct. 16 where Spanknoebel spoke. He was alleged to have drawn a blackjack to use against an anti-Nazi demonstrator. The court ruled that Kauf will be released provided deportation proceedings will be started within thirty days.

Kfar-Saba which Rosenblatt asserted he had attended. Rosenblatt took part in the meeting, the witness de-clared. He swore that he had seen Rosenblatt there as late as ten-thirty at night. Rosenblatt, according to the prosecution charges, was at the Tel Aviv seashore (about fifteen miles away), where the murder was committed at exactly eleven o'clock. Rosenblatt is accused of the actual shooting of Dr. Arlosoroff.

His testimony was considered important to the defense since the prosecution had made much of the fact earlier in the hearing that the minutes of the meeting had been mutilated and pages of the minute book torn out.
