#### The New Nuremberg Toy

Julius Streicher, the editor of Der Stuermer, Governor of Franconia, friend of Hitler and disseminator of the "ritual murder" legend, has helped a Nuremberg Jew to leave Germany by paying his fare to the frontier. Streicher boasts of his generosity and uses the incident to promote his anti-Jewish propaganda.

In a recent issue of the Stuermer there appeared a letter received by the Printing Trade Labor Organization of Nuremberg-Fuerth from a Jewish printer, named Philip Lengyel, asking to be helped financially to leave Germany. He claimed that he was entitled to such financial assistance under the rules of the Union, as he had paid his dues to the Union regularly since 1901. The application was made to the Nazi District Leader, who happens to be Julius Streicher himself. And the Stuermer published the following editorial comment:

"Philip Lengyel is a Jew, the only Jew engaged as a printing craft workman in the whole of Bavaria. For this reason he deserves to be exhibited after his death as a rarity in a wax-works show. We would gladly have kept him here for exhibition purposes, but he wants to go, so we cannot hold him. He asks for his travelling expenses to the frontier. The leader of the Gau (Nazi District) to whom he applies is Julius Streicher. The foreign Jewish press dubs him 'Jew-murderer,' 'bloody Franconian,' 'the most dangerous man in Europe.' Strange! The Jew Lengyel thinks otherwise. He is confident that Julius Streicher is sufficiently accommodating and generous to give him his expenses. And stranger still, Julius Streicher has given them to him. The Gau has granted his application and Lengyel has travelled free to Passau. This should not, however, be considered a precedent for the Jews to have their fares paid when they leave the country. We know that we shall get rid of them without that."

The Jewish printer Lengyel is fortunate enough to have escaped from Germany, especially from the district governed by the wretched sadist, Streicher, even though he furnished Streicher the opportunity to display "generosity." The diabolical cynicism and the lying propaganda of Julius Streicher mirror the Hitler regime and reflect disgrace upon the people who tolerate that regime. Even the Black Hundred pogrom leaders of Tsarist Russia were less cynical, less brutal and less unscrupulous than Julius Streicher. Nuremberg has produced a fine "toy" which gives it a new reputation.

## Poultry Code to Assume Duties Now Handled by New York City

### Municipal Health Rules to Be Rescinded Sept. 9

WASHINGTON, Aug. 12.—All live poultry inspection activities now being conducted by the City of New York will be made part of the code of fair competition now in effect for the New York live poultry industry, it was learned here today. This was seen as a direct step toward wiping out the traffic in diseased and "cull" poultry on that market, which sells chiefly to Jewish consumers.

## Naras Resume Attacks, Print Banned Organ

### Polish Jews Fear New Drive as Proscribed Party Acts

(Jewish Telegraphic Agency)

WARSAW, Aug. 12.—The Naras, National Radical anti-Semitic party suppressed months ago by the Pilsudski regime, yesterday resumed the illegal publication of their chief organ, Sztafeta. Filled with vitriolic anti-Jewish propaganda, the issue has been widely circulated through the mail. Copies were sent to leading Polish Jewish organizations, including the Warsaw Jewish community.

Polish Jewish circles fear that the reappearance of the Nara organ means that a new campaign of agitation has been opened.

The Naras were suppressed after the murder of Minister of the Interior Colonel Bronislaw Pieracki. Before their suppression, the Naras had carried out widespread attacks against Jews, resulting in a state of panic among the population.

## Attorney General Can Prevent Jews' Mulcting, Says Goldstein

The one man who could break up the charity rackets incorporated as Jewish congregations, Attorney General John J. Bennett, has consistently avoided doing so, even in the face of an appeal from Governor Lehman.

This was the charge made yesterday by Magistrate Jonah J. Goldstein, a tireless campaigner against rackets masquerading as charity.

Striding back and forth in his office in the East Fifty-seventh street Magistrate's Court, Judge Goldstein demanded to know why Attorney General Bennett has done nothing about these rackets which Goldstein termed a "chilul lesheim" (sacrilege).

"I told Bennett he is in a position to stop the racket," Judge Goldstein angrily declared to this reporter. "All he has to do is to bring injunction proceedings against these racketeers to enjoin them from soliciting funds and then bring action to revoke their charter."

## Zionists Arraign Palestine Police

### Charge Brutality in Treatment of Illegal Entry Suspects, Arrested on Arabs' Words—Jail Terror, Bail Refusals Revealed

LONDON, Aug. 12.—Amazing facts concerning the callous brutality of Palestine police in dealing with cases of Jewish immigrants suspected of having entered Palestine illegally were revealed today by Haolom, official organ of the executive of the World Zionist Organization.

For some time past a savage hunt has been going on in

Palestine for Jewish illegal entrants, with the police offering rewards for information concerning such immigrants and with widespread arrests of suspects all over the country, many of whom were later released.

## Cuza to Visit Hitler in Berlin; Jews in Fear

### Trip of Rumanian Seen Boding Them Little Good

BUCHAREST, Aug. 13 (Monday).—An announcement in the local press that Prof. Alexander Cuza and his son are on their way to Berlin to visit Adolf Hitler has created something akin to consternation in the Jewish community here.

The fear is expressed in many quarters that the Berlin visit of the Cuzas, notorious anti-Semites and leaders of the violently anti-Semitic Iron Guard party, will be followed upon their return by a new campaign against Rumanian Jews.

#### Young Women Maltreated

No mercy is shown arrested Jewish suspects, Haolom stated, pointing out that even young Jewish women have been thrown into old jails, inadequately fed and forced to endure bad living quarters on the flimsiest information by any Arab who happened to have a grudge against the Jews. All suspects are in great danger of deportation if they are unable to furnish proof of their right to remain in Palestine.

Haolom relates the story of thirty-two Jewish girls who were hiking through the country, near Tiberias, far from the Syrian border, when they were arrested after an Arab boy had denounced them. They were thrown into an overcrowded jail at Bethlehem, where more than 100 prisoners are kept in a place built originally for sixty.

#### Refused Bail by Police

The court ordered them released on bail, but the police refused to obey the order and are keeping the girls on a starvation diet of bread alone, declaring that if they are released on bail they may marry Palestinian citizens and obtain the right to stay.

In Haifa three Jewish girls were arrested on the street, jailed and finally deported on an Italian steamer. Italian authorities refused to allow them to land in Italy and the girls were shipped back and forth between Italy and Palestine until the Italian captain prevailed upon Palestine authorities to take the girls off his hands. They are now imprisoned in the Bethlehem jail, where they await their fate.

## Police Ban Youth Units In Westphalia District

(Jewish Telegraphic Agency)

BERLIN, Aug. 12.—More than 1,000 Jewish youths in the Westphalian district of Arnsberg were affected today by a special police order absolutely prohibiting and declaring illegal all Jewish youth organizations in the district.

Jewish youth organizations were also forbidden to hunt, march, camp, or to wear uniforms and carry flags or streamers on pain of imprisonment or fine. Only indoor sport activities and private hiking groups are permitted for Jewish youths.

"I wrote, I conferred with his office. The Henry Street Settlement urged him to do something. Governor Lehman appealed to him to start injunction proceedings. For some unknown reason that I cannot fathom, the Attorney General has taken no step.

"If he said the State couldn't afford it, I offered him a special assistant attorney general at no cost to him. If he said he was afraid to mix in Jewish religious business, I offered to get him the signatures of Jewish religious leaders to a petition backing the proceedings.

Attorney General Bennett, who will come up for reelection this Fall, could not be reached yesterday to answer the charges.

Judge Goldstein placed the burden of the blame for the religious charity rackets on the prominent citizens who, without investigating charity organizations, permit their names to be attached to them.

"I hold these prominent citizens responsible. If they hold positions of respect, they should protect

## Will Broaden Scope of B'klyn Education Plan

### Program of Religious Learning Projected by Association

A plan to extend the program of religious education for Jewish children in Brooklyn will be started soon with a fund and membership campaign by the Brooklyn Division of the Jewish Education Association.

The program will get under way tomorrow night at a meeting at Rothman's Inn, 285 Kingston avenue, Brooklyn. Otto A. Rosalsky, Justice of the Court of General Session, will be the principal speaker. The Brooklyn Division will seek to raise \$200,000 and increase its membership to 25,000.

Justice Rosalsky succeeded the late Israel Unterberg as president of the Association about six months ago. Another speaker will be Bernard Semel, honorary secretary of the Association.

Municipal Court Justice Nathan Sweedler of Brooklyn, chairman of the local division, said there were more than sixty Jewish religious schools affiliated with the Association. The organization, he said, was formed about fifteen years ago with functions similar to a municipal board of education.

Jewish schools willing to conform with the requirements are asked to stress American citizenship and Judaism in their teachings, according to Sweedler. The teachers are required to be licensed and graduates of both secular and Jewish colleges.

Justice Sweedler estimated that 80,000 Jewish children are living in Brooklyn without opportunities for religious education. There are, he said, about 25,000 Jewish children in schools providing religious instruction but not all these schools have become associated with the Jewish Education Association.

The membership in the Brooklyn division was said to be more than 600. The purpose of the campaigns, Sweedler explained, is to get more supporters in order to provide a larger number of children with a Jewish education.

Most of the schools are Talmud Torahs, only two or three being parochial schools which provide both secular and religious education. The former, through the public school year, maintain religious classes from 4:30 p. m. to 9 p. m., on school days. During the summer classes are held from 9 a. m. to 3 p. m. Classes also are held throughout the year on Sunday mornings. Religious instruction is augmented by training in music, literature and recreational programs.

Justice Sweedler said he planned to have a camp to accommodate 5,000 Jewish children during the summer months.

## Fascist 'Peril' Dissipates in Face Of Los Angeles 'Shirt' Probe

LOS ANGELES, Aug. 12.—If investigation by the Congressional Committee on un-American activities has proven anything during the past week, it is only that the United States is still safe for democracy.

Neither the Fascist nor Communist elements have shown themselves a menace in this part of the country, although the investigation inspired large headlines in the daily newspapers here for five days running.

The Silver Shirts, stronger in Los Angeles than in any other part of the country, have been exposed as one of the minor cults in which this particular part of the West seems to abound.

### Kemp Beats Putsch

The fanatical W. W. Kemp of San Diego, who envisioned violent overthrow of the Government, and who prepared for this great day, so it was testified, by drilling secret Silver Shirt units and caching arms and ammunition near his country place in Southern California, has fled in the face of his folly. Many of his staunchest supporters were Government agents seeking the lowdown on the man's operations. He is German and is understood to have attempted to make possible the realization of his putsch plans by drawing liberally from the funds of his wealthy American wife.

The failure of the Silver Shirts may best be illustrated in figures. West of Omaha there are about 600 members in good standing. Throughout the entire country there are not more than 2,500. The wide circulation of Shirtsissimo Pelley's publications and the inordinate queerism of his ideas

which have gained unmerited publicity for the gentleman and his pack have served to give an illusion of strength.

### Pelley After the \$

Pelley has further been charged with having sought to grow rich on his movement, and these charges are not restricted to Los Angeles. In Washington, as well as in Los Angeles witnesses testified to the mercenary aspects of the leader's principles, and, generally, those who know him well are frank in expressing their opinion that Pelley is inspired by dimes and dollars rather than reform ideals.

No less innocuous than the Silver Shirts are the Communists here. It is learned that one of the witnesses against Communist activities admitted on questioning in private hearings that a fair proportion of Communists are agents paid by "patriotic" societies and industrialists. Further, it was admitted that some of the funds collected to fight a largely imaginary Red Menace were diverted to other more sensible, but perhaps less honest, personal purposes.

### San Francisco, Chicago on List

One committee attendant said of the Communist hearings: "The Communists themselves supplied us with far more factual information on their operations than the Government and organizational spies. The latter seemed inclined to make speeches."

Investigation is being undertaken in San Francisco and parts of the Middle West, particularly Chicago. It has been stated that no open hearings will be held in San Francisco. Most of the information gained there is only corroboration of testimony already taken and will be used as such.

## Lipman Appointed to Board Of New Brunswick Education

Lipman, director of the New Jersey Agricultural Experiment Station and Rutgers faculty member, has been appointed a member of the local Board of Education to succeed the late Jesse Straus. Dr. Lipman, who served on the building and finance committees of the Board, was a member of the Palestine Survey Commission at the time the Jewish Agency was formed.

## Temple Takes Action Against Deposed Head

JERSEY CITY, N. J., Aug. 12.—Vice-Chancellor James F. Fielder has issued an order directing Morris Rinzler of Passaic to show cause in Chancery Court here tomorrow why he should not be permanently restrained from interfering with meetings of Congregation Tifereth Israel in Passaic.

The congregation, in its petition seeking the restraint, reports that Rinzler was suspended as president on July 29 after he had failed to appear before a grievance committee to defend himself against charges of conduct unbecoming a member and officer. Rinzler, is charged, refused to relinquish his chair.

### Old Chicago Resident Dies

CHICAGO, Aug. 12.—Funeral services for Mrs. Josephine Tausig, 86, resident of Chicago for seventy years, who died in her home here after a year's illness, were held at the Beth El Temple, with burial in Graceland cemetery. ## 'Mushrooms' Facing Fight In Brooklyn

### Theatres, Banquet Halls Come Under Ban by Committee

A drive against the operation of theaters and banquet halls as houses of worship for the Holy Days will be launched in Brooklyn by a committee representing established congregations in the Borough Park section.

The committee will be guided in its plan to rid the borough of "mushroom" synagogues under provisions of Chapter 445 of the Laws of 1934, which is section 925-B of the Penal law, recently enacted to have such unauthorized religious groups eliminated.

As a result of investigations carried on in the district during the Summer, Rabbi Moses Abels of Temple Emanuel, Forty-eighth street and Fifteenth avenue, said that members of his congregation had reported to him that the managements of theaters and halls, who find it a financial loss to keep open during the holidays, have rented their quarters for the purpose of holding religious services by Jewish religious leaders who were not authorized rabbis.

"This is a great evil," Rabbi Abels said, "because these unscrupulous individuals open up these synagogues for religious services and use the funds obtained for their own purposes. The members of our congregation will strive to prevent the operation and spread of these groups."

Louis Levy, president of the congregation of Temple Emanuel, who is a member of the committee, maintained that complaints had been received by himself and other members of the committee that dance halls, motion picture theaters and other assembly rooms had been obtained by persons who were "masquerading as clergymen."

### Prepare to Investigate

Following the adoption of a resolution by members of the committee, Mr. Levy said that the group was now prepared to investigate "these new corporations which are operating under fictitious names," and bring the matter to the attention of the penal authorities under the legislation which was enacted about a week ago.

## Survey Indicates Tel Aviv Growth

### Reveals Enormous Increase in Traffic and Housing Developments

(J.T.A. Special Correspondence)

TEL AVIV, July 24.—The enormous growth of traffic through this city's railway system is revealed in figures published in the Tel Aviv Municipality Bulletin.

During the calendar year of 1933, the incoming tonnage handled was 121,871, and outgoing tonnage was 10,591. In all there were 85,666 passengers. Thus railway receipts for the year show an increase of 11,969 pounds over the 1932 total of 10,395.

Statistics on building construction activity, just released, are interesting. No less than 103,481 square metres of buildings were added to Tel Aviv during the quarter ending May 30, 1932, representing an increase of some 22,000 square metres over the same quarter of 1933. The number of building permits issued was 540, compared with 560 in the same 1933 quarter.

# Adjusting Our Lives

By DR. HERMAN FRANK

## Choosing a Trade or Occupation

Severe competition for jobs makes it more necessary now than ever that society assist the individual, particularly the adolescent, to select for himself or herself the occupation most suited to the given person's capacities. This social obligation was realized some twenty-five years ago in the United States, before any other country took cognizance of this new branch of social-educational activities. Vocational guidance, as a scientific theory and practical craft, is thus a distinct contribution of America to our modern civilization.

Now, vocational guidance is the process of assisting the individual to choose an occupation, prepare for it, enter upon it and progress in it. This aim, of course, presupposes a knowledge of the person, a knowledge of all possible occupations and a power of relating one to the other.

In the circumstances of our rapidly changing economic scene, vocational guidance also must stress the development of the self-reliant individual. Such a one can adjust himself to the changing industrial world, and understands not only the requirements of his job, but the larger implications of vocational life, the roads to job success and economic security.

## A Young Man's Dilemma

Although a factor in American school life and adult education, the possibilities of vocational guidance have yet not made a deep impress upon the mentality of the young person himself. He is still bewildered by the immense variety of possible trades and occupations among which he has to grope after this or that one. So, for instance, a perplexed reader of this series has written to me as follows:

Dear Dr. Frank:

I am a young man of twenty-two, high school graduate, with two years of evening college. After spending two years in the so-called higher seat of learning, I decided to give up the hopeless and unprofitable struggle of trying to make the grade in any of the overcrowded liberal professions, and instead learn a skilled trade which would offer me a more or less secure economic future. And here I'm facing the greatest dilemma. Agents of private trade schools have showered me with glittering promises. I, however, have little faith in their talks. Some of my friends suggested to me mechanical dentistry, others linotype operating. Is it wise to learn one of these trades? Are there any schools where skilled trades are taught free of tuition fee? Daily, for that matter, new trades are being opened to the ambitious youth.

Would you kindly show me a way out of my present uncertainty, for which I would be eternally grateful to you?

## An Individual Problem

Well, though a preference for one or the other of the skilled trades, as compared with the liberal professions, in the circumstances which a Jewish young man in America has to face, is justified (unless special and quite exceptional gifts were in favor of a profession), no specific advice as to the preference of this, that or another trade can be given in an off-hand manner.

Success in any trade and occupation hinges on individual fitness and adaptability to the job's requirements—physical, psychological, educational. In this particular case, mechanical dentistry, like the watchmaker's and optician's craft, is suitable for a person in whom, among other traits, attention to the finest detail and precision in work are outspoken characteristics. Linotype composing, on the other hand, makes very different demands upon the physical and mental constitution, as well as the behavior pattern, of a person. So, his lungs have to be invulnerable to lead-dust, he has to possess what psychologists call "visual" memory, and in

his behavior there must be an inclination to a sedentary job.

## Consulting Guidance Experts

First of all, then, high school or public school graduates, who intend to take up a skilled trade for a life career, have to consult an expert in vocational guidance, a practitioner in this new field of applied psychological science. These "counselors" are to be found in nearly every school or college where a vocational guidance department exists.

Again, it is very advisable to secure an interview with the Guidance experts of the Vocational Service for Juniors Scholarship Department, 122 East Twenty-fifth street in New York, a privately supported non-sectarian agency.

This organization, furthermore, has published a manual, "Opportunities for Vocational Training in New York City," with a supplement and revision issued in 1932. From this book, sold at a very reasonable price, the aspirant for a skilled trade is able to get a bird's-eye view of an immense field with wide opportunities for a prospective craftsman.

## Limitations of Vocational

As could be seen, vocational guidance is fundamentally concerned with preparing and helping people make wise decisions, to solve vocational problems intelligently, to meet vocational situations effectively—tasks involved in planning and living a life.

But, as should be remembered, a career cannot be planned and mapped out in advance, especially in the ever-shifting economic conditions of our times, and more especially in view of the handicaps imposed upon the Jew by a hostile world.

No career can be chosen, though a trade or occupation can be. Careers are dynamic not static, and success in them depends upon a series of adjustments. Adjustments not only to work, but to the general social conditions of work, and to working conditions other than economic and social (as getting on with superiors and associates, etc.) In this way maladjustment, and failure, through wrong courses of action can be prevented.

# New England Stores Join in Anti-Nazi Move

## Boston Business Houses Active in Boycott, AJC Announces

Further impetus to the spread of the boycott on Nazi goods has been given by the action of a number of leading department stores in Boston and other New England communities.

This announcement was made yesterday by the Boycott Committee of the American Jewish Congress on the basis of a report received from Rabbi J. S. Shubow, executive director of the New England office of the American Jewish Congress. The committee has canvassed for proprietors and managers of department stores in New England to ascertain their attitude towards the anti-Nazi boycott. The following stores have declared their adherence to the boycott policy: E. T. Slattery Company, Tremont street, Boston; Chandler & Co., Boston; Conrad & Co., Boston; Enterprise Department stores, Cambridge, Mass.; Harvard Bazar, Inc., Cambridge, Mass.; Timothy Smith Company, Roxbury, Mass.; Gorin's Inc., Somerville, Mass.; Young Novelty Co., Inc., Boston.

An interesting feature in this New England development is the statement made by T. V. Houser, general merchandise manager of Sears, Roebuck and Co. "We have decided that the fair thing to do to all concerned is to indicate plainly on every article of merchandise, and on every quotation in our catalogue, the country of origin on all imported goods. In this way customers may make their own decision based upon a full statement of fact," declared Mr. Houser, as the policy of Sears, Roebuck & Co. in regard to the anti-Nazi boycott.

Church dictator. The Bishop, who only a few days ago declared that Hindenburg's last words to him were to "preach Christ to Germany," has received full powers of dictatorship in church matters, and the pastors, instead of swearing allegiance to Christ, will now be forced to take the following oath to Hitler, on pain of expulsion from their pastorates:

"I swear before God, holy and omnipotent, that I will be true and obedient to the leader of the German people and the German State, Adolf Hitler, and that I will offer every sacrifice and service for the good of the German people. Furthermore that I will perform my duties as pastor in accord with the instructions issued by the German Evangelical Church and finally that I will serve my parish loyally."

The final church law passed just now provides that in the future only the black, white and red, the Swastika flag, is to be flown on church buildings, and the white church flag with a purple cross, adopted in 1922, is to be abolished.

Thus, unlike any of the other dictators, Hitler has made the church subservient to his Nazi dictatorship. There was a time when the whole world sneered at the former Kaiser's customary phrase, "God and I." Wilhelm's conceit pales into insignificance when compared with the perverted egotism of the adventurer who rules Germany today.

# Poultry Code to Assume Duties Now Handled by New York City

(Continued from Page One) Under-Secretary of Agriculture Rexford G. Tugwell. This hearing will be held at the Hotel New Yorker, New York City, on Aug. 17. It will be under the direction of the Agricultural Adjustment Administration.

The move toward assuming responsibility for live poultry inspection was taken by the poultry code authority after it was learned that on Sept. 19 the City of New York was planning to rescind all health regulations relating to live poultry inspection. Under present arrangements, members of the industry pay for this inspection service and this arrangement would be continued when the service becomes incorporated in the code. Under the code, inspection of live poultry by competent inspectors would be mandatory.

Another amendment which will be considered at the hearing would require all live poultry dealers to file sales prices and terms of sales with the code authority. It would also provide for listing of these schedules in a prominent place for public inspection at the individual establishments. Industry sponsors of this amendment say it is designed to bring competition out in the open. They also claim it will permit the more effective handling of destructive price-cutting practices and is expected to result in material price benefits to both consumers and producers of poultry.

Authority to enforce health regulations in the live poultry industry will give the code enforcing officials an important weapon with which to combat a distinct form of racketeering. One of the rackets with which the code administrators have had to contend has been the traffic in diseased poultry.

Already the Federal Government has taken steps to stop this traffic. Recently authorities started action in the Federal Court in Brooklyn to determine the government's authority to enforce provisions of the New York live poultry code.

## Schechter Firms Indicted

A Federal grand jury in Brooklyn indicted two live poultry firms, the A. L. A. Schechter Poultry Corporation of 858 Fifty-second street, Brooklyn, and the Schechter Live Poultry Market, Inc., of 991 Rockaway avenue, Brooklyn, and four individuals, Joseph, Martin, Alex and Aaron

Schechter, the joint owners of the two corporations, on charges of violating and conspiring to violate the live poultry industry code for the metropolitan area of New York.

The corporations and individuals are charged with sixty separate offenses against the code, each punishable, if proved, by a fine of \$500. The conspiracy charge under the law is a felony punishable by a maximum penalty of two years' imprisonment and \$10,000 fine.

Specifically, the government's move is designed to break up the interstate traffic in diseased fowl. It was explained that ninety-eight per cent of New York's live poultry supply comes from the West and South. This particular market it is alleged, has virtually been made a dumping ground for "culls" and chickens infected with disease or otherwise unfit for human consumption.

That the attempt to wipe out the traffic in diseased poultry is significant may be seen from the fact that the live poultry industry in the New York area involves a turnover ranging from \$175,000,000 to \$200,000,000 a year. Conditions and practices in the industry affect millions of consumers, particularly Jews, who are the chief purchasers of live poultry on this market.

Recently William Fellowes Morgan, Commissioner of Markets in New York, charged that racketeers in the New York poultry industry were taking more than \$10,000,000 a year from the consuming public.

The code for the industry is administered jointly by the Agricultural Adjustment Administration and the National Recovery Administration.

The Schechter firms are reputedly the "key" people in the industry, doing a business of more than \$60,000,000 annually. The indictment against the Schechters contains more than 15,000 words and charges them with having bought uninspected and diseased poultry. Other charges include the slaughter of poultry by methods other than on the basis of official grades, committing acts of violence, coercion and intimidation against code authority representatives, withholding reports or furnishing false reports to the code officials, and working their employees in excess of the regulation hours and paying employees less than the prescribed rates of pay.

Prosecution of the case is in the hands of Walter L. Rice, special assistant to Attorney General Homer S. Cummings. Assisting are Leo J. Hickey, United States Attorney in Brooklyn; Arthur M. Loeb, attorney for the live poultry code authority, and Irving Dale, Mr. Loeb's assistant.

The government's case is based on information resulting from weeks of inquiry by Leroy Peterson, code supervisor. Additional investigational work was done under the direction of Mr. Rice. Efforts are being made by the Department of Justice to bring the case to an early trial. While the case is pending the government intends to write into the code specific provisions relating to the inspection of poultry offered for sale on the New York market.

## History of the 'Wandering Jew' Captured in Seminary's Exhibit

Very interesting portions of the history of Jewish wanderings from Palestine to Europe, the Americas, and as far as China are made real by the collection of historical objects of the Jewish Theological Seminary, now on view at Broadway and 122nd street.

A small clay object, like some sea-shell you might pick up on the beach, recalls the Period of the Judges in Jewish history three thousand years ago. It is an oil lamp, from which Samuel the prophet may easily have anointed Saul first king of the primitive tribes of the hills of Judea. It resembles to the inexperienced observer the clay pottery of the pueblos of New Mexico, representing the same period of development in Jewish civilization.

At another case you step abruptly into the early days of the Puritans in America. Increase Mathew, "President of Harvard College at Cambridge in Massachusetts," speculates upon "The Future Conversion of the Jewish Nation," of which nation there may have been a round hundred members in the new world at the time. This preoccupation of pioneers with the Jews, who could rarely have been encountered in early American times, crops up again in a treatise on "The Ten Tribes" of Israel and the Aborigines of America," which rests by the side of "The Mystery of Israel's Salvation," that is to say, conversion.

### A Philosopher's Letter

Turning to another section of the exhibit, the Medieval Period, the living evidence of the life of the Jews in Europe and the Near East has been collected, and a letter from Maimonides, blackened and faded, attests the fact that those glowing, distant names of history were attached to people, people who signed letters and sent them and waited for the mail in the twelfth century as in the twentieth.

Illuminated manuscripts, the work of years of incredible painstaking, often the fruit of an entire life in a dark, restricted Ghetto, gleam with color across from similarly illuminated marriage-contracts, signed and sealed at lively festivities of long-departed Jewish families.

### Triumph of Renaissance

From that "most precious piece of printing in existence," the Gutenberg Bible, the first book printed by movable type, the Book of Esther has found its way into this collection. This triumph of the Renaissance is a job of printing that any modern publisher would be fortunate to equal.

Coins dating from Palestine of the Greek-Roman period, from the times of the Maccabees and of Bar Kochba, resemble pretty closely the dime or quarter of current circulation, though they bear inscriptions of the Herods and Caesars and are arranged in glass cases along a wall. With such pieces of money you bought yourself a ride on a donkey from Beer-sheba to Jerusalem, just to see the show and goings-on, on your week-end or summer vacation.

The history of their ancestors is made very easy to assimilate for people through an exhibition of this kind.

An inscription from a synagogue of the fifteenth century, which Jews had somehow managed to establish on the Yellow River in China, bears witness to an incredible trek of some ten thousand miles from the origin of the Jews in Palestine deserts, through the Caucasus, Turkestan, Tibet and Eastern China, blazing a trail for Marco Polo to follow. Hardly showing Jewish influence, it is only the scholar who can connect this Mongolian document with a Jewish congregation. Already in the fifteenth century, this Jewish community was writing its inscription in Chinese characters. When must

it have arrived in the region of the Yellow River? And by what means? And how long must the trip have taken?

The American room of the exhibit, which has been assembled by the Jewish Historical Society, contains also, among other things, memorials to Congress by various individuals and communities of the nineteenth century, and also portraits of the worthies of that day.

## 20,000 Exiles From Germany In New Homes

### Most of Them Settled in Palestine, Says McDonald

More than 20,000 refugees from Germany already have found permanent homes in other countries, according to a report from Refugee High Commissioner McDonald to the United Jewish Appeal, in which he states that Palestine is the principal country of their settlement. Apart from the thousands who made their way there directly, Commissioner McDonald reports about 100 a month are being assisted to migrate to Palestine from the countries of refuge.

A survey of the whole refugee situation, made by a special committee of the Refugee High Commission, the report states, discloses that of those dependent on relief organization abroad, about 4,500 are fitted for immediate immigration to various overseas countries. The cost of transporting and maintaining them until they could be absorbed in the economic life of their new countries, Mr. McDonald's report states, would be about \$225,000.

"That capital sum," he says, "would give the Refugee Commission the means of liquidating the bulk of the present emigration problem. Meantime, however, the aid committees in nearly all of the countries bordering on Germany are sorely pressed for funds to enable them to do their absolutely essential work of relief. This must be continued until those refugees who are not absorbed in the countries where they are can be emigrated."

### Rabbi Finds Arbiter's Lot Is Not a Happy One

CLEVELAND, Aug. 9.—A meeting was called at the Jewish Center by the right-wing sponsors of the Jewish bread strike to test the sentiment of the Jewish organizations, but it was taken over by the left-wing strikers who objected to the methods of procedure, and the meeting ended in a deadlock.

Previous to the meeting, Rabbi Armond Cohn, who was recently elected to the pulpit of the Jewish Center in the absence of Rabbi Harry S. Davidowitz, made futile attempts at bringing the strikers and bakery owners to an agreement. The two sides met in the afternoon with Rabbi Cohn and representatives of the Jewish Bakers Union.

"I thought," said the Rabbi, "I was just helping settle a question of the price of bread, but I find that that dispute is entangled with a fight between Socialist and Communist forces for leadership. My impression was that both parties were about to accept the compromise terms when they left the conference."

The body of Mr. Wormser was brought back to Chicago Friday by his daughter Elaine, 22, who was driving the car at the time of the accident. In attempting to avoid hitting another car, her automobile overturned. She and her father were bound for Charlevoix, Mich., to visit Mr. Wormser's mother.

Burial took place at Mount May-riv Cemetery.

Mr. Wormser, former attorney for the late Julius Rosenwald, was director and counsel to the Jewish Charities of Chicago. In a statement to the Jewish Daily Bulletin Samuel A. Goldsmith, executive director of the Jewish Charities, declared yesterday that "the sudden and swift hand of blind accident has swept from us a genuinely strong and noble person. Gifted with a fine mind and a generous spirit, possessing a genius for friendship, he was easily one of the outstanding personalities of the Jewish Community of Chicago."

The deceased leaves a widow, the former Miss Helen E. Goldsmith of Chicago, and a daughter, Elaine.

## Open Grape Cure Station at Tel Aviv

### German Exile Is in Charge of Establishment at the Levant Fair

TEL AVIV, July 22.—A grape cure station has been established at the Levant Fair grounds here. The Thuva marketing cooperative made the arrangements for the station which is under the patronage of the Physicians' Association of this city.

Dr. Muskat, formerly of Reichenthal, Germany, is director of the station. The Thuva restaurants will supply food, according to diets prescribed by physicians and arrangements have been made for physical treatment also according to prescription. The latter includes sea and sun bathing, massage, walking exercises, light games and calisthenics.

The essential elements in the cure are grapes and grape juice. The dietetic treatment also includes "Kephir," "Leber," and pasteurized milk.

Tel Avivians are welcoming this cure station as a first step in establishing this city as a health resort, especially for people of moderate means.

## Four Cruises Include Visits to Palestine In Their Itineraries

Capitalizing on the heavy travel movement of the month, the Fall cruise season was this week ushered in for an early start by the announcement from the American Express Company, in cooperation with the American Export Lines, that four 58-day Fall cruise tours had been arranged Tuesday for Mediterranean countries, the first of the series to leave New York Aug. 21 on the Yankee Cruiser S.S. Exeter.

## Arab Physician Lauds Zionists For Their Palestine Activities

Characterizing the work of the Zionists in Palestine as "constructive" and denouncing the "idle talk" of the Arabs, Dr. Faik Shacker, an Arab physician, who is Director of Posts and Telegraph in Iraq, contrasts the two peoples in a book just published in Baghdad. Translated extracts from the volume were received here yesterday by Hadassah, the Women's Zionist Organization of America, from Dr. Haim Yassky, director of the Hadassah medical work in Palestine.

Dr. Shacker recently paid a visit to Palestine and observed, as he says, "the activities of the Zionists in this Arab land."

### Visited Institutions

"I visited their modern orange groves, factories and banks, but nothing attracted my attention as much as their health institutions," the author says. "After visiting these institutions I could not help feeling that the Zionist ideal is bound to be realized by the Jews while the Arab nation will make no progress if it continues to neglect the health of its people and the welfare of the race."

The author proceeds to describe the health activities of Hadassah, stressing the devotion and proficiency of its medical and nursing personnel, and concludes:

"Such successful activities make for the progress of a nation. If the Arabs will continue their idle talk without concrete accomplishments, and if Zionists will quietly continue their constructive work, I am very much afraid that the Zionists will be victorious, Heaven forbid!"

In the section describing the Hadassah health work Dr. Shacker says in part:

"The Hadassah officials are physicians who have a staff of trained nurses chosen from among Jewish immigrants from all parts of the world. The aim of this organization is to guard the health of the Jewish race and create a strong nation, hale and hearty."

"I must admit that I found the Hadassah staff fully devoted to this aim and working untiringly towards its speedy realization. Those who wish to rebuild their nation and to serve it should emulate the commendable example of the Hadassah employees who work like bees in a hive. They know their work and do it well, without any commotion."

### Changed Policy

"In the past it was the function of the Hadassah Medical Organization to cure the sick, but in recent years Hadassah has changed its policy and has become an institution which, with infinite foresight, concentrates its energies on safeguarding the health of the infants. To this end Hadassah spends large sums for the care of the

34,000 children in the various Zionist schools in Palestine, providing food free for needy children. The organization employs nurses for each school. These nurses treat the eyes of the children suffering from trachoma and teach hygiene in the schools.

"Hadassah now has twenty-three infant welfare, pre-natal and post-natal service. Each station has its physician, nurse and midwife. The health welfare centers also have home visiting nurses who teach the mothers to protect the health of their children and advise expectant mothers during pregnancy. The physicians treat sick children and teach the mothers how to care for their infants in order to assure their normal development. The nurses of the centers often invite mothers for tea and arrange for talks by physicians on various health topics.

"Hadassah provides free layettes for the infants of the poor mothers. The organization has a pasteurization plant and mothers are taught to sterilize milk at home."

Dr. Shacker closes this chapter with the prediction of Zionist success.

## Turkish Drive On Anti-Semites Highly Praised

### 'Near East and India' Hails Government for Swift Action

(J.T.A. Special Correspondence)

LONDON, Aug. 2.—Commenting on the recent anti-Semitic disturbances in Turkey, the current issue of Near East and India declares that "the statement issued by the government following the report submitted by Minister of the Interior Shukru Kaya Bey, on the inquiry that he has conducted in Thrace is a document remarkable for both the spirit in which it was conceived and for the importance that it may have on the future of Turkish Judaism."

"Seldom has any government," the article continues, "so fully and so sincerely laid bare such regrettable events as have recently happened in that province, and in fact, the Jews consider it as bearing the mark of the Ghazi's personal inspiration."

The statement stresses the fact that since the middle of June rumors have been circulated among the public to the effect that the government was desirous of removing the Jews resident in Thrace, but that it preferred that this movement should not be conducted openly, but by means of intrigue and pressure. It then gives a short but exact description of the happenings, as a consequence of which three thousand out of thirteen thousand Jews were compelled to leave their homes.

"In order to cope with the situation," states the report, "everywhere the minds of civil servants have been liberated from any influence exercised by any kind of propaganda and they have been put in a position whence they can seriously dominate the situations. Administrative and judicial steps have been taken against the civil servants whose activity, in the course of the events has been insufficient, or who have shown leniency."

The authors of the events at Kırklareli, where Jews were attacked and sixty-five Jewish houses plundered, are being proceeded against with the greatest severity. The government declares that it will oppose any pressure for emigration or boycott movements for any reason or under any form whatever. All offenses brought before the justice will be judged with celerity. It will not be allowed to oppose the return of the Jews who left and the Government will not permit provocations and hostile suggestions against any citizens to take place. It expects the press to show prudence with regard to suggestions, likely to spread disunion among citizens. Most important, however, is the announcement that an inquiry is

being made with regard to regional committees, and that measure will be taken by the Popular Party against all those who have abused their position.

"It is now rumored that, had it not been for energy of the Governor of Brussa and his ability to nip the trouble in the bud, an anti-Semitic movement might have begun in that town before even it was started in Thrace. In that particular case very young men, again actuated by extreme national feelings, are said to have been the alleged promoters of the plan."

## Nazi Lawyers Raise Protest Against Jews

### Resent Decision Letting Cultural League to Register

(J.T.A. Special Correspondence)

BERLIN, July 31.—Objection to a decision of the Berlin District Court, in which the refusal of the Registry Court to register the Cultural League of German Jews was reversed, has been voiced here by the League of National Socialist German Lawyers, through its central organ, The Deutsche Recht.

The paper attempts to justify its objection to the decision on the ground that there are no German Jews in the same sense that are no Polish or French Jews.

"It is impossible for us to understand the decision of the Court," the article says. "First of all, we have no guarantee that because of what the statutes say, the Jewish Culture League does not also pursue anti-State aims, but apart from that it is intolerable to associate Jewish cultural efforts in any way with German culture. It is precisely that against which the National Socialist movement is fighting."

Jews here, however, are in disagreement with The Deutsche Recht, maintaining that the paper's stand is based upon a complete failure to realize the actual conditions. They point out that the District Court in handing down its decision said that the aims of the organization appear to be in no way political, and according to the statutes are exclusively cultural.

The Juedische Rundschau, the Zionist newspaper, has remarked that both the formation of the Jewish Culture League and its name and aims were known to the Ministry, and were approved by it

## Painters Spurn Golden's Bid To Drop Strike

### Won't Return to Status Quo Suggested by Labor Board

"The painters' strike will not be ended on any conditional basis. We will not return to our jobs until we have our demands for a \$9-seven hour day met," declared Philip M. Zausner, executive secretary of the Brotherhood of Painters, Paper-Hangers and Decorators, District Council 9, yesterday.

Commenting on the suggestion of Benjamin Golden of the Regional Labor Board that the painters go back to work and adopt the status quo prior to the strike, Zausner said, "We refuse to go back to work at the height of the season, and then lose our jobs when business becomes slack."

"On other terms, beside those of wages and hours, we are willing to join the members of the Master Painters and Decorators in round table discussion. But the Union must be assured that the terms agreed upon in these conferences will be carried out. There must be no vague promises which will be forgotten when the men return to work."

He said that the conditions the strikers seek are for both the interest of the employers and employees. "Chiselling," he declared, "will be prevented and the industry as a whole will be in a better condition."

## Palestine Records Show Consumption Increase Of Alcoholic Beverages

(J.T.A. Special Correspondence)

JERUSALEM, July 30.—Whatever else they may do, the people who live in Palestine don't go in very enthusiastically for potent alcoholic beverages even now, but they seem to be getting to like it somewhat more as time goes on.

This is shown clearly by the record. The Palestine Commercial Bulletin, published by the Department of Customs, Excise and Trade, reports that in the month of February only 3,583 litres (about 940 gallons) of whisky were imported, and very little is manufactured domestically. In February, 1933, the whisky imports were one-third as great.

## Theory Nazis Shot U. S. Fliers On Transocean Hop Brought Up

"Did Nazis Shoot Down Yank Transatlantic Flyers?" is the question raised in an article appearing in the current issue of Popular Aviation.

E. Stanton Brown, author of the article, goes back to July 17, 1933, when it was announced that "the airplane 'Lithuania,' in which Stephen Parius and Stanley Girenas were attempting a non-stop flight from New York to Kaunas, Lithuania, crashed early today at Kuhdamm (in Germany) and both flyers were killed. Kuhdamm is five miles short of Soldin, Pomerania."

Brown asks in the subhead of his article: "Did blood-mad Nazis relentlessly shoot down the Lithuanian flyers, Darius and Girenas, almost at the completion of their magnificent transatlantic flight? Officially no, but the present habits of international intrigue, artful maneuvering and national white-washing within the circles of international politics makes it impossible to accept official statements when there is so much seeming evidence and rumor to the contrary."

The writer points out there must be doubt about the fact that the Nazi government has told the entire truth about the matter. He says that German officials at first declared that the flyers had crashed because of motor trouble. Expert opinion was to the effect that neither motor trouble nor the weather was responsible. The article says there were three such accidents within ten miles of the spot where the men crashed. Were all these accidents the work of Nazi operations? it asks.

The article points out that, for three months, Nazis kept the bodies of the two flyers. When the bodies were finally seen, there were evidences of surgical treatment, and there were marks on the bodies which might easily have been bullet holes.

Although the United States State Department said "it was an unfortunate accident," the article concludes by asking, "Why has the matter not been thoroughly investigated by the American government? These two men were American citizens, entitled to every consideration as such."

### Noted Attorney Urges Boycott Continuation

It is the duty of the American people, in keeping with their traditional belief, not only to protest but actively to oppose the "injustice and cruelty of the Hitler regime," declared George Gordon Battle in a broadcast Friday night over radio station WEVD. Battle, a member of the board of directors of the Non-Sectarian Anti-Nazi League, discussed present conditions in Germany. The broadcast was sponsored by the League.

Outlining the acts of the Nazi regime by which "the civilized world has been shocked beyond expression," Battle asserted that "the American people must and should impress upon the present German government, that the people of this country profoundly disapproves of what now is going on in Germany."

## The Bulletin's Day Book

Jews of the world should find some cause for optimism in a Berlin dispatch over the week-end which quotes General Werner von Blomberg, Nazi Minister of Defense, as ordering members of Germany's land and sea forces henceforth to address Adolf Hitler as "Mein Fuehrer."

There is something almost diabolic in the abbreviated quality which in the past has characterized the words in the Nazi lexicon.

If you have never been a newspaper man yourself, you won't understand this allusion, so let it herein be explained.

The headline writer, who frequently decides how prominently a story shall be featured, metes out destiny with his copy pencil. The over-worked editor tosses a story over to the headline writer and says, "Play this for what you think it's worth."

The headline writer, otherwise known as a copy reader, looks the story over and finds it full of names and terms too long to fit readily into the large type of the newspaper's more important headlines.

"This is just a rehash," he tells the editor. "I'll cut it way down and put a fourteen-point head on it. We can use it on an inside page."

Along come the Nazis. What could be a better word for a big headline than "Nazi"? Words don't come much shorter than that.

"Hitler" isn't a bad headline either. The letters "i" and "l" are thin, and take up only half as much space as most other letters.

And so Hitler and his Nazi peril—"peril" is another of those convenient short words—take their place of importance in the newspapers of the world alongside Benito Mussolini, who perhaps would have been born to bluster unheard, had not some thoughtful person hit upon "Il Duce" as his official headline cognomen.

Nazism has deliberately shunned the implications of that whimsy of Mark Twain, who told of stretching a single German word clear across a long bridge.

"Goering," "Roehm," "Ernst," "Heines"—all these have been more or less pie for the headline boys.

On the other hand take Dr. Alfred Rosenberg and Ernst Franz Sedgwick Hanfstaengl, both of whom have been more important and more venomously effective in Nazi councils than some of those whose names make the news more frequently.

Hanfstaengl finally came into his own when "Putzy," the nickname of his Harvard undergraduate days, was brought to light. Now, if Dr. Rosenberg entertains any hopes for a bright and publicized future, he ought to ask the boys to start calling him "Rosey."

But "Mein Fuehrer" is bad stuff. That is gilding the lily, if you don't mind our thus referring to Herr Adolf Hitler.

"Mein Fuehrer" is a move in the wrong direction. We prophecy he'll never get anywhere with it. "Fuehrer" by itself isn't bad, although it's decidedly inferior to "Hitler," but when you stick a "Mein" in front of the word you present a real problem to the headline writers.

The dispatch which tells of the von Blomberg order draws an analogy between the new "Mein Fuehrer" salute for Adolf and the "Mon Empereur" or "My Emperor," with which Napoleon's soldiers addressed him.

All we can say to von Blomberg is, if he had Napoleon in mind he was on the wrong track.

Autres temps autres moeurs, von Blomberg, old boy. We can assure you that if Napoleon had had twentieth century journalism to

deal with, he'd have had his men calling him "Nappy," "Bony" or even "Empy."

And while you're at it, you want to watch this fellow Rudolf Hess, Roehm's successor as head of the storm troops. Hess' four-letter name undoubtedly had much to do with his rise to importance in the Nazi set-up.

Von Blomberg seems to think "Mein Fuehrer" is more personal than some of the titles to which Hitler is entitled.

In answer we point out that the "personal" attributes of a title don't necessarily assure it of success.

What could be more personal than some of the names we've indicated we'd like to call Hitler in these columns? You've never seen any of THEM in the headlines, have you, von Blomberg?

"Every really up-to-date cinema of this age gives a program consisting of a news review, a Mickey Mouse or similar item, a four or five reeler ordinary picture and then the feature picture, and for two shillings six pence (about fifty cents at par) one sits in a really comfortable upholstered stall with plenty of leg room."

"Here, for the same money, one has a hard chair, a draught in winter, insufferable heat and closeness in summer, a quantity of purely commercial advertising matter, an old newsreel, sometimes a Mickey Mouse and one feature picture with a devil of a lot cut out of it."

### From Cohn to Columbia

Last Friday at the Palace Theatre Leslie Howard's latest picture, "The Lady Is Willing," was shown for the first time. The occasion was not in itself of special moment, but as Columbia Pictures produced the film, it gives me a long-delayed chance to tell you something about the Two Cohns who own and control that organization.

The Cohn brothers, Jack and Harry, two short, thick-set, plain-spoken, plain-looking, blunt Jewish gentlemen who have passed the first flush of exuberant youth, have enjoyed an amazing success in the motion picture industry. While other companies were expanding, building theatres, signing actors and directors to long-term expensive contracts, floating huge bond issues which had an annoying way of maturing at crucial times, the Cohn boys went their way quietly, effectively and profitably.

How they were able to weather the depression and how they have managed to make money is too long a story to be told in one sitting. It is sufficient to point out one idea that saved their company untold sums of money and yet permitted them to produce films starring the leading players and directors in the industry.

Their method was obvious but clever. A scenario would come to the Columbia offices. One of the roles would call for the acting of a star working for another company. The Cohn boys would make inquiries and find out that the star in question was under contract. If the player were idle one of the boys would approach the head of the rival company and ask to borrow the star for one picture. Usually they got what they wanted. In this way they were able to keep their payroll down and yet produce "name" pictures. The same thing was done with directors. The Cohns had another virtue, they were patient. If the star or director wanted was busy, the boys were willing to wait. Another method they followed was to hire

actors whose options had not as yet been taken up. The actor waiting between contracts would often be willing to work cheaply in order that his or her name would be kept before the public.

Harry and Jack Cohn are New York boys who were brought up within walking distance of Broadway. Their first successful venture into the film business was the production of a series of shorts known as "The Hall Room Boys," based on the famous script of a decade ago. Their progress, although not meteoric, has been steady, and today they control one of the major studios in California. There should be some moral to this story, but I have been unable to find it. No one has ever accused the Cohns of intellectual brilliancy or of possessing a highly-developed esthetic sense. Perhaps they believe that business is business and art doesn't pay. Anyway, their formula seems to work.

### Radio

Radio does not come within the scope of this column and I am undoubtedly poaching a little in introducing this note, but I should like to raise a voice in violent protest against the length of advertising matter permitted in a radio program. I believe that the radio is, in most of its moments, entertaining and enjoyable. Program directors have a sound idea of what people like and they employ actors who can deliver. But the sponsors (the fellows who pay for the time), insist upon overburdening listeners with praise of their product. A comparatively new program advertising a Milwaukee beer is a perfect example. The master of ceremonies, the comedians, the tenor, orchestra and chorus, all blend perfectly, but just as soon as you begin to enjoy the program, along comes a "hick" voice and in sickening and dulcet tones interjects a plea for this beer. Not satisfied, the announcer then follows with more blarney about the product. I don't know what your reaction is to this, but in my home this particular beer is now tabooed.

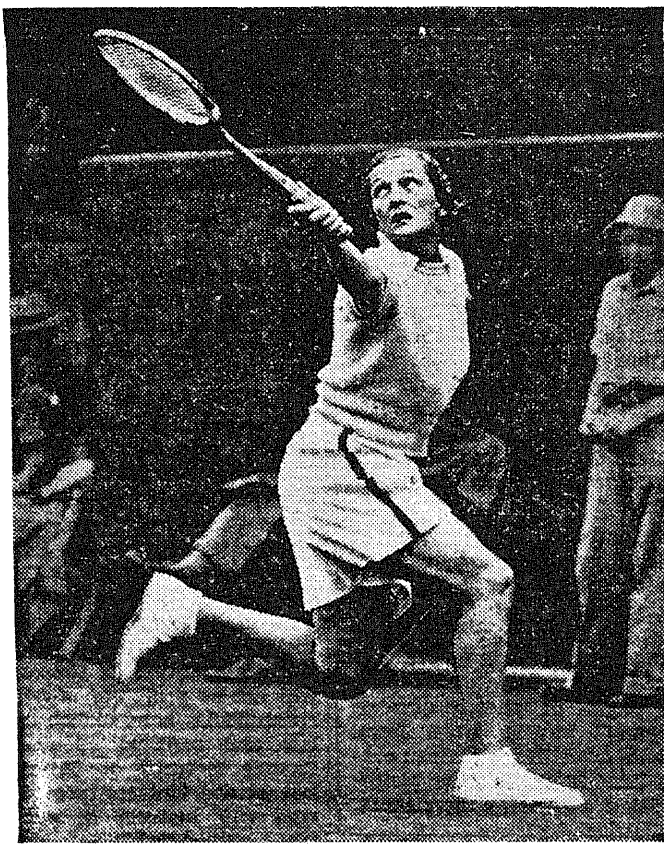

There was another case of a fireman's association. The members paraded around in blue uniforms lined with red flannel, suspiciously like the regulation fireman's uniforms. They sold tickets for charity affairs. Yet not one member of the association had ever been a fireman.

### Enough Charity Groups

"There is no necessity for more charity organizations," Judge Goldstein asserted. "If any one feels kind-hearted, there are enough organizations that will gladly accept offers of assistance. Bonafide charity organizations today haven't nearly as much help as they need."

At present, charity organizations incorporated as religious congregations are immune from investigation by the Department. Most charity organizations organized as congregations conduct only sham religious services, it has been found.

## German Anti-Hitlerites Hold Sunday Program

"After Hindenburg — What?" will be considered by German anti-Hitlerites in New York's first anti-Fascist German Day to be celebrated Sunday at North Beach Park, Astoria.

Chief speaker on this theme will be Dr. Franz Hoellering, German journalist and political commentator, former editor-in-chief of the Berliner Zeitung am Mittag, and the Zwölf Uhr Blatt. The announcement was made yesterday by the Anti-Fascist Aktion (Anti-Fascist Action), of 243 East Eighty-fourth street, which is sponsoring the program.

### Appeals on Suffrage

When the municipal election lists closed in Haifa, Palestine, last month, there were 900 appeals in connection with unregistered voters, of whom 200 were Jews and the remainder Arabs.

## Calls on Jews Not to Compete For Olympics

### Untermeyer Hits Efforts of Officials to Belittle Discrimination

A call to Jewish athletes not to compete for places on the American Olympic Team was issued yesterday by Samuel Untermeyer as president of the Non-Sectarian Anti-Nazi League to Champion Human Rights.

Mr. Untermeyer scored the efforts of American Olympic officials to gloss over the race discrimination issue in moving to accept the invitation to the 1936 Olympic Games which are to be held under the auspices of the Nazis in Berlin.

He said: "My advice to the athletes and others of world Jewry is not only not to compete but to keep as far away as possible from any form of participation in the Olympic Athletic Games to be held in Berlin in 1936. Out of decent consideration for their race, it is unthinkable that any self-respecting Jew could accept the hospitality of a country that persists in so insulting, degrading and persecuting our people."

"Any man with a Jewish ancestor, with a drop of Jewish blood in his veins, who crosses Germany's border, or accepts its hospitality, is deserving only of the contempt of his fellowmen, be they Jews or Christians."

## Munich Humor Paper Pokes Fun at Nazi 'Theories' on Race

BERLIN, Aug. 1.—What seems to be the declining popularity of the race theory among the general population has found expression in The Judent, humorous periodical of Munich.

The publication has gone to the length of publishing an article poking fun at the race-policy of the Government indirectly by describing the manners and customs of the ancient Teutons as they have been recorded by Tacitus and others of that day.

## Brutal Palestine Police Tactics Assailed by Zionist Executives

According to Haolom, there are at least fifty Jewish girls in the Bethlehem jail, and it urges that something must be done for the victims of police brutality.

### Tactics Caused Riot

Hunting for illegal immigrants seems to have assumed the proportions of a major industry in Palestine, with low types of police informers exceedingly active in catching illegal entrants for the miserable reward of a few shillings.

Palestine Arabs have joined gleefully in the game, denouncing Jews as illegal immigrants on the slightest pretext. Thus a number of native-born Palestinian Jews were arrested and freed later.

At least one major riot in Tel Aviv several months ago was the direct outcome of the hunt for illegal immigrants, when Revisionist youths climaxed a protest meeting against police activities by marching through the city's streets. When they clashed with police, bystanders joined in and it was hours before fighting ended.

### Tribesmen Enlisted

Recently the Palestine Arab Youth Federation announced the organization of special squads of young Arab volunteers to patrol roads adjacent to the Palestine frontiers to spy on and capture illegal Jewish immigrants.

Even Beduin tribesmen, known for their ruthless ferocity and lawlessness, are being mobilized by the Federation to watch the borders.

Beduins in the Tiberias and Beisan areas are being promised rewards for every Jewish man or woman they catch.

## Hitler's Doom Is Near, Has No Army Backing, Says Dr. Rosenfeld

(Special to the J.D.B.)

SEATTLE, Wash., Aug. 12.—Although Chancellor Hitler has successfully seized for himself the presidential prerogatives held by the late von Hindenburg, "it is the beginning of the end for the German Dictator," Kurt Rosenfeld, former Prussian Minister of Justice, prophesied here. Rosenfeld, who is an exile from the land of his birth because of his hatred of Hitler, visited this city for a two-day speech tour.

"Hindenburg's death has made Hitler stronger in name only," he declared. "He may have another title, but the German army, the Reichswehr, which Hindenburg commanded, will never follow a corporal. The Dictator is only a puppet of Thyssen, Germany's steel king, and Krupp, munitions maker."

## Gentile Solomon Sought By Jews in Perplexity

BELMAR, N. J., Aug. 12.—The Borough Commissioners here—all of whom are Christians—are perplexed. They have been asked to take a hand in the conduct of the Jewish High Holy Days services.

Maintaining that Congregation Sons of Israel loses financial support when guests or residents attend services in hotels, Joseph Silverstein, Borough Solicitor, has urged the Commissioners to adopt an ordinance which would prohibit hotels here from conducting religious services without the written consent of the Congregation, which has the only synagogue in town.

Action on the proposed ordinance has been deferred.

## Nuremberg Order Hits Jewish Stores Trade

(Jewish Telegraphic Agency)

BERLIN, Aug. 12.—Nuremberg, most bitterly anti-Semitic city in Germany, yesterday ordered the owners of all Jewish stores there to inscribe their names at the stores' entrances in letters "no smaller than ten centimetres in order that Germans buying there should not be able to say that they did not know that they were customers in Jewish stores." The order was issued by municipal authorities.

Nuremberg is the home of Julius Streicher, notorious anti-Semite and editor of the Jew-baiting weekly, Der Stuermer. Recently this paper and other Franconian papers have resumed the practice of carrying full pages of photographs of "Aryans" buying from Jews. Pickets are still maintained outside Jewish stores. The photographs are taken by the pickets.

## Wise Will Preside At Installation

### Will Help Induct Rabbi Jacob Into Hoboken, N. J., Synagogue Pulpit

(Special to the J.D.B.)

HOBOKEN, N. J., Aug. 12.—Dr. Stephen S. Wise, of the Free Synagogue of New York City, will preside at the official installation of Rabbi Robert P. Jacobs as spiritual leader of Congregation Adas Emuno of this city on September 7, it was announced yesterday by Bernard E. Marx, president of the Temple.

Rabbi Jacobs, according to the statement released by the president, was a pupil of Dr. Wise at the Jewish Institute of Religion of New York City, from which he graduated in 1933. He also has studied at the Hebrew University of Palestine.

The special installation services, which will open the season for Congregation Adas Emuno, will mark the beginning of the Temple's sixty-fourth year of service to Hudson County Jews, Mr. Marx said.

## Frick Denies Ritual In Food Slaughtering To Wurtemberg Jews

(Jewish Telegraphic Agency)

BERLIN, Aug. 12.—Reichsminister of the Interior Dr. Wilhelm Frick yesterday rejected the request of the Wurtemberg Jewish community to be allowed to kill at least poultry according to the orthodox Jewish ritual, if not cattle.

Shechita was forbidden by the Nazis immediately after they came into power on the ground that killing of animals for food according to the orthodox Jewish ritual was cruel.

## Add 6 Germans To Faculty of 'Exile' College

### New School Names Noted Refugees to Its Graduate Staff

Six more German professors will be added to next year's staff of the Graduate Faculty of Political and Social Science, the "University in Exile," at the New School for Social Research, it has been announced by Dr. Alvin Johnson, director. The new academic year begins October 1.

The faculty's new members are Hans Staudinger, economist and former Secretary of State for Prussia, who will act as Professor of Economic and Business Administration; Albert Salomon, former sociology professor at the Pedagogical Institute in Cologne, who will act as professor of sociology; Erich Hula, a specialist in public law and political science and a former lecturer on international law at the University of Cologne, who will instruct in public law and political science.

Also, Dr. Alfred Kahler, who will lecture on banking and business legislation; Fritz Lehmann, who will lecture on banking and business economics; and Carl Mayer, formerly a member of the faculty at the Institute for Social and Political Science at Heidelberg, who will lecture on economics and sociology.

With the new additions, the teaching staff of the "University in Exile" totals eighteen professors, seventeen Germans and one Italian.

## Rabid Nazi Anti-Semite Successor to von Papen As Saar Commissioner

BERLIN, Aug. 12.—Joseph Burckal, a Nazi leader, who is a violent anti-Semite, was yesterday appointed Commissioner for the Saar to replace Vice Chancellor Franz von Papen, who is leaving for Vienna as special minister.

The post is regarded as highly important in Nazi Germany, which is set on regaining the Saar. In 1935 the inhabitants of the Saar will vote whether to return to Germany, stay under the rule of the League of Nations, or join France.

## Recover 16 Bodies Of Jews Drowned In Bus Disaster

(Jewish Telegraphic Agency)

WARSAW, Aug. 12.—Heart-breaking scenes took place at Lomza when divers finally succeeded in bringing to the surface the bus in which eighteen Polish Jews were drowned when it plunged into the Bug River. Only sixteen bodies were recovered. The others are missing. The families of the missing men together with members of the Lomza burial society had been praying all day long near the scene of the accident.

In view of the Jewish ritual the government permitted the immediate burial of the victims of the disaster without performing autopsies.

## Rites for Waldman, Jersey Rabbi, Held

ATLANTIC CITY, N. J., Aug. 12.—Funeral services were held here for the Rev. Zalmon Waldman, sixty-two, former rabbi of the Rodeph Sholem Synagogue and one of its founders, who died here Friday, at his home.

Surviving are his widow, Ida, three sons, and two daughters.

Semites, charged with having made an attack on patrons of a Jewish cafe, on the ground that the men were charged with an attempt to overthrow the existing order. The Endecks wounded a number of Jews.

They were immediately arrested and the government ordered the closing of the Endeck headquarters located on the same street as the cafe. The swift arrests of the Lodz Endecks indicates that the authorities are determined to suppress anti-Jewish activities.

The official organ of the Polish government, Gazetta Polska, yesterday carried a cabled resume of the articles on the Polish Jewish situation written for the Jewish Daily Bulletin by Boris Smolar, staff correspondent of the Jewish Telegraphic Agency.

## Attacks on Jews Denied By Polish Agency Head

In a communication to the Jewish Daily Bulletin, Dr. A. Morawski Nawench, general representative of the Polish Telegraphic Agency stated: "I am authorized to deny most emphatically the reports published in the Jewish Daily Bulletin of August 7 and 10 on alleged anti-Semitic riots in Warsaw and Lodz and on the alleged passivity of the Polish government toward such excesses. The Polish government is always acting with the utmost energy and without delay against any attempts to provoke anti-Semitic excesses."

It was unofficially reported that the government had refused to grant the Golden Shirts a permit for a parade which was to have been held yesterday but which failed to materialize.

## Nazis Must Not Fire Jews, Frankfurt Court Holds

BERLIN, Aug. 12.—The Labor Front, Nazi workers union, cannot dismiss Jewish workers from employment, it was ruled today by a court in Frankfurt. The decision ordered the reinstatement of a Jewish laborer in whose discharge from a Frankfurt enterprise the Labor Front had been instrumental.

As a general rule the courts have frowned on interference from the outside with the authority of the "fuhrer" of any given enterprise.

## Anti-Semitism Deplored At Baptist Congress

BERLIN, Aug. 13 (Monday).—The resolution passed by the World Congress of Baptists in their session here reads as follows, it was revealed today:

"The Congress deplores and condemns as a violation of God's law all racial animosity and every form of oppression of, and unfair discrimination against, Jews."

## Ponder Hiring 34 Reich Exiles At Hebrew U.

### Board Members Weigh Proposal Today in Zurich Session

A five-year plan providing for the employment of thirty-four exiled German professors at the Hebrew University in Jerusalem will be presented today at the annual meeting of the board of governors of the university, assembled in Zurich, Switzerland, according to an announcement by Dr. A. S. W. Rosenbach, president of the American Friends of the Hebrew University.

Chancellor Judah L. Magnes, who has negotiated directly with outstanding German scholars and scientists dismissed from their posts during the past year, will present his report in person. If the plan is approved the Hebrew University will have more of these German exiled scholars on its staff than are now attached to any other institution in the world.

The funds which will finance this program, Dr. Rosenbach stated, have been raised both here and abroad, and fourteen scholars have already been appointed.

The American members of the board of governors who are in attendance at the Zurich sessions include Dr. Cyrus Adler of Philadelphia, Drs. Emanuel Libman and Nathan Ratnoff of New York, Charles Rosenbloom of Pittsburgh, and Dr. Stephen S. Wise.

The European members of the board of governors, most of whom are expected to attend, include Professor Sigmund Freud of Vienna, Chief Rabbi J. H. Hertz of England, Sir Herbert Samuel and James de Rothschild of London, Senator Samuel Van der Bergh Jr. of Holland, and Dr. Chaim Weizmann of London, president of the Hebrew University, who will preside.

Important announcements also are expected concerning the choice of a site for the new University Hospital in Jerusalem, and the plans for the new department of cancer research to be established with the fund of over \$200,000 supplied by an anonymous giver.

## Tel Aviv Votes £100 For Algeria Relief

### Moslem Pogrom Victims Get Money and City Extends Them Its Sympathies

(Jewish Telegraphic Agency)

TEL AVIV, Aug. 12.—A fund of £100 was raised by this municipality tonight to be sent to Algeria for the relief of victims of the Moslem pogrom in Constantine. The money was voted at a meeting of municipal officials who passed a resolution extending the city's sympathies to the Algerian Jews. In memory of those who died in the Constantine massacre, those present stood and observed silence for one minute.

The resolution appealed to the French authorities not to permit any further bloodshed.

## Fair Is Canceled, Moslem Troops Disarmed and Held

(Jewish Telegraphic Agency)

PARIS, Aug. 12.—French authorities at Bone, Algeria, yesterday cancelled the weekly fair in the city, fearing an anti-Jewish outbreak, it was reported here.

All Jewish shops were ordered to close their doors. Moslem troops, who form part of the local garrison, were disarmed and locked up in their barracks. European troops, including marines from the French battleships Mateiot and Leblang, are patrolling the street.
