Dr. Lipman Honored

Dr. Jacob G. Lipman, Dean of Agriculture at Rutgers University and director of the New Jersey Agricultural Experiment Station, has been awarded the Chandler Medal of Columbia University for 1934. According to the announcement of the Medal Committee, "Dr. Lipman's work on the determination of the nature of the chemical action produced by bacteria in making both organic and inorganic components of soils available for plant food has been of great importance to agriculture all over the world."

The medal will be conferred at a national assembly of scientists at Columbia in November.

Dr. Lipman, who came to this country as a Russo-Jewish immigrant boy in 1887, was one of the pioneer Jewish farmers in Woodbine, N. J. He is a graduate of the Baron de Hirsch Agricultural School. Since his graduation he has devoted himself to various phases of scientific work regarding agriculture and has become recognized as one of the foremost authorities on the subject in the world. His monographs on "Education and Research," "Rural Settlements" and technical papers on soils, soil bacteriology and agronomy are considered both here and abroad as authoritative contributions of great value.

If, by chance, Dr. Lipman had emigrated from Russia to Germany instead of to the United States, his scientific achievements and contributions would have placed him now in the category of the despised and persecuted "non-Aryan" intellectuals.

Allenby on Fascism

Viscount Allenby, the modern liberator of Palestine from Turkish rule, discussing Fascism, said:

"Mosley made an ass of himself. I do not think Fascism is needed in Britain, nor in Canada, nor in the United States."

The Fascist leader in England, Mosley, has recently discovered that his movement is not making any headway. Some of his prominent supporters have abandoned him and his Fascism, which was patterned somewhat along the lines of Hitlerite Nazism. The recent savage antics of the Nazis have opened the eyes of many reactionary people in other lands, who at first believed they could strengthen reaction in their countries by emulating the Hitlerite methods. Now they have convinced themselves that these revolting methods could not be transplanted in a civilized country.

Bienefeld Used Justice's Name Without Authority, Court Hears

Howe Denounces 'Center' Work as 'Disgrace to Community'

A motion to dismiss charges of conspiracy to defraud against Rabbi Jacob Bienefeld and his son, Myron, on the grounds of insufficient evidence, was denied by Magistrate Richard McKiniry in First District Magistrate's Court yesterday.

Witnesses testified that the Downtown Center, Rabbi Bienefeld's organization, used a judge's name without permission in soliciting funds, that Rabbi Bienefeld misrepresented himself over the telephone, and that the Downtown Center is a "racket."

Among the witnesses were former Magistrate Hyman Bushell, Sylvia Wells, a secretarial worker at the Downtown Center, Deputy Commissioner of Welfare Stanley H. Howe and Clark F. Ruck, a Port Jefferson Justice of the Peace.

Commissioner Howe termed the

Downtown Center "a religious corporation that does primarily charity work. The kind of charity work performed," he said, "is a disgrace to the community."

Stuermer Will Renew Fight on 'Judah' Aug. 18

Two-Week Suspension Up on That Date; Had Attacked Masaryk

BERLIN, Aug. 14.—Der Stuermer, bitter anti-Semitic weekly edited by Julius Streicher, today notified all subscribers it will resume publication on August 18 and will "carry on the fight against all Judah as usual."

Herr Streicher's paper was suspended for two weeks by the Nazi government, not for its continual incitement against the Jews, but for having declared that the venerable Czechoslovakian president, Thomas G. Masaryk, was a half Jew and was therefore furthering Jewish plots. An attack on the head of a foreign government was considered reason enough to halt the publication of Der Stuermer for a short period.

Der Stuermer is published in Nuremberg, headquarters of Herr Streicher, who is Nazi commissioner for Franconia, where the worst excesses against the German Jews occurred.

Wauchope Told Tel Aviv Needs Hospital Beds

TEL AVIV, Aug. 14.—A serious shortage of hospital beds exists here, High Commissioner Sir Arthur Grenfell Wauchope was told today when he arrived to inspect this all-Jewish city.

The High Commissioner also was informed by officials that the municipality is badly in need of land on which to build suburbs for persons of small means. Municipal officials asked for government assistance for this project.

Smugglers Aid Many Jews to Enter Palestine

Haifa Judge Sentences 23 to Deportation; Jails Crowded

JERUSALEM, Aug. 14.—Palestinian jails are overcrowded with Jewish suspects accused of having entered the country illegally, while agencies in Beirut, Syria, are undertaking the large-scale smuggling of Jews into Palestine, a survey made today indicated.

In Haifa, local magistrates today sentenced twenty-three Jews and three Russian Christians to serve two months in jail and to be deported at the end of their sentences. They were charged with having entered the country illegally.

Seek 500 Planes To Halt Arab Riots

Paris Set to Grant Demands of Constantine Mayor Who Asks Permanent Military Defense and Inquiry to Check Future Pogroms

PARIS, Aug. 14.—Three startling recommendations to prevent recurrences of the anti-Semitic outbreaks in Algeria, which cost the lives of at least twenty-three Jews and four Arabs, were received here today by the Minister of Colonies from Mayor Marinaud of Constantine, who urged a permanent guard of 500 military airplanes to patrol areas of the country not readily accessible the army and gendarmerie.

2,000 Extra Police Sought By Saar Basin

Situation Out of Control There, Says League Commission

GENEVA, Aug. 14.—At least 2,000 additional police are needed in the Saar Basin, the League of Nations commission governing the area informed the League today, if the plebiscite to be held there in January is to be carried out peacefully. The inhabitants of the Saar are to choose whether they are to return to Germany, become a part of France, or continue under the rule of the League of Nations.

Conditions in the Saar have become so bad in the last few months that it was utterly out of control, the commission said, asking for the recruiting of the additional 2,000 men in foreign countries, recommending countries which are members of the League and in which German is spoken.

According to the commission the Saar gendarmerie is utterly useless and is maintaining relations with the Nazi secret police, and that its impartiality is being rap-

Name Goldman Postmaster

(Special to the J.D.B.)

WASHINGTON, Aug. 14.—Albert Goldman, former Commissioner of Plant and Structures, was appointed Acting Postmaster of New York City today.

The mayor of the third most popular city also demanded that the present garrison of Constantine be maintained and requested the right immediately to mobilize all French citizens resident in Algeria up to the age of sixty. The Jewish population of Algeria is made up almost entirely of citizens of France, while the native Arabs have been loath to assume citizenship, going so far as to brand such action traitorous.

Gov. General Jules Carde, the Jewish Telegraphic Agency learns, as well as the French government, have approved M. Marinaud's demands, which also include the request that an official fact-finding committee be nominated to estimate the losses attending the fierce Moslem pogrom. At the same time M. Marinaud asks that the proposed body be empowered to authorize the creation of a huge relief fund.

Those injured during the Arab riots, when whole families were wiped out in certain Jewish quarters, the throats of women and children slashed from ear to ear, have been placed unofficially in the hundreds. Property damage is reported to have exceeded \$3,000,000. Seventy Arabs have been jailed thus far, receiving sentences of from two to three years each. Approximately 150 others are under arrest, awaiting trial. Unofficial estimates of the dead range from sixty to 100.

Poland Honors Rabbi

WARSAW, Aug. 14.—The Polish Government today bestowed a gold medal upon Rabbi Gutschlechter in recognition of his organizational activities in behalf of the internal loan recently floated by the government.

Indian Moslems Protest Jewish Entry in Palestine

SIMLA, India, Aug. 14.—Both the Indian Moslem League and the Indian Moslem Conference, which are now in session here today, passed resolutions condemning further Jewish immigration into Palestine as "unjust and dangerous."

Two Indian Moslem delegations recently left India; one to intervene with the British Colonial Office on the question of Palestine, and the other to meet and confer with Moslem leaders in Egypt, Palestine and Syria on the problem of Zionism in Palestine.

Jews Crushed in Austria Turmoil

Are Caught in Three-Cornered Struggle for Political Control

Once Powerful Vienna Community Reduced to Destitution; Prey of Nazis, 'Reds' and Fascists, 250,000 Face Starvation, Writer Says

The political turmoil in Austria has wreaked havoc with the Jewish population of that country, more particularly with the Jews of Vienna.

Only five years ago Vienna was a thriving, virile, powerful community of nearly a quarter of a million Jews. They owned property. They were respected by their neighbors. They were looked up to as one of the leading Jewish communities of the world.

Now, all that has vanished. The Jewish community of Vienna is impoverished. It is sunk in misery. It is despondent, pride is gone and little remains of the fighting spirit of the old self-reliant, economically self-supporting, emancipated Jewish community.

Every Jewish hand in this city, in all Austria, indeed, is now stretched out begging for bread and work.

There has suddenly descended upon Austrian Jewry an economic catastrophe. The cause lies mainly outside itself, in the political influence of Hitlerism. It lies in the combined plotting of the terrorist and vandalist elements among the Hitlerists, Socialists and Communists in Austria, all of which are aiming to overthrow the existing government.

Terrorism Grows

This terrorism is increasing from week to week, despite the most drastic measures taken by the government.

There are people holding the highest office in the land who are strangely quiet about it all. The reasons contributing to this ominous quiet are many. We list the two most plausible. They are quiet because the Nazis, the very bomb throwers and terrorists for whom the law specifically demands death, are their own sons, their own flesh and blood.

It is literally true that the country and the government service areoneycombed with Nazis.

Only a few days before Dollfuss was assassinated, he had again reconstructed his government. What could the luckless man do? He could not rely upon his most important ministers. One did not want to shoot or imprison every Socialist in Austria. The other refused to sentence to death every Nazi in the country.

And who could blame either for refusing by their own hand to send to death their own sons and daughters; their own brothers and sisters?

Condition an Open Secret

These are among the things it is not permitted to write about in Austria. But people talk about them, and they are no secret to

anyone. The Minister of War, Prince Schoenberg-Hartenstein, one of the highest Imperial Generals of the old Austrian empire, resigned because his own son had been arrested for Hitlerist activities and is now in a concentration camp. The commandant of the Vienna mounted police was dismissed together with a dozen other high police officers, having been caught redhanded at Hitlerist activities. They were found in possession of Nazi material.

All the above information is written down in printer's black in the official publication "Prager Presse," the organ of the Czechoslovakian government which was friendly to the Dollfuss regime. It would be necessary to hang or put in concentration camps about eighty per cent. of the active Austrian population to pacify the country and assure the stability of the present government.

Austria a Ruined Land

This terrorism and uncertainty have ruined the country economically. And the result is, that the Jews, who depend on trade, have lost the very ground under their feet.

Commerce and industry are killed. The tourist traffic is dead—there is no security in the country. A kind of Mexico or Albania is developing in the heart of Europe.

The whole country has descended into the depths. Every man's hand is against his neighbor's. And all hands are against the Jews.

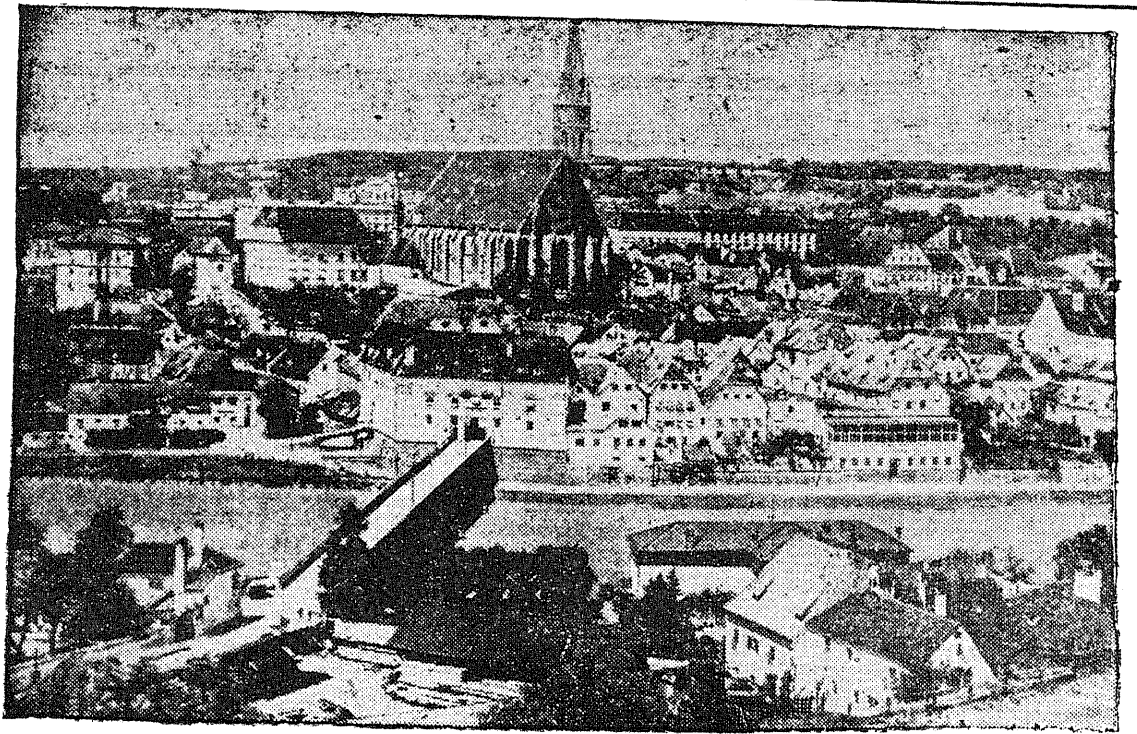
The Jews are buffeted and beaten from three different sides. Everybody knows that even the bombing of Jewish business places is not the work of Nazis alone. Communists and Socialists have been and still are their accomplices. Not out of anti-Semitism, but because they are furious with certain Jewish politicians who are friendly to the government.

Revolutionary conspirative elements in Austrian Socialism refuse to accept the Jewish explanations that they have no choice. The left party revolutionaries contend that, so far as they are concerned, Hitler or Starhemberg makes no difference to them. It is a matter of no moment to them, they assert, if the Jews want to take refuge under the wings of Catholic Fascism.

The result is, that the Jews are struck from all sides. From the Nazis, from Socialist and Communist terrorists and also from the new Christian-German political movement in Austria. (On top of all this, I am informed that the Left Party elements even boycott Jews in trading).

There is no evidence that the Fascist government has issued instructions to enforce a numerus clausus against Jews, let alone a numerus nullus. But it is, nevertheless, a fact that the Christian-German policy is enforced rigorously in all institutions and enterprises connected in any way with the government or various municipalities. This is done without official orders. They are not needed. Socialist Jews have been dis-

ment, whatever it is, as assistant in any business, as packers or carriers, at any kind of work—anything, so long as it will enable them to keep their families from starvation."

"In addition," the appeal points out, "it is now the end of the school year, and many Jewish girls and boys are leaving school, without the slightest chance of finding work. Nobody will take them. A Jewish mother who visited a Christian firm was told: 'Even Jews do not accept Jewish employees.'"

This appeal shows how really desperate the position is in Austrian Jewry. The Vienna Jewish community is crashing financially under the load of trying to find the funds to pay out the small doles that keep body and soul together among those who are otherwise at the end of their tether. And the dole amounts in all to a few cents, not enough to provide a man with one good meal to still his hunger—and the community is compelled therefore to go to seek help from Jewish organizations abroad to enable it to continue to dole out these few cents per head to keep from starvation tens of thousands of shame-faced Jews who not long ago were well-to-do.

A special representative of the Vienna Jewish community may soon be going abroad to try obtain help among the Jewish communities of other countries. Will the help be just a few more cents to stave off starvation for another day, or is it possible to do something to alleviate the terrible position of Austrian Jewry?

missed from every official position because they are Socialists. Others who are not Socialists have been dismissed under all sorts of pretexts. It is only in rare instances that a Jew has been able to retain his office and then only by bringing powerful influences to bear on his behalf by those Jews who are in close association with the government. That this intervention is possible is due to the fact that the government needs its Jewish leaders. They need them not only to create a friendly attitude abroad for Christian-German Austria, but what is of more immediate importance, to obtain for it financial assistance, out of their own pockets or from abroad. And thus it happens that sometimes a Jew here and there retains his old position.

"Nothing Left for Nazis"

There is a bitter jest going the rounds in Austria:

"By the time the Nazis come to power in Austria, they will find there isn't a thing left for them to do in the direction of eliminating the Jews. It will all have been done for them."

The Jewish situation in Austria is a terrible one, especially in Vienna where nine-tenths of Austrian Jewry lives. I shall say nothing now of the complete annihilation of Jewish emancipation in Austria. At the present moment,

it would be more to the point if Austrian Jewry could be assured of the means of bare subsistence, for it is utterly destitute and all avenues to bread and employment seem closed to it.

It is here that we have the calamity at its worst. There is no bread and no work. Hunger and distress stalk through every section of the Jewish population. Hardly a family is exempt. Doctors, lawyers, members of the liberal professions, artisans, officials, skilled workers, merchants, brokers—all of them are in enforced idleness. For them there is no employment and no bread.

I have in front of me an appeal issued by an official Jewish body, formed for the special purpose of endeavoring to find employment openings for these unemployed. It reads as follows:

Appeal for Aid

"The number of Jews in search of work is growing more and more. Directors of first-class banks, bank managers, bookkeepers, owners of large enterprises, representatives of immense stores, salesmen in flourishing business houses, civil engineers, building workers, electro technicians, mechanics, skilled and unskilled workers, bakers, hairdressers, etc., etc.—are seeking work. All without exception are prepared to take any employ-

Adjusting Our Lives

Employment Agencies and Anti-Jewish Discrimination

Even before the great depression, the increasing severity of anti-Jewish discrimination in office employment forced upon the attention of Jewish communal workers the question of exclusively Jewish employment agencies. Many Jewish leaders were convinced that part of the discrimination was due to a prejudiced attitude of managers and their subordinates in commercial employment agencies. Steps were even undertaken to study the legal aspects of the situation.

The economic depression has sharply intensified the handicap against the Jewish workers and office employees. Racial prejudice on the part of personnel directors, coupled with the anti-Semitism of certain employment agencies, have made the un-American economic discrimination a burning problem of American-Jewish life. In 1930 and 1931 a few employment agencies in New York displayed placards reading, "Applications not accepted from Jews." These signs were removed after protest.

Attitudes of Agencies

The Bureau of Jewish Social Research undertook, in 1929, a study of twenty-three commercial agencies as regards anti-Jewish discrimination. Eight of these were very discouraging and emphasized the futility of registering since Jewish girls stood no chance of being placed. Several other did register them, but pointed out to the difficulties in placing.

All in all, in ten out of twenty-three agencies the Jewish girls had no chance of being placed, while in seven others they had a very little chance, and only at six they had as good a chance as if they were not Jewish.

According to some of the employment agencies, such discrimination is found among Jewish professional and business people as well as among non-Jews, and the agencies must meet the demands of employers.

Case for Jewish Agencies

While various Jewish welfare agencies for youth, such as the Young Men's and Women's Hebrew Associations, have now for many years carried on placement work among young men and women, there have appeared in recent times recommendations to put this branch of welfare work upon a broader foundation. Several leading social workers have suggested that Jewish welfare federations should consider the establishment of employment exchanges as an integral part of their community program, and as a means to concentrate upon the problem of anti-Semitic discrimination.

Jewish employes, according to this current of thought, face unemployment not only as workers, but as Jews, particularly when better-paid work is involved. Therefore, much more individual attention is needed for this new type of involuntary unemployed Jew.

The Jewish social work agency, the argument runs, being in touch with both the Jewish job-giver and the Jewish job-seeker, is surely in a much better position for service than the usual employment agency. Truth to tell, the latter is hardly equipped in America to cope with the ordinary day-to-day problem of unemployment for even non-Jewish wage-earners. Again, cooperation and experiences of such experiments as the employment exchanges of the men's clothing workers should stand in good stead during the first stages of a purely Jewish employment service.

A Controversial Issue

On the other hand, various authoritative students of American-Jewish community problems, among whom Dr. J. M. Rubinow is foremost, are not at all enthusiastic about the plan of organizing special Jewish employment bureaus, particularly under the auspices of Jewish social service agencies. "The case worker in his praiseworthy anxiety to achieve an individual adjustment," says Dr.

Rubinow, "may lend all his efforts in that direction, as perhaps he rightly should, but he often does it without due regard to the more remote and obscure but inevitable social consequences."

Furthermore, a job at any cost, no matter what the conditions of employment, may suit the particular individuals economic and psychiatric situation, but proper relations between social and economic classes cannot be established in that way. Placement of a few handicapped is one thing, and proper organization of the labor market as a whole quite another.

This view, then, takes notice of the new trend toward far greater consolidation and not subdivision of the all-important machinery of bringing job and man together. In the long run, a special Jewish employment office may only facilitate anti-Jewish discrimination, and may cause sub-standard conditions of employment for Jewish labor.

An Expert Opinion

The argument for purely Jewish employment agencies is vulnerable to refutation in the opinion also of a leading non-Jewish specialist in placement problems. We refer to Dr. Mary H. S. Hayes, director of the Vocational Service for Juniors, a free, non-sectarian placement organization located in the East Side of New York.

Hers is the following reasoning. No employer who thinks he does not want Jewish help will pay any attention to a Jewish agency. An agency having applicants of all races, upon whose judgment the employer has come to rely, sometimes can persuade him however to make a trial of some particularly suitable applicant, even though Jewish.

As a matter of fact, sheer anti-Semitism on the part of the employment agency is a rare and casual occurrence. In most cases, their anti-Jewish attitude is caused not by personal prejudice but by the bias of their customers and clients, the employers of labor. Thus, a shifting of responsibility from agency to employer, and from the employer further on to the public usually takes place. The whole situation, one may say, is a far-flung and most vicious circle.

Anti-Nazi Circulate Protest on Rumored Loan to Nazis by U.S.

CHICAGO, Aug. 14.—The Chicago Committee for the Defense of Human Rights Against Nazism is circulating 25,000 petitions addressed to Secretary of State Cordell Hull protesting against rumored loans to Germany, it was announced today.

The petitions emphasize the fact that any money loaned to Germany will "strengthen the Hitler government." It states further, "We feel deeply that the United States can not afford in any way to seem to approve of a government that persecutes and kills scholars, Pacifists, Socialists, Catholics, Protestants, Jews, women and labor almost indiscriminately."

Buyers of Nazi Goods Protest Firm Picketing

Claim Purchases Are Necessary as Minute Men Go on Duty

Denying that his firm, the New York Merchandising Company, dealt in German products unless it were absolutely unavoidable, Philip Maslansky, president, yesterday bitterly protested against picketing activities of the Anti-Nazi Minute Men of America.

"Our company," he informed the Jewish Daily "Bulletin," "has lost big customers throughout the country because it has so completely cut off German goods. We have gone to Czechoslovakia, Poland, Japan and all over the world to find substitutes for German products."

Maslansky, whose place of business is at 32 West Twenty-third street, is the son of Rabbi Zvei Hirsh Maslansky of Brooklyn.

Edgar H. Burman, commander-in-chief of the Minute Men, who supervised the picketing, said his organization found that while the importing firm had cut its purchases from Germany down to more than one-third of the last year's total, Maslansky was still buying considerable Nazi merchandise.

The picketing started yesterday. Members of the anti-Nazi unit paraded in front of the building, carrying signs that read:

"For Humanity's Sake, Don't Buy German Goods. The New York Merchandising Company Sells Nazi Goods. Cooperate With the Anti-Nazi Minute Men of America, 100% American, Non-Political, Non-Sectarian."

Maslansky, a prominent figure in Jewish activities, said his organization had formerly specialized in German goods, but was now boycotting all Reich products whenever substitutes could be found.

He admitted receiving several cases of German gloves recently, but explained he was forced to make the purchase because there were no possible substitutes. He said he was now trying to have Polish glove manufacturers make up gloves for his firm to replace the German product. He declared it was absolutely necessary for the company to use Hamburg as a shipping center, but that no goods that came to his company was being shipped on Nazi boats.

During the picketing a block of wood fell from a second-story window of the building which the firm occupies. Glass was shattered and Fred A. Victor, of 150 Fifth avenue, was injured. Officials of the company said it was an accident. Victor was not among the picketers.

word he warns the reader thus: "I am neither a stylist nor a master of English. Through a ghost writer I could have masqueraded as either or both. I refrained from employing a ghost for fear of having substance whittled by style."

"Through this book the author is chatting with you in the hope of arousing interest in the subject of the Law's Mishandling of Domestic Relations."

Magistrate Goldstein's book is full of "human interest" stories based upon cases that came up before him and other judges. It is marked with flashes of genuine humor and wit. It is a simple but deeply sympathetic analysis of the ills resulting from misunderstanding, from indifference, from cold legalism, in the old-fashioned attitude of the court toward domestic relations. And the author proposes the remedy.

"Human maladjustment affects the community at large as seriously as an infectious disease," writes Magistrate Goldstein. "When the medical scientist seeks new cures for old ills, he enters the laboratory with a desire to probe, study, test and experiment until he has found a cure. In the same spirit as the scientist enters the laboratory, so the Domestic Relations Court should be used as a laboratory for the study of human behavior in an effort to find cures for old ills."

"One thing is certain—old ways and methods have failed."

The book ends with a few remarks on the "magic" judicial gown. The author is just as modest in his conclusion as in his foreword.

Thus he writes:

"The judicial gown, as you know, is a black silk robe that the judge wears. With many, it acts as a magic robe. The moment he dons it, he becomes all-knowing. He acquires the knowledge, experience and training necessary for the solution of any problem or any controversy. Many judges who, with-

out it, could not rig up an electric bell, with it, acquire the scientific knowledge necessary to pass on patents involving highly technical engineering matters. Without the gown, many of them limit their reading to the newspapers; with it, they become literary critics and censors. Without it, they could not solve or diagnose or prescribe concerning matters in their own homes; with it, they acquire the knowledge, training and experience of psychologists, psychiatrists, religious leaders, educators and child guidance experts.

"For some unknown reason, my judicial gown lacks the magic power. . . ."

"And so I venture the opinion that there is no magic to the judicial gown; that it is, in fact, just a fairy tale. A lawyer without social vision becomes a judge without social vision. By social vision I simply mean the desire and ability to see further than your nose; to treat individuals in their relation to society and to think of society when you are prescribing for the individual—to think not only of yesterday and today but also of a better tomorrow."

The common sense, the vision and the sympathetic understanding with which the author treats the complicated problems that come before the Domestic Relations Court cannot fail to serve a good purpose and to lead to essential reforms.

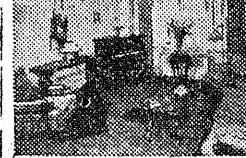

Sanctuary Conducts Meetings At Blue-Stocking Church Here

Col. E. N. Sanctuary, notorious anti-Semite and American leader of the World Association against Jewish Aggression, who twists Biblical phrases in his efforts at inciting racial hatred, has been conducting so-called midweek prayer services at the blue-stocking Broadway Presbyterian Church, Broadway and 114th street, the Jewish Daily Bulletin learned yesterday.

The last of this series of six services will be held in the lecture room of the church tonight.

Sanctuary will begin conducting Bible classes in the Fifth Avenue Presbyterian Church Sunday morning at 10 o'clock, it was learned at the same time.

Most of the leading members and officials of the two churches, both of which have wealthy congregations, were out of town yesterday. The sextons at both, however, confirmed the fact that Sanctuary had received or was to receive the hospitality of their institutions.

At the Broadway Presbyterian Church, Charles Jones, the sexton, explained that the anti-Semite's audiences, which have been large, have consisted principally of "outsiders" during the past six weeks.

"We're near Columbia University, you know," he said, "and during the warm season our sessions

are attended chiefly by summer students from there."

No Pastor for Flock

Asked who is the pastor, Jones said the church has been without one since last February, when Dr. Walter D. Buchanan, its last spiritual leader, died. Since then, he declared, the affairs of the church have been in charge of a governing body known as the session, of which Dr. Frank C. Yeomans, a Park avenue physician, is the clerk and head officer. The session invited Sanctuary to use the lecture room of the church on Wednesdays.

"Not more than fifteen of our members have attended any single midweek meeting conducted by Col. Sanctuary," the sexton said. "I must say that the ones who did go were somewhat surprised and dissatisfied with the type of thing he was talking about. We usually have old-fashioned prayer meetings, you know, and Sanctuary did almost everything except hold the type of services to which our members are accustomed."

On the first night of Sanctuary's appearance at the church, he said, several policemen were discovered outside the door before the meeting began. This was distasteful to the session, which subsequently succeeded in having the police guard withdrawn.

Mosley Made an Ass Of Self, Says Allenby

MONTREAL, Que., Aug. 14.—"Mosley made an ass of himself," bluntly declared Field Marshall Viscount Allenby when interviewed here before his departure for England.

"I do not think Fascism is needed in Britain, nor in Canada, nor in the United States," he added.

Pressed for a statement on Palestine, which he helped to liberate during the war, he said:

"I had no dreams, no aspirations, no hopes in Palestine. My duty there was to beat the common enemy. He happened to be the Turk. I beat him and that was all the aspiration I had."

Pay Honor to 2 Chileans for Anti-Nazi Stand

Deputies' Names In-scribed by Jews in 'Golden Book'

(J.T.A. Special Correspondence)

SANTIAGO, Chile, July 24.—The names of Edmundo Fuensalida Espinoza and Carlos Vicuna Fuentes, Chilean parliamentarians, have been written into the Golden Book of the Jewish National Fund (Keren Kayemeth) in recognition of their efforts against the persecution of German Jews.

In April of last year Deputy Fuensalida introduced a bill condemning the Hitlerite barbarities in Germany. Deputy Vicuna energetically supported the bill in the Chamber of Deputies, where it was adopted after a short debate.

Certificates from the Golden Book were presented to both deputies at a special ceremony at which they were given a great ovation and were greeted with shouts of "Long Live Chile!"

In reply to speeches by M. Fainovich, president of the Zionist Federation of Chile, and David Dubinovsky, director of the Keren Kayemeth, Deputy Fuensalida praised the Jewish people for their contributions to the development of civilization. He condemned the foolish and incongruous assertions by anti-Semites in general and Nazis in particular and expressed the opinion that the Nazi regime would end soon and anti-Semitism be dealt a telling blow.

Ruck admitted signing the letter but denied ever having delegated authority to sign his name or use his name in collecting of funds.

Gerson showed discrepancies between the copy and the original letter and proved to Judge McKiniry's satisfaction it was not a true carbon copy. Ruck could not explain the discrepancies.

Likens Hitler To Hindenburg In Essentials

Political Commentator Doubts Reich Faces Early Change

"The new Hitler is flesh and blood of the old Hindenburg," declares Frank Bohn, political commentator, in the current issue of Today. He says that although these two were superficially different, as soon as the essential factors of history behind them are seen, the similarity becomes evident.

"The Hindenburgs bred, as cannon fodder, an over-populated nation—65,000,000 on 208,000 square miles of territory. Now that these 65,000,000 starvelings occupy only 182,000 square miles, the Hitlers will go on the job," Bohn writes.

"If the Hindenburgs as a class had really opposed Hitler, he could have never come to power. Hindenburg, to the last, represented the Germany of arrested development, the old and stultified political mind of Bismarck and the Kaisers. He accepted the Republic because nothing else, at that time, was possible."

"Some of us are not so hopeful as are the younger folk of an early change in Germany," the writer concludes.

Kanter Will Lead Passaic Vets at National Convention

Bienefeld Used Justice's Name Without Authority, Court Hears

(Continued from Page One)

"Children are exploited in its camp," he asserted, "to line the pockets of the promoters. Reliable social workers have found that conditions at the camp are rotten. On some days the children were fed only potatoes."

These remarks were stricken off the record after an objection raised by Irving Spieler, defense counsel.

Bushell repeatedly referred to the Downtown Center as a "racket." "The Downtown Center is a fake," he declared at one point. At another time he said, "I didn't know synagogues work these rackets." These remarks were stricken out.

Bushell explained how Myron Bienefeld, the messenger for the Downtown Center, had been trapped. He said he received a call from Evelyn Langfeld, secretary to Rudy Vallee, asking for advice about an alleged telephone request from Judge Ruck for a donation.

Bushell testified that he called the number left by the solicitor and asked for Judge Ruck. A man answered. Bushell said, identifying himself as Mr. Avery, secretary to Judge Ruck. Bushell testified that the voice guaranteed that Judge Ruck was a judge in New York City.

Later Ruck testified that he was a Justice of the Peace in Suffolk County, Long Island, that he had never had a secretary, and that he had never heard of Avery. The number Bushell called, Worth 2-7000, is the number of the Downtown Center, of which Rabbi Bienefeld is the head.

Bushell said he phoned again on the following day, July 26, and that a girl answered the phone. Bushell said he told the girl he was Lester Laydon, Vallee's secretary. He testified he then heard the girl shout "a call for Judge Ruck."

A man then spoke, Bushell said, who identified himself as Avery. Bushell said the voice was unmistakably that of Rabbi Bienefeld. Bushell asked to speak to Ruck, he testified, and after a pause Rabbi Bienefeld again spoke, saying he was Judge Ruck.

"Rabbi Bienefeld became Avery or Ruck just as he pleased," declared Bushell.

"Will you fix cases in court for

me?" Bushell testified he asked, still posing as Laydon. "Sure I will," Bienefeld is said to have answered, saying, "I'll fix cases for you or Vallee," still pretending to be Judge Ruck.

Bushell then asked for a messenger to take Vallee's check. Detective Harry Lichtblau of the District Attorney's office, who had been listening to this conversation on an extension telephone, arrested the messenger, Myron Bienefeld, when he arrived with a letter and receipt.

Bushell, Lichtblau and the boy then went to the Downtown Center in his car, Bushell testified, and on the way the boy, in answer to the question, "Don't you know your father is operating a racket?" answered, "What about it?"

Admittance and Retraction

At the Downtown Center all found there were placed under arrest and taken to the District Attorney's office. Bushell said Sylvia Wells admitted under questioning she had been the girl who answered the phone and it was Bienefeld who passed as Avery and Ruck.

In court yesterday she said she was not sure who had answered the telephone, although it was on her desk.

She testified Bienefeld often endorsed checks in Ruck's name and that he signed Ruck's name to letters. She also testified Bienefeld instructed her to call him if any one asked for Ruck.

Placed on the stand by John Sullivan, Assistant District Attorney, Ruck testified he had never given Bienefeld permission to use or sign his name. He said he received no money for use of his name.

Ruck was shown a letterhead of the Downtown Center listing him as honorary camp chairman. He said he never had given permission for such use of his name.

A letter was produced by Henry Gerson, associate defense counsel, the last paragraph of which gave a Mr. Every permission to act as secretary for Ruck in collecting funds. The letter was signed by Ruck.

Ruck did not write the last paragraph, he said, although he types all his letters himself. He exhibited a carbon copy of the letter, which did not contain the last paragraph.

'Suicide Preventers' Fleece Many Under Guise of Religion

'Life Savers' Call for Contributions and Save Own Lives—'Home for Blind' Racket Successful—For a While—Swindlers Use Lehman's Name

One of the outfits which mulct New Yorkers of considerable sums of money yearly was an organization whose sole avowed purpose was to prevent people from committing suicide, the Jewish Daily Bulletin learned yesterday.

Three enterprising individuals incorporated their organization as a religious congregation. After all, they said, when filing application for certificate of incorporation, saving lives by telling men to have faith in God is real religious work.

Opening a small office, the life-savers had three telephones installed under a fictitious name. From one of the agencies which specialize in such things, a "sucker list" was obtained, and operations got under way.

Various persons were called on the telephone and asked to save lives to contribute to this organization which spent all of its money persuading people not to commit suicide.

You Don't Need a License

No Department of Welfare license was necessary because under the now famous section 199a of the New York Code of Ordinances organizations incorporated as religious congregations need not apply for licenses.

Needless to say, the organization prospered. It is impossible to estimate to just what extent it prospered. Anyway, there was no thought in the mind of the promoters of committing suicide themselves. Aside from preventing themselves from shuffling off the mortal coil, there was no evidence that others had been so aided. The suicide charts of the Bureau of Vital Statistics showed no appreciable diminution.

The District Attorney's office launched an investigation. The three promoters found it expedient to terminate their good work, and decamped, incidentally leaving the Telephone Company with an unpaid bill of several hundred dollars.

One Blind Man

There was a home of the blind which carried on its work via the convenient telephone. A welfare agency decided to send an investigator to visit the home. At the address only one blind man was found—the director of the campaign. Not having incorporated itself as a religious congregation, this racket was closed up.

There was another case of a charity promotion agency which was conducting a campaign for an institution whose name bore a strange resemblance to that of the Judea Convalescent Home. One of the solicitors for the agency phoned Albert Warner of Warner Bros. motion pictures.

The 'Governor' Calling

"I am calling for Governor Lehman," said the solicitor, "and he would like you to contribute to our campaign."

Warner, a friend of Gov. Lehman, made out a check for \$500 and forwarded it to the agency. As an afterthought, he communicated with the Governor who denied any connection with the institution. Warner brought charges of fraud against the agency, and it was halted in its nefarious activity.

John B. Prest, superintendent of the New York State Department of Social Welfare, yesterday told this reporter of one man who built an organization with distinguished names on its letterhead by dint of solicitation and ingenuity.

The man sent out an appeal to many presidents of railroads for contributions to a fund to send tubercular patients to sanitariums. He received a check for fifty dollars. Immediately, the racketeer had new letterheads printed with the name of the railroad official listed as a "contributing member." He made photostatic copies of the check, and cashed the original, pocketing the proceeds.

With the new letterhead, he

found it easier to get contributions from his next "sucker list," the hotel owners. He received a contribution, printed a new letterhead, and went through the process again. As the list of influential "contributing members" grew, it became easier to secure funds. The enterprising racketeer fled from the United States with a comfortable fortune when the district attorney's office got on his tail.

U. S. Poles Flay Germans Here On Nazi Stand

Score Double Allegiance As They Refuse to Join World Body

(J.D.B. Special Correspondence)

MILWAUKEE, Aug. 13.—A sharp attack against the allegiance many German Americans have shown to Hitler was contained in an editorial published yesterday by the Nowiny Polskie, local Polish daily.

The editorial defends the action of the American Polish delegation at Warsaw in its refusal to sign the by-laws of what was to become known as the Alliance of the Poles of the World.

"One cannot profess a double national loyalty," the editorial points out. "One must be politically loyal either to America or to Poland."

Germans in this country have failed to show such loyalty, the paper continues, explaining that Americans of Polish extraction "gave evidence before the entire world as to their honesty and political maturity."

"This far surpasses the maturity of Americans of German birth who are forming in America units of Hitler storm troopers," the editorial declares. "Americans of Polish descent have shown here that they are better American citizens than all so-called Nordic Americans."

The American delegation to the conference for a world union of Poles living abroad was headed by F. X. Swietlik, dean of the law school of Marquette University in Milwaukee. A fifth of Milwaukee's population is of Polish descent.

Canadian Rabbi Returns From London Conclave

MONTREAL, Que., Aug. 14.—Rabbi J. H. Stern, spiritual leader of the Temple Emanuel, has returned from London, England, where he participated in the World Conference of Liberal Judaism.

Rabbi Stern was also a delegate to the Jewish World Conference in Zurich as the spokesman of the Canadian Jewish Congress, but he was forced to return before the opening of the session.

plans, she declared, call for 210 beds, which will make the hospital one of the two largest in Palestine. She added that the cornerstone of the building will be laid at the same time that the Hadassah organization here holds its convention.

Officers of Hadassah and the American Friends of the Hebrew University hailed the selection of a definite site as the final step toward a speedy realization of the medical center.

"With complete facilities for research and teaching, the hospital will bring Palestine to the forefront of medical science in the Near East. It will give Palestine wonderful opportunities to advance science and raise health standards in that part of the world," said Mrs. Jacobs.

Dr. A. S. W. Rosenbach, president of the American Friends of the Hebrew University, sees "limitless possibilities" in the performance of medical work on the part of the new hospital.

"It not only can serve all the people of the Near East, regardless of faith or creed, but may become part of a great medical center from which in time to come may emerge solutions of scientific problems which will benefit mankind," he declared.

German Specialists Considered

Mrs. Jacobs pointed out that the new institution will supplant the present Hadassah-Rothschild Hospital, which is housed in a building more than eighty years old and is situated in cramped quarters in the busiest section of Jerusalem. She said that among the noted German specialists who are being considered for positions on the hospital and teaching staffs are Prof. Ludwig Halberstadter, director of the Hadassah radiology institute which will become a part of the medical center; Prof. Bernhard Zondek, noted gynecologist; Dr. H. A. Krebs, formerly of the Kaiser Wilhelm Physics Institute, and Dr. Georg Goldhaber, who was Dr. Halberstadter's assistant in Berlin.

To augment the resources already on hand, a building fund campaign for \$200,000 for the medical center is now in progress in this country under the auspices of Hadassah and the American Jewish Physicians' Committee, with Mrs. Jacobs as chairman.

Special Prayers for Victims Of Algerian Outrages Asked

WARSAW, Aug. 14.—Polish Jewish organizations today urged all rabbis in Poland to arrange for special prayers in synagogues next Saturday for the victims of the Algerian pogroms and to arrange for collections to be used in fighting anti-Semitism.

N. Y.'s Congress House to Cater To Special Reich Refugee Type

"Yooohoooo," called the lady in the foyer to the lady in the kitchen, "a reporter."

"Yooohoooo," called the lady in the kitchen to the lady in the foyer, "come on down." And down, stepping carefully over unrolled rugs and unthumbed tacks, we went. Down to the basement of what was formerly the Walden School, where next month the women of the American Jewish Congress will replace little aspirants to culture with adult exponents of kultur. When the last rug and tack have been placed at 50 West Sixty-eighth street Congress House will open as a rendezvous for German refugees, proving the brilliance of an inspiration of Mrs. Stephen S. Wise.

In the gleaming kitchen Mrs. Jerome Michael, who is in charge of the proceedings in the absence of Mrs. Wise, sparred single handed with a gas-fitter, her dog Sherry and the Frigidaire Company bearing the gift of a colossal ice-box.

Cater to Special Type

"We are catering to a rather special type of refugee," she said between rounds. "The intellectuals, the ones who are really up against it, are handicapped by pride. Their work is much harder to find than that of an ordinary workman, and yet their sensitivities forbid them to accept charity. During the first period of adjustment when they have absolutely no place to go, they may stay here for a few days until some other arrangement has been made. We shall have a social worker in the house who will analyze their problems more personally than a philanthropic agency would, and a host and hostess, themselves refugees."

Six large, well-appointed bedrooms attest to this welcome. Somewhere in Central Park there is an exiled Berlin musician anxiously awaiting the Ides of September when he will exchange his municipal boudoir for one of these. Other future occupants will be directed thither by the Congress agencies abroad, and a dock worker here at Quarantine.

Aside from the sleeping quarters there are to be a gay little tea room with equipment for those

who want to flip their own pfannkuchen, a library music room, drawing room, garden restaurant and ubiquitous powder rooms where one may embellish her non-Aryan features unmolested. The function of the place will eventually be that of a salon. For even those who have already found sustenance on these shores are seeking a place where they will find those of their own ilk. The composer Arnold Schonberg has already cast a proprietary eye upon the new Sohmer that dominates the second floor.

Receive Many Donations

Everyone, it appears, is touched by the cause. Department stores, merchants, and individuals have provided all the necessary furnishings. Even the taxi-driver who carts Mrs. Michael and Sherry to the house every morning has volunteered to do the minor trucking of the place. And the lady who lives next door, although reduced to the point of living in her own cellar, donated a magnificent wash-tub cover to the oppressed.

"And here on the top floor we have sky-lights, too," said Mrs. Michael, "accommodations for every sort of artist, you see."

"Yooohoooo," floated up from the basement, "the Edison man." And the reporter, unable to cope with the energy of these good women, fled with a parting yoohooo.

8 New Rabbis To Be Ordained

The Bulletin's Day Book

The stage is set in Austria for a Dr. Jekyll and Mr. Hyde melodrama that might well make the Robert Louis Stevenson thriller appear a milk-and-water concoction by comparison.

The stage is set, but it may be set in vain, for in the wings there stands a grim gallows with a noose that waits patiently for its next occupant. And this next occupant, it is reasonable to believe, may be the person who would play the leading role in the Jekyll-Hyde tale of our imagination.

He is Dr. Anton (Rin-Tin-Tin) Rintelen, former Austrian Minister to Italy, and a man in whom the anti-Semitic fever was known to have reached such a high degree that the mercury popped through the thermometer's top every time he came within sight of an "international banker." Rin-Tin-Tin (and we hope the heirs of that great movie actor won't take offense at our dubbing Anton after him) was a Nazi after Goering's own heart.

If King Anton (as he was known in Styria) escapes the neck-stretching party that may be his lot should he recover from the supposedly self-inflicted wound he received when the Nazi rebellion folded, that will constitute the second act of the drama. As a second act climax it will be a hummer. The picture of a man foiling the hangman's hemp always gives the gallery gods palpitations of the pump.

But what will give such a second act its significance (for Jews, particularly) is what occurred in the preceding act. When the curtain rises, the scene discovered is the operating arena of a Vienna hospital.

Rin-Tin-Tin is on the operating table. His face is waxen. Death is written all over it. But the doctors haven't given up hope. He may yet be saved for the noose or whatever Fate holds in store for him.

While the orderlies are wheeling into the operating arena a second white-sheeted figure, one of the doctors punctures an artery in Rinty's exposed arm and inserts a thin tube. At the same time, an artery in the second fellow's arm is punctured. The other end of the tube is inserted and the blood transfusion is on.

After a few minutes, a pale pink glow appears on the cheeks of Rintelen. (That may not be medically accurate but it sounds good). The transfusion bids fair to be successful.

But for the Jews among the gallery gods watching the play unfold, the glow of pink has added meaning. For presently, as the curtain is descending on the transfusion scene, the physician who has performed the operation laughs softly and, as if talking to himself, says in a stage-murmur: "Ah, a good day's work. If Rintelen lives, he has a Jew to thank for it. The Jewish blood of Josef Kraus flows in his veins."

Next? It makes one believe that Fate is not only a dramatist of the first water, but might be a Jewish dramatist at that.

That scene, minus the trimmings inserted by your Daybooker, actually took place in Vienna the other day.

Vienna now awaits the second act. Will the noose get the plump Rintelen neck or will the plump Rintelen neck foil its hempen grip?

All drama-loving Vienna is on edge with expectancy. They like a good show in that city and they like their shows to have three acts.

If Rintelen, with a pint or so of Jewish blood coursing in his veins, dies for treason to the country, the show ends with the second act. And Fate will have to step before the curtain and announce "That's all there is, there isn't any more."

And who will blame the temperamental Viennese audiences if they

pelt Fate with soft vegetables and give it the Bronx cheer?

This Daybooker for one will be in a mood to toss an overripe tomato or two at the dramatist for having dubbed a "natural." In company with millions of others he wants to see this drama acted out to a more pleasing finish. The spotlight focused on a figure dangling from a gallows may be okay for those who like their theatre fare realistic, but we'd rather have a dash of pollyanna in our foot-light cocktail if you don't mind.

Bring on that third act, Austria. Curtain!

(Rintelen, breathing a lot easier since the hempen neck-lace was found unsuitable for his Adam's apple, is discovered seated in the Chancellor's seat once occupied by the game-cock Dollfuss. As the curtain rises, Marshal Fey walks on the set from the left. Fey is now Vice Chancellor in the new Nazi cabinet, a reward for his part in protecting his late master from the Nazi assailants. Fey bears an ornate document on a swastika-decorated platter).

FEY: Mein Fuehrer, here is an order "Aryanizing" the legal, medical, theatrical and writing professions. *(With a sly smile).* And the blood donor's profession as well.

(At this last unnecessary reminder by Fey of an unhappy incident in Rin-Tin-Tin's life, Rinty winces. Incidentally, the Austrian press has been forbidden ever to mention the blood transfusion incident on pain of execution for the entire staff of any newspaper that let such mention slip its columns. But among the official family, the joke was bandied about with considerable freedom to the obvious discomfiture of its object).

RINTELEN: *(The vince turning to a maniacal grin of pleasure)* Aha, aha, give it here! How I will enjoy signing that one.

(Rin-Tin-Tin's foam-flecked fangs are bared in the typical Hyde manner as he grasps the quill which Hitler presented to him on his accession to office and scrawls his signature. It will be noted that, for the purposes of the Day Book's version of Dr. Jekyll and Mr. Hyde, Rintelen is Hyde before he's Jekyll).

FEY: *(Grinning from ear to ear)* Ah, 'tis well, Mein Fuehrer. The people will heal you plenty for that one, ja.

RINTELEN: *(The fangs still bared)* Tell them to think nothing of it. I do my duty as Hitler himself would do it.

(Fey departs. No sooner is he gone than Rinty undergoes a startling change. His face becomes rigid, the fangs, foam and all, disappear. The pint of Jewish blood in him is beginning to go into action. In a moment he has become a benign, contrite Dr. Jekyll, all too aware of the deed he has just committed).

RINTELEN-JEKYLL: *(Tearing at his hair and beating his chest)* What have I done? What have I done? I am slaughtering my own blood brothers. I must make amends.

(No sooner said than done. Rintykyll rushes to a phone and calls Mussolini).

RINTELEN: *(Talking into the telephone excitedly).* Muss, old pal, give me a hand. I want you to help me exterminate a certain party in Berlin who acts on me like a drug. When I'm under his influence I do things I'm sorry for later. Help me get rid of the Hitler-habit. Call out your army and I'll call out mine. Muss, we'll make war on that nasty drug. Please, Muss.

MUSSOLINI: *(His voice heard in the distance).* Rinty, you're off your nut again. I think it's the Kraus in you. I can't help you.

The Nazi leaders have gone. Unmistakably, as the curtain is slowly lowered, the Heil, Heil turns into a low, lying, poignant "Heil, Heil.")

Critical Moments

Galsworthy's River Runs Smoothly

English novelists who have their books made into American moving pictures seem to receive better treatment at the hands of their adapters than do their American cousins. When H. G. Wells' "Invisible Man" was dramatized for the screen the result was one of the season's most unusual and striking films. Somerset Maugham's "Of Human Bondage" was another picture version that turned out surprisingly well and now Universal have produced John Galsworthy's "One More River" in a manner that should be satisfying even to the author. The audience that witnessed it at the Music Hall was loud in its approval.

R. C. Sherriff, the English playwright whose "Journey's End" was one of the most sensitive of the war plays, and James Whale are responsible for the screen play of "One More River," and they have done a magnificent piece of work. Without following slavishly the sequence of the book this team of collaborators have managed to retain Galsworthy's shrewd and penetrating delineation of character and to weave a believable and moving story.

"One More River," if you remember your Galsworthy, was the third of the trilogy concerning the very human Forsythe family. In this book the English novelist traced the unhappy existence of the Cherrell girls, one of whom, Claire, married the sadistic Sir Corven who celebrates his honeymoon by horsewhipping his young wife. She leaves him only to meet young Tony Croom who is very much in love with her. Sir Corven begs Claire to return, promising to desist from his abnormal proclivities. She, however continues to see Tony and although innocent of infidelity is

shadowed by her husband's detectives and is finally sued for divorce.

A divorce courtroom scene in London brings this film to its most stirring moments. Shots of this kind are nothing new to pictures and most of them are overdone but Universal deserves three cheers for the screening of this particular bit. It is realistic, believable, pertinent and superbly directed. Diana Wynyard as Clare, Frank Lawton as Tony, Colin Clive as Sir Corven in the three major roles all act their roles sensitively, intelligently and excellently. The minor parts: Dinny Cherrell (Jane Wyatt), Sir Corven's lawyer (Lionel Atwill) and Alan Mowbray as the defendants attorney are also very well handled.

"One More River" is easily the best picture of the Summer. You must not miss it.

Housewife

George Brent, Bette Davis and Ann Dvorak were handed a lemon by Warner Brothers when they were called to act in "Housewife." It is just another very trite and obvious triangle picture which tells what happened to a man (Brent) and his wife (Dvorak) when they began to argue about their respective duties in and out of the home. The third party is the other woman (Davis) who works in the same office as the man and of course seems to be all the things his wife is not. Finally there is a divorce scene in a courtroom and at the last possible moment the husband and wife are reconciled, no doubt to spend the rest of their lives fighting the same battle over and over again.

"Housewife" is the kind of a picture that would inspire an accountant to figure that it was made because the studio was open, the actors under the contract and undeveloped film very cheap.

King Levinsky a Bridegroom, Weds World Fair Fan Dancer

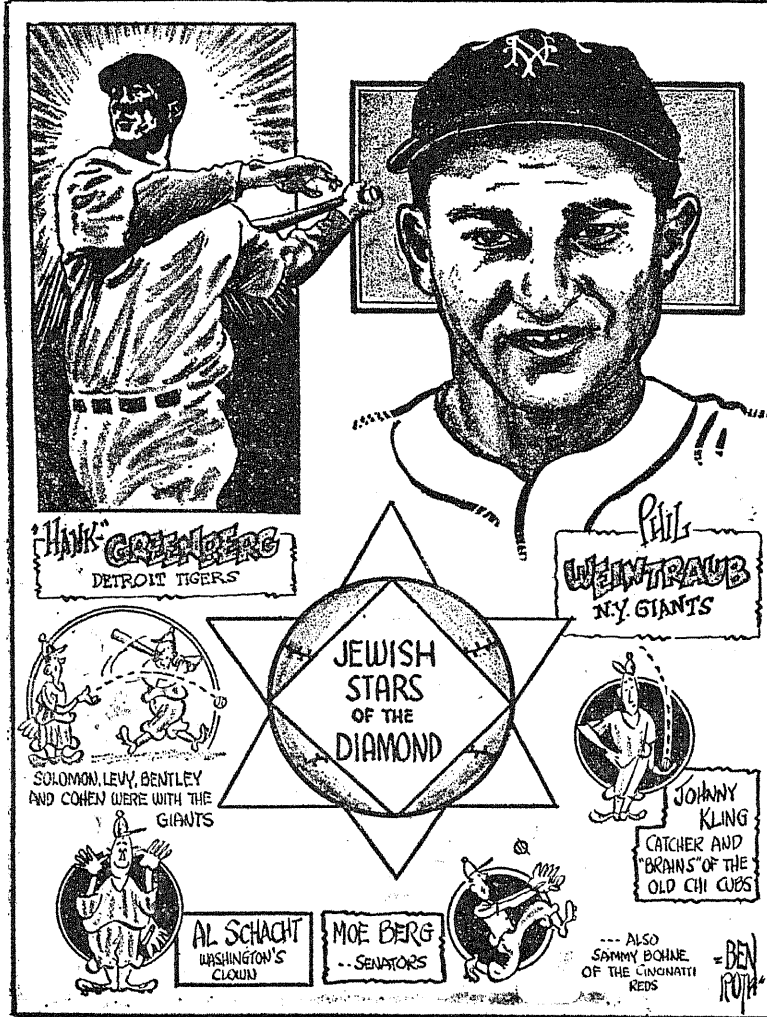

Austrians Ask Larger Army From 3 Powers

Seek 8,000 Increase to Forestall Threat of Nazi 'Putsch'

(Jewish Telegraphic Agency)
LONDON, Aug. 14.—The Austrian government has asked the governments of Great Britain, France and Italy for permission to enlarge the Austrian Army by 8,000 men in anticipation of another Nazi putsch, which Austrian authorities believe imminent, it was learned today.

Aid Given to 32 Girls Jailed in Bethlehem

JERUSALEM, Aug. 14.—Inspector General Roy G. B. Spicer, commandant of the Palestine police, today permitted interested Jewish organizations to supply beds and kosher food to the thirty-two Jewish girls confined in the Bethlehem jail on the charge of having entered the country illegally.

Dispatches from London last Sunday described the girls as incarcerated in an old prison now housing 100 prisoners instead of the sixty it was originally intended to house. They were sleeping on the floor and were inadequately fed, according to the reports.

Anti-Semitism in U. S. Will Never Be Serious, Says C.C.N.Y. Professor

"There is undoubtedly an undercurrent of anti-Semitic feeling in the United States, especially in the South and West, but I do not believe that such a movement can become a serious one in this country even under similar circumstances as those of Europe," declared Professor Nelson P. Mead, head of the history department of the College of the City of New York, at the Horace Mann Auditorium yesterday.

Discussing before 150 history students of Teachers College "The World Twenty Years After the World War," Professor Mead said: "It is nonsense that Jews cannot be patriotic Germans. Many Jewish families have a longer German ancestry than most German families."

Jurist Decries Jews' Neglect Of Education

Religious Schooling Still Needed, Rosalsky, Semel Hold

The failure of Jewish leaders to realize their obligations to the Jewish children of the country in regard to religious education was scored last night by Justice Otto A. Rosalsky of the Court of General Sessions.

Although scheduled to deliver the speech in person at a meeting in Brooklyn of 100 workers representing fifteen Jewish education organizations, Judge Rosalsky was unable to appear. His prepared address, however, was read by Municipal Court Justice Nathan Sweedler.

The importance of Jewish education, Justice Rosalsky's speech emphasized, had been obscured lately "by the pressure of a number of emergency problems that have been forced upon us."

"The crying needs of the moment," he continued, "have prevented us from hearing the call of eternity. But it is a mark of true statesmanship not to be deflected from our leading purpose by the necessities of the moment. Let us remember that it is our historic duty to continue as the people of God, and unless we induct our children into a knowledge and understanding of the great mission we forfeit our future."

Calls for Vision

"Jewish leadership, I regret to say, is failing us in an appreciation of this problem," in Justice Rosalsky's opinion. "Jewish leadership seems able to react only to the need of the moment. We need vision as well as commiseration. Let the Jews of humble station show our leaders the way."

The meeting, which was addressed also by Municipal Court Justice Nathan Sweedler, chairman of the Brooklyn Division of the Jewish Education Association, and Bernard Semel, honorary secretary of the association, was held at Rothman's Inn, 285 Kingston avenue, Brooklyn.

"The number of Jewish children who are not receiving a Jewish education is appalling," said Mr. Semel. "In Brooklyn alone there are some 80,000 of them. Can you visualize an army of 80,000 children. What would you say if we took those children and transported them to a place where they were deprived of the blessings and opportunities of this great and glorious land where they were born? Are we not depriving them just as tragically when we remove them from the great and glorious heritage of their people?"

Federation of Kosher Dealers Vote Confidence in Cohen

Members of the Federation of Kosher Butchers held a protest meeting last night at the Beethoven Hall, Fifth street and Second avenue, at which it was charged that the attempt to "frame officers of the Federation was a move to destroy the organization." Joining in the general protest were members of the Association of New Deal Butchers.

Charles Cohen, president of the Federation for the past twenty-five years and now under indictment on charges of racketeering, was the principal speaker. He declared the charges filed against him with the district attorney are pure lies.

Cohen was given a vote of confidence by members of the Federation during the evening. In his address to the butchers he intimated that "wholesalers or slaughter houses were behind the attempts to have him arrested." He branded as lies all statements that intimidation was being used as a weapon of the Federation.

Other speakers who joined in condemning the railroading of Cohen were David S. Andron, Federation attorney; Louis Marcus, attorney for the Association of New Deal butchers; Oscar Spitalnick, general manager of the Federation, and Emil Horn.

Zionists Score Article Hitting Palestine Entry

London Times Publishes Second Story Urging British to Act

LONDON, Aug. 14. — Zionists circles here were greatly irritated today by the appearance of an outspoken anti-Zionist article, the second within a week, to appear in the London Times as special correspondence from Palestine.

The Times article openly urged the British government to discontinue Jewish immigration into Palestine saying: "It isn't right that Great Britain should allow the Arabs to be swamped by Jewish immigrants as the red Indians were in America."

"The Jews have acquired one-tenth of the cultivatable land in Palestine and left the barren highlands for the natives," the Times article alleged.

Never before has the London Times carried such bitter anti-Zionist articles, Zionists emphasized, pointing out that the article says that the Arab peasants are not benefiting from Jewish immigration, as the Zionists assert, but that only a small number of Arabs in the coastal belt of Palestine have profited from the coming of Jewish immigrants.

Cap Makers Strike; Demand Higher Wages

1,200 in Walkout Also Seek Equal Division of Season Work

Approximately 1,200 members of Cap Makers' Union Local No. 1 walked out of their factories yesterday morning at 10 o'clock in a strike for better working conditions and higher wages.

The strikers are demanding a fifteen per cent wage increase and equal division of work during both slack and busy periods. These demands were approved by members of the union at a mass meeting yesterday in Beethoven Hall.

Eight hundred members of the cap making industry are still at work, as independent bosses have already capitulated to the demands of the union.

Striking Painters' Kin To Parade on Park Ave.

Daughters of striking painters of the Brotherhood of Painters, Paperhangers and Decorators District Council No. 9, will stage a demonstration on Park avenue today. They will march from Ninety-sixth street to Fiftieth street. Several hundred girls are expected to demonstrate.

Meanwhile, it was announced by union spokesmen yesterday that the union will encourage independent bosses to assume the work usually done by the Association of Master Painters and Decorators, the employers group, if the latter body does not attempt to settle the strike immediately.

The painters are striking for nine dollars for a seven-hour day. The association is offering eight dollars for an eight-hour day. The employers will meet Thursday evening at their headquarters, 2 Park avenue, to reconsider the suggestion of Ben Golden, executive secretary of the Regional Labor Board, to effect a settlement.

Hospital Denies Strike Of Its Dental Staff

Spokesmen of St. John's Hospital, Long Island City, yesterday denied there was a strike in the hospital despite the fact that seventeen members of the dental staff walked out of the clinic last Friday afternoon.

The work of the striking dentists is being done by an emergency staff. Led by Dr. William Lefkowitz of 60-14 Roosevelt avenue, Queens, the dentists walked out in protest against the dismissal of Dr. John Cavanaugh, who, they claimed, was dismissed arbitrarily.

Police and Strikers Clash; Five Are Injured

Five persons were injured as a climax to a melee between police and striking members of the Knit Goods Workers Union last night in front of a knitting mill at 250 Moore street, Brooklyn. Three of the injured were women.

According to police, the strikers attempted to invade the mill. A free for all battle then ensued and did not subside until two police emergency squads and five radio cars rushed to the scene. Several arrests were made.
