Five Millions Said No!

About five million people in Germany dared to say "No!" to Adolf Hitler. That is the significant outcome of the plebiscite which was really nothing else than a command to vote "Yes" for Hitler as Reich Fuehrer and Chancellor. Every device of propaganda, threat and compulsion has been resorted to by the Nazis. And yet five million people were courageous enough to take the risk of opposing Hitler.

According to The New York Times Berlin correspondent, the hospital of the Jewish community in one district cast 168 "Yes" votes, ninety-two "Noes," and forty-six ballots were invalid.

The correspondent points out also that "former Marxists cast a far heavier vote for Chancellor Hitler than the so-called bourgeoisie. In Berlin, especially, judging by their vote, former Communists still are Leader Hitler's most loyal supporters. In one voting district in Wedding, where a few years ago Communists fought from behind barricades against the police, the 'Yes' votes amounted to 949; the 'No' votes and invalid ballots totaled 237."

The voting of the Marxists and the Communists favoring Hitler to the extent reported in The Times is extremely puzzling. Either most of these Marxists and Communists in name only before the advent of Hitler as Chancellor, or they have become so demoralized by persecution and intimidation that they now blindly obeyed the Nazi orders.

The Jewish "No" votes are a heroic demonstration of courage, self-respect and self-sacrifice. It was a foregone conclusion that the farcical plebiscite would endorse Hitler's seizure of the Presidency by an overwhelming majority. If the plebiscite is a true expression of the German people's estimate of Hitler and Hitlerism, then the German people are unworthy of a better Leader, and the indignation of civilized public opinion should be directed not only against Hitler but also against those who have endorsed him for leadership.

The Jewish "No" votes redeem to a great extent the Jews of Germany who did not express themselves throughout their tragic martyrdom under the Nazi regime. The inmates of the Jewish hospital who said "No!" to Hitler have set an example which puts to shame the so-called radical elements that voted for Hitler, whatever the explanation, pretext or excuse may be.

Faulhaber Defies Hitler on Race As Nazis Suppress His Speech

God Always Punishes Persecutors, He Warns

LONDON, Aug. 20.—In a speech bristling with defiance of the Nazi racial policy and the fight against Jews, Michael Cardinal Faulhaber, courageous Archbishop of Munich, declared that no persecution would ever "eradicate the ancient Jewish people," it was disclosed today. Cardinal Faulhaber stated that "no Catholic had ever agreed to the persecution of the Jews in Germany" and said that "God always punishes the persecutors of the Jews."

The daring speech of Cardinal Faulhaber was suppressed by the Nazis and the Propaganda Ministry forbade German papers to

Belgium to Deport Refugees at Work

Unemployment Problem Forces Drastic Action—Relief Facilities Strained

(Jewish Telegraphic Agency)
ANTWERP, Aug. 20.—Belgium will admit no more German refugees and will deport those who are now employed in the country, the Belgian government officially informed the Jewish Telegraphic Agency today.

The tremendous influx of German refugees into the countries bordering Germany has created a knotty problem for officials of those lands. Relief facilities have been strained to the utmost.

France to Aid Victims Of Arabs in Algeria

PARIS, Aug. 20.—The French Home Office today assigned 120,000 francs for relief of victims of the Constantine pogrom. This is the first official action by the French government in regard to organizing relief for the victims, most of whom are homeless and penniless as the result of the brutal Arab pogrom on the Jewish quarter in Constantine. Practically the entire Jewish quarter was gutted by fires set by the Arab bands.

Detective Who Raided Offices Describes Operations

Ten men connected with the United Relief Associations, 216 Madison street, were arraigned yesterday before Magistrate Thomas A. Aurelio in First District Magistrate's Court, after Detective John C. Leffler of the District Attorney's office, who made the arrests, had described the methods of operation of charity racketeers.

LONDON, Aug. 20.—Professing to be overjoyed at the results of yesterday's referendum, when approximately 5,000,000 Germans dared Nazi wrath either by saying "nein" to Hitler's request for approval or by defacing their ballots, as opposed to slightly more than 38,000,000 voters who docilely indicated "ja," Nazi officialdom was today girding its loins for the next crucial plebiscite in its career.

The next plebiscite, for which the Nazi orators are tuning up tongue, microphone and bludgeon, is still five months off. But de-

Rep. Sabath of Illinois May Succeed Rainey

WASHINGTON, Aug. 20.—The death of Henry P. Rainey, Speaker of the House, who passed away in St. Louis yesterday, leaves a vacancy that may possibly be filled by Representative Adolph J. Sabath of Illinois. Representative Sabath, with a record of fifteen consecutive terms, would get the post if the seniority succession rule is strictly observed.

However, Mr. Sabath is not a candidate for the Speakership, according to a report from Chicago.

Rabbi at Geneva Parley Charges East Europe Evades Vows

GENEVA, Aug. 20.—A dark picture of the Jewish situation the world over and a reminder to Adolf Hitler and his cohorts that the Jews in the past have managed to withstand more potent foes were presented today at the opening of the World Jewish Conference by Dr. Nahum Goldmann, president of the Committee of Jewish Delegations and a noted Zionist leader.

Delivering the principal address at the opening session of the conference, Dr. Goldmann castigated the Nazi regime in Germany, which has deprived the Jews of the most elementary rights, as "a thing of horror." He promised that the anti-Reich boycott will be pursued with vigor until the Jews regain their previous status.

Dr. Goldmann spoke after Rabbi Stephen S. Wise, who presided, delivered an eulogy on the late Dr. Leo Motzkin, president of the Committee of Jewish Delegations. Rabbi Wise also eulogized Chaim Nachman Bialik, Hebrew poet laureate who died in Vienna July 4.

Dr. Goldmann expressed deep regret that the American Jewish Committee, the Board of Deputies of British Jews and other similar organizations, were not represented at the conference, but declared he hoped that these organizations would cooperate with the conference in important individual cases.

Reviewing the situation of the Jews in Europe, Dr. Goldmann stated that all the East European governments, with the exception of Czechoslovakia, were not fulfilling their minority obligations under the Treaty of Versailles and

Police Ban Stuermer, Call Story 'Nonsense'

BRESLAU, Aug. 20.—Police today prohibited the circulation of the current issue of Julius Streicher's anti-Semitic weekly, Der Stuermer, and confiscated all the copies they could find. The prohibition was based on the fact that the Stuermer misrepresented a sadistic, sexual murder, which occurred in Breslau many years ago, rewriting the story under the caption, "Ritual murder in Breslau." Police officials termed the Stuermer story "nonsense."

Breslau, under the late Edmund Heines, who was executed in the purge of June 30, was the scene of violent excesses against the Jews. Heines, a convicted murderer, was made police chief of Breslau and head of the Silesian Nazis when Adolf Hitler became Chancellor.

CINCINNATI, Aug. 20.—Joseph Herbach, director of the B'nai B'rith membership campaign, today announced that Edwin J. Schanfarber of Columbus, Ohio, attorney and Jewish communal leader, has accepted the post of chairman of the national campaign committee in B'nai B'rith's drive for 75,000 members in honor of the seventy-fifth birthday of the order's president, Alfred M. Cohen.

Mr. Schanfarber, a graduate of Ohio State University Law School, is a past president of District Grand Lodge No. 2, and has served as president of the United Jewish Fund of Columbus. He has been a director or trustee of many institutions.

Socialists' Aid Is Pledged to Paint Strikers

Waldman Throws Blame on Bosses in Speech Before Brotherhood

Speaking before several thousand painters and paperhangers, members of the striking Brotherhood of Painters, Paperhangers and Decorators of America, last night at Mecca Temple, Louis Waldman, state chairman of the Socialist party, pledged the strikers full support of the Socialist party.

Mr. Waldman declared that "the employers are responsible for the strike and the union is fighting in self-defense. The Socialist party and all its subdivisions will back the strike. New York City is in the vanguard of the movement for the six-hour day, five-day week."

"No employer in the painting, decorating and paperhanging industry," Mr. Waldman warned, "will be permitted under the law to obtain a contract on any of the buildings constructed under the control of the New York City Housing Authority if he persists in following the unconscionable policy affecting labor which the employers' association now pursues."

The noted Socialist attorney demanded that "not a dollar of the federal government should reach an anti-union labor employer in the painting or other industry."

Included among other speakers were Joseph P. Ayan, president of the Central Trades and Labor Council, and George Meaney.

Jews in '49 Gold Rush

Nazi Campers Deign to Comply With Sanitary Laws in Jersey

BOONTON, N. J., Aug. 20.—Joseph Schuster, commander-in-chief of the Nazi storm troopers, and leader of the Nazi Youth, who have been in their summer encampment here, wants to "do what is right."

This is what the young Nazi told William Stephenson, clerk of Parsippany-Troy Hills Township, when the latter took the storm troop commander to task for filthy conditions alleged to exist at Camp Wille und Macht.

To Drop Charges

As a result charges of sanitary code violations probably will be dropped. Schuster was accused of having failed to communicate with the township board of health on water and sewage conditions in the camp.

Schuster condescended to speak with the town's authorities only after the township committee last Wednesday night decided to issue a warrant for his arrest.

In a conversation with Stephenson, Schuster agreed to comply with the laws and take whatever steps are necessary to place the camp in good standing. He said he was not familiar with state laws and local regulations. He also promised to break camp within the coming week.

The camp, Wille und Macht, was established about two months ago by philanthropic Nazis, to provide their storm troopers a rest from the arduous task of goose-stepping at the Friends of New Germany meetings here. They have since been goose-stepping in the wide open spaces.

"To prepare them for the labors of the coming winter," was

the way the solicitation put it.

Well browned and ready for anything that might arise, the young storm troopers will go marching home again this week-end, it is understood.

Final "war games," scheduled to be held last Sunday, were called off because of the stir caused when advance press notices heralded the drills.

More than 500 proud parents and friends of the 150 Nazi youths were forced to watch the strapping youngsters go through acrobatic rather than military tactics on the swastika-bedecked field.

Typically "Aryan" by Nazi definition, with a record as a front-line soldier during the war, holding an appointment at the University of Cologne and at the Rautenstrauch-Joest Museum, he sacrificed the material achievements of a lifetime by resigning in protest against the Nazi regime.

A native of the Saar, which he revisited this spring, he is thoroughly familiar with the complexities and tyrannies of developments there. His knowledge is that of direct observation and personal experience. Though a member of a cultured, well-to-do family, he began his career by earning his living as a miner in the Saar coal mines; later worked as a postman, tutor among the upper classes, in lunatic asylums, shops and on newspapers. He spent several years traveling in European and other countries, especially in Africa.

A former member of the City Council of Cologne he is intimately acquainted with the political background of the Nazi movement and has kept in close touch with developments there since his departure last spring.

Though a young man he is one of the foremost ethnologists of our time. He is the author of many books and innumerable articles in his chosen field of study as well as in the fine arts and politics. He has been associated with Fritz Graebner and Bernhard Ankerman as publisher of "Ethnologica" since 1927. His new book, "The Savage Hits Back" is to appear shortly.

Ivy Lee Firing Denied by Head Of Composers

Still Press Agent for ASCAP, Says Mills, General Manager

E. C. Mills, general manager of the American Society of Composers, Authors, and Publishers, yesterday labelled as canards reports that Ivy Lee has been ousted as publicity adviser to the society.

"There has been absolutely no complaint against Mr. Lee," Mills said. "He has been publicity advisor to this society for about two years. His work and character have been entirely satisfactory."

Referring to Lee's testimony before the McCormack Congressional Committee, in which the publicist admitted that he had advised the German government in respect to its rearmament and other policies, Mills said:

"We have gone over all of Mr. Lee's testimony, and find that there is no basis for accusations that he supported any anti-Jewish or anti-Catholic movement. Had he done so, it is safe to assume that he would have been asked to resign."

"His conduct has been all right, as far as we are concerned."

Mills said that almost eighty percent of the American Society of Composers, Authors and Publishers is Jewish.

estants have also voted against Hitler.

Uneasy lies the head of the Reich Fuehrer as he contemplates the meaning of five million brave people opposing him so fearlessly. He surely knows that autocracies have been overthrown by very small groups of revolutionaries. He can have but little comfort from the fact that nine tenths of the votes were cast in his favor, for he knows under what conditions the "plebiscite" was conducted. The one tenth must worry him, for this one tenth will eventually liberate the German people from the scourge of both Hitler and Hitlerism.

Hitler's Reichsbishop Mueller now hails his master's victory as a victory over the Jews. "Hitler's fight is a fight for Christianity against Jews, the most savage enemies of Christianity," said the Nazi "spiritual" leader. To him Hitler is comparable to Jesus.

"As in the days of the old Christians, faith is equal to confidence," he declared. "Jesus, preaching the gospel, pleaded for confidence. So did our Leader when he put the plebiscite as a question of confidence to the nation. We as true Christians had to give him our 'Ja,' as only our consent gives him the right to defend our religion." And he concluded by saying that the result of the election was "the beginning of the whole nation's Christianity, since it had the courage to vote for and stand behind the leader in his fight against the Jews."

The Reichsbishop, the Nazi church dictator appointed by Hitler, thus admits that Hitlerism is based solely on anti-Semitism, and that the "beginning of the (German) nation's Christianity" is marked by the Leader's fight against the Jews.

Peace Reigns As Strikers Go Back to Work

Independents Expected to Settle With Knit-Goods Union Soon

Comparative peace reigned in the knit goods industry yesterday with two-thirds of the Knit Goods Workers Union, branch of the International Ladies Garment Workers Union, reporting to work yesterday. Speedy settlements with independent bosses are expected momentarily.

Picketing still continued, however, in front of the Star Sportswear Corporation, 568 Broadway, and small independent corporations. A tentative agreement was signed Saturday between the union and the employers, the Metropolitan Knitted Textile Association.

Approximately sixty strikers picketed the Star Sportswear yesterday without police interference. For the first time since the strike at the Broadway company started ten months ago mass picketing was permitted. It is understood that the police are "laying off" as a result of instructions issued to police by Chief Inspector Valentine at the Mayor's request.

Because of the mass picketing the Star Sportswear Corporation closed yesterday while George Schaib, manager of the company, announced that he plans to seek legal advice.

Polish Town Picks Two Jews In Municipal Election

Trouble Dogs Steps of Butchers As Employees Plan to Strike

Workers Will Set Date for Walk-Out on Friday Night

Trouble, which has been the consistent portion of the Federation of Koshers Shop Owners of Greater New York during the recent past, will knock at that organization's door with renewed vigor Friday night, when the Hebrew Butcher workers Union will decide on a date for a general strike of its 5,000 members.

Vigorous protest by the employers greeted this disclosure when it was made by Joseph Belsky, secretary of the workers' union, yesterday.

In answer to charges of the butcher workers that some employers are replacing skilled meat handlers with child labor and are resorting to fake partnerships in efforts to escape the requirements of their agreements with the union, shop owners launched a counter-attack which took form in the following statements:

1. No collective agreement between the Federation and the Hebrew Butcher Workers Union ever has been reached. Any existing agreements are between the latter union and individual shop owners, who may or may not be members of the Federation. The union therefore has no right to mention the Federation in its child-labor and fake-partnership accusations.

See Public Chief Victim

2. Whatever the outcome of the workers' threats and decisions, no one will suffer so much as the Jewish buying public, which will find itself either deprived of kosher meats during the High Holidays or forced to pay higher prices as a result of the dispute. It is pointed out that the workers have chosen a peculiarly psychological moment at which to launch their strike threats, in view of the fact that Rosh Hashonah will be a little more than two weeks off when the walk-out session convenes in Webster Hall, 119 East Eleventh street, Friday night.

3. Good faith on the part of the Federation in regard to its attitude on the question of employment of minors has been proven in the proposed code of fair competition it has submitted to the NRA, David Andron, counsel for the Federation, declares. If members of the organization are violating this clause, he asserts, they constitute isolated cases.

\$25,000 Defense Fund

Despite the above counter-claims by the shop owners, the Butcher Workers Union is going ahead with its plans for the Friday night meeting. Preparation and enforcement of the proposed general strike, according to Belsky, will be carried on with the assistance of a \$25,000 defense fund, which the kosher shop employees already have raised.

Agreements under which the employees are now working will expire in October, and the meat handlers will demand that these contracts be renewed without alteration.

Belsky charges the employers with attempting to defeat his organization's efforts to raise the living standards of its members. On this allegation he bases his belief in the necessity for a general strike.

Some owners, Belsky asserts, are hiring boys to work seventy hours a week for as little as \$7 a week and are replacing skilled union workers with these minors, in violation of the terms of their agreements.

Textile Strike To Hit 10,000 In Silk Trade

'Mushroom Mills' Have Made Inroads on Industry

(Special to the J.D.B.) PATERSON, N. J., Aug. 20.—More than 10,000 silk workers and employers, most of them Jewish, will be affected by the proposed United Textile Workers of America strike, statistics revealed today.

Under the provisions of employer-employee contracts signed after the 1933 general strike, workers may not walk out unless the Industrial Relations Board finds forty per cent of the 100,000 silk looms in the United States lying idle.

"Mushroom mills" have sprung up here, displacing the huge mills of a once proud silk industry, a survey shows. In the "mushroom mill," it is charged, the entire family works at the looms far into the night, cutting prices and lowering the wage scale.

Rayon, too, is declared to have contributed to ruining the Paterson silk industry. Selling far below the price of silk, it has been so highly developed that only the expert eye can distinguish it from the natural product.

Medical School Racket Case Set For Tomorrow

Two Will Be Arraigned on Charges Preferred by Contractor

Charged with conspiring to defraud the parents of a pre-medical student of \$500 on the pretense of enabling the student to enter a medical college, two men will be arraigned in First District Magistrate's Court tomorrow.

The two are Beard John Dupree, a tax attorney of 22 East Thirty-eighth street, and Martin Ira Phillips, an accountant of 844 East Forty-eighth street, Brooklyn.

Both men were arrested two weeks ago on information given Assistant District Attorney Maurice G. Wahl by Louis Vogel, a clothing contractor of 1222 Avenue R, Brooklyn, who parted with the \$500 in vain.

According to Mr. Wahl, Phillips represented himself as a professor, doctor and colonel.

At the trial, Wahl is expected to disclose the existence of a widespread racket which for years has been preying on the parents of Jewish college students who have been aiming at entrance to medical schools, but who for one reason or another have been unsuccessful in their attempts to gain admittance.

Mexican Students Form New Group to Further Aims, Ideals of Judaism

(J.T.A. Special Correspondence) MEXICO, D. F., Aug. 16.—An organization of Jewish students attending the preparatory public school (equivalent to American high school and junior college) and the National University, has been formed with approximately fifty members.

The chief aim of the organization is to acquaint the youth of the Jewish colony, who are rapidly assimilating ideas of their environment, with the fundamentals of Judaism. The program of the organization is non-political. Dr. J. Kutler is president of the group.

Review of South African Nazi Trial

Sokolow's Testimony Gives Lie To Allegations of Grey Shirts

Forgery Forms Basis of Charge Jews Seek Rule of World

(J.T.A. Special Correspondence)

JOHANNESBURG, South Africa, July 14.—Dr. Nahum Sokolow, president of the Zionist World Organization and the Jewish Agency for Palestine, who is now in South Africa on behalf of the Keren Hayesod, gave important evidence in the action at Grahams-town before the Judge-President, Sir Thomas Graham, and Justice Gutche, brought by Rev. A. Levy of the Western Road Synagogue, Port Elizabeth, against three leaders of the Anti-Semitic Jazi Grey-shirt Organization, Johannes von Moltke, Harry Victor Inch, and David Hermanus Olivier, for damages for alleged defamation, arising out of the publication of a document said to have been stolen from the synagogue of which he is minister, which is alleged to show the existence of a Jewish world plot.

He was the president of the Zionist Organization, Dr. Sokolow told the court, and was a journalist by profession. He had edited, among others, the first Hebrew paper; he was a life-long associate of Dr. Herzl, the great Zionist leader, and was largely co-responsible for the declaration of Lord Balfour given in the name of Lord Rothschild. He had also represented Jewry at the League of Nations.

There was absolutely no truth in the suggestion that there was a Jewish plot to overcome the world.

The Zionist Congresses were organized to establish a home for the Jewish people.

Dr. Sokolow said he was present at the First Zionist Congress in Basle in 1897, and he helped to organize it, together with the late Dr. Herzl. He told how he had arranged the agenda, all the proceedings of the Congress being of a public nature. The Congress was attended by people from all parts of the world, including professors from the Basle University, who were non-Jews. A full report of the proceedings was later issued.

Explains Exposure

He could testify that there was no truth in the allegation that the "Protocols of the Elders of Zion" were ever promulgated by Dr. Herzl. This slanderous document was never heard of.

He knew Ward Price personally, and it was Ward Price who had exposed the "Protocols" in The Times in 1920. Every word in the "Protocols" was a mischievous lie written to excite the Gentiles against the Jews. It was discovered that the origin of the "Protocols" was a political pamphlet written in the time of Napoleon III. It was a copy. He had seen the original in the British Museum, and in the "Protocols," instead of the name Napoleon there was substituted the name Herzl, and instead of the Napoleonic people there were the Jews.

Cross-examined by Inch, Dr. Sokolow said he was born in Poland, but he was now a naturalized British subject.

Inch: Why are you here today giving evidence? Are you here to defend world Jewry?

Dr. Sokolow: Not necessarily; I am here to give evidence on the "Protocols." World Jewry can defend itself. I am here to refute the false and malicious allegations about the Elders of Zion.

In reply to further questions, Dr. Sokolow said that the Jews were of the Caucasian race. They

were related to the Arabs. There was a Semitic race, and the Arabs were a branch of that race. He did not know that the film business was controlled by Jewry, said Dr. Sokolow.

Seeks to Discredit Jews

Inch: Do you agree with the posters of half-naked women which are exhibited for our children to look at?

Dr. Sokolow: I am not a great admirer of nakedness.

Inch: Can you give the name of any paper in the world that is not controlled by the Jews or their advertisements?

Dr. Sokolow: I do know that the Times, the greatest paper in the world, is not controlled by the Jews. I know nothing about the South African papers. It is an empty phrase anyway. The Daily Herald is another paper that is not controlled by the Jews.

Inch: Do you consider that the Jews monopolize the white slave traffic?

Both Sir Thomas Graham and Reynolds strongly objected to this question, and Inch replied that he had a quotation from the Jewish Chronicle of April 1, 1910, which practically admitted what his question implied.

Reynolds pointed out that Inch was reading from a printed pamphlet and not from the Jewish Chronicle.

Sir Thomas Graham to Inch: You must produce the paper itself.

Inch: I cannot obtain the 1910 issue.

Sir Thomas Graham: Then you must not make such a serious charge if you cannot substantiate it.

Dr. Nahum Sokolow said that so far from the Jews encouraging the white slave traffic there was a society in London which existed for the purpose of fighting the traffic. The extract to which Inch had referred must have been taken from some speech made at a meeting of that society, and in order to appreciate its real significance one would have to read the whole report. He suggested that Inch write to the British Museum for the full text.

Answers Inch's Queries

Inch: Why have the Jews been persecuted throughout the world?

Dr. Sokolow: Ask the persecutors, not the persecuted.

Dr. Sokolow said that if the Jews had entire control of the press, the films, the gold industry and governments, as was alleged, naturally they would not wish to go to a country of their own, but it was purely a conditional question, it was a question if they had this control then naturally they would wish to stay.

Dr. Sokolow denied that Zionism was a failure in South Africa.

Von Moltke: Is it true that the British Board of Deputies is described as the super British Parliament?

Dr. Sokolow: Some American journalist might have described it so.

Von Moltke: Did you and your colleagues not level a pistol at the head of the British government when you came forward with your Zionist proposals?

Dr. Sokolow: Are you speaking in an allegorical way?

Von Moltke: I am speaking in the best English I can muster.

In answer to further questions, Dr. Sokolow said that the British government did not rely on the financial support of the Rothschilds. He complained frequently that Von Moltke relied on extracts torn from their context which did not reveal the true state of affairs.

"You exaggerate the importance of the Jews," he said. "Do you seriously think that we could blackmail British politicians and frighten the British government? The whole thing is childish."

Cites Ford's Retraction

When one of the defendants mentioned the attacks of Henry Ford on the Jews, Dr. Sokolow drew attention to Ford's retraction. As a matter of fact, Ford had attended a dinner given in the

Hotel Commodore by the Jewish community in New York in honor of Ford. "I met Mr. Ford at that banquet," went on Dr. Sokolow. "Mr. Ford at that banquet expressed extreme regret at his anti-Semitic activities."

Mention was then made of Francois Coty, the millionaire Perfume king, who was alleged to have made statements against the Jews; but Counsel for Rev. Levy objected to this and declared that Coty had retracted his statements, just as Henry Ford had done.

In answer to von Moltke, Dr. Sokolow admitted that Pope Gregory IX had been instrumental in having the contents of the Talmud examined in solemn assembly in France, and the Talmud had been burnt. But so had the Jews been burnt, he added, and he could explain as little why the Talmud had been burnt as why the Jews had been burnt.

A sensation was caused when von Moltke, on reading to the Court an alleged quotation from Dr. Sokolow's "History of Zionism," was told by Dr. Sokolow that the quotation was misleading. The reference was made not to Jewish satisfaction with the Bolshevik revolution, but with the previous Kerensky revolution.

The Judges repeatedly interposed and warned defendants of the danger of quoting unverified authorities.

Dr. Sokolow, in reply to Olivier, said that anybody could buy a German Talmud translation through a reputable Berlin bookseller.

Rev. Levy's Charges

Rev. Levy in his declaration said he was not a Rabbi, but was widely referred to and known as the Rabbi of the Congregation. The defendant was a leader for the Eastern Province of a society called the South African Gentile National Socialist movement, and from time to time held meetings in support of the movement. On or about April 4 at a public meeting in the Feather Market Hall at Port Elizabeth, attended by over 500 persons, the defendant, it was alleged, wrongfully and maliciously published false and defamatory words by reading out to the meeting a document falsely alleged to have been obtained by means of theft from the Western Road Synagogue.

It was further alleged that on or about March 27 at a large public meeting at Aberdeen the defendant maliciously published the same defamatory words.

A Couple of Charges

By these words the defendant meant and was understood to mean that the Jewish citizens of Port Elizabeth, as of the rest of the

world, were entirely antagonistic to the Christian religion and determined on destroying it, and were guilty of blasphemy in referring to the Christian religion and to the founder and the mother of the founder of the Christian religion; that at a forthcoming meeting of the South African Gentile National Socialist Movement it was alleged that certain Jews were to go armed in order to create a disturbance and even to commit murder, homicide, manslaughter and the destruction of property; that the members of the Jewish faith intended to subvert the existing system of civilization and substitute the Japanese system, and to destroy the British Empire and hand back South Africa to the natives, so that those of the Jewish faith would be no longer in any danger from natives who were all destitute of any good qualities as were the Dutch people of South Africa; and that the members of the Jewish faith were financing certain portions of the press for the purpose of disseminating false and atrocious news that the members of the Jewish faith should keep silent in regard to the foregoing designs and await propaganda from Moscow to help in the subversive activities already alluded to, and that this propaganda would be sent to and distributed by the Western Road Synagogue.

The defendant, in his plea, said that the plaintiff was not widely known or referred to as a rabbi in Port Elizabeth or elsewhere. He said that the South African Gentile National Socialist Movement was not a society, but a political movement and organization with the ostensible purpose of combating Jewish perverse influence in economics, culture, religion, ethics and statecraft and to re-establish European Aryan control in South Africa for the welfare of the Christian peoples of South Africa.

Not Maliciously

The defendant admitted that he published the words complained of, but said that he did not do so wrongfully, unlawfully or maliciously. He further said that the words were not meant and could not have been understood to refer to the plaintiff, but were directed against the Jewish race.

He also said that the document was stolen out of the Western Road Synagogue, Port Elizabeth. He denied that the words complained of were capable of bearing the meanings and innuendoes placed on them and said that in any case they did not refer to the plaintiff, but to the Jewish race.

The alternative plea was that

Jews in Mexico

August 18, 1934.

To the Editor, Jewish Daily Bulletin:

I read with some degree of satisfaction of the expulsion of Julio Madero from the National Revolutionary party of Mexico as reported in the Jewish Daily Bulletin on August 13. This, according to your article, was a punishment meted out to him for his anti-Semitic activities. Perhaps it was for this reason, but who really knows the true purpose for his expulsion. It may have been due entirely to a desire on the part of some powerful leaders in the party to oust him purely for political reasons.

I was instructor in modern languages in the city of Monterey, Mexico, in 1930. I feel quite safe in saying that I was the only Jewish instructor in the entire Republic.

I traveled considerably through Mexico, having met Jews here and there. The anti-Semitic feeling in Mexico is very evident, and the Jews do everything possible to conceal their identity. The Jew in Mexico is, in the practical sense of the word, a social outcast.

I doubt very much, even in spite of the gratifying news contained in your article, whether the Mexican government officials (i. e., the leaders of the National Revolutionary party) are at all anxious to have the Jew there.

In the entire country there are only 13,000 Jews. About 7,000 live in Mexico City and the balance are distributed in the small groups throughout the principal cities of the Republic. Last month I met a Jew from Mexico, who is visiting this country, and he tells me that for about four years he was the only Jew living in the State of Campeche.

The Jews of Mexico hope to be able to finally come to the United States and I am more than certain that there would not be a Jew left in Mexico if the immigration doors were suddenly opened by the American government.

I hope to read more interesting news in the Jewish Daily Bulletin from time to time concerning the Jews of Mexico.

Nazi - Fascists' Aims in Mexico Are Under Fire

Golden Shirts Attacked for Restrictive Stand on Immigration

(J.T.A. Special Correspondence)

MEXICO, D. F., Aug. 17.—Notable among recent developments in the anti-Semitic situation has been the cessation of attacks on Jews by the leading daily newspapers of this city, who seem to have changed their policy and are instead assailing the activities of the Accion Revolucionaria Mexicana (Golden Shirts), the Nazi-Fascist organization which had been leading the anti-foreign campaign, especially against the Jews.

El Universal, one of the leading morning newspapers, published an editorial in which it emphasized that Mexico needs immigrants, citing the examples of the United States and Mexico, which were built up as strong countries with the aid of European immigration. The editorial further pointed out that Mexico is still thinly populated and needs "active, vigorous, economically useful" elements to help make the country progress along the upward path it has taken.

The editorial indicated opposition to the idea of restricting immigration merely because the United States has done so, pointing out the difference of situations in the two countries and stressing the point that Mexico has far from reached the saturation point. The fact that the United States has strongly discriminated against Mexican immigrants, and that they have been subjected frequently to arbitrary action by American immigration authorities, especially in the Southwest, was pointed out as one factor which led to tightening of the immigration laws of this country.

Paul Baginsky, Reich Exile, Will Teach at Paterson

Hunger Faces Ukraine Areas Hit by Drought

Failure of Crops Leads to Forebodings of Hard Winter

(Jewish Telegraphic Agency)

MOSCOW, Aug. 20.—Fears were expressed today that as a result of the drought in the Ukraine which adversely affected crops, Jewish regions in the Ukraine, particularly Kalininsdorf and Stalinsdorf, will suffer from hunger this winter. Earlier reports stated that some of the crops in the Jewish regions stood so low on the fields that it was impossible to harvest them by modern machinery.

At the same time it was stated that due to extraordinary methods pursued in getting in what harvest there was there would be no hunger.

Today's Soviet papers suggest that irrigation for the fields is imperative.

Icor Secretary Here Scouts Starvation Scare

There is no danger of hunger in the Jewish regions of the Ukraine, S. Almazov, national secretary of Icor, Association for Jewish Colonization in Soviet Russia, declared when informed of the cabled reports from Moscow. "We have been in constant touch with Moscow," he said, "and were informed that thanks to extraordinary steps taken to combat the drought, all danger of hunger was obviated."

"In addition we have here the latest issues of the newspapers published in Yiddish in the Jewish regions in the Ukraine, which tell of measures taken to safeguard crops. It is true that the whole region suffered and some of the crops were bad, but the grain crop was very good this year."

Pioneer Utah Jews

Grigat Asks to Speak

Before the brief session was adjourned until September 6, at the request of a representative from the office of Martin Burke, counsel for the defendants, Grigat asked permission of the court to make the statement in which he charged intimidation.

"All efforts," he said, "are being made to compel Judge Goldstein and me to drop the action. I received a telephone call last Tuesday at my office and was told if this action was not dropped I would be taken for a one-way ride."

Addressing the representative for the accused, Magistrate Brill advised him to "take this information back to your office."

"We do justice here in our courts and not outside our courts," she added.

The Bulletin's Day Book

It was nine in the evening on the corner of Lexington avenue and Eighty-sixth street.

In fact, it was nine in the evening all over town.

A truckload of Nazis, hale and hearty after their day in the country, came tearing down Lexington avenue. Fine girls and boys, all of them, and for the most part excellent singers as they gave voice to the Horst Wessel Lied, that charming anthem which sets so many feet to goose stepping in many parts of the globe.

Red lights flashed on as the truck came to the corner. Quite obligingly, the Nazi vehicle drew up to a sudden halt.

From one corner of the truck there piped the voice of a stalwart brownshirt, "Hier, mein Herr, a paper please."

With a gallant sweep of the trusty right arm grown muscular in performing the Hitler salute, he tossed the news vendor two coppers and received, as was his just due, a brand new copy of one of the early morning editions. He gazed at the headlines, read them aloud:

"MILLIONS VOTE NO IN NAZI ELECTION"

"Gott In Himmel," the unfortunate man uttered. Then he swooned.

It seems to us there must have been a lot of swooning throughout the many countries in which Nazis abide. The swoon center,

of course, was Germany itself. Nobody could have realized that almost five million fearless souls had survived Hitler's year-and-a-half in office.

No doubt the five million stalwarts in the fatherland must have gone to the polls fearfully. We won't attempt to describe the caution with which stormtroopers must have guarded the polling places, because we weren't on hand to see for ourselves the espionage in this particular incident. But knowing as we do the manner in which the watchful warriors guard every written and spoken opinion in the homeland, we are convinced that there must have been a lot of peeking from behind the election booth curtains.

To these five million should go the thanks of the entire German posterity. They have given evidence that there remains in the regimented country a shred of reason.

It is our private opinion that long after the name of Hitler has been forgotten the spirit of the five million will be reflected from the pages of German history as the single bright light over a murky period of repression and persecution such as the civilized world has never known.

And whether they come from the ghettos and ditches or the salons and tea rooms we shall always choose to consider the five million the real "four hundred" of a fast-decaying Germany.

Foreign Chambers to Cooperate With Mexico on Immigration

(Jewish Telegraphic Agency)

MEXICO, D. F., Aug. 20.—Development of a more lenient and at the same time more centrally controlled policy on immigration, of special interest to prospective Jewish immigrants, is indicated today following a communication from the Mexican immigration chief, Senor Andres Landa y Pina, seeking cooperation of the Jewish Chamber of Commerce in stabilizing the immigration problem.

The communication, simultaneously addressed to all foreign chambers of commerce, told of the immigration department's desire to eliminate irregularities such as are produced by employment of special agents, commonly known in Mexico as "coyotes," who intervene on behalf of the immigrant.

The various chambers of commerce were invited to send delegates to a meeting which was held recently and which was attended by many representatives of the foreign chambers of commerce. The department officials expressed a desire of instituting a system whereby the chambers of commerce will be responsible for citizens of their respective countries who seek admission to this country. Prospective immigrants will be requested to send in their applications, affidavits and other necessary documents to the proper chamber of commerce, which will study the matter together with the immigration authorities. The representatives at the meeting agreed to maintain weekly contact with the immigration authorities.

The American Chamber of Commerce immediately announced establishment of a special immigration department which will handle immigration matters for American citizens. Among the Jewish residents of Mexico, especially those who have relatives abroad whom they wish to bring here, the new plan has aroused great interest. Officials of the Jewish Chamber of Commerce are urging local Jews who wish to bring relatives over to establish contact with that or-

ganization and also recommended that Jews residing outside of Mexico who may be contemplating coming here first get in touch with the Chamber of Commerce in order to avoid establishing relations with any of the numerous "coyotes" who operate in this field and whom the immigration department wishes to eliminate.

Anti-Nazi Minute Men Hold Boycott Meeting Tonight at Brighton

Members of the Brighton Post of the Anti-Nazi Minute Men of America will hold a boycott meeting tonight at nine o'clock at Coney Island avenue and the Boardwalk, Brighton Beach.

Edgar H. Burman, commander-in-chief of the national organization; George Green, president of the Brighton Beach Chamber of Commerce; Assemblyman Albert D. Shanzer, Leo Kluder and David Levy will be the principal speakers at the meeting.

Soviet Appoints Envoy, Ends Rumanian Breach

(Jewish Telegraphic Agency)

MOSCOW, Aug. 20.—The Soviet government officially announced today that Michael Ostrowsky, Soviet Jewish diplomat, had been appointed the first Soviet Ambassador to Rumania.

There have been no official diplomatic relations between the two neighboring countries since 1917. One of the chief points which kept the two countries apart was Rumanian seizure of the Besarabian provinces of Russia.

Columbia Signs Bulgakov

Columbia Pictures this week exercised its option on the services of Leo Bulgakov, noted director.

Signed for a term contract last Spring in New York where his brilliant success, "One Sunday Afternoon" and other Broadway plays had attracted wide-spread attention, Bulgakov immediately went to the coast.

Since his arrival there he has been acting in the capacity of observer, in order to familiarize himself with the ramifications of the industry. He will be assigned to his first production within the next few days.

Hebrew Congregations To Issue Holiday Sermons

Sokolow's Testimony Gives Lie To Allegations of Grey Shirts

the words complained of were true in substance and in fact and were for the public benefit.

Shirt Leaders Appear
Mr. H. G. Reynolds, K. C., with him Mr. W. Stewart, appeared for the plaintiff, and Mr. L. Pinshaw holds a watching brief for M. Lazarus, whose name was mentioned in the proceedings. The three Grey Shirt leaders appeared in person.

Mr. Reynolds referred to the document in question as one of the foulest nature. At certain indictment proceedings, affidavits were filed and in one, Inch gave details as to how he stole the document from the Western Road Synagogue. He also described how on March 17 he obtained certain documents which made him suspect that there were documents to be obtained in the synagogue, but Mr. Reynolds proposed to show that Inch's description of the interior of the synagogue proved that he had never been in it.

Rev. Levy, giving evidence, said that he had been in charge of the Western Road Synagogue for twenty years. He was chairman of the education committee of the school board and a member of the committee of the Child Welfare Society.

On March 24, when he left the synagogue, there was no red curtain there and he had never known a red curtain to be there. There was a blue curtain. The lectern was not a place suitable for keeping papers, and papers were not kept there. The door which Inch described as the one by which he had said that he had left the synagogue was the one door which was locked with a key. A man of Inch's build could just get through the window, but if anyone went up to that window he could be seen by the neighbors. All papers were kept in the vestry, where there was a safe.

The document was absolutely false, said Mr. Levy, and he knew nothing about other documents to which Inch had referred.

Ignorance of Hebrew Shown

At the top of the document appeared the words "Kosher Lepe-sach," which meant fit for Pass-over. This was the usual label appearing on articles of drink or food, but he had never known the phrase to be applied to literature. The letter "R" in Hebrew on the document looked like a "D," and this and a great many other things signified that the writer knew nothing at all about Hebrew. One letter meant for "s" was actually an "m," and all the Hebrew letters were badly formed. None of them could have been written by any literate Hebrew. In one issue of the Jewish Chronicle one could find all the phrases, and the whole document was a forgery. He connected the language of the document with the language of the notorious "Protocols of the Elders of Zion."

He had never heard of the Select High Circle of the Anti-Nazi Propaganda Society, which was the organization which was alleged to have issued the document. His synagogue had no council such as was referred to in the documents, but a committee. He had no antagonism to the Protestant and Catholic Churches, nor did he know anything about a world Socialistic movement. The Jews had nothing to do with Communism.

The witness gave exhaustive evidence on Jewish customs, laws and religious beliefs in refutation of certain pamphlets which had been distributed. Many of the alleged quotations were deliberate forgeries or mistranslations, and these publications were absolutely abhorrent to him.

Jews Have No Occult Movement

Cross-examined by Inch, the witness said he was taking action against the defendants because he considered the good name of him-

self and the whole of Jewry had been defamed. It was a filthy, blasphemous and scurrilous document.

He was not responsible for anyone entering the synagogue or for the organizations that used it. If they left any documents lying about, he was not responsible. The synagogue was the last place one would expect to find such a document. The Jews had no occult movement in their midst.

Mr. Inch: Did not Jacob use camouflage to get the birth-right? I am here to fight the cause of my fatherland. You have no fatherland, therefore you can afford to pay these people to sweat for you.

Cross-examined by von Moltke, Rev. Levy said that the Jews did not pervert Christianity. His religion was Judaism, and he was subordinate ecclesiastically to no one. He supposed that the Port Elizabeth Press was sympathetic to him because he had earned its sympathy. He had never spoken against the South African Gentile Nationalist Socialist movement or the South African Grey Shirt movement.

Christian Upholds Jews

Professor Dingemans said he had studied Hebrew since the age of sixteen and had maintained his studies ever since. He was still teaching Hebrew. He was a philologist and a Christian.

He had made a careful examination of the document and had come to the conclusion that it was not all that it pretended to be, namely, a secret document drawn up by an educated Jew. There were defective Hebrew characters and ludicrous incongruities between the Hebrew words and the purpose of the lectures. The document was a clumsy and unconvincing attempt to reproduce Hebrew characters. Advertisements in Hebrew had been copied, and a glorious mess has been made of them. The writer did not only not know Hebrew but English, and his thoughts were quite incoherent. One phase in particular was clearly intended to inflame the Gentiles against the Jews.

He knew a good deal of the Jewish teaching, and he knew that the Jews had never made any attempt to annex the Almighty to themselves; they preferred to leave that to racialism gone mad.

He was satisfied the internal evidence was overwhelmingly in favor of the supposition the document was an impudent and malicious forgery.

Exposes Crude Forgery

The document could not be the product of an educated man, Jew or Gentile. The same was true of the other documents produced. They were an attempt to poison the minds of gullible people, but Satan was particularly ill-advised when he selected for the job such an incompetent man. Any man who knew Hebrew would come inevitably to the same conclusion.

Inch: Why are you so sympathetic to Jewry?

Professor Dingemans: I am sympathetic to all nations, and I am sympathetic to Jewry because my Lord and Saviour was a Jew, but I am not prejudiced in favor of the Jews.

Professor Dingemans said that there was no Jewish blood in his veins or in his family. Cross-examined on Communism, he said that the originators were both Jews and Gentiles. He had always found that anti-Semites were against the Biblical God.

Professor Dingemans insisted the document was the product of a disordered mind. "I believe it to be a deliberate malicious forgery," he said.

Ignorant Mind Behind Document

Von Moltke: Can you forge something that is non-existent?

Professor Dingemans: If I am an enemy of a particular race

I can easily write stuff to vilify that race and attempt to create the impression that the statement which I made emanates from the people whom I wish to vilify. This document pretends to be something it is not. It pretends to be utterances from a synagogue written by a learned Jew, and I maintain that if it ever came from the synagogue it was put there by the person who wrote it, and he was not a learned Jew, nor was he a learned Gentile.

Von Moltke: Do you believe that a man who does not do as Christ and His apostles did is acting wrongly?

Professor Dingemans: Let me say this of an organization that pretends to be a Christian organization: "He that hates his brother walks in darkness and knoweth not whither he goeth."

Von Moltke objected to this reply.

The Judge - President: You brought it on yourself.

145 West Forty-fifth street—where crews of telephone solicitors telephoned prospects, using the names of judges and prominent citizens. 60,000 Calls

The detective said he raided the midtown office and found five men at school desks soliciting funds by telephone. He said 60,000 'phone calls were made in one month.

The defendants were charged with obtaining money under false pretenses. The charge grew out of the alleged use of names of judges without permission.

One of the solicitors, Leffler said, identified himself as "Judge Silberman," over the 'phone.

"What court are you from?" Leffler testified he asked the solicitor.

"I'm down at Municipal Court. Any time you want a favor just let me know," the "coxe" (salesman) is said to have replied.

The salesman, Leffler testified, received thirty-five per cent of each contribution, while the messenger got ten per cent. These revelations were made by the Jewish Daily Bulletin last week.

Seizes Messenger

Leffler said he promised a donation of \$15 for the United Relief Associations' camp at Phillipsport, N. Y. He arrested the messenger who came to obtain the contribution and then raided the "boiler room" (room from which the soliciting was done).

Szold Attacks British Stand On Palestine

Sees Mass Immigration as Chief Zionist Problem

Mass immigration of Jews into Palestine was set forth as the greatest Zionist problem of today by Robert Szold, vice-president of the Zionist Organization of America, in an address to 500 delegates attending the eleventh annual Junior Hadassah convention at the Hotel New Yorker yesterday.

"The problem is to get the maximum number of Jews into Palestine in the shortest space of time," he asserted. "We must face the fact that a structure of Arab national life is developing, and quickly. Great Britain is retarding immigration. We must fight all this, and transfer as many Jews as possible into Palestine."

Mr. Szold presented official figures showing that 40,000 Jews entered Palestine in 1933 of which 2,500 were illegal settlers.

Zion Ideal for Jews

"Palestine is fit for the Jew," he said, "and the Jew is fit for Palestine. Palestine comes nearer than any other place to being the ideal land for Jewish development."

Speaking of the Histadruth, Palestine labor organization, Rabbi Samuel Wohl, chairman of the League for Labor Palestine said, in part: "If we are to build, let us build a Palestine which will express the noblest aspirations of our people. The ideals of the shared life and the cooperative commonwealth will establish a Jewishness as the Torah is Jewish and the Prophets are Jewish and the Land of Israel is Jewish. Palestine without Kyutsoth without Kupath Holim, without its cooperatives would not have raised the sacrificial service of its youth to a religious fervor."

Mrs. Samuel W. Halprin, president of Hadassah, traced the rise of the Zionist movements and the various philosophies which emerged from the first Zionist ideal of Herzl.

Golden keys for cultural service were presented to the following: Ethel Alder of Omaha; Dorothy Finkelstein, Minna Olander and Ida Neuer of Columbus, Ohio; Rose Kotzin, Adele J. Leventhal and Rose Shur of Philadelphia; Sylvia Brody, Katherine Sheinin and Anne Trenner of Akron, Ohio; Ida Ebin of Minneapolis; Clara Wildman of Rochester, N. Y.; Estelle Weiss of Chicago; Pessa Polasky and Sarah Metz of Cincinnati; and Zella Ruslander of Buffalo, N. Y.

A discussion of cultural problems was held during the afternoon. Resolutions for more popular participation in cultural activity and better-rounded programs were adopted. Speakers were: Esther Norogrodsky, Rose Kornblatt, Thelma Goldfarb and Sylvia Brody.

Weinstein Tells of Bond

The bond between Jewish youth and Palestine was described by Rabbi Jacob J. Weinstein at a banquet last night.

"I confess that I could not consider as lost and forsaken those young people who asserted that Judaism, Zionism, the Jewish people were entirely irrelevant," Rabbi Weinstein said. "There were only two basic divisions of mankind, as they saw it, the Haves and the Have-nots—the powerful rich who were in and the powerless who were out—boss or worker, capitalist or proletariat, exploiter or exploited. All differences, all hates, all loves depended on which side of the class line you stood. What has 'Jew' to do with this?"

"History teaches that God always punishes the persecutors of the Jews," Cardinal Faulhaber said. "No Catholic ever agreed with the persecution of the Jews in Germany."

"When God punished the numerous persecutors of the Jews on June 30, that punishment was deserved by them."

"Persecution will never eradicate the ancient Jewish people, which has been suffering and which always suffers because of its deep devotion to religion."

"Let us Catholics take an example from the Jews and honor them because they gave the world the best gift, which is the Bible."

"Catholics, educate your brothers that racial hatred is the wildest poison in our life," the ringing appeal of the Munich Cardinal concluded.

"Jews Most Brutal Foes Of Christianity"—Mueller

BERLIN, Aug. 20.—Anti-Semitism is a Christian campaign, Reichsbishop Ludwig Mueller, Nazi choice as head of the Protestant church in Germany, declared yesterday before a meeting of 5,000 German Christians, Nazi adherents within the Protestant churches, assembled to celebrate the victory of Adolf Hitler in the plebiscite.

"Hitler's fight is a fight against the Jews, the most brutal foes of Christianity," the Nazi bishop said. "The German people may go through bitterness and distress, but will win a victory for Christianity, even if the Jews are resolved to destroy the nation."

New York? These are my people; to them will I minister; to them will I bring healing. Nor did they stand even on one impatient foot to wait for an answer.

"You Hadassah Juniors have been aware of all the burden in the fate of the Jew and yet have not considered Jewishness a worthless distinction or a rank misfortune. A people that has lived 3,000 years against every discouragement has gained a sheer momentum that cannot lightly be gained. If historic fate and social forces have conspired to keep the Jew alive, there must be a need for him in the world."

"Now, have you faced the challenge implied in the statement that it is foolish to worry about trachoma in Palestine when there is tuberculosis among the poor of your own street? You have discovered that a sensitive being, conscious of her past, develops a personality in which memory is impounded in flesh."

the Covenant of the League of Nations, and charged that these governments were "deliberately depriving the Jews of the means of earning a livelihood." The situation of the Jews in Germany, Poland and other East European countries was deplorable, Dr. Goldman said, and required "earnest attention."

Austrian anti-Semitism was similar to the German brand, the Jewish leader declared, asserting that the Austrian government was by no means free of anti-Semitic tendencies.

At the same time he pointed out that anti-Jewish feeling was developing rapidly in Mexico and in the Argentine Republic.

Dr. Goldmann concluded his address with the declaration that, in his opinion, the time had come for "peaceful negotiations with the Soviet government for a modus vivendi on the all-important questions of Zionism, Hebrew and the Jewish religion in the Soviet Union."

Greetings to the conference were extended by the noted Jewish writers Sholom Asch and Andre Spire.

A proposal to make the world boycott on German goods even more effective than it is at present is to be placed before the conference, it was learned. Rabbi Stephen S. Wise, head of the American delegation to the conference, is sponsoring the move. Dr. S. Margoshes, editor of The Day, New York Yiddish daily, will present a report to the conference on the working of the boycott against Germany in the United States.

Dr. Motzkin Honored

Dr. Leo Motzkin sought security for his people, while the Hebrew poet laureate, Chaim Nachman Bialik, ministered to his peoples' soul, Rabbi Wise declared in his tribute to the two great Jewish leaders whose passing he mourned.

"In addition to every burden of woe which Israel has borne throughout the year soon to end, it has sustained many grievous losses, greatest among them the passing of Leo Motzkin and Chaim Nachman Bialik," Dr. Wise said.

Urges Clearing House for Boycott in Parley Message

GENEVA, Aug. 20.—The executive committee charged with the task of preparing for a world Jewish congress, today decided at a closed meeting to convene the congress not later than the Autumn of 1935, the Jewish Telegraphic Agency learned today.

World Congress Set for 1935 As Geneva Conference Opens

Consolidation of the boycott movement against Nazi Germany on a world-wide scale, regulated through a central clearing house, was urged yesterday by the Boycott Committee of the American Jewish Congress in a cable addressed to the conference of Jewish leaders which opened its four-day sessions in Geneva yesterday.

Two specific requests were made. The first urges the establishment of a central bureau to serve as a clearing house for boycott activities throughout the world. Dr. Tenenbaum, head of the Boycott Committee, in his cable declared that this was absolutely imperative in order "to deal with the international aspects of the boycott work." This he defines as "the prevention of the camouflaging of imports and the falsification of labels"; and the withdrawal of "contemplated credits designed to bolster up German exports as well as to secure the import of raw materials into Germany."

The Geneva conference is further urged to "issue a solemn manifesto setting forth the moral issues involved in the boycott and urging universal adherence thereto as a preventive to war and as a

means of safeguarding civilization."

The hope is expressed that the conference will be able to devise means aimed at securing the lifting of boycott activities now directly or indirectly banned in such countries as Turkey, Poland and Yugoslavia.

The conference adopted a resolution to create a chair at the Hebrew University in honor of the memory of Dr. Motzkin. It will be known as the Motzkin Chair for the Study of the Jewish Minorities Problems in the Diaspora.

In addition to the delegates, official representatives of the League of Nations and the International Labor Office and diplomats from several countries were present at the session.

Lithuania Confiscates 2 Jewish Dailies for Report of Zionist Attack

KAUNAS, Lithuania, Aug. 20.—Two Jewish daily newspapers were confiscated by the authorities today for publishing accounts of an attack upon Zionist youths in the town of Siauliai which was instigated by a Lithuanian youth organization.

The publications are "Moment" and "Dos Wort." Objection was taken to their assertion that a state of panic still prevailed, whereas, according to the police, order had been quickly restored.

Extremist Appeal Bans Arab Paper

Action Follows Warning by Wauchope on Printing 'Mischievous' Matter

JERUSALEM, Aug. 20.—The Arab newspaper Al Jamai Al Islamia was suppressed today in conformity with last week's warning by the Palestine government against "mischievous" statements, the specific offense being the publication of an appeal by Jamal Al Hussein, Arab extremist leader, to the Arab youth to continue guarding the coast against illegal Jewish immigrants.

Such activities were forbidden by High Commissioner Sir Arthur Grenfell Wauchope last week, following a clash near Nathania between Arabs and Jews. At that time newspapers were threatened with drastic treatment if they failed to discontinue printing inflammatory matter, and, while none was named, it was believed Hebrew organs were meant.

Big 'Nein' Vote Blow to Nazis

spite the distance of the event, it is believed that the size of the "nein" vote, more than double that recorded in the last plebiscite, held in November on the League of Nations question, has given the Nazi overlords the closest thing they have had to a real scare since the June 30 "purge." So, spurred by the unexpectedly large negative vote and sensing that despite all their efforts at suppression the opposition is becoming more vocal, the Nazi party is already pointing to the Saar, where the next plebiscite will be held in June.

Less Subject to Force

It is being widely predicted in informed circles here that the effect of the 5,000,000 "neiners" on residents of the Saar will be much more pronounced than will be the effect of the 38,000,000 who voted "ja." With this in mind, plus the knowledge that in the Saar there was a tremendous revulsion of feeling over the "purge" and that the population there will be less susceptible to force than in Germany proper, the Nazi overlords have already begun to go into huddles on the January election.

In some quarters it is being said that the government, mindful of both the big negative vote and the vital necessity for changing the alarming trend of anti-Nazi opinion in the Saar, is preparing to take action which will have for its purpose mollification of the opposition.

Speaks to Saar Nazis

A fact that lent emphasis to these predictions was the speech made by Hitler immediately after the Nazi officials had released the preliminary figures on the plebiscite. The speech was made to a delegation of 2,000 members of the Nazi party from the Saar Valley.

"We must and shall succeed," he said, referring to the negative vote, "in winning over the last ten per cent. of the nation for national socialism."

Then, directing his attention to the Saar problem, he sounded what will probably become the keynote of the Nazi drive for recovery of Saarland.

"Everything German in the world belongs to Germany," he declared, "and we must, as well as possible under the existing treaties, seek to win everything German back. No matter what happens we will never desert you. Yesterday you saw how Germans stick together in difficult times. There will soon be a time when you will not need to come to me. Then I can come to you and it will be the most beautiful journey of my life."
