The Anti-German Boycott

At the World Jewish Conference held in Geneva, Dr. Nahum Goldmann, president of the Jewish Delegations, delivered a stirring address in which he reviewed the present situation of the Jewish people in various lands, and stressed particularly the tragic plight of German Jewry. He denounced Hitlerism as a "thing of horror" and predicted that Israel will outlive the modern Haman as it outlived the Hamans of the past. Dr. Goldmann also emphasized that the anti-German economic boycott will be continued vigorously by the Jews abroad until the rights of the Jews of Germany are restored.

Dr. Goldmann stated that most of the East European governments, with the exception of that of Czechoslovakia, were violating the clauses for the protection of the rights of minorities in the peace treaties concluded at the close of the World War.

While the address of Dr. Goldmann contains nothing that has not been said before on this subject, it has nevertheless attracted widespread attention and is valuable for that reason. There is danger in letting world public opinion grow accustomed and indifferent to the cruel iniquities that are being perpetrated upon the Jewish people in Nazi-land. In exposing the outrages of Hitlerism, the Jews are not merely fighting their own battle but they are also combatting the gravest menace to peace and economic stability everywhere.

But it should be emphasized at the Jewish conference in Geneva that the anti-German boycott is not a Jewish boycott, that without the co-operation of the laboring masses here and abroad, and without the aid of the non-Jews in various lands where the menace of Hitlerism to civilization is fully understood, the anti-German boycott could not have succeeded.

Mr. Samuel Untermeyer, whose cable to Dr. Stephen S. Wise, chairman of the World Jewish Conference, is reproduced in this issue of the Jewish Daily Bulletin, has presented the case for the continuation of the boycott with his usual vigor and clarity. The conference would enhance the effectiveness of the boycott by accentuating its broader scope along the lines indicated in Mr. Untermeyer's message.

Reich to Put Blame for Ills on Jews

Role of Scapegoat for Economic Debacle Is Seen

(Jewish Telegraphic Agency)

BERLIN, Aug. 21.—Despite the fact that Nazi governmental circles have officially denied to the Jewish Telegraphic Agency reports carried in the London Daily Herald that the Hitler government intends to carry out a new campaign of arrests and repressions against the German Jews following Hitler's victory in the plebiscite, the feeling persists in Jewish circles that Germany will soon witness a widespread renewal of the anti-Jewish campaign.

It is held that the Nazis, in need of a scapegoat to explain the disastrous economic conditions of the country under Nazi rule, will make the Jews responsible for the economic ills of Germany.

Evidence of Jewish anxiety for the future is seen in the fact that fifty per cent of the Jewish population of Pomerania has asked for advice on emigration in the last three months. Most of the requests concerned emigration possibilities to the United States, Italy, Switzerland and Great Britain.

Recently it was announced that as a result of the large-scale removal of Jewish firms, the city of

Ten Are Injured In Lithuania Riots

New Attacks on Jews Reported in Several Villages; Shops Looted; Nazis Blamed

KAUNAS, Lithuania, Aug. 21.—New attacks upon Jews were reported today from Siauliai, where peasants arriving from neighboring villages for bazaar day plundered Jewish stores and severely assaulted their owners. Many peasants were arrested. Jews feared to leave their homes this evening.

At Ponewesz ten Jews were injured by Lithuanians and at Raseiniai the offices of the Zion-

Boycott Fight to Finish, Wise Insists at Geneva

Untermeyer Hits Parley's Stand As Misleading

Drive Is Non-Sectarian, Not Entirely Jewish, He Points Out

Samuel Untermeyer, president of the American Non-Sectarian Boycott League and the World Boycott Federation, yesterday criticized the World Jewish Conference at Geneva for assuming the position that the world anti-Nazi boycott is a strictly Jewish action.

Untermeyer, both in an interview and in a cable to Rabbi Stephen S. Wise, chairman of the conference, criticized statements at the conference creating a "damaging, misleading world impression" that the texture of the boycott is purely Jewish.

In an interview he explained that it was not correct to have it appear that Jews are responsible for the boycott to the exclusion of Catholics, Protestants and labor unions.

"It is a conflict that concerns all civilization," Untermeyer said.

"It would be unwise for the Jews," he said, "to assume full responsibility for the boycott. Throughout the world we are only a small percentage of the population. Unless we give other denominations their right to full expression of grievances against Nazi Germany, the boycott will not be effective."

"Jews alone," he concluded, "can not effectively boycott Germany."

Sends Cable to Wise

In a cable yesterday to Rabbi Wise, Mr. Untermeyer declared:

"As president of the American Non-Sectarian Boycott League and World Boycott Federation organized at Amsterdam last August, I earnestly urge the Conference against creating a damaging, misleading world impression that the boycott is distinctly Jewish."

"It is civilization's protest and only weapon, regardless of creed."

Not Representative, American Body Says

Morris D. Waldman, secretary of the American Jewish Committee, in a statement last night drew attention to the fact that his organization has not endorsed and is not participating in the World Jewish Conference now in session at Geneva, Switzerland.

He pointed out also that the Board of Jewish Deputies of England and the Alliance Israelite Universelle of France have not sent delegates to the gathering.

"In the light of these facts," the statement said, "the conference cannot truthfully be described as representative of the opinion of Jews of the world or as expressing the viewpoint of Jewish citizens of the United States."

Official Laxity Is Charged in Algerian Riots

Youth Association Seeks Sweeping Probe of Massacres

ALGIERS, Aug. 21.—The Algerian Jewish Youth Association today accused the Algerian government of not having given the police orders to stop the recent pogrom against the Jews in Constantine. The association demanded that the French government immediately institute a sweeping investigation of the massacre and punish all officials guilty of laxity, particularly local and high governmental officials who took no steps to halt the bloodshed.

According to official French reports, the riots began in Constantine on August 4, but English and French newspapers charged the French government with having

World Center Is Called for To Aid Work

Palestine Transfer Plan Assailed by Rabbi as Help to Reich

(Jewish Telegraphic Agency)

GENEVA, Aug. 21.—The anti-German boycott will not be abandoned until the Hitler regime falls or cancels "every law and practice violating human freedom and political equality," Rabbi Stephen S. Wise declared today in a fighting speech before the World Jewish Conference now in session here. Dr. Wise severely criticized Jewish organizations which urge silence and bitterly condemned the much discussed Palestine transfer agreement, under which German Jews going to Palestine took their capital with them in the form of German goods.

"World Jewry and not German Jewry alone is under attack and therefore a compromise with Hitlerism is impossible," Dr. Wise declared, "not even if the German Jews be compelled to accept a peace pact which may slightly ameliorate their wrongs, but will not alter their intolerable status of second class citizens."

Will Reject Compromise.

"The Nazi Reich may decide to disarm Jewish protest by going as far as offering the Jews special terms in order to have them side with Hitlerism against civilization," he said.

"Such a compromise will be definitely rejected because the place of the Jews is unalterably by the side of those forces of civilization and freedom which cannot exist side by side with Nazism."

Einstein Bolshevik, Says Nazi Chief

Rosenberg Accuses Scientist of 'Red' Affiliation in Race Science Talk

(Jewish Telegraphic Agency)

BERLIN, Aug. 21.—Professor Albert Einstein is nothing but a "Bolshevik agent," Dr. Alfred Rosenberg, head of the foreign affairs division of the Nazi party and editor of the Voelkischer Beobachter, leading Nazi paper, declared today. Dr. Rosenberg maintained that the Nazis favor freedom of science.

"A certain misunderstanding has been caused," he said, "because many Jewish scientists as well as a number of misled Germans have equated freedom of scientific research with freedom to calumniate the German people."

"If a certain Mr. Einstein professes that the white race has no right to claim superiority over the Negroes, then such a deviation is not freedom of research," the Nazi leader stated.

\$9,000 Penalty Deals Fatal Blow To Grey Shirts in South Africa

JOHANNESBURG, South Africa, Aug. 21.—Signal victory over three anti-Semitic Gray Shirt leaders was won here today by the Rev. Abraham Levy when he was awarded judgments totalling £1,775 (approximately \$8,900) and costs in his defamation suit, which grew to the stature of a world cause celebre while it was being heard.

Specific awards for damages arising out of publication by the trio of a document which they falsely claimed to have stolen from Levy's Western Road Syna-

gogue in Port Elizabeth, and which purported to show the existence of a Jewish world plot were as follows:

From Harry Victor Inch, £1,000; from Johannes von Strauss von Moltke, £750; from David Hermannus Olivier, £25. Each of the defendants also must pay the Port Elizabeth leader the costs of litigation. Levy in each case had sued for £2,000.

Heard in the Eastern Districts Division of the Supreme Court in Grahamstown before Sir Thomas Graham, Judge-President, and Justice Gutsche, the action pre-

sented so many complex and interesting angles that the court required 130 pages in which to explain its decision today.

World Jewry hailed the outcome of the case as a decisive blow at the South African Fascist movement, which was threatening to assume dangerous proportions until Levy brought it into the open by his courageous course of action.

Two of the defendants already have made it plain that the Grey Shirt movement faces imminent collapse. Inch tried to back water on July 23 by asking the court's

Younghusband, Wise Advocate Peace Pact Day

Urge Annual World-Wide Celebration on August 27

Sir Francis Younghusband, chairman of the British committee, and Rabbi Stephen S. Wise, vice-chairman of the American committee of the World Fellowship of Faiths, jointly sent out an appeal to the public to support a resolution passed at the Parliament of Religions at Chicago in 1933, recommending that August 27 (anniversary of the Kellogg-Briand Peace Pact) be observed internationally every year as World Peace Day.

"It is now coming to be recognized more fully," said Sir Francis, "that peace is no mere absence of war but is an attitude of soul which has to be heroically striven for day by day. Opportunities for strengthening this attitude have therefore to be made."

"With all governments adding to their armaments," said Rabbi Wise, "the whole world bristling with deadly weapons of war, and men's minds everywhere befogged by suspicion, enmity and fear, it is most appropriate to celebrate the anniversary of the day of the signing of the pact of Paris as World Peace Day."

The World Fellowship of Faiths, of which the Maharaja Gaekwar of Baroda is international president; former President Hoover, honorary national president, and Bishop Francis J. McConnell, national chairman, has arranged for the observance of World Peace Day on August 27 in many cities.

Kedarnath Das Gupta, general executive of the World Fellowship of Faiths, has sent out the following seven suggestions for the observance of World Peace Day:

1. Observe August 27 as a festive day of rejoicing. Invite neighbors to your home or visit them, particularly those who are not of your own nationality, race or religion.
2. Pray or meditate for world peace, practice non-violence in thought, word and deed, and feel within yourself at peace with all.
3. Come to an amicable understanding with those at home or abroad with whom you have aroused discord.
4. Make of Peace Day a gift day, presenting books or cards which emphasize the spirit of peace and good will to men.
5. Arrange public or private meetings or parties, for discussing some aspect of world peace, or read peace literature to your friends.
6. Send out a vibrating peace thought to those who are away.
7. Write to your government to uphold the Kellogg-Briand Peace Pact to the letter and to declare an economic boycott on the violators of the pact.

United Appeal To Fete Schaap At Commodore

Chairman of Trades Unit to Resume Activities Following Return

Michael Schaap, chairman of the Trades Council of the United Jewish Appeal will be honored today for his leadership in the campaign at a luncheon at the Hotel Commodore, Dr. G. A. Lowenstein, chairman of the luncheon committee, announced yesterday.

The luncheon will mark Mr. Schaap's resumption of active work among industrial and professional groups on behalf of German refugees following his return from Europe. Mr. Schaap's activities enabled the Trades Council to raise more than \$250,000 for the United Jewish Appeal. He has accepted one of the committee chairmanships for the "Night of Stars" production at the Yankee Stadium on September 20.

Leaders of the thirty trade and professional groups affiliated with the Trades Council, as well as other prominent leaders in industry and commerce, will be present at the luncheon.

Among the speakers will be Morris Rothenberg, president of the Zionist Organization of America, and Louis K. Sidney.

Support Seminary, Rabbis Urge Public

Call on All Congregations to Give Aid to Yeshiva on High Holidays

A joint meeting of American rabbinical bodies, including the Agudath HaRabbanim, the Vaad HaRabbanim, and the alumni of the Rabbi Isaac Elchanan Theological Seminary has issued a call for the seminary's support. The following resolution was passed:

"Whereas, the Yeshiva Rabbi Isaac Elchanan, which fulfills in this land the functions and traditions of the Yeshivah of all ages, by transplanting Torah and Jewish idealism into the American community, under present conditions finds itself in deep financial distress.

"We, American rabbis, call upon all congregations, through their spiritual and lay leadership, to dedicate one day during the coming High Holidays to a public plea that this essential institution in the life of American Israel be permitted to function without financial handicap, and with the material as well as spiritual support of those it serves."

A similar appeal for the collection of funds for the Yeshiva during the High Holidays has been issued by The Union of Orthodox Jewish Congregations of America.

Nazi Torch Bearer to Tell Here How He Helped Burn Reichstag

Only Survivor Will Talk Before Inquiry Body in Washington

Storm Trooper J. Kruse, self-confessed and last surviving member of the Brown Shirt group which under instruction from high Nazis set fire to the Reichstag, will be one of many witnesses who will come from Europe to testify before the American Inquiry Commission when it reconvenes during the first week of October in Washington, Arthur Garfield Hays, member of the Commission, announced yesterday.

The Commission held its first sessions on July 2 and 3 in New York. Its purpose is to examine events and trends under the Hitler regime. The group will be enlarged by the presence of several French and British jurists.

True Story of Fire

The true story of the burning of the Reichstag, the background of Hitler's "blood purge" of June 30, the accelerating economic crisis in the Reich, the changes precipitated by the death of Hindenburg, and the significance of the presidential "plebiscite" are some of the lines of investigation which it is planned to pursue in public sessions in Washington.

In addition to the escaped, self-confessed Reichstag incendiary, Herr Kruse, the chief Washington witnesses are to include:

Ellen Wilkinson, former member of Parliament, member of the editorial staff of the London Daily Herald, and leader in the work of caring for refugees and victims of German Fascist dictatorship.

Otto Lehman-Russbult, pacifist, former secretary of the German League for Human Rights, author of the expose, "The Bloody International of Heavy Industry"; he is to submit authentic data on German armaments.

Authorized representatives of European, Catholic, Protestant and Jewish organizations, who will submit surveys of measures taken against various religious groups under the German Fascist dictatorship.

Officials of German labor organizations disbanded by Hitler, who will present reports of the economic developments affecting workers and employees.

Foreign Members of Body

Foreign members who will sit in the Commission with equal right of examination and equal voice in preparation of reports on testimony taken are:

Sir Stafford Cripps, Parliamentary chairman of the Labor Party.

Sir Slesser, former Lord Justice for England.

D. N. Pritt, Kings Counselor, former Attorney General of Great Britain.

Gaston Bergery, attorney and Parliamentary leader, formerly of the Foreign Relations Committee of the French Chamber of Deputies.

Maitre De Moro Gjaferi, noted French criminal lawyer.

Senator Morizet of France.

Each of these six, it was pointed out, besides being a qualified student of law and legal procedure in his native country, was associated either with the French or the British Inquiry Commission which in 1933 investigated the first outbreaks of terror under Hitler and the burning of the Reichstag.

Former Reich Soldier to Talk On Anti-Nazi Radio Broadcast

Eugene F. Grigat, president of the America First and Always Society, writer and lecturer, will speak on the weekly program of the Non-Sectarian Anti-Nazi League over Station WLTH to-night at 10:30 o'clock. Mr. Grigat will talk on "German-American Views on Nazism." Born in Germany, he served in the German army during the war and has fought against Nazism in America since its inception.

Survey Shows Jewish Pupils Learn Rapidly

Racially They Win Best Progress Rating in New York

Jewish children show relatively the smallest percentage of slow progress of New York City's ethnic groups, according to a report on the "Economic and Social Correlatives of School Progress in New York City," compiled by Dr. J. B. Maller of the Teacher's College Institute of Experimentation. The study, which covered the 600 elementary public schools distributed among various neighborhoods, was chiefly concerned with German, Italian, Jewish, Polish and Negro children.

The variability in the rate of school progress among the thirty-one Board of Health districts shows that those in which the index was highest was Washington Heights, Riverside, Fordham and Tremont. The lowest rate of progress was found, among others, in the Central Harlem and Red Hook districts.

"The racial difference between the pupils of these sections is obviously the cause of the difference in the rate of progress," according to the report.

Plead to Reopen Case Of Italian Anti-Fascist

Terming impending deportation on September 1 of Antonio Bellussi, Italian anti-Fascist, a "manifest injustice," a group of liberals, among them Rabbi Israel Goldstein, today petitioned Secretary of Labor Frances Perkins to reinvestigate the case.

Bellussi, according to the petition, which accompanies a legal memorandum prepared by the Provisional Committee for Non-Partisan Labor Defense, was arrested in Pennsylvania in March, 1933, ordered deported to Italy, and kept in jail nine months.

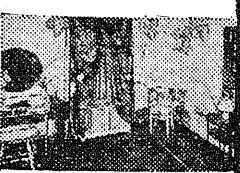

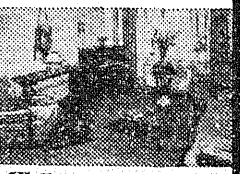

Adjusting Our Lives

Investigating the Employment Discrimination Evil

The practice of employers to deny employment to Jewish applicants, on the basis of unjustified discrimination; that is, without regard to their experience, past record, or fitness for the positions they are eager to get, is doubtless the most widespread and discouraging manifestation of racial and religious intolerance against the Jews.

Our American Jewish civic organizations, notably the American Jewish Committee, have now and then, when cases of such discrimination were reported to it, taken action to combat this un-American practice. In many instances, especially when the discrimination manifested of was practiced by a governmental, quasi-governmental, or public service agency, the fight could be brought to a victorious end.

As a rule, the employers who discriminate against Jews attempt to escape censure for their vicious practice by offering specious reasons for their denial of work to Jews. These subterfuges, coupled with the difficulty of securing direct evidence that the anti-Jewish discrimination is practiced, make the fight against it a problem of great complexity and vast extent. This problem requires nice handling, and a solid basis in the form of incontrovertible facts and figures is needed for an efficient attempt at a solution.

Several years ago the American Jewish Committee, in cooperation with a christian employment agency, undertook a study, on a small scale, of the practice of anti-Jewish discrimination which revealed many interesting facts, especially as regards the underlying "reasons." This study indicated that a wider investigation, aimed particularly at finding out the extent to which the discrimination is practiced, especially by public or quasi-public agencies, may prove of great usefulness in determining the proper way of coping with the evil.

In the meantime, the severe economic depression aggravated the calamitous situation to an acuter degree, and more energetic action was urgently called for. In October, 1930, a report of the National Committee on Discrimination, that had been set up by the American Jewish Congress several years before, came to the following conclusion: "Unless definite steps were taken by a representative Jewish body, such as the American Jewish Congress, it would become increasingly difficult for Jews to find employment."

No wonder, then, that in December, 1930, and January, 1931, representatives of national Jewish organizations, called by the B'nai B'rith, discussed at conferences held at New York the subject of unemployment discrimination. Stress was laid upon the desirability of a comprehensive study of the subject to be undertaken cooperatively by a group of national Jewish organizations. As an outcome of this discussion, a National Conference on Jewish Employment was formed.

The participating organizations, besides the B'nai B'rith, were: the American Jewish Committee, the American Jewish Congress, the National Council of Jewish Women, the Jewish Welfare Board, United Hebrew Trades, and a few others.

The purpose and aims of the National Conference were formulated thus: to study the position of the Jew in the field of employment in the United States, particularly from the point of view of possible discrimination against Jewish labor on the ground of creed or nationality; to ascertain the facts and to endeavor to improve conditions through educational vocational guidance.

A procedure was agreed upon, and a few of the participating bodies voted appropriations as their shares of a fund for a preliminary study of the subject. However, the new agency has been unable, during 1931-1932, to begin its work because of lack of money.

At the same time, several communities beside New York have

ment bureau for this specific purpose was set up in Los Angeles by the local B'nai B'rith lodge and the Jewish Social Service Bureau.

In April, 1932, a Committee on Unjust Discrimination Against Jews Seeking Employment was established in Chicago. The noted lawyer, Sigmund Livingston, founder of the Anti-Defamation League of the B'nai B'rith, was elected chairman.

Now, the program of this committee, in the opinion of Harry Schneiderman, editor of the American Jewish Year Book, expressed in his review of the year 1931-1932, reflects the most salient elements which should underlie efforts to cope with the employment discrimination evil.

This committee on anti-Jewish Discrimination in Employment established a couple of years ago in Chicago, set itself a five-fold task, namely: First, to make a survey of cases of discrimination; second, to cooperate with the existing employment agencies in discouraging such discrimination; third, to educate offending employers as to the unfairness of the practice; fourth, to discourage individual volunteers who may wish to attempt corrective measures.

And last, but not least, to prevent and discourage false rumors of unjust discrimination against any employer.

During the year 1933, finally, the National Conference on Jewish Employment, formed two years before in New York, decided that, instead, of attempting a study on a national scale, it would be more expedient to sponsor and promote local efforts along the lines of

taken steps to study some of the aspects of the subject.

In November, 1931, as a result of a study under the auspices of the Council of Jewish Women and the Jewish Family Welfare Association of Minneapolis, a number of Jewish organizations in that city determined to expand the functions of an existing employment bureau for Jews so as to include an effort to deal with the problem of anti-Jewish discrimination.

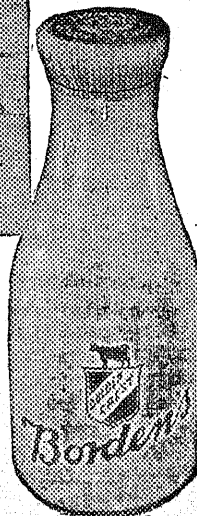

The Bulletin's Day Book

An important conference was held early last night at the Bronx Zoological Gardens. It was supposed to be one of those hush-hush conferences. The press was barred. To insure the utmost secrecy, the committee in charge of the conclave had requested the park authorities to post extra guards around all entrances.

But your reporter had got wind of the proposed parley through the grapevine channels that run from all over the world direct to the bottom drawer of his desk. And with him, to get wind of a secret confabulation is like tossing a pansy at a Nazi official. It was a challenge, a dare, an invitation to the combat.

Such a challenge to a reporter is usually enough to enable him to surmount seemingly impassable barriers. In the case of this particular news terrier, there was the added incentive of a report that the meeting would be attended by an unofficial representative of the Nazi regime.

It was no wonder then that the secret conference at Bronx Park held no secrets last night from the writer. And those secrets, which he was able to penetrate at the mere cost of a torn seat out of a pair of trousers which he had long ago decided to discard anyway, are now about to be divulged exclusively in the Day Book.

The conference was held in the ostrich corral. Present were the following members of the Empire of Zoo: Oscar Ostrich, Emanuel Monk, Sammy Snake, Charley Crocodile and Slim Skunk. Although none of the delegates wore identification badges on their lapels, it was not very difficult for the keen-eyed Bulletin man to establish their identities. The problem of identities was made comparatively simple by the immediate elimination of one of the conferees from the doubtful class. It was impossible to mistake the Nazi emissary. Slim's black and white stripes, bushy tail and snooping nose would have made him recognizable even to one who had never seen a Nazi before. But, in order to make identification easier, if possible, there was the faint but unmistakable design of the Swastika woven in among the broad stripes.

Oscar Ostrich was chairman of the meeting. While a large round object was taking the elevator down his throat, he blinked, ruffled his feathers and stomped one of his big feet.

"The meeting will now come to order," Oscar burped.

Oscar lowered his knob, picked up a fair-sized boulder and gave it the freedom of his throat. He gulped, smacked his lips and then proceeded with the business of the conference.

"Before going any further," Oscar announced, "I wish first of all to give the lie to a coward that has long been going the rounds concerning some of my gastronomical habits. I am making this announcement, as it shall presently develop, because it has a very vital connection to the purpose for which this assembly has been called by our brother from across the sea.

"You have all noticed that just now I swallowed a stone. In fact I swallowed several stones. There is a vicious lie going the rounds of this beautiful country of ours (and I know the Jews who are spreading those lies) to the effect that these stones I eat are for the purpose of aiding my digestion. I wish to state here and now that there is absolutely nothing wrong with my digestion, never has been and probably never will be anything wrong with it. About the only thing I probably could not digest would be a Jew, one of these around this park, for example, who have been spreading this

vicious international propaganda about me.

"Now I'll tell you the real reason why I eat these stones. Long ago, way back in the early 200's A. D. there was a Roman emperor, by name Heliogabalus. This Emperor one day caused to be slain 600 of my ancestors because he suddenly conceived a fancy for their brains as a piece de resistance at meals. He ate the brains of all 600 at one sitting.

"Ever since then it has been the custom of ostriches to eat stones. The stones, you see, represent the brains of Heliogabalus and his spawn."

When Oscar had finished this lengthy announcement, in the course of which the real purpose of the meeting was revealed to this eavesdropper, he blinked his eyes, picked up another stone, flapped his wings and sat down. Did you ever see an ostrich sit down? Well I did. And I almost broke out into raucous laughter which would have revealed my presence to the conferees.

When Oscar had regained his breath, he arose as awkwardly as he had sat down and again called the meeting to order.

"Hurrah," they all yowled in unison. "Let's organize a Zoo edition of the Stuermer and start a pogrom."

Immediately a vote was taken. It was decided to make Emanuel editor of the anti-Semitic weekly. Following this the "Aryan" plotters laid their heads together and fell to whispering so that the reporter could no longer make out what was being plotted. Sabath Prefers Not to Enter Speaker Race

Although Senior Member of House, Chicagoan Steps Aside

(Special to the J.D.B.)

CHICAGO, Aug. 21.—Congressman Adolph J. Sabath today told the Jewish Daily Bulletin that he will not press his eligibility for the Speakership of the House, a post vacated by the death of Henry T. Rainey.

Sabath, now dean of the House of Representatives said: "In view of present conditions and despite the fact that I am the oldest member of the House of Representatives and, from the viewpoint of seniority, am in line for the Speakership, I will not press the matter.

"I prefer not to be in the rostrum," he said.

The Congressman said that he would not enter the race for the Speakership unless matters became so tangled that his entrance would help straighten them out.

He will leave tonight to attend the funeral of the late Mr. Rainey at Carrollton, Ill.

Others leaving Chicago for the funeral will be members of the McCormack Congressional Committee to Investigate Un-American Activities, which held executive sessions here this morning. Governor Henry Horner will leave Springfield for the burial.

Sabath Office Besieged by Calls

(Special to the J.D.B.)

WASHINGTON, D. C., Aug. 21.—No one has officially announced himself, but, nevertheless, there is much speculation as to who will be the next House Speaker.

Congressman Sabath's office announced that it has been receiving many calls from various members of the House regarding his possible candidacy for Speaker because of his being the new dean of the House.

His secretary has communicated with Mr. Sabath, now in Chicago, advising him of these requests. As yet no direct word has been received here from the Congressman.

Judging from a recent interview with Representative Sabath it is unlikely that he will compete in the race for speakership. During this interview, before Congress adjourned, he stated that although there has always been some feeling of anti-Semitism existing in Congress, it has not been directed against him, "because I do not force myself to the front."

It is unlikely that he will seek the speakership despite his seniority.

Any member of the House, or even an eligible citizen of the United States, may be Congress' choice for Speaker. It has been customary, however, to promote the majority leader of the floor to this division, although there have been exceptions when a senior member was made Speaker.

Lehman Urges U. S. Control of Milk Problem

Tells Dairymen State Should Not Take Over Industry

(Special to the J.D.B.)

GENEVA, N. Y., Aug. 21.—Governor Herbert H. Lehman declared today that he was disappointed that the Federal Government had not supplemented State action in attempts to control interstate shipments of milk. Dairymen who attended the Dairy Day gathering at the New York State Agricultural Experimental Station here heard the Governor say that "the State cannot effectively control interstate shipments of milk, and our milk problem has important interstate aspects."

Mr. Lehman said that on the whole "milk control efforts to date have brought material results to the milk producer, although a few dishonest elements have made trouble for the group through threats to close milk plants and purchase milk elsewhere."

The Governor opposed the suggestion that a State authority take over the dairy industry, saying he hoped "that a permanent plan could be worked out between dealers and producers which would be satisfactory to all concerned."

Court Rejects Move to Drop Racket Charge

'Charity' Body Must Present Defense Friday, Aurelio Rules

A motion to dismiss charges of conspiracy to defraud, lodged against ten messengers and telephone salesmen of the United Relief Association on the grounds of insufficient evidence was denied by Magistrate Thomas A. Aurelio in Tombs Court yesterday. The Association will put in a defense Friday.

John C. Leffer, the detective attached to the District Attorney's office who raided the association's office after a complaint by the Department of Public Welfare, testified yesterday that one of the solicitors told him at the time of the raid, "We make phone calls, solicit funds and use the name of Judge Silverman."

Leffer told the court that, masquerading as a prospective contributor, he was told over the phone that Judge Silverman was speaking and that he was a Justice in the Municipal Court, in New York City.

Called to the stand by Assistant District Attorney John Sullivan, Rabbi Haim Weinberg, rabbi of the United Relief Association congregation, testified that Silverman is a magistrate in a small town in Sullivan County.

Shows Silverstein Letter

A letter signed by Judge Isaac H. Silverman, Monticello, N. Y., was produced, giving the Association permission to use his name in soliciting funds and to appoint campaign secretaries.

Magistrate Aurelio held that the salesmen could not call themselves "secretaries to Judge Silverman" without specifying that they were secretaries for the campaign. Certainly, Aurelio said, they could not legally impersonate the Judge.

Rabbi Weinberg said that he conducted the campaign but admitted that he had never been at the West Forty-fifth street office where the raid was made. He also disclaimed any knowledge of disposition of the funds collected. All this, he said, was in the hands of Nathan Iskowitz and Zisa Billick, respectively president and treasurer of the Association.

Sullivan vehemently protested the continuance of the case. "This is the sixth day of my vacation," he complained, "and the sixth day I've been working. Your honor knows that having denied a motion to dismiss on the grounds of insufficient evidence you will hold the defendants for Special Sessions even if they deny every allegation."

40 Back From Germany Report 'All Well' There

(Special to the J.D.B.)

ALLENTOWN, Pa., Aug. 21.—All is well in Germany, forty members of the Schwenkfelder Church who have just returned from a pilgrimage to their native Silesia and from a tour of Germany, reported. The pilgrims took the trip in celebration of the 200th anniversary of the arrival of their ancestors in America.

"There is not the slightest unrest," the report, written while the pilgrims were in Germany, reads. "The only sad fact still is the church discord which, however, is in no wise directed against the Hitler government. None of the pastors have hitherto been prevented from preaching the unadulterated word of God. But the Communists have been prevented from making attacks upon Christianity."

Mr. Deutsch and Mexico

To the Editor, *Jewish Daily Bulletin*:
Bernard S. Deutsch, president of the American Jewish Congress, is at present in Mexico, where he has distinguished himself by heaping fulsome praise on several occasions upon a government which has pursued an anti-religious policy equalled only by the interdiction of religion which has been accomplished in Soviet Russia. According to a dispatch to The New York Times from Mexico City on August 15, Mr. Deutsch, addressing the Mexican Advertising Club, said that "Mexico's best advertisement was the stability of her democratic government and the vigorous character of her industrial and commercial interests."

It is not besides the point to remind your readers that Mr. Deutsch, together with his conferees in the American Jewish Congress, has been the most valuable opponent of Nazi rule in Germany. He has, on more than one occasion, appealed to the world for liberty, tolerance and fair play for the Jews. Yet Mr. Deutsch is spending his visit to Mexico by heaping praise upon a country whose rulers are persecuting Catholicism as ruthlessly as the Nazis in Germany are persecuting the Jews.

Mr. Deutsch, I am sure, would be the first one to raise his voice in protest if some well-known

Catholic were to go to Germany and praise the accomplishments of the Nazi government. But he has no compunction about bestowing encomiums on a government whose policies are outraging American Catholics.

It may be argued that Mr. Deutsch spoke as an official of the government of New York City. Nevertheless, Mr. Deutsch is also president of the American Jewish Congress which affirms, wherever it can get a hearing, that it speaks for all the Jews of America. However, I for one should like to go on record as emphasizing that Mr. Deutsch in this instance, speaks for no one, unless it be himself—certainly not for the Jews of America.

Mr. Deutsch's utterances in Mexico are indicative of many of the actions of some so-called leaders in the American Jewish Congress who can lay more claim to trouble-mongering than they can to statesmanship. It is high time that Jews like Mr. Deutsch, whose name is backed up by some official title, do a little calm and logical thinking before acting, instead of acting first and thinking afterward. Let them consider that their actions and their utterances sometimes reflect on other Jews. Or if these Jews insist on being irresponsible, let us turn them out of office and elect statesmen instead.

Before the homegoing excitement drowned out the speakers, Celia B. Slohm of Buffalo, re-elected president of the organization, managed to bid farewell to the convention and make a speech promising great things to come.

"I believe each one of us is ready to return to her community and transmit to the others who are not able to be with us the enthusiasm and interest which this convention has created," she said. "That spirit must not in any way flag. Certainly we know that our enlarged program demands renewed efforts of us and it merits the assistance of an increasing membership."

Enthusiastic applause greeted her statement that "we are brave people who will return to our units with reports and plans for the new year, for we are willing to accept new responsibilities."

A resolution was adopted against Nazi oppression of the Jews. "Whereas the political, economic and social policies put into effect by the German government in respect to its Jewish citizens and residents," the resolution read, "has continued to horrify the civilized world.

"Be it resolved that the Eleventh Annual Convention of Junior Hadassah go on record as condemning both the inception and continuation of said policies, and

"Be it further resolved that constituent units continue to impress upon their membership and their community through effective means the importance of unified expression of public opinion against these existing conditions."

Resolutions for cooperation with Young Judaea and Masada, Zion-

ist youth organizations, were also adopted.

The Jewish National Fund was commended for its work in a resolution, and the convention pledged the aid of the organization in collecting funds for the JNF.

Strife on Stand Of Arabs Seen By Jabotinsky

Warns Cunliffe-Lister Their Acts on Entry Menace Palestine

(Jewish Telegraphic Agency)

PARIS, Aug. 21.—Vladimir Jabotinsky, leader of the Zionist Revisionists, today addressed a letter to Sir Philip Cunliffe-Lister, British Secretary of State for Colonies, pointing out that peace in Palestine had been endangered by the action of the Palestine government in permitting civilians to attempt to stop illegal Jewish immigration into the Holy Land.

The letter will be sent to the League of Nations in order to place on record Mr. Jabotinsky's warning of the grave consequences to be expected from the action of the Palestine government, it was announced.

Palestinian Arabs have organized volunteer patrols which guard the frontiers of Palestine to prevent Jewish immigrants from entering the country illegally and turn over to the police all illegal immigrants they detect.

Late last Friday a serious clash took place at Nathania, a Jewish colony, when a group of Arabs dressed as scouts passed through the village on their way to the seashore to guard against the illegal landing of Jewish immigrants. One Arab was injured in the fight between the Jews and the Arabs.

Schuschnigg and Mussolini Confer

Independence of Austria Believed Topic in Conversations

(Jewish Telegraphic Agency)

ROME, Aug. 21.—With the eyes of all Europe upon them, since the result of their conference may well decide the future course of events in Central Europe, Premier Mussolini and Chancellor Schuschnigg of Austria today held their first conversations in Florence.

Although spokesmen for both conferees have repeatedly insisted that the conference would be purely an informal exchange of ideas, it is held reasonably certain that among the topics considered by the leaders will be the problem of Austria's independence.

"The Verdict," by S. Levitanoff, Soviet playwright, and Schnitzler's "Dr. Bernhardi" have been selected by the New York Art Troupe, heirs of the Maurice Schwartz tradition on the East Side's Broadway for the opening of the Yiddish Folk Theatre's season.

This newly formed production unit, which hopes to carry on for the thirty weeks of the Yiddish theatrical season with a succession of semi-classical Yiddish plays of the type of "Crime and Punishment" and "David Golder," begins its first season under the management of Leon Hoffman, who worked with Maurice Schwartz until Schwartz left for Hollywood. Most of the artists who formed the old Yiddish Art Group, will be with

the unit: Joseph Buloff, Lazar Freed, Anna Appel, Ben Zwi Barattoff, Luba Kadison and others. A company of sixty will be gathered together before the opening night, Sept. 19.

At the Second Avenue Theatre, Molly Picon, after an absence of four years from the Yiddish stage, returns in Dymov's "Runaway Bride." At the Public Theatre, Aaron Lebedeff presents the opera, "A Happy Family," last season's outstanding Yiddish dramatic success, with Menachem Reuben and Itzhack Freed. Four theatres in the Bronx and Brooklyn offer theatre fare to the Yiddish playgoer.

"Arteff," the Yiddish proletarian and experimental group, which last year produced Gorki's "Yegor Bulitcheff," has secured the Little Theatre at Forty-eighth street and Broadway for its amateur players this season.

Critical Moments

The Cat's Paw

Harold Lloyd, whose tortoiseshelled lensless spectacles were nearly as popular and well-known to film fans of a decade ago as Charlie Chaplin's roomy shoes, has returned to the talkies after an absence of two years with his spectacles and his sense of the ridiculous intact. At the Radio City Music Hall he may be seen in "The Cat's Paw," a Fox release which was adapted from the story of the same name by Clarence Budington Kelland.

"The Cat's Paw" was bought for the screen with the idea of giving Lloyd a vehicle the sight of which would send audiences into the proverbial gales of laughter. I must say that the producers have come very close to succeeding. It is amusing throughout and in some places downright hilarious. Unlike the previous Lloyd pictures, "The Cat's Paw" has a sturdy plot, one with a real story that requires a cast of actors. It concerns the exploits of one Ezekiel Cobb (Lloyd), the son of missionaries, who has been brought up from childhood in complete ignorance of existence in the Western world.

Upon his return to the small town where he was born, he is taken in tow by a typical grafting, unscrupulous politician (George Barbier), who decides that Ezekiel would make a fine "dummy" mayor. With the aid of the political machine, Ezekiel is elected. The politician then finds that he has a mayor who refuses to take orders from his makers. The machine that made him then tries to undo him, which brings into the films the gangster phase of American life. How Ezekiel solves the crime problem after going to a wise Chinaman for advice is one of the brightest film moments I've experienced in some time.

Other amusing situations arise when Ezekiel is confronted with modern slang, the radio and other alleged innovations of the present. His confusion and distaste are carried off with an air of bewilderment that will delight those who are fed up with the mechanization of our daily life.

As the mayor Lloyd carries off his role skillfully, believably and neatly. George Barbier as the crooked politician, Una Merkel as the girl who sympathizes with the plight of Ezekiel, and Alan Dinehart as the ex-mayor, are likewise excellent.

"The Cat's Paw" is high comedy of a superior brand.

Frohman Tells of Bygones, Marks 83rd Birthday Quietly

Wants to Produce One More Hit Before He Quits

Daniel Frohman will be eighty-three today.

Not eighty-four, as some reports would have it.

The old gentleman of the American stage yesterday took exception to published reports that he was nearing his eighty-fourth anniversary, and with a vehemence that somewhat belied his four score and three years, demanded:

"Now, I don't look that old, do I?"

He went on to explain that while he was willing to grant that he looked like eighty-three (and he most certainly did not) no one could accuse him of looking like eighty-four.

"For one thing," he remarked, "I don't have the experience of a man of eighty-four."

Daniel Frohman has his home above the Lyceum Theatre on Forty-fourth street. He has maintained quarters there for thirty-two years.

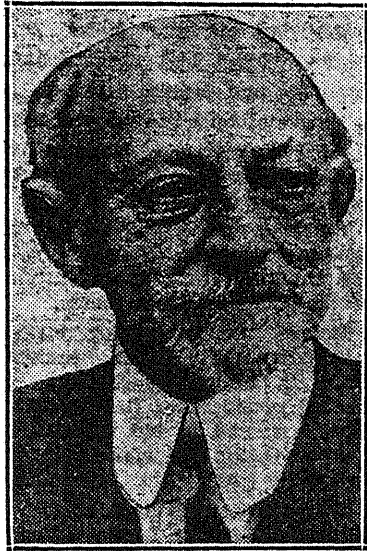
"Always living in the past," he said yesterday, as one long arm indicated the pictures, the signatures, the mementoes of past dramatic stars. "And," he added, "living in the past now more than ever."

Pictures Live Again

As he talked, the producer brought back to life long-dead and some forgotten stars of the old stage. The pictures that fairly covered his walls came to life and stalked again on the stage of his theatre below.

"It was from here that we used to watch our second night performance," he said, opening a door in the wall through which one could look directly below onto the stage. "It was from here that my guests and I watched some of the greatest actors of all countries make history."

He showed the reporter about his home, modest and comfortable in its old-fashioned trappings, cool from the floor to the high ceiling. He touched some of the pictures gently, caressingly, reminiscently.

"Here is Bernhardt, the Divine Sarah," he mumbled, as though talking to himself. "What an actress! What a lovely personality! Why, it seems only yesterday. But never mind, we'll look at a few other old friends."

The boy who was born in Sandusky, Ohio, in 1851, turned back the calendar for a glimpse of the glamorous years that marked his rise to the pinnacle of success as a producer and manager.

As president of the Actors Fund he has spent the past few years of his life caring for the cast-off veterans of the stage.

"It was here I sat with Paderewski more years ago than you can remember," he told the reporter. He indicated a table upon which pens, papers and books rested. "It was here that I entertained Signor Salvini, Edwin Booth, Duse, Modjeska, Lilly Langtry, Joseph Hoffman and others that I remember as the greatest actors that ever lived."

He found the reporter copying the names.

"Wait now, if you're going to mention those, you'll have to mention a few others as well. It's hard to say which have been the greatest actors I've ever managed, but I'll give you the names of the few I can remember offhand.

"There were, of course, all those

First Case Up Friday Under New Wald Act

Defendant Is Accused of Removing 'Made in Reich' Label

The first case to be pressed by the Non-Sectarian Anti-Nazi League under the new Wald Act prohibiting the removal, defacing or changing of the marks of origin on imported goods by merchants in New York State will come up in the Fourth District Magistrate's Court, Fifty-seventh street and Lexington avenue, on Friday morning.

The defendant is Joseph Bleimeyer, an employe of the Pen-nant Stationery Co., who is charged with the sale of a package of German-made thumb tacks from which the stamp "Made in Germany" had been removed.

The Wald Act was passed at the last regular session of the State Legislature. It was sponsored by Senator Albert Wald and was drawn from memoranda submitted by the New York State Lawyers Committee of the Non-Sectarian Anti-Nazi League in an effort to check the numerous frauds perpetrated by importers and dealers in their efforts to overcome the sales resistance to German-made merchandise created by the anti-Nazi boycott. The League is the sponsor of the boycott movement. Samuel Untermyer is president of the League.

Stage Before Films

Frohman says that a good play, well acted, will always prove popular.

"And the movies will never replace the stage," he predicted. "Even the highest salaried actors get tired of making movies—turning out plays that appeal to the standards of the masses. Why, just the other day I met a friend of mine who has been doing very well in Hollywood. What do you think he said? He told me, 'I'm going to stay out there another year. Then I'll have made enough money to be able to afford to act on the stage again.'"

Daniel Frohman wants to produce one more "hit." He wants to see his name in lights over his theatre just once more.

"Then I'll be content," he said yesterday. "Give me a good script, a good cast and an intelligent audience, and I'll ask for nothing more from life."

He will spend his anniversary today quietly. He will take dinner with his nephew and niece, Mr. and Mrs. Daniel Davis.

Will Dublinsky Click?

Harry Dublinsky, the Jewish lad from Milwaukee who hails from such prolific parents, takes on Tony Canzoneri, in the Italian flash's first fight as a welterweight. The bout originally scheduled for tonight has been postponed for a short time due to the fact that Tony ruptured a tendon in his leg.

But, regardless of the fact that the fight has been called off your sports scribe did not think that Harry Dublinsky would win. Recently, in any major sporting contest around town, we have deemed it best to swing along with the Jewish contestants—not because of any racial prejudice but rather due to straight facts, a knowledge of training conditions, and an impartial survey of the fighters before the fight. That is why we picked Ross to take McLarnin and figured Maxie to trump the Primo's ace with a couple of clubs.

However, even though Tony is fighting his first fight as a welterweight against Harry Dublinsky, we are confident that he will wallop the Milwaukee Mauler and show him a few dance steps besides. Dublinsky is a good fighter and has come along very nicely, but not too well, since he started boxing in 1926. (In our opinion, he isn't in Canzoneri's class, and doesn't even attend the same school). Canzoneri can teach even the champion Barney Ross a few things and can beat Dublinsky with ease. He cannot outwit young Ross, the lad who belted the crown off his noble block because the present champ is a great fighter, a clever boxer, and possesses speed and punch. Tony is just a very good fighter whom though not nearly as expert a boxer as his Jewish opponent Barney Ross, nevertheless can take on Harry Dublinsky on Monday, Wednesday, and Friday with a special matinee on Saturday—and win on each occasion.

We feel that Dublinsky needs a few more fights under his belt in order to be a real match for the former lightweight champ, Tony Canzoneri. Harry will click when they meet and in all probabilities it will be with his eyes. However, all of the ninety-two cousins, uncles, and aunts of the numerous Dublinsky clan will have to trek it back to Chicago and Milwaukee sadly disappointed.

Both Fighters Former Lightweights

Harry Dublinsky began his fighting career as a lightweight and then changed to the next heavier class—the 147-pound division. Likewise with Canzoneri, who reigned for a year as king of the lightweight class and now switches to the welter contingent also. Both boys were moved by the same principles. Extra fat, added years, and the fact that Jimmy McLarnin was weakening. Neither figured on Barney Ross toppling the Irish idol from his 147 pound pinnacle.

Tony Canzoneri licked the Jewish boy from Chicago and Milwaukee (Ed. note—there are so many Dublinskys in both of these towns that each city has an equal claim to Harry) in 1932 when both were lightweights. However, Harry held Barney Ross to an eight round draw in 1930. Notwithstanding, we admire Dublinsky on this count. He never boasted of his draw with Ross as did Frankie Klick of California.

Klick trimmed Ross in the first round of their fight on the coast but Ross came back and trimmed the whiskers off Klick's chin with

right and left cuts. But Klick talked the West coast eighteen to the dozen and came here for a crack at Barney's new crowns. Canzoneri, whom the Boxing Commission set up as an obstacle in Klick's path, sent the young Pacific Coast fighter home with his tail between his legs and a very bad, aye, a very bad right eye.

Dublinsky, at the time, realized that he had caught Barney in an off moment and merited a draw. He realized only too well that at the time he was not in Barney's class but would be some day. That's why he didn't shoot his mouth off like a machine gun the way Frankie Klick did.

Yet, we'll be at the ringside the night of the fight to cheer Harry Dublinsky on, even if we don't feel he'll lick his Italian opponent. We'll be sure of a hectic tussle when the Italian and the Jew start scrapping in the Ebbett's Field resined arena.

Palestine Jewish Girl Athletes

"The Empire Games are over. The Palestine Jewish girl athletes made a splendid showing for so small an athletic contingent. No first places were taken by these girls but their spirit was undaunted."

This terse cable came in over the ticker last week, and it speaks volumes. It was the first time that an athletic group consisting solely of Jewish girls from Palestine was ever represented at the Empire Games in England as a recognized athletic contingent.

The youngest of the team was fifteen years old and the oldest twenty-two. There were twelve members on this team led by their captain, Dr. David Almador. Dr. Almador said, before the games started, that this team was not out to win all the events on the program but rather to give as good a showing of themselves as they possibly could. The team was hoping to gain a good experience from this participation. They were only a young Federation and willing to learn, hoping at the same time to give a good account of themselves.

At the official reception which was tendered them on their first night in England, Mr. Barnett Janner, M. P., on behalf of the Maccabi World Union, said that "We are welcoming these young people from Palestine who have come to England in order to uphold the athletic prowess of the Jewish people in the women's world events."

Mr. Janner made a special point of the fact that here was a movement which stood above political internecine strife, so far as the Jewish people were concerned. The Maccabi stood for the development of Jewish youth, so that the Jewish body and the Jewish mind might be of an equally good type. He also said that while he and his colleagues were in Palestine they had the privilege of seeing something of the Maccabi movement which consisted of a body of young people whose ideas were modelled upon the best possible standards, and they came away thrilled by what they had seen. He concluded his remarks to the team saying that even if they did not win, he was sure that they would take defeat in a sportsmanlike spirit.

Pelley, Henchmen Reindicted For Fraudulent Stock Sales

ASHEVILLE, N. C., Aug. 21.—The Buncombe County Grand Jury indicted William Dudley Pelley again today for violation of the Security Law in selling stocks in his Galahad Press.

Arraigned with Pelley are three of his henchmen who are said to have taken part in the Silver Shirtissimo's business affairs. They are:

Robert C. Summerville
Don D. Kellogg
H. M. Hardwicke

The Galahad Press, now bankrupt, served as an organ for the metaphysical utterances of the eader of the Silver Shirts. Through it, Pelley circulated broadcasts from the Great Beyond, which he alone was privileged to hear.

Summerville was indicted with his chief last May on charges of fraudulent stock sales, but he continued his activities in the Silver

Legion, which is fashioned after the stormtroops of Adolf Hitler. Summerville was ordained chief of staff in the Silver Legion shortly after Pelley decided that what this country needed was a Hitler capable of "showing the Jews their place" in American affairs.

Kellogg was also indicted on the same counts during the May sessions, but this is the first time Hardwicke has been brought to answer before the law.

The quartet of Silver Shirts will face trial in Superior Court when the criminal term opens on September 17, it was learned today.

Hardwicke, still at large, is expected to be arrested momentarily. The others have been under \$2,500 bond since their arrest.

When the Silver Shirt heads come up for trial they will be asked to respond to an indictment containing sixteen counts, all of them understood to involve Pelley's business transactions.

Wise Insists On Boycott At Geneva

Says Drive Is Result of 'Rightful Instincts' of Masses

(Continued from Page One)

"To die at the hands of the Nazis is cruel, but to survive by Nazi grace were ten thousand times worse. We will survive Nazism unless we commit the inexplicable sin of bartering with it in order to save some of the victims," Dr. Wise said.

Pointing out that the boycott was the single non-violent weapon capable of being used by the Jews in self-defense, Dr. Wise declared: "The boycott could not have been averted by anyone, any more than it could have been halted by super-cautious Jewish bodies in London and New York.

"The boycott is the result of the rightful instincts of the Jewish masses, intensified in America by Samuel Untermyer, the American Federation of Labor, the American Jewish Congress and numerous Catholic and Protestant groups.

Protests Palestine Action

"We solemnly protest against Palestine breaking the boycott. At the last Zionist Congress in Prague, under the joint influence of German Zionists and certain Palestinian leaders, we made the woeful blunder of withholding our condemnation of the Palestine-German transfer agreement, which is a breach of the boycott. This breach is being continued and even widened with every excuse being given.

"The conference must clearly state that while Palestine enjoys primacy this primacy ceases when it comes into conflict with a higher moral law. Had we been prepared to gain Palestine under lower terms it might have been encompassed sooner and easier.

"We were given warning that support for Palestine would be alienated for the World Jewish Congress if the conference adopts a resolution against the Palestine German transfer agreement.

"I do not fear this threat," Dr. Wise concluded. "The Jewish people are prepared to accept the guidance of Eretz Israel, but not commands or threats, when they conflict with the interests of all Israel."

Creation of an international boycott center with sections devoted to fighting Nazi propaganda was recommended by the French and Polish delegations to the conference.

A stormy discussion developed in the closed session of the boycott committee on the Palestine German transfer agreement, with opinion seemingly divided on the issue, some supporting the agreement, others condemning it.

A resolution will be formulated calling for the coordination of boycott activities and containing a clause against the purchase of German goods by Palestine, it was learned.

Tomorrow's session of the conference will be devoted to committee meetings.

Discuss Saar Jews' Fate

The fate of the Jews in the Saar Valley after the January, 1935, plebiscite, in connection with the forthcoming session of the League of Nations, and the question of extending the world-wide boycott against Germany were discussed today at a closed session of a special committee appointed by the World Jewish Conference, which opened its sessions here yesterday. The committee also discussed the Jewish position in Austria, Poland, Rumania, Mexico and the Soviet Union, and the necessary action to take in each case. The inhabitants of the Saar are

Popular Song Proves Undoing of Stowaway

HALIFAX, N. S., Aug. 21.—Mo Kolerman, a Polish Jew, is on his way back to his native land after a thwarted attempt to enter Canada as a stowaway. The whistling of a popular tune proved to be Kolerman's undoing.

Kolerman had arranged with two members of the crew of a steamer to stowaway on the ship at Gdynia. The arrangement called for one of them to whistle a popular tune as soon as the ship reached Halifax. He boarded the ship safely.

Unfortunately, the tune apparently was too popular, for a steward happened to intone it while the ship was still on the high seas. When Kolerman heard the pre-arranged signal, he happily left his hiding-place and walked into the arms of an officer.

After a brief stop at the local harbor the ship left on its return trip to Gdynia, where the Polish police will deal with the hapless stowaway.

to vote in the plebiscite whether to return to Germany, become a part of the French Republic or to continue under the rule of the League commission now governing the territory. Fear has been expressed that the Jewish population of the region will suffer the same disabilities now in force in Germany. At the forthcoming meeting the League of Nations will be asked to secure guarantees that Jews of the Saar will not be persecuted if the Nazi government assumes hegemony over the region.

Dr. Lestchinsky Reports

The open session of the World Jewish Conference listened to a lengthy report by Dr. Jacob Lestchinsky, well-known Jewish economist and journalist, who was exiled by the Hitler regime. Dr. Lestchinsky painted a gloomy picture of the Jewish economic and political situation in Germany and other European countries, based on his extensive survey in recent months.

More than 60,000 Jews left Germany in 1933 and another 10,000 departed in the first six months of 1934, Dr. Lestchinsky said.

"The position of the Jews remaining there is becoming desperate, since there is no hope of finding refuge abroad," Dr. Lestchinsky declared. He described conditions in other countries as worse than desperate, owing to the depressed economic condition of the lands which have absorbed the larger portion of the German Jewish refugees. In Poland, Rumania, Lithuania and Latvia, Jews were refused employment in state undertakings.

"Jewish youth has no prospects in any of the Central European countries," Dr. Lestchinsky said. "The pauperism of the Jewish masses is alarming. Emigration is impossible except to Palestine and migration offers no chance of salvation."

A. J. C. Explains Functions Of World Jewish Congress

The American Jewish Congress issued a statement yesterday commenting upon the decision of the Geneva conference under the joint auspices of the Committee of Jewish Delegations and the Executive Committee for the World Jewish Congress, and explaining what the functions of the projected World Jewish Congress are to be.

The statement points to the fact that the elections for delegates to the World Jewish Congress coincide with the national democratic elections to the American Jewish Congress to be held next April.

The statement declares:

"The World Jewish Congress is to be a gathering of Jewish representatives of all countries. Delegates are to be elected by demo-

Nazi Chieftain 'Exposes' Red Plot to Blow Up Youth Camp

NEWARK, N. J., Aug. 21.—Hugo Haas, leader of the Nazi youth camp in Griggstown, smells a Communist plot to blow up, set fire to and otherwise inconvenience his Hitlerite camping grounds, the Newark Star Eagle reports today.

Menacing letters warning him to evacuate the site of his Camp Wille und Macht have been received, he says.

One of the alleged letters reads as follows:

"We will give you four days to leave the camp. If you do not, we will blow it up. (signed) Anti-Nazi."

With great courage, Haas figu-

ratively snapped his fingers and said, "They are empty threats. The four days expired and nothing happened."

Haas is certain that the letters are Communist-inspired, although he does not state the reasons for the assumption.

"Empty" as the threats are, sentries are posted around the camp every night. Haas admits that the reason for the sentries is "to give warnings of possible attack by anti-Nazi sympathizers or other intruders."

"The campers can take care of themselves," Haas asserted. They range in age from eight to sixteen years.

Deutsch Talks With 'Strong Man' Calles

Also Entertains Ambassador Josephus Daniels in Mexico City

MEXICO CITY, Aug. 21.—Bernard S. Deutsch, president of the New York City Board of Aldermen, today returned the courtesies shown him and Mrs. Deutsch during their visit to Mexico by acting as host at a country club luncheon to United States Ambassador Josephus Daniels and Federal District Governor Aaron Saenz.

Observers today viewed as significant Mr. Deutsch's visit to former President Plutarco Elias Calles, Mexico's "strong man," at Cuernavaca. General Calles and the New Yorker yesterday conversed for nearly an hour on a multitude of topics, including relations between their countries.

A surmise that Jewish problems were discussed could not be confirmed, but the fact that the former President, who is still the political dictator of Mexico, had announced during his occupancy of office an open invitation to 10,000 Jews to settle here was recalled.

Rubin Is Honored At Farewell Feast

About 200 representatives and guests of all the Zionist groups in New York attended a farewell banquet which was held last night in honor of Isaac Rubin, secretary of the Jewish National Fund, at Trotsky's restaurant, Thirty-fifth street and Seventh avenue.

Mr. Rubin, who was secretary of the Jewish National Fund for over 24 years, has just resigned that position in order to settle in Palestine. He is sailing this Friday with his wife and daughter Libby.

Frankfurt-am-Main was facing a desperate financial future. According to the report, an average of forty Jewish firms had liquidated monthly their affairs during the past year, while in the month of June, 1934, 120 Jewish firms gave up business.

Jewish fears are aggravated by the fact that many of the Jewish districts voted heavily against Chancellor Hitler's seizure of the office of Reichspresident and combining it with the office of Chancellor. During the plebiscite campaign Nazis threatened that all those who voted "No" would be regarded as traitors to the German people. At the same time it appeared that orders were issued to tone down the anti-Jewish campaign in the Reich during the plebiscite drive.

Yesterday Chancellor Hitler, in a post-election address, declared that the Nazi party would now devote itself "to winning over" the ten per cent who had voted against the Nazi regime, "in typical Nazi fashion."

Representative Body Protests Streicher 'Ritual' Libel

BERLIN, Aug. 21.—The All-German Jewish Representative Body, central German Jewish organization, today protested officially to the Nazi government against the attempt made by Julius Streicher in his anti-Semitic weekly, Der Stuermer, to renew accusations of ritual murders against the Jews.

The current issue of Der Stuermer was suppressed yesterday in Breslau for raking up an old murder case involving a sadistic, sexual crime and featuring it under the heading of "Ritual Murder in Breslau." Breslau police termed the story "nonsense."

Paint Strikers' Ultimatum Is Called 'Weak'

Masters Association Does Not Take Union Action Seriously

The Association of Master Painters and Decorators, in an organization meeting yesterday, called the ultimatum given them Monday evening by the striking painters a "weakness upon the part of the union."

The union's resolution, which was passed at a mass meeting of the Brotherhood of Painters, Paperhangers and Decorators Monday night at Mecca Temple, declares that if the union's demands are not met by the Masters Association within forty-eight hours (tomorrow morning) the employers organization will no longer be recognized, and the striking painters will deal directly with individual employers.
