#### The Jewish Conference in Geneva

A report from Geneva, sent out by the United Press and published widely in this country under screaming headlines, told of the formation of the "Jews' Super-Government" at the "World Jewish Conference," in Geneva.

The opening paragraphs of that report said:

"A super-government of Judaism, representative of Jews in every country and pledged to fight unceasingly and uncompromisingly against oppression of the race, was in process of formation today.

"Plans were formulated by the World Jewish Congress for the government, actually a Jewish parliament with delegates from every country, and with permanent headquarters here."

After quoting from the address by Dr. Nahum Goldmann, president of the Committee of Jewish Delegations, the United Press listed the following five main activities of the present "congress," according to Dr. Goldmann's statement to the United Press:

Preparation for permanent congress.

Intensification of the boycott against Germany.

Position of Jewish minorities in various nations.

The situation of the Jews in Soviet Russia.

Methods of combating anti-Semitism, which is growing throughout the world.

Dr. Stephen S. Wise, upon learning of the report concerning a Jewish super-government to combat anti-Semitism, declared:

"This report is so absurd that you may be astonished that I refer to it at all. There are doubtless Jews in New York, London and Paris who are not so enthusiastic as we about the projected World Jewish Congress. But there is not a man or woman in this room who would be guilty of saying such a foolish thing as that we favor a world super-government.

"We do not favor any Jewish government. We do favor Jewish self-respect and the idea that Jews shall cease to be victims of hatred. As far as a super-government is concerned, we merely ask that every government on earth be just, not only to Jews but to all peoples and all religions. More than that we do not ask."

Morris D. Waldman, secretary of the American Jewish Committee, in a statement to the press, declared:

"In view of the erroneous headlines and statements contained in some reports of the press of a conference of Jews now being held in Geneva, attention is drawn to the fact that the American Jewish Committee

## Mexico Not Anti-Semitic, Deutsch Says

### Calles Talk Confirmed; New Yorker Ends His Visit

MEXICO CITY, Aug. 22.—Bernard S. Deutsch, president of the Board of Aldermen of New York City and of the American Jewish Congress, today confirmed reports that he had discussed Jewish problems with former President Plutarco Elias Calles, Mexico's "strong man."

In an interview with the press prior to his departure for New York, Deutsch said he believed anti-Semitism in Mexico was not supported by the government but was merely the tool of certain "ambitious groups" seeking to use the campaign against the Jews as "a political ladder."

Deutsch declared he was convinced the government of Mexico is friendly to his co-religionists and that anti-Semitism in Mexico "will die in its cradle."

"A strong government like Mexico," he said, "will not tolerate such a campaign."

## HolyLandExcludes Alien Newspapers

### Forbids Sale of Lithuanian Jewish Publication for Full Year

JERUSALEM, Aug. 22.—The Palestine government has adopted a regular policy of prohibiting foreign Jewish newspapers from being sold in the Holy Land.

Authorities today prohibited The Moment of Kaunas, Lithuania, for a full year. Unser Zeit of Kishinev, Rumania, was banned recently.

Government censorship of foreign Jewish papers coming here has evoked wide comment.

## Reich's Prettiest Girl 'Non-Aryan,' So Envoy Refuses Judge's Post

LONDON, Aug. 22.—Because "the most beautiful girl in Germany" is partly Jewish and hence a "non-Aryan," the German Ambassador to London, Herr von Hoesch, has declined an invitation to join in the judging at Hastings to select "Miss Europe" from among the most beautiful girls of eighteen countries.

"Miss Germany" is Emma Kant, a grand-niece of the philosopher. She is partly Jewish.

"Because 'Miss Germany' is not a pure Aryan, I could not be present in an official capacity at Hastings," von Hoesch declared.

## Label Jews Aliens, Demand Of Polish Anti-Semitic Organ

WARSAW, Aug. 22.—Gazeta Warszawska, principal organ of the National Democrat anti-Semitic party, today demanded that the government deprive all Polish Jews of their citizenship rights and declare them aliens.

## Parley to Urge World Congress, Ask Creation of Jewish League

GENEVA, Aug. 22.—The organization committee of the Jewish World Conference today adopted a resolution calling for the convening of a world Jewish congress in August, 1935. The decision advocates that the forthcoming congress create a World Jewish League, resembling in structure the League of Nations. The new body will have a council, an assembly and a permanent secretariat, similar to the league division. The committee's recommendation undoubtedly will receive support of the entire conference, observers stated.

The conference boycott committee resolved to summon a world Jewish boycott conference, to be held in London on October 8, to take steps to coordinate the world boycott movement against Nazi Germany.

Samuel Untermyer, leader of

the American boycott movement, is expected to attend the London conference.

The entire day was devoted to committee meetings, at which questions of paramount importance were being thrashed out and policies formulated. The conference itself did not meet today.

A resolution urging the continuation of the boycott against Germany, but omitting reference to the Palestine-German transfer agreement, severely criticized yesterday by Rabbi Stephen S. Wise, was agreed upon today at a session of the conference boycott committee.

At the same time an agreement was reached to address a special resolution to responsible Jewish bodies in Palestine urging them to take steps to insure that the transfer transaction under the Palestine-German agreement will

## War Awards To Be Named After Hitler

### 100,000 Jews Who Saw Service May Lose Honor Cross

BERLIN, Aug. 22.—The cross of honor to be awarded to all those who fought in the German armies during the World War, one of the last decrees signed by the late President Paul von Hindenburg, will be named the Hitler Cross and not Hindenburg Cross as originally planned, the Nazi government announced today.

Thus about 100,000 German Jews who served in the German armies will either be deprived of the medal, since the dead president and the Chancellor clashed on the issue of the awards to Jewish war veterans, or they will be compelled to wear the Hitler Cross, which is regarded as highly improbable.

Chancellor Hitler, it was announced, objected to the cross being given to Jewish war veterans, but the aged Field Marshal decided over his protest to award the cross to all World War veterans, irrespective of faith. The measure was regarded as a rebuke to the anti-Semitic policies of the Nazi leader.

## Reich 'Race' Passports Feared as Beginning 'Yellow Badge' System

BERLIN, Aug. 22.—The Nazi government registry office today issued the first of the new passports containing, in addition to the customary information, details of the racial descent of the holder.

The step was opposed by Jewish organizations as the beginning of a "yellow badge" system, similar to the distinctive marks worn by the Jews in the Middle Ages.

Through the new passport system officials will be able to distinguish at once between "Aryans" and "non-Aryans."

## 142 Lithuanian Nazis Face Court-Martial

KAUNAS, Lithuania, Aug. 22.—It was officially announced here last night that 142 members of the Lithuanian Nazi organization will be court-martialed for attempted insurrection. The Nazi organization in Lithuania, which pledged fealty to Berlin, has been prohibited by the authorities.

## Prussian Government Bans 'Non-Aryan' Social Workers

BERLIN, Aug. 22.—The Prussian government will not employ "non-Aryan" social workers, Bernhard Rust, Prussian Minister of Education, announced today.

## Dickstein Reopens Nazi Probe; May Quiz New Jersey Campers

Congressman Samuel Dickstein, vice-chairman of the McCormack Committee to Investigate Un-American activities, will re-open interrogation of Nazis at the Bar Association Building at two o'clock this afternoon.

Yesterday it was said that the hearing probably would be private.

It is understood that the committee will concern itself at today's session with conditions existing at the Nazi camp at McDonald's Lake near Bridgetown,

N. J., where Nazi youth and storm-troop organizations have been holding their summer encampment.

The Nazi camp was recently taken to task by authorities for violation of the State's sanitary laws.

It is expected that Hugo Haas, 23-year-old leader of the Nazi youth movement here, will be asked to account for the activities of his group. Haas has been held responsible for the unsanitary conditions.

## Algiers Guilt Is France's, League Holds

### Foes of Anti-Semitism Throw Gauntlet to Administration

(Jewish Telegraphic Agency)

PARIS, Aug. 22.—The French administration in Algiers was openly charged here tonight with direct responsibility for the pogroms in Constantine at a public protest meeting under the auspices of the French League to Combat Anti-Semitism. President Bernhard Lecache of the League, who presided, demanded to know whether it was true that:

1. The Constantine garrison was locked up in the barracks during the pogrom after a Zouave regiment had expressed the desire to intervene and protect the Jewish population.

2. The civil authorities of Constantine refused to ask for troops to halt the pogrom.

3. Anti-Semitic propaganda was not forbidden.

"Why were none of the officials responsible for the pogrom dismissed from their posts?" Leache asked.

## Palestine May Bar Two Revisionists

### Stavsky and Rosenblatt Not Given Return Visas After Krakow Conference

(Jewish Telegraphic Agency)

JERUSALEM, Aug. 22.—Abraham Stavsky and Zvi Rosenblatt, young Zionist Revisionists recently acquitted of the murder of Dr. Chaim Arlosoroff, have not been granted return visas and may not be allowed to reenter Palestine, it was announced today.

The two Revisionists applied for passports in order to attend a Revisionist conference scheduled to be held in Krakau.

After the final acquittal of Stavsky by the Palestine Appeals Court, the two men were warned by Tel Aviv police to leave as the police could not be responsible for their safety.

## Nuremberg Shops Get Special 'Aryan' Signs

NUREMBERG, Aug. 22.—Jewish stores in this center of anti-Semitism will be easily recognized from now on. The Nazi Trade League today issued special posters to be displayed by all "German" stores and hotels.

The city is the headquarters of Julius Streicher, Nazi overlord of Franconia and editor of Der Stürmer, most pronounced anti-Jewish paper in Germany.

Under Streicher Nuremberg has taken the lead in adopting the strongest anti-Jewish laws. The Nazi party congress is to be held here this Fall, as was the case last year.

## A. J. C. Urges Boycott Drive During Holiday

### Requests 1,350 Rabbis to Give Sermons on Subject

An appeal to Jewish communities throughout the country to observe the High Holiday season as a period of national concentration for the purpose of extending and strengthening the boycott against the products and services of Nazi Germany has been issued by the Boycott Committee of the American Jewish Congress, it was disclosed yesterday by Dr. Joseph Tenenbaum, its chairman.

In the interests of advancing the boycott movement, 1,350 rabbis throughout the country have been requested to devote at least one sermon during the High Holiday period to a discussion of the necessity of bringing about the economic isolation of Nazi Germany. Rabbis of all denominations have been approached in this connection.

At the same time local branches of the American Jewish Congress in various sections of the country will initiate boycott drives during the holiday period.

Special boycott vigilante committees will visit the synagogues before Rosh Hashonah and on the eve and expiration of the holidays for the purpose of distributing boycott pledge cards for signature.

In appealing for an extension of the boycott, Dr. Tenenbaum calls upon an aroused public opinion to prevent the issuance of new credits to the Hitler government, as now contemplated by "selfish financial interests." The voice of American Jewry must be heard, he asserts, "against those in our midst who trade with the enemy as well as against those financiers who would help prolong the shame and torture of the Nazi regime."

### Maria Halberstadt to Discuss Late Developments in Reich

Maria Halberstadt, formerly a high school teacher in Germany, will discuss latest developments in the Reich tonight at the Hotel Newton. The talk is one of a series of lectures on Fascism sponsored by the West Side Branch of the Friends of the Soviet Union.

### Pre-Revolutionary Jews

Lancaster is one of the few cities in the United States that can boast of a pre-Revolutionary settlement of Jews. The Pennsylvania town, founded in 1730, had about ten Jewish families in it shortly after its formation.

### Trumpeldorite Going 'Home'

## Wilno Institute Will Celebrate Decade's Work

### Plans for Anniversary Revealed by Shur, Visiting Here

Michael Shur, secretary of the Yiddish Scientific Institute of Wilno, who is in this country until October, when he will return to Poland, yesterday announced tentative plans for the tenth anniversary celebration next year in Wilno of the founding of the Institute, which has branches in nineteen countries and a board of trustees including such scholars and scientists as Albert Einstein, Sigmund Freud, Edward Sapir and Chaim Zhitlovsky.

The Yiddish Scientific Institute has for its aims the study of all phases of Jewish life in all languages and in all countries. It collects material mirroring Jewish life and preserves Jewish folklore, maintaining archives and museums in Wilno in which is accumulated a body of material unequalled in this field by any other institution in the world. The Institute has 1,000 members in the United States, according to Mr. Shur, who plans to visit Jewish communities in the South and West before returning to Poland.

### Exiles Swarm Library To Read Reich Papers

Eagerness for news from home has become so great among German Jewish refugees in New York City, Dr. Joshua Block, chief of the Jewish division of the New York Public Library, declared yesterday, that limitations have had to be made by the library authorities on the circulation of German Jewish weeklies. The few copies of the Jewish papers that arrive from Germany are so avidly scanned by the numerous visitors that the library's bindery receives them practically in shreds he declared.

### Soviet Friends to Hear Exiled Reich Educator

Under the auspices of the West Side branch of the Friends of the Soviet Union, Maria Halberstadt, exiled German educator, will speak tonight at the Hotel Newton, Broadway and Ninety-fourth street on the latest developments in Germany.

### Jaffee to Talk Over WBBC

Charles D. Jaffee, president of the Clothing Manufacturers' Association and vice-chairman of the Clothing Code Authority, will discuss the German situation over the air tonight over station WBBC from 7:30 to 7:45.

## Judge Throws Sabbath Case Out of Court

### Finds Evidence Scanty in Charge Against Store Clerk

Dismissal in Tombs Court by Magistrate Thomas A. Aurello of the case against Samuel Evans, an employe of Aaron Chodorow, for violation of the Sabbath law was hailed yesterday as a victory by officers of the Jewish Sabbath Alliance in their campaign to permit Jewish shopkeepers to keep their establishments open on Sundays instead of Saturdays.

Evans, a clerk in Chodorow's leather shop on 21 Mott street, was given a summons on Sunday for keeping the store open. The police officer making the arrest admitted under cross-examination by Herman Koenigsberg, attorney for the Alliance, that he had seen no actual sale made. The complaint was dismissed upon the grounds that the evidence was insufficient and that no prima facie case had been proved.

Koenigsberg brought out in the hearing that the defendant kept his store closed on Saturday and that no complaints were made by any of the residents in the neighborhood. The complaining officer testified that the arrest was made on a complaint received from some leather association. He did not disclose the name of the association.

Koenigsberg attempted to show that the complainant was the Metropolitan Leather and Findings Association, which, he charged, is less interested in seeing the Sabbath law observed than in bringing non-members into the association.

## Gruening Elevation Pleasing to Villard

### Editor Finds His Associate Ideally Fitted to Fill New Position

Oswald Garrison Villard, in a signed editorial in the issue of The Nation, out today, warmly greets the appointment of Dr. Ernest H. Gruening as head of the newly created Division of Territories and Island Possessions by President Roosevelt. Dr. Gruening has been a member of the Nation staff since 1920.

"It seems really too good to be true," says Mr. Villard, "that this important position has been given to one who is ideally fitted for it—and in saying this I do not think that I am biased by my years of editorial association with him on the Nation, and our personal friendship. In the first place, he is an excellent linguist, speaking French, German and Spanish. Next, his whole career would seem to have led right up to this post, since he has been specializing on the Latin American relations of the United States ever since he first joined the staff of the Nation in 1920."

Mr. Villard points out that no one else brought such persistence and fidelity to the study of the Caribbean situation and that he helped bring about a reversal of American policy toward Central and South America.

## Student Fraud Suspects Held For High Court

### Magistrate Raises Bail for Georgia Lawyer to \$2,500

Charged with defrauding by promising to gain Jewish students admission into medical schools, Beard John Dupree and Martin I. Phillips were held for Special Sessions by Magistrate Thomas Aurelio in Tombs Court yesterday. Bail for Dupree was increased from \$500 to \$2,500 on the request of Assistant District Attorney Maurice G. Wahl, who said he had evidence that Dupree practiced fraud in other counties.

Evidence was presented in court showing that Dupree told Phillips he could get two or three students into medical school each term, and that Phillips, on the basis of Dupree's statement, made an agreement with Louis Vogel, a clothing manufacturer, to get his son Joseph into New York University Medical College, although the boy did not have proper qualifications. Wahl exhibited Dupree's business card, which stated he is a member of the New York bar. Dupree admitted on the stand that he is a member of the Georgia but not of the New York bar.

Dupree denied saying he could get anybody into medical school, and claimed he tried to get Vogel into N. Y. U. only at the request of Phillips.

Others who testified were: Professor W. C. McTavish, N. Y. U. professor of chemistry, Louis Vogel and Harry Lichtblau, the officer who arrested the defendants.

## Degener Finds No Bias in Reich, Says Nazis Buy From Palestine

To the strains of a German band, the Hamburg-American liner Stuttgart docked yesterday with Dr. Albert Degener, secretary of the German-American Board of Trade on board, returning from Berlin.

Dr. Degener, ignoring the music, announced simultaneously that there is no, absolutely no, anti-Jewish discrimination in Germany and also that "the German-Jewish situation is moderating."

In his two months' stay in the Reich, Dr. Degener declared, he had visited Jewish shops in Berlin and had made purchases from Jews. He had been unable to detect any sign of ostracism of Jews from the business life of Germany. In his own words, he "had found nothing."

Referring to a report in his hand, Dr. Degener, who as secretary of German-American Commerce, Inc., had received it in his official capacity from a Hamburg exporting firm, asserted that Germany bought twenty-two percent of the entire Palestine orange exports last year.

### Bad Business, the Boycott

"This boycott business," he said, "is foolish. Jews and Germans ought to get together. Business relations would be improved."

Dr. Degener referred several times to his Jewish friends in Germany and pointed out a Jew who only several weeks ago acted for the German Foreign Office in reparations negotiations with England. He was unable to remember his name. When asked if the reporter might look at the report of the orange importations from Palestine to Germany, Dr. Degener said that the report was confidential.

Also returning on the Stuttgart, from a three weeks' stay in Germany, Ellery Sedgwick Jr., son of the editor of The Atlantic Monthly, declared that while in Munich just prior to the attempted Putsch in Vienna, he had noticed great camps, containing thousands of uniformed and armed Nazis waiting the signal to cross the border into Austria. Traveling about with the American consul in Munich, Sedgwick estimated that there must have been about 40,000 men prepared to invade Austria, within the scope of his sight-seeing.

"German youth," he said, "is filled with the most intense kind

of nationalism. They are all ready to die for their country. Especially the young men in the universities. They would go to war for the Fatherland at the drop of a hat. Among the middle-aged there is less enthusiasm. They have seen war. They are afraid of Hitlerism. Nevertheless, the country was simply teeming with uniforms."

### Baptist Delegates Return

Other passengers included forty Baptist ministers returning from the congress of the Baptist World Alliance held in Berlin. Members of the ministerial group reported that the resolutions passed by the congress against racial animosity, interference with religious freedom and against war were voted on favorably by German delegates, or at worst, were not publicly objected to on the floor of the convention by them.

The Rev. Carl A. Daniel of Detroit declared, however, that German youth is being removed from the control of church organizations and enrolled in Nazi activities. A lapse into paganism is consequently feared by religious leaders.

## Christian Clergymen Condemn Nazi 'Pagans'

(Special to the J.D.B.) PHILADELPHIA, Aug. 22.—Christian clergymen here condemned the Nazi onslaught upon Christianity.

Dr. G. H. Bechtold, superintendent of the Lutheran Bureau, declared the Lutheran Church in Germany will fight Nazi "paganism" with all its power. In that fight the entire Lutheran Church in this country will give its full support, he said.

Dr. John A. MacCallum, pastor of the Walnut Street Presbyterian Church, said: "The Nazi 'religion' is a denial of religion. Hitler's campaign against the church is conclusive proof that Nazism is a menace to civilization."

tee, which is made up of representatives in every important city in the United States, has not endorsed and is not participating in the world conference, and that important organizations abroad, among them the Board of Jewish Deputies of England and the Alliance Israelite Universelle of France, have declined to send delegates to represent them. In the light of these facts, the conference cannot truthfully be described as representative of the opinion of Jews of the world or as expressing the viewpoint of Jewish citizens of the United States."

The World Jewish Conference at Geneva is indeed not representative of a united Jewish public opinion. The organization headed by Dr. Nahum Goldmann, while doing useful work in behalf of the Jewish people abroad, is no longer as representative as was the Committee of Jewish Delegations that functioned during the peace conference in Paris.

A number of Jewish leaders, without having received any mandate from the Jewish people, have gathered in Geneva and have discussed the burning questions affecting the Jewish people at this crucial moment. Some of these moulders of Jewish public opinion are very influential. Others represent only themselves and cannot be described as leaders. Still others have come to the World Jewish Conference merely because they happened to be in Europe at the time of the conference. There is no doubt that all are sincerely concerned about the plight of the Jewish people and are eager to devise ways and means of combating Nazism and the spread of anti-Nazism in other lands. The delegates have succeeded in attracting much attention to the deliberations of the conference. But the conference cannot be characterized as representative of all Israel.

The misleading and untruthful references to a Jewish "super-government" are extremely deplorable and harmful. Anti-Semites everywhere will point to these statements as a confirmation of the Jewish "super-government" outlined in the forged "Protocols of the Wise Men of Zion." No responsible Jewish leader has ever conceived such a scheme. No Jewish leader could indulge in such an absurdity without being repudiated by the Jewish people.

And yet, notwithstanding the unfortunate exaggerations regarding the Jewish "super-government" and the unrepresentative character of the conference from a democratic point of view, the presentation of Jewish loss of rights and the Jews' sufferings during this crisis has proved to be effective. The injustice to the Jewish people must be called to the attention of the civilized world vividly and truthfully so long as such injustice prevails. Co-ordinated efforts to win the cooperation of the civilized non-Jewish world to combat anti-Jewish hate and persecutions must be organized. Failure on the part of the Jewish people to unite and work for their self-preservation would merit the contempt of their Christian neighbors. But the organization must be representative, embracing all elements of the Jewish people. Unless it is recognized as representative and authoritative, an organization speaking in behalf of the Jewish people, however eloquently and powerfully and intelligently, will fail to attain the desired goal.

## Nazis Forged 'Plot' Papers, Judge Holds

130-Page Judgment in  
South African Case  
Reveals Perjury

(Jewish Telegraphic Agency)  
JOHANNESBURG, South Africa, Aug. 22. — Judge-President Sir Thomas Graham and Justice Gutsche, who heard the defamation suit brought by the Rev. Abraham Levy against the three leaders of the anti-Semitic Grey Shirt organization, were convinced that the documents alleged to show the existence of a Jewish world plot were compiled by a member or members of the Grey Shirts, the 130-page judgment reveals.

The court also held that the story told by Harry Victor Inch, Grey Shirt leader, who alleged to have stolen the document from the Port Elizabeth Synagogue, was "recklessly false."

The judgment also declared that the court was satisfied that the "documents were never found in the synagogue." Judge-President Graham also stated that "it was difficult to accept the evidence of Beamish seriously, since he holds an exaggerated view of his own importance."

A man described as Captain Beamish, editor of the London anti-Semitic paper, The Patriot, testified at the trial, affirming the truth of the notorious "Protocols of the Elders of Zion," and the truth of the paper alleged to have been stolen from the synagogue. He also claimed that he was a personal friend of Adolf Hitler and of every anti-Semite of any importance, stating that he instructed all of them in anti-Semitism. The London Patriot denied that Beamish was ever editor of the paper and disclaimed all knowledge of him.

The defamation case, which assumed the proportions of a cause celebre, ended in a complete rout for the Grey Shirts. Judgement against the three totalling £1,775 (approximately \$8,900) were awarded the Rev. Levy. Inch and his codefendants, Johannes Strauss von Moltke and David Hermannus Olivier, had been sued for £2,000 each.

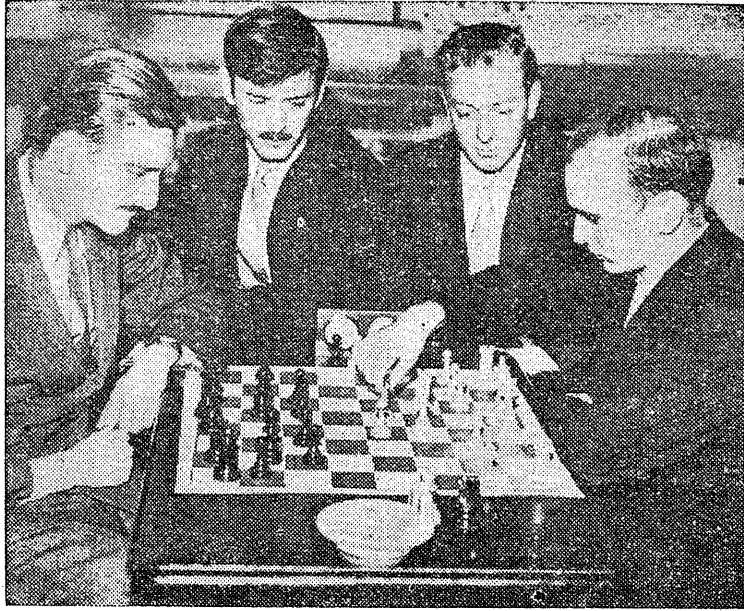
### Judge Steuer Rules Kross Needn't 'Take It'

## Writer Likens Press Attacks On Hitler to War-Time Stories

Newspaper anti-Hitlerism is a mere psychosis, according to George Weiss Jr., who writes on "The Newest Psychosis" in the current issue of the American Spectator.

"The recrudescence of Germanophobia," he writes, "differs from the war-time hysteria only in degree, not in nature, and it is far more prevalent among intellectuals than in any other stratum."

"The old familiar signs turn up with astonishing regularity—especially in the metropolitan press. The New York Post and its distant contemporary, the Mirror, carry the color of their prejudice right into their two-inch headlines. The Times lines up its galaxy of foreign correspondents to demonstrate with wearisome iteration that Fascism a l'allemande is a reversion to Teutonic barbarism, that the average German is a dolt who loves banners and torchlight parades and that his woman has been condemned to a dull life in which obstetrics supplants self-expression."

### "Free Pumpenheimer"

"And count the day lost whose low descending sun doesn't see in its New York journalistic namesake some brief editorial effecting a tie-up between the prevalence of hay-fever and the brutality of the Nazi philosophy."

"Strangest of all, however, is the zealous interest which many Americans are taking in the obscure phases of contemporary German life. For a people whose ignorance of foreign affairs is proverbial, we have developed an amazing sensitivity as regards the injustices perpetrated upon our German cousins. At first the Communists seize the watchword. Perhaps it is, 'Free Pumpenheimer.' The movement spreads to the cloak-and-suiters and the Arbeiter Rings. Then it commences to seep into the more elite circles. The Socialists take it up, and the liberals."

### "All Join in Fight"

"An American League to Free Pumpenheimer" blossoms into existence. The Christian clergy and the Jewish rabbinate are impelled to make statements about the unfortunate Pumpenheimer, who by now represents the crystallization of the spirit of the German workers, or something similar. Mass meetings are held; funds are raised.

"If Pumpenheimer later should renounce his beliefs and exchange Marx for Hitler, the rain would descend and the floods come, and within twenty-four hour the erstwhile martyr would be dragged into the vile dust whence he had

sprung, his cousin living in Philadelphia would require a police escort, and Americans would learn from their liberal mentors that the Magna Charta could not survive, unless Pumpenheimerism was squelched."

At the same time the League published an open letter to the French government asking:

1. Why were all the local authorities of Constantine absent from the city during the massacre?
2. Why were not troops immediately dispatched to the scene of the riot to check the outbreak?
3. Why did the censorship prevent news of the riot from reaching Paris?

Yesterday the Algerian Jewish Youth Association accused the Algerian government of having made no attempt to stop the pogrom and of having failed to issue orders to the police to do so. The association demanded that the French government institute a sweeping investigation of the riots and punish the officials guilty of laxity.

Populaire, leading French Socialist daily, bluntly accused Governor General Jules Carde and other Algerian officials of being responsible for the massacre in Constantine and also accused the French government of having suppressed news of the riot for several days and of having deliberately minimized the death toll.

## Tunisia Guards Against Outbreaks; Agitation Grows

TUNIS, Aug. 22. — Police and military forces throughout Tunisia today adopted extraordinary precautions against anti-Semitic outbreaks. Agitation against the Jews in Tunisia has grown enormously since the Algerian pogrom, causing a panic among the Jews and arousing fears of a massacre similar to the one in Constantine.

# Supporters of 'Night of Stars' Promise to Sell 45,000 Tickets

## Dr. Lowenstein Thanks Ruppert for Gift of Stadium

Pledging themselves to sell at least 45,000 tickets for the theatrical presentation being sponsored by the amusement division of the United Jewish Appeal at the Yankee Stadium on September 20 to aid German Jewish refugees, representative New York business men offered whole-hearted support to the project at a luncheon yesterday at the Hotel Commodore in honor of Michael Schaap, chairman of the Trades Council of the Appeal.

Dr. G. A. Lowenstein, chairman of the business men's committee for the "Night of Stars" production, paid tribute to Col. Jacob Ruppert for contributing use of the Stadium for the occasion. He disclosed that Ruppert had refused the use of the Stadium to a local Nazi group, the Steel Helmets, despite the fact that the baseball magnate is of "German stock," as he declared.

It was further announced that Mr. Schaap's group had collected \$250,000, or about forty per cent of the total raised in New York.

The show will conclude the drive for funds in New York City. Samuel Caplan, assistant director of the project, announced that "everybody in the amusement field who is worth while will participate in the spectacle," including George Jessel, Eddie Cantor and Al Jolson.

Morris Rothenberg, co-chairman of the United Jewish Appeal and president of the Zionist Organization of America, praised the work of Mr. Schaap in the drive for funds, and urged those present to follow his example in the sale of tickets.

Felix M. Warburg, national chairman of the U. J. A., who was unable to attend the luncheon, sent a message to Mr. Schaap expressing appreciation for "the splendid work you are doing."

## Fels Backs Fight Against Pneumonia

### Kolmer, Paralysis Vaccine Founder, Announces New Research Fund

(Special to the J.D.B.)

PHILADELPHIA, Aug. 22.—Substantial gifts from Samuel S. Fels, Philadelphia philanthropist, are financing efforts to perfect an anti-pneumonia serum.

Dr. John A. Kolmer, Temple University pathologist, made this revelation yesterday as he announced that his staff of research workers is beginning a three-months' test of a new serum.

The donation by Fels, he said, is ample to guarantee completion of the experiments, although the exact amount remains a secret.

Dr. Kolmer last week announced the discovery of an infantile paralysis vaccine. He is now making plans for the inoculation of twenty children with the serum to prove its immunization powers.

Although refusing to reveal the extent of his laboratory work with the pneumonia vaccine, Dr. Kolmer indicated that it had been used successfully upon monkeys, dogs and rabbits.

## N. J. Veterans to Combat Hitler Youth Band Menace to Citizens

(Special to the J.D.B.)

PATERSON, N. J., Aug. 22.—Robert J. McDermott, a local lawyer, has been retained by the Veterans of Foreign Wars to combat the Nazi movement which has sprung up strongly in Mountainview, a suburb. The appointment followed attacks on Paterson war veterans by fifteen Nazi-clad youths wearing the swastika on their shoulders.

So strong has been the influence of the Hitler followers that it has been practically impossible to make Mountainview citizens testify in court. In one case a wounded veteran is reported to have been threatened by the Nazis because he fought against Germany in the war.

The Nazis have established a fort-like structure on the Pipeline, in Mountainview. This house, reputedly owned by a man who returned to Germany and now occupied by his two sons, has been furnished with turrets. Skulls of animals decorate the front of the house. Several police dogs furnish protection. In one attack case when police interfered, the dogs ripped a policeman's uniform.

## Italy Pledges Aid to Austria Against Nazis

### Mussolini Talks With Schuschnigg, Who Slights Zita

(Jewish Telegraphic Agency)

LONDON, Aug. 22.—Premier Benito Mussolini today reaffirmed his determination to preserve the independence of Austria from the encroachments of the Nazis in a conversation with the Austrian Chancellor, Kurt Schuschnigg, it was reported here.

Traveling with a military escort, Schuschnigg stopped off at Rome on the way to the French Riviera, where he will spend a vacation.

Rumors of a meeting between the Austrian Chancellor and the former Empress Zita to discuss restoration of the monarchy were dispelled when Schuschnigg sped through Viareggio, where the former Empress is staying, without stopping to see her.

### To Fight Anschluss

Interviewed at his villa at Nice, Chancellor Schuschnigg declared his intention of fighting to the end against Anschluss with Germany.

"I follow in the footsteps of my predecessor, Chancellor Dollfuss," he said. "I am of the firm opinion that Germany has no right to mix herself in Austria's internal problems."

## Poland Seizes Daily For Attack on Hitler

(Jewish Telegraphic Agency)

WARSAW, Aug. 22.—Die Naje Volkszeitung, Yiddish Socialist daily, was confiscated by the Polish authorities today for having attacked Chancellor Adolf Hitler editorially.

Yiddish language papers in Warsaw were warned recently by the Polish censor not to criticize the Nazi regime and its leaders, on pain of confiscation. During the visit of Propaganda Minister Paul Joseph Goebbels to Warsaw, these newspapers frequently appeared with gaping holes in their pages, where articles striking at the Nazi cabinet member had been ordered removed.

## The Bulletin's Day Book

The fact that the writer of this column has two brothers who are dentists has positively not influenced him in making the suggestions that will appear somewhere in the course of today's Day Book.

One of the interesting stories of the week concerns the case of a Mount Gilead, Ohio, citizen who is afflicted with a strange malady known as encephalitis. The particular type of this mental disease with which young Donald Campbell is suffering is characterized by one outstanding symptom. Campbell talks incessantly, against his will. He is literally "talking himself to death." At least he appeared to be talking himself into an early grave in the opinion of many physicians. But the other day a glimmer of hope appeared.

If that doesn't relieve the pressure on the lower part of your anti-Semitic brain, and stop that irrational flow of words which is slowly wasting you away into a mere shadow of yourself, then the dentist probably pulled the wrong ivories. Sit down again, Sir Oswald. It won't take but a moment. Close your eyes. Open your mouth. Wider. There! That didn't hurt a bit, did it? Sir Oswald, here's your canine. Just a moment, now, and I'll have that bicuspid out for you.

**Representative Louis T. McFadden of Pennsylvania.** Congressman, at last you have been discovered. Do you realize that at the rate you are going, Louis, you'll talk yourself into an "Aryan" heaven in less time than it takes to purge seventy-seven Nazis? Louis, for the sake of the America that needs you so desperately in her hour of crisis; for the sake of the printers who are employed on the Congressional Record and who would surely be made jobless if you were to kick the bucket; for the sake of the Pelleys, the Gissels, the Christians and all those others who look to you for leadership, please do not delay. Go see your dentist at once. Have him extract your wisdom teeth. We can tell from here that they're decaying badly. If you don't know a good dentist, we'll gladly introduce you to our brothers.

**Professor Alexander Cuza of Rumania.** Somehow or another, Professor, you have managed to escape the wrath and the satire of the Day Bookers. But, having escaped thus far, this writer has no desire to impale you on his shafts. Rather, he has nothing but your best interests at heart. After all, Cuza old socks, Rumania without an anti-Semite would be like salami without bicarbonate of soda. Wouldn't it? And since we can't eat salami without the bicarb, no more can we envision Rumania without her Cuza. Therefore, since you are obviously in such dire

straits—or don't you think talking yourself to death isn't dire enough—we wish to extend you a helping hand. In the hand, you will note, is a pair of chromium plated forceps. Open wide, Professor. There, that's the old geezer. One, two, button your shoe, and it's out. My, my, what a nasty old incisor that was. See that white spot on the tip of the root there? That's an abscess. One more day and you would have been a gone goose. How Rumania would have wept. How the world would have mourned your passing. And what a fine funeral you would have had, professor. But you wouldn't have enjoyed it one bit, professor. That extraction will cost you five dollars, please. On the cuff, did you say, professor?

And, of course, the most prominent sufferers of them all: Hitler, Goering, Goebbels. Imagine what relief these three poor lads could get if they but took our advice and consulted a Zahnarzt.

But, judging from the aggravated state of their case, brought on by long neglect, it is doubtful whether removing one or two or three molars would be of material aid in effecting a cure. It is entirely probable that in the case of Hitler, Goering and Goebbels, a major operation is indicated. X-rays show that each of the three has a full set of upper and lower impacted teeth. Only their strong pagan constitutions have enabled them, evidently, to pull through one of the worst attacks of encephalitis any mortal ever withstood.

To overcome such fargone cases of the talking sickness, drastic measures will have to be taken. Doctors when they're out, fashion for their mouths special sets of plates that will lock their jaws forever. For it is seriously to be feared that with them the encephalitis has taken such root that not even removing all the teeth will have the desired effect of stopping their insensate prattle.

### Committee to Probe Plight of Reich Jews Sought by N. J. Paper

**PASSAIC, N. J., Aug. 22.**—The Passaic Herald-News, commenting editorially on the Berlin story concerning the support of Hitler in the recent plebiscite by a Jewish group, advocates the formation of a committee to investigate the Jewish situation in Germany today.

"We suggest that a committee of eminent Jewish citizens, in whom everybody can repose the utmost confidence, be sent at once to Germany to learn the exact truth and report back to us. It would be as well if there were included several Americans who are not Jews, not because we would distrust the report of an all-Jewish committee, but because the presence of non-Jews on the committee would tend to intensify American confidence in the committee's report."

# The Human Touch

## The Clanging of Brass

EARLY one morning this week I was standing at the southwest corner of Twenty-third street and Second avenue, waiting for the bus that takes me to the office, and thinking of nothing. My mind was in that pleasant daze which it achieves rarely enough to be news. I wasn't even thinking of the subject matter of my next column. And while I was standing there, with my mind so pleasantly empty of all thoughts and concerns, an automobile—not the bus I was waiting for—halted and a pleasant young woman poked out her head and asked: "Can you tell us where the brass shops are, Mister?"

Thus rudely jostled, I asked, querulously, "Brass shops?" as if brass shops were the last thing I could be expected to think of, as indeed they were. Had the car been filled with old men wearing iron grey beards and women with scheitels beneath their shawls, I would have guessed at once that they mean shops somewhere on the East Side. But this car was filled with blonde and bland young women, dressed neatly but not gaudily, four or five of them, looking like graduates from some Middle Western college having a cultural spree in New York. If my young questioner had asked the way to the Aquarium or Grant's Tomb I would have been less puzzled. For the rude shaking-up they gave my state of mind they might just as well have asked me where they could find a good kosher delicatessen, which question I was asked on Fifth avenue more than a year ago by a southbound auto-load of out-of-town Jews.

## See the Light

After I said "brass shops?" thus querulously I gained grasp of the simple situation. They meant the brass shops on Allen street and perhaps among those Middle Western girls there was a bride who was going to bring home some brass fixings for the house, or a curio-seeker, or a brass collector, someone who, in the Middle, or Far West had been told of New York's brass shops on the East Side, and was given no more specific direction than that.

It wasn't much to ask of me, and yet I failed those strangers. For the thirty-five seconds during which I was trying to orient myself I failed to think of Allen street in relation to brass shops and to relate Allen street to Twenty-third street and Second avenue. But I did not fail them completely. I directed them to ride down Second avenue until they reached First street, at which point, I assured them, someone would be sure to put them on the right road. It was only when I saw the car speeding away and my bus approaching that the lost name of Allen street came to mind and then I visualized Allen street and its brass shops as south of Houston and east of Eldridge. I consoled myself for my dereliction by pointing out to myself that I had brought them at least twenty-three blocks closer to their goal and by the reflection that had they struck any one of the five hundred other denizens of the Twenty-third street sector, the auto-load of brass shop seekers would have been completely misdirected, if directed at all.

It peeved me that I couldn't

think of Allen street right off, and you needn't bother to give me any of your Freudian explanations because I knew them. Allen street was the first street in the New World in which I lived when, as a mite of four or five, I came off the boat. Yes, I too was once a mite. But between the comparatively narrow space separating Allen from the extension of Chrystie street that is Second avenue have intruded East Bronx and West Bronx, Harlem and Fifth avenue, Oklahoma and Europe and many points in between. And that is why I could not think of Allen street when the young female Nordic said "brass shops" to me.

## I Also Bought Brass

But it wasn't because I had lived on Allen street in my childhood and had even attended Cheder there that I should have answered "Allen street" when someone asked "brass shops?" When we moved off Allen street and onto Norfolk or Suffolk street, which was our second residence in the New World, I was utterly innocent of the knowledge of brass shops, on Allen street, or anywhere else.

I should have made the connection between the two ideas because, when I returned to Allen street as a more or less grown person, some time in 1921, I returned to it to buy brass in its brass shops. We spent a morning walking up and down flights of stoop stairs, looking at and selecting objects of brass. I took almost no part in the selecting, or in the rejecting, in the dickering or in the final purchases, when those purchases were made, for what is one to do when one's wife has impeccable taste and knows more about bargaining than you can learn in a month of Sundays? And we carried off from Allen street that day two sturdy candlesticks of a design most original and two brass flower pots, of which, after more than a decade, we still possess the candlesticks and one of the pots. I have seen the candlesticks a thousand times and never once thought of Allen street in connection with them, but now, after that strange query about brass shops, Allen street will be like an invisible tag upon them.

Next time, I promise you, no auto-load or hay wagon-load or Fifth avenue bus-load of out-of-town curio seekers will find me at a loss to do the honors of the brass shop district. But in all likelihood the next time any one asks me for the way to some point of interest, that point of interest will be the nearest airport, or where

### Newark Woman Admits Subsidies for Nazi Cause

NEWARK, N. J., Aug. 22.—Mrs. Madge Peer, who resides at the Hotel Douglas here and who claims to be of American Revolutionary stock, admitted today that she had sent a \$25 contribution to the Nazi Camp Wille und Macht at Bridgetown.

"You may also be interested to know," she smirked, "that I send \$100 every Christmas to Adolf Hitler. No, I have never met the man, but I believe he has saved Germany from 'Jewish Communism,' and deserves support for that reason."

Mrs. Peer believes the camp is a "fine thing to combat radical and subversive movements which threaten to undermine our government."

"I would send my own son there if I had one that age," she said.

### American Legion Demands Probe of Hitlerite Camp

SOMERSET, N. J., Aug. 22.—Somerset County's American Legion joined with its brother group in Middlesex County in a demand today for an immediate and sweeping investigation of Camp Wille und Macht, near Bridgetown, despite the recent assurance given by camp leaders that the youth colony will be disbanded during the coming week.

be strictly surveyed in accordance with the Jewish boycott.

Conference committees are still in session, working out the resolution to be presented tomorrow night at the concluding session.

In the meanwhile, the conference political committee adopted a resolution declaring that the conference had established a fact that the Constantine pogrom was not caused by race hatred but by a criminal plot. The French delegation to the conference was authorized to ask the French government to carry out a complete investigation of the pogrom and to punish all those guilty. The conference expressed complete confidence in French justice.

The conference today replied to Samuel Untermyer's cablegram yesterday in which he asked the conference to treat the boycott as a broad moral issue affecting the whole world, not the Jews alone. The text of the reply follows:

"The conference agrees with you that the boycott is not chiefly Jewish, but is a moral and material self-defense of civilization against the Nazi forces of darkness and enslavement. We pledge ourselves together with all freedom-enjoying and justice-loving peoples and faiths, to stand by the boycott and all other lawful means against Hitlerism."

"The conference earnestly hopes the American Boycott League, the American Federation of Labor and the American Jewish Congress will continue in full cooperation."

### Nazis Plaster Posters Against Jews on Buildings

GENEVA, Aug. 22.—Local Nazis last night utilized the meeting here of the World Jewish Conference to draw attention to their anti-Semitic campaign.

They plastered walls of buildings with huge posters bearing the slogan, "Beware of the Jews."

## Hitler Keeps House With Sister While Aides Work Out on 'Noes'

BERLIN, Aug. 22.—While Reichsfuehrer Adolf Hitler was on a holiday at his sister's home in Obersalzberg today, his brown-shirted storm troops undertook to "convert to Nazi ideals" the four and a quarter million persons who dared last Sunday to vote against him.

Meanwhile, Rudolf Hess, Minister Without Portfolio, warned Nazis guilty of the "mutiny" of taking grievances to public authorities instead of to party headquarters that they invite expulsion from Nazi ranks.

Hitler Infallible, Says Goering  
Premier Hermann Wilhelm Goering of Prussia was quoted by the Allgemeine Zeitung as saying: "Before our leader, Adolf Hitler, all criticism subsides. If Der Fuehrer issues orders, everyone must obey implicitly, no matter who he is."

and have refused to endorse the conference was issued by Morris Waldman, secretary of the organization. Mr. Waldman asked that the committee's stand be made clear in fairness "to over 4,000,000 Jews in America."

At the same time Senator Alfred M. Cohen, international president of the B'nai B'rith, declared in a telegram to the Jewish Daily Bulletin that "the B'nai B'rith is not represented at the conference now being held in Geneva and will not pass judgment upon the proposals of the conference until it has an authentic report of the proceedings."

Mr. Waldman's statement follows:

"In the interest of accuracy and in fairness to over 4,000,000 Jews in America, we call your attention to the following: In view of the erroneous headlines and statements contained in some press reports of a conference of Jews now being held in Geneva, attention is drawn to the fact that the American Jewish Committee, which is made up of representatives in every important city in the United States, has not endorsed and is not participating in the World Conference, and that important organizations abroad, among them the Board of Jewish Deputies of England and the Alliance Israelite Universelle of France, have advised against the holding of such a conference and have declined to send delegates to represent them."

"In the light of these facts, the conference cannot be truthfully described as representative of the

visiting labor elements in the industrial sections of Berlin in furtherance of the "conversion" campaign, the storm troops encountered open resistance as workingmen used their fists to good advantage.

This opposition was interpreted today by well informed observers as indicative of a definite loss of prestige by the brown shirts since the Roehm revolt of June 30.

### Catholics Strongly 'No'

Fully 2,000,000 votes were cast against Hitler in Catholic districts, it was learned today.

August Hoppe, a Nazi youth leader, was denounced by the Official Catholic Bulletin for urging the youth "to summon all forces for a final battle against Christianity." The publication demanded to know how Hoppe's statement could be reconciled with the official Nazi pledge to uphold Christianity.

## Court Refuses Injunction to 'Red' Painters

Brotherhood Upheld by Rosenman in Local 499 Expulsion

Justice Samuel Irving Rosenman, of the New York State Supreme Court, yesterday refused to grant an injunction to Local 499, which would force the Brotherhood of Painters, Paper-Hangers and Decorators to reinstate the left-wing organization after its expulsion from the parent body several weeks ago. The local was expelled when the Brotherhood claimed that its members were carrying on activities which were detrimental to the present painters' strike.

At a late hour yesterday afternoon officials of the Brotherhood spoke vaguely about a possible meeting tonight between them and the Association of Master Painters and Decorators to consider arbitration.

The ultimatum which the union offered Monday night to the association ends this morning. The resolution, which declares that if the union's demands are not met by today the employers' organization will no longer be recognized, and striking painters will deal directly with individual employers, has not been taken seriously by the association.

The organization is still considering the offer of arbitration which Ben Golden, of the Regional Labor Board, gave Tuesday afternoon.

## Can't Confirm Report U. S. Will Participate In Berlin Olympics

BERLIN, Aug. 22.—Efforts to confirm a report that Daniel Ferris, secretary of the American Athletic Union, had said the United States was certain to take part in the 1936 Olympics were unsuccessful here tonight.

Ferris was quoted as having said:

"The German invitation to participate is sure to be accepted. If we had voted on it at our last meeting American participation would have been decided."

## Radzimin Rebbe Left Good-Sized Fortune; Relatives Seek Cuts

WARSAW, Aug. 23.—Rabbi Aaron Menachem Guterman, the "Radziminer rebbe," who died at Radzimin last Monday from pneumonia, left a fortune estimated at 500,000 zloty (about \$96,000), the Jewish press here reported today.

The famous Chassidic rabbi died childless. Now, according to the local press, scores of his closest relatives have secretly assembled at Radzimin to distribute the fortune he amassed among themselves.

## Yeshiva Graduates Become Lawyers, Doctors, Teachers

A majority of the fifty recent graduates of Yeshiva College have become teachers and social workers or entered law or medical schools, it was announced yesterday. A dozen of these men who received bachelor's degrees from the College are now continuing their rabbinical studies at the institution.

## Advocated Free Education

Through the efforts of Paul Tenczer, Hungarian Jewish author, free tuition was given in the public schools of Budapest.
