## NAZIS DEMAND CHARTER

### Riot Arouses Rector's Ire At Krakow U.

#### Threatens to Disband Classes Following Outbreak

(Jewish Telegraphic Agency)  
KRAKOW, Poland, Nov. 19.—The rector of the University of Krakow today threatened to close the university as the result of another anti-Semitic disturbance, which occurred there today.

University employees were compelled to use fire hoses to drive out anti-Semitic students who set up a din in the lecture rooms of the various schools, demanding that the Jewish students be forced to leave at once.

Declaring that many of the trouble makers were not students at all, university authorities ordered that all students entering the lecture halls be compelled to produce their documents.

Jewish students at the university were brutally attacked last week by anti-Jewish student groups. Many were injured in the fighting which began last Monday and was continued on Wednesday.

The rector of the school denounced "the brutal attacks on innocent, defenseless Jewish students." He threatened severe disciplinary action against the aggressors.

### New Nazi Party Formed in Poland

WARSAW, Nov. 19.—A new Polish Nazi party, formed here today, will be known as the "Independent Socialist Labor Party." The group was formed by the same leaders who organized the Polish Nazi Labor Party, dissolved by the government early in 1934 after a short existence.

The Polish Nazis in their manifesto declare that Polish anti-Semitism of the National Democrats and other anti-Jewish groups is not strong enough and that the complete Hitler program must be adopted in order to solve the Jewish question. They call for the complete "Aryanization" of Poland and the exclusion of Jews from all government posts. They also demand that Jews' citizenship rights be withdrawn.

### Latvian Premier Greets Riga Jews in Hebrew

RIGA, Nov. 19.—A greeting in Hebrew, the first of its kind ever sent by a premier of the country, was dispatched today by Premier Karlis Ulmanis of Latvia to the congregation of the oldest Latvian synagogue, in the city of Mitau, Latvia, celebrating its 150th anniversary today.

### Only Jewish Rail Chef In Business 25 Years

MINNEAPOLIS, Nov. 19.—Jake Rubinstein, America's only Jewish railroad chef, is celebrating his twenty-fifth year as a food dispenser. He now occupies the galley on "The Viking," Chicago, Northwestern and Omaha flyer, traveling between Minneapolis and Chicago.

Rubinstein has served innumerable celebrities, including Palestine's High Commissioner, Sir Herbert Samuel, Admiral Cary T. Grayson, Andrew Carnegie, the Mayo Brothers and Bernard Baruch.

### J. N. F. Obtains \$1,400,000 in Current Year

#### Funds Most Successful Period; Britain Gives More Than U. S.

JERUSALEM, Nov. 19.—The largest sum ever obtained by the Jewish National Fund was exceeded this year, during which over \$1,400,000 was collected for the fund, it was announced today.

In making this announcement the headquarters of the Fund, however, emphasized that so powerful a community as American Jewry still has failed to raise as much as British Jewry, which comprises only 300,000 persons. The highest sum raised in any one country—\$215,000—while creditable to Great Britain and Ireland, is not a figure sufficiently imposing to hold first place among lands contributing to a nation's fund, the statement says.

### Swastika Party Set for Praha

#### Two Professors Head New Czechoslovak Political Clique

PRAHA, Nov. 19.—A Nazi party under the name of Narodni Front was officially formed here today. It will pursue the same policies as the Nazis in Germany.

The new party has proclaimed anti-Semitism as a part of its program and has adopted the swastika as its party symbol. The party is headed by Professors Mares and Nicolu of the Czechoslovakian university. It will participate in the forthcoming national elections in the country.

The Czechoslovakian press complains today that the streets of Praha are flooded with anti-Semitic leaflets. "It is the first time that our Czechoslovakian doctors are invited from the streets of the city to engage in anti-Jewish actions imitating our neighbors," the press comments today.

### McGoldrick Aide Heads Fascist Body

#### Prout Tries to Wriggle Out of Charge of Anti-Semitism

The American Concentration Inc., Fascist anti-Semitic organization, which was organized more than a year ago emerged into the open yesterday with a program calling for a fight against the "Jewish Communists."

Major John T. Prout, confidential clerk to Comptroller Joseph P. McGoldrick, is commander-in-chief, or "Consul" of the new Fascist organization. He was busy yesterday explaining that he was acting entirely on his own responsibility and that his connection with the revived Fascist outfit had nothing to do with the Comptroller.

In an interview with the Jewish Daily Bulletin Major Prout explained that the group he now heads was "purely devoted to fighting Communism in the United States, but it is my impression that Jews predominate in the Communist movement." He denied that he personally was biased toward any race adding "some of my best friends are Jewish."

### Nazis Disavow Schacht Edict Favoring Jews

#### Party Organ Nullifies Ban on Molesting Yule Trading

BERLIN, Nov. 19.—Counteracting the order issued last Saturday by Dr. Hjalmer Schacht, economic dictator of Germany, not to interfere with Jewish business firms in trading with Christmas gifts and novelties, the Voelkischer Beobachter, official organ of the Nazi party, came out today with a warning to party members not to take this order seriously.

"The order of Dr. Schacht has nothing to do with the orders issued by the National Socialist party and the organizations affiliated to abstain from patronizing Jewish enterprises," the newspaper which is owned by Adolf Hitler, declared.

The warning of the Voelkischer Beobachter is published side by side with the text of Dr. Schacht's order. It is given in heavy type with the deliberate aim to nullify the effect of Dr. Schacht's order and to make clear to members of the Nazi party that it will be held against them if they will be seen shopping in Jewish stores.

### Il Duce Interested In Problems of Jews

ROME, Nov. 19.—Interest in acute Jewish problems in several countries was displayed by Premier Mussolini, it was disclosed today after a visit paid to Il Duce by Chief Rabbi Dr. Angelo Sacerdoti of Italy and Dr. Nahum Goldmann of the Committee of Jewish Delegations.

Mussolini was especially interested in Jewish minority rights in those countries where international peace treaties provide for such guarantees.

### Arab Thieves Fell Watchman On J. N. F. Land

#### Wounded Man Held for Slaying One of Attackers

JERUSALEM, Nov. 19.—Solomon Jacobson, eighteen-year-old watchman patrolling property belonging to the Jewish National Fund (Keren Kayemeth) was badly injured today in attempting to prevent the theft of stones from a quarry owned by the Jewish people.

Jacobson has been placed under arrest by government police on charges growing out of the incident.

When a group of Arabs descended upon the quarry on Jacobson's beat in the Haifa Bay area with the intention of stealing some of the stone lying about, Jacobson attempted to stop them. The Arabs thereupon attacked the young Jewish watchman, using the stones as missiles. In the melee Jacobson was seriously injured and one Arab was killed.

### Seek Division Of Austro-Jews

#### Orthodox Group Asks Regime for Separate Community

VIENNA, Nov. 19.—The creation of a separate orthodox Jewish community in Austria was suggested to the government today by a delegation of the extreme orthodox congregation of Vienna, known as the Schiff synagogue.

This suggestion aims to split the existing united Jewish community which is recognized by the government as the institution representing the Jewish interests. The delegation of the orthodox congregation which intervened with the Austrian government consisted of Jewish orthodox leaders who are supporting the present regime in Austria.

### Court Hears Their Appeal Here Today

#### Pro-Hitlerites Run for Cover on Many Frontiers

Perhaps the most important move in the battle of the pro-Hitler forces to retain their slipping hold on the sympathies of their followers will take place here this morning before Supreme Court Justice Edward J. McGoldrick when the Friends of New Germany will reopen its campaign to obtain a state charter.

Congressman Samuel Dickstein, vice-chairman of the Congressional committee to investigate Nazi and other un-American activities in the United States, who played a part in the successful effort to block a recent similar attempt, will appear in opposition to the petition again today.

One New York and two New Jersey attorneys will appear for the Friends. Dickstein intends to show that prestige which a state charter would give the movement would enable it to gain a foothold for Hitlerism in this country, under pretense of American patriotism.

Congressional Probe Today  
Dickstein also will preside at a closed hearing of the Congressional committee of which he is a member, in the Bar Association Building this afternoon. The session will be of unusual importance, he says, and promises that at least one of the witnesses will be "a man of national prominence, who will expose subversive efforts of major interest."

The executive hearing, the Congressman explained yesterday, is preparatory to an open examination of testimony, which he expects will get under way next Monday.

Walk-out on Zeitung  
Treachery on the part of local Nazi ringleaders was made apparent yesterday, when all doubt was dispelled that W. L. McLaughlin, whom prominent Jews saved from serving a year in prison for libeling former Magistrate Joseph Goldstein, has been left "holding the bag" by his erstwhile cronies.

McLaughlin, editor of the English supplement and part publisher of the Deutsche Zeitung, did a right-about-face rather than serve a prison term and agreed to alter the entire tenor of his publication, which in the past had been flagrantly anti-Semitic and pro-Hitler.

Yesterday the Jewish Daily Bulletin learned that every employee of the Deutsche Zeitung, with the exception of McLaughlin, has walked out. This includes the editorial, advertising and business staffs, comprising a total of fifteen persons.

# Clinchy Sees Anti-Semitism Checked

## Has Failed to Make Headway Here, Is Ministers' Conclusion

**Despite Pressure of Nazi Propaganda in U. S., Interfaith Leader Finds Racial Prejudice Hasn't Caught on; But Warns Career Is Not Yet Ended**

(Editor's Note: The following article by Dr. Clinchy concludes a chapter from his new book, "Ail in the Name of God," which in the author's own words is "a vigorous plea to end racial and religious prejudice." The first part of the chapter appeared yesterday. Dr. Clinchy, an ordained Presbyterian Minister, has since 1928 been director of the National Conference of Jews and Christians of which Newton D. About this time many thoughtful Jews acted on the assumption that a scientific diagnosis of anti-Semitism would be more valuable than moralizing on the subject. This led them to assert that, as the treatment for a malignant disease demands both restraints and action on the part of the victim of it, so the Jew suffering from anti-Semitism can do much to help himself. "Such a formula," said one Jew, "must necessitate a biting self-analysis among Jews, as a preliminary requisite." The willingness of forward-looking Christians to confess Christian faults in the relations between Christians and Jews, led to plain speaking by Jews about Jewish faults. The frank admission and straight dealing by Christian leaders of Christian prejudice and intolerance toward Jews, brought Jewish leaders to the point where they called for a study of Jewish prejudices against Christians, to be made by Jews.

The progress along these lines, however, was threatened by influences from Germany under Hitler. The reactionaries in Europe began to plant the seeds of hatred of the Jew upon the soil of economic misery, political chaos and general timidity and fear by the simple strategy of making the Jew a scapegoat for all the evils from which society suffers. In Germany, anti-Semitism was organized with the efficiency of a well-oiled machine. Adolf Hitler's National Socialist Party made its case chiefly around a mania against one per cent of Germany's population. The Nazi "Program for the Ages" had twenty-five points, of which seven planks were devoted to the humiliation and disenfranchisement of Jewish citizens. For the first time in the history of modern civilization anti-Semitism became an integral part of a state policy when Hitler came into power in 1933. During the ten years previous the Nazi campaigners initiated and executed a devastating attack on the Jews, using pamphlets, derisive songs, speeches and posters. Before the election of Hitler, potent newspapers had been headlining anti-Semitism for five years. To warm up the party, Hitler in his campaign declared, "We need spite, hatred, hatred and once more hatred." To stimulate this madness, which Hitler aroused in order to unify his followers in a consuming emotion, he wanted a common enemy upon which to focus it, and singled out the Jews. The Nazi anti-Semitic agitators drew the worst slander of Jews from the storehouse of historic Jew-baiting, and from current "Aryan" racial legends. They used the fictitious Protocols of the Elders of Zion to indict Jews as guilty of the Red Revolution. In another mood they damned the Jews for the diametrically opposite crime of exercising outrageous capitalistic power.

**Pastor Hits Hitlerism**  
"Hitler's anti-Semitic agitation," wrote a German Lutheran Chris-

tian pastor in 1932, "surpasses by far all past anti-Semitic propaganda and the immorality of the methods has increased in the same measure. By baiting, lying, slandering, forging, insinuating, in word and print, Die Nationalsozialistische Arbeiterpartei (The Nazi Party) overshadows all previous achievements at mass suggestion. The level of taste has sunk far below any human dignity."

The years of agitation, social ostracism, business boycott, and vocational discrimination by Nazis not only hurt the Jews, it coarsened the Germans who themselves were infected by the poisonous spirit that they exhibited. Obviously the campaign brought woe to the Jews; when any human being is mistreated and denied full rights as a man, he undergoes a psychological distortion. If tormentors belonging to the major groups think a Jew or Quaker or Negro or Oriental to be "peculiar" they should learn that persecution creates peculiarities. And it is obvious, too, that the Nazis suffered; the years of anti-Semitic talk, mulled over in mass meetings night after night by orators who combined the technique of Aimee Semple MacPherson with that of the Ku-Klux-Klan, made hooligan rowdies out of many storm-troopers. Their rough horseplay turned frequently into bullying parties for whippings with steel rods, and sadistic torturing of Jewish victims, even to the point of death.

### Resistance Here

A surprising aspect of this anti-Semitic parade, drummed up by Hitler in Germany, was the resistance to it in America. The Nazis exhibited missionary ambition in 1933, hoping to spread their doctrines and influence internationally. Nazi spokesmen lectured in the United States, Nazi drill masters introduced the goose step, and Nazi publicists scattered tons of printed matter, all with the anti-Semitic note in the refrain of their song. But anti-Semitism simply, did not catch on in the America of 1933.

To be sure, during this period, high-powered anti-Semitic organizers were active in this country. Not only did twenty-four anti-Semitic organizations emerge sponsored by friends of the Brown Shirts, but the Klan rode again in some communities. Whisperings went the rounds, "We need a Hitler in America." Moreover, Khaki Shirts, White Shirts and Silver Shirts appeared. Taking their cues from Hitler these outfits emphasized the dangers to the United States of "Jewish bankers" and "Jewish communists," adding a third warning against "the Jewish N.R.A." But the seed thus sown fell on stony ground. In 1934 the Silver Shirts went bankrupt in North Carolina, where their national headquarters were located. A few months earlier, failure to make headway closed their offices in Oklahoma where, twelve years before, the agents of the Ku-Klux-

Klan had successfully swept the State in a whirlwind campaign for members at ten dollars a man. In Southern California where Shirt organizers had solicited members from door-to-door, with an auto-Semitic appeal, the first flush of success in 1933 faded out in 1934, whereas the Utopians, a society with pronounced social passion free from group animosities, in the same year rolled upon a membership five times that of which the dying anti-Semites could boast.

### Depression a Factor

The industrial depression introduced by the financial crash of 1929 was accompanied, as earlier depressions have been, by an acute outbreak of racial and religious prejudice, but this was the first major depression during which such hysteria met with so little hospitality or support. While Nazis were duping their followers once more with summons to meet the depression with hatred, and setting one group against another, Americans, refusing to be fooled again, seemed to have the sense to realize that Protestants, Catholics and Jews were all in the same economic boat, and that all would float or sink together.

The career of anti-Semitism, however, is not yet ended. Anti-Semitism is a disease of the body politic whose course it is difficult to predict. We may believe that the disease is arrested; we cannot hope that it is cured. At any time it may break out again, perhaps at some new place, for the seeds of it are deeply embedded and widely spread. Let any portion of the social organism be subjected to unusual strain and the insidious malady is likely to appear once more. Like a convalescent patient, the American people will do well to guard their social health during the critical decade that is ahead, since, as thoughtful observers are aware, the adjustments in industrial and political economy that are already under way will provide occasions for a relapse into anti-Semitism. It is in seasons of stormy economic weather that chronic religious and racial prejudices are revived and exploited.

## Education Association Puts Rosalsky in Chair

Judge Otto Rosalsky is to be inducted as president of the Jewish Education Association at a dinner given by Abraham Gevirtz at his home, 145 Central Park West, this evening. Guests will include officers of the Jewish Education Association and the dinner committee of the Bar Mitzvah celebration scheduled for December 2 at the Waldorf-Astoria. Benjamin Leibel is chairman of the dinner committee.

## Judge Lewis Speaks at Boston Zionist Party

BOSTON, Mass., Nov. 19.—An appeal to the Jews of America to aid their co-religionists in Germany was issued here today by Judge William M. Lewis of Philadelphia before 2,000 persons attending a meeting of the New England Zionist Region. Colonel Benjamin Everts of Holyoke, president of the regional organization, presided.

## Report of New Zionist Coalition Denied by Paris Revisionists

PARIS, Nov. 19.—Reports that a coalitionary World Zionist Executive may be formed with Dr. Chaim Weizmann as president and Vladimir Jabotinsky as vice president, were denied today in an official statement issued by the headquarters of the Revisionist Executive here.

"There is not even the slightest possibility of such a coalition," the statement says.

Simultaneously, the Revisionist headquarters disclosed that the terms published in the Haolam,

official organ of the World Zionist Executive, with regard to a rapprochement between the Revisionists and the Zionist Executive, were not correct. The Haolam had stated that complete peace with the Revisionists was possible either if the Revisionist Party fully obeyed the discipline issued by the Zionist Executive or if the Revisionists seceded from the Zionist Organization, making it possible for the Zionist Organization, in the latter event, to enter into negotiations with the Revisionists from time to time whenever matters of common interest arise.

Mr. Jabotinsky is now in Paris holding consultations with the Executive of his party on further steps to be decided upon in connection with the pending negotiations with the World Zionist Executive.

## League Postpones Action on Petition

**Acts on Revisionist Plea for Time to Amplify Charges**

PARIS, Nov. 19.—A petition submitted to the Mandates Commission of the League of Nations by the Zionist Revisionist party with regard to a number of problems concerning immigration into Palestine will be considered at the June session of the Commission, it was announced here today by the Revisionist Executive.

The petition was to have been taken up by the Commission at its present session. It was postponed at the request of the Revisionists in order to enable the petitioner to submit documents required for the substantiation of the complaints made.

Rabbi Raphael M. Barishansky, opponent of the rabbinical poultry ban, was expelled yesterday from the Rabbinical Board, which met at the Beth Hamedresh Hagodol, Washington avenue and Claremont Parkway, at the behest of the Bronx Rabbinical Board.

Rabbi Barishansky last week flouted the rabbinical ban on unlabeled poultry and signed an agreement with the Live Poultry Institute of New York, wholesalers' organization, to supervise eleven Bronx wholesale markets without attachment of the metal leg-bands required by the Kashruth Association.

Judge Otto A. Rosalsky, whose decision establishing rabbinical supervision of poultry markets the Kashruth Association is trying to enforce, yesterday received a delegation of executives of Shochtim Union Local 440, organization of kosher slaughterers which is in opposition to the rabbinical ban.

The parley was held behind closed doors, but it was understood that Judge Rosalsky was trying to influence the shochtim to support the issur.

After the conference, the shochtim returned to their office and held a closed session of their own.

### Yemen Chief Rabbi Dies

(Jewish Telegraphic Agency) JERUSALEM, Nov. 19. — The death of Chief Rabbi Yehia Aviad of Yemen was reported here today. Rabbi Aviad was sixty-five.

## Planned Barter Pact Again Hit By Untermeyer

Secretary Hull Warned Proposal Will End in Utter Fiasco

Before sailing for London on Friday night to attend the world anti-Nazi boycott parley, Samuel Untermeyer, president of the Non-Sectarian Anti-Nazi League, wrote a letter to Secretary of State Cordell Hull again protesting the proposed trade agreement between the United States and Germany that calls for the exchange of 500,000 bales of United States cotton for German manufactured merchandise, it was revealed yesterday.

Untermeyer stated he realizes the importance to the cotton growers of marketing so substantial a part of their surplus crop, and said that were the deal "an outright sale, for cash or credit, to a responsible purchaser who keeps its bargains, its desirability would be beyond question." But since this is not the case, he said, the damage it would do to American manufacturers would more than offset the benefits gained by the cotton producers.

### Reb Samuel Dances Jig On His 106th Birthday

Wearied from the excitement of a birthday surprise party, Samuel Baron dozed fitfully at the Home of the Daughters of Jacob, 167th street and Findlay avenue, Bronx, yesterday, while he dreamed of the varied experiences which have been his lot during his 106 years.

Reb Samuel—the title is his as the Home's oldest resident—was born in Wilno, Lithuania, in 1828. A party in honor of his birthday was held Sunday afternoon at the Home, where he has lived for the past three years. The centenarian danced a jig to prove he is still spry and active.

## College Senior Denies Charge He Is Agitator

Magazine Called Youth Contact Man for Gulden's Society

Pelham St. George Bissell 3rd, a Columbia University senior, denied that he is an anti-Semite or that he is connected with any anti-Semitic organization in an interview printed yesterday in the Spectator, Columbia University student daily. Bissell was charged by John L. Spivak, in an article in the current issue of the New Masses, with being a "special contact man" on the campus for the secret and "patriotic" society of Paul Reveres which the article charges is tied up with Royal Scott Gulden in the spreading of anti-Semitic propaganda and student espionage in the American colleges.

Bissell, the son of Municipal Court Justice Pelham St. George Bissell, made a flat denial of all charges to the Spectator reporter. The editor of the paper, however, was promised "adequate documentary proof" of the accusations by Spivak.

In his article, Spivak charged that Gulden had attended a secret meeting of the Paul Reveres held in Bissell's home, 270 Park avenue, on March twenty-ninth of this year. Though Bissell laughs at this charge, Spivak claims to have a stenographic report on the proceedings of that meeting.

## Hunter Admits His Affiliation With H.A. Jung

'Anti-Communist' Finds His Memory Weak in Libel Suit

(Special to the J.D.B.) BOSTON, Nov. 19. — Evading questions put by Reuben Lurie, counsel for the Artkino Guild in its libel suit against the Industrial Defense Association, Edward H. Hunter, executive secretary of the group, yesterday displayed a weak memory where details of the working of the organization were concerned.

He admitted that Harry A. Jung, notorious Chicago anti-Semite and disseminator of the "Protocols of the Elders of Zion," is on the board of directors of the Industrial Association.

Hunter declared he could produce no bound records of the organization, but only loose papers none of which bear any signatures.

Other papers called for "are missing or can't be found," Hunter stated.

George Krasker, manager of the Fine Arts Theatre, the plaintiff, named many prominent Yankee blue-bloods as patrons of the Artkino, which Hunter, in a report, had called "Communist" and "corrupting to the morals of American youth."

Krasker pointed out that the pictures produced by Artkino, in addition to being shown at Symphony Hall and the Fine Arts, were also shown at the Coolidge estate, the Pitman estate, at an American Legion affair and for the Christmas basket fund.

On further cross-examination Hunter named a "Mr. Lee" as president of the Industrial Defense Association for a certain year, although evidence introduced from records showed there was no president.

## Rudy Vallee's Lawyer Testifies In 'Racket' Trial of Bienefeld

Rabbi Jacob Bienefeld and his son, Myron, went on trial in Manhattan Special Sessions Court yesterday on a charge of conspiracy to defraud in connection with an alleged charity racket. The trial will be continued Thursday morning.

Witnesses yesterday were former Magistrate Hyman Bushell, Detective Harry Lichtblau and Carl F. Ruck.

Bushell told of a trap set for Rabbi Bienefeld's son after Rudy Vallee had been approached for a donation to the Downtown Center of Relief, run by Rabbi Bienefeld.

He testified that he posed as Vallee's secretary and that Rabbi Bienefeld, posing over the telephone as "Judge Ruck," promised to fix cases for him in return for a donation.

Detective Lichtblau told the court of being present when Myron Bienefeld, acting as messenger,

came to collect the check and was placed under arrest.

Mr. Ruck, a justice of the peace on Long Island, denied giving Rabbi Bienefeld permission to use his name in soliciting donations.

When Rabbi Bienefeld was arraigned in Magistrates Court last July, Mr. Bushell and Deputy Welfare Commissioner Stanley H. Howe testified that the Downtown Center is a "racket."

### Rare Objects Are Stolen From Vienna Synagogues

(Jewish Telegraphic Agency) VIENNA, Nov. 19.—Rare synagogal objects, including massive golden shields and pointers ornamenting scrolls of the Law, and cups of gold decorated with precious stones, were stolen here today when burglars broke into two synagogues.

The thieves were not apprehended.

## Relaxing Laws

In two countries—Mexico and Brazil—voices have been raised this week to recommend relaxation of the immigration laws existing there. In Brazil this issue was raised by the press. In Mexico it came as a special recommendation of the Mexican Immigration Council which consists of representatives of all government departments.

The call to relax immigration regulations of these two American countries is no doubt of interest to Jews. Though no specific reference is made to Jewish immigrants, it is nevertheless clear that if the immigration bars are lifted in Brazil and in Mexico, Jewish prospective immigrants will benefit.

Brazil is especially in need of immigrants who are fit for agricultural work. Mexico, too, could absorb more easily the class of immigrant who would be interested chiefly in settling on land rather than in engaging in trade.

In suggesting to the government that a milder immigration policy be adopted the Immigration Council of Mexico goes out of its way to emphasize that the doors of Mexico should be opened more widely only for immigrants who guarantee that they will not remain city dwellers but will settle on the land.

Though the full text of the recommendation submitted by the Council to the Mexican government is not available as yet, it is nevertheless known that official circles in Mexico are definitely inclined to revise existing immigration regulations.

As to the sentiment of the government of Brazil, it has been indicated on several occasions that the Brazil government would not like to encourage a large Jewish immigration into the country, but would welcome certain categories of Jewish refugees. A number of Jewish doctors from Germany who have proceeded to Brazil have been warmly met by the local population and have been satisfactorily settled there. A limited number of other Jewish professionals from Germany have also found refuge in Brazil.

The sentiments now prevailing in Mexico and Brazil for a less restricted immigration into these countries obviously deserves the attention of Jewish immigration organizations.

## PROGRESS IN ITALY

ROME.

The Italian League of Jewish Communities has just published the first report of its activities during the period beginning June, 1933, and ending October, 1934.

The League originated as a result of the new laws governing Jewish communities in Italy and aims both to care for the combined Jewish religious and cultural life in Italy and to co-ordinate the activities of the individual communities. At the same time it is intended to be the most important, indeed, the only representative of Italian Jewry to the government and the outside world.

One of the principal purposes of the League was brought about by point six of the new law: "to participate in the general religious and social activity of Jewry by maintaining spiritual and cultural contacts with the Jewish communities abroad, and especially with those communities which, as a result of their tradition, are in close touch with Italian Jewry and with Italy."

## Smaller Communities Are Helped to Expand

From the first report of the League, which is headed by Attorney Felice Ravenna, noted figure in Italian Jewish life, it is evident that the principal effort has been bent towards giving moral, organizational and financial aid to various Jewish communities, particularly the smaller ones.

Many of the smaller Jewish communities, some of which have religious and cultural traditions which are very old (as for instance Alessandria, Mancalvo, Monferato, Sienna), are in danger of complete disappearance because their few Jewish families are, for both religious and economic reasons, moving to larger cities.

In those instances where a community seems definitely doomed to disappearance, the League has taken care that at least its archives and old libraries are preserved. This work has been entrusted to Professor Zonne of the rabbinical seminary of Florence. Professor Zonne is a Polish Jew who devotes all his time to research in Jewish manuscripts and is a bibliographical authority.

## Seminary in Florence Transferred to Rome

One of the more important contributions of the League was the transferring of the Florence rabbinical seminary to Rome and its complete reorganization. The 1934 budget of the League provided 70,000 lira for the seminary and two stipends for rabbinical candidates. A number of authorities have been added to the faculty of the seminary, which now includes Professor Freiman of Frankfurt am Main, Professor Cohn of Hungary, Professor Cosuto of Florence, (a member of the Imperial Academy of Science), and Professor Dante Lattes.

An attempt to establish a yeshiva for German Jewish students at Fiume, where Dr. Breuer of Frankfurt was to settle at the request of the local Orthodox community, failed when the League opposed it on the ground that it furthered separatist activity while the new law sought unified work. The Fiume community leaders, motivated largely by economic difficulties, resigned, and the Jewish activities of Fiume are now being directed by a government official.

## Padua Rabbi Makes Survey in Tripoli

The Jewish community of Tri-

poli, which has problems peculiar to itself, has given the League much anxiety of a different nature. The community numbers some 16,000 souls. There is much poverty, which seems partly responsible for a rising number of mixed marriages, formerly a rarity among these people. Moreover, the group is spiritually and culturally backward and in need of much assistance.

With this in view, the League delegated Rabbi Dr. Castelhalanesi of Padua to study the situation. He spent five months in the North African colony, attempting to unify the various community groups, to introduce religious instruction in the general elementary schools and to see to it that Jewish children are excused from school on the sabbath and on Jewish holidays. As a result of his efforts special classes have been promised for the Jewish children in schools where there are a considerable number of them, while where they are few they are simply to be excused on the days specified. If this arrangement is not kept by the authorities, the League will seek to establish special elementary schools for the Jewish children of Tripoli.

## Has Raised Money To Aid Nazis' Victims

The League has also worked for German Jewry, its report shows. It has raised money for many who have been thus enabled to find definite occupation in Italian cities. About 400,000 lira were sent to the Central Aid Committee in London, 50,000 to the technical school at Haifa. The agricultural school maintained, with the consent of the authorities, by the Italian Fascist Organization, at Sienna, where twenty German Jews are being prepared for work in Palestine, received 20,000 lira. In addition, some 300,000 lira were

expended by the Italian Relief Committee to aid German refugees in various ways.

As previously reported, the League, with the consent of Premier Mussolini, participated in the Jewish World conferences in Paris, London and Geneva, where Professor Sacerdoti was chosen a member of the executive committee which is to call the forthcoming World Jewish Congress.

The League has also intervened with Premier Mussolini on behalf of the German Jews, and with other leaders as well. Both for the German Jews and for the Jews in the Saar and in Austria they were thus able to procure assistance, the report indicates.

## Achievements Merit Publicity and Praise

Altogether the document indicates a definite, positive, active approach to the problems presented to the League, and lists achievements which deserve publication. Italian Jewry needs a strong spiritual national force, an organization which can care for its cultural and religious needs, for the education of its youth in the traditional Jewish spirit.

The League of Jewish Communities was created for this purpose, and from its first report seems to have this well in mind in attacking the problems of the 60,000 Jews of Italy.

"We endeavor to make our report help in strengthening the cultural worth, with the aid of which we were able to live through long centuries of martyrdom and which should give us the strength to continue to work and fight, in order that we may impart to our children the spiritual wealth we have received from our fathers, thanks to the countless sacrifices they have brought," the document declares.

## Between the Lines

Saar and Danzig

When the League of Nations assembles tomorrow to discuss the problem of the Saar and at the same time to secure equal rights for the national minorities of that region, it would be well to draw the attention of the assembly also to the situation of the national minorities in Danzig.

Danzig is a Free City. Like the Saar it is administered by a special high commissioner appointed by the League of Nations. As in the Saar region, the Nazis there are spreading anti-Semitic propaganda and terror.

The communal elections held yesterday in Danzig, which were the first since the Nazis took over the administration of the city, have given a clear cut victory to the Hitlerites. About eighty per cent. of the votes in these elections were cast for the Nazi ticket.

## The "Free City"

A Free City is no longer free when a party which advocates racial hatred becomes its administrator. A Free City is no longer free when a part of the population there—in this case the Jewish population—is compelled to seek protection.

It was on the day of the communal elections in Danzig that a delegation representing the Jewish community appeared before Dr. Greiser, vice-president of the Nazi-controlled Danzig Senate and asked him that special laws be enacted for the protection of Danzig Jews. Dr. Greiser's attention was called to the wave of anti-Semitic propaganda in the Nazi press of Danzig and to the fact that the Nazis are forcing the dismissal of Jewish employees of Danzig firms.

The reply of the vice-president to the court delegation was an emphatic "No." Dr. Greiser flatly refused to discuss any special protective legislation for Jews. He acknowledged the fact that the Jews in Danzig are facing difficult anti-Semitic days and will perhaps face even harder days, but he declared himself helpless to modify the situation.

## Where is the League?

In a "Free City" which is ruled by Nazis and where the Nazi influence grows stronger from day to day, a vice-president of the local parliament may really be helpless to give any assistance to the Jews. But what about the High Commissioner of the League of Nations in Danzig? What about Mr. Lester? Is he, too, helpless to do something for the protection of the Jews in Danzig?

The position of the Jews in Danzig must be very desperate, if it has come to the point where a Jewish delegation appeals for special laws for protection. The refusal even to consider the issuance of such laws makes the situation still more hopeless for the Danzig Jews. The results of yesterday's communal elections, giving eighty per cent. of the votes to the Nazis, show that the several thousand Jewish families in Danzig are exposed to no less danger than are the 5,000 Jews in the Saar.

The League of Nations should certainly not be interested in seeing the Nazis rule Danzig. A Danzig ruled by the Nazis is a danger for the entire Danzig corridor; is a danger to world peace. That is why the League should consider the Nazi problem in Danzig just as it is considering now the Nazi problem in the Saar.



## Climb Out of the Vacuum!

Nothing reflects the true condition of any people as clearly as its press. The vitality of a race or movement will be brilliantly echoed in the things they like to read.

Similarly a chaotic, timid, undisciplined point of view will be demonstrated in a press largely dignified by its paucity of ideas.

Without being able to read Yiddish, I rather suspect that the Yiddish press shows a considerable power and vibrancy which the Anglo-Jewish press denies itself.

### Judges by Readers

I am led to believe this because of the very considerable circulations of these newspapers and the fact that it is not uncommon to see bearded gentlemen absorbed in reading them on the street cars. Evidently these papers represent something in tenacity and bold treatment which finds its counterpart in the souls of its readers.

The English language press on the other hand, read by a generation which has had the advantage of freedom, economic liberation, and education, should reflect a high level of Jewish purposefulness, intelligence and creative spirit. If these qualities existed among their readers it would be difficult to show any other spirit in the publications serving them.

### What It Wants

When after looking through a long list of Anglo-Jewish periodicals I find that each one is apt to set a new low in staleness, spinelessness and general inadequacy of idea, it seems entirely probable that the assimilationist, weak-kneed, temporizing bulk of American Jewry is getting exactly what it wants.

If a man is dominated by a futile escapist psychology, it is highly improbable that anything but platitudes and masochism will appeal to him.

How is it possible to believe that these people have hopes and dreams, convictions, courage and a design for the future when everything that is done and said for them exists on the basis of innocuous platitudes? It seems that the attitude is that it is better not to organize even the mind for any purpose since the more weakly disorganized they are the better they can hide.

### Merely Weak Lie

Wherever a condition cannot be transformed into something purely inane, it is recreated so that in effect it becomes merely a weak lie.

Thus we read in the American Jewish press long-winded statements about how Booth Tarkington and others say that prejudice is on the wane, despite the fact that the opposite is strictly true. You can find the usual folderol about the unparalleled development of Palestine, although Palestine at the present moment only admits a few thousand Jews and is a first-class sinkhole for Jewish money for English and Arab advantage.

### Fight on England

If these papers, instead of helping Jews delude themselves, would add another idea besides serving as advertising mediums, they might put up a creative fight to mass the Jews against our unquestionable opponent, England. We must have Palestine but we are not getting it, and all the foolish mouthings which are being uttered in regard to it and "its unparalleled" (Continued on Page Six)

# Digest of World Press Opinion

## Biro Bidjan As Military Center

The *Chicago Tribune* sent John Powell as its special correspondent to Biro-Bidjan to investigate the territory there from a military viewpoint. Mr. Powell reports his impressions to his paper as follows:

The Jewish colony of Biro-Bidjan constitutes another link in the defense chain which Soviet Russia has forged about the Japanese dominated state of Manchukuo. It is a triangular area not far west of Khabarovsk and is known as the Jewish national district. It gets its name from two small rivers, the Biro and the Bidjan, which flow south into the Amur.

The bolsheviks established the settlement in 1928 directly across the Amur from Manchukuo. Its position is such as to give the Japanese a maximum amount of trouble in the event of war. The Sungari river, chief navigable waterway of northern Manchukuo, flows into the Amur at Tungkiang, which is adjacent to the southern border of Biro-Bidjan. It is here that, the gunboats belonging to the Manchukuo "navy" are concentrated.

### Carry Japanese Crews

All these gunboats carry Japanese officers and crews. In the event of a war between Japan and the U. S. S. R. fighting probably would break out here immediately, since the Soviet has stationed its Amur river fleet between Tungkiang and Khabarovsk, the capital of the Soviet far east.

The Japanese now are pushing the construction of a new railway to extend from the new Japanese port of Rashin on the upper western Korean coast to the mouth of the Sungari. This will permit the transportation of troops to the Manchukuo terrain west of both Vladivostok and Khabarovsk. It also will pave the way for any offensive designed for the occupation of far eastern Russia, long eyed hungrily by the imperial Japanese army.

It becomes obvious, therefore, that a Soviet fostered Jewish colony at this strategic point will serve as a convenient base in any armed conflict. Meanwhile the agricultural and other products of the area will be of service to the Russian army which is headquartered at Khabarovsk.

## Soviet Policy Toward Religion

The *Chicago Sentinel*, speaking of Judaism in Soviet Russia, believes that the Soviet government will soon adopt a milder policy towards religion. The paper writes:

The recent restoration of the rights of citizenship to clergymen and to all other church and synagogue officials represents a prophetic event in the life of Russian Jewry. According to the new decree all clerics no longer belong to the category of "declassed" and they are entitled to obtain food and other necessities in government establishments.

We believe that the next step of the Russian government will be to allow greater leeway in religious matters. Not only internal but also external happenings are bound to dictate such a policy. The recognition which the Soviet government is constantly gaining in foreign countries will automatically make for greater liberalism in religion. Our readers will recall that we have never been discouraged about the future of Judaism in Russia. Russian Jewry has for a long time been an inexhaustible reservoir of

spiritual and cultural energy and it is our firm conviction that a new day will still dawn Jewishly for our brethren in that country.

## Roosevelt Triumph Blow to Demagogues

That the Democratic election victory will also deal a hard blow to those demagogues who are spreading propaganda that the NRA was wrecked by Jews is the opinion expressed by the *Spokesman*, published in Louisville, Kentucky. It states:

Depression breeds anti-Semitism. No depression, no anti-Semitism. Given the endorsement of the populace, the Roosevelt administration, with time to reinforce and solidify what good work it has so far accomplished, should pull through and out of the depression. If prosperity returns, if men go back to work and once again enjoy the sense of security engendered by a weekly pay check, demagogues like Pelley will no longer have a great army of disgruntled unemployed from which to enlist a following.

The anti-Semitic danger is still potential, and with a failure of recovery, would grow into a real menace, but with the nation behind the New Deal, even the most pessimistic business will admit that the depression is a thing of the past.

## Special Protection For Saar Jews

The *American Jewish World*, dealing with the forthcoming session of the League of Nations next Wednesday, says:

The League of Nations committee to deal with the Saar problem is now considering the question whether to stipulate special protection for the Jews in the Saar, in the event the plebiscite favors the return of the region to Germany, or whether to include the Jews in the general demand for protection of national minorities residing in the Saar.

The experience of the last fifteen years of European history should convince the members of the League committee of the need for special and specific protection for the Jews. The League experts ought to find no difficulty in compiling a long list of special official and governmental discrimination which do not apply to other minorities.

## Poland and Canada Sign Trade Pact

The benefit which Poland can derive from a better treatment of its Jewish population is pointed out in an editorial in the *Canadian Jewish Chronicle* in connection with a commercial treaty which is to be signed between Canada and Poland. The editorial declares:

While most nations are glowering at each other, and making ominous preparations for their individual welfare, Canada and Poland are about to consummate a treaty which will be to the mutual advantage of both nations. For some inexplicable reason, there was no common platform on which these two countries could meet, much to the detriment of Canadian-Polish trade, but with a common working basis, we can readily understand how the people of both lands will eventually benefit from this interchange of business.

We have heard so many dolorous stories of the plight of Polish Jewry, and of late they have been more hair-raising than ever, that as Jews as well as Canadians, we welcome every effort that is being made towards international amity on an industrial basis. The Jews of Poland have lost many privileges under the enactment of re-

cent laws, and the poverty is so indescribable as to be almost unbelievable. The projected treaty may not be of value in correcting such discrepancies as the wholesale discharge of Jewish teachers or the crowding out of Jews from their vocations, but as an instrument for more amity, it is of great value.

Commenting on Father Coughlin's interview with the JTA, in which he expressed himself as a friend of the Jews, the *Wisconsin Jewish Chronicle* of Milwaukee says:

When Father Charles E. Coughlin last Spring attacked Henry Morgenthau Jr., Secretary of the Treasury, on the silver monetization issue and in the course of an acrid argument used the terms "Jewish gold" and "Gentile silver" we were struck with feelings of disappointment and fear. Disappointment because we had admired the eloquent clergyman's courageous crusade against a vicious financial and political system that had produced the paradox of poverty amidst abundant wealth, and believed him to be a man of broad human sympathies and liberality. Fear because the injection of the "Jewish issue" in a purely technical dispute on monetary policy indicated an anti-Semitic attitude on the part of the celebrated Catholic priest.

We could not understand how any Catholic lay or clerical leader in America could even conceive of utilizing the vicious weapon of race or religious prejudice to gain any advantage, moral or material; for that poisonous weapon has been just as damaging to the Catholic in America as it has been to the

### The Children's Hour Tonight

Tonight at the Maxine Elliott Theatre Herman Shulman will present a play by Lillian Hellman which that young lady has satirically titled "The Children's Hour." Although Miss Hellman has been on the verge of a "writing career" for the past decade, this is her first effort to reach a state of production and if her play acts as well as it reads it should do very well indeed.

When the curtain rises on "The Children's Hour" the author will have an audience with nothing but good-will in its hearts. Brought up in the West End avenue section of this city Miss Hellman has as many acquaintances as a politician up for re-election who has a good chance of getting in. The only difference being that practically everyone who has ever met Miss Hellman really likes her. She is one of those unusual women of whom other women speak well and that despite the fact that men find her attractive.

Her play is a serious, sincere drama which should prove provocative and moving. It traces the effect of a child's lie upon the lives of two women. As a framework Miss Hellman has used a little school girl, who, out of her imagination, accuses two women teachers of having unnatural relationship, the busybody begins to work and the result is tragic to the teachers involved. It is a difficult and touchy theme but Miss Hellman has handled it delicately and convincingly.

Elmer Rice's fine play "Between Two Worlds" at the Belasco closes tomorrow night which doesn't give you much time to see one of the season's best plays . . . The Forum Players who were trained at the Madison Street Settlement House will give "Singing Jailbirds," Upton Sinclair's play at the Heckscher Foundation theatre all this week. . . . "Gold Eagle Guy," Melvin Levy's play, will be presented by the Group Theatre at the Morosco on November 28. Edward Bromberg, who played one of the leading roles in "Men in White," will head the cast. Stella Adler and the rest of the Group company will also have parts in this play of life in the northwest.

### Gay Divorcee Very Gay

"The Gay Divorcee," which is playing at the Music Hall, is easily the most entertaining film of the current cinema season. RKO-Radio Pictures, which have been very much in the background these past months can be proud of having achieved a success that will sweep the country. In this gay entirely delightful film Fred Astaire dances, sings and acts his way through a number of amusing situations. He is ably aided by Ginger Rogers, Alice Brady and Edward Horton in the major roles. The minor parts are skillfully handled by Erik Rhodes and Eric Blore. The story of "The Gay Divorcee" follows in broad outlines the musical play of the same name. It concerns Astaire's pursuit of Miss Rogers who is trying to get a divorce from her husband. When she mistakes Astaire for the professional co-respondent the picture makes a new record in laughs per film-foot.

The writers of the dialogue for "The Gay Divorcee" have earned at least one gold medal that won't tarnish. Mark Sandrich is the director and he, too, has earned a round of applause.

ed development" will ultimately end in a tragedy which will sever the Jewish soul from its moorings. In effect, all these moon-eyed orators, in transforming the fact into their own dream wish, are actually helping to sabotage the Jewish hope for the future.

With England bending every effort to create a situation where the Jewish state in Palestine will be effectively stopped, the idea of the Jewish press in perpetuating the legends that Palestine is ours and the British our friends, is little less than legerdemain. This whole sleight-of-hand performance might be amusing if it were not so close to home. It is an indication of something woefully sad and wanting in the Jewish mind and soul.

### In "Spiritual Vacuum"

If the Jewish people will get out of the spiritual vacuum they are in, possibly instead of reading about drives for this and that, banquets for the purpose of that and this, messianic wish fulfillments and other weakling sops to self-delusion, we might see a strong, creative spirit. We might see an active campaign for united Jewry; for a reconstructed, brave Jewish soul; for action against our unquestioned opponent, England; and for courage and intelligence and dignity, which the Jewish mass structure now badly lacks.

There are probably many people in existence who still believe that it isn't nice of me to tell the truth in this matter. However, I never claimed that the truth was necessarily nice.

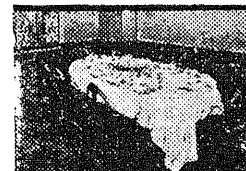

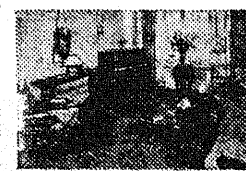

His batting average before he was run out of town was .000—no hits, no runs and four errors.

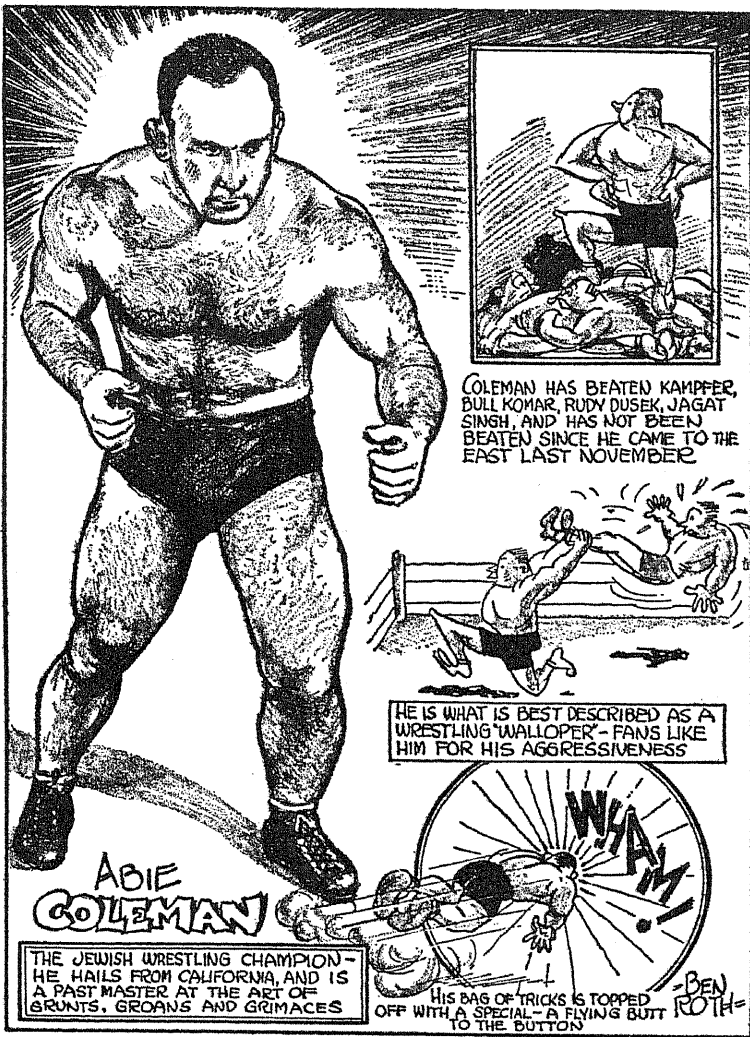
## But Now He's Coming Back in Grand Style

# Figures Show New Importance Of Berlin's Jewish Community

(Jewish Telegraphic Agency)

BERLIN, Nov. 19.—The extent to which Jewish life in this city now centers around the Jewish community was stressed here today in an address by Moritz Rosenthal, member of the community executive body, who addressed a meeting in the Prince Regensstrasse Synagogue.

"We have ruthlessly put aside everything that does not belong to the immediate order of the day," Herr Rosenthal declared. "We have opened an economic office of the community and taken over the emigration office of the Hilfsverein. We have built up a

loan system for the middle classes and enlarged our welfare bureau.

"Our welfare office has 20,000 clients; the schools of the community are attended by 4,000 children, and 36,000 patients are treated in our community institutions. There are 800 in our homes for the aged and the 4,000 school children are taken care of in our Summer camps.

"Our work makes it essential that we deal in every-day necessities and we have not allowed ourselves to be led away by high-sounding phrases. Last Winter we gave economic relief to our people. This coming Winter we must not only give bread but spiritual relief as well."

## Baron Rothschild Tribute Arranged

National Fund to Hold Public Memorial Assembly December 12

Public memorial services for the "one man Zionist movement," Baron Edmond de Rothschild of Paris, will be held December 12 at the Hotel Astor under auspices of the Jewish National Fund. Making the announcement yesterday, Rabbi Israel Goldstein, president of the Fund, urged other communities to hold similar assemblies throughout the country.

A special volume of the Golden Book of the Keren Kayemeth Le'Israel has been opened in Jerusalem in which will be inscribed the name of the late Baron as a tribute to his great contribution towards the upbuilding of Palestine as the Jewish national home.

At the memorial assemblies individuals and organizations will be given the opportunity, by contributing \$100 or more to link their names with that of the Baron in the redemption of Palestine land.

## McGoldrick Aide Heads Fascist Group, Disclaims Anti-Semitism

of his organization held Sunday at He admitted that at a meeting 611 Broadway, headquarters of the group, he had spoken on the same program with Louis Zahne, bitter anti-Semite, and leader of Nazi-fied Friends of New Germany.

"I did not know who Zahne was," Prout declared, "or what organization he represented. Zahne spoke at length about 'Asiatics' and only towards the end of his speech did it dawn on me that he was speaking about the Jews."

### Too Many Jews in Parade

"I am against Communists no matter what their nationality and I intend to use the organization to prevent the rise and progress of Communism in the United States. Ever since the last May Day parade of the Communists I determined to do something about the matter. It was my impression that Jews predominated in the parade."

Major Prout stated that he had been invited to the meeting on Sunday by another Irishman, and that when he heard of the program of the organization, he immediately accepted the leadership and became "Consul" with "a life-time tenure since the spirit of the A. C. is that the Consul can do no wrong."

The Major is a veteran of the United States army, having served overseas during the World War. During the Irish rebellion and later in the Free State army, he held the rank of Major General.

He disclaimed all knowledge of the ambitious Fascist program of the American Concentration, declaring that he was interested only "in fighting Communists, no matter what their nationality."

### Other Leaders Italian

At the office of the American Concentration Inc., Raphael Mucilli, a naturalized Italian with a heavy accent, who described himself as the originator of the movement, "but now second in command," did the talking.

When the Bulletin reporter walked into the bare office Mucilli was dictating in Italian to a secretary. He halted his dictation to explain the program of the organization.

At a table working away busily was a man who was introduced merely as "Citizen Racchoni, former Brigadier General in the Khaki Shirts." The General, however, spoke no English and Mucilli acted as interpreter.

Mucilli admitted readily that his organization had taken over most of the defunct Khaki Shirt outfit. "You see," he said, "they came over to us after, shall we say, the 'demise' of commander-in-chief Art J. Smith." Smith is now serving a seven year sentence for perjury in connection with the murder of Athos Terzani at a Fascist meeting in Queens.

"I started this movement about three years ago," Mucilli declared. On June 12, 1933, I obtained a state charter for the organization. You can see it on the wall.

### 'Genuine Italian Americans'

"True, most of our members are Italians and Fascists, but I kept the movement quiet until we could get genuine native Americans into our organizations. Now we have Major General Prout as our commander and we are ready to come into the open.

"We have several thousand members. I can't tell you exactly how many, that is secret. But I can tell you that we are making tremendous inroads among the Italian Fusion clubs here in New York City. Only a few days ago 500 members of those clubs came over as a group to our organization. So far all our contacts and members come from the Italians, but we hope to have the American elements with us soon.

"I am a great patriot for Amer-

ica," Mucilli assented. "Like all immigrants, I am perhaps too patriotic, but I can't help that."

Asked about a statement against the anti-Nazi boycott credited to Major Prout, Mucilli quickly declared that he was responsible for the statement. "We are against all boycotts because of our intense nationalism," he said. Mucilli declared that he and Major Prout were the speakers, omitting the name of Zahne and the fact that many German Nazis, most of whom could not speak English had also been at the meeting on Sunday.

"The program of our organization," Mucilli stated, "calls for the most intense nationalism. We demand a conscript army in which all American youth must serve. We also call for intense imperialistic expansion until the entire Western Hemisphere is under the American flag and speaks only one language. We also demand the abolition of the states and the division of the country into thirteen prefectural divisions which shall be ruled by prefects appointed by the leader.

"Those who join our ranks now and become 'regimented citizens' who place themselves at the disposal of the organization' will enjoy special privileges later."

### Blue Uniforms

The outfit's uniform is a blue shirt, blue trousers, blue beret and Sam Browne belt.

Membership charges are two dollars a year, plus a one dollar initiation, plus fifty cents dues monthly. To this must be added the cost of the uniform. Mucilli refused to say how the uniforms are procured and whether like Smith's Khaki Shirts, the shirt selling business was the chief feature of the organization.

The motto of the organization according to Mucilli is "For God, Country and Home." The salute is "Hail America" and the response is "All for all."

Asked whether the part of the program calling for "regimented citizens" did not mean the creation of storm troops in New York, Mucilli refused to comment. He admitted that the entire program was based on a military concept and called for a military organization with rigid military discipline to all commands by superior officers."

He asked for the reporter's name, asking his secretary to note it "in case any dirty work is done by your paper." As the reporter left the room, the "fuehrers" rose and gave him the Fascist salute with outstretched arms.

(Continued from Page One) publication has lost virtually all its advertising, which is now being given instead to the Deutsche Beobachter, which steps into the anti-Semitic shoes tossed into the scrap heap by the Deutsche Zeitung.

Although Louis Zahne, self-appointed Fuehrer of American Germanism, telephoned a Bulletin reporter some time ago to ask him to intercede for McLaughlin, Zahne appeared quite callous yesterday to the editor's predicament. Leaders of the Friends of New Germany gave notice that any one who outwears his usefulness to them may expect an unceremonious repudiation.

### Kappe on New Paper

Among those who deserted the Zeitung to go over to the Beobachter is Walter Kappe, former editor of the German portion of the discredited sheet. Dr. Herbert Schnuch, national president of the Friends, which is publishing the new organ, admitted yesterday that Kappe is now a Beobachter employee, but refused to say in

what capacity.

### New Publication

Another abortive journalistic enterprise appeared in the field yesterday. This one is Healey's Irish Weekly, so-called, although there is no proof that any one connected with it is a bona fide Irishman.

Raymond Healey, a twenty-two-year-old grammar school graduate, insists he's an Irishman and a Catholic, but grew elusive when he was asked pointed questions about the church he attends.

He finally admitted he has attended no church for several years, and was unable to name a single person of Irish antecedents who is associated with or friendly toward him.

His newspaper in its masthead reports it is being published "to combat the radical Jewish minority influence." Below its title it bears the legend, "Gentiles Awake!" This admonition is decorated on one side with a shamrock and on the other with a swastika.

The Irish Weekly, Healey says, is based on the forged Protocols of the Elders of Zion, which is his favorite reading matter.

Its only address is "Box 118, 308 East Eighty-sixth street." This place is known as New York's "Nazi post office." It is the office of Ernst Hopf, an accountant, who sells the right to receive mail there to 190 persons, most of whom are Nazi leaders and men engaged in anti-Semitic activities and other rackets.

Healey, who has addressed several meetings of the Friends of New Germany, boasted that his staff consists of "100 men, eighty-nine of them Irish." He frequently contradicted himself in statements to the reporter.

He said he is in the real estate business, and claimed to have been the editor of Art Smith's Khaki Shirt paper in Philadelphia.

## Aden Stops Yemen Jews on Way to Zion

### Ordered to Return to Homes Despite Palestine Visas

(Jewish Telegraphic Agency)

JERUSALEM, Nov. 19. — A number of Jewish families from Yemen who were on their way to Palestine were compelled by British authorities today to return to Yemen as soon as they reached Aden, which is a British protectorate.

The order to return the immigrants to their native cities was issued by the Aden authorities on the strength of the recent order prohibiting Jews to enter Aden.

Today's incident constitutes a big problem for the Jewish organizations which are interested in assisting Yemenite Jews to migrate to Palestine. The families
