# Soviet May Aid Polish Jews Says Feeling High Against

### Suritz Group Sees Kalinin On Settling

Ask Him to Open Biro-Bidjan for Entry of First 300

(Jewish Telegraphic Agency) MOSCOW, Dec. 7.—The Soviet government may soon permit an organized Jewish immigration from Poland to Russia, it was officially learned here today when a Jewish delegation from Poland arrived here to negotiate with the Soviet to open its doors to Polish Jews.

The delegation, headed by Dr. Michael Suritz, president of the Agro-Yid organizatio in Poland, was received today by M. Kalinin, president of the U.S.S.R., and handed to him a memorandum describing the economic plight of Polish Jews. The delegation asked President Kalinin to permit the settling of the first 300 Jewish emigrants from Poland in Biro-Bidjan, autonomous Jewish region in the Far East.

### Yale Students' Group Discusses Problems of Jewry

NEW HAVEN, Conn., Dec. 7 .-The Jewish Club of Yale began its second year with an address by James Rowland Angell, president of the university, on "The University as a Center of Liberal Thought."

### Denmark Bars Discrimination, Leaders Aver

### Express Surprise That Topic Should Even Be Considered

(Jewish Telegraphic Agency) COPENHAGEN, Dec. 7.-Leaders of the four political parties in Denmark, who were invited to address a Jewish meeting on anti-Semitism, united in expressing surprise that Danish Jews should even consider the subject, pointing out that there is no anti-Semitism in the country and that its introduction is unthinkable.

Christian Moeller, leader of the Conservative party, said it is impossible for Denmark to assimilate 100,000 aliens, but the Jews are not aliens, he declared.

"No one was a better champion of Denmark than Georg Brandes, who added luster to Denmark by his writing," the conservative leader said, adding that "Brandes was the finest stylist in the Danish language."

The liberal leader Bro and the Radical Ragar denounced anti-Semitism as being "against civilization" and a "product of barbarism."

Kurt Rasmussen, Socialist leader, said there is no anti-Semitism in the country, but admitted there may be anti-Semitic sentiment in certain quarters, which must be vigorously opposed, he said, if it ever shows itself in the open. Such sentiment, he declared, is mainly due to envy of Jewish initiative and capacity.

### Haavara Tells Of Palestine's **Reich Compact**

New Agreement Enables **Emigrants to Take** More Cash

(Jewish Telegraphic Agency) JERUSALEM .- Three new arrangements with the German government for facilitating the transfer of Jewish money from Germany into Palestine were announced here today by the Haavara, the organization supervising the Palestine barter agreement.

The new agreements provide:

1.—That special certificates be issued by the Haavara, with the approval of the German government, to Jewish capitalist immigrants from Germany, against the sum which they expect to take out. These certificates are to be recognized by the Palestine government as entitling their holders to enter Palestine under the category of capitalists possessing not less than five thousand dollars.

2.—That German Jews residing in Palestine and dependent upon income from pensions and rent in Germany receive their income through the Haavara.

#### Raise Cash Allowance

3.—That German Jews desiring to come to Palestine as tourists be permitted to take with them from Germany not the limited sum of ten marks which is provided by the present exchange regulations, but a sum of five hundred marks, on condition that these sums are paid out to the tourists in Palestine by the Haavara from the barter accounts.

Making these new arrangements public, the Haavara has issued the following statement to the

Jewish Telegraphic Agency:
"According to the practice, recently introduced by the Immigration Department, immigration certificates to immigrants of the "Category A" have been issued on the production of "Haavara" Certificates, showing that the applicants for the immigration certificates, showing that the applicants for the immigration certificates have an amount in their favor with the above company up to £1,000.

#### Don't Need Bank Notes

"By this arrangement German Jews are enabled to immigrate into Palestine as capitalists without being obliged to produce bankcertificates.

"The enactment of the German government which provides that a tourist may not take with him for traveling purposes an amount in cash exceeding ten marks has been a serious threat to Jewish tourist traffic from Germany into Palestine.

"This danger has been eliminated by the new arrangement of the Haavara (transfer) whereby it is made possible for every tourist from Germany to transfer an amount of 500 marks to Palestine through the Haavara.

#### Delay Avoided

"According to the agreement made between the Haavara and the Palestine and Egypt Lloyd, it will no longer be necessary for the Jewish tourist to wait until the Haavara will have effected the realization of the amount transferred in his favor and he will be able to obtain the sum needed by him for travelling purposes immediately upon his arrival in Palestine. It is to be noted that this arrangement applies to Palestine only and that the above enactment remains valid in regard to other countries.

"According to recent arrangements there now exists a possibility for the Haavara to transfer to Palestine moneys representing pensions and rents on the revenue of which the owners are dependent on their immigration into Pales-

"Without this arrangement pensioners and owners of rents from

Germany who have immigrated into Palestine would be threatened by the loss of their only means of livelihood.

#### Opening the Gates

The news that the Soviet government is about to permit the entrance of Polish Jews into Soviet Russia on condition that they settle in Biro-Bidjan will be received with great interest in America, where the situation of the Polish Jews is watched very keenly.

There are over a million Jews in Poland today facing actual starvation. The desperate situation of Polish Jewry is especally noticeable among the youth. Cut off from all roads to employment, Tewish youth in Poland is depressed and forlorn.

With the immigration restrictions in Palestine, and with no other country permitting the entrance of Jewish immigrants, Soviet Russia remains the only hope for thousands of Polish Jews. There is no unemployment in Russia, so Polish Jews believe they can easily find employment

Informal negotiations with the Soviet government to permit Polish Jews to enter Russia have been going on for qute a time. The Soviet authorities were, however, not so keen on relieving Poland of its obligations toward its Jewish citizens.

Now the news comes that the Soviet government may permit the first 300 Jewish families from Poland to settle in Biro-Bidjan and that a special Jewish delegation from Warsaw has arrived in Moscow to negotiate this project.

Should a Jewish migration begin from Poland to Biro-Bidjan on a larger scale, it will doubt eventually be supported by Jewish relief organizations abroad. The fact that the Polish government is driving the Jews to Biro-Bidjan by depriving them of economic existence in Poland will stimulate many organizations abroad to assist the migration from Poland, despite the fact that very few Jewish leaders would like to see foreign Jews seeking refuge in Russia.

The Polish government may not be aware of the fact that it is creating a situation whereby the Jews of the world must become more sympathetic towards the Soviet regime. With the unbearable anti-Jewish discriminations in Poland, Polish Jews would migrate anywhere, Biro-Bidian included.

## VEEK'S EVENTS IN REVIEW

### By BORIS SMOLAR

A blow to Jewish interests was dealt this week by the League of Nations in sanctioning the Franco-German agreement which drives the Saar Jews into exile.

The agreement, which is a result of secret negotiations between Germany and France, gives the Jews of the Saar one year to liquidate their businesses and move from the territory. This pact had been reached despite assurances given by the French government to Jewish delegations that the rights of Jews in the Saar will be made one of the major issues before the League if the region is turned over to Germany by the plebiscite next month.

Sanctioning of the agreement by the League provoked many protests on the part of Jewish organizations. The League for Defending Jewish Rights in Europe, of which Senator Justin Goddard is president, has submitted a formal memorandum of protest to the French govern-

#### Encouraged Jews To Protest Threat

On no other occasion were Jewish leaders so misled by France as this time. While bargaining with Germany for the agreement which yielded to France \$60,000,000, the French government was inspiring Jewish organization to flood the League of Nations with memorandums urging not to turn the Saar over to Germany before equality for the Jews there is guaranteed by the Nazi government.

Promising to support the Jewish memorandums when they will be taken up by the League, the French government had in the meantime conducted silent negotiations with representa-tives of the Reich. The agreement now concluded is a complete victory for the Nazis and is considered by many a betrayal, on the part of France, of Jewish interests.

The 5,000 Jewish families in the Saar are now definitely doomed to migration. None of them will be able to remain in the Saar a year after next January. All of them will have to leave their homes and go into exile.

#### Similar Fate In Silesia

The fate of the Saar Jews also may soon be shared by the Jews of Upper Silesia, a territory which will now be under the administration of the notorious Jewbaiter, Julius Streicher.

Though the rights of the Jews in Upper Silesia are guaranteed by Germany, under the supervision of the League of Nations, there is no doubt that Streicher will make the existence of the Jews unbearable as soon as he takes over the governorship of Silesia. The experience in Jew-baiting which Streicher has had in Franconia, where he made the life of the Jews bitter, will no doubt not be lost to him in Silesia.

The comparatively peaceful time which the Jews in Silesia enjoyed under the Nazis till now because of the decision of the League of Nations on the Bernheim petition may therefore be considered over. There is every ground to believe that Streicher will violate the decisions of the League of Nations with regard to the Jewish rights in Upper Silesia, especially since the League now has proven to be so helpless in compelling Germany to maintain Jewish rights in the Saar.

#### **Borders Closed** To Refugees

This opens again the problem of migration. Very few countries today permit Jewish exiles to cross their borders. In France severe anti-alien legislation is being advocated and the deportation of many refugees is expected.

Voices are also being heard in England against "undesirable aliens." Restrictions for entering Palestine also are becoming more and more evident. Sir Philip Cunliffe-Lister made it clear this week in the British Parliament that the number of immigration visas to Palestine will be sharply reduced as a measure to counteract illegal immigration of Jews into Pales-

Unprecedented precautions in checking Jewish immigration to Palestine were taken this week by the British government when it compelled Greece not to permit Jewish travelers to enter Greek territory without special permision from the central authorities in Athens. This is the first instance a stronger government exercised pressure upon a country of minor power to impose upon her the carrying out of anti-Jewish discriminations.

#### British Claim Greece Is Base

The British Legation in Athens, forcing the Greek government to close its borders to foreign Jews, argued that most illegal Jewish immigrants are smuggling their way into Palestine from Greece. This argument, which would be considered by any other government an insult to its independence, was swallowed by the Greeks without contradiction, and orders have been issued to all the Greek consulates abroad not to

issue visas to Jews before inquiring at Athens in each case.

In connection with the anti-Jewish measures taken by the Greek government, it was disclosed this week that not less than 2,000 Jews have obtained Greek visas in Poland this year. The Greek consulate in Warsaw is now instructed to refrain from issuing visas to Jews proceeding to Greece or passing Greek territory in transit.

#### Transport Plans Are Nullified

One cannot say that Greek commerce will benefit from this order. It is only recently that an increased navigation between Greek and Palestinian ports has developed. Plans were formulated for a passenger air service between Salonica and Haifa in view of the growing traffic between Palestine and Greece.

This traffic will no doubt decline to the very minimum, now that foreign Jews are not permitted even to pass through Greece. Italian steamship lines will remain in control of transportation of Jews from Europe to Palestine.

#### Huleh Project Brightens Horizon

Perhaps the most important achievement in Palestine during the last few years was the acquisition this week of the Huleh territory by Jews. Located at the Palestine-Syrian border, this territory contains of approximately 40,000 acres of land, most of which needs extensive drainage. It is, however, estimated that the entire work of draining the land will be completed within three years. Then not less than \$,000 Jewish families will be settled on the soil, which experts believe wil be very fertile and especially good for extensive colonization.

The entire project of acquiring the land and draining it is financed by the Palestine Land Development Company, the Association of Jewish Farmers in Palestine and the Palestine Labor Bank. It is hoped that the Jewish Colonization Association (ICO) also will become interested in financing the enterprise.

#### ICA Work in Russia Banned

Ukraine.

The work of the Jewish Colonization Association this week suffered a blow in Russia, when the Soviet government suddenly ordered the Moscow office of the association to liquidate its colonization activities in the Jewish autonomous regions in the

This order came after ten years of work which the ICA had invested in Russia under the Soviet regime, spending many millions of dollars there. The Soviet government explains the ousting with the fact that the ICA has itself practically been liquidating its activities for the last few years and instead of investing money in Russia it has been engaged in collecting debts from Jewish colonists and taking the money out abroad. The liquidation of the ICA in Russia will have no effect upon the Jewish colonists settled in the regions where the ICA had been operating. These colonists have long been collectivized by the Soviet government. They have been receiving from the government much larger funds than from the ICA. As a matter of fact they have long been more under the Soviet administration rather than under the ICA administration.

Opposition to American participation in the Olympic Games at Berlin crystallized last week and was to be manifested this week at the annual convention of the American Athletic Union at Miami. The A.A.U., a year ago, voted not to certify American athletes for participation in the games until Germany removed the disabilities against Jewish athletes. Despite the action of the American Olympic Committee in voting to accept the invitation of Germany, the A.A.U. has not yet changed its stand.

Efforts of Avery Brundage, president of the A.A.U. and of the A.O.C., whose report to the latter body led to its acceptance of the invitation, to swing the into support of the games appeared certain to meet with strong opposition not only from Jewish members of the body but also from non-Jewish sportsmen who expressed dissatisfaction with Germany's pledges.

#### Barter

At Washington it appeared that pressure of Southern representatives for consummation of a barter deal with Germany involving the exchange of 500,-000 bales of surplus American cotton for \$30,000,000 in German goods were to be successful. Berlin had approved the terms of the agreement, it was stated. and only approval of American government departments was necessary. Secretary Wallace declared that the negotiations were "coming to a head."

This shift in sentiment at Washington occasioned much surprise, particularly in view of Secretary Hull's admonitions to Germany on the subject of discrimination against American creditors of the Reich. The stand which the United States had taken on Germany's defaulted obligations had made it evident that this country could no longer place faith in Germany's pledges. Consequently, Washington developments of the week came as a rude shock to those who had expected the government to pay heed to the protests of the millions who are opposed to the present German regime.

#### Medical Schools

Much comment was occasioned by the forthright advice of President McConaughy of Weslevan University to Jewish medical students that medical schools limit the number of Jewish students and that those preparing for a career in medicine should govern themselves accordingly.

President McConaughy brought into the open what many Jewish college students have learned only through sad experience. That is that entrance to medical schools here is painfully difficult, impossible for all but a small fraction of the Jewish applicants.

Two views on an important subject were brought to the attention of American Jewish educators. Dr. Thomas S. Gates, president of the University of Pensylvania, stressed the importance of religious training and urged the Jewish community to increase efforts along such lines.

Dr. Leo Honor, of Chicago,

appealed to Jewish educators not to stuff the minds of children with "primitive notions" which the teachers themselves did not believe. He also stressed the futility of mentioning God to children too young to understand the concept.

Along the Nazi Front Armed with information re-

vealed by the Jewish Daily Bulletin, the Congressional Committee on un-American Activities took off last week after peddlers of anti-Semitic literature, chiefly the spurious "Protocols of the Elders of Zion." The committee questioned J. B. Snow, former statistician, whose anti-Semitic propaganda activities had been exposed by the Bulletin.

A committee hearing at which Congressman Dickstein presided took on the aspects of a farce when the bedecked Raymond Healey, youthful grammar school graduate and publisher of 'Healey's Weekly," an anti-Jewish sheet published in Yorkville, was permitted to enact a Napoleonic role before a large body of appreciative members of the Friends of New Germany.

Zionist Activities

The National Labor Committee for Palestine launched a \$250,000 drive for Palestine labor activities. The Masada, Zionist youth group, adopted a six-point Zionist program of activities and closed its annual convention at Philadelphia with a sharp debate on the question of unity in American Jewish youth. Senator Wagner heartily approved the project for a "Palestine Day" on January 20.

## Remedies By LUDWIG LEWISOHN

III.

LL that I have been trying to say can be summed up in a simple statement: we need pride. An able young revisionist corrected me one day: we need a fierce pride. Perhaps. It is better surely than the other extreme of inner servility to which we have been brought by degradation and hate. For let us not be deceived: degradation degrades and hate may render the object hateful. But I am afraid of the element of fierceness in our re-awakened pride as being of the nature of an over-compensation for an inner servility of spirit and hence subject to all the unsureness and the vagaries and the possibility of sudden collapse of all such mechanisms.

Nor do I mean the well-known kind of pride that apes humility nor must we (though this is a council of hopeless perfection under the circumstances) be proud of our newly-won pride. This was meant by Arnold Zweig, himself an uncompromising Jewish nationalist, when one day he castigated the "Zionist snob."

I am humbler in my expectations; perfection is far from my hopes; I would give much, infinitely much to see many, many of the younger Jews whom I have recently met attach their notions of what is distinguished and of good repute and, if you like, even swanky, to the cause of our people rather than to the glow and glitter, the superficial distinctions and unworthier rewards of the world. For the things of the pagan world that they long for are always the trivial and the unworthy things, since (strange fate of a strange people) we always have the high and noble things.

IN EVERY generation Jewish names are numerous among the true benefactors of all mankind and in every community where Jews dwell in any number all but the blindest anti-Semite admits (and even he *knows*) that among the most honorable and beneficent citizens there are more Jews than according to the number of Jews in that community there need by ordinary measures to be.

Thus it is clear that the things of the world to which our servile-minded younger and older people attach their desires are the trivial and utterly perishable things, the things that the true Christian too wholly condemns: membership in clubs and fraternities, dwelling among those who quite properly desire to remain among themselves and other false and vain and negligible shows of a world the fashion of which will pass away like the shadow of a dream.

I have come so far from these things that I no longer know how to deal with them even when I meet them in their defensively-inverted form of "we don't care to go where we're not wanted" in which, alas, that negative remains a mere woeful negative and does not flower into affirmative and happy Jewish solidarity and its works and ways. I no longer imaginatively grasp these antics of a hurt servility of spirit.

Many of my best friends are Gentiles and I believe that the affection which unites us will last our lives. But the greater number of those who are very close to me in life are Jews. And I cannot imagine it otherwise and I should be unhappy were it otherwise.

For we are united by character and fate, by faith and memories, by common joys and sorrows, by our own way (even in our differences) of apprehending men and nature and human life. And with whom should a man—any man—feel happy and at ease except among those whose ancestors and his own stood together in good and evil days and prayed together and at need died together for the same good eternal cause?

In the company of such there is—again for every man of any kin or clan—a contentment and wealth of relationship which, without aught but perfect good will to the rest of mankind, he can find nowhere else.

ND so I regard it as infinitely right and proper that certain groups of my Gentile fellow-citizens desire to remain among themselves. For I have the same feeling concerning my group. I know certain Gentiles whom I would gladly admit into the closer circle of my friends and indeed I do so. But if there came into that circle a group of Gentiles whose chief interests, as is natural and proper for them, given their back-ground and ancestral friends, were in competitive sports or in hunting or in war or in the manufacture of material things as ends and not as means or else in their ancestral memories and their just pride therein of border-chieftains or march-raiders or valiant fighters in all the wars of the world-if such came in too great numbers into the group of my friends and fellows, would we not be, while sincerely respecting the other-ness of those others, stricken quite dumb and desolate and be cramped and ill at ease? So truly I no longer understand either intellectually or emotionally the attractiveness of that world of pagan ways and pagan values which still so strangely lures so many.

We need the pride that is in the free play of our natural loyalties and instinctive tastes. It is the release of these from false and foolish fears that is our great necessity. It is in that release and in it only that we shall find both freedom and sustaining pride.

#### Poles Threaten No Jews in Parliament

A definite break between the Polish government and Jewish members of the Polish Parliament was seen this week in the report that constitutional changes soon will be made which will prevent Jews from becoming members of Parliament.

This will be the first time since Poland obtained its independence that Jews will have no voice in the Polish Parliament.

The Polish government seems to be very much irritated by the speech which Dr. Thon, Jewish Parliamentarian, recently delivered in the Polish Sejm, charging before the entire world that Poland is mistreating its 3,000,000 Jews economically as well as legally and has reduced a million Jews to beggary.

Partly because of Dr. Thon's speech and the general anti-Jewish sentiment now prevailing in Poland, the Polish government seems to be determined to silence the Jewish voice. The Polish government does not, however, realize that Jews abroad are well-posted on anti-Jewish discriminations in Poland; also, that non-Jewish representative bodies as well as the world's leading newspapers are quite well-informed about the status of Jews in Poland today.



Imagine a huge, severe room, the walls wood-panelled, the heavy conference table, the deep chairs suggesting important board-meetings, the large desk with its green shaded lamp and its many telephones the very epitome of efficiency and you will have visualized the office of Mrs. Anna M. Rosenberg, the new State NRA Compliance Director. It is a room evidently dedicated to work, to constant, energetic, impersonal work. Yet there is one touch of beauty, one touch of femininity in all this uncompromising severity. On the dark, heavily carved mantel there stands a vase with fresh flowers, glowing in all the richest autumn hues.

Mrs. Rosenberg is just like the office she inhabits and imbues with her personality. Efficient, competent, engrossed in her work, she nevertheless possesses a distinctive feminine charm. An NRA label guarantees against such conditions, and if women will insist on this label and only patronize stores that comply with the NRA requirements they will help not only the New Deal but will protect themselves and their children."

The following instructions for orange marmalade are the cherished possession of a lovely Viennese lady who permitted me to copy them for you.

Take any number of oranges and allow one lemon for each five oranges. Wipe fruit with damp cloth, cut each in quarters, then cut each quarter into very thin slices, keeping pulps as well as rind, but discarding the seeds. For each pound of prepared fruit allow three pints of cold water. Let the fruit stand in the water for twenty-four hours, cook then till peel is very tender, or about six hours, and let stand again for another twenty-four hours. Weigh the mixture and add one pound of sugar for each pound of fruit. Mix and let cook until the syrup jellies on a cold dish. Keep marmalade in glass jars and cover with paraf-

### A Letter to Twelve Jewish Students

### By ABBA HILLEL SILVER

The charge of discrimination against Jewish students in American schools has again been resurrected. The occasion this time has been a letter sent by Dr. James L. McConaughy, president of

Wesleyan University, to twelve Jewish students taking pre-medical courses in the university apprising them of the difficulties which they will encounter when they will come to seek admission to a medical school. Dr. McConaughy advises these Tewish students "that the opportunity to study medicine is definitely limited by the medical schools of this and other lands." More than twice as many students apply for admission than are actually admitted.

"While the racial question does enter somewhat into the selection of students, it does not enter as much as some claim. The Association

of Medical Colleges reports that 17 per cent of the freshman students in medical schools are Jews. It is pointed out that in this country out of a population of more than 120,000,000 there are probably between 5,000,00 and 6,000,-000 Jews. They, in round numbers, make up not more than five per cent of the entire population. It has further been reported that over fifty per cent of the aplications for entrance to the medical schools in 1933 were of Jewish ancestry. The above facts explain why it is difficult for Wesleyan to place her graduates of the Jewish race in medical schools."

This letter makes unpleasant reading-as does so much of Jewish news today. Our first reaction to it is one of bitter resentment. In free America, why should a young man be forced to turn aside from the path of his chosen career by the fact that other young men of the same racial stock have chosen, in numbers beyond their population quota, to enter the same profession? Neither the basic law of the land nor the classic tradition of American democracy recognizes any such race groupings or prerequisites. Why should one single race—the Jewish—be placed in one scale of the balance while all the other races in this country - Anglo-Saxon, Teuton, Slav, Celt, Latin, etc.—are bunched together and placed in the other scale of the balance?

If quotas are to be established in professional schools on the basis of race, then every race in these United States should be submitted to the same restriction and should be assigned a fixed quota. Again, if this single-race quota system in the field of higher education is accepted as just and as being in complete consonance with the American principle of the individual's right to "life, liberty the pursuit of happiness (which, if it means anything at all, means the right of every individual to follow the career which he has chosen, unhampered by any legal restrictions based on race, religion or color), then we shall have to acknowledge that the Nazis were justified in carrying out this principle, in their country, to to American medical schools. Of its logical conclusion, and in applying it rigorously and mathematica'ly in all fields of human endeavor.

The Nazis merely added insult to injury. . . . In this country those guilty of perpetrating the injury are too urbane to stoop to banal race libels to justify the injury. Here they are rather decent about it. They attempt to save appearances all around by making fictitious personality and psychological tests do the dirty work of discrimination. . . .

This is our first reaction. On second thought, however, and after we had relieved ourselves of our feeling of indignation, Professor Morris R. Cohen's comment on President McConaughy's letter seemed to be quite valid: "The president happens to be a very courageous person. He is facing

the situation and telling the truth.' For it is true that medical schools are limiting Jewish students. A few years ago Dr. Frank Gavin wrote that "Jewish college graduates of New York who desire to enter medicine have applied to as many as orty colleges before securing admission." It has been argued by Dr. Harold Rypins that "the case of Jewish students in New York City seeking admission to the study of medicine presents a special problem deserving special consideration, the solution of which will be hindered rather than advanced by unfounded claims of racial or religious prejudices."

Other Jewish physicians have stoutly denied that discrimination exists in American medical schools. Dr. A. J. Rongy wrote not so long ago: "We must not overlook the essential fact that every Jewish student of proper competence and talent can eventually succeed in entering the doors of almost any medical school in this country. . . Undeniably, Jewish applicants must exert greater effort and perseverance than the non-Jewish. Still, in a country where the Jewish population aggregates three and one-half per cent of the total, Jews are represented by six times their ratio percentage among the medical student body. With this score, can we intelligently impugn the liberal attitude of the admission boards?"

But whether American medical schools are anti-Semitic or not, the cold, hard fact remains that nearly all of them are trying in one way or another to restrict the number of Jewish students while at the same time the number of Jewish applicants is mounting steadily every year. If Dr. McConaughy's figures are correct that over fifty per cent of the applicants for entrance in the medical schools in 1933 were Jews (if this figure is not the result of the large number of "multiple" applications which Jewish students are forced to make), then we are confronted by a very startling and serious situation. About fourteen thousand students apply annually these over seven thousand are Jews, and only a little over six thousand, all told, Jews and non-Jews, can be admitted! . . .

What is the answer? Shall we build special Jewish medical schools to make room for those who cannot be admitted in existing schools? We do not recoil from the idea of a Jewish medical college out of any fear of imputed segregation. Such schools may some day be necessary. But at present, with the percentage of Jewish students already very high in our medical schols, another additional school or schools would simply increase the number of Jewish doctors in this country, whose number seems already to be excessive, especially in the large metropolitan centers of our coun-

### Dr.Rosenbaum Wagner for Unity Dies in Tel Aviv At the Age of 75

Once Cabinet Member in Lithuania; Fought for Jewish Rights

(Jewish Telegraphic Agency) JERUSALEM, Dec. 7. - Dr. Shimshon Rosenbaum, former Minister of Jewish Affairs in Lithuania and until recently the Consul General of Lithuania in Palestine, died Thursday in Tel Aviv at the age of seventy-five.

Dr. Rosenbaum was one of the outstanding figures in Jewish life. He played an important role in Russia under the Czar, fighting for Jewish rights there. When Lithuania seceded from Russia and was proclaimed an independent country, he was appointed a member of the Lithuanian Cabinet, in charge of Jewish affairs.

Later when constitutional changes were made in Lithuania and when Jewish autonomy there was rescinded, Dr. Rosenbaum left for Palestine, where he was appointed Honorary Consul General of Lithuania.

Last year Dr. Rosenbaum was relieved of his diplomatic post. He nevertheless remained in Palestine, making his home in Tel Aviv.

Dr. Rosenbaum was a holder of the Order of Prince Gedimin, conferred upon him by the Lithuanian government on the occasion of the celebration of his seventieth birth-

to our Jewish youth, in deference to their own future, to apprise them early of the facts as they exist today in this profession and in others? Much can be accomplished by careful fact-finding, planning, and education from within.

## CRITICAL TOMENTS By GEORGE JOEL

Shall Reporters Tell All?

There are many problems connected with the business of reporting what transpires on screens and behind footlights that puzzle me and about them I know no help is to be expected from readers. However, there is one phase of dramatic reporting about which these same readers could be of valuable assistance. Specifically, should a critic give his readers a complete synopsis of the play or picture he is criticizing?

Personally I feel that setting down the complete story of a theatrical production tends to spoil the fun of those who decide to go to see it. If a play or film has an unusual plot, or a surprise ending, by telling your readers what this plot or ending is, you certainly eliminate the element of surprise. I know that if I were to be given an exhaustive synopsis of a book, my interest in reading that book would be appreciably less and I don't see why this same test cannot be applied to things theatrical.

I believe a reporter has done his duty when he has given the reader some idea of the plot and thesis of the production. He should confine his comments to the plausibility of the author's idea and the manner in which the work is produced and acted. What do you think? I am very eager to hear your opinion.

Unexciting Theatrical Week

The week was unexciting the atrically. "Post Road," the semicomic melodrama about baby snatching, was the only piece worth mentioning twice. Although its reception by the critics was not unanimously favorable, most of the gentleman marked it down as better than fair entertainment. I concur.

The story of The Forty Days of Musa Dagh is a simple one. It deals with the wholesale "evacua- With Life of Cervantes tion" during the World War of a million Armenians from Syria into the Mesopotamian Desert by the Turks under Enver Pascha. Even the Turks themselves estimated that the "evacuation" would result in the death of ninety per cent of the people. It was a measure with only the sigilitest pretense of military necessity and it was motivated solely by the unreason-ing hatred of the Truks for the Armenians.

One of Werfel's greatest contributions lies in his description of the underlying nature of race hatred—the three basic reasons jealousy of greater industry and wealth of the people, religious contempt and hatred, and the desire for women of alien race.

But Werfel is not content to write of the tragedy of this wholesale slaughter. He has chosen one incident of the "evacuation," An Armenian, due to his wealth and his European education, has been able to overcome the docile acceptance so characteristic of his race, of whatever life may bring, and through his example to arouse to resistance, the people at the foot of Musa Dagh, "The Mountain of Moses." They encamp on the mountain and for forty days hold the entire might of the Turkish armies at bay. The eventual result of this gallant defense becomes relatively unimportant. All that retains significance is the satisfaction that lies in action itself. Here at last the Armenian people have given notice to Turkey and to the world that they will no longer allow themselves to be persecuted by an alien race.

Forty Days of Musa Dagh is, on the other hand, a stirring tale of gallant deeds and quiet heroism. On the other, it is Werfel's solution to the problem of the Jew. Werfel's method is that when one's back is to the wall, there are only two courses of action-meek surrender to extinction or heroic resistance, however slight the chance for recovery. And through the relatively unimportant incident of the defense of Musa Dagh, he has shown his choice.

The statement asserted that the Jews are aware that "these elements will never be taught better" except by strong action of the authorities, adding that the Swiss people are supporting its officials in their efforts to "exterminate" Nazi rowdies.



United States and Germany, especially as regards to nitrates, as constituting dumping. The German nitrates would replace those bought now from Chile at the price ordinarily paid for Chilean nitrates. This price is said to be below the domestic price in Ger-

The Treasury Department has been making an intensive investigation. The latest information is that Treasury lawyers were drafting an opinion which would say, in effect, that the trade of cotton for nitrates with Germany would not violate anti-dumping statutes.

The southern cotton boys are particularly pleased over the way things are developing. At first they feared they would be left with all of the cotton in their laps. What made the situation worse for them was the prospect of further increased production next year, and a greater cotton carry-over. George Peek, president of the Export-Import Bank, is doubly pleased because barter with countries unable to pay in cash is a pet idea of his.

In the event the cotton barter arrangement with Germany does go through, and there is but little likelihood now that it will not, the next problem will be the actual collecting of what is due, whether it be in the form of goods At the present time a number of European countries are having great difficulties with Germany in getting her to pay for what is received.

The Netherlands and the United Kingdom are having their troubles in getting Germany to pay for recent purchases. British cotton yarn producers recently refused to make further deliveries until overdue accounts were paid While an arrangement has worked out to make some sort of settlement, in the meantime the business went to Belgium, where cash orders were placed for practically all available stocks of yarn.

Trade relations between the Netherlands and Germany are reported to the United States Department of Commerce as being "in an unfavorable state. The clearing agreement negotiated in was denounced November 1, in part because of the alteration in the trade balance with that country (Germany) and because protest developed from its subordination of past-due current accounts. "This situation is resulting in new negotiations between the Netherlands and Germany. Meanwhile, however, "an important part of the capital of trading firms has been frozen in Germany."

Negotiations between France and Germany over the Saar Valley came as a pleasant surprise to Washington because it removes one of the dangers of another European conflagration. In view of the agreement between the two countries there is no doubt now who will be in possession of the Saar after the January 13 plebis-

Briton Relates Experiences on Trip to Reich

Met Only Bitter Hate for Jews, Colonel Says on Return

(Jewish Telegraphic Agency)
LONDON. — Returned from a visit to the Rhineland, the Ruhr, Berlin and several provincial German towns, Colonel E. W. Lennard reports that he failed to encounter 'a single 'Aryan' German who could discuss Jews without hatred or bitterness."

Colonel Lennard, in a series of articles on his experiences in the Bristol Evening Post, writes:

"To mention the question anywhere is to invite the repetition of statements and statistics that are unmistakably of propagandist origin and from a common source.

"I profoundly distrust most of the biased and one-sided 'facts' that everyone tried to thrust upon me as an explanation and extenuation of German treatment of her Jewish citizens. Much of it boils down to the truth that the Jewish one per cent of the entire population possessed better brains or were materially less unfortunate than some of their neighbors in the post-war days."

As soon as Jews were men-tioned, Colonel Lennard relates, the faces of "otherwise charming and reasonable people" would harden and a flood of invective would be loosed.

The utmost concession (and that by no means general) that I got was that while Jews richly deserved their fate both present or pending, it might have been better, in view of foreign opinion, to have 'spread it over' a little, and not to have been so prompt in denouncing and despoiling them."



Refutes Brundage

'The Congress message refuted the assertions of Avery Brundage that Germany will keep "her sol-emn pledges to uphold all principles upon which the Olympic Games and international sport are based." It affirmed that the conditions which led to the strong resolution of the A. A. U. last year not only continue but have been intensified.

The message further asserted that since Brundage visited Germany last Summer and since the formal vote of acceptance of Germany's invitation by the A. O. C. Germany has contravened the spirit and text of its promises.

In this summary of the entire situation, affecting Jews in sports from July, 1933, to December, 1934, the American Jewish Congress charges that none of the discriminatory decrees have been withdrawn. The communication was submitted by Bernard S. Deutsch, president.

Untermyer's Message

Samuel Untermyer, president of the non-sectarian anti-Nazi league to champion human rights, in an open telegram to Avery Brundage urged that the A. A. U. refuse to certify entries to the 1936 Olympic games if held in Germany. The telegram follows:

This is to renew protest of the Non-Sectarian League against holding Olympic games in Berlin on grounds stated in my letter to you dated September 26, copy of which being mailed you to-night with request that it and this message be read in their entirety to convention. Every promise made is being flagrantly violated by Nazi government. You are doubtless aware that Berlin Olympic Stadium has been pledged as barracks to Reichswehr after games and that everyone contributing through participation becomes supporter of Germany's militaristic policies. doubt whether any American sportsman will relish that situation. ### Race Prejudice Here Rapped by Justice

"Royal Scott Gulden and his Order of '76, of which my son was falsely accused of being a member, are un-American," Pelham St. George Bissell, President Justice of the Municipal Court, told a Jewish Daily Bulletin reporter Friday.

"Let me add," Justice Bissell continued, "that any organization which directly or indirectly makes for racial prejudice is abhorrent to everything this country holds sacred."

David Blum, the jurist's Jewish secretary, expressed anger at charges of anti-Semitism loged against Justice Bissell.

"I've known him for seventeen years," Blum declared. "Tve never met anyone more tolerant nor more friendly to Jews, both in deed and in thought."

Twice the ownership of the land was called into question, once under the old Turkish administration and again in 1925. Each time Jewish ownership was upheld.

"Another element opposing legislation to improve the immigration laws is made up of persons whose racial interests and prejudices warp their judgment as to the general interest. (This is especially true with many of Hebrew origin). Persons classing themselves as leaders have not grasped the fact, fully recognized by their more progressive and clear thinking associates, that the solution of their problem lies elsewhere than in spreading poverty and want from one overpopulated area to another through continued and uncontrolled mass migrations. We can sympathize with their feelings, but we cannot agree that what they are doing holds promise of permanent benefit to their own peoples, the United States or the world at large.

"This racial element has found that our country as a whole is in favor of limiting immigration. In the face of overwhelming evidence to this effect, they often give lip service to the principle of limita-tion of immigration, while opposing every effort that promises to make substantial limitation effective. They are therefore working to counteract the will of the people in another way."

### Warburg Among Donors Poultry Group **Ends Objection** To Trade Code

#### **Commission Merchants** Take New Stand in Surprise Move

An open hearing was held Friday at the Hotel New Yorker on a code of fair competition for the live poultry industry in the northeastern states. The proposed code, aimed at wiping out unfair trade practices and racketeering, met with almost unanimous support from live poultry dealers and slaughterhouse men present.

A surprising point in the hearing arose when Herbert Frankel, representing the New York poultry commission merchants, an-nounced that these former bitter opponents of the New York code now support it.

David S. Andron, representing the kosher butchers' group, asked protection for retail poultry sellers from competition of wholesalers who also sell retail.

He urged that kosher poultry retailing be placed under the code for kosher meat retailers because this code regulates closing of places of business on Jewish holidays and provides for kosher supervision. Failing adoption of this recommendation, Mr. Andron demanded that poultry wholesalers be forbidden to sell retail poultry as kosher.

He said the matter can be settled by negotiation between code authorities.

The regional code, estimated to cover an annual live poultry business of 75,000,000 pounds, is sponsored by the New Jersey Poultry Dealers' Association, the Retail Live Poultry Dealers' Protective A sociation of Philadelphia and the Greater Boston Live Poultry Slaughterhousemen's Association.

### Soviet May Aid Polish Jews

(Continued from Page One) the Agro-Yid, an organization interested in helping Jews migrate to Biro-Bidjan, will contribute \$150 for each Jewish family which the Soviet government permits to enter Russia and settle in Biro-Bidjan.

This contribution will be made on condition that the Soviet government guarantees to supply the families with houses and food in Biro-Bidjan and with at least one cow per family. The first 300 families will be permitted to settle in the Jewish region not later than the spring of 1935.

The Jewish Telegraphic Agency was informed today from most re-liable sources that the above conditions will most likely be accepted.

The memorandum to President Kalinin deals chiefly with the present desperate economic condition of the Jews in Poland. It has been known here that of the 3,000,000 Jews residing in the Polish republic at least 1,000,000 are suffering acute starvation due to the anti-Jewish economic policy of the government. Reports received here during the past few weeks disclose that the number of Jewish suicides in Poland is growing daily because of hunger and privation.

It is believed here that the Polish government, though not willing to see its citizens go to Russia, will nevertheless not make difficulties for those Jews who migrate to Biro-Bidjan, since Polish authorities are interester in seeing as many Jews as possible leave.
