Levy of \$4.10 per Dunam Will Affect Orange Plantations

(Jewish Telegraphic Agency) JERUSALEM, Jan. 7.—The new rural taxation ordinance in Paleswhich is considered highly etrimental to citrus planters beause of the increased tax imposed ipon land developed for orange rowing, will be enforced beginning January 13, it was learned here today.

This ordinance will impose a levy of \$4.10 on each dunam of and cultivated for orange plantaions. At the same time the ordinance provides a decrease of taxes on land devoted for grain.

Representations made by the Jewish Agency to the Palestine government against this ordinance have so far proved unsuccessful. The enforcing of the order will affect the export from Palestine of citrus products, which constitute the largest proportion of Palestine's exports.

It is expected that the increased axation will prevent many from developing new orange planta-tions. The tax will take at least ten per cent. of the average plantation income under normal circumstances.

The new ordinance, while high-ly detrimental to Jewish-owned orange groves, will prove highly beneficial to Arab fellaheen, toward whom the High Commissioner has been adopting a liberal policy.

See Blow to Press In New Brazil Law

Only Natives Are Permitted as Publishers; Papers Face Reorganization

(Jewish Telegraphic Agency) SAO PAULO, Brazil, Jan. 7 .-'All heads of publishing concerns and publishers of newspapers in this country must be native born Brazilians as a result of a law which went into effect today. The entire Jewish press of the country faces reorganization as a result of

Brazilian papers today were lavish in their praise of Dr. Horacio Lafer, Jewish member of parliament, who introduced a resolution calling for the recognition of the Soviet Union. Dr. Lafer formerly represented Brazil at the League of Nations in Geneva.

Palestine Imports Jump, Monthly Figures Reveal

(Jewish Telegraphic Agency) JERUSALEM, Jan. 7 .- During the month of July, 1934, Palestine imported \$5,715,000 worth of goods and exported \$245,000 worth, the government officially announced today.

Comparative figures show that in July, 1933, Palestine imported goods worth \$4,565,000 and exported goods valued at \$258,500.

In Palestine Statement by New Palestine That Wire Service Offered to Submit to Histadruth Censorship Scored as 'Libelous and Unmitigated Falsehood' by Landau

The statement contained in the latest issue of the New Palestine, official organ of the Zionist Organization of America, that Jacob Landau, managing director of the Jewish Telegraphic Agency, has offered to submit the J.T.A. to "fullest censorship" of the Histadruth-controlled Executive of the Jewish Agency for Palestine, was termed yesterday by Mr. Landau as libelous and an unmitigated falsehood.

"At the request of Mr. Ben-Gurion, Histadruth member of the Executive," Mr. Landau declared, "I submitted proposals to the Executive when I was in Palestine the early part of December. These proposals contained not a single word about censorship, nor was any such reference made in the conferences I had with Mr. Ben-Gurion and Mr. Shertok. Quite the contrary, during these conferences, which were always held in the presence of witnesses, I strenuously objected to submitting the J.T.A. to censorship or

Greeks Allot Sum | Mayor of Tel Aviv

\$50,000 Non-Sectarian Project Will Exclude Refugees From Turkey

(Jewish Telegraphic Agency) SALONICA, Jan. 7. - The Greek government today assigned 5,000,000 drachmas (approximately \$50,000) for a housing project for Christians and Jews, excludonly the Jewish refugees who fled recently from Turkey.

Governor General Pericles Rhallis declared that the project would prove a boon, since "one-fourth of the Jewish population was without shelter after the catastrophic conditions of 1918 and 1934."

Berlin Denies Reported Attempt to Kill Hitler

BERLIN, Jan. 7.—Reports that an attempt upon the life of Aolf Hitler had been made by two disgruntled storm stroopers were denied here today.

Rumor has it that Hitler, on the night of December 31, was shot at in the Chancellory. His chauffeur, instead, received the bullets, reports declared.

Attempts have been made to tie up the alleged try at killing der Fuehrer with the Opera House meeting last Thursday of government and party leaders.

The latest rumor is the third in the past few weeks of attempts upon Hitler's life.

Praha Forbids Work for 2,000 Reich Refugees

Edict to Protect Natives Takes Livelihoods From Many

(Jewish Telegraphic Agency)
PRAHA, Jan. 7.—Some 2,000
Jewish refugees from Germany who have been staying in Czecho slovakia have been left without hope of livelihood as a result of a new government order barring the employment of political refugees.

While the new instructions are intended to protect the native population, they strike at the many remaining German Jews of the thousands who sought haven here. Most of the original refugees who came here have managed to find more permanent refuge in Palestine, France and other lands.

In April of last year Dr. Eduard Benes, Czechoslovakian Foreign Minister, gave assurance to James G. McDonald, League of Nations High Commissioner for Refugees, that the Czechoslovakian government would do everything in its power to assist the refugees with passports and vocational training which would prepare them for life

Austria Envoy Gives Pledge After Request

Officials Join Cry for Boycott of Jewish **Businesses**

LONDON, Jan. 7. — Foreign Minister Egon Berger-Waldenegg's denial that Austria has discriminated against the Jews is the direct result of representations made to the Austrian Minister of Finance, Dr. Karl Buresch, by Sir Otto Niemeyer, noted banker, when Austria sought a loan in London, the Jewish Telegraphic Agency learned today.

Sir Otto, it was learned, vehemently reproached Dr. Buresch for the ill treatment of Austrian Jews by the present government, particularly the unjustified dismissals of Jewish physicians, nurses and teachers by municipal authorities in Vienna.

Dr. Buresch promised that Austrian authorities would withdraw all anti-Jewish measures and reinstate a number of the dismissed Jewish professionals, it was stated.

Revisionist Chief Opens **Annual Convention** in Krakow

(Jewish Telegraphic Agency) KRAKOW, Jan. 7.-Clad in the brown-shirt uniform of the Briting Trumpeldor, Zionist Revisionist youth organization, Vladimir Ja-botinsky, leader of the Revisionists, last night opened the second annual conference of the world Brith Trumpeldor organization.

In the course of a three-hour speech Jabotinsky outlined the history and purpose of the Britin Trumpeldor, declaring that the group now had branches in thirtyfour countries and 70,000 mem-

Revisionist Ideals

The ideological basis of the organization was a mixture of army training and school, which is "most suitable for the education of Jewish youth," Jabotinsky declared. He stated that 3,000 instructors are preparing the Brith Trumpeldor groups for "defense" on the basis of "self-sacrifice."

The movement, Jabotinsky said, in addition to "don'ts," had also seven commandments including: sacrifice for the Jewish state; Jewish defense; study of Hebrew; discipline; noble behavior; social sacrifice, and mobilization of the forces of Jewish youth.

Never Offered to Submit J. T. A. To Censorship, Landau States

Louis Lipsky's Desire to Protect Vested Interests Seen by News Service Head as Behind 'Deliberate Falsehoods' of New Palestine

"The arrangement would have been technical in nature and compensation was asked only with regard to the additional expenditure which the cabling and distribution of the Executive's news statements would have caused the J.T.A.

Insisted on Complete Independence

"If I had not insisted on maintaining our own service from Palestine and agreed to carrying nothing but news items offered by the Executive, it would have constituted acceptance of control or censorship. The J.T.A. would not have been responsible for any but its own service, and just because I insisted on the continuation of our own service and rejected control of the J.T.A. news, no agreement was reached.

"It is also untrue that in my proposals I declared myself willing to appoint a Jerusalem correspondent with the consent of the Executive. Nothing to this effect was contained in my written proposals nor in my conversations with Mr. Ben-Gurion and Mr. Shertok or at the time I met the entire

Charges Malicious

Distortion of Fact
"It is evident that the New
Palestine wishes to confuse the public by issuing such misleading statements. These statements published in the New Palestine are gress, deliberate and malicious disfortions of the facts. If the J.T.A. had maintined during its existence such a low standard of veracity, it could hardly have continued for seventeen years.

"The statement, for example, claims that the decision to establish the new service was taken in the spring of 1934. As a matter of fact, this service was already operating at the beginning of 1934, and in the official report issued in February, 1934, by the organiza-tion department of the Executive in London, reference was made to the fact that the service had been established.

J. T. A. Statement Reply to Executive

The New Palestine also quotes a statement by the Executive in Jerusalem in reply to the statement published in the Jewish Daily Bulletin with regard to these developments. As a matter of fact the statement issued by the J.T.A. was a reply to the statement issued by the Executive on December 18, or more than three weeks ago. It seems that the statement as published in the New Palestine has been embellished by some additional vituperative remarks. example, the statement as issued on December 18 in Jerusalem did not contain the following sentence: Other insinuations contained in the New York Jewish Daily Bulletin the Executive regards as beneath contempt.

"It would be interesting to establish whether the New Palestine did not take liberties with the statement of the Executive, and 1 wonder whether they could produce the cablegram showing that this sentence was included in the original statement of the Executive.

New Agency Serves

Only Histadruth

The New Palestine also claims that the new service serves no party. The most superficial perusal of the reports issued by the new service permits no doubt of its partisan character. The activities of parties opposed to the Histad-

ruth are completely ignored in the service, and at no time during its year's existence has this service carried even one statement emanating from an anti-Histadruth Zionist leader. Its obvious tendency is to glorify the present Histadruth - controlled Executive, quite apart from the fact that all other vital aspects of Jewish life are not dealt with.

"The statement in the New Palestine denies that any member of the Executive ever suggested that the J.T.A. be placed under the control of the Executive. The suggestion had already been made in the beginning of this year by Mr. Berl Locker, Histadruth member of the Executive, who is at present in New York. He repeated the suggestion only a few weeks ago when speaking with me and with Mr. Joseph Leftwich, editor of the London Bulletin of the J.T.A.

Suggested Control

Of Palestine J. T. A. "During the first talk which I had with Mr. Ben-Gurion and Mr. Shertok, the suggestion was made by them that the Palestine part of the J.T.A. be placed under the control of the Executive. The following day Mr. Ben-Gurion suggested that the Histadruth propaganda service be the representative of the J.T.A. in Palestine, and that the J.T.A. should not maintain any correspondent in Palestine. In the conversation between Mr. Ben-Gurion, myself and Mr. Braude, a well-known South African Zionist leader, Mr. Ben-Gurion stated for the first time that no control of the J.T.A. was desired.

"However, it is clear that by establishing the new service, the intention is to replace the J.T.A. by an agency which would be under the complete control of the Histadruth dominated Executive. In essence it would amount to the

fessor Brodetsky and Mr. Louis Lipsky. Dr. Gruenbaum, Dr. Ruppin and Professor Brodetsky in their talks with me indicated a desire that some understanding be reached and they were not the moving spirit in the catablishment of the new service.

"Mr. Lipsky, who owes his election to the Executive to Histadruth influence, has his own personal motives. When the J.T.A. received a cable that the manager of the Palestine branch of his insurance company had resigned in protest against the draining of all funds of the Palestine company in order to pay debts of the New York company, frantic appeals were made to the J.T.A. to withhold the report from publication by Mr. David Freiberger, lawyer and intimate friend of Mr. Lipsky. On the evening of that very same day, Mr. Lipsky began to hatch his plot for establishing a rival system, as can be proven by me.

Seeks to Protect Vested Interests

"Mr. Lipsky and certain other Zionist leaders do not desire any agency not fully controlled by them. It might bring out facts which might shock the public by revealing conditions which would destroy the position of leadership they hold today. It might reveal the high-handedness, the partisan favoritism and brutal machine policies which characterize the Histadruth Executive, a revelation that would shake the confidence of the public. To protect themselves against such possibilities and to safeguard vested party interests are their real motives.

"The many deliberate falsehoods contained in the statement which appeared in the New Palestine are characteristic of the unscrupulous tactics, worthy only of Tammany Hall politicians, which are employed by the editor of the New

Palestine.

Refutes Charges Of Zionist Editor

He claims in his editorial that the J.T.A. in its reporting stimulated and incited dissension. Friction between the parties in the Zionist movement had reached such unheard of proportions that Jews were attacking others, freely resorting to physical violence leading to actual blood-shed. This situation reached such dangerous heights that the British authorities urged the Zionist leaders to put their house in order. In giving a truthful record and by making the Jewish public aware of such conditions, the J.T.A. enabled Jewish opinion to exercise a moderating and sane influence on a leadership which was carried away by fanaticism and extreme partisan spirit. But to hide the true state of affairs from the public, to make it believe that everything is ideal within the Zionist organization and Palestine is the real aim of the Histadruth leaders.

Lipsky Inspired Party Strife

criticism sowed dissension is made by the very same Mr. Lipsky who has been responsible more than anybody else for creating dissension in the Zionist life of this country. He was mainly responsible for the split within the Zionist movement in 1922, preventing a truly solidified organization, and has been chiefly instrumental in the loss of prestige and strength of the Zionist movement, bringing it down to a position of insignificance and decay and reducing the influence of the American Zionist organization at the World Zionist Congress to almost naught.

"Lacking sincerity, conviction and consistency, inspired only by the desire to maintain his position, suiting his views to opportunistic considerations, a master of intrigue qualifying him for the position of a Grand Vizier at any oriental court. Mr. Lipsky has

turned the Zionist Organization of America into a hotbed of cabal and an annex of the Histadruth being at their beck and call for any service they might ask of

Non-Zionists Not Listed As at Conference

"It is interesting that among those whom the New Palestine mentions as present when the decision was taken to establish a new service, there is not a single name of a non-Zionist member of the Executive. It confirms my previous statement that the decision was taken by the Histadruth leaders and those who are intimately associated with or dependent upon them The Zionist leaders proceeded likewise in the matter of the loan where £500,000 of property was mortgaged without consulting the Administrative Committee of the Jewish Agency or its non-Zionist officers.

"The Histadruth leaders are imposing upon the Jewish people their own decisions without the pretense even of consultation with those who are carrying the responsibility with them.

Service Suddenly Becomes Private

The New Palestine mentions that the new service is a private company limited by shares. This step has been taken only now, after the service has been in existence a year. It is remarkable that the main argument against the J.T.A. was that it is a private enterprise. Having discovered that an official and partisan propaganda agency meets with opposition, the Histadruth propaganda service is being transformed into a private company, while the J.T.A. is at the same time criticized for being one.

"The sudden change throws light on the hypocrisy of the arguments used against the J.T.A. Mr. Lipsky and his henchmen are masters in the art of camouflage. Anxious to I gain the public confidence, their declared.

A Tireless Worker, S. A. Goldsmith Butchers Meet Began Welfare Endeavor As Youth

Born in New York, Now He Heads Chicago Charities

One of the speakers at the recent national conference of Jewish social workers who aroused the most spontaneous outbursts of applause was Samuel A. Goldsmith, executive director of the Jewish Charities of Chicago.

Direct, blunt, incisive of speech, Goldsmith is the epitome of sincerity and intelligently applied zeal in one of the most difficult of professions. His intensity, informed and brightened with a deep understanding of the problems of those he strives to aid, communi cates itself to any audience he addresses.

In a field where statistics sometimes tend to obfuscate the people around whom they have been collated, with deadening results for the statistician, Goldsmith has never permitted himself to be victimized by facts and figures. The statistics never become a Frankenstein; they're always under his thumb, put in the shade by his own vibrant personality and alert realization of the important but not all-important role they necessarily play in his work.

Relentless Worker

Goldsmith is of medium height, a bit heavy around the waist, on the swarthy side in complexion. In his brown eyes there's a sparkle dimmed only little by glasses. His sturdy frame, holding resources of physical energy, announces the secret of an ability to drive himself at a relentless pace that makes him the marvel of his associates in Chicago and his former colleagues in New York, where he was for ten years executive director of the Bureau of Jewish Social Research.

The Chicagoan, who was born in New York City, learned the value of driving himself at top speed at New York University, en 1911 and 1912, Goldsmith was a crack track man, competing as a two-miler, where endurance and the knowledge of how to conserve energy for a last-lap burst of speed is vital to success.

When Goldsmith wasn't burning Louis Lipsky addressed a Zionist ing up his opponents in the equally difficult field of forensic competition. He was captain of the debating team of New York University. Where his flying feet sometimes failed to humble an intercollegiate opponent, his cutting tongue seldom fell short of turning the trick for alma mater.

Sense of Humor

One of the noteworthy characteristics of this social worker from the gusty city is that the seriousness of his job hasn't injured his sense of humor.

He tells with relish two stories that represent the opposite poles of his job. One is of the time in 1922 when, as secretary of a special commission of the Joint Distribution Committee which was sent abroad to study conditions in various European countries, he arrived in Wilno.

There the commission was met by a fervent plea for aid by the heads of the Jewish community. The population of the city was destitute and terror struck because of the current occupation by Polish troops. Reflecting the demoralized state of the people, the leaders made a dramatic plea for several million marks. Then, apologizing for the size of the request one of the leaders explained as follows:

"You see, we ourselves have had to collect 3,000,000 marks to send to our brothers in the Volga dis-

To Form Trade Code Authority

Will Choose Board of 11 With Headquarters in New York

JDC and Polish Jewry

Leaders of the Joint Distribution Committee in America had a chance yesterday to hear a complete summary of the extensive JDC work in Europe, when Dr. Bernhard Kahn and Dr. Joseph Rosen presented their reports on the activities which they supervise in different countries.

At no other time has the IDC work been as important as at present when the Jewish communities of Poland, Austria, Germany and other countries are crying out for relief. It is not an exaggeration to say that the eyes of at least five million Jews are turned towards the JDC for assist-

Few know that in addition to the relief granted by the JDC in various European countries, it also spent not less than eight million dollars in Palestine. This huge sum is never sufficiently emphasized by those who speak of Palestine achievements. Thus the false impression is created that the JDC spends its funds anywhere but in Palestine.

In the light of reports now coming from Poland, it is only natural that the JDC should concentrate its activities on relief for Polish Jewry, both by enlarging its highly useful credit work in Poland and by seriously considering the possibilities of helping Polish Jews to migrate to Biro-Bidjan.

Everybody knows that life in Biro-Bidjan is hard and full of difficulties. So do the Jews of Poland. Nevertheless, if despite this knowledge they still wish to go to Biro-Bidjan. there is no reason why they should not be helped to do so, especially since there is no other country where they are admitted freely.

It is of interest to note that Polish Jews, when settling in Biro-Bidjan, are not supposed to become Soviet citizens. They still remain foreign subjects and can leave the country whenever they wish-within two years, if they find their experiences in Biro-Bidjan disappointing.

It is, however, the authentic opinion of Jewish leaders who visited Poland and have also studied conditions in Biro-Bidjan that the Polish Jews, when coming to Biro-Bidjan, will not be disappointed. That is why the Biro-Bidjan idea should not be dismissed.

Jermany Faces a New Year

(The following article by a correspondent of the famed Manchester Guardian is of particular interest at this time in view of recent developments in Germany and the many rumors of a weakening in Nazi power.)

In spite of appearances, the Nazi dictatorship is stronger than ever. It is true that there is widespread discontent in Germany-there is less enthusiasm, more grumbling, and far more indifference than there was at any time since Hitler became Chancellor. Dissatisfaction has even invaded the ranks of the Nazis themselves, although it is they alone who have, at the expense of all others, benefited by their counter-revolution. general standard of living has dropped, wages and salaries have fallen, taxes have risen. Favoritism and corruption are far worse than under the Republic. There is a shortage of raw materials, and the winter promises to be the worst since the winter of 1923-4, the last "inflation winter." Freedom has gone, the arts, letters, and learning have declined, and the Terror is as inhuman as ever.

Dictatorship Is

Not Weakened But the dictatorship is none the weaker. Nowhere is there a serious political opposition (the Protestant opposition is, of course, serious, but it has nothing to do with politics; the Catholic opposition is dormant, for it is not being roused and probably will not be roused until after the plebiscite in the Saar; then it will, no doubt, be serious). The S.A., or Brownshirts, who until the executions of June 30 were the foundation of the Third Realm, count for little now.

Thousands of Brownshirts have been converted into revolutionaries and are determined to avenge Roehm and their other murdered leaders. Some are trying to form terrorist groups -if there are any political assassinations in Germany they are most likely to be carried out by these groups,—but so far there is no sign of an organized Brownshirt revolutionary movement. As for the underground opposition of the Socialists and Communists, it is extraordinarily heroic, but it amounts to so little that it is not even a problem for the dictatorship.

Emigre Press In World of Illusion
The entire "emigre" press—

the Neue Vorwaerts, the Gegen-Angriff, and so on-is produced by people who either live in a world of illusion or are trying to create illusions amongst their readers when they talk, as they do in almost every issue, of the "weakening" of the dictatorship, of its "impending collapse," of the "rising revolutionary wave," and so on.

The dictatorship has power, and power, when skilfully and ruthlessly used, can grow indefinitely. The dictatorship has not even achieved the summit of its power-it is still gaining control over every nerve-centre of German life. There is, as yet no sign that this process of consolidation is coming to an end; nor is there any sign that the political opposition has finished disintegrating, even if there are certain embryonic movements that will, perhaps, be able to challenge the dictatorship in the remote future.

It is not true, as is being continually asserted, that Hitler is "in the hands of the Reichswehr." The executions of June 30 were certainly a victory for the Reichswehr and a defeat for

the S.A., but while that defeat was final the victory was not. The Third Realm destroyed its own foundation and simply shifted to another; but that other foundation was not the Reichs-

The Brownshirts were the embodiment of the National Socialist idea—that idea was massacred with Roehm and the other Brownshirt leaders-but the National Socialist party still exists and rules Germany more powerfully than ever. It has shed the Brownshirts, except for display, military training, and patriotic indoctrination, but it controls the bureaucracy, it controls the Secret State Police. and, in place of the Brownshirts. it has converted the S.S., or Blackshirts, into such an instrument of power and domination that they are rivals to the Reichswehr no less than the Brownshirts were.

The Growing Power Of the Blackshirts

Germany can hardly be said to possess a government in the normal sense. In any case, she is not governed by her cabinet. which seldom meets nowadays. Hitler himself is almost unapproachable, and is surrounded by nonentities. Goering and Goebbels have little influence and less power. Himmler, the commander of the S.S. and chief of the Secret State Police, is far more powerful than Goering and Goebbels put together. Hess, the leader of the National Socialist party, is also power-So is Dr. Schacht—to call him "economic dictator" is not far wrong.

The full strength of the Blackshirts is a secret. They probably number well over 300,000. They are picked men; they are free from the enthusiasm and idealism that characterised many of the more youthful Brownshirts. They are wellarmed and well-trained. They have the military value of the Reichswehr, but their principal purpose is not to make war In civil war they would probably be a match even for the Reichswehr (not that civil war is to be thought of in Germany.) In any case, all talk about a "Reichswehr putsch" or of the "Reichswehr arresting Hitler" has ceased. It is probable that by next spring the Blackshirts will be at least half a million strong.

Nazi Party Base Of Third Realm

The Reichswehr are, of course, a power, too. But they are not directly concerned with home affairs—their one interest at home is to secure money and supplies for rearmament (considerable sums which would formerly have gone to the Reichswehr now go to the Blackshirts). In foreign affairs the Reichswehr naturally have a considerable, though perhaps not decisive influence. They impinge on German affairs, but do not direct them. The Third Realm is not a military dictatorship.

The Third Realm is thus founded on the National Socialist party (including the bureaucracy), the Secret State Police known as the "Gestapo," the Blackshirts, and Dr. Schacht. If the Third Realm did not need the Reichswehr for the big decisions that are being prepared in foreign politics, it could do without it altogether.

In any case, the Nazi dictatorship has shown far greater skill and resolution in dealing with the military commanders than either the former Kaiser and the governments of Imperial Germany or the successive governments of the Weimar Republic showed.

From Victory

To Empty Victory
Hitler and his party have gone from victory to victory—and yet nothing is better than it was before, everything is worse. There is no reason why they should not win more victories —nor is there any reason to believe that things will not continue to get worse. It is known that Hitler himself is unhappy. Although he can look forward to further victories, he has become a pessimist. That is the paradox of the Third Realmthe greater the victories are, the emptier they are. The Nazi dictatorship has achieved everything-and nothing.

Nara Freed From Jail, Rearrested as Vandal

Between the Lines

The Harmful Anti-Yiddish Drive The anti-Yiddish persecutions in Palestine which lead to the expulsion of Dr. Rafalkes, Yiddishist lawyer, from the Tel Aviv Bar Association and to clashes last Saturday in a Tel Aviv theatre, are not at all helpful to the efforts now being made by the American Jewish Committee and American Jewish Congress to obtain a better status for Zionism and Hebrew in Soviet Russia.

By their drive against Yiddish in Palestine, Zionists are giving the Soviet government a good excuse for not permitting Hebrew in Russia. If Yiddish is not tolerated in a country dominated by Zionists, why should Hebrew and Zionism be tolerated in a country where Jewish questions are regulated by Yiddishists?

Fair Play Demanded

It is altogether difficult to understand why Yiddish is more discriminated against in Palestine than German, Polish and other languages. One can see on the streets of Tel Aviv posters in all languages. But when a paper in Yiddish is displayed, Hebrew extremists immediately raise a row.

The case of Dr. Rafalkes, Poale-Zionist leader who was expelled from the Bar Association in Tel Aviv merely because he issued a publication in Yiddish has no precedent in any civilized country. No one can challenge Hebrew as the language of Palestine, but at the same time none can agree with the semiterrorist methods used against Yiddish there.

A Dangerous Example

The Yiddish language should be given the same chance in Palestine as it is being given in any other country. There will be no crying if Yiddish eventually disappears from daily use in Palestine. This, however, must not occur by force. Once force is used, the impression is created that Yiddish is really the language which the majority of Palestinian Jews should like to

By suppressing Yiddish, the extremists are serving as a bad example for those countries where the Jews fight to win government subsidies for Hebrew as well as for Yiddish schools. The Polish government, in justifying its refusal to subsidize Hebrew schools, makes it a point that "if the Jews in Palestine are so nationalistic as to demand nothing but Hebrew, why should we not follow the same system and demand nothing but Po-

Executive Should Step In

There are today thousands of Jews entering Palestine monthly from every part of the world. The majority do not speak Hebrew. Most of them, however, do speak and read Yiddish. By the drive against Yiddish, these thousands are practically deprived of their native language. This is not only abnormal, but is also a grave injustice.

The Executive of the Jewish Agency should see to it that the semi - terroristic campaign against Yiddish in Palestine is discontinued. Otherwise obstacles are put in the way of those American organizations which should like to see Zionism permitted in Soviet Russia and Hebrew looked upon more favorably there.

At a meeting of the recently formed Physicians Equity Association of America, Dr. Harold Hays,

who is the moving spirit of that organization, told the following pointed story:

A doctor in Deposit, N. Y., was roused out of bed one night by the telephone. The voice at the other end



asked him what he would charge for a call at the town of Walton, N. Y. The doctor thought a moment and fixed the price at six dollars. The other agreed and said he would be right over.

The doctor then dressed, brought his car out of the garage and drove the man to Walton. When they reached the main street, the stranger handed him six dollars and told him he could return to Deposit.

"But where's the patient?" the amazed doctor inquired.

"There isn't any," his passenger smiled. "The taxi driver in Deposit wanted ten bucks to drive to Walton. I was sure a doctor would take me for less.'

No Standard Fees

The anecdote was by way of illustration of the lack of all economic standards in the medical profession. At one end, famous, fashionable and occasionally over-M rated doctors receive fantastic At the other end, doctors with less business acumen or less luck are content to get anything.

Dr. Hays is doing a major public service in calling attention to the difficulties of the medical fraternity. After long years of study and unpaid work in hospitals and contributions of time and talent to philanthropic causes, the doctor is left without effective protection against hard times, against governmental competition and against exploitation of his deficient sense of business.

Free, or nearly-free hospitals, health services by large corporations or by social service organizations certainly deserve public commendation. At the same time it must not be overlooked that such institutions take the bread out of the physician's mouth. The upper strata of overpaid and pampered practitioners, in this as in other professions, are not affected. The lower lays of underpaid, overworked and chronically worried practitioners are hard hit.

Organization Advocated


Socialized medicine in which the physician would be guaranteed a decent minimum standard of living and be left free to work without economic worries-is one thing. The present in-between system, in which doctors are expected to practise privately while publicly-financed institutions make ever deeper inroads upon their private domain, is another.

It is the contention of Dr. Hays and those associated with him in the Equity organization that the problem of economic justice and economic safety for the medical man should be solved by the doctors themselves, through organization, precisely as other professions are trying to solve theirs.

They ask, in short, for the equivalents of a code and a New Deal for physicians.

Jewish doctors are so large a part of the medical profession, and so many of them are on the sheer brink of abject poverty, that the problem has its place in these col-

Digest of World Press Opinion

Airs Problem of Legislative Council

Will there or will there not be a legislative assembly in Palestine?

The Near East and India, semiofficial organ of the British colonial ministry, answers this question by publishing the following editorial:

Sir Arthur Wauchope allowed little time to elapse after his return to Palestine before replying to the criticisms that had been evoked by his previous references to the establishment of a Legislative Council. Taking advantage of the presence of an Arab deputation which had come to complain to him about Jewish immigration, the High Commissioner stated that the British Government stood by its declaration of 1930 regarding a Legislative Council. A reasonable period will be allowed for an examination into the working of the new Municipal Councils, and in the meantime discussions will be inaugurated with Arab and Jewish leaders to consider the Government's proposals for the establishment of a Legislative Council. When these discussions are opened it will, no doubt, be found that many of the fears aroused by the preliminary announcement rest on no solid foundation.

As in the case of the Indian Constitution, safeguards will play an important part in connection with the Palestine Legislative Council; the peace and security of the country will be assured, and no opening for infringing upon the terms of the Mandate will be given. It is essential however, that the leaders of the Jews and Arabs, who have made no effort of their own in this direction so far, should

terest the public as well. Adequate compensation for doctors in charitable or semi-charitable institutions is essential. In fact, some form of relief for doctors in economic distress, from all I hear, is essential.

A great deal is said about the doctor's duties to the public. Much has been made of his heroism and devotion and pioneering courage. be provided with an opportunity for meeting in conference, for facing one another when they make their charges one against the other and for understanding one another better than they do

On the Jewish side many arguments are adduced in support of the contention that it is premature to give Palestine a Legislative Council. Individually they may be legitimate and useful debating points, but singly and collectively they have no weight against the palpable fact that the present unsatisfactory state of affairs in regard to the relations between Jews and Arabs cannot be allowed to continue indefinitely. In every sphere other than the political, Jews and Arabs are co-operating; such antagonism as there may be is almost exclusively confined to or inspired by the politically-minded on the two sides. As far as is known, no other suggestion for ending this state of affairs, apart from bringing the parties together in Legislative Council, holds the field. A policy of drift does not meet the situation; yet that would seem to be the only alternative offered by those who oppose the establishment of a Legislative Council.

Chronicle Attacks Stand on Quotas

The Wisconsin Jewish Chronicle comments editorially on the suggestion by Max . . Steuer and Dr Samuel Kopetzky for a quota for Jewish medical and law students in American universities:

Any non-Jew bold enough to advocate that the Jews of America be reduced to second-class citizenship and be compelled to live within the walls of a medieval-type ghetto would be immediately pounced upon as an arch anti-Semite of the most virulent stripe. That any Jew might make such a declaration could only be conceived as the irresponsible mouthing of a lunatic. And yet, in effect and carrying out their statements to a logical conclusion, that is exactly what Max D. Steuer and Dr. Samuel J. Kopetzky have unwittingly involved themselves in when they declared themselves in favor of a quota for Jewish medical and law students in American universities.

Mir. Steller is a Jew who has

achieved national distinction as the most successful criminal lawyer in New York. Dr. Kopetzky is president of the medical board of Beth Israel Hospital, New York, and is undoubtedly a highly successful physician. As authorties in their respective professions we do not question their eminence, but as commentators on what we regard as one of the most fundamental of all Jewish civil rights in America, they have shown a woeful lack of that analysis and judgment which any professional man ought to apply to any important question in or out of his own particular field.

Disabilities In Poland

Under the headline, "The Barred Windows of Warsaw," the B'nai B'rith Magazine publishes the following editorial in its current issue:

News reports brought strange from Warsaw last tidings month. Iron bars being put up against the upper windows of tenement houses in the Jewish district.

And why?

Jews were throwing themselves from windows. The number of suicides among Jews in Warsaw was increasing alarmingly.

And why were Jews killing themselves? Tews to whose traditions suicide was abhorrent? Many Jews killing themselves?

Jews in Poland have come alost to beggary. Even thousands who were well-to-do eat the meager bread of charity. Evil for all men are today's economic conditions in Poland, but if there is a crust for others there is only a crumb for Jews.

If work is scarce, the way to make more work is to keep the Jews out of the trades. If professional men . . . lawyers, doctors . . . are impoverished, the way to do is to set bars up against Jewish doctors and lawyers. If the business of merchants languishes the way to help the Polish merchants is to destroy competition by oppressive taxes against Jewish merchants.

Thus by a slow crushing Poland has accomplished in a number of years what Hitler did by a stroke in Germany. The German method may be the more efficient, but the Polish way is more diplomatic.

Polish Jewry Sounds Appeal For More Help

Resolutions Cite Grave Economic Plight of Community

(Jewish Telegraphic Agency)

WARSAW, Jan. 7.—A group of resolutions passed at an extraordinary conference of Polish Jewish leaders here, stressing the grave plight of Jews in this country and importuning increased help from abroad were before the Jews of the world today.

The dangerous economic situation threatens the physical existence of Polish Jewry, which is now living through the most fatal epoch in its history, the first resolution declares.

Polish Jewry is forced now, more than ever before, to appeal to Jews in other countries for brotherly help, which will stimulate the organization of its own powers, it was pointed out.

Aid Called Inadequate

Sums granted to Polish Jewry last year from drives in other countries not only were inadequate to meet the needs occasioned by its plight but also were not in proportion to the total amount raised by the American Jewish Joint Distribution Committee's campaign for European relief, the group decided.

Another resolution states that every form of large-scale social aid work ever created here by Jews is now on the brink of collapse. and that orphanages, professional schools, educational institutions and medical services are unable to carry on, in the light of Polish Jewry's dire poverty, unless assistance is given from outside.

Plea for Succor

"We regret to state that in recent years the American Jewish Joint Distribution Committee has failed almost entirely to assist the free loan societies toward their important work in supporting the existences of tens of thousands of Jews, and therefore this assembly turns to Jewry abroad with a plea for brotherly aid to pauperized Polish Jewry, to enable it to maintain its economic position by assisting it in proportion with the requirements of the Polish Jewish community, which numbers 3,500,000 persons," the concluding resolution declares.

Rabbi Dr. M. Schorr presided at the conference, which heard the appeals of numerous Polish Jewish leaders.

essay is W. C. Fields and the inspiration is his latest picture, "It's a Gift," now current at the Roxy Theatre. Before going into the inricacies of this exposition, I must cell you "It's a Gift" must receive serious consideration as one of the funniest films of the new year. If comedy such as this is to become the standard of 1935 we are in for some heavy and hearty laughter.

W. C. Fields is one of the oldimers. For many years his antics on the vaudeville stage kept audiences throughout the country in a constant uproar. But when raudeville declined Fields found fewer and fewer outlets for his comedy and about three or four years ago discovered he was an actor without a public. Motion pictures beckoned rather coyly. He was ex-pected to start as though he were beginner.

Directors could see little possibilities in his type of humor. Fields knew his own worth and efused to go West until he was assured of a real chance. It finally ame, but not until half a dozen 3roadwayites who had gone to Hollywood had practically insisted ipon getting Fields a tryout. The est you know-within two years ne has become one of the best boxoffice attractions in the business.

Pantomime . . . As a comedian W. C. Fields has lemonstrated that not even the alkies have made pantomime impossible. Unlike many of the aleged funny men, Fields is not dependent upon the story written for him. Certainly "It's a Gift" has little in the way of a plot. It concerns a hen-pecked grocer and his dream of an orange ranch in California. With his ever-talking wife and two children he sets out in an automobile for the promised land and arrives there only to find that his ranch-is a barren spot, but a wish-fulfilment" ending is added to the story and Fields, who plays

What places Fields so far above his contemporaries is his keen sense of the ridiculous. Give him a situation such as trying to shave in a crowded washroom without a mirror and he is able to squeeze out the last drop of humor; or show him trying to get a night's sleep in a din-ridden house and again his dire unhappiness is turned into farce that will bring smiles even to a "bluenose." Fields has the magic touch. His blundering, fumbling inability to do such simple tasks as lighting a cigar, starting an automobile or even drinking a cup of coffee makes us all feel so warmly superior.

Opportunity Beckons

As I intimated, the plot of "It's a Gift" is thin stuff, but it enables Fields to be on the screen almost constantly and there is never a moment when you become tired of him. One of these days a real script will be given the great comedian and then you will have a really memorable picture, something that will equal Chaplin at his best.

Aiding Mr. Fields in "It's a Gift" you will find Kathleen Howard, who as the nagging wife helps make Fields' actions justifiable. Baby LeRoy is also in the cast but he adds very little to the general hilarity.

On direct orders from Hamburg, Germany, Deckert was deposed and charged with having cooperated with Socialist organizations dominated by "Jews, Jesuits and Masons." He was also accused of having antagonized American pro-Nazi groups by refusing to fly the swastika at meetings of his organization. Deckert is to be tried by a "court of honor."

A. J. Congress Disclaims Blame For Students' Anti-Fascist Row

The American Jewish Congress refuses to shoulder responsibility for recent demonstrations against a visiting Italian student delegation, pointing out that it has no connection with colleges at which the outbreaks occurred and that it does not consider itself in a position to pass judgment on the actions of any part of their student bodies, a communication sent by the Congress to the Federation of Italian Jewish Communities in reply to the latter organization's letter deploring the incidents revealed yesterday.

Joshua L. Goldberg, national secretary of the Congress, referred the Italian Federation's letter to Professor Morris Cohen, head of the philosophy department of the College of the City of New York, who wrote in return that in his opinion the demonstrations were in no way Jewish in origin.

Disclaim Responsibility Mr. Goldberg's letter to the Italian Jewish body follows in part:

"The American Jewish Congress is neither in a position to speak nor to pass judgment upon the actions of all or any part of the student bodies of the colleges of this country. For this reason we took the liberty of referring your communication to Professor Morris Raphael Cohen, asking him to be good enough to enlighten us as to the facts. Herewith we beg to enclose a copy of his reply.'

Excerpts from Professor Cohen's letter to Mr. Goldberg, a copy of which was forwarded to the Italian Federation, follows:

Students Fear Fascism

"I . . . am very much pained that any one should get the impression that the demonstrations against the visiting Italian students (G. U. F.) were in any way Jewish in origin. I am sure that no one acquainted with conditions in American colleges would subscribe to this view. The recent years of economic depression have led some Americans to entertain the idea that possibly we might do better if we abandoned our more democratic institutions.

"This has naturally provoked and intensified the fear among our liberally minded youth lest this should lead to a real loss of our traditional liberties and democratic or parliamentary institutions. As the impression has spread in this country that the visit of the Italian students was in the nature of propaganda for Fascism, it naturally provoked demonstrations from those of our students who felt that such foreign propaganda must be fought at every point.

Pelley has since undertaken the publication of a new organ, Pelley's Weekly, in which he charges the Jews of the United States with having deliberately plotted his undoing. He once was a well-known author and Y. M. C. A. worker, later bobbing up as an anti-Semite. His organization was investigated by the Congressional Committee investigating subversive activities in the United States.

delle Israeliticha Italiane (Federation of Italian Jewish Communities) is perfectly correct in insisting on the difference between Fascism and Nazism in their relation to the Jews. But I think that American Jews generally are aware of this, and appreciate the consideration and freedom allowed the Jews by the Italian govern-

"It is true that one of the worst demonstrations against the G. U. F. took place at the City College, where a majority of the students are Jews. But this was the result of an unfortunate series of circumstances independent of the fact that there are so many Jews among our students. . . . '

"Jewish Fascists" Scored

Shops Bombed By Naras; One Seriously Hurt

Wawer Merchant's Arm Amputated—Wilno Store Damaged

(Jewish Telegraphic Agency) WARSAW, Jan. 7.—Jacob Finkelstein, Jewish merchant of Wawer, Poland, was seriously injured today when a bomb was thrown into his shop by anti-Semites. He was rushed to a hospital, where one arm was amputated immediately. His condition was described as critical. The shop was completely destroyed by the explosion.

Nara anti-Semites are suspected of the bombing, since the town is a Nara stronghold and the group has recently carried on intense anti-Jewish agitation.

Bomb Causes Damage In Jewish Bookstore

(Jewish Telegraphic Agency) WILNO, Jan. 7.—A Jewish book shop owned by M. Icowicz was destroyed last night when a bomb was thrown into the store. There were no casualities, but the damage is believed to be heavy.

Buresch's Promise Clouded in Mystery

(Jewish Telegraphic Agency) VIENNA, Jan. 7.—All attempts made here today have failed to ascertain from Austrian Jewish sources whether the promises made in London by Dr. Karl Buresch have had any practical results as far as a let-up in the anti-Jewish program of the government.

Austrian Officials Call For Anti-Jewish Boycott

(Jewish Telegraphic Agency)
VIENNA, Jan. 7.—Despite the promise given by Finance Minister Dr. Karl Buresch in London that the Austrian government would end all anti-Tewish meas ures, government officials, members of the Fatherland Front, are issuing propaganda calling for a boycott of the Jews, Stimme, organ of the Austrian Zionists, revealed today.

The paper published an invitation, officially circularized by the government, urgently calling upon all Austrians to buy only from "native, Christian shop owners." The document was issued by the economic section of the Fatherland Front.

The Austrian film industry has introduced complete "Aryanism." the Neue Welt, published by Dr. Robert Stricker, reported today. Two new films, "Asef" and "Traveling Into Youth," are pure "Aryan," the paper stated, adding that not a single Jewish artist, technician or laborer was employed in the creation of the two films.

Fur Workers File Protest On Extortion

Give Reply to Dickstein as Insurance Parley Opens in Capitol

(Special to the J.D.B.)

WASHINGTON, Jan. 7.-Representatives of the Fur Workers Industrial Union today filed a formal protest with Representative Samuel Dickstein, vice-chairman of the House committee to investigate un-American activities, against recent testimony given the commit-tee to the effect that the union was extorting three per cent of the New York fur trade payrolls.

Irving Potash of New York City headed the delegation of twenty persons, and filed the protest with Representative Dickstein's secretary. The Congressman was reported out of the city. Failing to see him, the delegates decided to picket his home in New York City to force a public hearing on charges made against the union.

3,000 Attend Congress

The delegation was one of several groups representing various types of organizations, including Communists and Socialists, meeting here as the National Congress for Unemployment and Social Insurance. The 3,000 delegates attending the congress swarmed legislative and executive offices of the government today with resolutions adopted at the close of the sessions this morning.

Hundreds of delegates paraded through the halls of the Capitol to interview representatives and senators. The protest by the fur union pointed out that the Needle Trades Industrial Union, through a strike and through collective bargaining with the employers in the fur industry, has established an unemployment fund to which employers are contributing from one and one-half to three per cent of their payroll.

Secret Probe

Since establishment of this fund, it was stated, the employers have contributed about \$150,000, of which about \$75,000 already has been distributed to unemployed workers in the fur industry.

The House committee investigating un-American activities recently conducted a secret investigation of this fund. Employers in the New York fur industry testified that this fund was built up through extortion. Resenting this charge, the union delegates registered their protest, requesting that a public hearing be called to air the charges.

Leipsiger Rites Scheduled Today

Former Department of Correction Secretary Was Active in Politics

Funeral services will be held at 2 o'clock this afternoon at West End Funeral Chapel, 200 West Ninety-first street, for Moses S. Leipsiger, 59, former secretary to the New York City Department of Correction, who died on Sunday at his home, 176 West Eighty-seventh street, after an illness of almost a year's duration.

An associate of Marshall Ingram, Tammany leader of the Seventh Assembly District, Mr. Leipsiger was active in the Amsterdam Democratic Club of which he was secretary. He was appointed to the Department of Correction post in October, 1931, by Richard C. Patterson Jr., and continued in that office until January 1934. At one time he was a deputy collector of internal revenue.

Surviving are his widow, Mildred, two brothers and two sisters.
