# **Seeks to Curb** Nazi Libels In Austria

#### Law to Halt Anti-Jewish Propaganda Demanded by Volksbund

(Jewish Telegraphic Agency) VIENNA, Feb. 25. - A law to censor libelous anti-Jewish propaganda in the press was demanded today in a memorandum submitted

the Jewish Volksbund here. The memorandum emphasizes that such legislation is necessary in order to secure protection for the Jews against inflammatory attacks which the Nazi press in Austria is now conducting.

The Neuewelt, a German Jewish newspaper published by Dr. Robert Stricker, well-known Jewish leader, today published an article complaining that all efforts to prosecute the Nazi papers in court for their false allegations against the Jews are useless under the present laws which provide no opportunity for bringing a libel suit against anti-Jewish slanders.

"The anti-Semitic attacks which the Nazi newspapers in Austria are now conducting supersede the Jew-baiting propaganda conducted by the notorious Julius Streicher in his publication Der Stuermer in Nuremberg," the Neuewelt points out. Something must be done by the government to enable Jews to seek redress and to halt the libelous campaign which the Nazi press in Austria is now conducting against the Jews and which is assuming dangerous proportions, the Neuewelt demands.

#### Danzig Journalist Sues Streicher for Libel

(Jewish Telegraphic Agency)
DANZIG, Feb. 25.—An interesting case against Julius Streicher, notorious Jew-baiter of Nazi Germany, and his Danzig agent Bruno Schnarkovsky will come up in the Danzig court as a result of a libel suit brought here by a Jewish journalist, Sam Glicksman.

Glicksman bases his suit on a number of anti-Jewish articles which appeared in Der Stuermer, rabidly anti-Semitic publication issued by Streicher in Nuremberg and distributed by Schnarkovsky in Danzig. Schnarkovsky is a member of the Danzig police

#### Haifa Gives Ship Big 'Bon Voyage'

(Jewish Telegraphic Agency) HAIFA, Feb. 25. - A colorful celebration was held here today prior to the Jewish steamer Tel Aviv's departure on its first trip to Trieste. The ship was richly decorated for the event, bearing the flags of all nations, including the blue-white standard with an emblem of the city of Tel Aviv.

District Commissioner Keith-/Roach greeted the assembly in the name of the Palestine government. Arnold Bernstein, owner of the vessel, was among the speakers.

#### Jew Beats Nazi Boxer; Won't Pose With Him

WARSAW, Feb. 25.-Fighting against his own will and under orders of the sports authorities in Poland, Schepsel Rotholz, Jewish boxing champion, scored a sensational victory over a Nazi opponent, defeating the ace boxer of the German team, Herr Weinhold, in the Warsaw-Berlin boxing match which took place today in Warsaw Circus. The Polish team won, 9-7.

The Jewish champion refused to allow his photograph to be taken with the Nazi boxer after the fight was over. He received a tremendous ovation from the audience.

### Reject Demand For More Aid in Jewish Schools

#### Palestine Turns Down Vaad Leumi's Plea for Higher Subsidy

(Jewish Telegraphic Agency)

JERUSALEM, Feb. 25.—Despite the large income which the Palestine government is deriving from Jewish immigration into Palestine, the authorities today refused the demand of the Vaad Leumi, the Jewish National Council, that the government subsidy for Jewish schools should be increased.

The Vaad Leumi, in its demand to the government, pointed out that the small subsidy now granted the Jewish educational system must be enlarged in accordance with the proportion of Jewish/pupils in Jewish schools. In reply, the Palestine government informed the Vaad Leumi that it did not agree with its viewpoint.

Since the Arab school system in Palestine is fully maintained at government expense, Jewish leaders here declare the government is not justified in rejecting its demand for a proportionate increase in the subsidy for the Jewish school system.

# Ask Hospitals Train Youth In Medicine

#### Suggestion Is Made by Seligmann, Berlin Health Leader

(Jewish Telegraphic Agency) BERLIN, Feb. 25. — A suggestion that Jewish medical organizations and Jewish hospitals start the training of a new generation of Jews in medicine in Germany since Jewish students are almost entirely barred from the German medical schools was made here today by Professor Dr. Seligmann head of the Health Department of the Berlin Jewish Community.

Dr. Seligmann pointed out that a number of Jewish medical students who could no longer study in the German universities have resumed their studies in foreign universities. They are, however, lost to German Jewry since they will in all probability never return to Germany.

"Must Make Room"

"Jewish public opinion," Dr. Seligmann urged, "and the Jewish medical self-aid organizations must do something toward the training of a new generation of Jewish doctors. The Jewish hospitals and similar institutions will have to make room for them, to enable them to complete their training and obtain appointments."

difficulties Enumerating the which Jewish medical students encounter at present in pursuing their studies in Germany, Dr. Seligmann pointed out that many institutions, such as those in the city of Berlin which were previously open to Jewish students, are now closed. A few scattered Jewish medical men are admitted to some of the university clinics and denominational institutions, but the great mass of them are crowding the antercoms of the few Jewish hospitals in Germany. The number of openings is naturally very limited. Eight such institutions can find room for only thirty-eight practitioners, Dr. Seligmann con-

#### Erin to Trade Cattle For Palestine Fruits

# **Report of Peace MovebyPoland** Termed False

#### Dr. Thon Denies Parley to Bring Jews and Regime Together

(Jewish Telegraphic Agency)
WARSAW, Feb. 25.—A sensational report that representatives of the Polish government would hold a joint conference with representatives of all Jewish groups to improve the relations between the Jews and the government, was termed here today as "complete invention."

"Nothing is known to me about such a conference," Dr. Joshua Thon, the president of the Jewish Parliamentary Club, stated. "The entire report is probably an invention. Authoritative Jewish quarters that should surely be informed of an alleged Polish-Jewish conference, have no knowledge of it whatever."

The report of the "peace conference" between Jewish representatives and the Polish government was apparently circulated in connection with the open friction that has reached such proportions that the Jewish members of the Polish Parliament were compelled officially to record in Parliament the charge that the Jewish population in Poland is highly dissatisfied with the policy of the present government to attempt to reduce the Jews to poverty by overtaxation and discrimination against them in public and State service.

#### **Actions Committee Will** Settle Date of World Parley

(Jewish Telegraphic Agency) LONDON, Feb. 25.—The World Zionist Executive announced today that the meetings of the Actions Committee, known as the "Little World Zionist Congress," will open on March 27 in Jerusalem.

More than 100 delegates from all parts of the world will participate in this gathering at which the numerous questions concerning the political interests of the Jews in Palestine will be decided upon. Problems of economic interest in Palestine are also on the agenda and will be widely discussed at the

#### To Settle Parley Date

One of the intriguing questions which the session in Jerusalem will be called upon to decide is whether the next World Zionist Congress is to be held this Summer or postponed for another year. It is expected that the session will decide in favor of holding the Congress at the end of the coming Summer in one of the Central European countries.

The Actions Committee will hold its sessions in the Jewish Agency Executive building. This is the second time in two years that the Actions Committee is meeting in Jerusalem.

The present convention, it is expected, will take up at length the problem of subordinating the Zionist Revisionists to internal discipline of the Zionist party, A serious decision which may affect the status of the Zionist Revisionists may be adopted at this session.

# Cabinet's Decree on Jobs Reveals Animus Against Jews of Rumania

### Seen Determined on Discrimination

(Jewish Telegraphic Agency) BUCHAREST, Feb. 25 .- The extent to which Jews are restricted in all phases of employment in Rumania is indicated in a number of protests lodged this month by the Union of Rumanian Jews against an order issued by the Minister of Industry aimed to bar Jews from employment in commercial and industrial enterprises.

The order clearly shows how the present cabinet, which consists of members of the Liberal party, is determined to discriminate against Jews in every walk of life. It is a terrific blow to numerous Jews in Bukovina and Bessarabia where the Rumanian authorities refuse to naturalize the Jewish population despite the fact that they

Observers of the economic development in Palestine have recently noted a new revival in one of the country's oldest Jewish industries. In recent years, so much attention had been focused on the various branches of the citrus industry that profitable and sound agricultural Palestine enterprises have become synonymous with orange plantations. That Palestine once derived great benefit as

well as reputation in the world's markets through its wine industry neronne Grandes Caves of Rishon has almost been lost sight of.

The fact of the matter is that when the first steps were made to create in the Holy Land a new Jewish agricultural class, the vineyards rather than the speculative orange growth, was the center of attention. The late Baron Edmund de Rothschild, who single-handedly did as much, if not more than all groups or agencies combined for the sound development of the country and of the Jewish agricultural settlement, invested about 50,000 francs in the furtherance of the Palestinian wine industry.

The record of the first colonies, such as Rishon Le Zion, is the story of the struggle of the pioneers to replant the vine on the ancient soil, to learn again the art of cultivating the grape, to produce, under modern conditions, what was destined to become universally known as Carmel wine, and to open for this product the world market. To this end, the late Baron Edmund de Rothschild established the famous wine cellars in Rishon, now ranked the second largest in the world.

The march of events in the world's history temporarily played havoc with this Palestinian industry. The World War, followed by prohibition in the United States, closed what were formerly the largest markets for Carmel wines. With Russia and the United States out of the picture, and with the impoverishment in Eastern Europe the Carmel wine industry suffered a serious decline. The decline assumed such serious proportions as to cause some of the colonists to abandon their vineyards, not infrequently leading to the uprooting of the valuable vines and parceling off the land into real estate lots.

Two factors are now contributing to the new revival of the Palestine wine industry: the repeal of the Eighteenth Amendment in the United States, and the considerable growth of Jewish population in Palestine since the advent of Hitlerism. These events have, in the first place, created an internal market, in Palestine itself, and in the second place, have opened up the prospect for selling large quantities of Carmel wine to the United

# Between the Lines

A Jewish University in U.S.A. Jewish students in the United States are now proposing that a Jewish university be established in America, as many Jewish students are finding it difficult to enter general universities throughout the country.

This project, dismissed as it may be at first glance by many, deserves serious consideration. There are numerous Catholic colleges and universities in the United States. There are special universities of oher denominations. Why not also a Jewish university?

Many will be surprised to learn that Professor Einstein has long urged the necessity of establishing a Jewish university in America. Such a university need not be limited to Jewish students only. The faculty as well as of Jews. The doors of the Jewish university should be open to all.

A Popular Idea

The idea of establishing a Jewish university in the United States will no doubt find a wide echo not only among nationalistically inclined Jews but also among those who are entirely Americanized. It is those Americanized Jews who feel it most keenly when they are rejected from certain universities in the

The recent advice given by the dean of Wesleyan University to Jewish students not to crowd the fields of medicine and law only proves that it is high time for Jews in America to think about establishing a Jewish university. No such advice would be in place if a Jewish university were in existence.

There are plenty of Jewish professors today who would make up a brilliant faculty for a Jewish university. Many famous professors from other countries could also be attracted to its faculty. A Jewish university in the United States would have every opportunity to become one of the most popular institutions of higher learning in the world.

#### Financial Possibilities

Universities in the United States are conducted chiefly on a business basis. Very few of them are maintained by State funds. Almost all of them are obliged to cover their own budget. Under such circumstances. there is no reason to fear that a Jewish university would be more of a financial burden than the average university in America.

The Jews of the world must have at least one university somewhere. The Hebrew University in Palestine is more of a research school than a university in its proper sense. It lacks the colleges of medicine, law and of all those sciences to which Jewish students are chiefly attracted.

A Jewish university in the United States would include these colleges. It would be a real university. It would serve as a challenge to those countries where Jews are barred from universities. It would solve one of the most difficult problems for European Jewry and would be of assistance to those American Jewish youths who under the present circumstances are not at ease in many of our American universities.

#### Sees Hope for Jews Only in Soviet

The Manchester Evening News, commentnig on Mr. Sacks' book on "Jewish Problems," which appeared in London, says:

#### Excerpts From Reich Heathen Code

# Dpera 'Moses' Will Be Shown AtHippodrome

#### Rossini Pageant Was Last Seen in New York in 1860

For the first time in this county since 1860, the colorful Rosini operatic pageant, "Moses," ill be presented Friday night on he stage of the Hippodrome by he Chicago Opera Company.

Recalling the history of the play, Alfredo Salmaggi, general thrector of the Chicago Opera Company, declared Friday that the opera has been performed in this country only twice before.

"I have traced two performces of Rossini's opera," he said, given in New York City during ne seasons of 1835 and 1860 but m confident that the presentation of the work which I have now planned will be undoubtedly the first to do full artistic judgment, dramatically and pictorially to the specifications of the libretto. The mechanical perfections of modern staging were, of course, unavailable to grand opera impresarios of the past century and although Rossini's music may have been sung by singers in costume, there could not have been an adequate representation of the several spectacular dramatic episodes, such as the division of the Red Sea and Moses in the mountains, which have been worked out by my present scenic designers and stage

European revivals of Rossini's opus have been given at La Scala, Milan, last March, and at Verona, Italy, last July and August. First composed as an oratorio, "Moses" was first presented in Italy in 1818. Subsequently Rossini refashioned the score and libretto in Grand Opera and in this version it was presented in Paris in 1827.

It is interesting to note that among the witnesses of this Paris performance was the great novelist Honore De Balzac who later incorporated his impressions of the opera in his novelette, "Massimilla Doni."

"Never before," Balzac wrote, "was there so grand a synthesis of natural effect, so complete an idealization of nature."

#### Minute Men Charge Shackman Shop Buys and Sells Reich Products

As part of its intensive drive against the sale of German-made goods in this country, the Anti-Nazi Minute Men yesterday renewed its all-day picketing of the B. Schackman Novelty Shop, Thirty-fourth street and Madison evenue. The group charges the store, Jewish-owned, is deliberately purchasing and selling Nazi-manufactured goods.

Circulars reading, "Heil to the Jewish merchant who imports Nazi-made merchandise . . . merchandise fashioned in the scarlet shadows of the thousands of bleeding hearts of his fellow men," were distributed.


#### Find Stolen Goods on Arabs Seized in Raids

# London Press Reprints Views OfLloydGeorge

#### His Attitude on Jewish Question in Reich Publicized

(Jewish Telegraphic Agency)

LONDON. — The opinions of David Lloyd George on the Jewish situation in Germany are reproduced in the Manchester Guardian in connection with Lloyd George's possible return to power in England.

The Manchester Guardian publishes an interview which Lloyd George gave to the London correspondent of the Berliner Tageblatt in which he allegedly expressed himself as admiring new Germany. In this interview Lloyd George, however, emphasizes that "his attitude on the treatment of Jews in Germany is no doubt known to the German press."

Other London newspapers quoting Lloyd George on the Jewish question in Germany emphasize the statement which the British statesman made in the early months of the Hitler regime in which he said that "a nation of 60,000,000 people is entitled to justice, but must also treat with justice its 600,000 Jews."

# Yiddish League To Raise Fund For Print Shop

#### Will Seeks \$25,000 to Start Publishing Plant in Palestine

A resolution to raise \$25,000 in the United States for the purpose of establishing a cooperative printing shop in Palestine to publish books and publications in Yiddish was adopted Sunday at a conference called by the League for the Protection of Yiddish Rights in Palestine. The conference lasted for two days, and was attended by a number of representatives of cultural and labor organizations in the United States.

The conference also adopted a resolution of protest against the persecution of Yiddish in Palestine and against the Histadruth, the Palestine Labor party, for not permitting its members to utilize the Yiddish language at a time when the Histadruth is raising funds in America and other countries among Yiddish speaking masses.

Other resolutions adopted demand that the Histadruth also conduct cultural work in Yiddish in addition to its work in Hebrew, and should introduce the teaching of Yiddish in its schools of Palestine.

Another resolution calls for the withdrawal of the Histadruth order which prohibits its members from using Yiddish at open meetings after a two-year residence in Palestine.

An executive was elected at this conference comprising representatives of cultural organizations and labor unions.

#### Dr. Kahn to Survey Situation in Poland

(Jewish Telegraphic Agency)

PARIS, Feb. 25.—Dr. Bernard Kahn, European director of the Joint Distribution Committee, is proceeding to Poland this week to study the economic situation of the Polish Jews.

Reports from Poland which reached Jewish organizations in Paris this week described the situation there as "unbearable." With the approach of Passover, numerous Jewish families will now be entirely dependent on charity for their Passover food, the reports emphasized.

# Label Defacing Law To Be Tested Thursday

# Christian Rally In Switzerland Scores Nazis

#### Prof. Nabholz at Zurich Meeting Defends Jewish Citizens

(Jewish Telegraphic Agency)
GENEVA, Feb. 25. — A large
Christian demonstration against
anti-Semitism, arranged in Zurich
by the district branch of the
League of Nation's Union, condemned the anti-Jewish propaganda which Nazis are now con-

ducting in Switzerland.

Professor Nabholz, of the Zurich University, addressing the meeting, pointed out that there are only four or five Jews to every thousand Swiss citizens. The Jews have never exercised any real influence in Swiss political life and their economic influence is very slight, he declared. None of the directors of the big Swiss banks are Jews and the same applies to big industries and apartment stores also, he emphasized.

The Professor ridiculed the Nazi allegation that the Jews are endangering Switzerland. "A suggestion that a Jewish population of 18,000 could endanger the culture of about 4,000,000 Swiss people was an insult to the intelligence of the Swiss people," he said. "The Swiss press is entirely in the hands of 'Aryans' and the same applies to the schools. There are a few Jews attending Swiss universities, and most of these are men of exceptional eminence."

Professor Nabholz concluded by stating that the attitude of a people on the Jewish question is a barometer of the cultural level of that people. Dr. K. Fleischmann, voicing the Roman Catholic view at the meeting said that the Catholic Church always behaved with love and toleration towards the Jews and that anti-Semitism was a crime against Christianity.

# Palestine Alters Its Decision on 14 in Prison

#### Not to Release Them on \$125 Bail; New Strike Is Threatened

(Jewish Telegraphic Agency)
JERUSALEM, Feb. 25. — The
Palestine administration today altered its decision to release the ten
Jews and four Arabs who went on
a twenty-four hour hunger strike
Sunday demanding that they be released under bail.

The fourteen prisoners, all of whom are held on the charge of illegal entry into Palestine, ended their strike yesterday when the government promised to release them under individual jail bonds of \$125. Today, however, the authorities declared that the bail must be higher than the sum stipulated.

The prisoners, who have already served their sentences, notified the jail administration in Jerusalem that they will go on a new hunger strike if they are not released to-day. All ten Jewish prisoners are refugees from Adrianapole. The Vaad Leumi, the Jewish National Council of Palestine, is trying to raise bail for them.

#### Frankfurter Zeitung Hit by Beobachter, Hitler Newspaper

(Jewish Telegraphic Agency) BERLIN. - The Frankfurter Zeitung, which was recently assailed on all sides by Nazi newspapers because it urged that "some measures should be taken to enable the Jews to live and earn their livelihood in Germany," has now been taken to task by the Voelkischer Beobachter, Hitler's chief organ.

"How long does the Frankfurter Zeitung think to mislead foreign opinion?" Hitler's paper asks. "The Jew is caught red-handed in the act of theft and he shouts that he did not commit robbery. That is the method of the incorruptible Frankfurter Zeitung," Hitler's organ states.

The Voelkischer Beobachter concludes by saying that "it is not necessary to waste a single word in making it clear that all attempts to confuse and divert the aim and determination of the National Socialist Movement will be

# Cabinet Decree on Jobs Reveals Animus Against Rumanian Jews

Major of the Army.

3. All enterprises are obliged at the end of every year, at latest by February 1, to submit to the Minister of Industry a table giving by name every Rumanian and every foreigner employed in the enter-

The Minister of Industry has on the basis of the above issued an order, setting up a form of tabulation for this purpose, and every industrialist is under the obligation of filling in this table and sending it to the Minister. This table contains instead of the two columns, Rumanians and foreigners, three columns: Rumanian citizens, nation (ethnic origin) and foreigners.

#### Hold Queries Illegal

The Union of Rumanian Jews has issued a communique declaring this tabulation unconstitutional and illegal, and demanding that the words "Rumanian citizen and nation (ethnic origin)" be struck out and that in their place there should be only the word "Rumanians" which should include all who are not subjects of a foreign state.

On February 3, the Union of Rumanian Jews issued the following communique: "The Union of Rumanian Jews protests against the campaign which is contesting the most elementary and sacred right of the Rumanian Jews-the right to work. The Union places on record the fact that the constitution expressly prohibits any distinction whatever being made between Rumanian citizens or Rumanian subjects on the ground of religion, confession, ethnic origin, or language in relation to their civil, or political rights. It declares that any law or ministerial order which enforces such distinctions must be considered as unconstitutional. It places on record furthermore that in no circumstances can the economic crisis, or the financial crisis be overcome by changing the personnel of one religion by personnel of another religion; that on the contrary, such measures will not ease the economic and financial crisis, but on the contrary, they can only create more profound and far-reaching difficulties."

See "Human Rights" in Danger On February 9, the Union of Rumanian Jews published another statement ir which it said:

"The Union of Rumanian Jews, after examining the latest events, places on record that the Rumanian Jews are in danger. Not only their citizen rights, but their human rights are in danger. The Union of Rumanian Jews assures the Rumanian people that the Rumanian Jews, without distinction, are attached to the Rumanian land. The Jews have not had, and they have no other interest than to consolidate greater Rumania and to see the Rumanian people that for twenty years has pos-sessed the plenitude of cultural, economic and political rights, bring this plenitude into consummation.

"It declares, however, that any action that will violate the human or citizen rights of the Jews, will only mislead the Rumanian people.

#### Hits Favoritism

"State problems are not solved by threatening to take the bread out of the mouths of certain citizens in order to give it to other citizens, but by assuring their bread to all, not by the method of creating privileges, to favor one section of the population and to do harm to another section of the population, but by stimulating the initiative of the entire population, can a situation be created that is good for the entire population.

The Jews protest against the accusation that Jews have monopolized everything and against the false statistics on the basis of which it is sought to justify these unjust and illegal laws.

"The Jews did not make the laws of the Rumanian State. They

### Prepare Note to Mandates Body On Palestine

#### Memorandum to Clarify Balfour Intent, Revisionists Say

(Jewish Telegraphic Agency) PARIS.—The Zionist Revisionist Executive has announced here that a new memorandum will be submitted to the Mandates Commission at the League of Nations, which will contain important material and political documents making it clear that the authors of the Balfour Declaration and of the Palestine Mandate intended the creation of the Jewish State in Palestine, and that this was the purpose for which Britain assumed the Mandate for Palestine.

The new memorandum will be backed by a mass petition with tens of thousands of signatures of Palestinian citizens supporting this ultimate aim of Zionism, the announcement says. It will also be backed by hundreds of thousands of petitions from Jews all over the world addressed to the British Government and the British Parliament.

"If the second memorandum will fail to achieve its purpose, we together with the whole Jewish people will not tire, but will continue with a third and a fourth memorandum," the announcement promised. "We do not doubt that the just demands of the Jewish people for Palestine as a Jewish State will obtain the understanding and the recognition both of the mandatory power, the League of Nations and the public opinion of the entire civilized world," the statement concludes.

#### Toronto Jews Plan Bill Against Libels Nathan Laski Demands

Proposed Measure Would Make Individuals Liable for Group Slander

(Jewish Telegraphic Agency)
TORONTO, Ont., Feb. 25.—The victorious outcome of the Manitoba trial in which Jews obtained a court injunction against the local Nazi paper prohibiting publication of anti-Jewish propaganda, has encouraged Jewish leaders here to introduce a bill in the Ontario legislature asking for an anti-libel law, which would protect the Jews from libelous anti-Semitic attacks.

The bill, it is reported, will be introduced by J. J. Glass. a member of the legislative assembly. According to this bill individuals in Ontario will be held liable for slanderous statements made against any section of the community or any race or creed.

#### Lady Erleigh Says Reich and Polish Problems Don't 'Overlap'

(Jewish Telegraphic Agency)

LONDON. - An explanation as to why no united campaign for German and Polish Jewry is instituted in England was given here today by Lady Erleigh, chairman of the third appeal for funds which is to be launched by the Central British Fund for German Jews on Sunday, March 10.

"It was found to be impracticable to make a joint appeal for both German and Polish Jews. The situation with regard to Germany is more political and with Poland more economic. The two appeals will not overlap," Lady Erleigh stated.

"I have seen the horrible conditions under which the Jews live in Poland," Lady Erleigh continued. "We do not want to get in the way of people who want to raise money, and we have come to the conclusion that it is better to keep the appeals apart. We must do our best to keep them apart. We have a number of German Jews training in different countries. If they continue training this year, we can place them in positions. It is better to finish one thing before embarking upon another. We must do our best to liquidate the German situation."

Leonard Montefiore, the other chairman of the appeal, declared that many have felt that the German situation was a situation by itself, while the Polish situation in its misery is linked up with the general situation. When the German fund has been-completed, the Polish fund will begin, he said, adding that there is no question of rivalry, but only friendliness between the two campaigns.

The launching of the united appeal for Polish Jewry is scheduled for March 29.

### Mosley Dared ToUseNames in Attacks on Jews

### Fascist Leader Quit Generalities

(Jewish Telegraphic Agency)
MANCHESTER, Feb. 25. — A challenge to Sir Oswald Mosley to name names when attacking Jews in order to give them a chance to test his accusations in courts of law was made today by Nathan Laski, one of the leading Jewish figures in the Jewish community of Manchester.

"Sir Oswald knows what the libel laws are in this country, Mr. Laski said. "He, therefore, makes his anti-Semitic accusations in generalities. But let him, however, have the courage to mention names so as to enable us to bring a case in court against him."

The Blackshirt, official organ of Sir Oswald Mosley's British Union of Fascists, came out today with an article supporting the Nazis' arguments in the case of the Protocols of Zion which is now to be resumed soon in Berne.

# Sees No Danger For French Jews **AtPresentTime**

#### **Agitation Chiefly Against** Aliens, Yefroikin Says in Paris

(Jewish Telegraphic Agency) PARIS, Feb. 25.—The Jews in France have no ground for panic at the present moment, Israel Yefroikin, chairman of the Committee of Jewish Delegations, stated here addressing the Federation of Jewish Societies in Paris on the question of whether anti-Semitism exists in France.

Mr. Yefroikin pointed out that the present disturbances of Nationalist students in Paris and in Nancy are directed against aliens and not against Jews. It is, however, true that xenophobia may easily be converted into anti-Semitism, he added.

Mr. Yefroikin emphasized that there is no big party in France present which incorporates anti-Semitism into its program as is done in other countries. It is true that the cry "France for the French" is being raised, but this is a result of the crisis, he said. There is not enough bread for everybody so restrictions are being made which affect the entire population, not only the Jews.

Mr. Yefroikin also stated that the allegation of French Jews that immigrant Jews bring anti-Semitism with them into France is partially true. "Where there are no Jews, there is no anti-Semitism," was his sarcastic observation, concluding that a common full-blooded assimilation among the immigrant Jews and the French Jews is necessary.

## Low Fruit Cost In Britain Laid To Adolf Hitler

#### Jaffa Oranges, Barred in Hamburg, Glut **English Market**

(Jewish Telegraphic Agency)

LONDON.-Many and varied explanations for the cheapness of Jaffa oranges in Britain today have been put forward, but the real reason, it appears, is Herr Hitler.

It seems that one of Germany's leading fruit brokers had ordered a large consignment of Jaffa oranges from Palestine. The order was duly received and acknowledged and, at the start of the season the oranges were accordingly

Apparently it has taken Herr Hitler some years to find out that Jaffa is in Palestine and, therefore, that the oranges are handled by latest edict.

#### Nazi Demands Probe

Some astute Nazi, with that "Aryan" zeal for noticing anything that may be even faintly connected with the Jewish race, was horrified to find that thousands of boxes of Jaffa oranges were being unloaded at Hamburg.

Could this be possible? With characteristic thoroughness the Fuehrer's admirer demanded that an inquiry be held into this assault on "Aryanism." It was immediately brought to the notice of Herr Hitler, who decided that such a state of affairs could not continue so he put a ban on the orangeseveryone being sent back to Jaffa.

The oranges were reshipped to Britain by the agents in Palestine, with the result that the market here was flooded. Aberdeen, Glasgow, and all towns in Scotland are reaping the benefit of Hitler's ban
