Soviet Plans Airport for Biro-Bidjan

Part of 5-Year Program Mapped to Improve Far East Region

(Jewish Telegraphic Agency) MOSCOW, May 15—The development of the Jewish autonomous district of Biro-Bidjan as a great air transportation center between Europe and the countries of the Far East, is provided in a five-year plan for the Bureya announced

The announcement was made by M. Kantorovitch, vice-chairman of the Government Planning Commission. The five-year plan intends to accomplish the following:

- 1. To bring the total population of Biro-Bidjan to 220,000.
- 2. To cultivate an additional 40,000 hectares of land there for wheat alone.
- To bring in not less than 120,000 new immigrants. .
- To establish a huge metallur gical base employing 10,000 workers.
- To increase railway transportation.

To introduce a swifter Trans-Siberian airline with Biro-Bidjan as a stopping place, thus making possible a trip from Moscow, to Biro-Bidjan within three days, instead of the present nine days which it takes by express train.

The establishment of an air-line station in Biro-Bidjan will convert the district into one of the most important strategic points in the Far East, since the only way to reach China and Japan from any part of Europe by air will be through Biro-Bidjan.

The Gazeta Warszawska, organ of the anti-Semitic National Democratic Party, was expelled today from the Press Association of the Polish Republic for its "tactless attitude" while the nation was mourning the death of Marshal Pilsudski. The Press Association comprises all newspapers in Poland. The expulsion was decided on at a special session called for this purpose.

Charges Reich Jewish Policy Was Defended In Girls' Branch

NEW BRUNSWICK, N. J., May 15—The charge that anti-Semitic literature is being distributed in the German department of the Women's College branch of Rutgers University by members of the department, was made here today by Prof. Leonard Bergel, who declares he was dismissed for his attempt to fight the pro-Nazi spirit in the college.

President Robert C. Clothier of Rutgers today appointed a special committee to investigate the charge. The committee will also establish to what extent the anti-Semitic and pro-Hitler propaganda is encouraged by members of the faculty of the Women's College.

League Set For Action On Danzig

Council Will Take Up **Petitions Citing Anti-**Jewish Acts

(Jewish Telegraphic Agency)

DANZIG, May 15-The coming session of the Council of the League of Nations will take up for consideration a petition submitted by the Jews of Danzig emphasizing the anti-Jewish discrimination practiced by the administration of the Free City, in violation of the pro-visions of the League of Nations visions of the League of Nations with regard to national minorities, PressApplauds it was officially announced here to-

The petition brings out a number of facts showing that the Jews in Danzig are practically deprived of their rights under the present Nazicontrolled administration. It also charges that the anti-Jewish boycott is conducted with the support of the administration.

League Protest Irks Nazis

The Danziger Vorposten, the Nazi organ in Danzig, today published an article bitterly attacking the Jews for submitting their complaint to the League of Nations. The paper insinuates that this action was inspired by "internationalal Jewry."

It is believed here that the Polish representatives in Geneva will be especialy interested in securing a favorable hearing for the Jewish petition at the session of the League of Nations Council, since a large number of Jewish residents in Danzig who are Polish citizens are affected by the present discriminations practiced by the Nazis in Danzig against the Jews.

Sean Lester, the High Commissioner of Danzig appointed by the League of Nations, has also submitted a detailed report to the Council of the League of Nations on Jewish mistreatment by the administration of the Free City.

Palestine Train Brides Have Jail Honeymoon

(Jewish Telegraphic Agency) JERUSALEM, May 15--A unique double marriage ceremony on a moving train between Haifa and Jerusalem, was performed today when two Jewish young men married two sisters, Guella and Hel-

ena Greenberg.

The two girls were to be deported from Palestine on the charge of having illegally entered the country. In order to prevent their deportation, the young men married them on the train, thus officially making them the wives of Palestine citizens. The sisters were, however, imprisoned by the immigration authorities immediately after they left the train.

Jews Injured in Fresh Outbreak of Anti-Semitism

(Jewish Telegraphic Agency) BUCHAREST, May 15-Bucharest University was closed down today as a result of renewed anti-Jewish demonstrations, in which several Jewish students were in-

The Minister of Education summoned a meeting of the presidents of all universities in Rumania to consider new regulations for preserving strict order in the universities and to prevent further anti-Jewish outbreaks. The meeting is scheduled to take place May 23.

Starts in Medical School

The demonstrations against the Jewish students started in the Medical College of the University, which was reopened several days ago after a month's suspension, Shouting "Down with the Jews," anti-Semitic students attacked their Jewish colleagues, showing no mercy even to girl students.

Simultaneously with the anti-Jewish attacks on the university premises, Jewish passers-by were molested by anti-Semitic students in the vicinity of the university. The university building is now under a special police guard.

The authorities are disturbed by the fact that the university had to be closed down again a few days after it had been reopened. It appears that the anti-Semitic students are determined to continue their campaign against the Jewish students in order to force the government to bar Lews from the study of medicine.

Jacques May Dies at 70; Late Diplomat's Brother

Every Citizen a 'Lord of the Reich'

BERLIN.

Much speculation has been aroused here by the projected new citizenship law which provides that Germans will have to qualify for German citizenship instead of acquiring it by the accident of birth.

question of the Danish, Polish and Lithuanian minorities, who can hardly be described as "of German stock."

Foreigners not of German stock will be debarred, apparently, from becoming naturalized German citizens, in view of the statement made by the Nazi Minister of Interior Frick, that citizenship will no longer be obtainable "by a single administrative act or payment of a sum of money."

Hitler's Own Wish

Such is the wish of the Fuehrer Thinself, Dr. Frick explained in his statement. The Nazi Minister also is of the opinion that German citizeuship must be an honor which those of German stock may earn only through service to the people and State and by approbation.

For every German, citizenship tinus obtained would open the way to all public offices in party and State: only those who bore it would be able to enter the fighting formations of the Nazi movement and have the honor of serving muder arms for people and Reich; and such only would vote in elections and plebiscites, and take thereby a direct or indirect part in the government of the Reich. Citizenship would be conferred at a dignified ceremony which would fuclude a solemn oath of allegiance to the German Commonwealth, the German Reich, and its Fuehrer. It would not be granted to the undeserving or to enemies of the State.

"Lord of the Reich"

Adolf Hitler, said Herr Frick, had written in "Mein Kampf" that the German citizen would be the lord of the Reich. For the National-Socialist State citizens were not merely the sum of those living more or less accidentally within the borders of the Reich but rather the bearers of the State ideal. Therefore the grant of citizenship must be made subject to definite conditions, one of which, in conformity with Nazi principles, would be racial membership of the German people.

Herr Hitler, in his long dissertation on citizenship in "Mein interest. Kampf," maintained that citizenship should be granted to qualified Edict Criticized German males on the completion of military service. Females would acquire citizenship rights either by

A No-Profit Press

Herr Alfred Rosenberg has written an article in the Nazi Voclkischer Beobachter (of which he is editor) to remove foreign misconceptions about the new Press ordinances issued by his "old comradein-arms". Herr Amann, president of the Reich Press Chamber.

In National Socialist eyes, Herr Rosenberg explains, the press can never be an affair of naked profit. In Germany there were, and still are, large concerns which let themselves be guided by purely individualistic business principles. National Socialists, with their own code of press ethics, have been fighting this for years, and their own press, debarred from the same methods, has been at a continuous metnous, ...
disadvantage.

Sectional Interests Hit

Herr Rosenberg argues that what Herr Amann has really done is to proscribe all sectional interests in the German press, not excluding any that may arise in the Nazi Party. But this does not mean that religious interests will suffer. The great Church Press, as it consists of weekly journals and periodicals, will not be affected by the ordinances, which apply only to newspapers-and in German law a newspaper means a daily newspaper. Herr Rosenberg makes it clear, however, that the confessional daily press will not be tolerated because, "as many examples show, it is still ardently pursuing the same confessional policies as the now defunct confessional parties.'

The newspapers which will suffer are those produced by anonymous companies purely as profitable undertakings, and not as instruments of popular enlightenment, and those which exist for the advancement of sectional interests placed before the common

An announcement in another column of the same issue of the Beobachter, according to which the Nazi supervisory organs have the intention of compelling all public officials to subscribe to the official party press under pain of being disqualified as unfit for the public service, seems to fall in line with Herr Rosenberg's explanations.

The Frankfurier Zeitung, with every reason to be aware of the more dangerous aspects of the ordinances, has had the courage to criticize them in a leading article. Commenting on the provision for compulsory inspection and the closing down of newspapers where there is unhealthy competition, it observes that when over-production has been accentuated by the rise of the official party press, that press will be exempt from, its competitors subject to, interference.

Analyzes Results

What competition is unhealthy, the Frankfurter Zeitung continues, and what healthy is certainly a difficult question to decide. The better the press performs its educative duties, the more a lively competition will be missed, for experience has shown it to a most effective stimulus. Jews as Nazi Spies

That the Nazis hate the Jews is a well known fact, but that there are numerous Jews in the Nazi secret service in Germany and abroad, is a fact which is less known.

In Berlin I happened to know a Nazi-Jew who was the head of the Jewish Department in the Gestapo, the secret political police. Himself a young Jew from Upper Silesia, he made no secret to me of the fact that he was the chief spy for the Nazis among the foreign Jewish correspondents in Germany and the rapporteur for the Nazi secret service on the activities of Jewish organizations.

Spying in Palestine

From time to time I saw this young Jewish spy mingling in Jewish crowds, at meetings arranged by the Zionist Organization, at synagogue services, in the cafes on the Kurfurstendam which are visited chiefly by Jews, keeping an eve on the activities of Jewish leaders in Berlin and watching Jewish life

"I wish I were in Palestine," he once told me. And I did not know whether this meant that he was tired of working for the Nazis, and should have liked, like other German Jews, to emigrate, or whether he wished he had been sent by the Nazis to Palestine to do his spying there.

That the Nazis are maintaining an espionage system among the German Jews in Palestine, there is no doubt. They do this in England, they do it in France, they do it in Holland. Why not Palestine?

A Spy in Poland

The London press is now full of a sensational story about a Jew who was discovered in Poland as an agent of the German secret police. Six months ago this Jew calling himself Hans Sal, arrived in Warsaw. He told the German exiles that he had escaped from a Nazi concentration camp. They received him with open arms, especially since he had plenty of money.

Posing as a well-known writer, the man delivered recitations of his "own" poetry. He wrote for papers in Amsterdam, Praha and Paris. He became engaged to Elli Nadermann, a noted beauty, a painter and one of Poland's wealthiest heiresses.

Recognized on Stage On the 29th of April he went to Krakow to give yet another of his popular recitations. In the middle of it, a man in the audience arose. "You are not Hans. Sal!" the man shouted. "I know Hans Sal well. He is my best friend. He is in a concentration camp in Germany right now.

The "poet" did not stop to argue. He took to his heels. For two nights and a day the Polish police hunted him. They found him as he was trying to cross the frontier into Rumania.

Following the arrest, the Polish police issued a statement saying that "Hans Sal" is none other than Martin Ginsburg, Martin Ginsburg is an agent of the German secret police. He was given the papers of the real Hans Sal, who, in a concentration camp, had no use for them. His duty was to spy on the German colony in Poland. A veiled German beauty paid him regular visits. After each visit Martin Ginsburg swam in money, with which he feted his admirers.

Doubts Consistency of Quebec

Commenting on the bill introduced in Quebec to force the Jews to keep their stores closed on Sunday, the Canadian Jewish Chronicle

The introduction of a bill in the Quebec Legislature to deprive the Jewish people of certain rights in this province is the culmination of an agitation that has been going on for a long time. For some time past, the few Jewish stores who are allowed to trade on Sunday have been victimized by sleuths who have been spurred on to the delightful game of pin-pricking. The fact that trading is done on Sunday along St. Denis Street, St. Catherine Street, Verdun Lachine, etc., does not seem to bother the authorities very much, for consistency and fair play do not come within the orbit of their watchfulness.

The Premier's Support

The editorial also comments on the puzzling endorsement of this bill by Premier Taschereau:

As for Mr. Taschereau's role, it is somewhat perplexing. Mr. Taschereau was a member of the Legislature when the bill granting full rights to the Jews was passed unanimously twenty-five years ago. Now he suddenly proclaims that if the Legislature could constitutionally repeal the section of the laws affecting Jews, he would vote for it. The mystery is deepened by the fact that twenty-five years ago, the Legislature saw no reason why the clauses should not be adopted, but in suggesting their abrogation, it has been suggested that the "buck be passed" to the Court of King's

Palestine Action On Visas Held Unfair

The New Judea, official organ of the Zionist Executive in London, disclosing the fact that 2,800 immigration certificates were deducted by the Palestine government from the present labor schedule on account of hypothetical illegal immigrants, says:







The article then points out that the new "Aryan" clause for newspaper publishers puts the officials "Aryan" clause and the still stricter journalists clause in the shade. Hitherto only the hereditary class of peasants (Erbhofbauern) have been required to prove "Aryan" descent back to 1800. Of the provisions for "disanonymizing" paper concerns, the Frankfurter Zeitung says that in principle only sole traders and members of limited or private partnerships will have the right to publish newspapers that are not party newspapers, and they will be prohibited from taking direct or indirect subsidies.

29 Discharged NEWS By Hospital for NIRRIE Wage Protest

Aftermath of Walkout by Federation Workers' Association

Twenty-nine employes of Lebanon Hospital and an "unknown number" at Beth Israel, both affiliated with the Federation for the Support of Jewish Philanthropic Societies, have been discharged for participation in a protest walkout Tuesday against low wages, according to a statement yesterday from Association of Federation Workers, an organization claiming a membership of 800 among the workers in Federation institutions.

Louis J. Frank, superintendent of Beth Israel Hospital, denied that any workers were discharged and L. Victor Weil, president of Lebanon, admitting that twenty-nine workers were discharged, declared that the action was taken because the walkout had endangered the safety of the hospital's

Decries Agitation

Ii a statement to the Jewish Daily Bulletin, Mr. Weil charged that many workers were intimidated into walking out and decried the "agitation of a few employes interested in building up an organization which is quite apart from hospital activity."

No one could be reached at the office of the association with authority to answer these charges, but it was revealed that an executive meeting had been called for last night at the Central Jewish Institute where the situation was to

Solomon Loewenstein, executive vice-president of the Federation, to whom the Association announced it had appealed for aid in gaining the reinstatement of the discharged workers, refused to comment.

Meanwhile, it was understood that all other employes who had walked out were back at work yes-The walkout, which was called Tuesday in an effort to gain recognition of the Association and its demands for wage adjustments, involved Lebanon, Montefiore and Beth Israel Hospitals.

Hits Lack of Notice Mr. Weil's statement follows:

"Twenty-nine employes of Lebanon Hospital walked out without giving the hospital an opportunity to make provision for the care of the patients. The walkout endangered the safety and welfare of the patients and was due entirely to the agitation of a few employes

Rabbis Score Violation of Sabbath Laws

Voice Faith in Democracy; Assembly Parley Elects Kohn

Public desecration of the Sabbath was condemned and faith in the principles of democracy were reaffirmed in resolutions passed yesterday afternoon by the Rab binical Assembly of America at the concluding session of the threeday convention in Far Rockaway, at which Rabbi Eugene Kohn of Bayonne was elected president for the coming year.

The resolution against flouting of the Sabbath laws was introduced by Rabbi B. Leon Hurwitz of Brooklyn and Dr. Simon Greenberg of Philadelphia. It read: "We condemn all public desecration of the Sabbath such as meetings, luncheon, open offices, etc., by all groups of Jewish constituency or interest.'

The resolution on democracy, introduced by Dr. Robert Gordis of Rockaway Park and Rabbi Louis Fineberg of Cincinnati, stated that "mindful of the drawbacks that inhere in our present economic and political order and seeking to advance the ushering in of a more equitable system, we reaffirm our unshakable faith in democratic institutions as a basic ideal for human society."

Voices Thanks of Women

A message was received from Mrs. Rebekah Kohut, president of the World Association of Jewish Women, thanking the assembly for the action taken the previous day in the liberalization of the divorce law for Jewish women. The revision overcomes the problem of "agunah" (deserted wife who cannot get a divorce or remarry under the religious law) and calls for the same privileges for Jewish women under rabbinical law as she has under the civil law.

Other officers elected besides Rabbi Kohn are: Dr. Simon Greenberg, vice-president; Rabbi Alexander Basel of the Bronx, treasurer; Rabbis Henry Fisher of Arverne, recording secretary; Dr. Robert Gordis, corresponding secretary.

Vacancies on the executive board were filled by the election of Rabbis Abraham Heller of Brook lyn, Leon Lang of Newark, Israel Levinthal of Brooklyn, Elias Margolis of Mt. Vernon, retiring president, Joseph Miller of Brooklyn and Harry Schwartz of Hempstead.

Nazi 'Expert' Sued for Libel (Jewish Telegraphic Agency)

BERNE, May 15-M. Tobler, one of Switzerland's leading manufacturers, today filed suit for libel against Col. Ulrich Fleischauer, the Nazi "expert" from Germany who testified at the trial of the "Protocols of the Elders of Zion" which concluded yesterday with a verdict declaring them a forgery.

The libel suit against Fleischauer is based on the allegation made by him during the trial that Tobler gave false testimony when he appeared as one of the witnesses at the trial. Mr. Tobler, who is a ice of Fascism," and pointed out Col. Fleischauer for certain statements which the latter, as "expert for the Nazis, made against the Freemasons.

The suit will be tried May 28. The court fixed this day despite the protest of Col.
