## Nazis Quit Parley Of League Unit

### **Brussels Action Follows** Decision to Discuss Jewish Question

(Jewish Telegraphic Agency) BRUSSELS, June 11-The German delegation to the Congress of the Federation of League of Nations Societies walked out today in protest against the decision of the president that the Congress take up the question of Jewish persecution in Germany.

The question was submitted by the Palestine League of Nations Society which is represented at the Congress by Ben-Zion Mossenson and Dr. Nahum Goldmann.

An extraordinary meeting off the Executive of the Congress was called immediately after the German delegation left the hall. this meeting the German delegation was represented by Dr. Kirchhof. The Palestine delegation was represented by Mossenson and Goldmann. Viscount Cecil repre-Goldmann. Viscount Cecil reserved the British delegation.

### Delegates Not from Reich

The German delegation at the Congress does not represent the present Nazi Germany which is no longer a member of the League of Nations. It represents chiefly the German minorities from the Polish part of Silesia and from Czechoslo-This delegation is understood, however, to be under the control of the Nazi government and its activities are even said to be subsidized directly from Berlin.

A fight with regard to the question of whether the Federation of League of Nations Societies should take up the present Jewish problem in Germany had developed at a previous Congress.

The Jewish delegation announced at that Congress that it would not participate in the sessions if no resolution against the anti-Jewish persecutions in Germany were adopted. The German delegation, on the other hand, threatened to leave the Congress if the Jewish question was taken up.

### House Gets Bill to Aid Alien Exiles

### Measure Lifts Bars to Victims of Racial Persecution

(Special to the J.D.B.)

WASHINGTON, June 11-A bill demanding that no alien be excluded or deported from the United States, if a refugee for political, racial or religious reasons from the country of his origin, introduced into Congress this week by Representative Marcantonio, was referred today to the Committee on Immigration and Naturalization.

The bill specifies that no alien be deported from America if he is a fugitive from his native country because of his acial origin or because of his political or religious

Bars Deportation

Similarly, the bill would bar deportation of aliens who might be subjected in their native land to persecution or social and economic discrimination on account of their racial origin.

The bill provides that Section 4 of the Immigration Act of 1924, referring to the admissibility of immigrants, shall be amended by adding thereto a new subsection to read as follows:

"An immigrant who is admissible to the United States as an alien who is a refugee for political, racial, or religious reasons from the country of his origin; or is a fugitive from that country because of his political or religious beliefs (Continued on Page Four)

### Soviet Asks Comzet to Investigate Delays in **Building Projects**

(Jewish Telegraphic Agency MOSCOW, June 11-The Soviet government today urged the Comzet, the government commission to settle Jews on land, to speed up and strengthen activities with regard to settling Jews ni Biro-Bidjan, the Far Eastern Soviet district to be proclaimed an autonomous

The Commissariat of Agriculture has allocated 1,600,000 roubles for the building of 150 dwellings in Biro-Bidjan and 200 farm buildings. The local administration of Biro-Bidjan has so far not been efficient enough in providing timber and other materials for the building work. As a result, the Comzet was instructed by the government today to look into the matter.

The settlement of Soviet Jews in Biro-Bidjan is proceeding slowly, according to complaints in the Soviet press today. This is due to the fact that the younger Jewish generation has no difficulty in finding employment in any part of Soviet Russia and is thus unwilling of Biro-Bidian.

### Jews Reported LeavingTurkey For So. America

### Wide Emigration Move Centers in District Of Smyrna

(Jewish Telegraphic Agency)

ISTAMBOUL, June 11-A large Jewish emigration from Turkey to South America is reported today from official government sources, as a result of the economic difficulties which the Jewish population here

Most of the Jews leaving Turkey are Greek citizens living in the Smyrna district. Not being admitted to any other country and having no prospects in Greece, they leave with their families for Buenos Aires, where immigration is open to persons between the ages of 21 and 36.

The immigration regulations in Argentine, where most of the Jewish emigrants are proceeding, provide that any person up to the age of 36 can freely come into the country as long as he produces a document from his native land that he has no criminal record.

Persons over 36 years of age are not admitted to Argentine unless they have affidavits from close relatives to the effect that they will not permit the immigrant to become a public burden. All immigrants admitted can bring their families with them.

### **Actors Balk** At Edict By Dr.Goebbels

### Close Up Club in Berlin Rather Than Let Out Jewish Members

(Jewish Telegraphic Agency)

BERLIN, June 11-A revolution. ary act against Dr. Paul Joseph. Goebbels, Nazi Minister of Propaganda, was carried out today by the German Actors Club here. which had been instructed by Dr. Goebbels to dismiss all its "non-Aryan" members.

Rather than obey the Goebbels order, the executive of the Actors Club decided to close the club altogether.

This courageous decision is the first open demonstration by an important organization in Germany against the anti-Jewish persecution. in the country. Dissatisfaction with the anti-Jewish discriminations has been growing continually among the German population here but no institution has until now dared to given open expression to this feeling of resentment.

### Actors Hard Hit

The Actors Union in Germany has especially suffered since the advent of the Nazi regime despite the fact that many "Aryan" actors received better opportunities for employment because of the elimination of the Jewish actors. This elimination has resulted in the closing of many theatres and in a sharp decline in the theatrical life of the country. Unemployment among "Aryan" artists has therefore grown despite the fact that they no longer have Jewish competitors.

The Voelkischer Beobachter, Hitler's chief organ, is now making a study of the question whether Jews are dying out in Germany.

"Our past censuses," the paper writes, "unfortunately give no real picture of the numbers of the Jewish race in Germany, because they deal only with those Jews who describe themselves on the census sheet as belonging to the Mosaic

#### Affirm Membership

#### Yibboom and Halissa

The Jewish law with regard to divorce involves the delivery of a bill of divorcement before witnesses. The allegation in this respect was that the Bene-Israelites dispense with the bill of divorcement and permit a divorce to take place without any formalities at all.

To understand what is implied by the terms yibboom and halissa, reference must be made to the twentyfifth chapter of Deutoronomy, verses five to ten.

### Mosaic Law Disregarded

The marriage of a man to the widow of his deceased brother who has died childless is known as yibboom. The procedure which follows the refusal of the surviving brother to marry his sister-in-law is known as halissa, and when it is carried out it has the effect of setting the widow free to marry



#### Tribe's History Traced

The Bene-Israelites are confined to India, and to a large extent to the western side of India, their greatest strength being in Bombay. When they first came to India is uncertain. Their own tradition but those who have investigated the history of the tribe and are entitled to speak with authority, place

What, however, is quite certain is that the Bene-Israelites settled in India many years ago, and in the beginning freely intermarried with the inhabitants of India and adopted many Hindu customs.

\* \* \*

#### Came in 6th Century

Though there is no certainty as to the date when they came to India, it seems probable that it was in the sixth century. Their own tradition, for they have no records of any kind, states that they came to India about fourteen hundred years ago from the north, and that they were wrecked off Navgaon, a little to the north of Thal, at the southern entrance to the Bombay harbor, and only fourteen-seven men and seven women-were saved.

Several centuries ago, a Jewish priest, David Rahabi, coming to Bombay from Arabia, heard of the Jews in the country close by, and going among them, won them back from many Hindu observances and taught them the chief tenets and practices of the Hebrew faith. He also introduced the knowledge of the Hebrew language.

\* \* \*

### 13 Principles Accepted

It was conceded by the defendants that the Bene-Israelites now accept the thirteen fundamental principles of the Jewish faith, that they insist on circumcision, and that they observe the Jewish law except in the three respects already mentioned. As has been pointed out, modern Jews disregard the Mosaic law so far as yibboom is concerned and consequently it cannot be said that failure on the part of the Bene-Israelites to observe this law would make them unorthodox.

The issue was, therefore, reduced to this: Do the Bene-Israelites refuse to follow the Jewish law with regard to divorce and halissa and, if so, what is the affect?

By B. SMOLAR . Restoring the Nazis in U.S.A.

The Nazi movement in America has during recent months suffered a tremendous setback. Split into three divergent groups, it has lost considerable ground.

But it seems that the Nazi government in Berlin is interested in seeing the Nazi movement in America strengthened. Nazi emissaries from Berlin have arrived in the United States for the express purpose of restoring the Nazi movement here.

#### Organizers and Funds

With the arrival of organizers in the United States, it may be expected that the Nazi activities here will increase. There is no doubt that these organizers have not come empty-handed. They have undoubtedly brought with them not only plans but also funds to carry out the plans.

In view of all this, it would be well for our central Jewish organizations in America, which are engaged in combating Nazism, to be on their guard. The central point of the Nazi propaganda in America is anti-Semitism. An increase of anti-Jewish propaganda may therefore be expected, if no preventive measures are taken

### The Stuermer as "Baggage"

One of the preventive measures desirable, is to see to it that the anti-Semitic literature which is being shipped from Germany to the United States on a large scale by way of German steamers is not permitted into this country. The authorities are very ready to cooperate in this respect, if proper action is taken by the interested Jewish organizations.

The good will of the authorities in this respect, was displayed in recent weeks when thousands of copies of the notorious Stuermer, published by the Jew-baiter, Julius Streicher, were not permitted to be unloaded from the German steamers on which they were shipped. Checked by the federal officials, this "baggage" had to be taken back to Germany by the same steamers which had brought them to the United

### The Order from Berlin

The watchful eye of the authorities however, is not always in a position to prevent the smuggling of anti-Semitic literature from Germany into this country. With the order from Berlin to strengthen the Nazi movement in America, this filtering in of the Stuermer and other anti-Semitic publications may be expected to increase.

The anti-Jewish propaganda upon which the Nazis now intend to concentrate will not be limited to the spreading of leaflets and notorious periodicals. As the trial in New Brunswick disclosed, the Nazis have a definite plan for injecting anti-Semitic propaganda in colleges. This system of propaganda among the American youth is much more dangerous than the spreading of the Stuermer or any other obscene Nazi publication.

### Correct Estimates Necessary

It is certainly undesirable to overestimate the Nazi forces in America, when they are on the decline. But it is equally undesirable to underestimate the eforts which are now being made from Berlin to unify the Nazi groups in America and to cement them into one solid united organization. Backed by finances from the Ministry of Propaganda in Germany, these efforts may lead to a revival of the Nazi activities here, even though this revival, too, may be short-lived.

### Reich Nationalism Held Repulsive

Winston Churchill, writing in the London Sunday Chronicle on Germany says:

It is in Germany that nationalism presents itself in its most repulsive form. The bitterness of defeat has produced a monstrous reaction.

A whole people, the most educated, the most scientific, and one of the most gifted in the world, has cast away every vestige of constitutional law and liberty. It has repudiated the whole liberal civilization of the nineteenth cen-

It has plunged back into the Middle Ages, with Jew-baiting and official murder as the vaunted features of its national life. It proclaims in ludicrous defiance of historic fact its possession of a racial purity, in the name of which it conceives itself entitled to drive from its bosom every strain of alien blood.

Christianity itself is made to march at the goose-step. The swastika replaces the Cross. The Bible is rewritten so that the Jordan becomes the Rhine, and Jerusalem Berlin — or perhaps Munich. The Eternal Father of mankind and Creator of the universe must become a tribal god.

This is a terrible reversion. It can be explained only by an inferiority complex which has rendered one of the greatest branches of the human family singuarly unsure of itself.

### Palestine Viewed As a Crown Colony

The Near East and India, discussing the possibility of converting Palestine into a crown colony,

It is not the first time that the suggestion has been made that international authority, through the League of Nations, be sought for obtaining a Colonial charter. Jewish circles particularly are in many cases keenly interested in removing the present anomalous juridical condition of this land, on the ground that the political and economic disadvantages of this loose link with Great Britain far outweigh the benefits of a mandatory régime, and that it would be far more meet to go the

whole way to become "another jewel in England's colonial diadem," to use the common metaphor.

If Palestine, with its unusually important value for British Imperial communications (the air and land routes to the Far East, the Iraq Pipe-line, the fine harbor base at Haifa, and other unique strategic interests), were to be taken formally into the family of the Commonwealth, it would bring about significant economic changes for the benefit of local export trade. For not only could Palestine be included within the ring of Imperial preferential tariffs, but it might also escape the present drawbacks of mandatory life in the free trade maintained by other countries which have considerable import business into Palestine, without any hard-and-fast reciprocal export arrangement. The growing adverse trade balance of the country is giving cause for alarm in commercial quarters. Last year it is estimated that there was a margin of some ten or eleven million pounds between imports and exports, the former at £15,000,000 and the latter at some £4,000,000.

There are others who foresee a breakdown of the Mandates system of the League owing to the increasing nationalism among the European nations. From many points of view, the annexation of Palestine is thought to be coveted by certain Powers; and it is to forestall any sudden manoeuvre, should the exigency arise, that many believe in the wisdom of formal inclusion in the British Commonwealth.



The plan for the management of the Synagogue was amended by the Court when the period of office as far as the trustees are concerned was changed from three years to five years. The next election, therefore, was not due to take place until 1934. It was in fact fixed for January 21, 1934.

On January 3, 1934, certain Bene-Israelite residents in Rangoon asked the trustees to include in the list of persons eligible for election the names of those Bene-Israelites possessing the necessary qualifications with regard to age and residence in Rangoon.

This request was denied and further, the names of all Bene-Israelites were excluded from the voters' list, which action resulted in the recent court action and subsequent victory for the Bene-Israelperibers of the Synagogue.

# Jews Victors

### 4 Councillors Elected in Constantine, Scene of Riots Last Year

(Jewish Telegraphic Agency) ALGIERS, June 11—Results of municipal elections held throuhout Algeria simultaneously with the elections in France and the other French possessions, have now been compiled.

Fears that anti-Semitism would play a prominent role in the campaigning because of resentment against the Jews, who more or less hold the balance of power among the various factions, proved groundless and the elections passed off quietly with only a few minor incidents, none of them anti-Jewish in

In the city of Algiers, the election list of the so-called "national front" was completely victorious. The list included no Jews.

In Oran, the list headed by Abbe Lambert was elected by a large majority. There was a strong Jewish vote for this list which contained the name of a popular Jewish figure, a wounded war veteran.

In Constantine, scene of bloody disorders last year, and where anti-Semitism is still very strong, four Jews were elected to the municipal council of thirty-two. The Jewish electorate in Constantine comprises almost one-third of the

One or two Jews were elected to municipal councils also in Bone, Setif, Tlemcen and Ain-Beida.

### **Labor Slate Wins Canadian Majority**

### Peace Marks Nazis Attack Jewish Waiter; Algiers Voting; Union in Rio de Janeiro Sues

(Jewish Telegraphic Agency)

Union has instituted suit against a number of Nazi waiters for attacking a Jewish waiter, Boris Pomp, who has been working in a German restaurant here. The attack provoked great excitement in Rio de Janeiro.

The Jewish waiter came to Brazil seven years ago. He mastered several languages, including German and Portuguese, the latter being the language of the country.

Looking for a job, he applied to the German restaurant Paneuros without disclosing that he is a Jew. Because of his mastery of German he was immediately employed by the owner, who happens to be a Nazi. The waiters of the restaurant are also members of the local Nazi group. After the tourist season was over, Pomp left his job and disclosed his identity.

Enraged by the fact that "a Jew dared to work in a German restaurant," the Nazi waiters in the Paneuros telephoned him the next day that the owner of the restaurant wished to see him. When later he entered the restaurant, the waiters attacked him with iron bars, inflicting serious injuries.

"This is in return for your audacity in working with Germans," the assailants told him.

### Peaceways Director To Sail for London



### Hospital Held Not Adequate In Tel Aviv

### III Must be Transferred Elsewhere, Commons Is Informed

(Jewish Telegraphic Agency)

LONDON. — Captain Strickland asked the Colonial Secretary in the House whether he is aware that inhabitants of Tel Aviv in need of hospital treatment must in many cases be transferred to hospitals in other parts of the country because of lack of available beds in the Municipal Hospital; and whether he is yet in a position to state it the government has decided to accede to the request of the municipal authorities of Tel Aviv to be permitted to provide the necessary additional and improved accommodation.

Sir Philip Cunliffe-Lister replied: "I am not in a position to confirm the statement contained in the first part of the question. have communicated with the High Commissioner for Palestine but I have not yet received information as to the intentions of the government regarding the proposal of the Tel Aviv municipality for financing the enlargment and improvement of the Municipal Hospital. I should add that during last year, this hospital, to the cost of which the government contributes, was enlarged from 125 to 184 beds."

Captain Strickland then asked if the Colonial Secretary was aware that at present beds are being put up in the corridors of this hospital, and that patients have to be sent elsewhere because there is not room in this hospital. He asked if he would urge on the High Commissioner the need for dealing with this matter with some expedition.

Sir Philip replied: "Certainly. I am forwarding the suggestion and statement to the High Commissioner. I am sure we can rely on the High Commissioner to give all due weight to all relative considera-

Mr. Janner asked whether the Colonial Secretary will point out that in his opinion it is not correct to say that there should be no provisions for maternity cases and that it is not correct that there should be only two beds for every one thousand of the population, and that 184 for the population of 124,000 is wholly inadequate.

Sir Philip said: "It would be very unwise for me to forward exparte statements to the High Comsioner, who as the House knows, missioner, who as the House knows, gives most careful consideratoins to these matters."

"This calculation does not tally," the Nazi paper asserts, "because the largest number of Jews were not counted as belonging to the Mosaic faith, but described themselves as 'Konfessionslos,' Protestants or Catholics, and were not added to the number of religious Jews. Actually the number of Jews in Germany is much larger."

The paper comes to the conclusion that about 80,000 Jews emigrated from Germany since the Nazis came into power and that there are still 535,000 Jews left in Germany.

### Canadian House Bells Toll Zionist Anthem

J. Freiman, president of the Hadassah organization in Canda, was celebrated at the Chateau Garcia Hotel here.

More than 1,200 prominent Jews and non-Jews participated in the celebration. The Governor General of Canada was among those who greeted Mrs. Freiman.

The Hadassah Chapters in Canada presented Mrs. Freiman with a check of \$50,000 for the extension of Zionist work in Palestine.

### ClearsWoolworthof Selling Nazi Goods

Didn't Violate Wald Act, Court Rules; Case Brought By Bronx Girl

Charges that the F. W. Woolworth Company is selling Germanmade goods and is violating the State Wald Act which prohibits the sale of merchandise with the name and place of manufacture erased, were dismissed yesterday by Judge George B. DeLuca in Bronx Ma gistrates Court for lack of evidence.

The charges were brought by a Bronx Jewish girl, Thelma Grossman, and by her attorney, Samuel H. Reis. Miss Grossman said in court that she was a member of the Non-Sectarian Anti-Nazi yeague. She stated that she purchased in a Woolworth store three cans of Golden Harvest fish food and that one of the cans was marked "Made in Germany"

Philip S. Goldshall of the Brookman Manufacturing Company appeared as a witness and testified that the cans of fish food were marketed by his company. assured the court that his firm has not bought anything from Germany since the beginning of the Jewish persecutions in the Reich under the Hitler regime.

### **Argentine Doctor Wins High Honor**

Medal Given Dr. Duchowitz By Medical Ass'n for Research Efforts

(Jewish Telegraphic Agency) BUENOS AIRES .- Dr. Adolph Duchowitz, a well-known Jewish physician, has been awarded a gold medal by the Argentine Medical Association for his researches in connection with women's diseases.

Dr. Duchowitz, who has been connected with the Jewish Hospital in Buenos Aires for the last six years, is known for his medical works which have been published in local and foreign medical journals.

The work for which he received a medal consists of a biographic index of articles on women's diseases written during the last twentyfive years. This index will be published by the Medical Association in the form of a 300-page book.

leading article the suggestion made Zionism provides the solution of the Jewish problem in Germany through wholesale emigration to Palestine.

"Large sections of the Jewish youth will have to look for a place in Palestine," it writes. "We do not underrate the importance of the transformation created as a result of this in the life of the individual. But, however much we may desire to win over the strongest and most valuable part of the Jewish Community for the tremendous upbuilding work in Palestine, we do not overlook the fact that it is a long and a far road that we have to go to attain the goal. It cannot be achieved at one blow.

#### Refers to Program

"If people say that the Zionists do not take into sufficient account the interests of the Jews who live here in Germany and will remain in Germany, we declare that so far as the Jews living in Germany are concerned, whatever their Jewis views may be, their interests must be equally protected, and a program along these lines was laid down in this paper two months ago, set out in the manner of four points.

"It would be too primitive to attempt to present the situation if our aim were simply 'emigra tion.' It means the acceptance of Judaism, and of the consoling realization that something new is in the process of growth which imposes big demands upon Jews.

"Jews will have to continue to live together with other people," the Juedische Rundschau declares. 'Jewish history in the past has often been a history of emigration.
