Jews Win **Court Test** In Rumania

Public Worship Minister Took Vote from 11,000 Illegally, Is Ruling

(Jewish Telegraphic Agency) BUCHAREST, June 24 - The unique court case in which 11,000 Jewish citizens of Rumania sued the Minister of Public Worship for depriving them of election rights to the Czernowitz Jewish Community, concluded today with a victory for the Jews.

Supreme Administrative Court in Czernowitz ruled that the action of the Minister of Public Worship was illegal. The verdict is considered of the most importance with regard to the maintenance of the autonomy of the Jewish communities in Rumania.

Denies Ministry's Right

In issuing its verdict, the court declared that the Ministry had no right to liquidate the legally elected Jewish Community in Czernowitz; also that Dr. Marcus Menczer, the government commissioner, had no right to change the statutes of the Jewish Community in Czernowitz which affected the election rights of the 11,000 voters. Furthermore, the court pointed out, he did not even have the right to propose such changes because these changes must come only from a properly elected autonomous organization.

Dr. Menczer, the government commissioner, argued in court that he changed the statutes of the Czernowitz Jewish community not on his own initiative but upon instructions from the Minister. The change made in the statutes provides that only those Jews who pay religious taxes can participate in the elections of the Jewish com-As a result of this change, 11,000 voters in Czernowitz who had not paid a religious tax were deprived of their voting rights and only 3,000 were qualified and entitled to vote.

Dr. Karl Guthertz, president of the dissolved Jewish community, in appealing to the court in the name of the 11,000 disfranchised Jews, argued that the change in the statutes was illegal because the Jew ish Community existed under statutes approved by the government.

Hate Pledge Is Given By **Nazi Youths**

10,000 at Solstice Fete Take Formal Oath Against Jews

(Jewish Telegraphic Agency) NUREMBERG, June 24 - More than 10,000 German children, members of the Nazi Youth organization, gave their formal oath eternal-"to hate the Jews," at the Summer solstice festival last night on Hesenburg Mountain in Franconia.

The pledge was given to Julius Streicher, overlord of Franconia, and to General Goering, member of the Nazi Cabinet.

Earlier in the afternoon Goering addressed a meeting of more than 200,000 Nazis here, the capital of Franconia, at which he told the audience to follow the anti-Semitic policy of Julius Streicher which is fully approved by the government.

"The next war must be a crusade against the Jews," Herr Streicher said, addressing the youth festival in the evening. "The fight against the Jews must be as dear to you as your religious faith," he empha-"The future of the Jews in Ru-sized to his youthful audience.

Fined \$750 For **Defacing Label**

Firm Seeking to Hide Nazi Origin of Imports Lashed by Court

With a stinging rebuke to companies that deface labels of country of origin on imported goods, Judge William Bondy in United States Southern District Court yesterday fined the Atlas Hardware Company, 105 Chambers Street, \$750 for destroying the "made in Germany" label on a gas pilot light and substituting the label "de luxe."

Judge Bondy ,in fining the company, declared that he wished the person responsible for the act was in court so that he might jail him.

Zionist Quarters Target Of Anti-Semites; 2nd Grodno Death

WARSAW, June 24-A bomb was thrown last night by anti-Semites into the building of the Zionist group Kadimah in Lwow, seriously injuring two Jewish youths and causing heavy damage to the build-

The two injured youths are Emanuel erbner, 13, and Ephraim Fort man, 14. They are both members of the Zionist sports organization which is situated in the same building.

The police so far have not succeeded in discovering the bomb throwers. It is believed, however, that they are members of an anti-Semitic youth organization.

Gedalia Blecher, a 50-year-old Jew, one of the victims of the anti-Jewish riots in Grodno, Poland, died today in the hospital from injuries received during the attacks Blecher is the second fatality re corded as a result of the riots.

Jewish leaders here feel greatly disappointed over the fact that the government authorities have refused to reopen the Anti-Nazi Boycott Committee offices. Government officials explained that the offices were closed because of an anti-Nazi stamp which the Committee issued. none of the government authorities had previously objected to it.

Laborites Get 21,688

These fifty-five cities gave the Laborite ticket 21,688 votes as compared with 12.335 received by the joint ticket of the General Zionists and Hadassah. The Mizrachi ticket received 8,955 votes in these cities.

Returns from 200 smaller Jewish communities are still to be received in the General Election headquarters in New York.

In New York, the number of votes cast in fifty-five precincts was 10.966. Of this number the Laborites received 4,493 the Mizrachi, 3,512 and the General Zionists together with the Hadassah, 2,961. Turkey 'Cracks Down' on Colonization

ISTANBUL.

TECENT developments have created much apprehension among the Jews of Turkey. The avowed intent of the government to create a strong spirit of Turkish nationalism and to "crack down" every force that might be considered to militate against this, combined with the fears of the authorities

which have shaken the Jewish community.

The first of these was the arrest of Sadiaah Tcherniak, director of the Istanbul office of the Jewish Colonization Association. No charges were made against M. Tcherniak at the time of his arrest, or even at this writing. He was taken to central police headquarters where he was held incommunicado for several days. M. Henri Soriano, president of the Jewish community, was refused permission to see him. M. Couteaux, head of the League of Nations Committee for White Russian Refugees of the Christian Faith, demanded permission to see M. Tcherniak and finally obtained it. M. Tcherniak is also the head of the League committee for Jewish refugees from Germany.

AFTER Mr. Whithall, the British consul, had intervened, Mr. Tcherniak was transferred from the criminal to the political section and was provisionally released three days after his arrest.

He was lengthily questioned regarding Jewish emigration from Turkey to Palestine and examined as to the existence in Turkey of an organized group spreading Zionist propaganda. He was evidently able to convince the authorities that his part had not exceeded the giving of technical advice and aiding the British consul in the distribution of Palestine immigration certifi-

Although M. Tcherniak was pro visionally freed, the files and records seized at his office and home were not returned by the police. These contained the identification cards of 400 Turkish Jews who had applied for visas to settle in Pales

WHAT action may be taken with regard to these people is a cause of grave concern to themselves, their families and the community generally. It is safe to assume that all whose cards were found in M. Tcherniak's possession will be examined closely by the authorities to discover whether they had violated or attempted to violate Turkey's strict regulations with regard to the export of capital from the country. 



> ficulties Shortly after the Tcherniak incident, which was more disturbing for the Jewish community because of the mystery which surrounded the entire case and the secrecy with which the examination was conducted, it became known that the authorities were prenaring a new piece of legislation which would hit one of the strongest unifying factors in Turco-Jewish life, the B'nai B'rith.

> Two weeks after the general congress of the People's Party, the government party, the press revealed that the congress had decided to bring an end to the activities of all sorts of organizations and associations not primarily based on the Turkish nationalistic program and which maintain affiliation with similar groups in other countries. This measure would strike principally the B'nai B'rith and the Masonic lodges.

> WHILE this measure has not yet been enacted into law, government circles state that it will be presented to the National Assembly within a few days. It passage there is a certainty.

That the government is fully determined that there shall be no interests in Turkey conflicting with the nationalistic program proclaimed by Kemal Ataturk was evidenced again by the arrest of a Hebrew teacher named Isaacs for secretly giving lessons in Hebrew at his home to seventeen Jewish boys. Isaacs has been held for examination by the magistrates. His case is taken by the community to signify that the government will tolerate nothing that can be considered at variance with the nationalism of the new Turkey.

Premier Applauds Book on Kossuth

Gomboes Voices Appreciation To Jewish Biographer of Hungary's Hero

(Jewish Telegraphic Agency) BUDAPEST, June 24 - Prime Minister Gomboes received the Ger man-Jewish author Otto Zarek, who has been living in Budapest for the last eighteen months and thanked him for his book on Kossuth, the Hungarian national hero. The book has been hailed as an epoch-making work.

The Premier had a long and friendly talk with Mr. Zarek. He discussed with him particularly that part of his book which deals with the Jewish combatants in the Hungarian wars for liberation and where he discloses that one-twelfth of those participating in these wars were Jews.

Mr. Zarek quotes many authentic sources showing that hosts of Jewish volunteers enlisted in all battalions fighting for Hungary's freedom. They fought bravely and with distinction, the book points out. Many of them fell on the battlefield and a large number were promoted to the ranks of officers.

The bravery of the Jewish fighters was recognized by the entire army, according to the documents in Mr. Zareks' book.

American Citizenship for Jews

The bill introduced in Congress last week calling for the issuance of labor permits to non-citizens in the United States, provides food for thought to Jewish organizations in America interested in naturalization problems.

There are thousands of Jews in America who have been living here for many years but who are still not American citizens. Many of them neglect to become naturalized for the simple reason that they find no time to apply for their naturalization papers. Others are not sufficiently aware of the importance of becoming naturalized.

A Job for Jewish Institutions All these persons will now be exposed to the danger of losing their jobs if a proper campaign is not started by Jewish organizations to enlighten them on the necessity of obtaining American citizenship to which they are entitled. Furthermore, they may face even more serious dangers than being deprived of the right to work.

So far there is no basis for fear that the bill demanding the ousting of non-citizens from employment will pass. The fact that such a bill has been introduced, however, indicates that it is high time for the proper Jewish institutions to see to it that every Jew in the United States should not neglect his right to become an American citizen.

Where Danger Lies

There is no doubt that many liberal-minded Americans will support any restrictions which may be recommended against aliens as far as employment is concerned. Such restrictions exist now in practically every country of Europe. They exist against Americans in those countries. Why should America give employment to English, French, German and other citizens when these countries discriminate against the employment of Ameri-

The demand to introduce labor permits for non-citizens in America, along the same lines as in every country in Europe, may therefore find more and more supporters in the United States, especially since its purpose is to decrease unemployment among American citizens.

Jews and Other Non-Citizens One can easily imagine how seriously Italians, Poles, Germans, Greeks, Irish and others who have not yet become American citizens, will be affected, if restrictions in employment are introduced in the United States for non-citizens. These persons, however, have the alternative of returning to their homeland and enjoying full freedom in their native country. But such is not the case with the Jew.

The Jew in America who is not an American citizen cannot return to Poland because he is looked upon as an alien there even though he may still be a Polish citizen. He certainly cannot return to Germany. He would not find it possible to return to Russia. All East European countries from which the Jews emigrated to the United States are now practically closed

A Motto for Organizations The duty of the HIAS, the Naturalization Aid League, the Council of Jewish Women and other similar Jewish organizations, is therefore to start a nation-wide campaign among all the Jews in the United States to become citizens before any drastic measures against non-citizens are passed.

The Lake Placid Convention

The Philadelphia Jewish Exponent, commenting editorially on the convention of the Jewish social workers in Lake Placid, says:

Despite the stand taken by some of our Social Service experts that no effort be made to divert the attention of Jewish youth from the professions of medicine and law, as this would he interpreted as a defeatest attitude, the prevalent sentiment seemed to be that it was not wholesame either for the individual Jews or for the Jewish groups to have too many representatives in these professions. The experiences of the Jews in Germany need not be taken as a standard of measurement, as no precaution can be taken against so brutal and unheard-of attitude as that taken by the upstart Nazi leaders. It is not well, however, that Jews should overcrowd a few chosen professions and become conspicuous in them, merely because of their numbers.

The plan presented by Dr. Samuel C. Kohs, and referred to in the presidential message of Dr. Ben M. Selekman, is not intended to stifle innate inclinations or aptitudes in any young man who is impelled to enter a profession that is to his liking. Such young men and women will probably be encouraged to enter upon their chosen fields and stimulated in their native predilections. What the plan attempts to do is to indicate to the youth and to their parents the various fields of activity open to them, to point out to them that it would be for their own good to engage in work more in harmony with their natural bent, and holding a greater assurance of future economic stability.

Nazi Treatment Of Catholics Cited

Comparing the Nazi persecutions of Jews with those of Catholics, the Truth, a Catholic organ in London, writes:

During the past week there have been fresh outburts of officially-inspired persecution against Catholics, Jews and political opponents. Systematic raids on monasteries and convents have been going on all through the week. They have been accompanied by numerous arrests, and among the victims are Dr. Legge, Secretary-General of the Central Committee of German Catholics: the Vicar-General of the ancient See of Hildesheim, in West Germany; and the superiors of several monasteries in Paderborn. The campaign, which culminated last Sunday in mob violence against collectors and subscribers to the Catholic "Caritas" collections until the collections themselves were banned by the police, have made many German Catholics fear that the government intends to root out their Church altogether.

Foreign Firms VinCourtRight In Holy Land

May Sue Local Concerns Without Being Listed, Court Rules

JERUSALEM.—The right of a foreign company not doing business in Palestine to sue a domestic firm without first registering with the government was established by the Court of Appeal in the suit of A. G. Stybel Publishing House, a German firm not registered in this country, against the Amanut Co. Ltd. and the Dvir Co. Ltd. The latter firm was established by the late Dr. erya Levin, Zionist leader.

however, the foreign firm is carrying on business in Palestine, the court ruled, it must be registered with the government in order to be able to bring action in Palestine courts.

The court further ruled that the burden of proving that a foreign company is doing business here rests with the opposing party.

The Stybel house, which is a partnership with limited liability, nad never received authorization from the government of Palestine to carry on business here nor had it registered under the partnership or companies ordinance.

In 1933, the Stybel concern applied to the Jaffa District Court for confirmation of an arbitration against the Amanut and Dvir ompanies. The two companies objected that since the Stybel Company was not registered in Palestnie, it could neither carry on business nor sue.

The higher court took the case on peal from the district court and decided that a foreign commercial association manufacturing goods abroad and having no place of business or agency in Palestine is not carrying on business here within the meaning of the law when it sells goods to Palestine rms. Therefore, it can sue in Palestine courts without registering.

Name Kraemer **GrandMaster** Of Zion Sons

Is Reelected at Bradley Beach Parley; Gets \$1,000 Gift

(Special to the J.D.B.) BRADLEY BEACH, N. J., June 24—Joseph Kraemer of Newark was unanimously reelected grand master of the Order Sons of Zion at the final session today of that

body's twenty-sixth annual convention.

The 250 delegates present, representing seven States, voiced their appreciation of Mr. Kraemer's services in the past year by presenting him with a gift of \$1,000.

Heinrich Abramowitz and Louis Rimsky, both of New York, were unanimously reelected grand secretary and treasurer respectively.

Yesterday the Convention listened to addresses by Morris Rothenberg, president of the Zionist Organization of America; Abraham Goldberg, Zionist writer, representing the Histadruth Ivrith; Mendel M. Fisher, representing the Jewish National Fund; and Dr. Harris J. Levine of New York.

In his address Mr. Rothenberg stated that Zionism is the only hope for world Jewry and strife in Zionist ranks. He predicted a substantial colonization of Jews in Transjordan within the next ten years, declaring that from seven to eight million Jews should be settled in that area.

At today's business session, the delegates voted a special fund of \$1,000 for the establishment of a cultural department to stimulate an increase in membership. They also voted to aid the Histadruth Ivrith and felicitated Daniel Persky, Hebrew writer, upon the silver jubilee of his Hebrew literary endeavors.

Message from Goldstein

A letter was read to the delegates from Dr. Israel Goldstein, president of the Jewish National Fund of America, thanking the Order for its interest and fund-raising in be half of the Keren Kayemeth. Mr. Fisher appealed to the constituent camps of the Order to join actively in a new Order project-raising \$25,000 during the next three years for a Nachlath B'nai Zion in Palestine.

Dr. Levine of the Bronx, chairman of the Order's committee on Palestinian endeavor, in his report pointed out that about two years ago the Order undertook to-raise \$25,000 to redeem a section of land in honor of M. M. Ussishkin. The money was to be raised by October 1 of this year, but due to the energy and loyalty of the members, it has been raised about six months ahead of time.

The delegates affirmed a resolution introduced by the committee on grand master's message opposing dual World Zionist congresses and pledging their unqualified adherence only to the forthcoming one in Switzerland in August.

They also favored more constituent youth camps and referred to their incoming executive board a plan whereby special committees shall study the establishment of special Sons of Zion Centers for various communities, commencing with Greater New York.

The Arab paper also reports today that "uniformed and Nazified" Arab youth troops are being formed in Palestine.

The Association of Jewish Youth watches over the activities of fourteen boys' and twelve girls' clubs and, in addition, provides sports equipment for Jewish schools in London.
