Nazi Bishop Spurs Drive Upon Jews

**Mueller Says Waning
Campaign Must Be
Revived**

(Jewish Telegraphic Agency)

BERLIN, June 26—Reichsbishop Mueller, addressing 1,500 pastors last night, predicted that "the decreasing anti-Jewish movement in Germany must flare up again."

The Reichsbishop declared that the leaders of the Nazi movement will not tolerate the fact that German Christians are continuing to patronize Jewish shops.

The Voelkischer Beobachter, Hitler's chief organ, reporting today the mannikin parade which was organized for "Aryan" tailor shops for the purpose of pushing Jews out of the dressmaking industry, states that the Jewish tailoring industry in Germany is now completely ruined.

'Aryan' Firms Increase

"While on January 30, 1933, there were only twelve 'Aryan' dressmaking firms in Germany, today there are over 300," the Voelkischer Beobachter emphasizes. "The Jewish role in our tailoring industry has been reduced to non-existence. It is especially small in the cities of middle Germany."

The supreme Jewish representative body in Germany, the Reichsvertretung der Deutschen Juden, issued a statement explaining how matters stand under the new conscription law, in view of the doubt which exists among many German Jews about their position with regard to the conscription of the class of 1935 now in progress.

"Aryan" origin is a condition only for active military service," the statement says. "The conscription law includes both active service and reserve service. It follows from this that the German Jews are liable to service on the

Colonies Honor The Baroness

**Shops in Shomrom Close
6 Hours; All Palestine
Mourns Death**

TEL AVIV, June 26—All Jewish shops and restaurants in the colonies of Shomron were closed for six hours today in mourning for the death of Baroness de Rothschild, widow of the late Baron Edmond de Rothschild, who was the father of Jewish colonization in Palestine.

The death of the Baroness was mourned throughout the country. The Tel Aviv municipality paid special tribute to her memory. Special services were held in all Tel Aviv synagogues.

Numerous messages of condolence were sent by Jewish institutions and leaders to James de Rothschild, son of the Edmond de Rothschilds, who is now residing in London.

Palestine Zionists Buy 110,000 Shekolim

JERUSALEM, June 26—Palestine Jews bought a total of 110,000 Shekolim, entitling holders to vote for delegates to the Zionist Congress, it was officially announced today.

Approximately seventy-five per cent of this number was purchased by Laborites. The second largest group to buy Shekolim was the Mizrahi. Elections of delegates to the Congress are set for July 24. Eighty-nine delegates are to be elected.

Austria Curbs Bar Members In Vienna Body

**Edict Aims to Keep Jews
From Administrative
Role in Ass'n**

VIENNA, June 26—Aiming to prevent Jewish lawyers from sitting on the Executive of the Bar Association, the Austrian government today decreed that members of the Executive are to be nominated and not elected.

Abolition of the elections, an action which is contrary to the democratic principles of the Bar Association, will make it impossible for Jewish lawyers to play any role in the administration of the association. Despite the fact that the Jews form a majority in the Bar Association of Vienna, they were not consulted by the government about the change of procedure in the election to the Executive.

Two separate bar associations—one for "Aryans" and the other for "non-Aryans"—will be formed by the government, the Jewish Telegraphic Agency learned here today from reliable sources. The introduction of a numerus clausus for Jews in the legal profession is also expected, according to information from the same source.

Memorial services for Jewish heroes who fell in the World War were held today at the Jewish cemetery in Graz, where forty-nine graves of Jewish soldiers killed during the war are located. Military honors were paid to the fallen heroes. Dr. Goerbach, leader of the Vaterland Front Organization in Styria, delivered the eulogy.

Poles Strip Liquor Men Of Licenses

**Edict by Finance Chief
Hits Jews, 75% of
Land's Distillers**

WARSAW, June 26—A further attack on Jewish economic rights in Poland was made by the Polish government, which decided yesterday to withdraw licenses from Jewish distillers who comprise seventy-five per cent of all distillers in Poland.

The Jewish press in Warsaw today, reporting the decision of the Minister of Finance, emphasizes that the partial withdrawal of licenses being effected before the decision was officially made, has resulted in throwing 20,000 Jews out of employment.

Seize Grodno Manifesto

The Polish authorities today confiscated a manifesto issued by the Trade Union Council in Grodno in connection with the recent anti-Jewish excesses there. The manifesto warned the Polish workers against the notion that Jews are responsible for the depression. The pro-Jewish document was confiscated for allegedly containing political references against the government.

The tragic position of Jewish artisans was depicted here at a conference of the United Committee for the Affairs of Jewish Artisans held at the B'nai B'rith lodge. The conference was attended by artisans, economists, social workers and journalists.

The new industrial war which hits 50,000 Jewish "home artisans," known as Chalupniks, was the center of discussion at the conference. It was pointed out by all speakers that this law is a severe blow not only to Jewish economic interests but also to Jewish rights in general.

4,008 Jews Entered The Holy Land In May

JERUSALEM, June 26—A total of 4,008 Jews entered Palestine as immigrants during the month of May, it was officially announced today in the Palestine Gazette.

Polish Parliament Passes New Electoral Law; Blow Against Both Anti-Semites and Jews

WARSAW, June 26—Despite the general strike proclaimed in protest against the new electoral law, the Polish Parliament today adopted the law at its second reading by a vote of 277 against 114.

The law, which is a blow to the anti-Semitic National Democratic Party and to other groups opposing the present regime, at the same time will affect Jewish representation in the Parliament.

"The 3,500,000 Jews in Poland demand not only their due representation in the Sejm, but also such representation in which they

can place confidence," Dr. F. Rottenstreich, member of the Sejm, declared in a speech on the new electoral law before the Constitution Committee.

Dr. Rottenstreich pointed out that the new electoral law gives the Jews a chance to obtain representation at best in five constituencies. In Eastern Galicia, for example, 650,000 Jewish votes will not carry a single seat, he declared. In the districts of Wilno, Lublin and Bialystok, more than 1,200,000 Jewish votes will not obtain a single seat.

Deny His Cellmates Beat 'Hitler' Healey

A report that Raymond J. Healey, self-styled "American Hitler," was beaten up by fellow-prisoners on Welfare Island where he is serving a sixty-day term for disorderly conduct, was denied by the office of the Commissioner of Correction yesterday.

An assistant to Commissioner Austin H. MacCormick said that Healey is at present confined in Correction Hospital on the island undergoing the psychiatric tests suggested by Magistrate Brodsky when he sentenced Healey.

Jobs in Soviet Agreeing With Doctor Exiles

**Like Their Work in Jewish
Colonies, They
Tell Agro-Joint**

MOSCOW, June 26—Jewish doctors who left Germany and were permitted to enter Soviet Russia with the assistance of the Agro-Joint, the American Committee to Settle Jews on Land in the Soviet Union, are highly satisfied with their work in the Soviet institutions and in the Jewish colonies, according to reports reaching the Agro-Joint today.

In a number of letters received by the Agro-Joint office here from these doctors, enthusiasm is expressed over the reception which they were given in the Jewish colonies and the life there. One of the doctors, a specialist on rheumatism, refused to leave the Jewish colonies in the Stalindorf region for a higher position in a Soviet university, declaring that he feels happy in the Jewish settlement.

The Agro-Joint has arranged special quarters for the German-Jewish doctors who are being brought over to Soviet Russia on visas obtained for them through the Committee's offices. Each refugee is entitled to live in the special quarters for a period of two months, during which time everything is provided for him, until he is settled. So far, however, not a single German-Jewish doctor has spent more than two or three weeks in these quarters because they all, without exception, have found employment immediately upon their arrival.

Rabbis Back Split Wealth, Labor Laws

**Socialization of Industry
Advocated at Parley
In Chicago**

CHICAGO, June 26—The socialization of the basic enterprises in the United States and the redistribution of national income in America in accordance with equity and justice, was recommended today at the forty-sixth convention of the Central Conference of American Rabbis in session here at the Congress Hotel.

This recommendation was made in a report delivered before the convention by Rabbi Sidney E. Goldstein of New York, chairman of the Commission on Social Justice.

The report deals with current economic problems in American life and also with problems of marriage and the Jewish family. It contains also a recommendation that the Commission be empowered to undertake the task of formulating an official social philosophy of Judaism for the Conference.

Urges Amendment

The Commission on Social Justice, according to Rabbi Goldstein's report, advocates that an amendment be introduced to the Constitution of the United States, making it possible for Congress to pass legislation on child labor, working hours, wages and social security.

In addition to advocating the socialization of basic enterprises in America, the report urges the adoption of a tax program to effect the redistribution of national income in accordance with justice and equity.

"The government must exercise its power to conscript the income accumulated in order to save the mass of people of America from

Talks by Stahl Barred in Reich

**Ban on Jewish Leader
Of Berlin Reported
In Paris Paper**

PARIS, June 26—The Pariser Tageblatt, a German newspaper published here, reports that it has received information from Germany that Heinrich Stahl, president of the Berlin Jewish Community, was forbidden to speak in public by an order issued by Dr. Frick, the Reichsminister of Interior.

Dr. Stahl returned recently from a visit to Palestine and delivered an address in Berlin in which he warned Jews not to emigrate from Germany before they have a definite possibility of establishing themselves in Palestine or some other country. It was for this speech that the German authorities decided to prohibit Dr. Stahl from making any public addresses in the future.

German Emigration to Palestine

BERLIN.

SOME of the problems involved in the work of settling German Jews in Palestine and some of the results obtained by the Central Bureau for the Settlement of German Jews in Palestine, which he directs, were described to the Jewish Telegraphic Agency here by Dr. Werner Senator, member of the Jewish Agency Executive in Jerusalem. Dr. Senator is now in Berlin for consultations in connection with these activities and to make preparations for the September session of the Council of the Jewish Agency at Lucerne.

The work of the Central Bureau, he said, is conducted with the funds raised in the campaigns of 1933-34 and 1934-35. New drives for this special purpose will not be undertaken. The work of the Central Bureau, which was previously conducted within the framework of the activity of the Jewish Agency Executive, will therefore later on be completely incorporated in the general work of the Executive of the Jewish Agency and continued in the same way as before.

* * *

WITH regard to the immigration of Jews from Germany into Palestine, he declared, it is not yet possible, after two years of systematic settlement by the Central Bureau, to give any definite judgment concerning its success, but a general estimate could be made, and this was absolutely positive.

In view of the difficult problem created by the preponderance of settlement in the towns as compared with agricultural settlement, Dr. Senator expressed particular satisfaction that a comparatively higher proportion of the immigrants from Germany have gone on the land.

"At a time of sudden mass immigration it is impossible to prevent a comparatively larger growth of the towns which absorb the immigrants at the very first. But this is only transitional. There is a tendency to direct the immigration from the towns to the land into productive occupations necessary for the development of the country, and the work of the Central Bureau for the Settlement of German Jews is making it possible to realize these efforts.

* * *

TWENTY-five per cent of the immigration from Germany goes immediately on the land, he declared. He described the three categories of immigrants as: 1) Young people, up to the age of 18, who are put into land settlements either direct from Germany, or with the aid of the Central Bureau from the Palestinian towns in

which they had taken up residence on arrival with their parents; 2) Chaltzim groups; and 3) about 400 middle class families who have, with the aid of the Central Bureau, undergone Hachsharah either on National Fund soil or private land, and settled in a colony organized and parceled out by the German section of the Agency.

Dr. Senator paid tribute to the excellent work of the Working Committee for Youth Immigration conducted in Palestine under the direction of Miss Henrietta Szold.

"The Department for Settlement of Jews from Germany has endeavored to increase the absorptive capacity of the existing settlements for new settlers by devoting special attention to the problems of dwelling houses and subsidiary work," he declared. "In general, the policy is to increase the permanent provision of employment, in agriculture by credits for production and water, and in the towns for artisan and middle class work."

* * *

SPEAKING of urban settlement,

Dr. Senator said that the Central Bureau has set up training courses for vocational reconstruction at the Technical High School in Haifa, Tel Aviv and in the larger colonies. "Sound private initiative," he said, "is promoted by the grant of middle class small credits. The statistics of the American Economic Committee show how strongly the German immigration seeks productive work in the towns. A walk through the industrial quarter of the Haifa Bay and the industrial enterprises from Ramath Gan to Petach Tikvah show to what a large extent Jews from Germany are co-operating in the industrialization of Palestine and thereby in the creation of permanent employment. In general," he concluded, "the economic situation in Palestine continues to be most favorable."

Young Israel Set For 11th Meeting

Formation of College Units To Be Considered at Asbury Park

The eleventh annual convention of the Council of Young Israel will be held this week-end at the Clarendon-Brunswick Hotel, Asbury Park, N. J., Moses N. Hoenig, president, announced yesterday. The council represents forty branches in the United States, Canada and Palestine.

Formation of Young Israel groups in colleges and problems of orthodox Jewry will be considered. A year book entitled "The Golden Future of Young Israel," edited by Morris Lifschitz and Hayman Epstein is being prepared in connection with the convention.

A business session will be held Sunday at which 1,500 persons are expected. Speakers will be: Irwin Steingut of the New York Legislature, Assemblyman Samuel Mandelbaum, Rabbi Bernard Revel, president of Yeshiva College

Sons of Zion Adopt 10c Tax to Aid A.J.C.

Between the Lines

Jewish Divorce Racket

The Jewish divorce law is now coming to the fore in America. Only recently the Rabbinical Assembly of America dealt with it at length. Now the Vaad Harabonim, the Association of Rabbis of Greater New York, is considering measures to check what they call the Jewish "divorce racket."

At the association's convention which is now being held here, open accusation of maintaining so-called divorce mills, were made against a number of orthodox rabbis. These rabbis are charged with issuing divorces to husbands without even consulting the wives involved.

Restricting Rabbinical Rights

A recommendation is therefore now under discussion at this convention to restrict the rights of the rabbi with regard to issuing a Jewish religious divorce. The proposed restriction provides that in future a Jewish divorce may be issued only by a Beth Din, a rabbinical court composed of not less than three rabbis.

That "divorce mills" exist in New York is a fact which cannot be denied. Individual reverends are issuing Jewish religious divorces at a cost of a few dollars, without even the knowledge of the woman who is being divorced—certainly without her consent.

The Passive Wife

It is therefore to the credit of the rabbinical convention that this question has been taken up openly in order to put a stop to the abuse by some rabbis of the divorce law. It is essential that order once and for all be established in the chaotic divorce situation.

As is well known, the right to issue a divorce is vested, according to Jewish law, in the hands of the husband. The wife plays a passive role when it comes to divorce.

Equal Rights Essential

This unjust attitude towards the Jewish wife must be corrected. Equal rights should be given to the wife, in order not to make her dependent on the whim of the husband.

Although no common approach can be found by the different rabbinical groups in the United States on numerous problems in Jewish life, a practical solution to the Jewish divorce problem could be found if representatives of all these rabbinical groups get together just on the question of regulating operation of the Jewish divorce law.

Round Table Conference Needed

The rabbis in America owe it to the American-Jewish woman to find a common solution to the problems of the deserted or divorced wife. There is no reason why a round table conference of representatives of all the rabbinical bodies should not be held in order to save the Jewish Desertion Bureau some of its unpleasant work and also to prevent cruel divorces on the part of irresponsible husbands.

The divorce racket among Jews must be stopped. The prestige of American Jewry demands it. Those who can stop it are the rabbis themselves. A round-table conference of rabbis of all groups is the need of the hour.

World Press Digest

Crown Colony Plan Is Criticized

The *Haolam*, official organ of the World Zionist Executive in London, carries an article by Dr. Nahum Sokolow criticizing those who would like to see Palestine a Crown Colony. Dr. Sokolow writes:

They are all anxious to obtain certain trade privileges accorded to the other British Colonies. It is, however, too much to ask that for the sake of preferential treatment, they should try to alter the international foundations on which the Jewish National Home rests. It is in the interests of their national idea that Palestine should remain on an international basis.

The Anti-Semitic Weekly in Dublin

The *London Jewish Chronicle*, commenting on the publication of the first anti-Semitic weekly in Ireland, says:

In a pronouncement on the back page of the paper the public is specially directed to note that the policy of the paper, while anti-Semitic, is not one of attack on the Jewish Religion. So far it is not known who are the promoters or the editorial and the writing staff, but the pronouncement shows that the writing staff includes at least one humorist. One of the causes of this anti-Semitism in the Free State is the appreciable part played by Jews in the economic and commercial life in Dublin, and the opportunity taken by them of the openings in industry and commerce resulting from the policy of the present Free State government to industrialize the Free State and make it eco-

nomically self-supporting. In particular, the prominence of Jews in the manufacture and sale of clothing and furniture has led, it is stated, to a good deal of jealousy and ill-feeling on the part of their non-Jewish competitors. A matter of congratulation is the fact that the present government is completely free from sectarian prejudice, and with its record of rule, based on high principles of justice and impartiality, it can be relied on confidently to ensure that the uglier manifestations of anti-Semitism will not show themselves in Irish life, or will be repressed if they do.

Treatment of Jews By Nazis Varies

The *Manchester Guardian*, in an editorial entitled "The Jews in Germany," says:

In Germany the treatment of the Jews varies from place to place; it is worst in Berlin and in the South, especially in the districts which Julius Streicher, the Franconian district leader, controls. But everywhere Jews are kept not only out of the armed and the civil services but by indirect means out of all the professions and the universities. There are some who fear that the ultimate Nazi policy is to segregate the Jews entirely in a kind of extended ghetto. But a country with the civilized traditions of Germany cannot and will not permanently seek to base itself on racial persecution.

Zionist Parley To Draw 400 To Atlantic City

Platform for Congress, New Agency Plan To Be Aired

Between 400 and 450 delegates are expected at the thirty-eighth annual convention of the Zionist Organization of America which will be held at the Ritz-Carlton Hotel in Atlantic City, beginning Sunday, June 30, and continuing through July 2.

The number of delegates, it is estimated, will be at least 100 more than attended last year's convention. The increased attendance is partly to be accounted for by the fact that the World Zionist Congress will be held later in the Summer, and the convention at Atlantic City will have the opportunity of designating the final list of delegates representing the General Zionists and instructing them on the stand they are to take with respect to the issues to be brought up at the World Congress.

The convention will be opened Sunday morning by Morris Rothenberg, president, who will in his annual message review the developments of the year and offer recommendations for the further strengthening of the movement.

To Urge New Form for Agency

It is understood that among the new matters Mr. Rothenberg will deal with is a proposal affecting the structure of the Zionist Organization of America so as to bring within its scope large sections of American Jewry, and that he will also suggest a new form of representation in the Jewish Agency to the end of making it a more effective instrument.

Among other proposals that are expected to come forward for discussion is a project for the creation of National Economic Board for Palestine, for the purpose of coordinating and expediting in a more regulated way the present development that is taking place in Palestine.

Other proposals of interest affecting the internal structure of the Zionist Organization and its general stand with respect to partisan argument will be taken up for consideration.

A symposium addressed to the question of the future structure of the Zionist Organization will be participated in by Elihu D. Stone, Abraham Goldberg, Rabbi Edward L. Israel, Prof. Gustave Klausner, Dr. Alexander Wolf, Max Shulman, Dr. A. M. Heller, Leo Wolfson, Rabbi A. H. Silver, Ezra Shapiro and Bernard G. Richards.

To Air Platform

Unquestionably, great interest will be aroused by the discussion of the platform of the American delegates to the Lucerne Congress. The many questions that are to come up before the forthcoming World Congress make the stand of the American delegation of high importance.

The matter of fund raising for Palestinian purposes, it is expected, will come up for considerable debate. The point has been raised that at present several of the funds for Palestinian purposes have an element in them which appear competitive to the public.

Preceding the formal gathering of the convention, a meeting of the national executive committee will be held Saturday night, presided over by Ezra Shapiro of Cleveland, chairman of the national executive committee.

The first session of the convention proper will be held Sunday morning, June 30, at eleven o'clock, with greetings from the Governor of New Jersey and other distinguished personalities, including the heads of affiliated Zionist bodies.

A Shmarya Levin Memorial session with eulogies on the late Zionist leader by Maurice Samuel, Prof. Louis Finkelstein and Abraham Goldberg will be held on Sunday evening.

Monday morning, July 1, will be devoted to meetings of the convention standing committees.

The fourth session, Monday afternoon, will be devoted to the following issues: World Zionist Congress, Platform of American Delegates to the Congress, Instruction of Delegates, World Union of General Zionists, Jewish Agency for Palestine and Selection of Delegates to the Congress.

The fifth session, Monday evening, will be devoted to the presentation of reports of the several Palestine funds, including the United Jewish Appeal, the American Palestine Campaign, and affiliated Zionist bodies, and the Zionist Extension Fund. Dr. Israel Goldstein will report for the Jewish National Fund. Morris Margulies, secretary of the Zionist Organization, will present his report at this session.

The sixth session, Tuesday afternoon, has been set aside for a discussion of Zionist youth problems, the discussion to be led by Israel Chipkin, Charles A. Cowen and Milton Taylor.

The same session will see the adoption of all convention resolutions. The convention will be closed with elections on Tuesday evening, July 2.

Chicago Congress Unit Maps Year's Program

CHICAGO, June 26 — A mass Jewish organizations was held here tonight at which a program for the coming year for the local branch of the American Jewish Congress was adopted.

Probe of 'Divorce Mills' Here Ordered by Orthodox Rabbis

"Divorce mills," a widespread racket that has arisen under the Jewish law that any rabbi can give a man a divorce, came in for bitter denunciation at the convention of the Association of Rabbis of Greater New York, an orthodox group, which continued in its second week yesterday at Young Israel Hall, 229 East Broadway.

After a number of rabbis had heatedly attacked the system, the executive committee of the association was instructed to investigate and propose reforms.

Rabbi Israel Dushowitz, president of the association, suggested a plan whereby a Beth Din, or rabbinical tribunal, of three rabbis would be empowered to grant divorces.

Previously, speakers had told of numerous cases of "reverends" and irresponsible persons calling them-

selves rabbis, who, for a small sum of money, give men divorces without the knowledge or consent of their wives.

The convention is the first held by the association in a number of years.

Recently the Rabbinical Assembly, a body of Conservative rabbis, adopted a reform whereby a deserted wife can secure a divorce decree after three years provided there is a clause in the marriage contract permitting it.

Social Justice Body Advocates Law to Protect Labor's Rights

Amendment Regulating Child Labor, Hours, Wages Urged

misery and despair," the report recommends.

The danger of dictatorship in the United States, the report says, has greatly lessened through the decision of the Supreme Court killing the NRA. On the other hand, the danger of Communism and Fascism is growing greater through activities of well-organized groups and of reactionary organizations which are engaged in the name of patriotism in unpatriotic efforts to limit American liberties.

"We urge that an investigation be undertaken by the U.S. Senate Judiciary Committee concerning the dangers which threaten us. Such an investigation would uncover the source of the un-American propaganda activities against the established rights of the workers and the farmers," the Social Justice report states.

The Commission also advocates the development of projects now under the government work relief program, which will not depress the wage structure and which will at the same time give proper employment to young men and women who can be saved from demoralization and delinquency through vocational education and employment.

Seeks Labor Protection

The Commission also urges that a Federal law be passed setting up an agency to assure labor the right to organize and to bargain collectively as they must be protected against wrongs and the danger of economic oppression.

"We take our stand without reservation and compromise at the side of the workers in America," the report says.

Rabbi Max C. Currick of Erie, Pa., chairman of the Committee for International Peace, speaking on the international armament race, expressed the fear that the United States by all signs will undoubtedly be embroiled in the next war unless public opinion is sufficiently aroused in this country to prevent that eventuality.

"All peace lovers must be united so that the President and Congress shall realize the extent and the depth of the anti-war sentiment in the nation," Rabbi Currick said.

Backs Arms Embargo

Rabbi Currick declared that one sure way of keeping out of war is to join the collective system of the world with the object of abolishing war through the League of Nations. He urged support of the measure now before Congress to put an embargo on munitions.

The Committee on International Peace recommended that the Conference approve the Ludlow Amendment to the Constitution. The recommendation was also made to take the following attitude towards Germany:

"The Reich forms at the present time the greatest menace to peace in the Western World. We believe that while it is our duty to extend relief to the victims of Nazi cruelty and to agitate for the restoration of their human and citizenship rights, it is in the interest of world peace that our government should use its good offices to help restore the political and economic equality of the oppressed national minorities in Germany."

The report of the International Peace Committee reaffirms the previous stand of the Central Conference of American Rabbis advocating adherence to the World Court

and joining the League of Nations.

Symposium on Platform

Opening a symposium on the "Revaluation of Reform Judaism," which is the main theme of discussion at the convention, Dr. David Philipson of Cincinnati, gave an account of the conditions in American Judaism in the first half of the 1880's that led to the convening of the historic "Pittsburgh Conference" of 1885, at which was adopted the Platform of Reform Judaism in America, which has been adhered to with few exceptions ever since its adoption fifty years ago.

Reviewing the controversy between the Orthodox or Conservative and Reform Jewish leaders of that day, Dr. Philipson narrated the events which led to the actual convening of the Pittsburgh Conference, the story of the drafting of the Pittsburgh Platform, and a description of the repercussions in the Jewish religious world of that day.

Dr. Philipson, dean of American Rabbis, is the sole surviving member of the Committee which drew up the platform. Only one other person who participated in that conference—Dr. Samuel Sale of St. Louis—survives. Dr. Philipson was the youngest Rabbi at that historic meeting, and acted as secretary of the Conference.

In closing his presentation, Dr. Philipson urged the rabbis to make any changes in the Pittsburgh Platform, if necessary, "with deliberation and with a deep consciousness of our responsibility as the heirs of a great religious liberal tradition and as the instruments of a continuing revelation of God's truth with the passing of time."

"Let us beware lest we listen to the siren voices of sentimental reactionism or the advocacy of a political program," he concluded.

New Concept Of Judaism Is Laid to Zionism

Goldenson Cites Danger Of Regarding It as Civilization

(Special to the J.D.B.)

CHICAGO, June 26—Emphasizing that Judaism means religion rather than the recently advanced conception which would make of Judaism a civilization, Dr. Samuel H. Goldenson of New York, in his presidential address last night before the opening session of the annual convention of the Central Conference of American Rabbis, declared that the new interpretation of Judaism is due more than anything else to Zionism.

"There is a special reason," Dr. Goldenson said, "why Judaism as a religion tends to be less and less emphasized in connection with the Palestinian venture, while the so-called cultural aspects of the Jewish contributions are stressed more and more. That reason is that religion, particularly the high reaches of it, attained by the prophets of Israel, tends to be universal and transcendent."

"Such a conception of religion cannot but weaken every appeal that is based upon purely nationalistic and racial grounds."

Pointing out that he is not speaking in derogation of Palestine as a homeland for those Jews who dwell therein, either from choice or compulsion, Dr. Goldenson said:

"Should the tendency to substitute secular and political for spiritual values grow stronger and become incorporated in the group life of Palestine, I cannot but express the fear that Palestine may become like any one of a half dozen lands in that part of the world, where there will be the same racial antagonisms, class strife, economic exploitation, political chicanery and cultural barrenness."

"It is thought," Dr. Goldenson said, "that by regarding Judaism as a civilization instead of a religion it will be easier to cope with the disintegrating forces of modern life. But the incidental result of this thought is to demote the religion of Israel from its high and exalted place that it has always occupied in the life of the Jew."

in its representation in the Parliament, through which it should be able to speak to the government and Polish public opinion.

"We are a minority constituting ten per cent of the population of Poland and we feel ourselves degraded by this new electoral law," Dr. Rottenstreich declared, emphasizing that the Jews consider the maintenance of the proportional electoral system as the only just solution.

Spokesmen of the anti-Semitic National Democratic Party (Endeks) expressed the fear that the Jews might be able to secure in Lodz, Wilno, Cracow and Lwow, more seats than the four apparently saved for them.

The rapporteur for the government on the Constitutional Committee, Deputy Podoski, thereupon assured the anti-Semitic spokesmen that "the Jews cannot be certain of more than four seats."

"Two seats will be secured by them in Warsaw and two in the rest of the country," the deputy stated.

A.Z.A. Members Start Farm in Minnesota

Lacking the money to start the project, Horwitz and Greenspan secured the sponsorship of the A.Z.A. chapter. Victor Cowl donated a garden tract and officials of the chapter endorsed a \$100 note to provide money for seeds and fertilizer.

basis of the supplementary regulations to the conscription law. All those born in 1914 and 1915, and in East Prussia also in 1910, must therefore present themselves. German Jews are liable to service even if they are not qualified for active military service."

The statement refers to Paragraph 19, Clause 2, of the Ordinance, which says that those of "non-Aryan" origin who are liable to service and who do not within a fortnight after the conscription date submit an application for active military service, are transferred to the Additional Reserve II, which means that they are placed on leave.

"The possibility of submitting such an application," the statement of the Reichsvertretung explains, "exists under Paragraph 15, which allows for active military service irrespective of 'Aryan' origin. This

exemption does not apply, however, to pure race Jews.

"It is therefore useless for German Jews to apply for active military service. This must be made clear, no matter how painfully this legislation may affect German Jewry. To make such applications would also be incompatible with the requirement that Jews should remain reserved," the statement concludes.

Report Organized Riot Against Jews in Berlin

The United Press, in a dispatch from its Berlin correspondent yesterday, reported anti-Jewish demonstrations in Berlin in front of three Jewish ice-cream parlors.

An apparently organized mob of several hundred, including a scattering of uniformed storm troopers and Hitler youth, picketed three Jewish ice-cream parlors in Berlin, smashing one show window and forcing one shop to close. Police dispersed the crowd, many of whom were obviously sympathetic to the Jews and shouted "Scandal!" and "Shame!", the United Press reports.
