## Nazis Press Jews Hard InFrankfurt

#### Survey Discloses Loss of Nearly All Civil and **Human Rights**

(Jewish Telegraphic Agency)

FRANKFURT-AM-MAIN, July 8-The position of Jews in Frankfurt is today even worse than in Nuremberg, the seat of Julius Streicher's anti-Semitic activity, a survey by a special correspondent of the Jew ish Telegraphic Agency discloses.

For the last six months the con dition of the Jews has been going from bad to worse. Jews have vir tulaly been deprived of every civil and human right here, and are daily subjected to the most humiliating experiences.

The streets of this town are now hung with streamers saying: "Jews are Not Fellow Citizens." banners are displayed everywhere flaunting the demand: "Jews Must Go From Frankfurt."

#### Drive Intense

The anti-Semitic campaign is so ntensive here, that ninety per cent of the German shops are forced to display signs reading: "This is a German Business."

Most of the restaurants in this town make their appeal to "Aryan" trade by hanging out signs an nouncing that "Jews have been thrown out of here," or "Jews are not admitted here."

The large hotels are displaying announcements to the effect that "Jews and dogs are not allowed

Jews are not even safe when walking down the streets. Gangs of young Nazi hooligans follow every Jewish pedestrian taunting him with vile epithets, and making his passage impossible. And the Jews do not dare defend themselves against these attacks.

The Jews of this city have also heen notified that they may not use the municipal baths, a ban that is now general throughout Germany.

From another Frankfurt in Germany, Frankfurt-am-der-Oder, it is reported today that twenty-five additional names are listed of Jews who are deprived of their citizenship.

#### Jews Refused Right To Statue of War Hero

(Jewish Telegraphic Agency) BERLIN, July 8-The statue of Ludwig Frank, the only Reichstag member to be killed in the World War, which was recently

removed from the Goetheplatz in the city of Mannheim, may not be placed in the Jewish cemetery there, the municipal authorities of that city decided today.

The Frank statute was removed from the square by Nazis. The Jewish community petitioned the authorities for permission to place it in the Jewish cemetery. In refusing, the authorities gave as the reason the opinion that Frank had died for his country, not for the Jewish Community.

### Jews to Mark **Court Victory** In Czernowitz

#### To Celebrate Ruling That Returned Autonomy To 11,000

(Jewish Telegraphic Agency)

CZERNOWITZ, July 8-A decision to celebrate the recent ruling of the Czernowitz court against the Minister of Public Worship and in favor of the autonomous existence of the Jewish Community, was adopted today by the Jewish Community here.

The celebration is intended to serve as a lasting memorial so that posterity may remember how the autonomy of the Jewish Community in Czernowitz was secured, leaders declared today.

At the same time, officials of the Jewish Community announced today that they will not consider themselves responsible for the tax debts incurred by the government commissioner during the period of his regime. The government commissioner was appointed by the Minister of Public Worship to administrate the affairs of the Jewish Community here immediately after the dispute between the Community and the Minister started.

The debts incurred during the government commissioner's regime amount to millions of lei, it was disclosed today. These debts have endangered the existence of the entire Jewish Community of this city.

## **ReportNeed** For Labor In Crimea

#### Bumper Harvest Finds Dearth of Farm Hands In Jewish Colonies

(Jewish Telegraphic Agency)

MOSCOW, July 8-A shortage of labor is reported today from the Jewish colonies in Crimea in connection with the bumper harvest

The lack of farm hands in the Jewish colonies is endangering the harvesting of the crops. The shortage is ascribed to the fact that a large number of Jewish settlers left the Crimean settlements last year and returned to the cities to engage in industrial work.

The Moscow Emes, official Jewish Communist daily, reviews today the Jewish situation in Biro-Bidjan and emphasizes that the Far Eastern Jewish autonomous district is experiencing a period of prosperity. This prosperity, according to the paper, is expressed in the greater turnover in the local stores where the Jewish settlers spent 500,000 roubles in the month of May alone. It is also seen in the fact that the settlers are inviting their relatives from other parts of Soviet Russia to come to the Bureya.

#### Jewish Radio Plans Unknown in London

LONDON, July 8-Postmaster General Tryon knows of no Jewish radio station that is to be erected in England, he stated today in the House of Commons. The Postmaster General declared that he has received no request to issue a license for such a radio

The erection of a Jewish broadcasting station in England had been reported in a number of English newspapers, provoking great interest. According to the report the station was to be devoted to Jewish programs only, avoiding anything that could be construed as propaganda.

## Graft Attempt Costs Official His Soviet Job

#### Asked 25 Jews for 'Gift' In Exchange for Citizenship

(Jewish Telegraphic Agency)

MOSCOW, July 8-For extorting money from twenty-five declassed Jews on a threat of refusing to grant them citizenship, A. Greenblatt, chairman of the local Soviet in the township of Slavuta, Ukraine, was removed from his position today and will be put on trial together with a number of other local Soviet officials.

The twenty-five Jews discriminated against were recently permitted to take jobs in a local lumber mill, despite the fact that they were still being considered in the category of "declassed" elements. While working at the mill they proved to be among the best workers and were recommendede for citizenship.

The local Soviet had no objection to granting them full citizenship. However, they were notified by some of the officials of the Soviet, including the chairman, Green blatt, that citizenship would be granted to them only if they paid 500 roubles as a "gift" to the Soviet.

## Riots Flare **In Several Polish Cities**

#### Campaign by a Catholic Paper Stirs Attack in Upper Silesia

(Jewish Telegraphic Agency)

WARSAW, July 8-Anti-Jewish attacks in which the windows of many Jewish houses and shops were smashed are reported today from the town of Rybnick in Upper Silesia, while a wave of anti-Jewish propaganda is reported from several places in Pomerania.

The Rybnick riots started as a result of particularly venomous anti-Semitic propaganda conducted by the local Catholic paper, Zwiazeck Catolicki. The report does not indicate whether any arrests were made.

Posters Urge Boycott

Slowo Pomorski, a leading Polish newspaper, reports today from Semplona, Pomerania, that many houses in the neighboring townships are displaying posters calling upon the Polish population to boycott the Jews. "All those buying cott the Jews. from Jews are traitors to the country," the posters read.



Jews and Monarchs

Is monarchy good for Jews? This question is now being asked in two European countries: Austria ond Greece.

In Austria, where the Jews fear the eventual coming of the Nazis to power, the restoration of the Hapsburg monarchy and the bringing of Archduke Otto to Vienna is looked upon with favor in some Jewish circles. It is believed that with the proclamation of Archduke Otto as Emperor of Austria, the Jewish position there may be more secure than it is now.

Similar is the situation in Greece where the movement of restoring a monarchy there is considered a realistic possibility. Though the Jewish population in Greece has no reason to complain against the present Tsaldarist regime which is very friendly toward the Jews, no one can predict what the future holds in store for Greek Jewry as long as there is no political stability in the country. Only a monarchy can save Greece from repeated civil wars and thus forever establish safety for the Jews, numerous Jewish leaders in Greece believe.

#### Monarchy in Austria

There are today thousands of Jews in Austria who still remember the regime of the Emperor Franz Joseph, who was known for his friendliness toward the Jews. In the event of restoration of the Hapsburg dynasty in Austria, many Jews believe that the pro-Jewish tradition of Franz Joseph would be revived by his successors.

With Austria what it is today and with the constant fear of a turn which may hand over the administration of the country to Nazis, the Jewish population would rather see the return of Archduke Otto to the throne than eventual control by Hitler. With Otto ruling Austria, the Italian influence over the young Austrian Emperor will no doubt be greater than that of Nazi Germany. The Jews in Austria have, therefore, nothing to lose if monarchy is restored there.

#### A King for Greece

In Greece the Jews will also lose little if the king is returned to power. The present regime, which is not anti-Jewish, is silently sponsoring hte idea of bringing the king back to Athens. The one who opposed this idea was Venizelos. The Venizelist party has turned out to be definitely anti-Semitic, just as it is anti-monarchistic. Under a monarchy it will definitely not be permitted to grow. Hence the anti-Semitic movement in Greece will be checked if the king returns to the throne.

Officially the Jewish leaders of both Austria and Greece are refraining from an express of opinion on the advancing monarchist movements in these countries. The issue is too serious and too complicated and it is, therefore, logical that the Jews in these countries should abstain from committing themselves to any definite opinion. The situation, however, in these two countriesespecially in Austria—is quite clear. It cannot get any worse under a monarch than it is today under the Cabinet of Dr. Schuschnigg. The promises made by Dr. Schuschnigg with regard to normal treatment of Jews in Austria are not at all being kept. Perhaps a Hapsburg will keep his.

of war there were approximately 1,500 men, women, and children of the Jewish faith. There were approximately 200 men of military age. Of these 153 served in the forces, and 20 were killed. Included in the 200 mentioned there were some physically unfit for service, who took work of national importance. During the war 50,000 Jews domiciled in the British Empire served with the various forces, and of these 2425 made the supreme secrifice, while 6500 were wounded.

British Jews gained the following decorations: Victoria Crosses, 5; Distinguished Service Orders, 49; Military Crosses, 263; Distinguished Flying Crosses, 11; Distinguished Conduct Medals, 85; Military Medals 329; Meritorious Service Medals, 66; mentioned in dispatches, 336; foreign honors, 138; mentioned in home dispatches, 155; other distinctions, 159.

## Mayor Names|| Kin of Dr. Wise **ToFamilyCourt**

#### Mrs. J. W. Tulin Is First Woman in State to **Hold High Post**

Mrs. Justine Wise Tulin, daughter of Rabbi Stephen S. Wise, was vesterday sworn in as justice of the Domestic Relations Court at ceremonies in City Hall. She is the first woman in the State to hold a judicial post higher than magistrate.

Mayor LaGuardia, who swore in Mrs. Tulin, lauded her for her work às assistant corporation counsel in harge of the Workmen's Compenation Bureau in the law department.

"You have rendered a very valuable service to the City of New York," the Mayor said. "You have re-established and rehabilitated the workmen's compensation department in saving hundreds of thousands of dollars that formerly went to medical politicians.

"You cleaned that out and did a fine job.

"I may not keep you in this court for very long, but for the present it needs your vision and your understanding. I know you'll make good.

#### Term Is for 30 Days

Mrs. Tulin, who is thirty-two years old, thanked the Mayor simply for the appointment.

Her term will last thirty days after which it is believed that she will be appointed to succeed Justice Samuel D. Levy who has announced he will retire.

Mrs. Tulin said she had made no definite plans for changes in the court procedure. "My first job," she said, "is to find out all about my job."

Asked about her opinions on how the court should be run, she said, "Ask me that again in a few

Mrs. Tulin's last job was as legal assistant to Oswald W. Knauth, city relief administrator.

#### Authority on Compensation

She is known for her interest in labor and is regarded as an authority on workmen's compensation Mrs. Tulin is a graduate of Barnard College and Yale Law

After her early studies at Radcliffe and Bryn Mawr, she left school, changed her name and became a factory worker in the silk and woolen mills of Paterson and Passaic, N. J., in order to gain firsthand knowledge of labor condi-


The case involved the attempt of Isaac E. Goldman, Francis Goldman. Rebecca Goldman and Rose Goldman to remove their father's remains from an Orthodox to a Reform cemetery. Exhuming corps es is contrary to orthodox law.

Abraham Goldman, the father, who had been a member of the Sir Moses Montefiore Synagogue, leading Orthodox, congregation, had been buried in the family plot in the Montefiore Cemetery. After his death, the children joined the Beth Ahabah Congregation, leading Reform congregation in Virginia.

When Rachel, the mother, died, she was interred in the Hebrew Cemetery, controlled by the Reform congregation. The children tried to exhume the father's corpse so that it could be buried in the same plot, but the Orthodox trustees refused permission.

The children thereupon brought a bill in equity to enjoin the trustees from preventing the disinterment. In court, Rabbis Edwin N. Kallish and Sidney H. Lefkowitz, witnesses for the children, testified that the Shulchan Aruch, which forbids disinterment, is out moded and no longer binding on

## Cautions Jews On Absentee Land Holding

#### Freiberger Says U.S. Citizens Must Develop Palestine Property

The danger of American Jews owning land in Palestine and not developing it was emphasized yesterday by the American Zion Commonwealth, in a statement issued by David Freiberger, its president.

"We have many purchasers, devoted Zionists, who in good faith have purchased land for sentimental reasons, who are unable to keformGroupPlans live in Palestine and have no plans for the improvement of the property," the statement says. "Such ownership is detrimental to the building of Palestine as well as Governing Body of World to the owners, for the following

#### Cites Land Laws

"1. There is a la win Palestine known as the Land Dispute Ordinance, by virtue of which any person who is in possession of land, lawfully or unlawfully, even by force or violence, is alloewd to remain in possession of the land until evicted by order of the Court, which is not easily done.

"2. There is another law in Palestine known as the Protection of Cultivators' Ordinance, which gives almost ownership rights to persons who lawfully or unlawfully take possession of land and cultiit. These persons become statutory tenants after one year of occupation, and cannot later be evicted."

#### Trouble With Squatters

The American Zion Commonwealth, according to Mr. Freiberger's statement, has had constant litigation involving an expenditure of tens of thousands of dollars in order to protect the land against trespassers and squatters, because of the above laws.

"The only way to protect the land is to build or cultivate it," Mr. Freiberger warns.

The statement by the American Zion Commonwealth also touches upon the problem of preventing speculation in acquiring land from those who are not ready to improve

"We have found a solution to this problem," the statement points out. "An organization has been created under the auspices of the Central Bureau for Settlement of German Jews in Palestine, of which Dr. Chaim Weizmann is the head, and which has been organized for the purpose of acquiring land for German refugees. This new organization, known as the Rassco (Rural Agricultural Society Cooperative), will acquire land especially for absentee owners who have no desire to take possession and cultivate it, at a fair market price, and will resell such land to refugees upon fair prices and terms.'

#### Seen as Bar in Speculation

Mr. Freiberger expresses the belief that in acquiring large tracts of lands, the Rassco will be in a position to regulate and dictate prices which will have the effect of preventing unwholesome speculation.

"We have every reason to believe that those of our Zionists in America who have purchased land from us and have no desire to take possession will not hesitate to dispose of their lands to the Rassco rather than to speculators," the statement concludes.

The new order calls for the dismissal of those teachers who are married to any "non-Aryans" even though the latter may have served in the German army and have seen duty at the front in the last war.

With this new order the Minister of Education aims to remove any possibilities of "contaminating" the minds of the "Aryan" youngsters in the schools through even the remotest contact with "non-Arvans."

Addressing a church conference in Kassel, Reichsbishop Mueller told his listeners that every German must realize the importance of keping German blood untainted, and therefore all "non-Aryans" must be extirpated in Germany.

Jews being the enemies of Christ and Christendom, he said, they are therefore also the enemies of every German, and consequently every German must feel it a personal duty to have nothing whatsoever to do with the Jews.

## Heirs in Austria

#### Wassermann's Villa Near Vienna Is Sold At Auction

(Jewish Telegraphic Agency) GENEVA-A picture of the difficulties encountered by Jacob Wassermann's heirs, is given by Mrs. Julie Wassermann, his first wife, in an interview with the "Israelitisches Wochenblatt für die Schweiz." In this interview, Mrs. Julie Wassermann points out that Jacob Wassermann's will showed the same loving consideration for her and her four children, as for his second wife.

The villa which he possessed at Grinzing near Vienna has been sold at auction. This step was not the work of creditors, but the act of a single mortgage holder whose claim, amounting to 3,000 Austrian shillings, was in the end reduced to 1,000. The security offered by a Dutch publishing house was refused. The Berlin publishing house of S. Fisher which owes the family Wassermann tens of thousands of marks and which could have paid them into a German account, refused to give anything to the creditor.

Sold for Small Sum The villa was sold at auction for the extremely low sum of 58,000 Austrian shillings and it was bought by Herr Kommerzialrat Hollitzer, the husband of the well known Austrian actress,

Mrs. Wassermann at first thought that Hollitzer had bought the villa as an act of friendship toward Wassermann's family and was deeply disappointed when the real facts became known to her. son of Wassermann, who lived in the villa, was informed that he had to move out only three hours before the officials came to claim possession of the building.

Wassermann's valuable library in the villa was packed up by certain people who had no relation with the Wasserman family. The books have now been deposited with the Vienna municipality.

According to Mrs. Julie Wassermann, an attempt is now being made to sell also Wassermann's villa at Alt-Aussee (Styria). cording to the author's will, this house had been made over to her children and Mrs. Martha Wasser-This house, too, contains mann. an extremely valuable library with fourteen manuscripts by the author, and also all the books published by the Insel Verlag bound in vellum, as well as original editions of the publishing house of S. Fischer. Mrs. Julie Wassermann is at present doing her utmost to prevent the second house from falling under the hammer and is trying to raise the 40,000 Austrian shillings required for that purpose.


