## ZIONIST CONGRESS ASKS WORLD SUPPORT AGAINST NAZIS

LUCERNE, Switzerland, Sept. 3. (JTA) -- Over the opposition of the German delegation, the 19th biennial World Zionist Congress at its closing session today adopted a strongly worded resolution protesting the persecution of the Jews by the Nazis and appealing to the world to "assist the Jews in the fight to guarantee their existence."

The action came after Rabbi Stephen S. Wise of New York, president of the American Jewish Congress, in a powerful address had scored the Nazi regime in Germany.

The Zionist Congress "esether with the Jews throughout the world are fighting the racial theory of the Nazis "which aims to degrade a people on the Jole besis of rece," Dr. Wise declared.

He stated that it was beneath the dignity of the Congress to pay attention to the "slanders and falsities" of the "Protocols of the Elders of Zion." However, he thanked Swiss Jewry for furnishing an occasion to expose these falsities by the Berne trial. (He referred to the recent trial in Berne in which the "Protocols," purporting to reveal a Jewish plot for world domination were ruled a forgery."

The resolution follows:

"The 19th World Zionist Congress raises its voice against the systematic deprivation of rights of German Jewry which with growing intensity is undermining the moral and material existence of the Jews in Germany.

"At the same time the defamation of the entire Jewish nation is also being conducted by the German government with a view to under-mining the Jewish position in the whole world.

"The Zionist Congress considers it its legitimate duty to repudiate in the name of the Jewish people the defamation of the Jews on account of their racial origins as a contradiction in the elementary principles of morality and justice.

"The protest against this deprivation of rights does not concern only the Jewish people, but it is a question of the defence of the principle of equality of rights of all peoples."

The resolution further declares, "The Jewish people, which has defended its honor and national character during centuries of history regardless of great sacrifices, will never under any circumstances or for any price give up this fight.

"The Jews will fight for equality of rights of Jewish citizens of all countries as well as for their rights of existence as nationals among the nations of the world, and will defend with the same determination its right in other countries as they will defend the right for its national existence in Palestine as the solution to the problem of the Jews.

"The Jewish question has become a world question. It demands for its solution the cooperation and sympathy of the non-Jews of the world.

"The 19th Zionist Congress appeals to all peoples of the world to assist the Jews in the fight for the defense of their honor and to guarantee their existence."

The resolution was reported to the Congress by Dr. Wise as head of the Committee on the Situation of the Jews in Diaspora Lands.

# ZIONISIS BACK WORLD JEWISH CONGRESS

In addition, the Congress adopted a resolution approving the convocation of a world Jewish congress and instructing all Zionists and all Zionist groups to participate in preparation for the parley.

The resolution emphasises that the economic and political situation of the Jews in several Disspora lands is constantly growing worse and endangering the national minority rights of the Jewish populations of these countries.

"The World Jewish Congress would be composed of representatives of all factions of the Jewish nation and created along democratic lines," the resolution states. "Therefore, it is an urgent requirement of the work of defending Jewish political rights and their economic existence."

The first conference of the non-Zionist members of the Jewish Agency council was held today to formulate their demands for the

their demands for the sessions which open tomorrow. More than forty members from all parts of the world are present.

The Swiss Jewish Community will give a reception to the agency members tonight in the Congress and Arts Palace where the Zionist Congress is boing hele.

# FAVOR TRANSFER AGREEMENT CONTINUANCE

Late last night, amid tumultuous scenes during which delegates of the Jewish State Party shouting "Hitler Agents buy German goods!" demonstratively left the hall, the Congress adopted a resolution favoring the continuance of the Palestine-German barter agreement. The Congress decision, however, removes control of the transfer from the Haavara, special trustee office created for the execution of the pact, and lodges supreme control with the World Zionist Executive.

The resolution was adopted by a vote of 169 to 12. Seventeen refrained from voting. The entire Mizrachi delegation of 65 absented itself from the hall when the resolution was reported. The resolution had the support of the Laborites and Group A General Zionists. The Jewish State Party and Group B General Zionists, right-wing groups, opposed it.

The resolution, read by Rabbi Abba Hillel Silver of Cleveland, rapporteur for the special committee on the transfer agreement, follows:

"In order to encourage the continued immigration into Palestine of Jews from Germany, the incoming Executive is instructed to take over control of the work of Haavare."

A minority resolution demanding complete abrogation of the agreement with Germany was introduced by the Jowish State Party, but was defeated. As soon as the vote was announced, the Jewish State Party delegate marched out of the hall in protest.

Rabbi Silver informed the Congress that the committee had adopted a series of resolutions in connection with the barter pact which were not publishable, but which guaranteed that the transfer be limited only to transactions involving the capital of German-Jewish immigrants and that no goods imported from Germany through the transfer agreement can be sold in countries neighboring Palestine, he said.

Meier Grossman, leader of the Jewish State Party, speaking for his faction and Group "B" General Zionists, declared if the Congress decided to continue the agreement "the Zionist Executive will actually be converted into an agency for German industry."

Dr. Schmorak of Poland, speaking for Group "B" General Zionists, charged that it would be impossible to continue the anti-Nazi

boycott in Poland which is being conducted at a great loss to the Jews, "if the Zionist Executive agrees to act as official agents for Germany."

Mrs. Goldie Meyerson, Palestine woman labor leader, defended the resolution. "The boycott against Hitler," she said, "should not be converted into a boycott against the Jews in Germany." She emphasized that German Jews must be saved and must be enabled to go to Palestine. Under the control of the Zionist Executive, she said, no unscrupulous parties would be able to take advantage of the batter nact for personal exin.

#### \$15,000,000 COLONIZATION BUDGET ADOPTED

The Congress decided to raise at least \$15,000,000 in the next two years to meet urgent colonization requirements, and at least \$10,000,000 for the acquisition of new lend in Palestine. This is to be raised through the Keren Hayesod, Zionist colonizing agency, and the Jewish Pational Fund, land redemption agency, respectively.

The Congress also urgod the Executive of the Jewish Agency for Palestine to assist the Jewish National Fund in its present negotiations for a huge national loan to facilitate land redemption.

At the same time the Congress adopted a budget for the Zionist Organization for 1936. The budget aggregates \$1,940,000 and includes among its main items the following: \$150,000 for the settlement of German Jews in Palestine, \$372,500 for general colonizing work, \$275,000 for the immigration department of the World Zionist Organization and \$50,000 for the development of training farms for prospective young immigrant workers in the various countries of Europe.

The budget also includes \$100,000 for education, \$65,000 for the labor department of the organization, \$60,000 for its political department and \$55,000 for the administrative expenses of the World Zionist Executive. An appropriation of \$105,000 is set aside for the administrative expenses of the Keren Hayesod, Zionist colonizing and fund raising agency.

The Congress also decided that no Zionist or non-Zionist may enjoy "active or passive election rights" in the council of the Jewish Agency unless he has contributed to the Keren Hayesod, Zionist members of the Agency Council were instructed to fight for the adoption of this measure at the session of the council which opens here tomorrow.

# JEWISH DOCTORS TO COUVENE IN TEL AVIV NEXT SPRING

LUCERNE, September 3. (JTA) -- A world Jewish medical congress will be convoked in Tel Aviv, Palestine, in the Spring of 1936,

# AMERICAN JEWISH PELIE FUND PASSES \$1,500,000

NEW YORK, Sept. 3. (JTA) -- In an appeal to the Jews of America for a renewed effort to obtain large sums for German Jewish relief before the close of 1935, Felix M. Warburg, national chairman of the United Jewish Appeal, announced today that the Appeal has raised \$1,500,000 to date.

More than 600 communities in every part of the country participated during the Spring and early Summer in the raising of the sum which is being used for the relief and rehabilitation of the Jews of Germany and other lands and for settlement of Jews in Palestine. The campaign of the United Jewish Appeal has opened on January lat with a goal of \$3,250,000. It will continue until the end of the year and hundreds of additional cities and towns are organizing to conduct campaigns in September and October.

Emphasizing that an intensive effort would have to be made by American Jews within the next few months if the recently increased needs of the Jews of Germany, Poland and other lands were to be met, Mr. Warburg pointed out that scores of additional communities are still to hold campaigns before the end of the year. These include Baltimore, Louisville, Dayton, Memphis, Cincinnati, Youngstown, Altoona, Seattle and the State of Washington, Fargo and North Dakota, Nashville, Oakland, Erie, Roanoke, Newburgh and many others.

# NAZI ORGAN URGES "RESTRAINT"

BERLIN, September 3. (JTA) -- Demanding "the utmost restraint from taking the law in one's own hands," the Schlesische Zeitung, off-

icial organ of the National Socialist Party in Breslau, today reveals the real reason for the sudden flurry of reprovals by high Nazi officials against anti-Jewish acts in Germany.

Obviously referring to Economics Minister Schacht's efforts to secure loans abroad, the paper in an editorial states: "In this very difficult time for German foreign policy, everything must be avoided which might raflect against Germany."

The resolution was reported to the Congress by Dr. Wise as head of the Committee on the Situation of the Jews in Diaspora Lands.

# ZIONISUS BACK WORLD JEWISH CONGRESS

In addition, the Congress adopted a resolution approving the convocation of a world Jewish congress and instructing all Zionists and all Zionist groups to participate in preparation for the parley.

The resolution emphasises that the edonomic and political situation of the Jews in several Diaspora lands is constantly growing worse and endangering the national minority rights of the Jewish populations of these countries.

"The World Jewish Congress would be composed of representatives of all factions of the Jewish nation and created along democratic lines," the resolution states. "Therefore, it is an urgent requirement of the work of defending Jewish political rights and their economic existence."

The first conference of the non-Zionist members of the Jewish Agency council was held today to formulate their demands for the

their demands for the sessions which open tomorrow. More than forty members from all parts of the world are present.

The Swiss Jewish Commanity will give a reception to the agency members tonight in the Congress and Arts Palace where the Zionist Congress is being hele.

#### FAVOR TRANSFER AGREEMENT CONTINUANCE

Late last night, amid tumultuous scenes during which delegates of the Jewish State Party shouting "Hitler Agents buy German goods!" demonstratively left the hall, the Congress adopted a resolution favoring the continuance of the Palestine-German barter agreement. The Congress decision, however, removes control of the transfer from the Haavara, special trustee office created for the execution of the pact, and lodges supreme control with the World Zionist Executive.

The resolution was adopted by a vote of 169 to 12. Seventeen refrained from voting. The entire Mizrachi delegation of 65 absented itself from the hall when the resolution was reported. The resolution had the support of the Laborites and Group A General Zionists. The Jewish State Party and Group B General Zionists, right-wing groups, opposed it.

The resolution, read by Rabbi Abba Hillel Silver of Cleveland, rapporteur for the special committee on the transfer agreement, follows:

"In order to encourage the continued immigration into Palestine of Jews from Germany, the incoming Executive is instructed to take over control of the work of Haavare."

A minority resolution demanding complete abrogation of the agreement with Germany was introduced by the Jewish State Party, but was defeated. As soon as the vote was announced, the Jewish State Party delegate marched out of the hall in protest.

Rabbi Silver informed the Congress that the committee had adopted a series of resolutions in connection with the berter pact which were not publishable, but which guaranteed that the transfer be limited only to transactions involving the capital of German-Jewish immigrants and that no goods imported from Germany through the transfer agreement can be sold in countries neighboring Palestine, he said.

Meier Grossman, leader of the Jewish State Party, speaking for his faction and Group "B" General Zionists, declared if the Congress decided to continue the agreement "the Zionist Executive will actually be converted into an agency for German industry."

Dr. Schmorak of Poland, speaking for Group "B" General Zionists, charged that it would be impossible to continue the anti-Nazi

boycott in Poland which is being conducted at a great loss to the Jews, "if the Zionist Executive agrees to act as official agents for Germany."

Mrs. Goldie Meyerson, Palestine woman labor leader, defended the resolution. "The boycott against Hitler," she said, "should not be converted into a boycott against the Jews in Germany." She emphasized that German Jews must be saved and must be enabled to go to Palestine. Under the control of the Zionist Executive, she said, no unscrupulous parties would be able to take advantage of the barter pact for personal gain.

# \$15,000,000 COLONIZATION BUDGET ADOPTED

The Congress decided to raise at least \$15,000,000 in the next two years to meet urgent colonization requirements, and at least \$10,000,000 for the coquistion of new lend in Pelestine. This is to be raised through the Keren Hayesod, Zionist colonizing agency, and the Jewish Pational Fund, land redemption agency, respectively.

The Congress also urgod the Executive of the Jewish Agency for Palestine to assist the Jewish National Fund in its present negotations for a huge national loan to facilitate land redemption.

At the same time the Congress adopted a budget for the Zionist Organization for 1936. The budget aggregates \$1,940,000 and includes among its main items the following: \$150,000 for the settlement of German Jews in Palestine, \$372,500 for general colonizing work, \$275,000 for the immigration department of the World Zionist Organization and \$50,000 for the development of training farms for prospective young immigrant workers in the various countries of Europe.

The budget also includes \$100,000 for education, \$65,000 for the labor department of the organization, \$60,000 for its political department and \$55,000 for the administrative expenses of the World Zionist Executive. An appropriation of \$105,000 is set aside for the administrative expenses of the Keren Hayesod, Zionist colonizing and fund raising agency.

The Congress also decided that no Zionist or non-Zionist may enjoy "active or passive election rights" in the council of the Jewish Agency unless he has contributed to the Keren Hayesod. Zionist members of the Agency Council were instructed to fight for the adoption of this measure at the session of the council which opens here tomorrow.

# JEWISH DOCTORS TO COUVENE IN TEL AVIV NEXT SPRING

LUCERNE, September 3. (JTA) -- A world Jewish medical congress will be convoked in Tel Aviv, Palestine, in the Spring of 1936,

it was decided yesterday at the concluding session of the conference of Jewish doctors held here.

The purpose of the world congress will be:

- 1) To consider the general situation of Jewish doctors in various countries.
- 2) To consider the health problems of Jews in countries with large Jewish populations.
- 3) To work out measures to combat the tropical infectious diseases in Palestine.
- 4) To consider the establishment of a medical faculty at the Hebrew University in Jerusalem.

A special committee of prominent Jewish doctors has been appointed to make the necessary arrangements and to contact Jewish medical organizations throughout the world.

# AMERICAN JEWISH PELIE FUND PASSES \$1,500,000

NEW YORK, Sept. 3. (JTA) -- In an appeal to the Jews of America for a renewed effort to obtain large sums for German Jewish relief before the close of 1935, Felix M. Warburg, national chairman of the United Jewish Appeal, announced today that the Appeal has raised \$1,500,000 to date.

More than 600 communities in every part of the country participated during the Spring and early Summer in the raising of the sum which is being used for the relief and rehabilitation of the Jews of Germany and other lands and for settlement of Jews in Falestine. The campaign of the United Jewish Appeal has opened on January 1st with a goal of \$3,250,000. It will continue until the end of the year and hundreds of additional cities and towns are organizing to conduct campaigns in September and October.

Emphasizing that an intensive effort would have to be made by American Jews within the next few months if the recently increased needs of the Jews of Germany, Poland and other lands were to be met, Mr. Warburg pointed out that scores of additional communities are still to hold campaigns before the end of the year. These include Baltimore, Louisville, Dayton, Memphis, Cincinnati, Youngstown, Altoona, Seattle and the State of Washington, Fargo and North Dakota, Nashville, Oakland, Eric, Roanoke, Newburgh and many others.

# NAZI ORGAN URGES "RESTRAINT"

BERLIN, September 3. (JTA) -- Demanding "the utmost restraint from taking the law in one's own hands," the Schlesische Zeitung, off-

icial organ of the National Socialist Party in Breslau, today reveals the real reason for the sudden flurry of reprovals by high Nazi officials against anti-Jewish acts in Germany.

Obviously referring to Economics Minister Schacht's efforts to secure loans abread, the paper in an editorial states: "In this very difficult time for German foreign policy, everything must be avoided which might reflect against Germany."

# ANTI-JEWISH DRIVE GRO C IN THE SAAR

SAARBRUECKEN, Sept. 3. (JTA) -- The anti-Jewish drive is gaining momentum in the Saar territory, a survey of the district by a special Jewish Telegraphic Agency correspondent reveals.

Anti-Jewish posters are posted throughout the territory. Signs bearing the inscription "Jews are not permitted to enter," appear on the roads leading to many towns and villages. Many communities have posted signs reading "Jews are not tolerated here."

The anti-Jewish boycott in the business field, too, is pressed most vigorously, and numerous Jewish establishments are being forced to shut their doors.

In Saarbruecken proper, anti-Jewish posters have been put up in front of the principal synagogue.

#### GERZON, AMSTERDAM MERCHANT, DIES

AMSTERDAM, Sept. 3. (JTA) -- Eduard Gerzon, noted Jewish merchant and philanthropist, died here today. He was 73 years old.

# H.J. HIJMAN DEAD IN ROPTERDAM, AT 68

ROTTERDAM, September 3. (JTA) -- H. J. Hijman, member of the Rotterdam City Gouncil, and noted journalist, died here today. He was 68 years 'ld.

Hijman was also noted as a philanthropist, and was a founder of the Rudelsheim Institution for Feeble Minded Children here.

# HOLLAND'S QUEEN KNIGHTS 12 JEWS

AMSTERDAM, September 3. (JTA) -- Twelve Jews were knighted today on the occasion of Queen Wilhelmins's fifty-fifth birthday. Numerous other Jews are mentioned for various honors on the Queen's birthday honor list.
