FAILURE TO GET BIG LOAN SPURRING SCHACHT AGAINST NAZIS

BERLIN, Sept. 13. (JTA) -- The real reason for Economic Minister Schacht's determination to insist at the Nazi Party Congress in Nuremberg that the war against the Jews be abated is based on the unsuccessful attempt of the Reich's economic dictator to secure a loan of £200,000,000 in London and in New York, a special correspondent of the Jewish Telegraphic Agency was authoritatively informed today.

Dr. Schacht, however, has not given up his attempts to secure the loan, and has prepared to make every effort in this direction.

London banking circles, it is learned here, informed Schacht that the persecution of Jews and Catholics, as well as the strong measures recently adopted to crush the Stalhelm organization, are taken as evidence that the German situation is not stabilized, and therefore a loan to Germany is considered insecure.

REPORT LUTHER WILL BE RECALLED AS PROTEST ON BRODSKY RULING

BERLIN, Sept. 13. (JTA) -- The German government is contemplating the recall of Hans Luther, ambassador to the United States, as a gesture of protest against the decision of Magistrate Louis B. Brodsky of New York in freeing five defendants accused of inciting to riot in connection with disturbances on the liner Bremen July 26, it was authoritatively reported here today.

It was understood Dr. Luther would be replaced by another ambassador, whose name could not be learned.

It became known today that Reichsfuehrer Adolf Hitler will add his voice to the protest against Judge Brodsky's decision and alleged insults to the German flag when he addresses the Reichstag in Nuremberg Sunday evening.

Hitler's protest will be one of the sharpest yet voiced by a government official, it was said.

In preparation for Hitler's address Sunday night, it was reported from Nuremberg today, several anti-Semitic speeches were delivered to the Nazi Party Congress in session there. Every speaker this morning, including Minister of Agriculture Richard Walter Darre, attacked the Jews as enemies of the Reich. It was understood that the anti-Semitic speeches were being delivered to set the proper atmosphere for Hitler's address.

While the exact nature of Hitler's address is unknown as yet, it was indicated today that special laws against the Jews which Hitler intends to submit to the Reichstag for ratification will be practically the only internal matters which the Reichstag will be permitted to discuss.

The remainder of the speech will be devoted to foreign affairs, chiefly the German demand for colonies, it was learned. An attack on the Communist International and a warning to Europe about the situation in Memel will also be contained in the address.

It was reported that Hitler would also declare that Germany will never return to the League of Nations.

JEWISH CATTLE DEALERS LOSE SUIT AGAINST REICH COOPERATIVE

BERLIN, Sept. 13. (JTA) -- Stating that "not the dead letter of the law, but the meaning of the law under the Nazi racial principles," must be considered, the district court at Aachen (Aix-la-Chapelle) near the Belgian border, today rejected the writ of the Jewish cattle dealers against the local milk-marketing cooperative society.

The Jewish cattle dealers sued the cooperative for refusing to pay the agreed price to farmers dealing with Jews.

The Hartsfurt municipality municipality today warned local business men dealing with Jews that they would not receive orders from the municipality. It also warned that others dependent on the municipality would not receive unemployment benefits if they are caught having any dealings with Jews.

The same city bans Jewish children from child welfare centers in the community.

Benches in all public parks in the town have signs reading "Use by Jews not permitted."

In Rommersheim-am-Rhein orders were issued today forbidding Jews to park automobiles in public parking places.

Orders will shortly be issued by the Reich ministries of culture prohibiting Jews to attend cinema theaters throughout Germany, it was disclosed here today.

Laws to this effect are already in operation in Kiel and in numerous smaller cities. The effect of this new decree would be to extend the ban to cover the entire Reich and thus isolate the Jews further by restricting them only to performances arranged by the Jewish Cultural Association, under the control of Hans Hinkel, special Nazi commissar for Jewish cultural and intellectual affairs.

REICH COURT UPHOLDS FATHER WHO REFUSED DOWRY
TO DAUGHTER WHO WED JEW

COBLENZ, Germany, Sept. 13. (JTA) -- An "Aryan" woman today lost a court suit to force her father to give her a promised dowry which he was withholding because she married a Jew.

Although the woman had wed three years ago, before the Nazis came into power, the local court upheld the father, ruling that although the law against mixed marriages has not yet been proclaimed, an "Aryan" woman in marrying a Jew violates the racial principles of the Third Reich.

100 DELEGATES AT WORLD MACCABI CONGRESS IN CZECHOSLOVAKIA

BRUENN, Czechoslovakia, Sept. 13. (JTA) -- Representatives of the Czechoslovakian Government and of the Jewish Community today greeted the world congress of Maccabi, Jewish sport organization. More than 100 delegates and 1,000 guests from many countries are participating.

The congress sent a greeting in the name of Jewish youth to Czechoslovakia's President Masaryk, a noted friend of the Jews and Zionism.

Dr. H. Lilewer, president of the World Maccabi Organization delivered the keynote address, outlining the future program of the sport organization.

The Jewish Telegraphic Agency learns from unofficial but reliable sources that the praesidium of the organization has decided not to participate in the forthcoming Olympic games in Berlin, but that this decision shall not be binding on the German Maccabi organization.

LEAGUE APPOINTS GROUP TO STUDY REFUGEE ORGANIZATION

GENEVA, Sept. 13. (JTA) -- The special committee appointed by the League of Nations Assembly to investigate the Norwegian demand that the League establish an organization under its aegis to deal with the problems of refugees from Germany and other lands, today decided to create a sub-committee composed of representatives of fifteen states to study the matter further and report at a later meeting.

A majority of speakers at the session of the committee, presided over by Eamon de Valera, president of the Irish Free State, declared that they favor the proposal in principle, but would like to have the question studied by a sub-committee.

The Latvian, Italian and Russian representatives spoke against the proposal, but were not opposed to a study by a sub-committee. The Greek and Rumanian representatives made certain reservations.

Those favoring the proposal were Britain, France, Switzerland, the Netherlands, Poland, Sweden, Belgium, Czechoslovakia, Yugoslavia, China, and Norway.

JULIAN ROSE, COMEDIAN, DIES IN LONDON AT 66

LONDON, Sept. 13. (JTA) -- Julian Rose, veteran music hall and radio entertainer, died here today. He was 66 years old.

Rose, who was a native of America and originally resided in Philadelphia, was famous as the creator of the comic character, Levinsky. His best known monologue, "Levinsky's Wedding," was rendered thousands of times.

NO SURPRISE EVINCED AT U.S. RAISING TARIFFS AGAINST GERMANY

WASHINGTON, D.C. Sept. 13. (JTA) -- Diplomatic circles expressed no surprise today at the State Department's action in informing the German embassy that when the German-United States commercial agreement expires Oct. 15, the Reich will not enjoy the tariff concessions given other nations.

The notification, commercial experts said, follows naturally the action of the United States three weeks ago in dropping the "most favored nation" clause from the new treaty after the German government had informed the United States it could not live up to that provision of the treaty.

As a result of the new treaty, German exporters will be forced to pay the full Smoot-Hawley tariff on about 100 articles on which concessions in some cases as high as 50 per cent have been made to other nations.
