# SOVIET TO CULTIVATE 370,650 ACRES IN BIRO-BIDJAN

MOSCOW, Sept. 23. (JTA) -- An additional 150,000 hectares (some 370,650 acres) in Biro-Bidjan will be brought under cultivation in order to make possible the settlement of 200,000 Jews in the autonomous Jewish territory in the next few years, according to a plan approved yesterday by a special conference of the Agricultural Commissariat here.

The conference also decided to develop Biro-Bidjan into the biggest center of light industries in the Far East. Plans for the exploitation of coal fields in the region were also acted upon.

These plans, however, must first be approved by the Soviet Government before they can go into effect.

#### DR. KARPF STARTS SURVEY OF SOVIET JEWISH COLONIES

MOSCOW, Sept. 23. (JTA) -- Dr. Maurice J. Karpf of New York, head of the Graduate School of Jewish Social Work and a member of the World Executive of the Jewish Agency, arrived here today preliminary to undertaking a survey of the Jewish colonies in Crimea and the Ukraine.

Dr. Karpf is accompanied by Dr. Joseph Rosen, head of the Agro-Joint, committee for settlement of Russian Jews on the soil.

# HITLER FAVORS NATIONAL MINORITY STATUS FOR JEWS, PAPER REPORTS

BERLIN, Sept. 23. (JTA) -- Hitler himself favors a modus vivendi for Jews on the basis of a national minority status, but the radical wing of the Nazi party has a different opinion, the Frankfurter Zeitung states today. The paper also predicts that the Jewish question in Germany will in the future be solved only "in the sense of the Nazi Party program and in the spirit of the anti-Jewish Hackenkreug (swastka.)"

Meanwhile it was announced today that drastic new regulations prohibiting Jews from acquiring real estate and regulating the status of Jewish landlords have been completed.

The drafts of the new measures, it was learned, have been worked out by the Association of Nazi Jurists in collaboration with the legal department of the Nazi Party.

Announcing that there are still 143 Jewish movie house owners in the Reich, Der Angriff, Propaganda Minister Joseph Goebbels! personal organ, states that these holdings will be liquidated no later than December 31.

The paper also boasts that otherwise there is not a single Jew left in the German film industry, which formerly was 90 per cent in the hands of Jews.

The mayor of Munioh today forbade Jews even of foreign citizenshi to attend the celebrated Munioh festival in October "because their presence might lead to disturbances."

The order provides that no Jews should be employed even in the preparation of the festival.

# WARSAW JEWS APPEAL ON BEHALF OF REICH JEWRY

WARSAW, Sept. 23. (JTA) -- Protection for German Jews was today demanded by the Executive of the Jewish Community here in a telegram sent to James G. MacDonald, League of Nations High Commissioner for German and Other Refugees.

The Jewish Community Executive also addressed an appeal to the Board of Deputies of British Jews and to the Committee of Jewish Delegations of which Dr. Stephen S. Wise of New York is president, to strengthen Jewish defence activities.

The Jewish population of Warsaw was appealed to strengthen the anti-Nazi boycott.

A proposal was made by the Executive to consult Jewish world organizations about convening in Paris a world conference of rabbis to proclaim a Cherem (excommunication) against Nazi Germany. According to Jewish religious law anyone having dealings with an excommunicated person or thing is himself subject to communication. The effect of such a nove, it is felt here, would trapefor be to enforce more stringently the boycott of German goods and services.

## 2 JEWS SENTENCED IN GRODNO SELF-DEFENSE SLAYING

WARSAW, Sept. 23. (JTA) -- The Grodno District Court has sentenced Samuel Steiner to twelve years in jail and Melach Kontorowski to two years for participating in the slaying of Wladyslaw Kuszcza, who was stabbed while taking part in anti-Jewish riot in Grodno last June 10.

The defendants were also ordered to pay Kuszcza's family 30 zlotys a month as compensation.

Steiner and Kontorowski were two of the eight Jews held with 30 non-Jews after a Jewish self-defense corps had resisted an anti-Semitic attack which resulted in 60 injuries and unascertainable damage to property.

#### TEL AVIV TAKES STEPS TO MEET WAR CRISIS

TEL AVIV, Sept. 23. (JTA) -- In view of the threatening Italo-Ethiopian situation, Vice-Mayor I. Rokach today called upon Tel Aviv bankers, industrialists and heads of economic institutions to ensure continuance of normal Palestine economy and financial activities.

All economic leaders replied that they are cooperating in measures to face the crisis and to weather unheavals abroad.

# URGES USE OF SURPLUS TO STABILIZE PALESTINE BANKS

JERUSALEM, Sept. 23. (JTA) -- Appropriation of £500,000 (About \$2,500,000) from the idle surplus of the Palestine government for the prompt stabilization of Palestine banks, especially the smaller banking institutions, was urged today by Haaretz, Palestine daily newspaper.

A recent government report revealed the treasury surplus as  $\pm 5,727,690$  (about \$28,000,000).

#### ROTHENBERG VISITS BIALIK, LEVIN GRAVES

JERUSALEM, Sept. 23. (JTA) -- Morris Rothenberg, president of the Zionist Organization of America, today decorated the graves of Chaim Nachman Blalik, late Hebrew poet laureate, and of Shmarya Levin, late Zionist leader, in behalf of the American Organization at impressive memorial services.

RIGA, Latvia, Sept. 23. (JTA) -- The Jewish ropulation of Memel is greatly perturbed by Nazi propaganda in connection with the forthcoming elections on October 29, it was reported here today.

## FIRE GUTS SALONICA JEWISH QUARTER; SYNAGOGUES SAVED

SALONICA, Sept. 23. (JTA) -- Led by Grand Rabbi Zvi Hirsch Koretz and his son, firemen succeeded in saving the synagogues in a fire which today destroyed many Jewish houses and shops in Castoria, a Jewish quarter of Salonica.

One of the synagogues was used as a temporary shelter for men, women and children made homeless by the fire.

## REPORT OTHER NATIONS WILL ENFORCE REICH MARRIAGE LAWS

BERLIN, Sept. 23. (JTA) -- The law prohibiting German citizens residing abroad to marry Jews will, in addition to Holland, be enforced in Luxenbourg, Belgium, France, Rumania and Sweden, it was stated here today, because these countries are all signatories to the General International Convention on Marriages entered into at the Hague, June 12, 1902.

According to the pact, the citizens of one country are still subject to the marriage laws of that country even though they may be residing abroad.

Because of this provision considerable confusion was created las week in Holland, where a Marriage Registration Eureau had refuse to issue a lisence to a German-Jew who wanted to marry an "ary-an" woman in Holland, on the ground that the new Reich legislation enacted September 15, prohibits intermarriage between "ary-ans" and Jews.

A report issued here today states that Foland, Hungary, Italy and Danzig, will also be asked to abide by this law because of similar pacts between them and Germany.

German citizens residing in countries having no such pact with Germany, however, are not affected by the new race legislation.

# BRITISH THREATEN END OF FRIENDLY RELATIONS WITH REICH VETERANS

MANCHESTER, Sept. 23. (JTA) -- German War Veterans were notified in a letter by the British Legion that unless persecution of minorities in Germany ends the British veterans will break off their proposed friendly contacts with the German ex-soldiers, it was revealed today by Major Brunel Cohen, treasurer of the British Legion.

Addressing the Jewish war veterans here, Major Cohen declared that recent events in Germany are condemned by the British veterans.

Major Cohen last June refused to join the good-will tour of British ex-soldiers in Germany, despite the fact that he was scheduled to go as a member of the party. He declared at the time that he did not wish the German government to interpret his visit as an indication that British Jews are favorably inclined to the Hitler regime.

## FRENCH JEWISH GROUP PROFESTS TO LEAGUE ON NAZI LAWS

PARIS, Sept. 23. (JTA) -- A protest against the ghetto laws adopted by the German Reichstag a week ago was today cabled to Dr. Eduard Benes, president of the League of Nations Assembly, by the Federation of Jewish Societies here.

The Jewish League for Combatting Anti-Semitism today published an appeal for unity in Jewish ranks in the fight against Hitler's new anti-Jewish terror.

# PETITION OF DANZIG JEWS AIRED BY LEAGUE COUNCIL

GEMENYA, Sept. 23. (JTA) -- The menace to public order in Danzig as a result of the policies of the present Nazi regime of the Free City, was discussed today by the Council of the League of Nations following a report submitted by the committee of jurists on the petitions presented by the Council at its last session by Jews, Catholics and other minorities in Danzig.

Acting as rapporteur for the committee, Capt. Anthony Eden, British diplomat, made special reference to the petition of the Jewish population of Danzig.

"I think that it is especially desirable to draw the attention of the Danzig Senate to the seriousness of the situation," Capt. Eden said, pointing out the dire consequences that may result from the great activity of anti-Semitic elements of the Nazi Party in Danzig.

"Although the Danzig Senate emphasizes that not a single Jew has been killed or even seriously injured during the two years of Nazi rule in the Free City, the danger of disturbance of public order exists," Eden emphasized. "I hope, therefore, that the

President of the Danzig Senate will give the Council formal assurances concerning measures that the Senate hopes to take in this respect."

Eden also endorsed the opinion of the jurists! committee, which reported last week that the Nazis have no right to exclude Jews from public office, and that "no election results can overrule the statutes of the Danzis constitution."

The Council, after discussing the report, adopted the following resolution:

"The Council recommends that the Danzig Senate take the necessary measures to remedy the situation revealed by the petitions to the Council in conformity with the Danzig Constitution of which the League of Nations is guarantor. The Council requests the president of the Danzig Senate to submit to the High Commission at the next session of the Council a report of the action taken by the Danzig Senate in accordance with the Council's recommendations."

Speaking on the resolution, Sean Lester, the League's High Commissioner for Danzig, pointed out that the Council's decisions restore the guarantees of constitutional life in Danzig.

Concerning the general situation in Danzig, Lester states that certain members of the Danzig Senate have shown a hostility to constitutional principles. He appealed to Dr. Arthur Karl-Serieser, president of the Danzig Senate, that the constitution of the Free City be carried out "in the letter as well as in the squirt."

Fremier Laval of France and Minister Josef Beck of Poland also supported the Council's decisions and appealed to Greiser to see that they are carried out.

In reply Dr. Greiser promised that he would forward the Council; proposals to the Danzig Senate.
