WOMEN'S PEACE GROUP ASSAILS HITLER

GENEVA, Oct. 1. (JTA) -- Placing responsibility on Hitler for the treatment to which Jews are now subjected in Germany, the Executive of the Women's International League for Peace and Freedom today sent a letter to the Reich Chancellor stating that it "views this treatment with an increasing sense of horror."

"Such inhuman treatment disregarding human rights," the letter says, "definitely lowers Germany in the eyes of the civilized world."

The League has been active throughout in the fight against the suppression of minorities in Germany. On August 19, it accused all who remain silent as "accomplices of criminals fighting against civilization and humanity."

RABBI WISE DEFENDS PALESTINE-GERMAN BARTER AGREEMENT

NEW YORK, Oct. 1. (JTA) -- Rabbi Stephen S. Wise defended the Palestine-German barter agreement in an address last night before 800 persons attending a meeting in the Hotel Astor called by the Zionist Organization of America to hear reports of American delegates to the Lucerne World Zionist Congress.

The agreement, which set up an indirect method for German Jews emigrating to Palestine to withdraw their capital in the form of Reich goods, had been attacked by Joseph Kraemer, head of the Order Sons of Zion, as a violation of the anti-Nazi boycott.

Rabbi Wise declared that regardless how vigorously the boycott is pressed, the Jews cannot be permitted to "rot in Nazi Germany." The barter pact, he asserted, has allowed thousands of Jews to come to Palestine and reconstitute themselves.

Louis Lipsky, honorary president of the Z.O.A., who was chairman, pointed out that the Zionist Congress had placed full control of Haavara, Palestine office for the execution of the agreement, in the hands of the Zionist Executive with the stipulation that only goods of Jews coming from Germany would be admitted.

Rabbi Israel Goldstein, president of the American Jewish National Fund, asked support of the Histadruth, Palestine labor federation. Other speakers were Morris Margulies, secretary of the Z.O.A., and Bernard Shelvin of the Jewish Morning Journal.

METHODIST YOUTH FAVORS OLYMPIC BOYCOTT

NEW YORK, Oct, 1. (JTA) -- The ranks of the growing army protesting against holding the 1936 Olympic games in Berlin widened today with the announcement that the National Council of Methodist Youth has adopted a resolution favoring boycott of the games.

The resolution was made public in a letter to pasters of all faiths declaring that the "changing of the seat of the 1936 Olympic games would be one of the most effective means of expressing the indignation of the civilized world at the return to barbarism brought about by the present terrorist rule in Germany."

ALL JEWISH NOTARIES IN REICH LOSE POSTS

BERLIN, Oct. 1. (JTA) -- All Jewish notaries hitherto permitted to practice under an exemption of the "Aryan" clause were notified today by the Minister of Justice that they must surrender their notarial seals and records to the courts within one week, and that they may not practice "until further notice."

This order, striking at the existence of at least one thousand Jewish families in Germany, is believed to be a direct outcome of the Nuremberg laws,

The order also indicates that the Nuremberg laws cancel all exemptions for war service and other causes.

Another incident inspired by the Nuremberg laws occurred today in Weisbaden, where the gas and electric companies, following the example of those at Mainz, cut off the supply to Jewish firms.

The companies issued a statement explaining their act as a "special decision in accordance with the Nuremberg laws which permit electric and gas service to 'faryan' firms only."

"Neither the Jews nor the world need complain about the new ghetto-laws," Nazi leader Grohe told the district officials of Cologne today, "because these laws give the Jews State protection, which a Nazi State is not expected to furnish."

Mixed marriages contracted before September 17, when the new ghatto laws were promulgated, are valid, it was officially announced.

The Deutsche Nachrichten Bureau, official Nazi news service, today denied the report appearing in the London Daily Telegraph about anti-Jewish excesses in Frankfurt-am-Main.

The official service also denies that "Aryan" maids were pulled out of bed by Nazis for serving in Jewish households.

REFUSED TO EXPEL JEWS, REICH FRATERNITY IS BANNED

BERLIN, Oct. 1. (JTA) -- The Kosener Student Korps, one of the oldest and best known student fraternities in Germany, was ordered dissolved today following its announced refusal to expel its Jewish members.

The fraternity, numbering many German notables and government officials among its members, on Wednesday notified Reich Chancellor Hitler that it will not adhere to the "Aryan" principle, and that its Jowish members will not be asked to leave.

As a result of this act, Nazi Storm Troop headquarters issued an order threatening with expulsion any Storm Trooper who would not resign from the fraternity.
