DEPUTY WISLICKI DEAD; WARSAW JEWRY NOT REPRESENTED IN SEJM

WARSAW, Oct. 3. (JTA) 2- Waclav Wislicki, President of the Central Jewish Morchants Association and member of the Polish Sejm, died here suddenly today following a heart attack. He was 53 years old.

The death if Wislicki, who was the only Jew named to the Sejm in Warsaw in the last elections, leaves the Warsaw Jewish population unrepresented in the next Sejm. According to the new election laws new district elections can be held only when one-tenth of the seats in the Polish parliament remain vacant.

Wislicki, who was born in Warsaw of a half-assimilated family prominent in the commercial world, was active in Polish political circles even before he began to take a part in Jewish life. He was actively associated with the fight for Polish independence, and when Pilsudski's army entered Warsaw, Wislicki was at the head of the local militia.

Wislicki remained close to the Pilsudski faction throughout, and was a prominent member of the Non-Partisan government party. He was a member in many important Government commissions, and in 1926 was sent to Rumania to cement relations between the two countries. In recognition of his services, Wislicki was decorated by the Rumanian Government, but a year later, when the anti-Jewish pogroms broke out in Rumania, he returned his decoration and denounced the pogroms.

Although frequently opposed by the Jewish national elements in Poland because of his assimilatory tendencies, this act, and his subsequent devotion to the cause of the boycott against Nazi Germany, won him recognition as an outstanding Jewish leader. Since the war he was also active in other Jewish fields, particularly in the Jewish Merchants Association, of which he was a founder.

JEWISH DEPUTIES FORM BLOC; UNITED FRONT FAILS

WARSAW, Oct. 3. (JTA) -- Efforts to form a united front of Jewish deputies in the next Polish parliament failed here today when the Agudist representatives, Minzberg and Trockenheim, refused to join the Club of Jewish Deputies.

The remaining three Jewish members of parliament, however, did form a bloc, consisting of Deputy Rabbi Rubenstein of Wilno, Senator, Professor Schorr of Warsaw, and Deputy Sommerstein of Lwow, who was elected president.

RUMANIAN ANTI-SEMITES TO CONVENE ON YOM KIPPUR

CZERNOWITZ, Oct. 3. (JTA) -- The conference of Prof. Alexander Cuza's anti-Semitic League of Christian National Defence, which failed to take place here Saturday and Sunday as scheduled, has been postponed to Monday, Oct. 7, it was announced here today.

Originally designed to coincide with the Jewish New Year, the conference will now take place on Yom Kippur, the Jewish Day of Atonement.

Prof. Cuza, it is expected, will deliver an address on the results of the recent German Mazi pert congress in Nuremberg. This congress was the cause of a split between Prof. Cuza and Prof. Goga, Rumanian fascist leader, who recently joined forces. Prof. Goga opposed any affiliation with the German Nazi party congress.

YOUTH TO BE LASHED FOR PICKETING JEWISH SHOP SELLING GERMAN GOODS

JERUSAIEM, Oct. 5. (JTA) -- Zvi Safra, a 17-year old Jewish youth, was today sentenced to twelve lashes on the back for picketing a Jewish shop selling German goods.

In handing down the verdict, Magistrate Bodilly stated that he is imposing his sentence "because the defendant is aping those pressing the anti-Jewish boycott in Germany. He is thus harming the Jewish people by spoiling world sympathy for the sufferers in Germany."

CZECHOSLOVAKIAN MINISTER HEARS COMPLAINT ON DEPORTATION OF JEWISH REFUGEES

PRAHA, Oct. 3. (JTA) -- A complaint against the deportation of Jewish refugees from Bohemia and Moravia, was today lodged with the Minister of the Interior, Josef Cerny, by the Jewish deputies Angelo Goldstein and Murie Schmolna.

In an interview with the Jewish deputies, Interior Minister Cermy promised that the injustices would be removed, particularly as regards the discrimination treatment of Jewish allens.

The Minister of the Interior also praised the work of the Jewish Refugee Committee, Hicem and the Joint Distribution Committee, through whose combined efforts the thousands of Jewish refugees in Czechoslovakia have been reduced to but a few hundreds.

MOVEMENT IN SPAIN AGAINST BERLIN OLYMPICS

MADRID, Oct. 3. (JTA) -- A strong movement against Spanish participation in the Berlin Olympic Games in 1936 was in full swing here today under sponsorship of the Culture Federation for Workers! Sport.

In a manifesto undersigned by numerous other organizations, and by many anti-fascist intellectuals and politicians, Spanish athletes are urged to oppose participation in the forthcoming Olympic Games and to demand that the Government's grant of 400,000 Pesos for the Olympic games be used instead for the erection of gymnasiums, swimming pools and stadiums in Spain.

The German Tourist Agency here was forced to remove from its windows posters announcing the Berlin games, under threat that its show windows would be smashed.

5 GERER CHASSIDIM FINED

JERUSALEM, Oct. 3. (JTA) -- District Commissioner Campbell, in the capacity of Administrative Judge, today fined five followers of the Gerer Rebbe two pounds each, or eight days imprisonment, for defending their leader during an altercation with the police at the Cave of Machpela near Hebron, Sept. 25. The other five arrested Chassidim were released.

The clash with the police occured when an Arab policeman allegedly roughly shoved the Gerer Rebbe, soion of one of the most influential Chassidic dynasties in Poland, when the latter, unaware that a special permit is needed, attempted to enter the Cave of Machpela, tomb of the Hebrew patriachs. The Gerer Rebbe himself narrowly escaped arrest.

NO WINTER RELIEF FOR JEWS; GIRLS MUST QUIT JOBS

BERLIN, Oct. 3. (JTA) -- An internal order excluding all Jews from Winter relief, was issued here today, the Jewish Telegraphic Agency learns from most reliable sources.

The order, based on the Nuremberg laws, states that not only will no Winter relief be given to Jews henceforth, but contributions will not be solicited from Jews for relief funds.

This order nullifies the personal promise made in the past two years by Reich Chancellor Hitler that "Everybody will enjoy Winter relief in the Reich."

Owing to this order, relief will be granted in some localities directly from Nazi headquarters, while in others it will be distributed under the supervision of Jewish charitable bodies.

While Jews are excluded from relief, "non-Aryans" who are not Jewish, however, will continue to receive relief according to Hitler's declaration, it is learned.

All Jewish girls under twenty-five, serving as salesgirls, typists, bookkeepers, and in other office jobs, must quit work "for one year," according to an official order issued here today.

Under the pretext that "all girls require a year of freedom from work in order to learn household duties," the order states that even those Jewish girls who work for Jews must be replaced by "Aryans."

This order is a cruel blow to Jewish girls, who may never succeed in regaining the positions they are now forced to give up, and also to the hundreds of Jewish families who are now dependent for existence on the earnings of their children.

On the eve of his second major invasion of Berlin, Julius Streicher, Germany's leading Jew-baiter, today launched a venomous campaign against Jewish butchers and cattle-dealers.

With the powerful support of the Voelkischer Beobachter, Der Angriff and Der Schwarzekorps, the three most influential papers in the Third Reich, Streicher today demanded the closing of all Jewish butcher shops, accusing them of poisoning non-Jewish customers by selling them unsanitary meat products.

This drive is taken to indicate the government's determination to oust Jewish cattle-dealers completely, because of the fact that "Aryan" peasants have shown a tendency to purchase from Jew whose prices are lower than those of the government cooperatives.

The speech to be made tomorrow by Streicher in the Berlin Sportpalast will not be broadcast, it was announced today.

HITLER'S SEECHES, "MEIN KAMPF" BASIS OF GERMAN LAW, JURISTS TOLD

HAMBURG, Germany, Oct. 3. (JTA) -- All German law and jurisprudence must in the future be based on the racial principle according to the Nazi party, the conference of Nazi jurists was instructed here today by Chief Justice Rothenberger of the Hanseatic Supreme Court.
