BARTER PLAN URGED TO SPUR LIQUIDATION OF JEWISH PROPERTY IN REICH

BERLIN, Nov. 6. (JTA) -- Barter with Germans holding property abroad was held out today as a method whereby Jews could liquidate their holdings in this country.

In an article on the subject, the Westdeutscher Beobachter of Cologne, leading Neri organ in Western Germany, declares that the German Government would raise no objections to such a procedure.

Stating that the Government would even encourage transactions of this nature, the newspaper goes on to say that it is "reliably informed that the Government is ready in such cases not to interpret too strictly the regulations for emigrating non-Aryans and will help them as far as possible."

The paper urges that Jews who sell out their businesses in the provinces be forbidden to move to the larger German cities. The suggested prohibition is prompted by the fear that the Jews will open new shops in the cities.

The same article quotes a recent decision of the Reichs Association of German Textile Retail Dealers that Jews be not permitte, to engage in the retail textile trade because they are "politically unreliable." It also demands that "Aryans" taking over Jewish enterprises be permitted to display signs informing the public that "This Is An Aryan Firm."

PLAN PALESTINE COLONY TO HONOR REICH'S JEWISH WAR DEAD

VIENNA, Nov. 6. (JTA) -- At a meeting here today the Union of Jewish War Veterans decided to establish a colony in Palestine in commemoration of the 12,000 Jewish soldiers who died for Germary in the World War. The Union is requesting the Jewish war veterans of all countries to participate in the project.

2 POLES GET JAIL TERMS FOR ANTI-JEWISH ACTIVITIES

WARSAW, Nov. 6. (JTA) -- A summary court today sentenced Stanislaw Uniszewski and Jan Sawinski to fifty-day jail terms for hawking pamphlets urging an anti-Jewish boycott. The pamphlets had formerly been confiscated by the authorities.

J.L. GOLDBERG RESIGNS AS SECRETARY OF A.J.C.

NEW YORK, Nov. 6. (JTA) -- Rabbi Joshua L. Goldberg has resigned as secretary of the American Jewish Congress to devote himself to the Astoria Center of Israel, of which he is spiritual leader, and the Queens Jewish community, it was announced today.

The A.J.C. will tender Dr. Goldberg a dinner on Nov. 19 in appreciation of his services for more than a year. He will continue as member of the A.J.C. Administrative Committee and the Executive of the Committee of Jewish Delegations.

NAZI AGENTS SPREAD PROPAGANDA IN MEXICO,

MEXICO CITY, D.F. (JTA) -- By Mail - A group of Nazi agents arrived here recently and are spreading among the Mexican population propaganda against the Jews and for Hitlerism. They are conducting their activities with the aid of the Golden Shirts, Mexican anti-Semitic Fascist organization.

"Jewry and Crime" is the name of one of the pamphlets distributed by the Nazi agents in trolley cars throughout the capital and in many towns and cities of the provinces. Information contained in the pamphlet was compiled by the Nazi secret police in Germany under the direction of General Dalige.

The pamphlet charges that the Jews always contributed the largest percentage of criminals in Germany and that Nazism did away with them, but that Germany is now overrun by Jewish criminals in industry and commerce and that Jews are engaged in gambling and narcotic traffic.

One of the pamphlets, sent here from Germany and bearing the imprint of the Falkan Verlag, Leipzig, is published by the anti-Semitic league, Deutsche Fuechte Eund. Readers are asked to spread the pamphlets and invited to write to the Verlag for a free supply.

The propaganda is conducted without interference although Mexican law prohibits spreading of race hatred, particularly by foreigners.

One instrument of propaganda was checked recently when the government prohibited the film "Loyal to the Death," a UFA picture depicting the clash between Nazis and Communists during the early days of the Hitler revolution. The official explanation

of the ban is that it might have stirred clashes among the workers. The newspaper Excelsior sharply criticized the government for banning the film, accusing it of Communist sympathies.

UFA films monopolized Mexican markets until recently because American companies refused to pay the high tariffs imposed on American pictures. This situation, however, has been straightened out.

ANTI-JEWISH BIAS, DISORDERS AIRED IN POLISH SENATE

WARSAW, Nov. 6. (JTA) -- The question of economic discrimination against the Jews of Foland and the increase of anti-Semitic disturbances in recent weeks was the subject of considerable discussion on the floor of the Senate yesterday.

A vigorous demand for equality of treatment for Poland's Jews was voiced by Senator Rabbi Schorr in the course of a plenary session. Equal distribution of State credits and especially the right of Jewish youth to work was saked by Senator Schorr.

Senetor Schorr charged that the authorities were laggard in taking precautions against anti-Jewish disorders which, he said, were threatening Jewish life directly.

Describing the economic ruin of the Polish Jews, the Senator declared that they were still loyal and prepared to endure great sacrifices in the interests of building up the State. He concluded with an appeal for government intervention to see to it that "political battles are not fought on Jewish backs."

Col. Petrazycki took issue with Senator Schorr, contending that the continuous charges by Jews of discrimination were damaging their own cause. He said the Jews are quite privileged, citing in support of this contention their numbers in the institutions of higher learning. Col. Petrazycki also cited in this connection the development of the Jewish credit associations, which were organized with the aid of the American Jewish Joint Distribution Committee.

Senator Trockenheim, calling attention to a projected morator. In on the debts of government officials, declared that such a plan would work considerable hardship on the already hard-pressed Jewish traders of small means. The senator made an appeal for the annulment of tax debts of long standing.

HITLER PROMISES FAIR PLAY FOR JEWS IN OLYMPICS

NEW YORK, Nov. 6. (JTA) -- Reichsfuehrer Hitler today gave Count Henri de Baillet-Latour, president of the International Olympic Committee, his personal assurance that nothing would be done to hurt the susceptibilities of persons of religious beliefs or races other than the German in the forthcoming Olympics, the Associated Press recorded from Berlin.

The count said "Jews not wanted" signs would be removed from Gaymisch-Partenkirchen, where the Winter Olympic sports are to be held.

After a half-hour talk with Hitler, the Olympic chief said he was completely satisfied on the points which had aroused controversy in the United States and to a lesser degree in South Africa, according to the A.P.

"The international committee has neither right nor reason to object to the games being held in Berlin," he said. "If any national committee tries to prevent people from coming, then the international committee will take steps to remove such objections."

He added: "Jewish sportsmen have assured me that positively no distinction has been made as regards race and color."

BINGHAM NOW FAVORS U.S. PARTICIPATION IN OLYMPICS

CAMBRIDGE, Mass., Nov. 6. (JTA) -- William J. Bingham, director of athletics at Harvard University, chairman of the Field and Track Committee of American Olympic team and member of the American Olympic Committee, was on record today favoring United States participation in the Berlin games with a signed article in the Harvard Crimson, student daily newspaper.

Mr. Bingham in a previous interview said he would oppose American perticipation if discrimination against Jewish athletes were shown. In the article he insists that Germany will keep her promises in regard to the games and declares that German Jews are being given an opportunity to train for the German Olympic team.

JEWISH FIRMS ORDERED TO AID NAZI RELIEF DRIVE

EERLIN, Nov. 6. (JTA) -- Jewish business firms were today ordered to contribute to the Nazi Winter relief campaign despite the fact they are excluded from enjoying its benefits.

An official order seen by a Jewish Telegraphic Agency correspondent states that while Jews as individuals are free to contribute to Jewish relief funds, this is not the case with firms controlled by Jews "since they enjoy the benefit of being patronized by Arvans."

The order is expected to affect seriously the special Jewish driv. for Winter relief, which has until now been accorded a sympathete reception by individual Jews as well as among Jewish firms.

Meanwhile, a quota of 1,000,000 marks was set at the Berlin headquarters of the Jewish relief drive. Jewish leaders expect, judging from contributions hitherto received, that the goal will be reached if no unexpected obstacles are placed in the way of the campaign.

Emulating tactics employed in the general relief campaign, relief headquarters declared this Sunday a one-dish-day with the expectation that money saved on meals would be donated to the relief fund.

DISMISSED, 3 JEWS WIN SALARY SETTLEMENTS IN REICH COURT

FRANKFURT-AM-MAIN, Nov. 6. (JTA) -- An "Aryan" business man who testified that he had been forced to discharge three Jewish employes was today ordered by a local court to pay them each three months! salary in lieu of notice.

The merchant declared in court that he had discharged the three Jews only after pressure had been brought against him by the Nazi press. He testified that he had been absolutely satisfied with the work of the three men but when Nazi newspapers began to refuse his advertisements, he was oblined to dismiss them.

The incident is the second within a week in which discharged Jewish employes have been awarded salary settlements. Last Thursday a local court ordered the "Aryan" purchaser of a Jewish-owned firm to pay three months' salary to a Jewish employe discharged by him when he bought the business.

TO MARK 2,100TH CHANUKAH ANNIVERSARY

NEW YORK, Nov. 6. (JTA) -- The Jewish Education Association will celebrate the 2,100th anniversary of the Chanukah Festival with a dinner at the Hotel Astor Dec. 22, it was decided at a meeting tenight of the society's beard of directors. A resolution adopted by the beard calls attention to the "millenial anniversary" and urges Jews throughout the world to observe the festival which commemorates the victory in 165 B.C. of Judas Maccabeus over the Syrian Emperor Antiochus IV.

DER ANGRIFF ASSAILS FRANKFURTER ZEITUNG

BERLIN, Nov. 6. (JTA) -- A violent attack on the Frankfurter Zeitung, one of the less Nazified German newspapers, was printed today in Propaganda Minister Goebbels' paper, Der Angriff, for an article in the Zeitung Sunday demanding clarification of the Jews! status in commerce.

The Angriff insinuates that the Frankfurt paper is conducted by people of Jowish descent. That is why "it raised the cry for its brethren," the Angriff states.

The Zeitung had maintained that the present policy of terrorizing Jews by individual action into selling their property and keeping them in a constant state of uncertainty is harming the German economic structure.

LARGE BERLIN CLOTHING FIRM SOLD TO "ARYANS"

BERLIN, Nov. 6. (JTA) -- Max Davidson Company of Berlin, large clothing manufacturing firm, was today added to the list of Jewish firms being transferred to "Aryan" hands. The transaction will be completed Nov. 15, at which time a large number of Jews included among the 400 employes will be dismissed.

The amount involved in the transaction was not disclosed, but it was believed that only a fraction of the firm's worth would be paid.

HITLER GUARDS! PAPER ATTACKS AMERICAN PRESS

BERLIN, Nov. 6. (JTA) -- The Schwarze Korps, organ of Hitler's black-uniformed elite guards, today published a vitriclic attack upon the American press, declaring that "only the Hearst press dares print the truth about Germany."

The 'paper also sharply attacked Mayor LaGuardia of New York, calling him "an Italian Jew."

TO BLACKLIST FIRMS USING JEWISH AGENTS ABROAD

EERLIN, Nov. 6. (JTA) -- Names of German firms represented abroad by Jewish agents will be blacklisted in the Dautsche Wochenschau, official Nazi Party weekly, the paper warned today, publishing for the first time the names of concerns employing Jews as foreign agents.
