#### REPORT WHITE RUSSIANS TERRORIZING HARBIN JEWS

HARBIN, Nov. 17. (JTA) -- A reign of terror against Jews being conducted by White Russian groups is being fammed by publication in two White Russian papers, the Harbinskoye Vremya and the Nash Put, of featured articles accusing the Jewish people of various crimes.

The Nash Put features on its front page a telegram from Afghanistan purporting to reveal that Jews killed a Muslim child for ritual purposes.

Jews are attacked daily on the streets, but no one dares complain for fear of imprisonment by the gendarmerie in cellars, where they are reported kept indefinitely and tortured. The attacks are conducted without interference by the police.

### PAMPHLET CITES EXAMPLES OF NAZI CURBS ON ATHIETES

NEW YORK, Nov. 17. (JTA) -- A sixty-four page illustrated pamphlet, citing forty-three specific and typical examples of Nazi restrictions on Jewish athletes was issued here today by the Committee on Fair Play in Sports, non-sectarian group of which George Gordon Battle and Dr. Henry Smith Leiper are the co-chairman.

The pamphlet has been sent to the Amateur Athletic Union with an accompanying letter stating that the evidence cited offers sufficient cause for the withdrawal of the American team from participation in the Olympic Games if held in Nazi Germany. The committee requests that the record cited be presented at the December convention of the Union. Copies of the pamphlet have also been sent to the American Olympic Committee and the International Olympic Committee.

JERUSALEM, Nov. 17. (JTA) -- A proposal that all official city

#### LAWYERS TO STUDY NAZI LAWS AT WORLD PARLEY IN PARIS

PARIS, Nov. 15. (JTA) -- An international conference of lawyers to examine the Nazi conception of law and the legal position of the German Jews will open on November 30, it was announced.

### REICH POST OFFICES ORDERED TO DISPLAY DER STUERMER

EERLIN, Nov. 17. (JTA) -- The Reich Minister of Posts has ordered that Der Stuermer, Julius Streicher's anti-Semitic weekly, be displayed on bulletin boards in all post-offices throughout Germany.

# MONEY RETURNED TO PALESTINE BANKS

JERUSALEM, Nov. 17. (JTA) -- Approximately one-third of the \$1,750,000,000 withdrawn from Palestine banks during the recent financial panic resulting from the Italo-Ethiopian war situation has been redeposited, it was disclosed today. Fears that the war might involve Britain and spread to Falestine have abated.

#### REICH JEWISH WEEKLY RESUMES PUBLICATION

BERLIN, Nov. 17. (JTA) -- The Israelitische Wochenblatt, Jewish periodical, reappeared today after having been suspended by the authorities for three months.

### DANZIG COURT REVERSES APRIL ELECTION RESULTS

DANZIG, Nov. 17. (JTA) -- The Danzig Supreme Court, hearing complaints in connection with the April 7 Senate elections, ruled illegal the reprisals by the Nazis against opposition candidates and annulled ten per cent of the Nazi votes in the suburbs and three per cent of the votes in the city proper. As a result, two Nazi mandates were handed over to the Socialists and the Centrist

The Senate now includes 41 Nazis and 39 opposition members.

#### POLISH ZIONISTS HIT CURBS ON TOURISTS TO PALESTINE

WARSAW, Nov. 17. (JTA) -- The Polish Zionist Organization has cabled the World Zionist Executive at Jerusalem complaining of difficulties imposed upon would-be Palestine tourists by the British consulate.

According to the letters, the consul demands in addition to the deposit of 1,800 zlotys (about \$360) that the tourists sign a statement pledging they will not remain in Palestine longer than three months and that they will not apply for an extension of vieas or for a permit to remain in Palestine permanently.

#### DR. WEIZMANN IN PALESTINE

JERUSALEM, Nov. 17. (JTA) -- Dr. Chaim Weizmann, president of the World Zionist Organization, arrived here Friday for a visit of several months in Palestine. Met by members of the Palestine branch of the Zionist Executive, he left shortly thereafter for the colony of Rehoboth where he inspected the Sieff Institute, agricultural experimental station of which Dr. Weizmann, a noted chemist, is a director.

### HITLER YOUTH ORDERED TO STUDY RACIAL LAWS

BERLIN, Nov. 17. (JTA) -- Members of the Hitler Youth Organization must attend courses devoted to racial subjects, including the Nuremberg marriage and citizenship laws, it was officially announced here.

The announcement stated that leaders of the organization must qualify in special examinations and gain a diploma in racial science "in order to be able to speak on all questions of Nazi racial policy."

#### DER ANGRIFF DESCRIBES JEWS ON RELIEF JOBS

BERLIN, Nov. 17. (JTA) -- Apparently with the purpose of counteracting protests by the British and American press against the growing maltreatment of Jews, Der Angriff, leading Nazi organ and personal property of Propaganda Minister Paul Joseph Goebbels publishes a long article describing how Jewish recipients of relief are being included among the labor conscripts who are engaged in constructing sports grounds in the vicinity of Berlin.

Der Angriff declares that there are 420 conscript laborers engaged in this project and that 280 of these are Jews.

The majority of these 280, Der Angriff points out, are intelligent and were once wealthy.

The article describes them at work as follows:

"You can see among them one working in evening clothes, others still wear white shirts, some still wear tophats and some work with gloves covering their soft hands."

The paper admits that all of the Jews work diligently with pick and shovel.

While working and during rest periods, the article states, the Jews are kept apart from the "Aryans."

# JERUSALEM POLICE CURB PROTESTS ON NUREMBERG LAWS

JERUSALEM, Nov. 17. (JTA) -- All synagogues in this city were closed for part of the day yesterday in protest against the Nuremberg laws, regulations for the enforcement of which were promulgated in Berlin yesterday.

Protest meetings scheduled for various parts of the city were forbidden by the police on the grounds that sponsors of the meetings had failed to comply with police regulations. However, speakers in several of the city's theatres were permitted to deliver anti-Nazi lectures.

### PALESTINE SETS HIGH JAIL TERMS FOR ILLEGAL ARMING

JERUSALEM, Nov. 17. (JTA) -- The Palestine Government issued an order yesterday increasing from three to seven years imprisonment the punishment for possession of arms without a permit.

# 3 CALL HUNGER STRIKE OFF

JERUSALEM, Nov. 17. (JTA) -- Three Jews held in jail here as illegal immigrants yesterday abandoned their hunger strike, which was in its seventh day, and expressed the hope that the Jewish Community would provide bail for their release.

### HOLLAND'S QUEEN HONORS 2 JEWISH LEADERS

AMSTERDAM, Nov. 17. (JTA) -- Queen Wilhelmina yesterday conferred the order of the Knight of the Dutch Lion upon A. Ascher, president of the Ashkenazic Jewish Community which is celebrating its tercentenary, and the order of Orange and Massau upon A. S. Veder, president of the Community's executive board.

## MOSCICKI RECEIVES LEIB JAFFE IN WARSAW

WARSAW, Nov. 17. (JTA) -- President Ignace Moscicki yesterday received Leib Jaffe of Jerusalem, a director of the Falestine Foundation Fund (Keren Hayesod), in an audience that lasted three quant ers of an hour. Mr. Jaffe is here in connection with the Keren Hayesod campaign, which was opened with a mass meeting at Philharmonta Hall Friday.

# NUREMBERG LAWS NOT TO BE APPLIED IN UFFER SILESIA

BRESLAU, Germany, Nov. 17. (JTA) -- In view of the Polish-Ger convention on the rights of minorities, the Nuremberg anti-Jewi. laws are definitely not applicable in Upper Silesia, the press announced today.

The Upper Silesian branch of the German Lbor Front issued an official statement declaring that "Aryan" women employed by Jewish families in Upper Silesia do not have to give up their jobs.

## TO TRAIN JOBLESS JEWS TO REPLACE "ARYAN" MAIDS

BRESIAU, Germany, Nov. 17. (JTA) -- The Jewish Community of this city today announced it would start a course for unemployed Jews to train them for jobs vacated by "Aryan" maids in Jewish homes as a result of the Nuremberg laws.

## REICH ARMY COOKS (OVER 45) QUIT TO WORK FOR JEWS

BERLIN, Nov. 17. (JTA) -- Units of the Reichswehr which are stationed in the larger cities of Germany have been given cause to grumble as a result of that section of the Nuremberg laws which forbids employment of "Aryan" women over 45 in Jewish homes.

According to today's Frankfurter Zeitung, women army cooks over that age have begun to quit their jobs to seek more lucrative employment in the Jewish homes of cities where the Reichswehr is bivouacked.

#### NAZI PRESS PREDICTS FURTHER REGULATIONS FOR JEWS

BERLIN, Nov. 17. (JTA) -- Every important Nazi newspaper, including the Voelkischer Beobachter, Hitler's personal property and chief organ of the Nazi party, emphasized today that the regulatory decress implementing the Nuremberg laws are only part of the regulations which will ultimately define the status of Jews in commerce, medicine, derkstry and law.

Meanwhile, the regulations which were to have clarified the Jewish position, in at least two fields have produced nothing but confusion. The confusion is chiefly the result of the regulations classifying "non-Aryans" with Jews. Many "non-Aryan" maid servants, since they are classified as Jews, do not know whether they may remain in Jewish employ.

The marriage clauses also have produced confusion.

"Half-Aryans", for example, are completely at a loss on the subject of marriage, since under the present regulations it appears they can marry neither Jews nor non-Jews.

A Federal Court here today reversed the decision of a lower court by which an actress was granted a divorce on the grounds that, after having been married to him for twenty years she suddenly discovered he was a Jew. The Federal Court ruled that she could not possibly have been ignorant of his Jewishness.

# APPEAL FOR HAYESOD DRIVE MADE IN REICH SYNAGOGUES

BERLIN, Nov. 17. (JTA) -- An appeal for support of the Keren Hayosod (Palestine Foundation Fund) campaign was read in many synagogues throughout the Reich today.

The appeal, issued by the German Zionist Federation, was approved by Rabbi Leo Back on behalf of the Reichsvertretung, representative Jewish organization in Germany. The campaign was officially launched today.

## JEWISH WOMEN IN REICH TARGET OF EXTORTION THREATS

EERLIN, Nov. 17. (JTA) -- The Jewish Women League announced today that many of its members are recoiving threatening letters in connection with the ban on employment of "Aryan" domestics. The letters demand that "Aryan" servents who must leave their jobs as a result of the Nuremberg laws be given substantial Christmas gifts and a month's pay in lieu of severance notice since it is not the fault of the girls that they cannot continue in the service of Jews. The league advises its members not to pay attention to the letters.

# GERMAN ANTHROPOLOGICAL SOCIETY BANNED BY GESTAPO

BERLIN, Nov. 17. (JTA) -- The Gestapo, Nazi secret police, today ordered that all offices of the German Anthropological Society throughout Germany be closed because the society allegedly is "inclined to maintain international relations with Jows."

The Danziger Echo, only Jewish weekly publication in the Free City of Danzig, was today forbidden to be circulated or sold anywhere in the Reich as an anti-Nazi publication. Several editors of the paper have recently been deported from Danzig for having published anti-Nazi articles.
