### CHURCH OF ENGLAND HITS NAZI TREATMENT OF JEWS

LONDON, Nov. 20. (JTA) -- Strong criticism of the German Government's anti-Jewish policy and sympathy with the Jewish people of Germany is expressed in a resolution adopted today by the Church Assembly of the Church of England.

The resolution follows:

"The Assembly desires to express its sympathy with the Jewish people and those of Jewish origin in the sufferings which are being endured by many of their number in Germany and trusts that Christian people in this and other countries will exert their influence to make it plain to the rulers of Germany that continuance of their present policy will arouse widespread indignation and prove a great obstacle to the promotion of confidence and good will between Germany and other nations."

The resolution was proposed by the Bishop of Chichester and seconded by the Bishop of Southwark.

The Archbishop of Canterbury, forced to leave the chair during the discussion of the resolution, declared before he left that, lest his absence be misinterpreted, he was in the fullest sympathy with the resolution.

Among those speaking in favor of the resolution was Lord Hugh Cecil. The resolution was opposed by Carlisle Davies, an Englishman who acts as the German Consul at Plymouth. The assembly met under the presidency of the Archbishop of York.

### ITALY PLANS ITALIAN INSTITUTE IN JERUSALEM

ROME, Nov. 20. (JTA) -- The Italian Government will shortly open in Jerusalem an Institute for Italian Culture to be directed by the Italian Jewish writer, Professor Aldo Soriani; the Jewish Telegraphic Agency was informed by Piere Parini, Director of Italian Cultural Organizations Abroad.

In addition, Mr. Parini said, the Italian Government was sending teachers to Hebrew schools in Palestine to study. Professor Gattego, an Italian teacher, was the most recent educator to leave, he said. Prof. Gattego will study in Tel Aviv.

#### ARAB MURDER TRAIL SEEN LEADING TO TERRORISTIC GROUP

JERUSALEM, Nov. 20. (JTA) -- The trail of the murderers of Police Sergeant Moshe Rosenfeld, who was shot down while tracking grape-fruit thieves, leads to an Arab terroristic organization which has its centre in Haifa, the leading Hebrew newspapers reported today.

#### TEL AVIV CAFES NOW OPEN SATURDAY NIGHTS

TEL AVIV, Palestine, Nov. 20. (JTA) -- Night life on Saturday for the residents of this all-Jewish city was made possible by the enactment in the Tel Aviv Municipal Council of a new by-law permitting restaurants and cafes to open on Saturdays from nine p.m. until three a.m. Sunday morning. Sabbath laws previously kept these establishments closed all day Saturday.

#### SCOTLAND YARD LOOMS IN PALESTINE

JERUSALEM, Nov. 20. (JTA) -- The Holy Land will shortly have a bureau like London's famous Scotland Yard as a result of the visit of Roy G.B. Spicer, Palestine Inspector General of Police and Prisons, to London, it is predicted here.

Several detectives who have been trained at Scotland Yard will be added to the Criminal Investigation Department of the Palestine Police, the paper states, and a number of changes of methods and personnel of the C.I.D. will be introduced.

#### 5 ARABS, 1 BRITISH POLICEMAN KILLED IN GILBOA HILLS CLASH

JERUSALEM, Nov. 20. (JTA) -- Five Arabs and one British policeman were killed today in a clash between police and the Arab gang which is suspected of having murdered Sergeant Moshe Rosenfeld, Jewish policeman, on November 7 while tracking thieves who had been looting grapefruit groves in the vicinity of the Jewish colony Ein Charod.

News of the clash was officially announced by the Palestine Government which stated that five of the Arab gang were placed under arrest. The clash occurred in the Gilboa Hills.

#### DENVER COUNCIL BACKS OLYMPIC BOYCOTT

DENVER, Col., Nov. 20. (JTA) -- The Denver City Council by a vote of 8 to 1 today adopted a strongly worded resolution protesting against American participation in the 1936 Berlin Olympic games.

The resolution read:

"We are aghast and we cannot without protest countenance the prospect of the sully of American athletic traditions by cooperation amid surroundings where athletes are discriminated against on the basis of race or creed.

"We feel that to participate in such an atmosphere would be a prostitution of American athletic traditions, which recognize honest athletic skill regardless of color, race religion or politics."

The resolution was introduced by Councilmen Harrington and Rosenthal.

#### PREPARE EXHIBITS FOR ROCKEFELLER MUSEUM IN PALESTINE

JERUSALEM, Nov. 20. (JTA) -- The tedious process of preparing and transferring the exhibits of the Palestine Archaeological Museum to the new building erected with a \$2,000,000 endowment from John D. Rockefeller Jr. was under way today. The building will be formally opened next Spring.

The new museum will house in the original only genuine relics unearthed in Palestine since the World War by the various archaeological expeditions. In addition, reproductions are being made of antiquities unearthed before the war and relics in the possession of other museums throughout the world.

An additional donation of an unnamed sum by Mr. Rockefeller to the museum's Department of Antiquities for a library in all languages dealing with archaeology, particularly of Palestine, was announced. John Richmond, head of the department, is preparing the library.

While the museum will confine itself almost entirely to antiquities found in Palestine, exception will be made for relics of extraordinary importance and interest found in neighboring countries.

Some of the relics being reproduced in museums throughout the world, authorities of the museum said, are: the Greek inscription on Herod's temple forbidding strangers to enter, the inscription of Meshaa, King of Moab; the inscription found in the Shiloh tunnel and the discoveries unearthed in the ancient city of Shomron.

#### QUIET RESTORED IN POLAND AFTER NEW ANTI-JEWISH RIOTS

WARSAW, Nov. 20. (JTA) -- Quiet was fully restored in all sections of Poland today following the new outbreak of anti-Jewish excesses in which two Jews lost their lives, several score were wounded and considerable property was damaged.

All Jewish members of the Polish Parliament, including Senators Rabbi Schorr and Trockenheim, and Deputies Rubinstein, Sommerstein and Minzberg, today called in a body upon Minister of the

Interior Ladislaw Raczkiewicz and presented him with evidence of the result of anti-Jewish agitation in various parts of the country.

The delegation of Parliamentarians demanded that the life and property of the Jewish population be given the fullest protection. It also pointed out to the Minister of the Interior the extent to which the anti-Semitic agitation had spread even to the country's high schools.

Minister Raczkiewicz, stating that he was acquainted with the facts in the situation, declared that he has issued "strong instructions for securing order. I shall not tolerate any anti-Jewish excesses."

The Jewish Telegraphic Agency was informed that the police today received orders for the suppression of all rioters.

Tomorrow rectors of the high schools will hold a meeting for the purpose of planning concerted measures against rioters and also to plan the reopening of the schools which were closed down when the rioting broke out anew yesterday.

The deaths occurred in Lwow and Pogon, near Sosnoweic. Samuel Rosenberg, a Jewish student at the University of Lwow, died Monday of wounds received in an attack three days ago by Endek students upon Jewish students of the school. In Pogon, Abraham Rosenblum, 14, died yesterday of wounds sustained when a bomb was thrown at the town's synagogue.

#### MISS PERKINS TO SPEAK AT REBEKAH KOHUT DINNER TONIGHT

NEW YORK, Nov. 20. (JTA) -- Secretary of Labor Perkins will be the principal speaker at the Golden Jubilee dinner in honor of Mrs. Rebekah Kohut, noted author and social worker, tomorrow evening at the Hotel Commodore, it was announced today by Fannie Hurst, chairman of the sponsors committee. At the dinner, which marks Mrs. Kohut's fifty years in social work, she will be presented with \$50,000 for distribution among various organizations and charities. Other speakers: Mrs. August Belmont, Mrs. Felix Warburg, Henry Morgenthau, Miss Anne Morgan, Mrs. Arthur Brin and Rabbi Stephen S. Wise.

#### ANTI-OLYMPIC PARADE TO BE HELD TODAY

NEW YORK, Nov. 20. (JTA) -- An anti-Olympic parade, for which permission was finally received from Police Commissioner Valentine, will be held tomorrow afternoon under the auspices of the Anti-Nazi Federation from Eighth Ave. and 45th St. to Madison Square Park, where speeches will be delivered.

NAZI LABOR FRONT OUSTING ALL MEMBERS MARRIED TO JEWS

BERLIN, Nov. 20. (JTA) -- The Nazi party's intention of forming dissolution of all marriages between Jews and "Aryans" regardless of their duration was revealed in a decision today by a Frankfurt-am-Main labor court upholding the discharge of an "Aryan" technician from a position he had held 21 years on the sole ground that his wife was Jewish.

In the course of the court hearing in the case, it was also disclosed that the first step in this campaign is expulsion from the German Labor Front, and consequently from all opportunity for employment, of all "Aryans" married to Jews.

Instructions to that effect have been issued by Robert Ley, Labor Front leader, it was revealed during the court action.

The action was brought by an "Aryan" technician, whose name is not given in the German press which reports the case, a wounded war veteran who had been decorated for heroism. He testified that he had been married to the Jewess twenty-one years. The representative of the firm which had discharged him testified that the firm had no complaint against the veteran and wouldn't have disclosed him except upon the Labor Front's insistence.

The court thereupon inquired of Herr Ley whether "Aryans" married to Jews long before the Nazi regime are liable to expulsion from the Labor Front. Upon Ley's answer in the affirmative, the court ruled that it could not challenge the dismissal.

Addressing a meeting at Hanover last night, Ley declared that the Nuremberg laws would have been unnecessary if the Nazi Government had been certain that the entire nation was supporting its anti-Jewish policy.

"Our generation could have spared itself the Nuremberg laws with all its complications," he stated. "The Nazi party had other ways and means of protecting German blood. There was the danger, however, that because of a century of Jewish emancipation there wasn't enough resisting power among the people. We had to introduce measures which will affect our generation for a long time. The Nuremberg laws are nothing but training for us to keep our generation alive and not forgetting that it belongs to the German nation."

All Nazis today were ordered to consider the large Wertheim's Department Store in Berlin as purely Jewish and therefore to be boycotted by all loyal party members. The order was issued by party headquarters apparently to prevent Jews from sharing in the Christmas holiday trade.

Other developments affecting the Jewish position in Germany were:

The Reich Department for "Non-Aryan" Culture yesterday prohibited a scheduled performance of J. L. Peretz's "Night on the Old Market Place." The play, a symbolical, impressionistic drama which de-

picts the tragedy of Jewish life, was to have been produced by the Jewish Kulturbund, organization formed under the direction of the Department for "Non-Aryan" Culture, and whose activities are restricted exclusively to participation by Jews. No reason for the ban on the play was given. The play was written about twenty-five years ago.

Because it was discovered that his wife, to whom he has been married twenty-five years, is of "non-Aryan" origin, a war veteran who is himself 100 per cent "Aryan" has been dismissed from his civil service post by the municipal government of Breslau, it was reported in the local press yesterday.

When the case was brought to court, the judge ruled that the dismissal was justified under the Nuremberg laws, "despite the fact that it is naturally very painful for the dismissal official who was married long before the social question was ever taken into consideration."

Speaking at a meeting in Altenberg yesterday as a representative of the Reich Nazi Medical Association, Dr. A. Stercke, leader of the Munich Nazi brigade, declared that it is Germany's ambition to become the vanguard of a world fight against Jews.

Dr. Stercke is quoted as follows in the German press:

"Our hatred of Jews is not directed against the individual Jew but against Jewry as a whole. We hate Jews not because we derive pleasure from hating but because we love Germany and the entire world. It is a case of 'to be or not to be' for either us or the Jews."

The Federation of German Booksellers has issued notification to Jewish book dealers that they must either close or sell their shops immediately.

#### CORRECTION

In the J.T.A. report of Nov. 8, it was erroneously reported from Berlin that Propaganda Minister Paul Joseph Goebbels had written a preface to a 416-page volume, "The Jews in Germany," published with the sanction of the Nazi party, which is full of anti-Jewish libels. Dr. Goebbels is represented in the book only with a quotation on the fly-leaf taken from a speech made at the Nazi Party Day in Nuremberg in 1933. The quotation reads: "It is not true that we consider the Jew to be the only one to blame for the German spiritual and economic catastrophe. We know all the other causes which led to the downfall of our people. But we have also the courage to recognize his role in this process, and to call a spade a spade."
