SCHACHT HAS NO INFLUENCE WITH HITLER, SAYS BEOBACHTER

BERLIN, Nov. 24. (JTA) -- The Voelkischer Beobachter, principal mouthpiece of the Nazi Party and personal property of Reich Chancellor Adolf Hitler, yesterday bluntly stated that Reich Minister of Economics Dr. Hjalmar Schacht has no influence with Hitler and that Jews will definitely be eliminated from the nation's commerce.

Almost in the same breath, however, the Beobachter indicated that there will be no swift and drastic process of liquidation of Jews from the Reich's commercial life.

The liquidation, it declared, will proceed in an "evolutionary" way.

"We must leave the question of breaking down Jewish influence in commerce to the will of Der Fuehrer who will determine the tempo," the paper advises. "It is ridiculous to assert that anyone else's personal opinion on the Jewish question is influencing Nazi policy along with Der Fuehrer's will."

The Beobachter goes on to warn that "the large influence of the Jews cannot be broken today or tomorrow because this will lead to serious consequences for Nazism."

In business circles today the Beobachter's statement brought forth the comment that despite what the publication said, it was quite apparent that Dr. Schacht's influence with Hitler was far greater than Nazi officials of the more radical wing were willing to admit. This viewpoint was supported, it was stated in these circles, by the Beobachter's own disclosures that the liquidation will be "evolutionary" rather than abrupt. They emphasized the fact that Dr. Schacht has all along been pleading

against a sudden elimination of Jews from commerce, frequently warning that any such attempt would seriously upset the entire German economic system and plunge the nation into serious difficulties.

It was pointed out in this connection that Dr. Schacht's order eliminating Jewish brokers from membership in the Boerse was a sop to the radical elements in the party and Hitler cabinet which meant little or nothing since only thirteen (the figure is Der Angriff's) Jews are affected by it.

"Complete elimination of Jewish lawyers is the demand of the Nazi movement," Reich Minister without Portfolio Dr. Frank stated at a conference of leaders of the Nazi Lawyers' Association, according to the Nazionale Sozialistischer Partei Korrespondenz, official Nazi organ.

The publication quotes Dr. Frank as declaring that Jewish lawyers have converted German law into a business and that therefore "they as well as other unworthy elements must be eliminated."

Dr. Frank concluded by pointing out that elimination of the Jewish lawyers will give Nazi attorneys the opportunity to earn a better living.

DR. MAX NAUMANN ARRESTED BY GESTAPO

BERLIN, Nov. 24. (JTA) -- Dr. Max Naumann, president of the Union of Nationalist Jewish Germans, was yesterday arrested by the Gestapo, Nazi secret police. The Union, comprising the so-called "Jewish Nazis," was officially ordered disbanded yesterday.

REICH JEWS MAY MARRY DUTCH SUBJECTS IN HOLLAND

AMSTERDAM, The Netherlands, Nov. 24. (JTA) -- A German Jew wishing to marry a Dutch subject in Holland may legally do so, it was declared yesterday by Minister of Justice Dr. Van Schaik in the course of a discussion of the budget in the Second Chamber.

Dr. Van Schaik pointed out, however, that the legal position is still unclear in the case of a German woman "Aryan" who wishes to marry a Dutch Jew. This question, he said, will be decided by the Dutch courts soon.

The entire issue has been brought into the limelight here by the Nuremberg laws dealing with intermarriage of Jews and "Aryans." Shortly after their promulgation on Sept. 15, the Marriage Registration Bureau in Amsterdam refused to grant a marriage license to a German Jew and a Dutch woman on the ground that Holland, by an international convention of 1902 to which it was a signatory together with Germany, was obliged to observe the Nuremberg intermarriage laws. The Marriage Bureau later reversed its decision in the case cited above since the application for the license had been issued before the laws were passed.

NAZIS PUBLISH BLACKLIST OF JEWISH COMPOSERS

BERLIN, Nov. 24. (JTA) -- A blacklist of Jewish composers and musicians dating back to 1780 has been issued here under the title "Jewish Musical ABC." The pamphlet aims, according to the German press reports of it, "to help combat the Jewish cultural bolshevism of German music."

J.H. THOMAS NEW COLONIAL SECRETARY

LONDON, Nov. 24. (JTA) -- Zionists today were eagerly awaiting an official statement from J. H. Thomas, new Secretary for the Colonies, which would indicate his policy in the administration of Palestine.

Secretary Thomas was demoted from the post of Secretary for the Dominions, which position is now occupied by Malcolm MacDonald who had been appointed to the Colonial Secretaryship last June.

WAUCHOPE HALTS LAND TRANSFER TO JEWS

JERUSALEM, Nov. 24. (JTA) -- Although a court decision has awarded the land in the Kuskus Taboun area, possession of which is disputed by Arabs, to Jewish interests, the Government has stopped execution of the award, it was disclosed in a letter by High Commissioner Wauchope published in El Islamia, the Mufti's newspaper.

The High Commissioner's office confirmed to the Jewish Telegraphic Agency the report that Sir Arthur had been influenced in his action by the Meshek Company, legal owners of the land, not to press turning over of the land.

WARSAW POLICE FORBID RALLY TO PROTEST ENDEK RIOTS ✓

WARSAW, Nov. 24. (JTA) -- A meeting of the Jewish Workers Party to protest anti-Semitic agitation and excesses, scheduled to be held here yesterday, was called off at the eleventh hour by police. The action, according to the police, was in the interests of preserving public order.

An official complaint lodged by officials of the schools, which have been closed as a result of the anti-Semitic rioting, against students participating in the disturbances was referred by the police to a summary court.

A house-to-house search for student members of the anti-Semitic National Democratic Party (Endeks) continued today, resulting in many arrests on charges of participating in the attacks on Jewish students.

A conference between Rector Warchalowski of the Politechnic Institute and the president of the student body, failed to

accomplish the desired results when the latter insisted that the students would not pledge peace until their ultimatum of Friday is met. The ultimatum demanded a numerus clausus for Jewish students, subsidies for them to be based on the proportion of the Jewish population and separate seats and laboratories in the universities.

An appeal to the university authorities to adopt the most energetic measures to stop the students from rioting was voiced in the Gazeta Polska, semi-official Government organ, in an editorial captioned "Jungle."

The editorial, describing the fighting methods of the Endek youths as barbarous, states that they do not reflect credit on the Polish spirit.

The Gazeta caustically refers to the so-called national heroes who during the student riots before the universities were closed attacked unarmed individual in hordes, using knives, iron rods, razor blades attached to sticks and forced the captured Jewish students to run a gauntlet of armed tormentors, after which they were beaten to a pulp.

According to the Gazeta ^{Polska} one Jewish student in Lwow was thrown from the second story of a school building.

All schools and colleges in Warsaw closed as a result of anti-Semitic riots will continue closed indefinitely it was announced Friday following a conference of school officials and a representative of the Ministry of Education.

The Ministry's delegate to the conference declared that in the event of a recurrence of the riots when the schools are reopened finally, the Government will order a new enrollment as it did in 1933.

In the Government press it was pointed out that the riots in the schools were caused by the Endek agitation and had resulted in the enforced idleness of 20,000 students, hundreds of whom have been placed in the most difficult position since their subsidies have been stopped.

The entrances to all the schools where riots had occurred are being guarded by police.

An emergency court sentenced three Endek rioters to seven days each imprisonment and two to three days.

ENDEK CLUB EXECUTIVE ARRESTED IN LODZ

LODZ, Poland, Nov. 24. (JTA) -- Ten members of the executive board of the Endek Club, headquarters of the anti-Semitic National Democratic Party here, were under arrest today following the discovery of tear gas bombs and dynamite on the premises. The club's doors were sealed by the police.
