GERMAN JEWS TOLD THEY MUST GIVE PROPERTY TO STATE BECAUSE THEY GET PROTECTION

BERLIN, Jan. 30. (JEA) -- The Jews were informed today that because they receive protection they have "the obligation to place their possessions in the hands of the state when necessary."

This statement was made by Dr. Wilhelm Stuckart, State Secretary in the Ministry of Interior, writing in the special third anniversary issue of Hitler's Voelkischer Beobachter, chief organ of the Nazi Party.

Defining the obligations of the Jews to the Nazi state, Dr. Stuckart declared that they are obligated because of the protection they receive and because they are "allowed to participate in economic life within the framework of the existing laws."

He concluded with the statement that the "Nuremberg laws are the realization of the demand, "Germany for the Germans," and they will be considered the national basis of the German nation,"

Manumhile, Jowish schools joined today in observing the third anniversary of Hitler's accession to the chancellorship. Although Jowish schools are prohibited by law from displaying the German flag, the teachers told their classes that Nazism has united the German nation and the Jowish religion will unite all Jows.

REICH ZIONIST DECLARES SITUATION OF FOLISH JEWS WILL OVERSHADOW GERMAN

HERLIN, Jan. 30. (JTA) -- Dr. Franz Meyer, German Zionist leader, said today that the situation of the Jews in Poland will soon overshadow the Jewish situation in Germany.

His statement was made at a press conference held in connection with the first all-German Zionist conference since Hitler's accession to power, opening this Sunday.

Dr. Meyer disclosed that the World Zionist Executive in London had been active in preparing the plans for the visit to the United States of Sir Herbert Samuel, member of a delegation of three British Jews.

He emphasized that if Sir Herbert's plan for expatriating German Jews is successful, the cooperation of non-Zionist groups is guaranteed. The Zionist leader expressed the hope that Sir Herbert would return from America with a definite plan.

5 OFFICERS OF ANTI-NAZI GROUP TO BE TRIED; 10 YOUTHS JAILED FOR DEMONSTRATING BEFORE REICH CONSULATE

WARSAW, Jan. 30. (JTA) -- Authorities today set triels for three officers of an anti-Hitler committee, dissolved an anti-Nazi group in a different city and jailed youths for demonstrating before a German consulate in what appeared to be the beginning of a drive against anti-Nazi groups.

Ten Jewish youths were given jail sentences of seven days each for demonstrating outside the Reights consulate here. Meanwhile, the police dissolved the Anti-Hitler Committee of Jewish Youth of Warsaw.

In Lwow, three officers of the Anti-Hitler Committee, arrested after having been searched yesterday, will go on trial. They are Mr. Kruman, president; Mr. Hobel, secretary and Mr. Epstein, member of the executive board of the committee. Their documents have been confiscated by the police.

DISORDERS RESULT FROM ATTEMPT TO SEGREGATE JEWISH STUDENTS

WARSAW, Jan. 30. (FPA) -- Disorders occurred today in two cities as a result of attempts to segregate Jewish students into separate benches in classrooms.

In Warsaw, near-riots took place in the Agricultural High School and at the Veterinary College when efforts were made to impose a "Jim Crow" rule on Jewish students. The drive began to spread from the colleges to the secondary schools.

Jewish youths were beaten up at the Lodz Aryisan School after they had refused to sit in separate benches.

NEW YORK COUNCIL BACKS UNITED PALESTINE APPEAL

NEW YORK, Jan. 30. (JTA) -- Resolutions endorsing the United Palestine Appeal's \$2,500,000 campaign and backing convocation of a world Jewish congress have been adopted by the Council of Jewish Organization.

REPORT WAUCHOPE"SORRY" CCUIDN'T GET FULFILLMENT OF ARAB DEMANDS

NUSATEM, Jan. SO. (JTA) -- Al Liwaa, Arab daily, reported today that High Commissioner Sir Arthur Grenfell Wauchope expressed himself as "sorry" he could not obtain from the Colonial Office the fulfillment of Arab demands.

He was quoted as having told a delegation of Arab leaders, who called to protest that the Colonial Office had not met demands for stopping Jewish immagration:

"Sorry, this is all I could get from the Colonial Office after great efforts."

The Colonial Office reply to the Arab memorandum rejected the demand for helting Jewish immigration, said the demand for democracy was answered by the announcement of a legislative council and met demands for restriction on sale of Arab lends by stating that the Government was preparing curbs,

Full accord on all Arab political policies has been reached between the Grand Mufti of Jerusalem and former Mayor Ragheb Bey Nashashlbi, it is reported in the Arab newspapers. Two of outstanding Arab leaders, they have long held divergent views on many vital issues.

IRON GUARDS RESIST DISSOLUTION IN RUMANIA

BUCHAREST, Jan. 50. (JTA) -- Police in various parts of the country continued to make scores of arrests today as the anti-Semitte Iron quartists defied the order of the Government dissolving uniformed political troops.

The guards remained adament in their refusal to surrender their arms, In Jassy, members of the organization stormed the courthouse in an attempt to secure the release of prisoners taken by the police.

After having been repulsed, they ranged through the town, smashing windows of Jewish-owned shops.

REPORT BRITISH LABOR GROUPS ASKING BOYCOTT OF GERMAN NATIONALS

LONDON, Jan. 50. (JTA) -- Organization of a labor boycott against German nationals in England in protest against the Nazi regime was reported today by the Daily Herald.

The newspaper stated that twenty-four trades councils and a large number of local units of the labor Party adopted a resolution calling on Fritish citizens not to have dealings with German nationals and to refuse to purchase German goods until civil and religious liberties were restored in the Raich.

MORDECAT ELIASH, STABBED WHILE WALKING, SAYS ASSAILANTS WERE JEWS

JENUSALEM, Jan. 50, (JTA) -- Dr. Mordecai Eliash, noted Jewish attorney, who was stabbed in the throat and abdomen while walking in the center of the city yesterday, said today at Hadassah Hospital that his assailants were Jews. It appeared that there were no political motives behind the stabbing.

Improvement was noted today in the condition of Dr. Eliash. His condition was earlier reported as serious but hopes were held out for his recovery.

At Hadassah Hospital, where Dr. Eliash is confined, it was said that the dagger with which he was stabbed barely missed his lung, It was established today that the assault was carried out by two unidentified persons dressed in European-style clothing.

The attorney was a witness before the Shaw Commission sent by the British Government in December, 1929, to investigate Arab riots against the Jews. Later, he appeared as counsel for the Jews before a League of Nations commission arbitrating a dispute with the Arabs over respective rights at the Wailing Wall.

7 EXPELLED FROM LMCW INSTITUTE FOR PROTESTING RIOTS

LWCW, Foland, Jan. 30. (JTA) -- Seven members of the Jewish students' board at the Lwcw Polytechnic Institute were expelled today for signing a protest against recent enti-Jewish riots.

Meanwhile, following arrest of three officers of the Anti-Hitler Committee, police today carried out an extensive search of the homes of many persons known to be active in the anti-Nazi movement. No action resulted from the search.

ORDER RESTORED IN SYRIA AFTER 6 MORE DEATHS

BEIRUT, Jan. 30. (JTA) -- Order was restored throughout Syria today after netionalist demonstrations had resulted in the loss of six lives, four in Damascus and two in Aleppo. The principal bazaars in Damascus remained closed.

Anton Sasd, president of the Syrian Nationalist Party, was sentenced yesterday at Damasous to serve six months in jail as a result of his anti-French activities. Rioting by nationalists in the last few days has caused many deaths.

R.D. BLUMENFELD ILL IN LONDON

LONDON, Jan. 50. (JTA) -- Ralph D. Elumenfeld, noted British journalist, has been ill for several days, it was disclosed today. He was reported resting easier but his recovery is expected to take several days.

ME JEW ELECTED IN GREEK VOTE, ANOTHER POSSIBLY NAMED

SALONICA, Jan. 30. (JTA) -- T. Chenio, a Populist, was elected to Parliament in last Sunday's voting. Aaron Sciaky, a Venizelist, has good chances of being named, but the counting of ballots has not yet been completed.

2 REPORTED DEAD IN PALESTINE LABOR ACCIDENTS

TERUSALEM, Jan. 30. (JFA) -- Two deaths resulting from labor accidents have been reported here. Mendel Nagler, 25, German-Jewish refugee who arrived from Germany a month ago, died as a result of injuries received while at work in a quarry near the colony Rishon-le-Zion in the vicinity of Jaffa. The second victim was Joseph Davidson, 30, who died of injuries suffered in an accident at Tel Aviw.

DR. NIEMEROWER ELECTED TO RUMANIAN ZIONIST POST

BUCHAREST, Jan. 30. (JTA) -- Senator Jacob Isaac Miemerower, chief rabbl of Rumania, was elected honorary president of the Rumanian Zionist Organization today at its convention.

Making his first appearance since he was wounded in an attempted assassination January 11, Dm. Niemerower was acclaimed by the delegates. Samuel Singer was elected president of the organization.

76 JEWS LEAVE GERMAN TOWN, STUERMER ANNOUNCES

EERLIN, Jan. 30. (JTA) -- Julius Streicher's Der Stuermer announced today that all the seventy-six Jews of the town of Roth near Nuremberg have quit their homes and synagogue as a result of persecution by Nazi officials.

It added that the entire population of the town had acclaimed the announcement that the town was "Judenrein" (free of Jews."

ATTORNEYS HONOR JUDGES AT BROOKLYN FEDERATION DINNER

NEW YORK, Jan. 50, (JMA) -- Six inundred attorneys he bree three newly-elected jurists and entertained about thirty other members of the bench tonight at the "Bench Night" dinner meeting of the Layers Club of the Brooklyn Federation of Jewish Charittes, at the Unity Club, Bedford Avenue and Dean Street, Brooklyn

Those honored were Supreme Court Justices Mitchell May, Harry E. Lewis, and Francis G. Hooley, all of whom assumed their posts for new terms on Jan. 1.

Mennwhile, 500/young women gathered at the seventh annual fashion show of the Junior Pederation of the Brooklyn Pederation of Jewish Charities. The fashion show is the principal preliminary affair preceding the charity ball, which will be held Saturday night, February 15, at the Hotel St. George, Brooklyn.

JEWISH WOMEN'S FEDERATION BACKS OLYMPIC BOYCOTT

NEW YORK, Jan. 30. (JTA) -- A resolution asking Americans to stay away from the Berlin Olympic games was unanimously adopted today by more than 1,000 delegates representing 252 organizations at the convention of the Federation of Jewish Women's Organizations at the Hotel Astor.

Other resolutions adopted called upon the more than 110,000 persons represented in the federation to continue the boyoott of German goods and extended a vote of thanks to James G. McDonald for his work as League of Nations High Commissioner for Refugees.

The resolution on Olympics was adopted after former Supreme Court Justice Jereman T. Mahoney, leader of the anti-Berlin forces at the recent Amateur Athletic Union convention, had told the delegates that "the fight has just begun" and that he would "keep up the fight" until those who are sponsoring the sending of the Ameratoran athletes to Germany realize the error of their ways

Other speakers at the convention were Mrs. Herbert H. Lehman, Mrs. Felix M. Warburg, Fannie Hurst, Mrs. Mary Simkovitch and Mrs. David E. Goldfarly, who presided.

Previously, in an address at a meeting in Brooklyn of the Workmen's Circle and the Socialist Party, Mr. Mahoney had charged that memebors of the American Wlympic Committee let their personal ambitions betray American sportsdom.

He added that it is not yet too late to protest, urging that funds be withheld from the Olympic Committee.

"The uncontroverted truth shows that for some time past Germany as ruled by the Nazis, is a land of bigotry, persecution, discrimination and injustice," he said. "Minorities are not represented in any way in the Government, nor are they given any consideration whatsoever.

"The Nazi ideology, or its fundamental political philosophy, is based upon the principle of inferiority of races, fasticularly the Jewish races. This is contrary to agreements reached by Germany with the other Fowers in the treaty leading up to the final world war treaty, where Germany demanded recognition of German minorities in lend taken from her; she, on the other hand, agreeing to recognize minorities within her own borders."
