# NEW EMERGENCY MEASURES TO BE PROCLAIMED, COMMONS IS TOLD

LONDON, June 9. (JTA) -- In his first statement to the House of Commons as Colonial Secretary, William Ormsby-Gore announced today that further emergency powers, under a Palestine defense order in council, are being issued by proclamation.

The Palestine situation was the subject of heated discussion when Commons reconvened for the first time since the Whitsun recess.

Declaring that the previous improvement in the situation has not been maintained, the Colonial Secretary who succeeds JaH. Thomas said the Pelestine authorities, facing a continuing series of acts of violence, are taking all possible action to protect life, property and communications.

He voiced confidence that "ultimately, upon the basis of recommendations by the Royal Commission which His Majesty's Government has been advised to appoint when order is fully restored and acts of violence prevented, a means will be found within the framework of the mandate to establish a more lasting peace and contentment among the various peoples in Palestine."

Questions following this statement elicited the reply that the Government has no inhention of appointing a Royal Commission or publishing the terms of reference until the British administration is once more master of the country and until law and order are definitely established.

He said that leaders of the strike who are suspected of responsibility for crime and violence have been arrested and placed in concentration camps.

W. Gallacher, Communist member, interrupted a discussion to shout that the Arab strike is justifiable. He urged that justice be granted the Arabs in the form of the proposed legislative council instead of trying to impose a military dictatorship.

Herbort Morrison, Laborite, pointed out that the leaders of the Arab strike, which appeared to be political, were "well-to-de men, some of them capitalists, not union leaders."

#### POLICEMAN KILIED IN BATTLE; ARAB RAIDERS REPELLED BY COLONISTS

MERUSALEM, June 9. (JTA) -- Sharp pitched battles between Arab rebels and special Jewish policemen guarding colonies were reported to-day.

A forty-minute engagement was fought at Kfar Ivri, near Jerusalem, when well-armed Arab bands opened fire from several directions at a distance of four hundred meters. The Arabs were repelled by the guards.

A similar attack, lasting half an hour, occurred at Ramat Kovesh, the rebels retreating under fire. The Arabs stopped long enough, however, to set fire to crops at Meshek Kalmania.

The Jorinho-Jerusalem road late last night was the scene of a bitter skirmish between police and Arab snipers who attacked a convoyed caravan of seven motor busses of the Releatine Potash Company. An Arab policeman was killed in the battle, which lasted three hours before the snipers took to the hills.

One of the Arabs wounded in yesterday's bombing at the Jaffa Gate died today. A Sephardic Jew, Shabatai Mordechai, is being detained in connection with the bembing, which resulted in the wounding of 25 Arabs and Armenians. Mordecai Eliash, noted attorney, is representing him.

Investigation to determine who threw the bomb is still under way. Arabs charge it was thrown by Jews while the latter aver it was aimed by Arabs at Jewish passersby and landed instead among a group of Arabs and Armenians.

An Arab carrying a revolver and ammunition was arrested in the Neve Shaanon suburb of Jerusalem.

Jewish buses were again fired at near Jazur and Ben Shemen. No casualties were reported.

More than 170 Jewish special policemen were mobilized for emergency service. Sixty of them were detailed to Jerusalem and the remainder to other parts of the country.

A military station was established at Lifta, scene of an all-night battle between Government forces and Arab maraudors. The station will ensure greater safety on the Jerusalem-Fel Aviv road.

The Jewish Agency for Palestine has advised its London executive to invite Rabbi Moshe Blau, of the Agudath Israel, extreme orthodox organization, to go to London, it was learned.

The Government reaffirmed last night its determination not to yield to Arab disorders, aimed partly against Jewish immigration, which are continuing in their eighth week.

A Government spokesman stated over the official radio station: "The Arab press reports that the High Commissioner is ready to restrict immigration is void of foundation."

A false rumor that Jewish immigration had been halted caused Jaffa Arabs to hold celebrations in the streets.

#### INTERNATIONAL PHONES IN PALESTINE BARRED TO CORRESPONDENTS

- JENUSALEM, June 9. (JTA) -- Only Government officials, the Jewish Agency for Palestine and some of the largor banks were permitted today to use the international telephone system as a result of yesterday's order barring the wires to all except those with special mermission.

Newspaper and news service correspondents were not given the nec-essary permission.

# HEBREW U. STUDENTS TOLD THEY CAN'T JOIN BRITISH ARMY

JERUSALEM, June 9. (JTA) -- Offer of the Hebrew University student body to establish a Jewish military unit within the British Army in order to help the Government cope with Arab disorders was officially rejected today.

Notification of the rejection was made by the Palestine Government to the student corporation, "El Al", with the explanation that such a unit was impossible because Palestinians, whether Jows or non-Jows, are not being onlisted in the British Army,

The corporation was advised, however, that its members may enlist in the Transjordan frontier force and in the Palestine police.

## JEWISH LEGION COLORS ENTRUSTED TO HEBREW U. STUDENTS

TRIUSALEM, June 9. (JTA) -- The standard of the Jewish Legion, which added the late Lord Allenby in his conquest of Palestine from the Turks, was today handed over to the student body of the Hebrew University for preservation. The emblem of the Legion's prowess was presented to "El AI", student corporation, by Rabbi Falk of Australia, chaplain of the famous Jewish military unit, in whose care it has been since the War.

The colors originally were presented to the Legion by the Maccabl, world Jewish sports organization, at Alexandria. They were carried by the Legion at the Transjordan front during the War.

#### JAFFA CURFEW VIOLATORS TURNED INTO STREET CLEANERS

JAFFA, June 9. (JTA) -- Streets of this predominantly Arab city were being cleaned today by curfew violators, who were given brooms and forced to substitute for striking municipal white wings. The regular cleaners are, together with municipal departments of other Arab cities, striking to enforce Arab demands for stoppage of Jewish immigration and sale of land to Jews.

#### REVISIONIST PARLEY IN PALESTINE BARRED

TEL AVIV., June 9, (JTA) -- District Commissioner Crosbie today notified the Zionist Revisionist Organization that its convention scheduled to open June 12 has been prohibited on the basis of the existing ban on public gatherings, invoked as a result of the Arab disorders.

#### PRZYTYK POGROM PREARRANGED, RADOM COURT TOLD

RADOM, Poland, June 9. (JTA) -- The riots in Przytyk on March 9 in which three persons were killed and scores injured were apparently prearranged and began with the ringing of churchbells, according to testimony today in the trial of 42 Poles and 14 Jews on charges arising from the disturbances.

Cross-examination of Jewish witnesses in District Court failed to shake this testimony.

# PROTOCOLS LIBEL ACTION SETTIED AMICABLY; NAZI EDITOR RETRACTS

BASLE, June 9. (JTA) -- A libel action against the former editor of the Iron Broom, organ of the anti-Semitic National Front, arising from the famous trial in which the so-called Protocols of the Elders of Zion were proved spurious, was settled amicably today.

The action, pending since June 21, 1933, had been brought by three well-known Jewish leaders, Dreyfus Brodsky, president of the Basie Jewish Community, Dr. Marcus Cohn, president of the Swiss Zionist Federation, and Dr. Marcus Ebronpreis, Chief Rabbi of Stockholms

Dr. Zander, the defendant, agreed to withdraw assertions published in his paper alleging that Dr. Ehrenpreis had called the Protocols gonuine.

He admitted the Protocols had no connection with the first World Zionist Congress here in 1897.

Some 780 copies of the spurious document, imported by the Basle National Front from Germany, will be destroyed, Dr. Zander Promised. Costs of the action will be paid by Dr. Zander.

## POLISH PREMIER TELLS JEWISH TRADERS TAX-PAYERS! RIGHTS WILL BE GUARDED

WARSAW, June 9. (JTA) -- Premier Skladkowski today received a delegation of Jewish traders and informed them that all tax-paying Polish citizens have full trading rights and limitations against them would not be permitted.

The position of Jewish traders has become worse as a result of the "hands-off" policy declared by Fremier Skladkowski on internal economic competition, it was charged yesterday at the conference of the Federation of Jewish Traders.

The meeting asserted that Jewish contractors have now been excluded from servicing Government institutions and that provincial Jewish traders are being victimized by local authorities.

#### ANNOUNCEMENT OF ZASLAWSKI'S DEATH FOUND FALSE

WARSAW, June 9. (JTA) - The announcement Sunday that Rudolph Zaalawski, Jewish actor, had died of a heart attack in Danzig turned out today to be untrue. The statement of the death, made by the Jewish Artists' Union, was denied. The entire Polish Jewish press had been taken in by the false announcement.

#### AUSTRIAN JEW JAILED BY REICH FOR RASSENSCHANDE

BERLIN, June 9. (JTA) -- Victor Desser, 51, an Austrian Jew, was under sentence by a Dresden Court today to serve one year in prison on a charge of violating the Nuremberg racial defilement laws. The court explained the severity of the sentence with the statement that as a foreigner he had misused German hospitality by transgressing against the Nuremberg laws.

# LA GUARDIA HALES ANTI-SEMITE TO COURT, CHARGING RACE LIBEL

NEW YORK, June 9. (JTA) -- Charged with criminally libeling the Jews, Robert E. Edmondson, anti-Semitic propagandist must appear in Tombs Court temorrow morning to answer a summons issued by Mayor LaGuardia in his seldom-used capacity of chief magistrate.

District Attorneys of New York and Bronx counties had today a letter from the mayor urging them to investigate the case on the ground that "unless checked, this type of agitation may incite to a breach of peace and public disorder."

Education, who operates the so-called Education Economic Service, claims to have sent out 5,000,000 of his sheets attacking what he calls Jewish domination of the United States and linking various public figures, including President Rocsevelt and Governor Landon of Kansas, with Jews and Communists.

He says the Department of Justice and Post Office Department have previously investigated him. Representative Dickstein introduced a resolution in Congress recently to investigate Edmondson's service in connection with the Black Logion developments.

In issuing the summons, Mayor LaGuardia explained that in his opinion persons making statements should be responsible for them. He denied attempting to restrict freedom of press, declaring that when this freedom was abused it was time to act. The mayor withheld the name of the complainant.

The Mayor said in his letter to New York District Attorney Dodge -- a copy of which was sent to the Brenx District Attorney because of information that Edmondson's literature had been sent into that county -- that "it is most important that there be a thorough invostigation of the alleged orime."

#### MILLION ZLOTY LOAN TO REHABILITATE JEWS GRANTED BY POLAND

NEW YORK, June 9. (JTA) -- The Polish Government has granted a 1,000,000-zloty loan which, with 500,000 zlotys from the Joint Distribution Committee and affiliated organizations, and 500,000 zlotys raised by the Polish Jews will finance a new project for conomic rehabilitation of Jews in 500 to 700 small Polish towns and villages, it was announced today.

Alexandér Kahn, chairman of the J.D.C. s committee on Foland, said half of the Government loan will be made available immediately. The work is expected to get under way within a few works and will be conducted through the Gomiloth Chessed Kassas (free loan societies).

#### REPORT NASHASHIBI RESIGNED FROM ARAB COUNCIL

JERUSALEM, June 9. (JTA) -- The Hobrew daily, Dear Hayon, reported today that Ragheb Bey Nashashih, former mayor of Jorusalem and influential Arab leador, had be resigned from the Arab Supreme Council and from the Arab Strike Committee directing the general strike against the Jows and the Government.
