ARAB BOMB WOUNDS 7 SCHOOL CHILDREN IN TEL AVIV

JERUSALEM, July 23. (JTA) -- Seven children were slightly injured at noon today when an Arab threw a bomb into the yard of a Yemenite religious school on Brenner Street in the heart of the all-Jewish city of Tel Aviv; an official communique said.

One of the children was earlier reported seriously wounded. All were taken to Hadassah hospital. The victims range in age from nine to twelve years.

The fact that the bomb was evidently poorly aimed and struck a fence saved several hundred children at recess in the yard from possible injury.

A Jewish passer-by who saw the Arab throw the bomb, gave chase, but was halbed by a group of Arabs and severely beaten. He was taken to the hospital suffering from a broken arm. The Arab escaped.

A Jewish woman in Jerusalem prevented an explosion by picking up a home-made bomb thrown into her room and pulling out the fuse.

A bomb explosion slightly damaged police headquarters at Haife, Other bombs were thrown at the Government offices and the post office in Jaffa,

Sporadic shooting was reported in Betania, Kfar Ezekiel, Kalmania, Hedera and Bett Vegan. Thirty dunams of mixed fruit trees were dut down by marauders in the Government grove at Farwani near Beisan during the night.

Gurfew from nine p.m. to 2.45 a.m. was imposed on the Jenin municipal area.

HINT MARTIAL LAW NEEDED TO RESTORE ORDER IN PALESTINE

LONDON, July 25. (JTA) -- A hint that High Commissioner Sir Arthur Grenfell Wauchope may have to resort to martial law to restore order in Palestine is contained in an editorial today in the Times, whose editorials frequently mirror Government attitude on important questions Apparent unwillingness of "some members of the Palestine judicature" to cooperate with the administration in enforcing existing emergency measures, the editorial indicates, may be a deciding factor in such a decision.

Terrorist extortions in Arab villages, the Times points out, are likely to make the rebels unpopular. It suggests that the way to diminist fellaheen support of the terrorism would be to convince them of the administration's intentions to fulfill the sterner measures under the emergency ordinances.

Because of the failure of some of the judiciary to be "more helpful" in this respect, it is contended, martial law may have to be declared.

Commenting on Colonial Secretary William Ormsby-Core's statement in the House of Commons yesterday, the editorial declares his promise to announce the Royal Commission does not clash with the statement of his predecessor, J.H. Thomas, that order would have to be restored before the commission is sent.

The Colonial Secretary, it points out, has abundantly clarified that he has no intention of despatching the commission before order has been established,

In the House of Commons yesterday, Mr. Ormsby-Gore declared there was no question of a change in policy on Palestine before the commission's findings.

Concerning possible stoppage of immigration pending the investigating body's deliberations, over which there has been considerable discussion, the Colonial Secretary stated a decision would be made in due course and that it would not be influenced by intimidation.

1,603 JEWS ENTERED PALESTINE IN JUNE

JERUSALEM, July 22. (JTA) -- Despite Arab disorders, 1,603 Jews entered Palestine during the month of June, it was announced today in the official gazette. These included 157 in the capitalist category, possessing a minimum of \$5,000.

VIENNESE SWIMMER DISQUALIFIED FOR REFUSING TO GO TO BERLIN

VIENNA, July 23. (JTA) -- The Austrian sports authorities today disqualified for two years Ruth Langer, 15-year-old swimmer, a member of the Hakcah Jewish sports club, for refusing to join the Austrian Olympic team, which will compete in Berlin next month.

Miss Langer's refusal to compete was in accordance with the decision of the Maccabi Union, parent Jewish sports organization, to boycott the Olympis games.

Another Jewish swimmer, Judith Deutsch, 17, was meanwhile preparing, according to her friends, to fight in Federal Court against the action of the sports authorities in disqualifying her for two years for refusing a bid to participate in the Olympics.

"As a Jewes," Miss Deutsch wrote to the sports authorities, "I cannot take part in the Olympic games in Berlin because my conscience forbids me to do this. I declare that this is my free and unalterable decision. I ask that my point of view should be understood and that I should not be subjected to any compulsion."

Some observers said both cases of disqualification were illegal because there was no law providing for disciplining athletes for refusal to take part in any particular event.

REPORT WORLD CONGRESS OPENING MAY BE DEFERRED

WARSAW, July 23. (JTA) -- The Executive in Geneva for the World Jewish Congress was reported today to have agreed to postpone the opening session of the congress from August 8 to August 26 if technical arrangements permit.

The decision was made on the request of the Polish committee for the world congress, which had asked the stay to make possible election of the 60 Polish delegates. The originally-scheduled elections were delayed.

DR. JASCALEVICH, ARGENTINE SCHOLAR, DIES AT 42; TAUGHT AT COLUMBIA

BUENOS AIRES, July 1. (By Mail) - (JTA) -- Dr. Alejandro A. Jascalevich, philosopher, psychologist and essayist, who spent more than ten years studying and teaching in the United States, died here on June 26 after a prolonged illness. He was 42 years old.

Between 1925 and 1926 Dr. Jascalevich was an instructor in the Department of Philosophy and Psychology at Columbia University. Later, he taught elementary philosophy at the Long Island City Hospital.

While in the United States he published a number of essays in English and Spanish on modern and classic philosophers in the Journal of Philosophy, on whose editorial staff he served.

On his return to the Argentine, Dr. Jascalevich was appointed Vice Rector at the National School of Azul. In 1931 he published a volume of collected essays, entitled, "Interpreters of the Soul."

Six months ago he was appointed director of an English-language newspaper in Buenos Aires, but was forced to resign because of illness.

ARABS ENLIST TURTLES! AID IN FIRING JEWISH FIELDS

JERUSALEM (JTA) -- Emulating Samson's Bible-famed feat of loosingmg foxes with torches tied to their tails in the Philistines' cornfields Arabs have enlisted turtles in their campaign of guerilla warfare against the Jews and the Government.

Considerable head-scratching was caused among British soldiers guarding fields in the Nablus district at the sight of what seemed to be candles moving slowly through the darkness under their own power.

Patrols investigating increasing incendiarism finally caught several turtles "red-handed" with tapers tied to their backs and the mystery was solved.

The Book of Judges recounts how Samson tied torches to the tails of 300 foxes and turned them loose in the Philistines! fields to raze their crops.

ALGERIAN ARAB LEADER HITS EUROPEAN ANTI-JEWISH AGITATORS

ALGIER (JTA) -- The charge that European anti-Jewish agitators have been responsible for stirring Moslems to disorders was made by Dr. Salah Bendjelloul, the political leader of the Algerian Arabs, in an interview with the Jewish Telegraphic Agency.

"We have, however, awakened to the true facts," he said, "and the Europeans are wasting their breath in calling on us to massacre the Jawa."

He laid the responsibility for the Constantine disorders of 1934 entirely upon European agitators who, he declared, never essent to stir up hatred against the Jews at meetings and in their newspapers.

Relations between Jew and Moslem, he said, were cordial despite the recent lynching in Bon-Saada of a Jew accused of murdering a Moslem. The Moslems, he said, were intent on maintaining friendship with the Jews despite the agitation of Hitler agents.

Dr. Bendjelloul added that leaders of the Mohammedan population were constantly appealing to their co-religionists to observe order and not to lend their ears to the anti-Semitic agitators who sought to arouse them to violence against the Jews.

ENGLISH GROUP GETS INTEREST IN SCHOCKEN CHAIN

BERLIN (JTA) -- The Frankfurter Zeitung reports that an English group headed by Sir Andrew McFadyean has acquired a substantial interest in the Schocken chain of mineteen department stores. The principal stockholder is Salmen Schocken, treasurer of the Hebrew University in Jorusalem, who remains a partner, according to the report.
