J.T.A. BERLIN BUREAU EXPELLED FROM REICH NEWS AGENCY BODY

BERLIN, Oct. 1. (JTA) -- The authorities today notified the Berlin bureau of the Jewish Telegraphic Agency that it has been expelled from membership in the Association of News Agencies in Germany.

Executive heads of the bureau, Dr. Arno Herzberg and Otto Schick, were ordered to communicate at once with Hans Hinkel, Nazi Commissar for "non-Aryan" Culture, concerning its future activities.

At the same time, all German-Jewish newspapers in Berlin were informed that they had been expelled, as of today, from the Reich Press Chamber. The papers were placed under supervision of Mr. Hinkel.

This new move on the part of the authorities extends to the press the "ghetto" regulations hitherto limited to Jewish theatres.

The Berlin bureau of the J.T.A. supplies news to Jewish newspapers throughout Germany.

POMERANIAN NAZIS FORBID GERMANS TO SELL FOOD TO JEWS

BERLIN, Oct. 1. (JTA) -- Nazi authorities in the province of Pomerania have issued instructions forbidding Germans to sell food-stuffs to Jews, it was learned today.

The Nazi leader of Glowitz not only has prohibited local grocers from selling supplies to Jews, but has also issued a warning to individuals against donating food to Jews. The Jewish population there is now dependent on neighboring towns for sustenance.

Peasants were especially cautioned that they would be deprived of their lands or heavily taxed if they were discovered dealing with Jews.

REICH JEWISH DRUGGISTS CLOSE RATHER THAN SELL AT FIXED PRICES

BERLIN, Oct. 1. (JTA) -- A number of Jewish pharmacists today went out of business rather than sell out to "Aryans" at prices fixed by Nazi "experts" under a law announced six months ago. The law, setting Oct. 1 as the deadline for compliance, had ordered Jewish pharmacists either to liquidate or sell their establishments to "Aryans."

BERLIN KEBILLAH ASKS WINTER RELIEF FUNDS

BERLIN, Oct. 1. (JTA) -- The exodus of wealthy Jews from Germany and the consequent increase in the number of needy Jews today prompted Dr. Heinrich Stahl, president of the Berlin Jewish Community, to appeal for increased contributions to the Jewish Winter relief fund in Berlin.

SOLDIER WOUNDED IN ARAB ATTACK

JERUSALEM, Oct. 1. (JTA) -- A British soldier was seriously wounded today when Arab bands fired on a military patrol near Bab-el-Wad, a village on the Jaffa-Jerusalem road.

Derailement of a train between Haifa and Acre caused critical injuries to an Arab.

CLEARED OF LIBEL IN DENOUNCING RUMANIAN FOR MARRYING JEWESS

BUCHAREST, Oct. 1. (JTA) -- A verdict dismissing libel charges against an editor who called an army captain "traitor" for marrying a Jewess was interpreted by Nationalist newspapers today as permitting that description of Rumanian officers who intermarry.

The libel charges were instituted by Captain Ionseinu against Dr. Radelescu, editor of the extreme anti-Semitic paper, Porunca Vremi, after the editor had denounced him in print as a "traitor." Although there is no Rumanian law forbidding intermarriage, a Bucharest court acquitted the editor.

GOVERNMENT HELP ASKED AS BIRO-BIDJAN BUILDING PROGRAM LAGS

MOSCOW, Oct. 1. (JTA) -- A lag in the building program for the autonomous Jewish territory of Biro-Bidjan has prompted the Comzet, Government commission for settling Jews on land, to address an urgent request to the Commissar of Agriculture for measures to carry out the Government's plans, it was disclosed today.

The Comzet, at a meeting yesterday, adopted a resolution to inform the Commissar of Agriculture of the situation. Boris Trotsky, acting president of the body, said that only 138 houses were being built of a planned 900 and only 12 completed to date.

The newspaper Stern in Kharkow published an article by the Jewish writer, M. Chachevatzki, who stated after a visit to the region that bad management was forcing many of this year's settlers to leave the territory because of inadequate housing accommodations.

The settlers came to work in Biro-Bidjan's newly-constructed factories, he wrote, and found the houses not ready for occupancy.

LORD CRANBORNE NAMED RAPORTEUR OF REFUGEE SUBCOMMITTEE

GENEVA, Oct. 1. (JTA) -- The subcommittee on refugees appointed last week by the League of Nations Assembly's political commission today unanimously elected Lord Cranborne, British Parliamentary Under-secretary of State for Foreign Affairs, as rapporteur to the commission.

REPORT REICH OFFERS TO REPATRIATE 2,000 JEWISH DOCTORS

NEW YORK, Oct. 1. (JTA) -- The New York Herald-Tribune reports from Geneva today that Germany has indicated it will consider repatriating 2,000 Jewish doctors with the proviso that they donate their services to the Reich army. The newspaper gives as its source Sir Neill Malcolm, League of Nations High Commissioner for Refugees Coming From Germany.

SEE JEWS IN EAST EUROPE LOSING WILL TO LIVE

NEW YORK, Oct. 1. (JTA) -- Morris C. Troper, comptroller of the Joint Distribution Committee, said today on his arrival from a tour of Central and Eastern Europe that he noted a waning of the Jews' determination to live out their lives.

Should complete deprivation of legal rights of Jews, as occurred in Germany, be visited on the Jews in Eastern European countries, he said, "the disaster of the Jews in Germany would pale into insignificance."

"FWI" AIDS JEWISH FIRMS IN REICH TO LIQUIDATE

BERLIN (JTA) -- Organized in 1934 to facilitate liquidation of Jewish businesses here forced by Nazi measures, the FWI has become one of the most important Jewish agencies in aiding Jewish emigrants to take with them part of their funds.

The FWI, or Society for the Promotion of Economic Interests of the Jewish Residents or Former Residents in Germany, is an entirely private undertaking under the control of central Jewish organizations,

It has founded a central clearing house for pooling experiences in regard to sale of Jewish establishments and has been consulted by many businessmen of the Jewish faith anxious to sell their enterprises.

Recently, it branched out to the exchange of businesses and real property, a step made necessary by Government transfer restrictions and the continuing wave of emigration.

Representatives and correspondents of the FWI abroad inform the main office here of opportunities for exchanging businesses and property between purchasers in other lands and emigrants.

A further undertaking of the society is administering property of those Jews who have already departed from the Reich.

PALESTINE TRAINING SOUGHT FOR REICH JEWISH TEACHERS

BERLIN (JTA) -- A six-month training period in Palestine would be required of all teachers in the "ghetto schools" of the Reich if demands now being pressed by a group of Jewish educators are successful.

The training of teachers for the Jewish schools is one of the most acute problems facing German Jewry. Approximately 25,000 Jewish children are now being educated in schools maintained by Jewish communities. Provision will have to be made for an additional 20,000 who are still in the public schools but segregated under administrative orders.

REICH ISSUES "BOYCOTT LIST" OF JEWISH LAW COMMENTARIES

BERLIN (JTA) -- To preclude legal quotations from Jewish lawyers and judges, the Government has issued a directory of commentaries by Jews on German law. It lists all "non-Aryan" jurists and bar-members who have written commentaries on law cases.

A foreword to the directory points out that "the publication of such a handbook has become a necessity since many lawyers and judges find it necessary to establish quickly whether or not the author of a certain commentary is a Jew."

C.-V. ZEITUNG ABSORBS ORGAN OF REICH LIBERAL JEWS

BERLIN (JTA) -- The Juedische Allgemeine Zeitung, official organ of the Liberal Jews of Germany, has ceased publication and been merged with the C.-V. Zeitung, organ of the Central Union of Jews in Germany.

LONDON REPUDIATES SUPPORT OF ANTI-SEMITIC ORGANIZATIONS

TOPEKA, Kans.?Oct. 1. (JTA) -- Repudiating the support of "elements who are endeavoring to bring racial prejudices and religious bigotries into American life," Governor Landon declared in a statement today that if any group were persecuted for race or religion, "I would stand among their defenders."

His formal statement, given out at a press conference, follows:

"My attention has recently been directed to the activities of a number of agencies which, for selfish purposes or political reasons, are endeavoring to exploit prejudice between groups of American citizens.

"I have no use for any elements who are endeavoring to bring racial prejudices and religious bigotries into American life and state frankly that I disclaim the support of any such organizations or groups.

"If ever the day should come in this country that would see persecutions of any racial group or sect because of race or religion, contrary to the bill of rights, I would stand among their defenders."
