250,000 HALT BLACKSHIRTS' PARADE IN LONDON'S EAST END

LONDON, Oct. 4. (JTA) -- Shouting, "They shall not pass!" an unruly crowd of an estimated 250,000 persons today blocked the route of march of 5,000 Fascist Blackshirts into London's East End and forced the Police Commissioner to prohibit the parade at the last moment.

Many persons were injured and 53 arrested as members of the crowd frequently broke from the control of the 3,000 police and attacked the Fascist marchers. Three Blackshirts were beaten before the police could rescue them. Other injuries occurred when police charged on anti-Fascists attempting to block the parade.

(The Havas News Agency said nine bystanders, including three women, an old man and a 14-year-old boy were injured seriously enough to require hospital treatment, and many other spectators were trampled under foot and bruised. One group of young anti-Fascists overturned a truck in the middle of Cable Street in an attempt to blockade the road. About ten men were arrested at this point, Havas said.)

Several clashes with police occurred near the Royal Mint, where the members of Sir Oswald Mosley's British Union of Fascists assembled to begin their parade into London's Jewish quarter. Near Aldgate, the entrance to Whitechapel, the police were almost overpowered by the surging mob on several occasions.

Fifteen minutes after the parade was supposed to start from the mint, Sir Philip Game, the Police Commissioner, notified Mosley that the march had been banned. The Fascists thereupon cancelled meetings at Victoria Park and other places, and marched westward, away from the hostile crowd, to disband at Charing Cross.

Home Office Refused to Ban March

Groups broke away from the crowd and followed the Fascists, who continued to march in formation. Minor clashes occurred at Trafalgar Square and on the Strand between small groups of Blackshirts and anti-Fascists.

After the refusal of the Home Office yesterday, despite protests from Jewish and anti-Fascist groups, to prohibit the demonstration, the Communists, Independent Laborites and Jewish Peoples' Party last night and this morning feverishly canvassed the entire district, exhorting residents to turn out in protest.

As a result, hours before the march was supposed to begin, threatening crowds jammed the line of march, necessitating the strongest concentration of police in years to control them. Police had mobile equipment and firemen appeared on the scene with hoses to keep the mob in check. Hundreds of detectives had been assigned to mingle with the crowds to prevent outbreaks of violence.

Merchants in Whitechapel, the Jewish quarter of the East End, had boarded up their shops in anticipation of disorders.

Mosley's schedule called for a "march past of troops" in the East End, after which the Blackshirts were to divide into four columns and march to Shoreditch, Limehouse, Bow and Bethnal Green for separate night meetings.

A petition bearing 100,000 signatures asking prohibition of the demonstration was presented to the Home Office last Friday by a delegation from the Jewish Peoples' Council, headed by James H. Hall, Laborite M.P.

Barnet Jenner, former M.P. from Whitechapel, yesterday asked the Home Office authorities to reroute the parade if it could not be banned.

Mayors of London boroughs had asked a ban on the demonstration on the ground that it would lead to disorders. Fears of violence rose when Communists and Independent Laborites called mass meetings in the East End to begin a half hour before the scheduled Blackshirt parade.

ARABS ATTACK TEL AVIV QUARTER AND POLICE POST

JERUSALEM, Oct. 4. (JTA) -- Troop reinforcements were called today to repulse Arabs who attacked the Agricultural Bank quarter of Tel Aviv and a police post between Jerusalem and Jaffa as disorders entered their twenty-fifth week.

In Tel Aviv, a police car which arrived to disperse the Arabs was also attacked before troops arrived on the scene.

The police post, about 40 miles from Jerusalem, was subjected to a heavy barrage of rifle fire. When the defenders had exhausted their ammunition, they sent an S.O.S. to Jerusalem for aid. Troops were despatched to the scene, who engaged and routed the rebels.

Four soldiers were injured when an army car overturned near Jerusalem.

An Arab band destroyed a number of huts at Tel Keisan, near Acre, which were the property of the John Garstang archaeological expedition of England. An Arab watchman was injured.

Rebel bands yesterday killed an Arab sergeant in an attack on the police station at El Bassa, in northeastern Palestine, near the Syrian frontier.

Last Troops Sail for Palestine

SOUTHAMPTON, England, Oct. 4. (JTA) -- Three battalions of British troops, comprising the finest units in His Majesty's army, sailed on the Laurentic for Palestine yesterday to complete a force of approximately 30,000 effectives mobilized in the Holy Land under Lieut. Gen. J.G. Dill to quell Arab disorders.

Among the officers of the Third Battalion of Coldstream Guard is Lord Frederick Cambridge, a nephew of Queen Mary, who is serving as a subaltern.

Goldmann Hits Administration

PARIS, Oct. 4. (JTA) -- In a sharp attack on the Palestine administration, Dr. Nahum Goldmann, the Jewish Agency for Palestine's representative at Geneva, declared today that if further disorders were to be avoided, sweeping reforms would be necessary.

He told a Pro-Palestine Conference here that the Mandatory administration of the Holy Land was "bankrupt at all points."

REICH TO PURGE JURISPRUDENCE OF JEWISH INFLUENCES

BERLIN, Oct. 4. (JTA) -- A program to completely purge the German juridical system of Jewish influences, drawn up by Dr. Hans Frank, Nazi Commissar of Justice, was announced yesterday at the opening session of a two-day conference on the "Jew in Jurisprudence" held at the German Law Front House.

Dr. Frank's program follows:

- 1 - No Jew will be allowed in the future to be a spokesman for German law.
- 2 - German justice will be reserved only for German 'Aryans' as defined by the Nuremberg laws.
- 3 - Publishers will not be permitted to issue new editions of law books written by Jews.

4 - Law books written by Jews will be removed from all libraries and transferred to special anti-Jewish institutes, where they will be used to expose the "evil influence" of Jews.

5 - German lawyers must abstain from quoting from Jewish legal authorities, except when the quotations are intended to discredit Jews and the Jewish mentality.

6 - Law professors must not adhere to the "pure truth" but give preference to Nazi teachings in order to help the racial theory, remembering that "no more science for the sake of science exists in Germany."

The conference was under the chairmanship of Prof. Carl Schmidt, State Councillor for Justice, who is credited with having drafted the Nuremberg Laws.

Opening yesterday's session, Dr. Schmidt paid tribute to the "great and glorious fight which Julius Streicher (Franconia's Governor and high priest of German anti-Semitism) is conducting against the Jews.

In an address broadcast throughout the country, he asserted that the Jews had invaded the German spiritual world, "not only by means of conversions, but also through influencing German jurisprudence by insinuating themselves in German legal life for at least a century."

The purpose of the conference, he declared, was to root out of jurisprudence all writings and commentaries by Jews of their descendants.

Thousands of German lawyers, he charged, had been influenced to think "in the Jewish way" because their professors were Jews and their textbooks were by Jews.

GESTAPO HOLDS TWO JEWISH LEADERS BEYOND LEGAL LIMIT

BERLIN, Oct. 4. (JTA) -- Efforts to secure the release of Dr. Franz Meyer and Benno Cohen, Zionist leaders who were arrested by the Gestapo (State secret police) on Sept. 24, had been unavailing tonight.

With no reason for their detention yet revealed, the two were still being held incommunicado in Gestapo headquarters in the Alexanderplatz, although an ordinance limits detention without filing of charges to eight days.

Dr. Meyer is executive head of the German Zionist Federation and Mr. Cohen a member of the executive. They were arrested during the same week as Rabbis Max Nussbaum and Emil Cohen, both of whom have been released.

SEGREGATION OF JEWISH PUPILS PRESSED IN BADEN SCHOOLS

BERLIN, Oct. 4. (JTA) -- The teaching of Hebrew and English for Jewish pupils in the State schools of Baden was introduced over the weekend after the Jewish children had been segregated from the "Aryans."

Segregation of Jews, ordered under a new decree pending completion of the task of erecting a separate school system for Jews, has so far been completed in the public schools of Heidelberg, Mannheim, Karlsruhe, Freiburg and Bruchsal.

The segregation will be completed throughout Germany by Easter at the latest, it was estimated. While the classes must follow curricula laid out by the State, the Jewish communities must defray the costs of the Jewish classes.

Teachers for the Jewish classes are to be designated by the national authorities from the ranks of Jewish instructors dismissed from State schools under the "Aryan" clause.

REICH ORDERS JEWISH ART DEALERS TO DISPOSE OF STOCK

BERLIN, Oct. 4. (JTA) -- The Reich Chamber of Culture yesterday ordered Jewish art dealers of Berlin to sell out or auction off their stock at the earliest possible date, since Jews will be prohibited from dealing in art objects by the end of the year.

The Essener National Zeitung demanded that Jews be prohibited from dealing in Stock Exchange issues, pointing out that the market shows a small demand for the four per-cent German issues, while the demand for foreign issues, paying an average of only two per cent, is constantly growing. This situation is attributable "to the fact that Jews are still influencing German Stock Exchange transactions," the paper said.

NAZI LEADER WARNS GERMANS WHO DEAL WITH JEWS BY "BACKDOOR"

MAGDEBURG, Germany, Oct. 4. (JTA) -- Declaring that no laxity in the anti-Jewish boycott could be tolerated, District Nazi Commissar Krause demanded today in an address at a meeting here that "Aryans" neither buy from nor sell to Jews.

"Whoever displays a sign, 'Jews not wanted here!' but deals with Jews at the backdoor had better remember that the Nazis have long memories, and be prepared for a good lesson," Dr. Krause said.

JEWISH BANKER JAILED IN REICH

BERLIN, Oct. 4. (JTA) -- A Jewish banker named Karl Weil has been sentenced by a Stuttgart court to three years and three months of penal servitude in connection with a bankruptcy case, it was announced today in an official communique.

JESSE I. STRAUS, EX-AMBASSADOR TO FRANCE, DIES OF PNEUMONIA

NEW YORK, Oct. 4. (JTA) -- Jesse Isidor Straus, 64, recently resigned as United States ambassador to France, died at 9:11 a.m. today at his home, 720 Park Ave., of pneumonia, which he contracted on Friday.

Mr. Straus, a former president of R.H. Macy and Co., New York department store concern, had been forced by acute illness to take leave of absence in the United States from the embassy in Paris. Finally, on Aug. 18, he was obliged to resign.

Surviving him are his wife, Mrs. Irma N. Straus; a daughter, Mrs. Robert Levy, and two sons, Jack Isidor Straus and Robert K. Straus. Funeral services will be held 10 a.m. Tuesday from Temple Emanu-El with Rabbi Goldenson presiding.

The Jewish Telegraphic Agency was told at Mr. Straus' home that he died peacefully, unaware of the serious nature of his illness.

Mr. Straus was born June 25, 1872, in New York, the son of Isidor and Ida Straus, who died in the sinking of the Titanic in 1912. After studying at Harvard University and the University of Georgia, he became a bank clerk.

Shortly afterward he entered the firm of Abraham and Straus as an executive. In 1897, he became associated with R.H. Macy and Co., becoming a partner in the firm in 1914, and finally being named president in 1919.

Mr. Straus was named ambassador to France immediately after President Roosevelt took office in 1933. He and the President were close friends.

REPORT POLAND TO BASE CLAIM FOR COLONIES ON 'SURPLUS' OF JEWS

WARSAW, Oct. 4. (JTA) -- Nasz Przegląd, Polish-Jewish daily, reported yesterday that Col. Joseph Beck, Polish Foreign Minister, intended to submit a claim for colonies to the League of Nations.

His demand that territories be made accessible for colonization by Polish peasants and Jews, the newspaper said, will be based on the Government's assertion that 80,000 Polish Jews must be settled overseas, in order to decrease unemployment and restore some measure of prosperity.

Beck Receives Goldmann

GENEVA, Oct. 4. (JTA) -- Josef Beck, Polish Foreign Minister, yesterday received Dr. Nahum Goldmann, head of the Executive of the World Jewish Congress.

4 JEWISH LABOR CLUBS RAIDED IN POLAND

WARSAW, Oct. 4. (JTA) -- Police yesterday raided four Jewish labor societies, including the left-wing Poale-Zionist Sports Club in the township of Plonsk, and closed them all although no evidence of anti-Government activities was found.

23 PER CENT OF AUSTRIA'S NEW CONSCRIPTS ARE JEWS

VIENNA, Oct. 4. (JTA) -- Official figures disclosed today that twenty-three per cent of Austria's new conscript army of 15,000 is Jewish, although the Jews form three percent of the population.

Eighty per cent of the Jews called to duty were found fit, as against only thirty per cent before the World War. The first conscript to be registered was a Jewish youth named Abeles.
