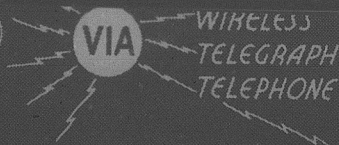

ARAB VIOLENCE FLARES AS JEWS THROU WAILING WALL TO LAMENT PARTITION

JERUSALEM, JULY 18. (JTA) -- LONG-FEARED OUTBREAKS OF ARAB VIOLENCE FLAMED TODAY IN MANY PARTS OF PALESTINE AS THOUSANDS OF JEWS MOURNED AT THE WAILING WALL AND ELSEWHERE THROUGHOUT THE COUNTRY OVER THE BRITISH GOVERNMENT'S PLAN TO PARTITION THE HOLY LAND.

ACTS OF TERRORISM BY SCATTERED ARAB BANDS COINCIDED WITH THE BEGINNING LAST NIGHT OF THE JEWISH DAY OF LAMENTATION FOR THE FALL OF JERUSALEM, TISHA B'AB.

TWENTY-THOUSAND JEWS MARCHED HERE IN THE PROCESSION TO THE WAILING WALL LAST NIGHT, AND THOUSANDS MORE CONVERGED ON THE WALL TODAY. THEY KISSED THE ANCIENT STONES AND SWORE THE TRADITIONAL OATH:

"YAM ESHKACHEICH JERUSHALAYIM" -- "IF I FORGET THEE, O JERUSALEM, MAY MY RIGHT HAND FORGET."

(THE BRITISH PLAN FOR PARTITIONING PALESTINE LEAVES JERUSALEM OUTSIDE OF THE PROPOSED JEWISH STATE).

SYNAGOGUES THE COUNTRY OVER WERE CROWDED WITH MOURNERS, WHILE CROWDS IN THE STREETS HEARD "KINOTH" (MOURNING PRAYERS) BROADCAST. HEBREW NEWSPAPERS RECALLED VERSES FROM THE PROPHETS RECLAIMING JERUSALEM AS THE CAPITAL OF THE LAND OF ISRAEL.

SIMULTANEOUSLY, ARAB TERRORISTS RESUMED THEIR ACTIVITIES IN THE JERUSALEM DISTRICT, AFTER HAVING BEEN MORE OR LESS QUIESCENT SINCE THE END OF THE 1936 ARAB GENERAL STRIKE. THEY ATTACKED THE BETH HAKAREM AND ATAROTS SUBURBS, AND WERE DRIVEN OFF BY SPECIAL POLICEMEN IN AN EXCHANGE OF RIFLE FIRE.

BOMBINGS, SHOOTINGS AND SETTING AFIRE OF TREES WERE REPORTED FROM NABLUS, JENIN AND TULKAREM. THE NABLUS DISTRICT COMMISSIONER ORDERED SIX ARABS OUT OF TOWN FOR INCITEMENT OF VIOLENCE.

MILITARY DETACHMENTS WERE SENT IN PURSUIT OF THE TERRORISTS. POLICE MADE SEVERAL ARRESTS AT AN ARAB VILLAGE NEAR HAIFA, WHERE THEY HAD SEIZED A QUANTITY OF ARMS AFTER A SEARCH. AT HEBRON, SOUTH OF JERUSALEM, THEY WERE INVESTIGATING REPORTED SHOOTINGS.

IN THE CITY OF JERUSALEM ITSELF, POLICE SEARCHED THE OFFICES OF THE WADF (FUND FOR ARAB HOLY PLACES), ARRESTING THERE SUBHI BEY EL KAHADRA, SAFAD ADMINISTRATOR OF THE FUND. THEY DISCONNECTED THE OFFICE'S TELEPHONES.

SEVERAL JEWISH DEMONSTRATORS WERE ALSO DETAINED IN JERUSALEM. SIX MEMBERS OF THE CENTRAL COMMITTEE OF THE REVISIONIST ORGANIZATION WERE ARRESTED FOR POSTING PROCLAMATIONS AGAINST PARTITION, ACTION REGARDED AS A "DEMONSTRATION." THE DISTRICT COMMISSIONER RELEASED THEM ON CONDITION THAT THEY REPORT TO POLICE THREE TIMES DAILY.

ANOTHER REVISIONIST WAS HELD IN £50 (ABOUT \$250) BAIL FOR TRIAL ON A SIMILAR CHARGE. THE POSTERS WERE TORN DOWN BY POLICE.

SCORES OF JEWS REPORTED INJURED, SHOPS LOOTED AFTER BAGDAD ARAB DEMONSTRATIONS

JERUSALEM, JULY 18. (JTA) -- SCORES OF JEWS WERE INJURED IN BAGDAD, CAPITAL OF IRAQ, THIRTY SO SERIOUSLY THEY WERE SENT TO HOSPITALS, AND MANY JEWISH SHOPS WERE PILLAGED, AFTER MASS DEMONSTRATIONS AGAINST ZIONISM, ACCORDING TO REPORTS RECEIVED HERE TODAY.

ALL JEWISH SHOPS IN THE CITY HAD BEEN CLOSED THROUGHOUT THE DAY BECAUSE OF THE DEMONSTRATION, CALLED TO PROTEST PARTITIONING OF PALESTINE AND LED BY AUNI BEY ABUL HADI, MILITANT PALESTINIAN ARAB NATIONALIST.

WARSAW AND ANTWERP SEE JEWISH ANTI-PARTITION DEMONSTRATION

JEWISH PROTESTS AGAINST PARTITION WERE CONDUCTED IN CONNECTION WITH TISHA B'AB OBSERVANCES IN WARSAW AND ANTWERP YESTERDAY. IN THE POLISH CAPITAL MEMBERS OF THE NEW ZIONIST ORGANIZATION DEMONSTRATED IN JEWISH DISTRICTS, HOLDING A PROCESSION THROUGH THE NALEWSKI QUARTER AND A MEETING AT MURANOWSKI SQUARE, WHERE A RESOLUTION AGAINST PARTITION WAS ADOPTED. IN THE BELGIAN CITY, THE HAVAS NEWS AGENCY REPORTED, JEWS PARADED THROUGH THE PRINCIPAL STREETS TO THE STATUE OF THE LATE KING ALBERT, WHERE THEY TOOK THE OATH NEVER TO FORGET JERUSALEM.

LLOYD GEORGE DENOUNCES PARTITION AS "CRAZY SCHEME"

NEW YORK, JULY 18. (JTA) -- PARTITION OF PALESTINE WAS DENOUNCED AS A "CRAZY SCHEME" AND "LAMENTABLE ADMISSION" OF BRITAIN'S FAILURE TODAY BY DAVID LLOYD GEORGE, WARTIME PRIME MINISTER OF GREAT BRITAIN, IN AN ARTICLE PUBLISHED IN THE SUNDAY JOURNAL AND AMERICAN.

DECLARING THE BRITISH GOVERNMENT'S PROPOSAL WOULD "MUTILATE" THE JEWISH NATIONAL HOME AND LOWER BRITISH PRESTIGE, MR. LLOYD GEORGE SAID: "WHAT WILL SIXTEEN AND A HALF MILLION JEWS, DISPERSED OVER THE SURFACE OF THE GLOBE IN EVERY CONTINENT, THINK OF THIS PROPOSAL TO BREAK THE SOLEMN PLEDGE GIVEN THEM BY THE GREAT NATIONS IN RETURN FOR SERVICES PROMISED AND RENDERED?"

EVEN IF PARTITION WAS INEVITABLE, HE DECLARED, THE PROPOSED DIVISION IS UN-INTELLIGENT AS "IT DOOMS LARGE TRACTS OF FERTILE LAND IN THE NORTH AND SOUTH TO DESOLATION."

POINTING OUT THAT IN INDIA AND CANADA DIFFERENT RACES LIVE TOGETHER AND "SHARE THE RESPONSIBILITIES OF GOVERNMENT," MR. LLOYD GEORGE ASKED: "WHY IS IT IMPOSSIBLE TO CONTEMPLATE SIMILAR CO-OPERATION OF RACES AND CREEDS IN PALESTINE?"

LONDON, JULY 18. (JTA) -- DAVID LLOYD GEORGE'S ARTICLE DENOUNCING PARTITION WAS PUBLISHED HERE TODAY IN THE SUNDAY EXPRESS UNDER THE TITLE "A SCANDALOUS REPORT."

NEW RIOTS IN POLAND; ANTI-SEMITES FIRE ALL JEWS' HOMES IN VILLAGE

WARSAW, JULY 18. (JTA) -- WIDESPREAD OUTBREAKS OF ANTI-SEMITIC VIOLENCE THROUGHOUT POLAND LEFT A JEWISH MERCHANT DYING TODAY, SEVERAL JEWS INJURED AND MANY HOMELESS.

THE MERCHANT, BENJAMIN RANENGISER, OF WILNO, WAS ATTACKED BY ENDEKS (MEMBERS OF THE ANTI-SEMITIC NATIONAL DEMOCRATIC PARTY) AS HE STEPPED OUT OF HIS SHOP. HE WAS TAKEN TO A HOSPITAL, AND IT WAS REPORTED HE WOULD NOT RECOVER.

THE ENTIRE JEWISH POPULATION OF THE VILLAGE OF PIONTKOW, NEAR BLAZOWA, IN THE PROVINCE OF RZESZOW, WAS LEFT HOMELESS AND DESTITUTE WHEN ANTI-SEMITES SET FIRE TO ALL THE JEWISH HOUSES IN THE VILLAGE AND THEN PREVENTED THE OWNERS FROM SAVING THEIR BELONGINGS. ONE JEW, TRYING TO RESCUE THE SEFER TORAH (SCROLL OF THE LAW), FROM A BLAZING SYNAGOGUE, WAS STONED BY THE RIOTERS.

A SIMILAR ATTEMPT BY ENDEKS TO BURN DOWN JEWISH HOMES IN KURZENIEC KROLEWCZYNA, IN WILNO PROVINCE, WAS THWARTED BY THE VIGILANCE OF THE JEWS, WHO PUT OUT THE FIRE.

IN THE MARKET PLACE AT MALISZ, ENDEKS FORCED THE JEWISH MERCHANTS INTO A BACK SECTION, AROUND WHICH THEY POSTED NOTICES READING: "JEWISH SHOPS. POLES MUST PURCHASE FROM POLES."

THE JEWISH BUSINESS MEN PROTESTED TO THE PREMIER AND THE GOVERNOR OF LODZ PROVINCE, AND ANNOUNCED THAT UNTIL THE "GHETTO MARKET" IS ABOLISHED THEY WILL REFUSE TO DO BUSINESS THERE. MEANWHILE THE ECONOMIC COMMISSION OF THE LODZ CHAMBER OF COMMERCE ADOPTED A RESOLUTION BLAMING ANTI-JEWISH EXCESSES FOR ECONOMIC COLLAPSE, WHICH WAS FORWARDED TO THE GOVERNMENT.

SEVERAL JEWS WERE BEATEN BY ENDEKS IN DISORDERS AT KAMINSK AND ZARRZOWEK, IN LUBLIN PROVINCE.

HAAVARAH MARKS OBTAINABLE HERE UNDER INTRIA-EXPRESS CO. PACT

NEW YORK, JULY 18. (JTA) -- AN ARRANGEMENT FOR FACILITATING THE SENDING OF MONEY BY JEWS TO RELATIVES IN GERMANY AND THE EXPORT OF FUNDS BY GERMAN JEWS WISHING TO EMIGRATE, WAS ANNOUNCED YESTERDAY BY DR. WERNER FEILCHENFELD, GENERAL MANAGER OF HAAVARA, LTD., OF TEL AVIV, PRIOR TO SAILING FOR EUROPE ON THE REX.

WHILE HERE, DR. FEILCHENFELD SAID, HE REACHED AN AGREEMENT WITH THE AMERICAN EXPRESS COMPANY, UNDER WHICH JEWS IN THE UNITED STATES AND ELSEWHERE OUTSIDE GERMANY CAN PURCHASE HAAVARAH MARKS (JEWISH EMIGRANT MARKS), ESTABLISHING CREDITS TO BE DRAWN AGAINST BY JEWS IN GERMANY. HAAVARAH MARKS WILL BE SOLD AT THE SAME DISCOUNT AS REGISTERED REICHSMARKS, NOW USED FOR THE SAME PURPOSE. THE SYSTEM WILL BE OPERATED JOINTLY BY THE AMERICAN EXPRESS COMPANY AND INTRIA, LTD., EUROPEAN AGENT FOR HAAVARAH, LTD., WHICH HAS A NEW YORK OFFICE AT 120 BROADWAY.

MAGNES LAUDS COMMISSION'S REPORT BUT DENIES PARTITION IS PROPER SOLUTION

NEW YORK, JULY 18. (JTA) -- TERMING THE 404-PAGE REPORT OF THE PALESTINE ROYAL COMMISSION "A GREAT STATE PAPER" AND A "PITILESS DOCUMENT," DR. JUDAH L. MAGNES, PRESIDENT OF THE HEBREW UNIVERSITY IN JERUSALEM, WAS ON RECORD TODAY AS STRONGLY DISAGREEING WITH ITS PROPOSAL OF PARTITION AS THE SOLUTION TO ARAB-JEWISH DIFFICULTIES.

DR. MAGNES' VIEWS ARE MADE PUBLIC IN THE FORM OF A LETTER TO THE EDITOR OF THE NEW YORK TIMES, WRITTEN FROM PARIS JULY 12 AND PUBLISHED TODAY.

AGREEING WITH THE COMMISSION'S THESIS THAT THE PRESENT SYSTEM, WHICH HE DESCRIBES AS "GOVERNMENT BY SEE-SAW," MUST GO, THE EDUCATOR ADVANCES THE THEORY THAT THE ONLY PRACTICAL ALTERNATIVE AT THE PRESENT TIME IS ONE WHICH WILL PERMIT ARABS AND JEWS TO ARRIVE AT "FREELY AND OPENLY NEGOTIATED AGREEMENTS."

DR. MAGNES CONTENDS THAT THE PALESTINE ADMINISTRATION HAS NEVER MADE AN EFFORT TO CREATE CONDITIONS LEADING TO CONCLUSION OF SUCH AGREEMENTS BETWEEN THE TWO PEOPLES.

"THUS FAR," HE WRITES, "THERE HAS BEEN GOVERNMENT BY SEE-SAW. FIRST ONE PEOPLE, THEN THE OTHER, WOULD BE FAVORED OR PUNISHED. THERE HAS NEVER BEEN FORMULATED, MUCH LESS WORKED OUT OR PUT INTO EFFECT, A CONSCIOUS DAY-BY-DAY POLICY THAT WOULD HAVE ONE GREAT BASIC OBJECT IN VIEW: FREELY AND OPENLY NEGOTIATED AGREEMENTS BETWEEN JEWS AND ARABS."

HIGH PRAISE FOR THE COMMISSION'S REPORT IS TEMPERED WITH CRITICISM FOR ITS NEGLECT IN EXPOSING WHAT HE DESCRIBED AS THE FAILURE OF "MANDATORY IMPERIALISM TO RISE TO ITS UNPARALLELED OPPORTUNITIES."

DESCRIBING THE REPORT AS "INCOMPARABLY THE MOST THOROUGHGOING AND MOST PENETRATING ANALYSIS OF THE PALESTINE SITUATION THAT HAS EVER BEEN MADE," DR. MAGNES CONTINUES: "IT IS A PITILESS DOCUMENT. THAT IS ONE OF ITS GREAT MERITS. IT EXHIBITS IN ALL ITS NAKEDNESS OUR MISERABLE FAILURE -- THE FAILURE OF EACH ONE OF US, JEW, ARAB AND ENGLISH. AN EXTRA-ORDINARY WORK OF BUILDING UP WASTE LAND HAS BEEN ACHIEVED. BUT WE HAVE FAILED. WE HAVE NOT KNOWN HOW TO MAKE PEACE. IT IS THE WELL-DOCUMENTED STORY OF TWO FIERCE NATIONALISMS AT WAR WITH ONE ANOTHER, A DOCUMENT THAT WOULD HAVE COMMANDED MORE CONFIDENCE HAD IT EXPOSED EQUALLY TO THE LIGHT OF DAY THE FAILURE ALSO OF MANDATORY IMPERIALISM TO RISE TO ITS UNPARALLELED OPPORTUNITIES."

DR. MAGNES DECLARES THAT THE "RIGHTS" CONFERRED ON THE JEWS BY THE STATES WHICH WON THE WAR ARE "A THOUSAND TIMES LESS IMPORTANT" THAN THE CONSENT OF THE ARABS "WHO WILL CONTINUE TO BE OUR NEIGHBORS EVEN AFTER BRITISH IMPERIALISM MAY HAVE PASSED."

DR. MAGNES ADMITS THAT THE COMMISSION HAS MADE OUT A STRONG CASE FOR PARTITION, BUT COUNSELS AGAINST IT ON THE GROUND THAT IT WOULD CREATE "PASSIONATE DISSATISFACTION" AND THAT A SINCERE EFFORT OUGHT FIRST TO BE MADE TO CREATE CONDITIONS FAVORABLE TO ARAB-JEWISH RAPPROCHEMENT. DEVELOPING THIS THESIS, THE EDUCATOR ARGUES THAT ARAB-JEWISH AGREEMENTS FREELY AND OPENLY REACHED COULD BE "INCORPORATED PROGRESSIVELY INTO THE BASIC LAW OF THE LAND." THE AGREEMENTS, DR. MAGNES EMPHASIZES SHOULD BE FOR "LIMITED PERIODS OF TIME."

HE SAYS THE PRESENT MANDATE OUGHT TO BE CHANGED TO INCLUDE TWO BASIC POINTS, ONE SETTING FORTH THAT "BOTH JEWS AND ARABS ARE IN PALESTINE AS OF RIGHT AND NOT ON SUFFERANCE," AND THE OTHER THAT "THE CHIEF REASON FOR THE MANDATORY'S PRESENCE IN PALESTINE IS TO ENDEAVOR TO CREATE CONDITIONS FAVORABLE" TO CONCLUSION OF THE AFORE-MENTIONED AGREEMENTS.
