WAUCHOPE TO QUIT EARLY NEXT YEAR, ORMSBY-GORE TELLS COMMONS; POOR HEALTH CITED

LONDON, OCT. 28. (JTA) -- LIEUTENANT-GENERAL SIR ARTHUR GRENFELL WAUCHOPE, FOR THE PAST SIX YEARS HIGH COMMISSIONER FOR PALESTINE, WILL RESIGN EARLY IN 1938 FOR REASONS OF HEALTH, COLONIAL SECRETARY WILLIAM G.A. ORMSBY-GORE ANNOUNCED TODAY IN THE HOUSE OF COMMONS.

SIR ARTHUR, WHO HAS BEEN CRITICIZED IN MANY QUARTERS FOR LENIENCY IN DEALING WITH ARAB TERRORISM, ONLY YESTERDAY LEFT A NURSING HOME, WHERE HE HAD BEEN TREATED FOR AN EYE ALLMENT WHILE ON LEAVE FROM JERUSALEM.

GENERAL WAUCHOPE WAS THE FOURTH HIGH COMMISSIONER, HAVING BEEN APPOINTED NOV. 12, 1931, TO SUCCEED SIR JOHN ROBERT CHANCELLOR, AND THEN RE-APPOINTED LAST YEAR FOR ANOTHER FIVE-YEAR TERM. NO ANNOUNCEMENT WAS MADE AS TO HIS SUCCESSOR, BUT IN RECENT WEEKS FIELD MARSHAL SIR PHILIP CHETWODE AND SIR JOHN ANDERSON, FORMER GOVERNOR OF BENGAL, HAVE BEEN SPOKEN OF AS THE LIKELIEST CANDIDATES FOR THE POST.

IN ANNOUNCING THE RESIGNATION IN COMMONS, MR. ORMSBY-GORE EXPRESSED THE GOVERN-MENT'S DEEP APPRECIATION OF SIR ARTHUR'S LONG AND DISTINGUISHED SERVICES TO THE STATE.

"SINCE WAUCHOPE CAME ON LEAVE," THE COLONIAL SECRETARY STATED, "HE HAS SUFFERED FROM AN ILLNESS REQUIRING TREATMENT IN A NURSING HOME. HE IS NOW RECOVERING, AND IT IS HOPED HE WILL BE SUFFICIENTLY PESTORED TO HEALTH TO RESUME HIS POST IN THE MIDDLE OF NOVEMBER.

"He has, however, intimated that he does not feel his health permits completion of the full second term, and therefore has asked to be relieved of his duties in the early part of next year."

MUSSOLINI HELD READY TO DENOUNCE MANDATE, BACK IBN SAUD AS ARAB'S RULER

LONDON, Oct. 28. (JTA) -- PREMIER MUSSOLINI IS ABOUT TO DENOUNCE THE PALESTINE MANDATE AND SUPPORT KING IBN SAUD OF SAUDI ARABIA WHO WILL PROCLAIM HIMSELF KING OF ALL ARABS, ACCORDING TO A SENSATIONAL REPORT PUBLISHED TODAY BY A PRIVATE NEWS AGENCY.

THE AGENCY ASSERTS THE BRITISH COLONIAL OFFICE HAS BEEN THROWN INTO A PANIC AT WHAT IT DESCRIBES AS "UNIMPEACHABLE INFORMATION" ON THE ITALIAN DICTATOR'S INTENTIONS. THE AGENCY'S REPORT WAS PUBLISHED IN ITS WEEKLY BULLETIN ON FOREIGN AFFAIRS, KNOWN AS "THE WEEK," A PRIVATELY CIRCULATED, MIMEOGRAPHED PUBLICATION. IT WAS REPRODUCED BY LE JOUR, CONSERVATIVE PARIS MORNING NEWSPAPER.

"Mussolini," THE REPORT STATES, "IS ABOUT TO DENOUNCE THE PALESTINE MANDATE AND AT A STROKE THROW THE BRITISH POSITIONS IN THE EASTERN MEDITERRANEAN INTO AS UNEASY A MESS AS THEY ARE ALREADY IN IN THE WEST, AND IMMEDIATELY AFTER THAT IBN SAUD WILL, BY ARRANGEMENT WITH ROME, PROCLAIM HIMSELF KING OF ALL THE ARABS, THUS STARTING A FIRE THAT WILL BLAZE FROM BACHDAD TO CASABLANCA."

ACCORDING TO LE JOUR, THE STORY WAS INSPIRED FROM ROME, "NOT AS A KITE TO TEST THE WIND, BUT AS NOTICE OF AN ACTION ALREADY DECIDED UPON."

THE NEWSPAPER REPORTS FURTHER THAT NEGOTIATIONS BETWEEN ROME AND IBN SAUD ON THE EXTENT OF ITALIAN AID HAVE GONE AS FAR AS TO CONSIDER THE AVAILABILITY OF LIGHT MACHINE GUNS FOR THE ARAB FORCES. IT ADDS THAT HIGH OFFICIALS OF THE COLONIAL OFFICE ARE CONSULTING WITH THE ADMIRALTY ON THE PROSPECTS OF WAR AT BOTH ENDS OF THE MEDITERRANEAN.

OFFICIAL CIRCLES SKEPTICAL

LONDON, Oct. 28. (JTA) -- OFFICIAL CIRCLES DESCRIBED AS "UTTERLY IMPROBABLE" TODAY PUBLISHED REPORTS THAT PREMIER MUSSOLINI AND KING IBN SAUD OF SAUDI ARABIA WERE PLOTTING TO UPSET THE PALESTINE MANDATE.

THE REPORTS, ACCORDING TO INFORMED SOURCES, PROBABLY ARISE FROM THE RUMOR THAT MUSSOLINI IS ANXIOUS TO SECURE ACCESS TO PORTS ON THE OTHER SIDE OF THE RED SEA IN ORDER TO PROTECT HIS ABYSSINIAN CONQUEST.

NEW COMMISSION TO HAVE ONLY 3 MEMBERS, LONDON HEARS

LONDON, OCT. 28. (JTA) -- THE EVENING NEWS REPORTS TODAY THAT THE NEW PALESTINE COMMISSION, AUTHORIZED BY THE LEAGUE OF NATIONS TO FRAME A DETAILED PARTITION PLAN, WILL COMPRISE ONLY THREE MEMBERS AND WILL NOT GO TO PALESTINE BEFORE SIX OR EVEN TWELVE MONTHS.

NEARLY THIRD OF BALFOUR FOREST WIPED OUT BY FIRE; DAMAGE PUT AT \$150,000

JERUSALEM, Oct. 28. (JTA) -- THE FIRE THAT SWEPT THE BALFOUR FOREST IN THE NAZARETH HILLS YESTERDAY DESTROYED NEARLY A THIRD OF ITS 250,000 TRESS AND CAUSED DAMAGES OF \$150,000, IT WAS ESTIMATED TODAY.

THE JEWISH NATIONAL FUND, ON WHOSE LAND THE FOREST STANDS, ANNOUNCED IT WOULD START REPLANTING AT ONCE. THE GOVERNMENT, THE FUND SAID, 18 BEING ASKED TO MEET THE COST AND TO GUARANTEE FUTURE PROTECTION.

THE FIRE, MOST SPECTACULAR IN YEARS, BROUGHT GRIEF AND INDIGNATION TO THE JEWISH COMMUNITY. BELIEVED TO HAVE BEEN SET BY ARAB TERRORISTS IN THE CAMPAIGN AGAINST PARTITION OF PALESTINE, IT RAGED FOUR HOURS BEFORE BEING CHECKED BY THE COMBINED EFFORTS OF NEIGHBORING JEWISH COLONISTS, POLICE FROM NAZARETH, AFULEH AND HAIFA, AND FIRE BRIGADES FROM HADAR HACARMEL, UNDER THE PERSMAL DIRECTION OF THE DISTRICT COMMISSIONER. AT ITS HEIGHT, THE BLAZE LIT UP HALF OF THE JEZREEL VALLEY.

POLICE DOSS PICKED UP THE TRAIL OF THE SUSPECTED INCENDIARIES, WHICH LED TO THE ARAB VILLAGE OF YAPETIL, NEAR NAZARETH. AN ARAB CARRYING A GERMAN RIFLE WAS ARRESTED ON SUSPICION OF PARTICIPATING IN TUESDAY'S AMBUSH OF A PALESTINE POTASH COMPANY CONVOY DURING WHICH A JEWISH WORKMAN WAS KILLED.

INCREASED TENSION RESULTING FROM THE FIRE AND THE LATEST KILLINGS OF JEWS BROUGHT STATEMENTS URGING JEWS TO MAINTAIN THEIR SELF-RESTRAINT, ISSUED BY THE JEWISH NATIONAL COUNCIL AND CHIEF RABBIS JACOB MEIR AND ISSAC HERTZOG. THE RABBINICAL LEADERS CALLED ON ALL CLASSES OF THE JEWISH COMMUNITY TO REMAIN CALM AND NOT TO "STAIN THE DEAR MEMORIES OF THE FALLEN" BY REPRISALS.

AN ATTEMPT TO BURN THE NEW ARAB GOVERNMENT SCHOOL AT HAIFA WAS FRUSTRATED WHEN WATCHMEN SWIFTLY EXTINGUISHED A FIRE.

THE AUTHORITIES WARNED ARAB NOTABLES OF GAZA AND MIGDAL THAT THEY WOULD BE SENT TO CONCENTRATION CAMPS AND THEIR HOMES DYNAMITED UNLESS THEY DISCLOSED THE WHEREABOUTS OF SABOTEURS.

ATTEMPT TO KILL MAGISTRATE BODILLY FAILS

JERUSALEM, Oct. 28. (JTA) -- AN ATTEMPT ON THE LIFE OF CHIEF MAGISTRATE RALPH B. BODILLY, WHO HAS SENTENCED MANY ARAB TERRORISTS, WAS BELIEVED TO HAVE BEEN FRUSTRATED TODAY BY AN ALERT BRITISH CONSTABLE.

MOTORING ON THE JAFFA-TEL AVIV BORDER, BODILLY WAS OVERTAKEN BY A CAR OCCUPIED BY FOUR ARABS, ONE OF WHOM POINTED TO THE MAGISTRATE, SHOUTING, "HERE HE IS!" THE CONSTABLE ACCOMPANYING BODILLY QUICKLY POINTED HIS RIFLE AT THE ARABS, AND THEY FLED.

THE INCIDENT OCCURRED SHORTLY AFTER THE MAGISTRATE, ONE OF THE MOST POPULAR ON PALESTINE'S BENCH, HAD RECEIVED A THREATENING LETTER.

MAJOR-GENERAL ARCHIBALD P. WAVELL, COMMANDER OF BRITISH FORCES IN PALESTINE, IN-SPECTING THE CELEBRATED BLACK WATCH REGIMENT, WHICH ARRIVED HERE RECENTLY, URGED THE TROOPS TO BE ALMAYS ON THE ALERT FOR THE UNEXPECTED.

THE ARABS, HE SAID, ARE A GOOD-HUMORED PEOPLE, 95 PER CENT OF THEM BEING PEACEFUL AND LAM-BBIDING, WITH THE REMAINING FIVE PER CENT MISCHIEF-MAKERS. "I SHALL NOT SPEAK ABOUT POLITICS," HE ADDED. "THE INTRICACIES OF THE SITUATION WILL BE EXPLAINED BY THE OFFICERS."

GENERAL WAVELL SAID THE WORST FEATURE OF THE PRESENT SITUATION WAS SECURITY. HE RECALLED THAT HE HAD VISITED PALESTINE 22 YEARS AGO, WHEN THE CITY OF TEL AVIV DID NOT EXIST AND THE AREA WAS ENTIRELY SAND DUNES.

SUSPECTED ILLEGAL ENTRANTS MUST PROVE RIGHT TO STAY IN PALESTINE

LONDON, OCT. 28. (JTA) -- THE NEW PALESTINE IMMIGRATION ORDINANCE PUTS ON ALL PALESTINIANS ACCUSED OF ENTERING ILLEGALLY, OR WHOSE VISAS HAVE EXPIRED, THE BURDEN OF PROVING THEIR RIGHT TO RESIDE IN THE COUNTRY, THE HOUSE OF COMMONS WAS TOLD TODAY BY COLONIAL SECRETARY WILLIAM ORMSBY-GORE, REPLYING TO A QUERY BY COL. JOSIAH WEDGWOOD, LABORITE.

THE ORDINANCE ALSO PROVIDES, THE COLONIAL SECRETARY SAID, PENALTIES FOR AIDING, ABETTING OR HARBORING ILLEGAL IMMIGRANTS AND EMPOWERS THE HIGH COMMISSIONER TO PRESCRIBE THE MAXIMUM OF IMMIGRANTS IN SPECIFIED PERIODS AND THE NUMBER OF JEWS TO BE INCLUDED IN THAT FIGURE.

WARBURG WILL GIVES BULK OF ESTATE TO KIN; CITES \$13,000,000 TO CHARITIES IN 15 YEARS

NEW YORK, OCT. 28. (JTA) -- FELIX M. WARBURG'S WILL, DISPOSING OF WELL OVER \$2,000,000 IN BEQUESTS, IN ADDITION TO PERSONAL PROPERTY AND REAL ESTATE, WAS FILED FOR PROBATE TODAY IN THE OFFICE OF THE NEW YORK COUNTY SURROGATE BY SOL M. STROOCK, THE PERSONAL COUNSEL OF THE BANKER, PHILANTHROPIST AND COMMUNAL LEADER.

THE BEQUESTS SUPPLEMENTED THE UPWARDS OF \$13,000,000 WHICH MR. AND MRS. WARBURG GAVE, ACCORDING TO A STATEMENT BY MR. STROOCK, IN THE PAST FIFTEEN YEARS TO PHILANTHROPIC, EDUCATIONAL AND CIVIC ENTERPRISES THROUGHOUT THE WORLD, NUMBERING MORE THAN 200.

The will, dated Feb. 12, 1935, leaves to Mrs. Frieda Schiff Warburg, the widow, all real estate and personal property; to each of his five children, \$250,000; to each of the eight grandchildren, a \$100,000 trust fund; \$50,000 each to Marion Bab Warburg and Walter N. Rothschild, his son-in-law, and \$150,000 to the executors to be used to aid Mr. Warburg's relatives.

THE LARGEST BEQUEST TO AN ORGANIZATION IS \$50,000 TO THE FEDERATION FOR THE SUPPORT OF JEWISH PHILANTHROPIC SOCIETIES OF NEW YORK. A TOTAL OF \$57,000 IS DISTRIBUTED TO NINE OTHER INSTITUTIONS, INCLUDING \$10,000 EACH TO THE AMERICAN MUSEUM OF NATURAL HISTORY, THE SOLOMON AND BETTY LOEB MEMORIAL HOME FOR CONVALESCENTS AT EAST VIEW, N.Y., AND TEACHERS COLLEGE OF COLUMBIA UNIVERSITY.

THE OPENING PARAGRAPH OF THE WILL EXPLAINS WHY OTHER INSTITUTIONS WERE OMITTED.

"AT THE PRESENT TIME I AM OVER SIXTY YEARS OLD," IT SAYS, "AND HAVE IN THE MAIN CARRIED OUT DURING MY LIFE MY PHILANTHROPIC PURPOSES WITH RESPECT TO MOST OF THE INSTITUTIONS IN THE DEVELOPMENT OF WHICH I HAVE BEEN FOR MANY YEARS INTERESTED AND I FEEL THAT I HAVE BEEN FORTUNATE IN HAVING LIVED LONG ENOUGH TO WATCH THESE INSTITUTIONS GROW AND TO SEE THEIR PLANS MORE OR LESS PERFECTED. FOR THESE REASONS I HAVE OMITTED IN LARGE PART THE BEQUESTS TO CHARITABLE PURPOSES WHICH HAVE BEEN INCLUDED IN PREVIOUS WILLS."

THE EXECUTORS NAMED IN THE WILL ARE THE WIDOW, THE SONS, FREDERICK M. AND PAUL FELIX WARBURG; HIS SON-IN-LAW, WALTER N. ROTHSCHILD, AND NEPHEW, JOHN M. SCHIFF, WITH A PROVISION THAT ONLY THREE OF THEM, AND IN THE ORDER NAMED, SHALL QUALIFY AND ACT. AT THE SAME TIME.

PROVISION IS MADE FOR EMPLOYES AT KUHN, LOEB & CO., OF WHICH MR. WARBURG WAS THE SENIOR PARTNER, AND FOR HIS HOUSEHOLD EMPLOYES. THE FIRM'S EMPLOYES RECEIVE FROM \$250 TO \$2,000 DEPENDING ON LENGTH OF SERVICE, AND THE HOUSEHOLD EMPLOYES \$100 TO \$10,000. AN ANNUITY OF 2,500 REICHSMARKS IS PROVIDED FOR MISS SELMA FLIESS OF FRANKFORT, GERMANY, FORMERLY A COMPANION OF MR. WARBURG'S GRANDMOTHER.

THE WILL PROVIDES THAT THE RESIDUE OF THE ESTATE SHALL BE DIVIDED EQUALLY AMONG MR. WARBURG'S SONS.

THE PROPERTY, WHICH WAS LEFT TO MRS. WARBURG, INCLUDES THE WARBURG RESIDENCES IN NEW YORK AND WHITE PLAINS. MRS. WARBURG RECEIVES HIS COLLECTION OF BLACK AND WHITE PRINTS. HIS SON, EDWARD, WHO "SHOWS DECIDED SIGNS OF HAVING INHERITED LOVE OF WORKS OF ART," IS GIVEN THE RIGHT, AFTER MRS. WARBURG'S DEATH, TO PURCHASE FROM THE ESTATE THE COLLECTION FOR A SUM TO BE DETERMINED BY THE EXECUTORS, OR IF HE FEELS THE COLLECTION IS TOO LARGE OR BURDENSOME, THE OTHER CHILDREN MAY BUY PRINTS NOT EXCEEDING IN AGGREGATE ONE-QUARTER IN VALUE OF THE COLLECTION, THE REST TO GO TO THE METROPOLITAN MUSEUM OF ART.

HADASSAH CONDEMNS PALESTINE POLITICAL CURB ON IMMIGRATION

ATLANTIC CITY, Oct. 28. (JTA) -- A RESOLUTION CONDEMNING THE NEW PALESTINE ORD-INANCE ESTABLISHING A POLITICAL BASIS FOR IMMIGRATION WAS ADOPTED LAST NIGHT BY THE TWENTY-THIRD ANNUAL CONVENTION OF HADASSAH AT THE HOTEL CHELSEA.

THE RESOLUTION, INTRODUCED BY MRS. EDWARD JACOBS, PRESIDENT, STATES THAT THE JEWS ACCEPTED IN GOOD FAITH THE PRINCIPLE OF ECONOMIC ABSORPTIVE CAPACITY AND LABORED TO BRING ABOUT "A MARKED TRANSFORMATION OF PALESTINE ADVANTAGEOUS TO ARABS AND JEWS."

THE ORDINANCE VIOLATES THE MANDATE AND THE AUGUST, 1937, RESOLUTION OF THE LEAGUE OF NATIONS MANDATES COMMISSION RECOMMENDING THAT THE MANDATORY POWER CONTINUE THE PRINCIPLE OF ECONOMIC ABSORPTIVE CAPACITY, THE RESOLUTION SAID. IT WAS SENT TO THE JEWISH AGENCY FOR TRANSMISSION TO THE COLONIAL OFFICE AND THE MANDATES COMMISSION.

MISS HENRIETTA SZOLD, WHO CAME FROM PALESTINE TO ATTEND THE CONVENTION, RECEIVED A TREMENDOUS OVATION FROM THE 2,500 DELEGATES. THE FOUNDER OF HADASSAH DECLARED IN AN ADDRESS THAT ARB-JEWISH RELATIONS CONSTITUTED THE ACID TEST OF THE ZIONIST MOVEMENT. SHE URGED THAT THE ZIONIST POSITIONS IN PALESTINE BE MAINTAINED AND ENLARGED.

DR. STEPHEN S. WISE DECLARMS IN AN ADDRESS: "THAT ZIONISM IS A POLITICAL PROBLEM, AND NOT CULTURAL OR SOCIAL OR SOCIALLY SPIRITUAL, IS BROUGHT HOME TO US BY THE BRITISH FAILURE TO IMPLEMENT THE MANDATE, BY ARAB ILL-WILL AND BY THE SEEMING INCAPACITY OF THE JEWISH PEOPLETO TAKE LARGE AND HEROIC MEASURES WHICH WOULD HAVE MADE IMPOSSIBLE THE PROPOSAL TO DISMEMBER PALESTINE."

SAMUEL BIENSTOCK DEAD AT 63; WAS J.T.A. TREASURER 1924-1927

NEW YORK, OCT. 28. (JTA) -- SAMUEL BIENSTOCK, RETIRED DRUGGIST AND FORMER TREAS-URER OF THE JEWISH TELEGRAPHIC AGENCY, DIED LAST NIGHT AFTER A LONG ILLNESS AT HIS HOME 43-33 46TH STREET, SUNNYSIDE, LONG ISLAND. HE WAS 63 YEARS OLD. BORN IN ODESSA, RUSSIA, MR. BIENSTOCK CAME TO THE UNITED STATES MORE THAN 45 YEARS AGO. FOR MANY YEARS HE WAS IN THE RETAIL DRUG BUSINESS IN HARTFORD, CONN., WHERE HE LOWS HELD THE POST OF SECRETARY OF THE HARTFORD RETAIL DRUGGISTS ASSOCIATION. AFTER HIS RETIREMENT, HE BECAME ASSOCIATED WITH THE JEWISH TELEGRAPHIC AGENCY, ACTING AS TREASURER FROM 1924 TO 1927.

MR. BIENSTOCK WAS A MASON AND A MEMBER OF THE INDEPENDENT ORDER OF ODD FELLOWS. HE IS SURVIVED BY HIS WIDOW, SOPHIA; THREE DAUGHTERS, MRS. IDA LANDAU, WIFE OF THE FOUNDER AND MANAGING DIRECTOR OF THE J.T.A., MRS. FREDA JOEL AND HARRIET; AND TWO SONS, NATHAN AND VICTOR M. BIENSTOCK, CHIEF OF THE J.T.A. EUROPEAN SERVICE, STATIONED IN LONDON.

Burial was at Mt. Zion Cemetery today, following services at Mr. Bienstock's late home.

II GET JAIL TERMS FOR DANZIG RIOTS; NEW ANTI-JEWISH MEASURES INVOKED

DANZIG, OCT. 28. (JTA) -- A SUMMARY COURT TODAY SENTENCED ELEVEN PERSONS TO JAIL TERMS OF ONE WEEK TO SIX MONTHS FOR PARTICIPATION IN ANTI-JEWISH DISORDERS HERE LAST SATURDAY.

A YOUTH CONVICTED OF LEADING THE RIOTS WAS SENTENCED TO FOUR TO SIX MONTHS. OTHERS, WHO PILLAGED JEWISH SHOPS DURING THE DISORDERS, RECEIVED TERMS RANGING FROM ONE TO TWELVE WEEKS.

SEVENTY OTHER PERSONS UNDER ARREST FOR THE RIOTING ARE AWAITING TRIAL. NATIONAL SOCIALIST HEADQUARTERS BROADCAST THE SENTENCES AS WARNING TO OTHER PROSPECTIVE DISTURBERS OF THE PEACE.

MEANWHILE, DISCRIMINATORY MEASURES CONTINUED TO BE INVOKED AGAINST JEWS. THE CHAMBER OF DOCTORS ISSUED A REGULATION PROHIBITING "NON-ARYAM" DOCTORS FROM PRACTICING AT NIGHT OR ON SUNDAYS.

AT THE SAME TIME A NUMBER OF RESTAURANTS AND CAFES THROUGHOUT DANZIG BANNED JEWS FROM THEIR PREMISES. THE ACTION WAS IN RESPONSE TO AN APPEAL BY THE NAZI PARTY TO THE ASSOCIATION OF RESTAURANT EMPLOYERS. THE RESTAURANTS COMPLYING WITH THE APPEAL POSTED SIGNS READING "ENTRY FORBIDDEN TO JEWS."

10 WOUNDED IN WILNO U. RIOTING; LWOW RECTOR QUITS OVER "GHETTO" DISPUTE

WARSAW, Oct. 28. (JTA) -- TEN JEWS WERE BEATEN AT WILDO UNIVERSITY, IT WAS RE-PORTED HERE TODAY, WHEN NATIONALISTS ATTACKED JEWISH STUDENTS WHO REFUSED TO OCCUPY "GHETTO BENCHES" ON THE LEFT SIDE OF CLASSROOMS.

THE RECTOR OF LWOW UNIVERSITY, PROFESSOR KULCZYNSKI, TENDERED HIS RESIGNATION TO THE UNIVERSITY'S SENATE COUNCIL BECAUSE OF A LACK OF UNANIMITY AMONG MEMBERS OF THE COUNCIL ON HIS DEMAND THAT STRICT MEASURES BE TAKEN AGAINST NATIONALIST STUDENTS DISTRIBUTING LEAFLETS ON THE GROUNDS ATTACKING HIM FOR HIS OPPOSITION TO SEGREGATION OF JEWS. THE RESIGNATION REQUIRES THE CONFIRMATION OF A PLENARY SESSION OF THE SENATE.

A JEWISH BAKER, ABRAM ROSENSTEIN, WAS FIRED UPON IN A WARSAW SUBURB AND STRUCK BY SEVERAL REVOLVER BULLETS. HE WAS TAKEN TO A HOSPITAL, WHERE LITTLE HOPE WAS HELD OUT FOR HIS RECOVERY.

CALLS ON ALL POLISH WORKERS TO FIGHT FASCISM, ANTI-SEMITISM

WARSAW, Oct. 28. (JTA) -- THE FIGHT AGAINST FASCISM AND ANTI-SEMITISM IS THE TASK OF THE ENTIRE POLISH WORKING CLASS, M. KWAPINSKI, PRESIDENT OF THE POLISH TRADES UNION CONGRESS, DECLARED YESTERDAY AT ITS OPENING SESSION.

POLISH MAYOR WARNS CITY EMPLOYES TO OBSERVE BOYCOTT OF JEWS

POZNAN, POLAND, OCT. 28. (JTA) -- MAYOR WICKOWSKI WARNED MUNICIPAL EMPLOYES IN A CIRCULAR TODAY THEY WOULD BE DEPRIVED OF ALL PRIVILEGES AND OPPORTUNITY FOR PROMOTION IF THEY BOUGHT FROM JEWISH TRADERS, VISITED JEWISH DOCTORS OR HAD ANY CONTACT WITH JEWS.

SWISS HIGH COURT HEARS NAZIS' APPEAL FROM "PROTOCOLS" VERDICT; DECISION MONDAY

BERNE, SWITZERLAND, OCT. 28. (JTA) -- A DECISION IS EXPECTED NEXT MONDAY IN AN APPEAL BROUGHT BY TWO SWISS NAZIS AGAINST THEIR CONVICTION UNDER ARTICLE 14 OF THE CANTONAL CODE, WHICH PROHIBITS DISSEMINATION OF "TRASH LITERATURE," FOR DISTRIBUTING "THE PROTOCOLS OF THE ELDERS OF ZION," DISCREDITED RECORD OF A PURPORTED JEWISH PLOTFOR WORLD DOMINATION.

No spectators were on hand when the hearing was held in the Court of Appeals yesterday. No new evidence was presented, but the appellants argued that the "Protocols" did not constitute "trash literature" within the meaning of the Law.

ONE ATTORNEY, URSPRUNG, MOVED FOR OVERRULING THE CONVICTION ON THE GROUND THAT THE "PROTOCOLS" INVOLVED THE ENTIRE JEWISH PEOPLE, AND THEREFORE THE SWISS JEWS DID NOT HAVE THE RIGHT TO APPEAR AS COMPLAINANTS. THE COURT DENIED THE MOTION AFTER A HALF-HOUR CONSIDERATION.

RUEF, COUNSEL FOR THE APPELLANT, SCHNELL, THEN SOUGHT A RETRIAL FOR HIS CLIENT ON THE GROUND THAT THE "PROTOCOLS" WAS OF A POLITICAL AND RELIGIOUS NATURE, AND NOT ERROTTO OR PORNOGRAPHIC IN THE SENSE OF THE LAW. URSPRUNG DEMANDED ACQUITTAL OF APPELLANT FISCHER ON THE SAME GROUND.

THE PUBLIC PROSECUTOR, LODER, EXPRESSED THE OPINION THAT THE "PROTOCOLS" WERE NOT "TRASH LITERATURE" WITHIN THE MEANING OF THE LAW. SOLY BRAUNSCHWIEG, PRESIDENT OF THE ZURICH JEWISH COMMUNITY, DEFENDED THE LOWER COURT'S RULING, AND COMPLAINED THAT, DESPITE THE RULING, THE SWISS FRONTIST ORGANIZATION WAS STILL ADVERTISING THE "PROTOCOLS."

PROF. MATTI REFUTED LODER'S CONTENTION, HOLDING THAT ARTICLE 14 WAS APPLICABLE TO THE CASE. LODER REPLIED THAT THE "PROTOCOLS" WAS CERTA" NLY LITERATURE OF A REPREHENSIBLE NATURE, BUT WAS PROPERLY A MATTER FOR ADMINISTRATIVE, NOT COURT ACTION. BRAUNSCHWEIG POINTED OUT THE COURT ACTION HAD BEEN BROUGHT AT THE ADVICE OF THE AUTHORITIES.

FULL TEXT OF PREAMBLE TO WARBURG WILL

FOLLOWING IS THE FULL TEXT OF THE OPENING PARAGRAPHS OF FELIX M. WARBURG'S WILL:

"I, FELIX M. WARBURG, OF THE COUNTY OF WESTCHESTER, STATE OF NEW YORK, DO HERE-BY MAKE, PUBLISH AND DECLARE THIS AS AND FOR MY LAST WILL AND TESTAMENT AS FOLLOWS:

"AT THE PRESENT TIME I AM OVER SIXTY YEARS OLD AND HAVE IN THE MAIN CARRIED OUT DURING MY LIFE MY PHILANTHROPIC PURPOSES WITH RESPECT TO MOST OF THE INSTITUTIONS IN THE DEVELOPMENT OF WHICH I HAVE BEEN FOR MANY YEARS INTERESTED AND I FEEL THAT I HAVE BEEN FORTUNATE IN HAVING LIVED LONG ENOUGH TO WATCH THESE INSTITUTIONS GROW AND TO SEE THEIR PLANS MORE OR LESS PERFECTED. FOR THESE REASONS I HAVE OMITTED IN LARGE PART THE BEQUESTS TO CHARITABLE PURPOSES WHICH HAVE BEEN INCLUDED IN PREVIOUS WILLS.

"ALL OF MY CHILDREN HAVE REACHED THEIR MAJORITY AND HAVE PROVEN TO MY FULL SATISFACTION THAT THEIR CHARACTERS HAVE DEVELOPED IN SUCH DIRECTIONS AND IN SUCH WAYS THAT I DO NOT FEEL CALLED UPON TO SAFEGUARD THEIR INHERITANCES BY COMPLICATED TRUSTS. I MOST GRATEFULLY EXPRESS MY JOY AT THE WONDERFUL RELATIONSHIP WHICH EXISTS AMONG THEM AND SINCERELY HOPE THAT THE SAME WILL CONTINUE EVEN MORE STRONGLY AFTER THEIR PARENTS ARE NOT ABLE TO BE WITH THEM ANY MORE. THEY HAVE TAKEN OVER VOLUNTARILY MANY OF THE INTERESTS WHICH BOTH MY WIFE AND I HAVE DEVELOPED IN OUR LIVES. I RECOGNIZE WITH PLEASURE THAT MY DAUGHTER CAROLA HAS INHERITED THE INCLINATION TO DO SOME OF THE HOSPITAL AND SCOUT WORK TO WHICH I HAVE GIVEN SOME TIME, THAT MY SON FREDERICK AND MY SON PAUL HAVE INHERITED THE INCLINATION TO DO PHILANTHROPIC AND CIVIC WORK; WHILE MY SON GERALD WHO HAS INHERITED A GREAT LOVE OF MUSIC, WILL NATURALLY DRIFT INTO ACTIVITIES IN THAT DIRECTION.

"MY SON EDWARD SHOWS DECIDED SIGNS OF HAVING INHERITED LOVE OF WORKS OF ART AND HE SHOULD HAVE THE FIRST CHOICE, IF HE SO DESIRES, AFTER THE DEMISE OF MY WIFE, TO INHERIT, ON THE TERMS HEREINAFTER PROVIDED, MY COLLECTION OF PRINTS IN BLACK AND WHITE, WHICH HAS GROWN IN QUANTITY AND IN VALUE AND CHARM DURING THE MANY YEARS THAT WE HAVE COLLECTED THEM."
